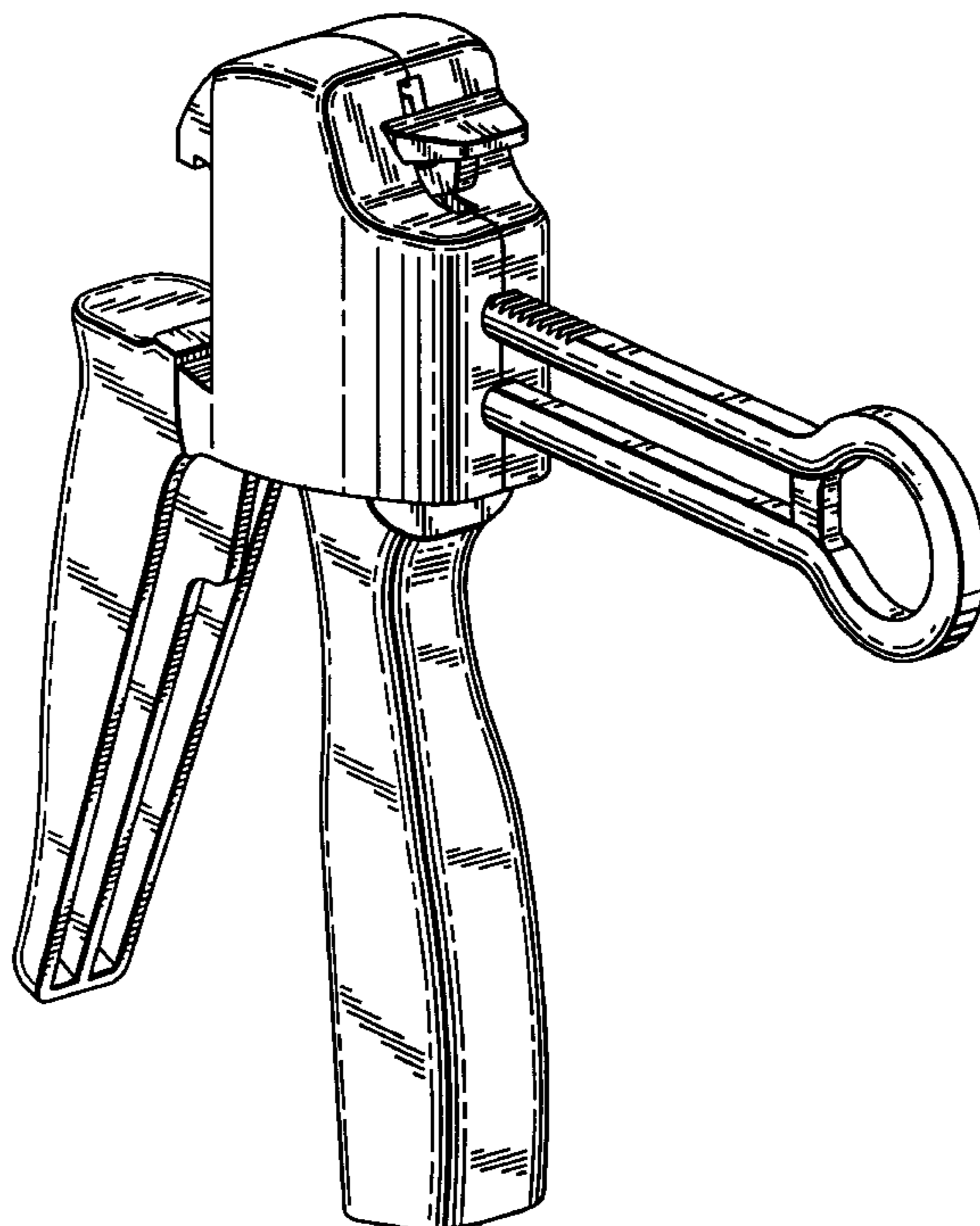
[57] **CLAIM**

The ornamental design for a cartridge dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a top, rear and right side perspective view of a cartridge dispenser showing my new design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a front elevational view thereof; and, FIG. 7 is a rear elevational view thereof.

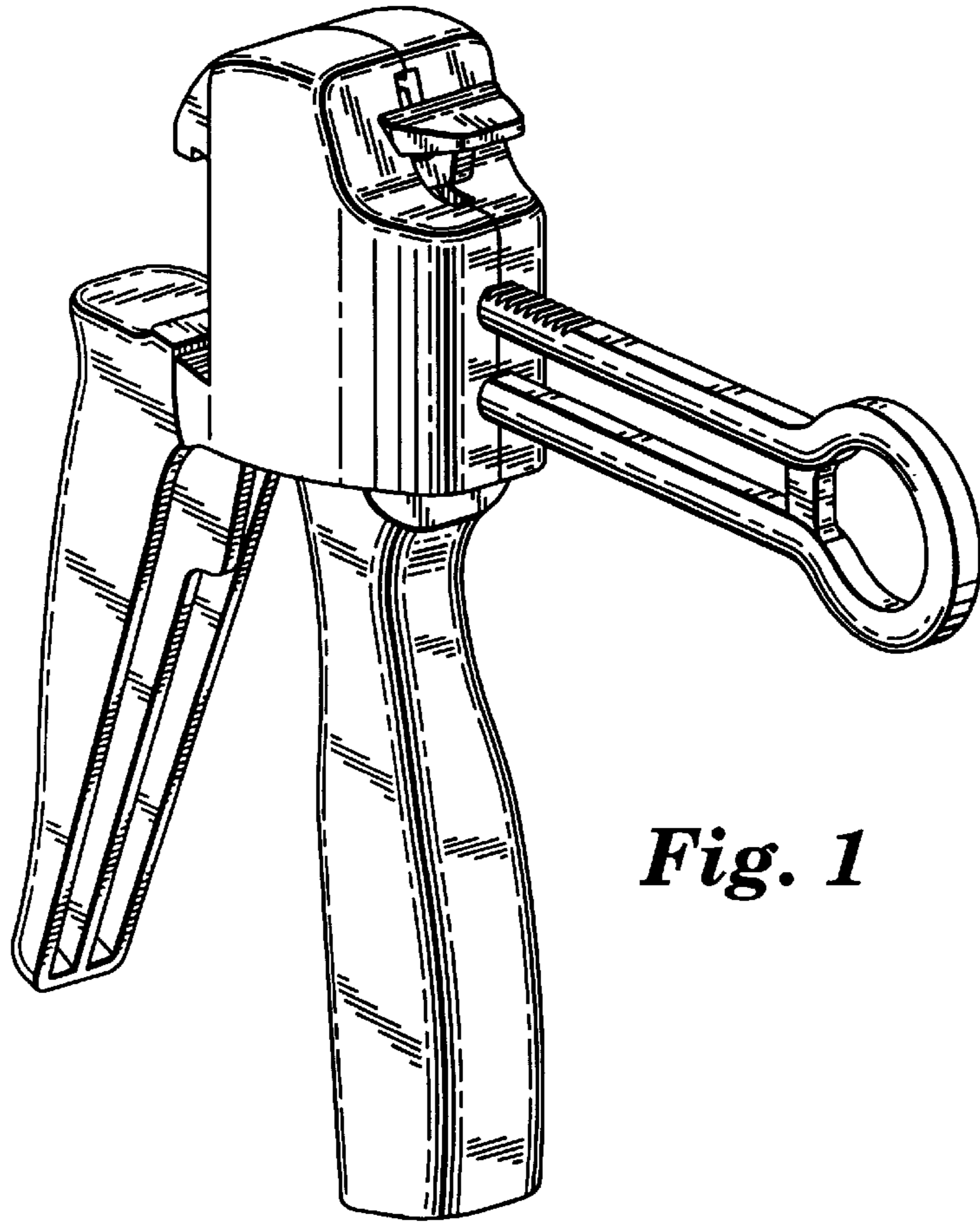

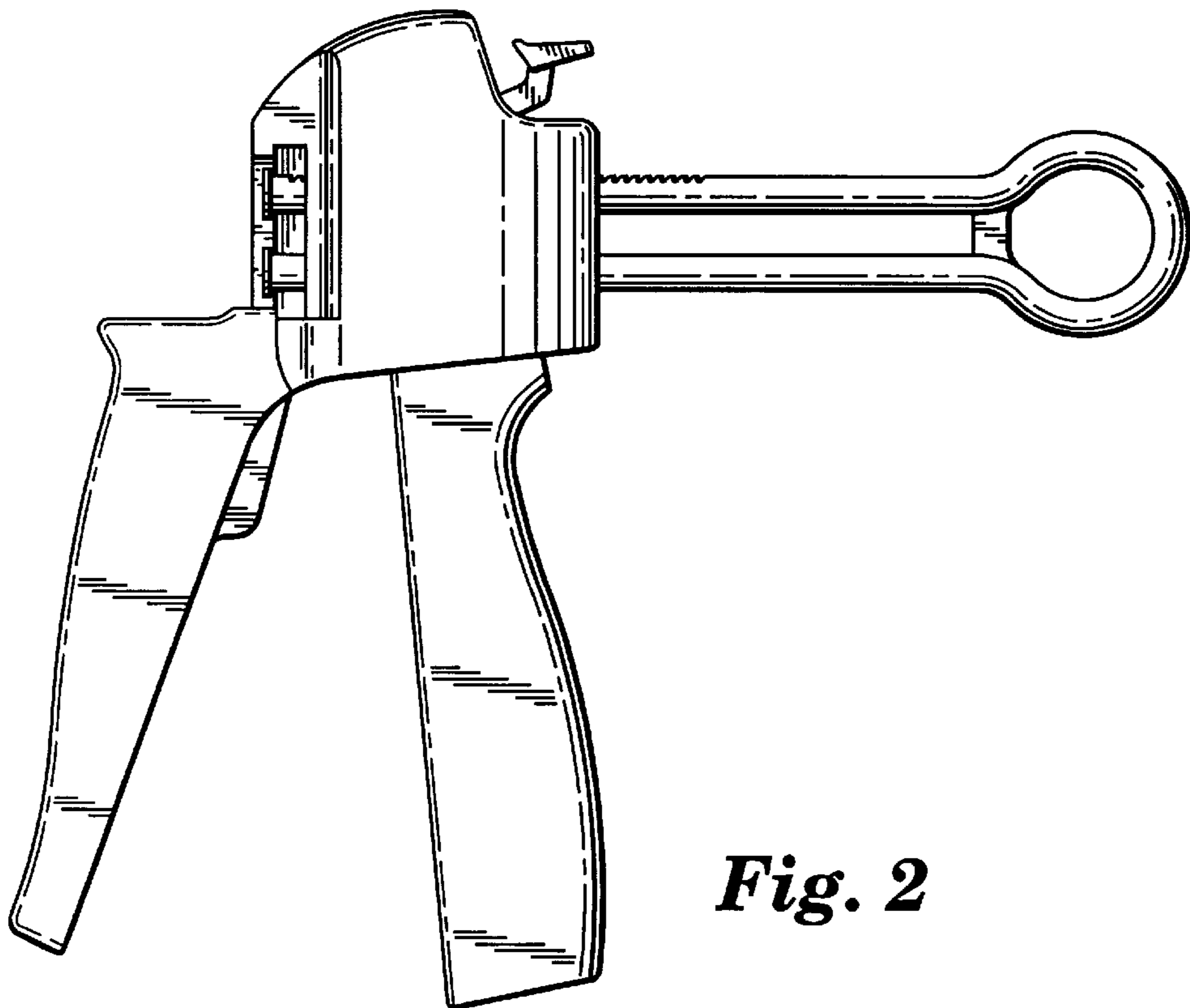

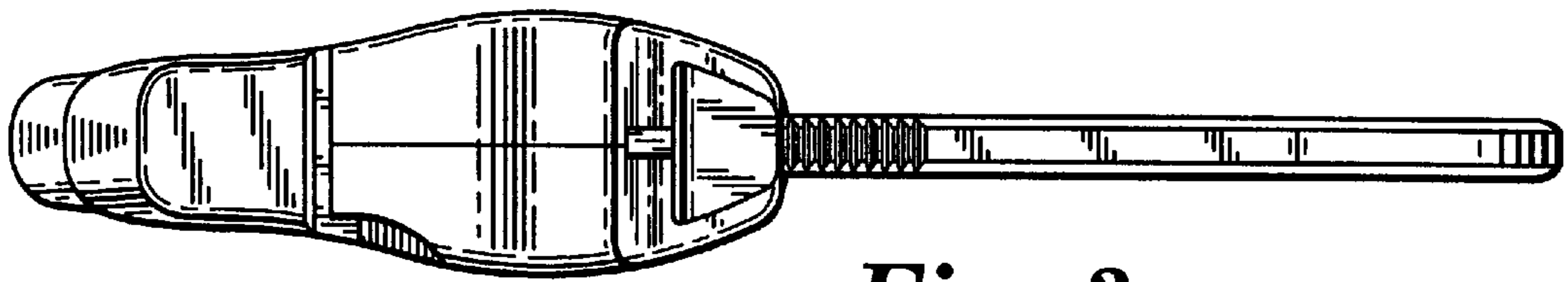

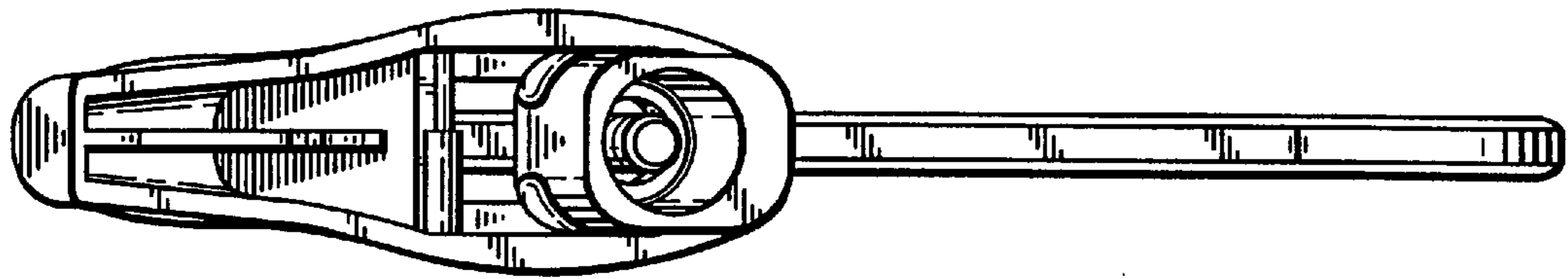

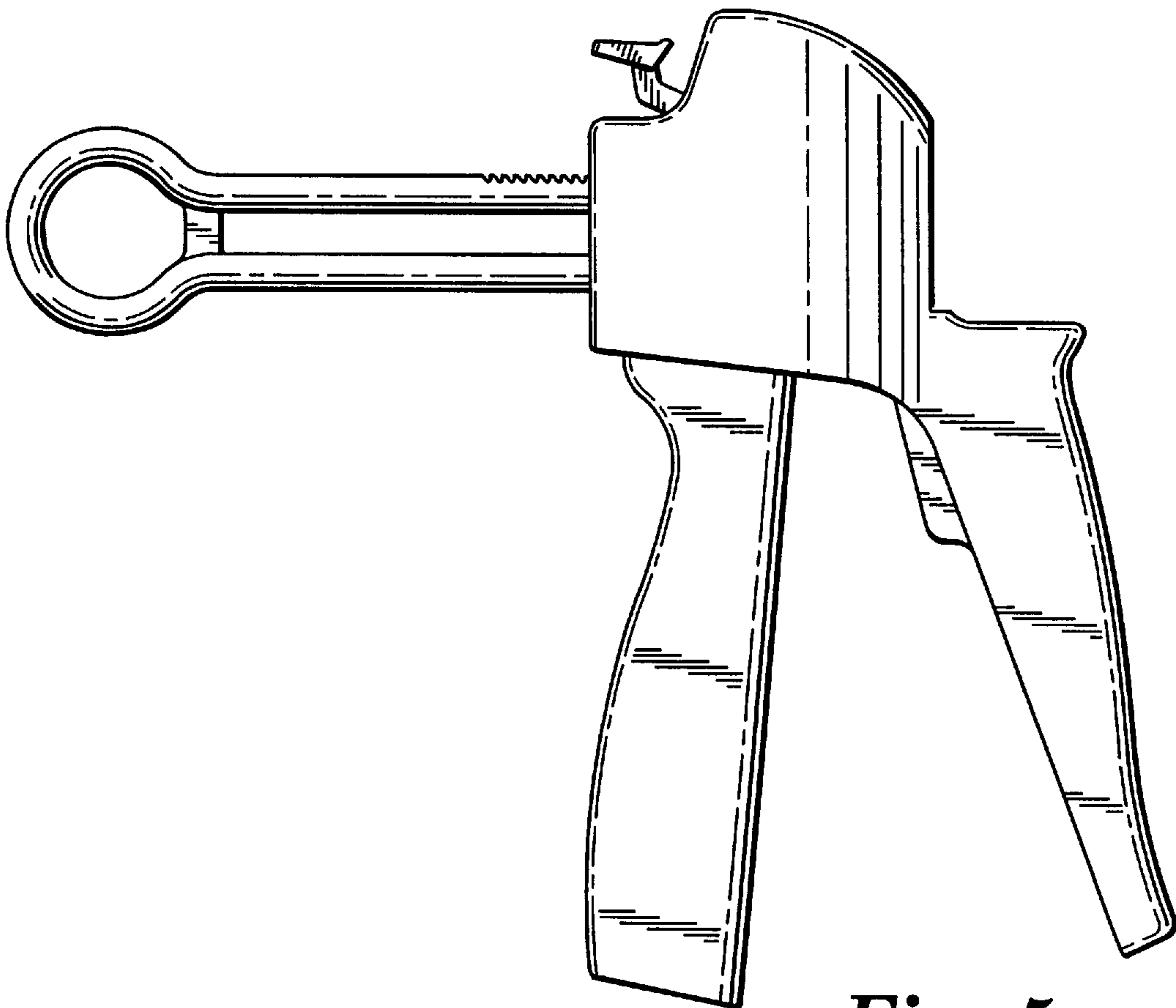

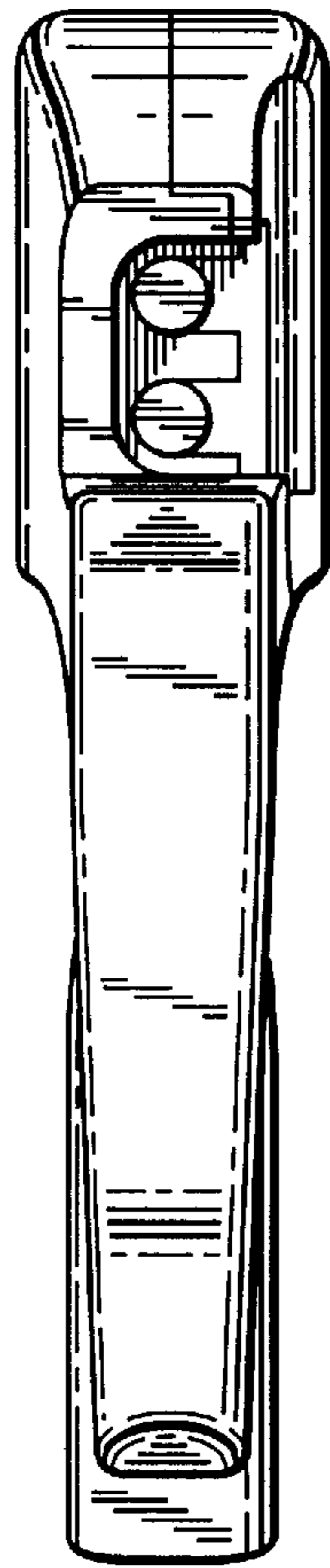

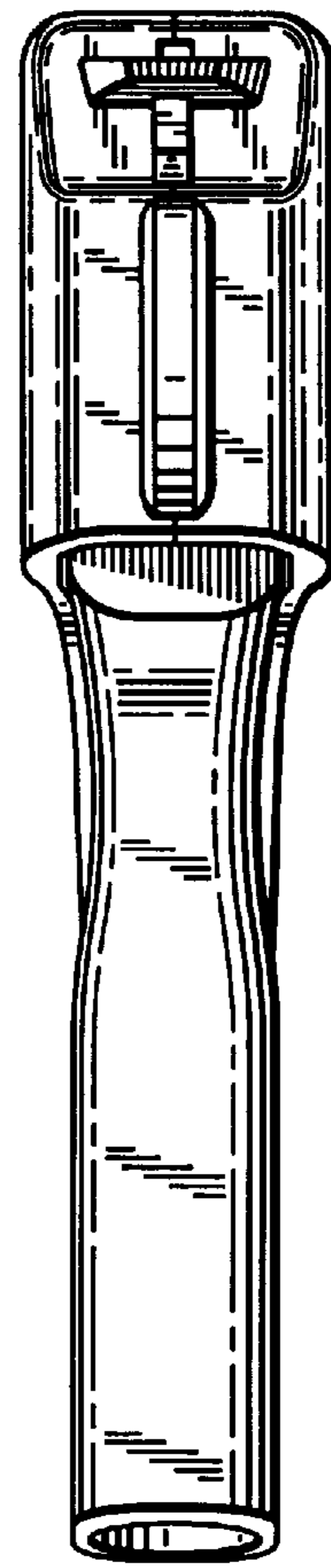
