I claim the ornamental design for a fluid dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a fluid dispenser;
FIG. 2 is a rear view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a front view of a fluid dispenser according to an alternative embodiment;
FIG. 8 is a rear view thereof;
FIG. 9 is a left side view thereof;
FIG. 10 is a right side view thereof;
FIG. 11 is a top view thereof; and,
FIG. 12 is a bottom view thereof.

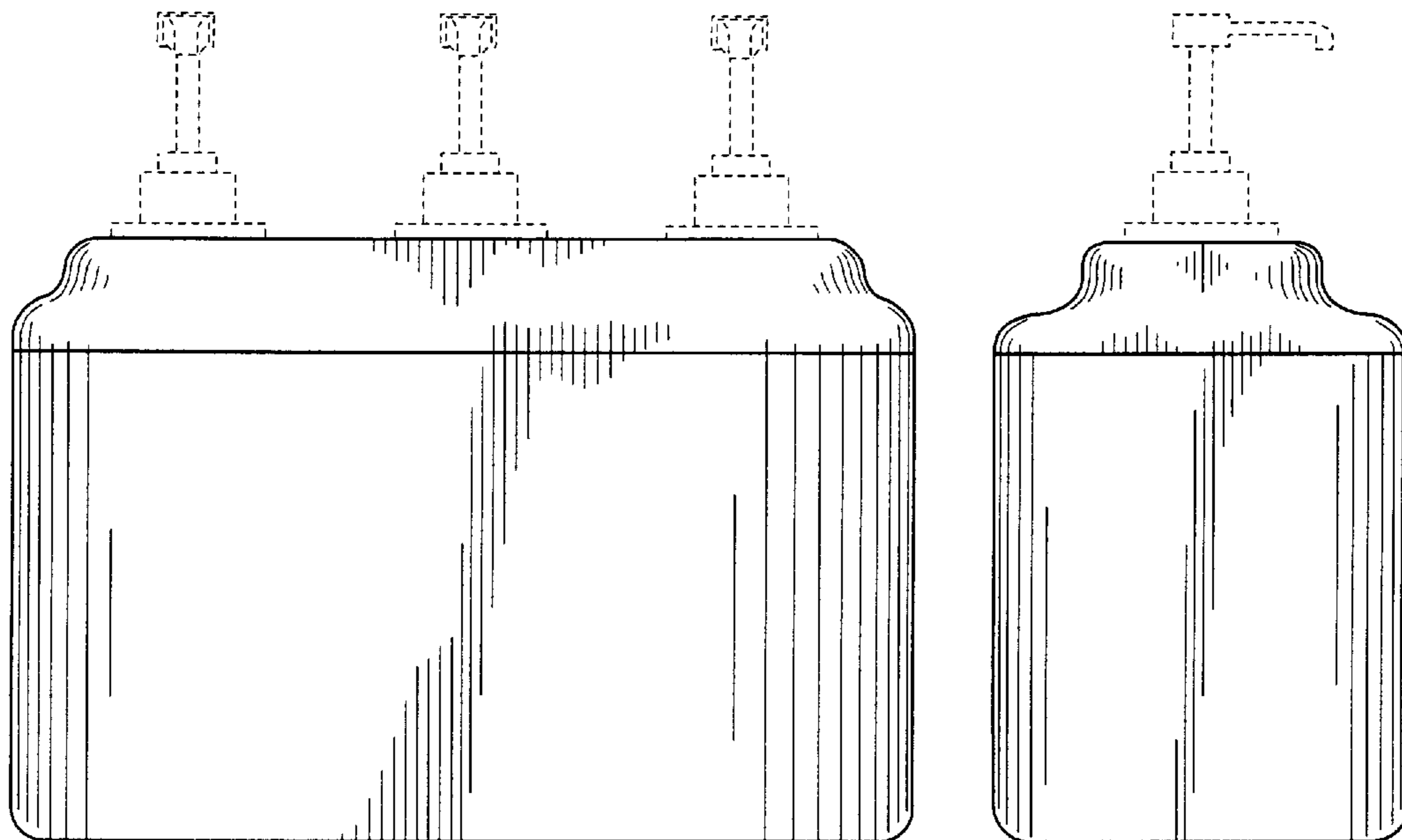

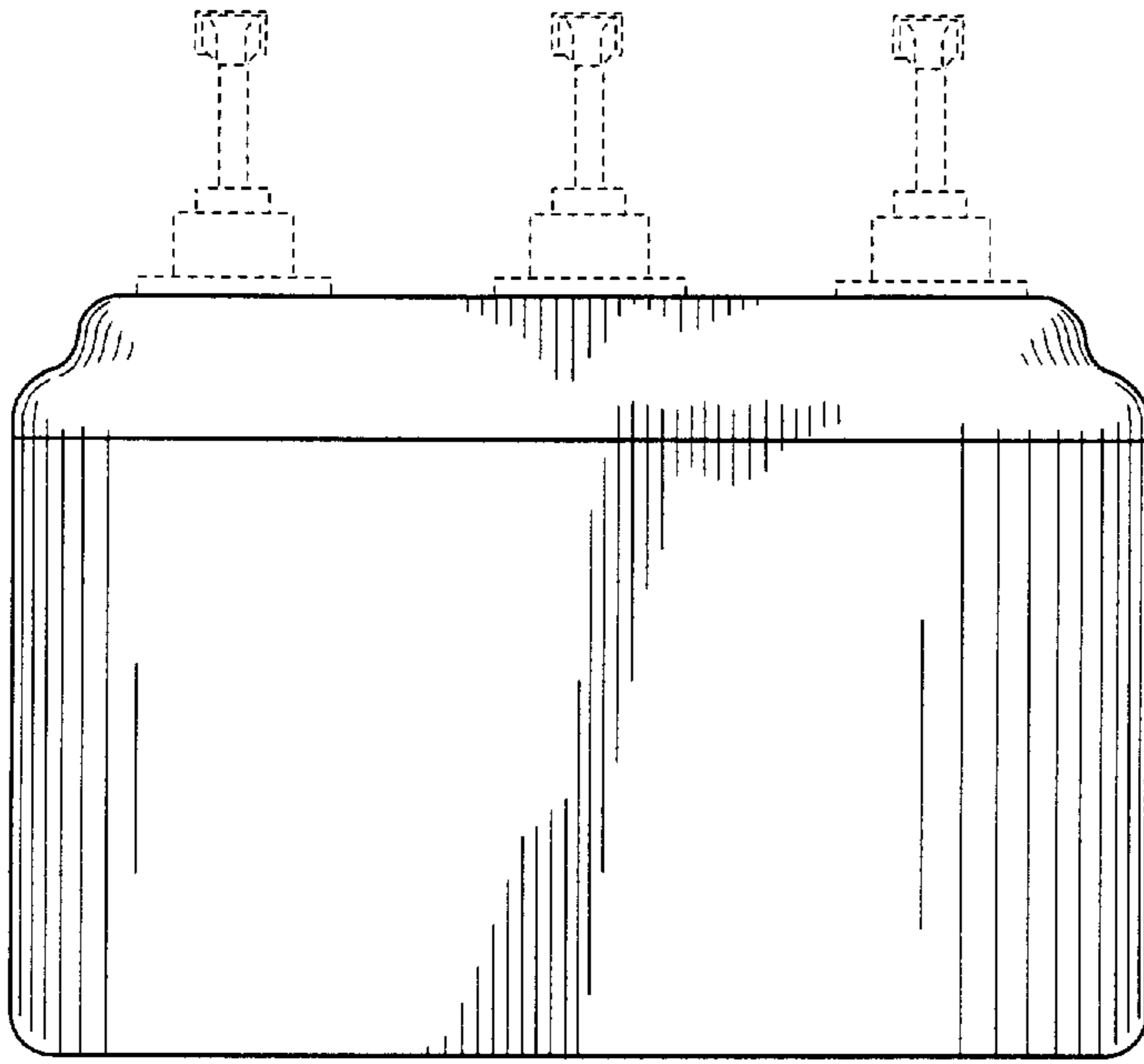

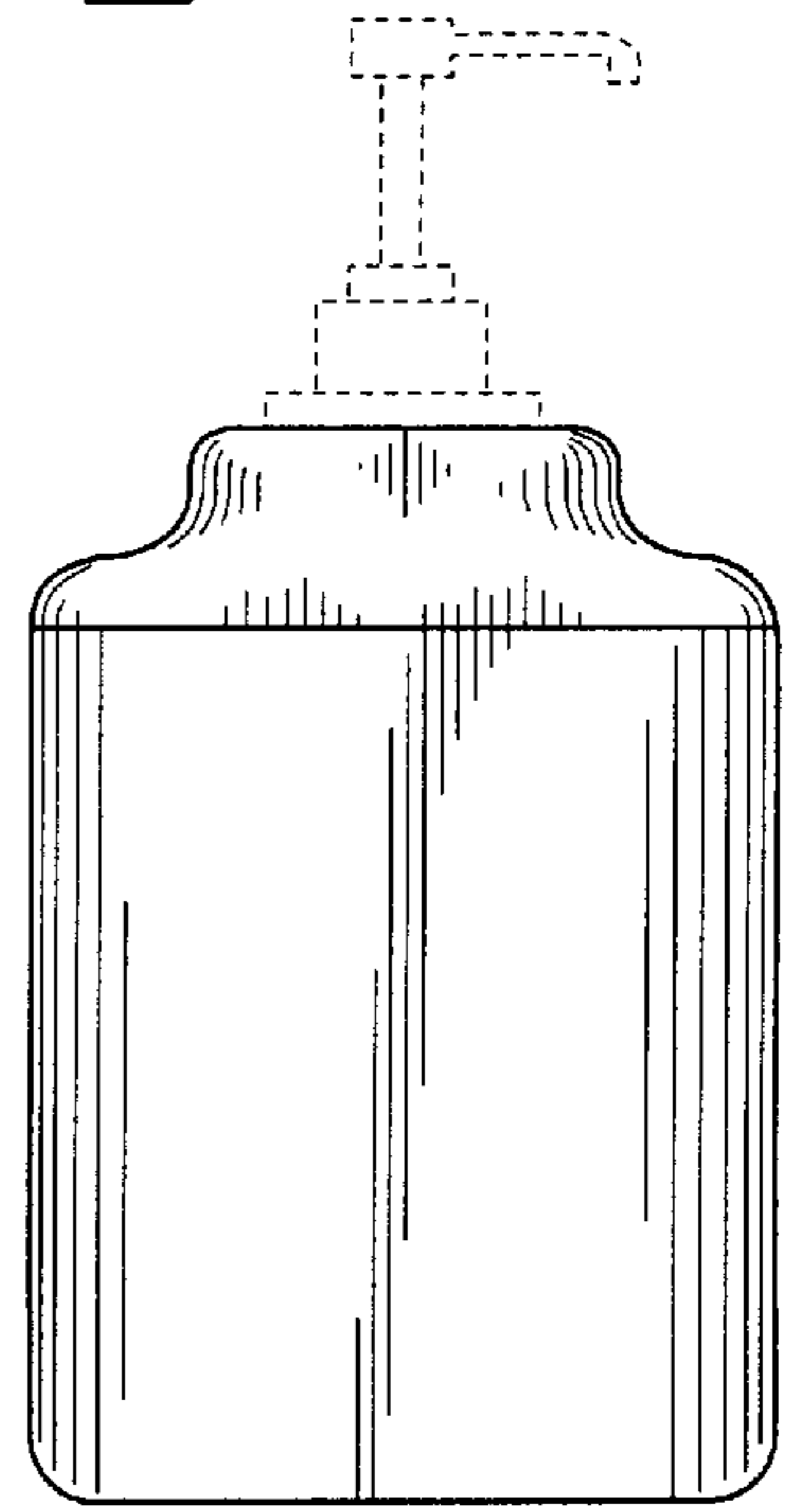

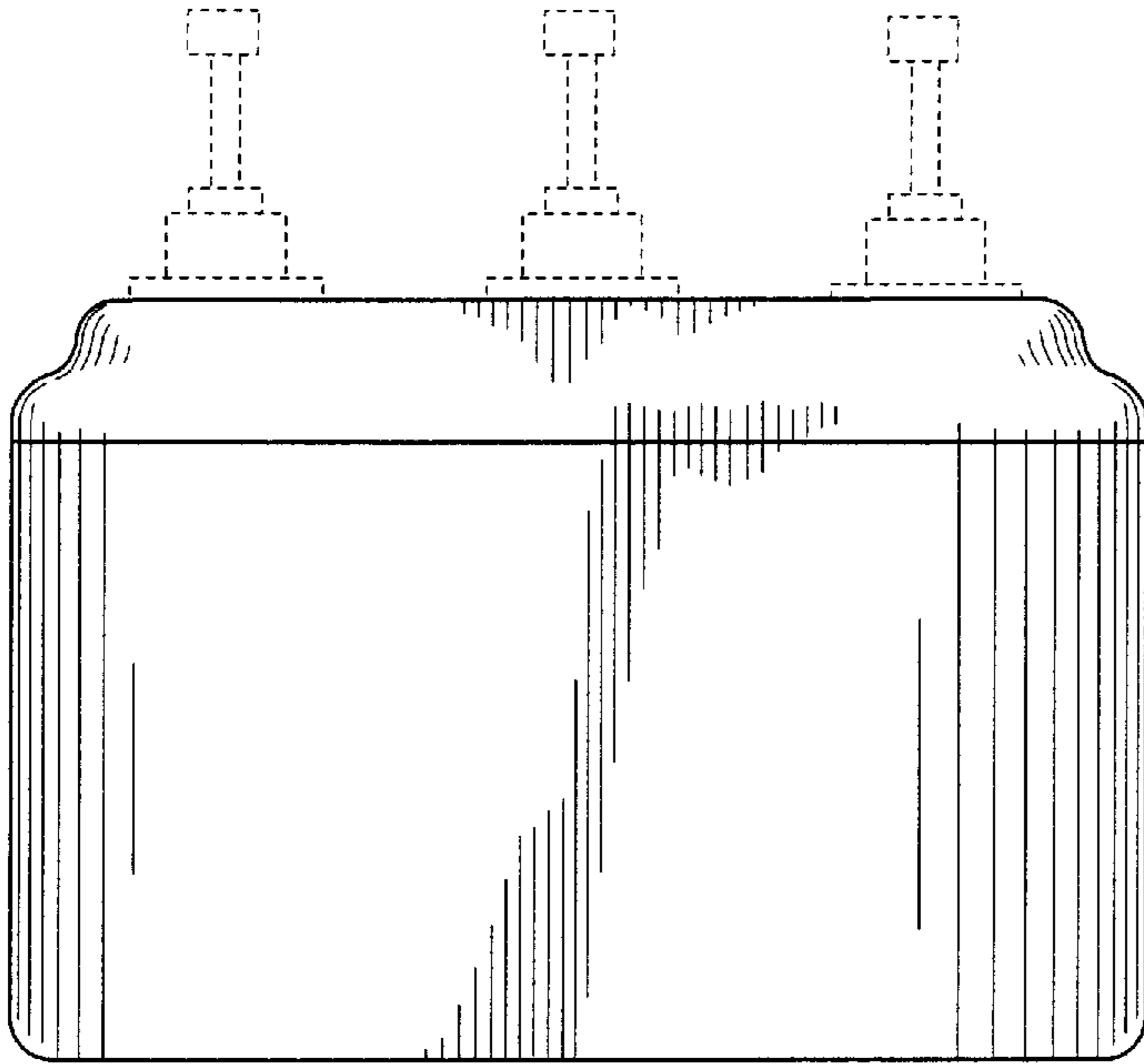

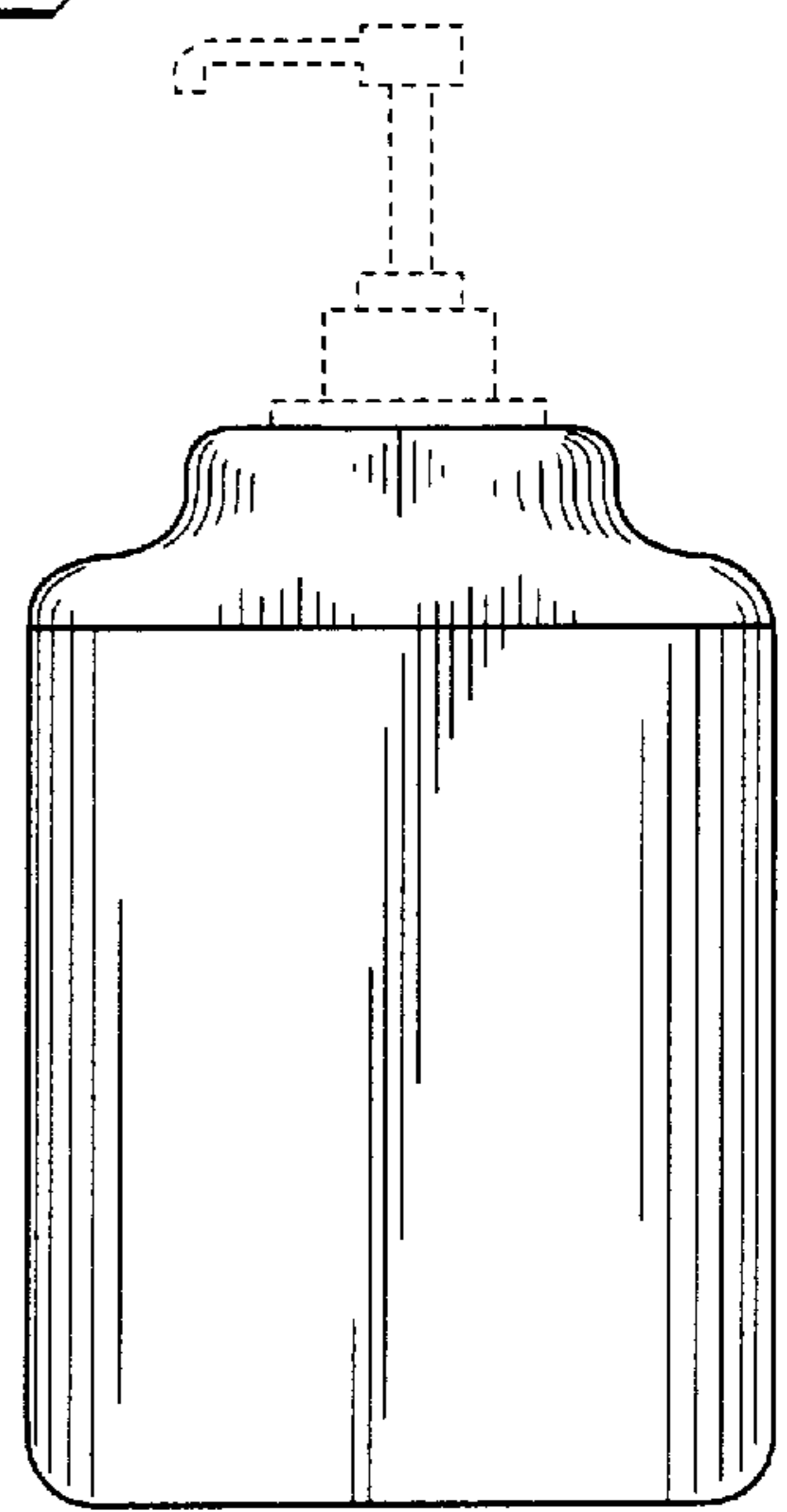

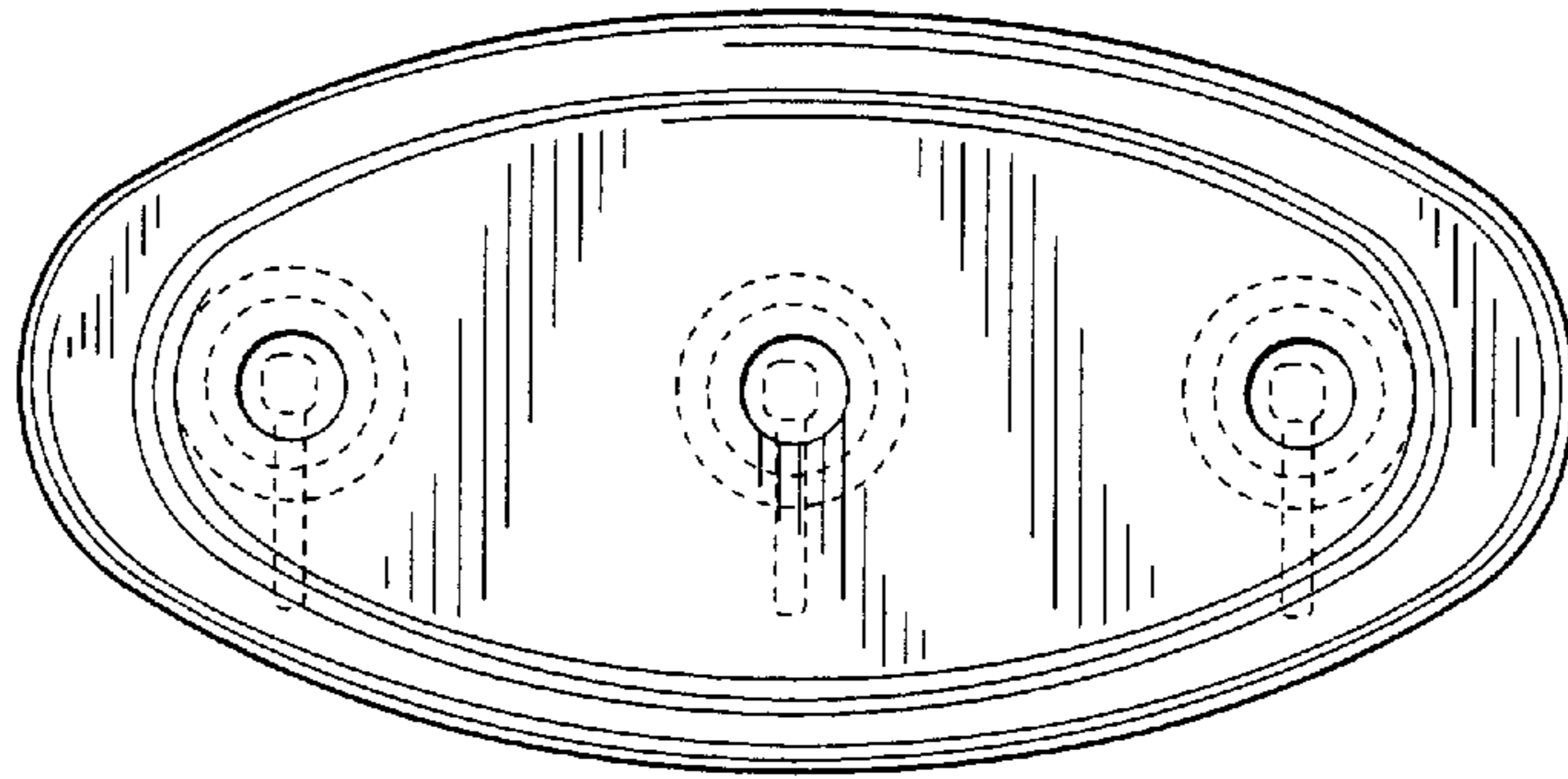

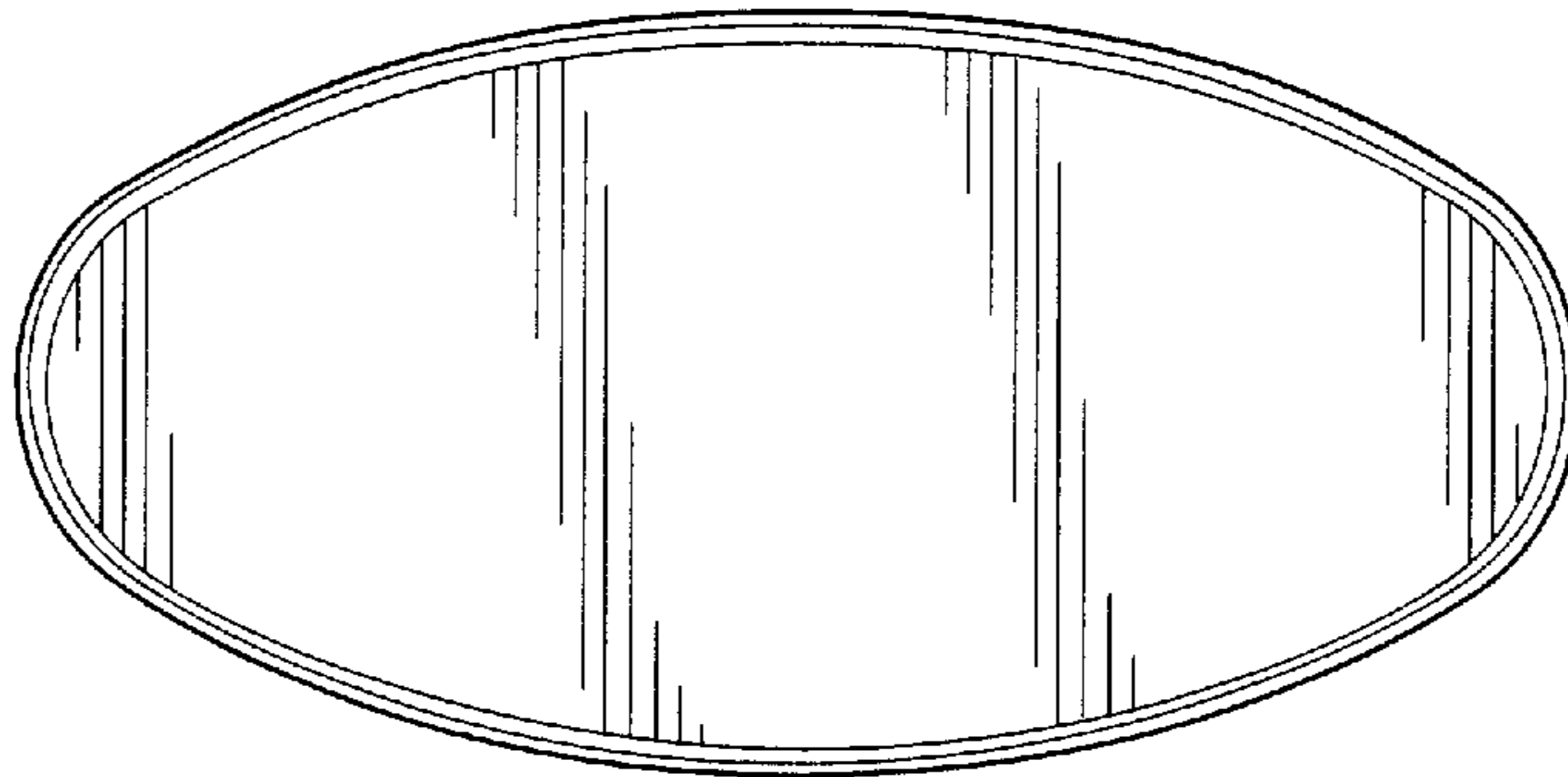

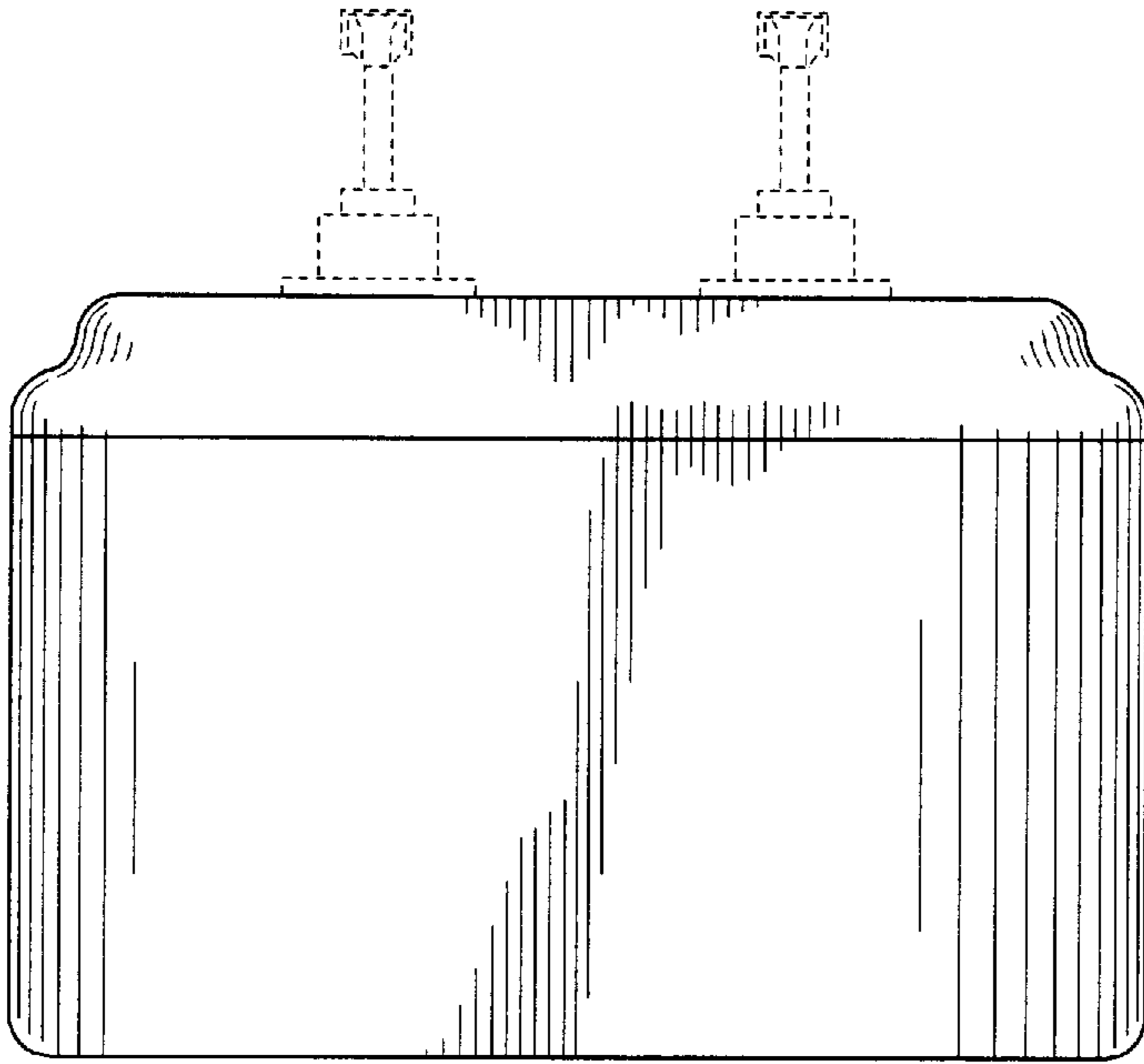

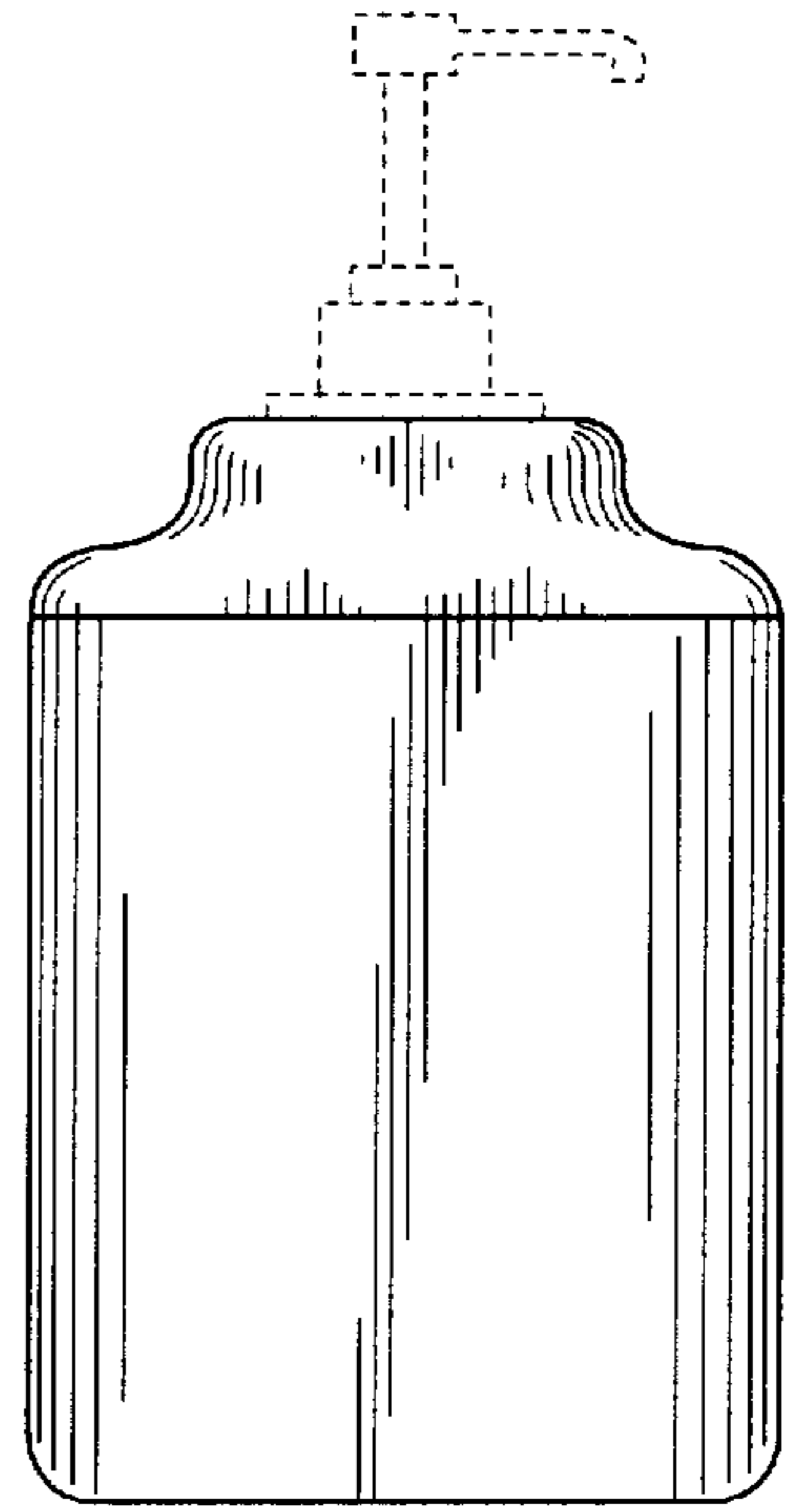

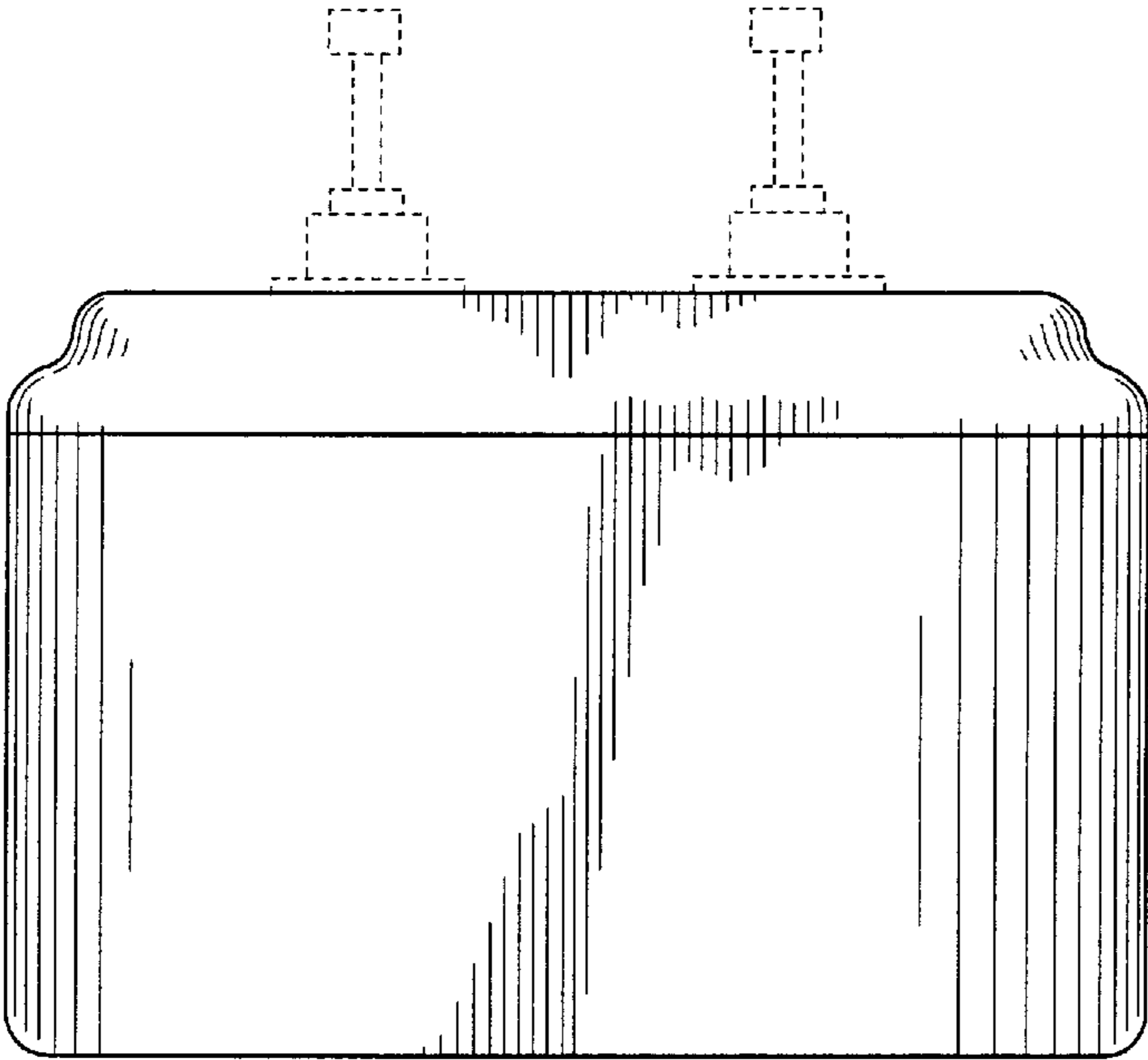

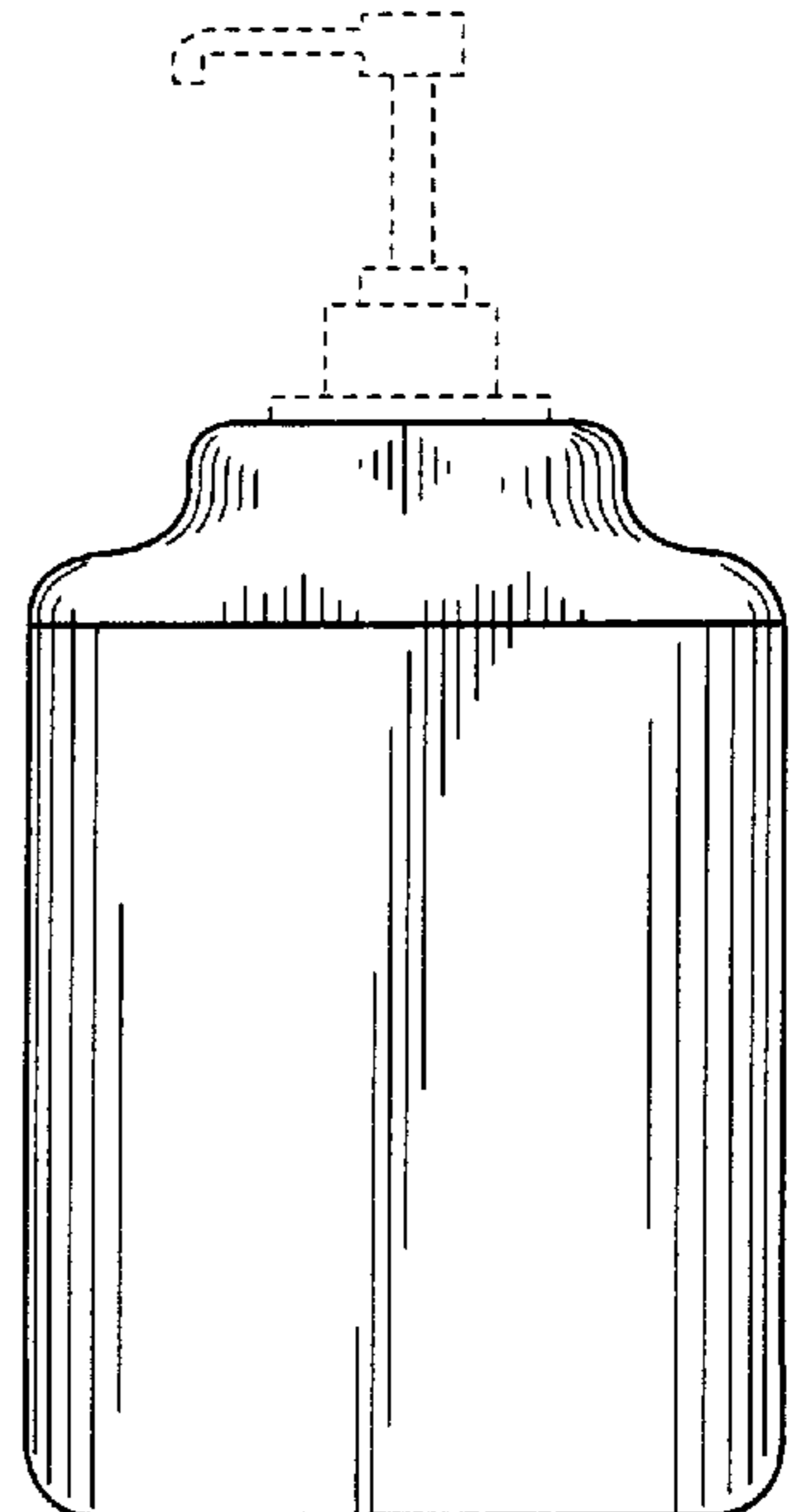

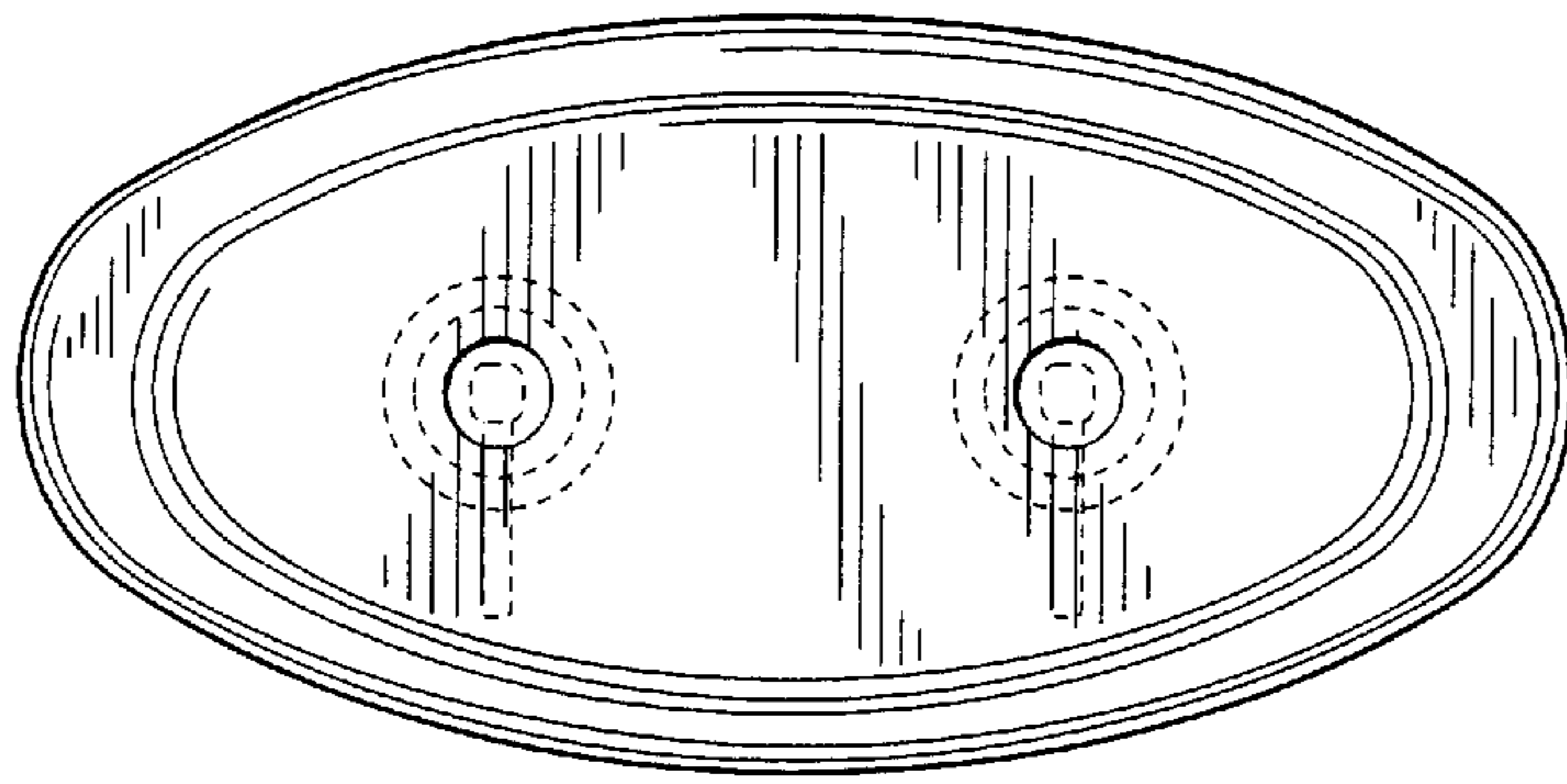
