The ornamental design for a running board, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a running board showing my new design;

FIG. 2 is a top plan view thereof, shown at an enlarged scale; FIG. 3 is a bottom plan view thereof, shown at an enlarged scale;

FIG. 4 is a front elevational view thereof, shown at an enlarged scale;

FIG. 5 is a rear elevational view thereof, shown at an enlarged scale;

FIG. 6 is a left side elevational view thereof, shown at an enlarged scale;

FIG. 7 is a right side elevational view thereof, shown at an enlarged scale;

FIG. 8 is a perspective view of a running board showing a second embodiment of my new design;

FIG. 9 is a top plan view of FIG. 8, shown at an enlarged scale;

FIG. 10 is a bottom plan view of FIG. 8, shown at an enlarged scale;

FIG. 11 is a front elevational view of FIG. 8, shown at an enlarged scale;

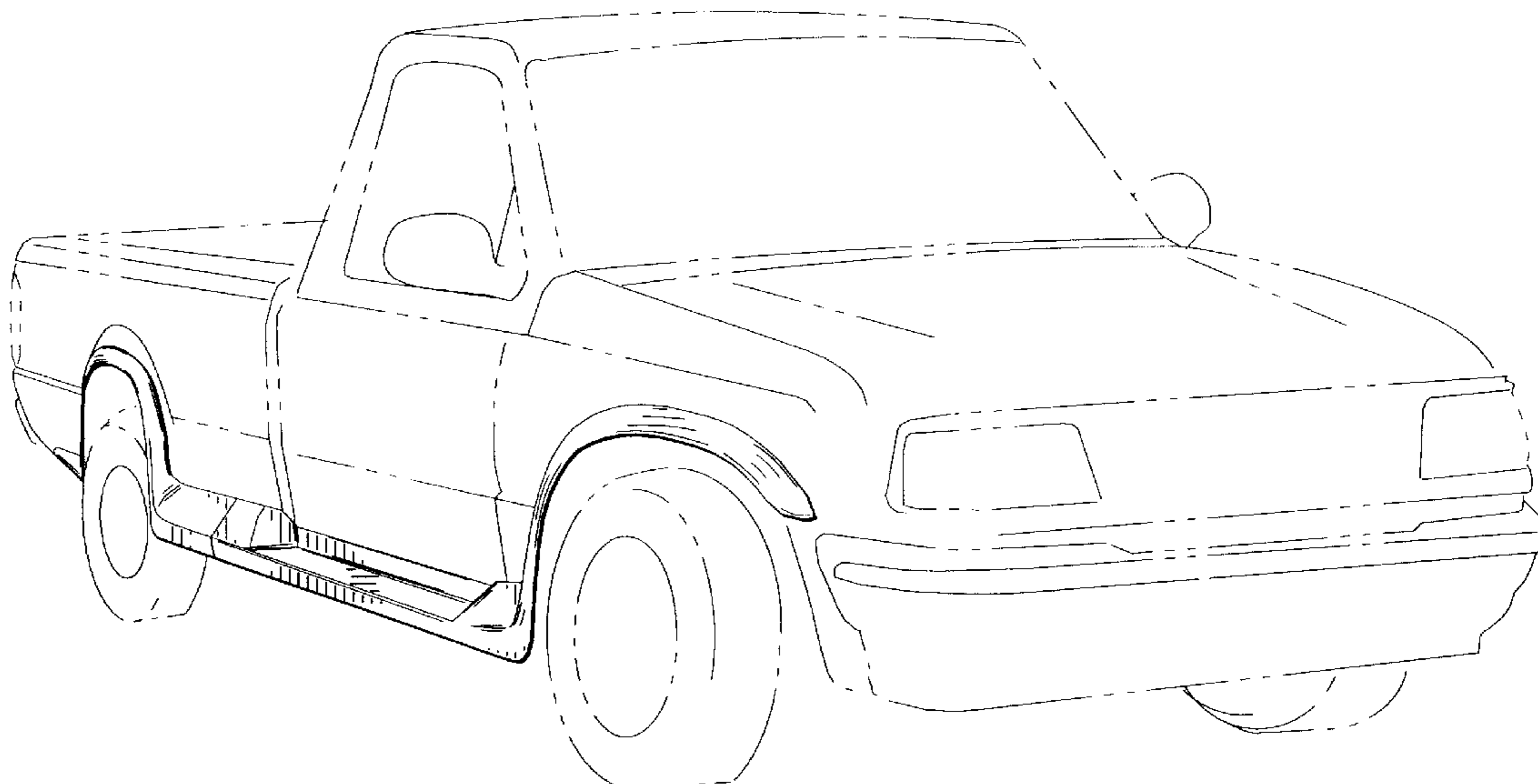
FIG. 12 is a rear elevational view of FIG. 8, shown at an enlarged scale;

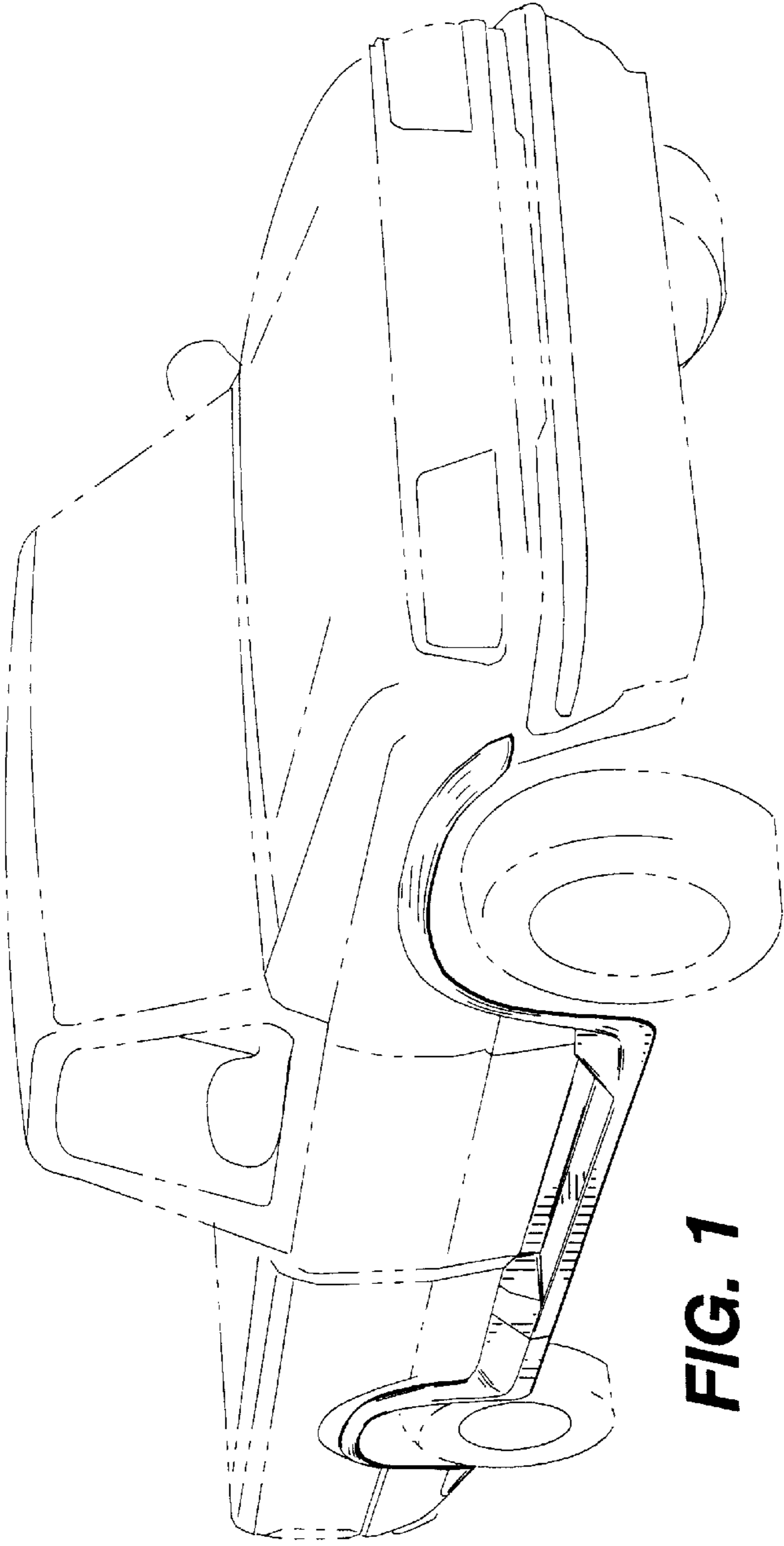
FIG. 13 is a left side elevational view of FIG. 8, shown at an enlarged scale; and,

FIG. 14 is a right side elevational view of FIG. 9, shown at an enlarged scale.

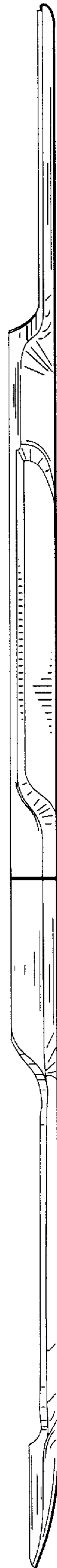
The broken lines shown in FIGS. 1, 6, 7, 8, 13 and 14 are for illustrative purposes only and form no part of the claimed design.

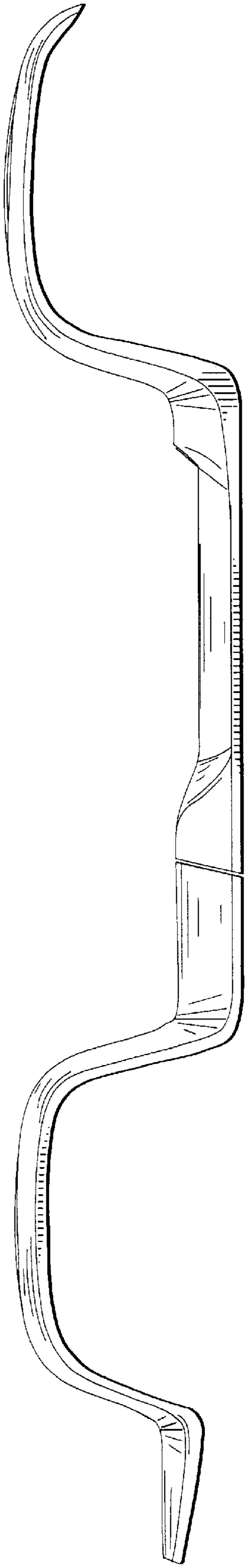

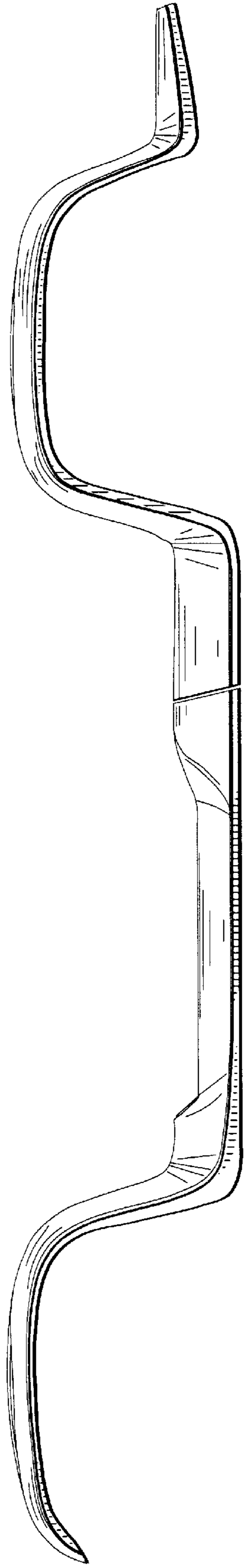

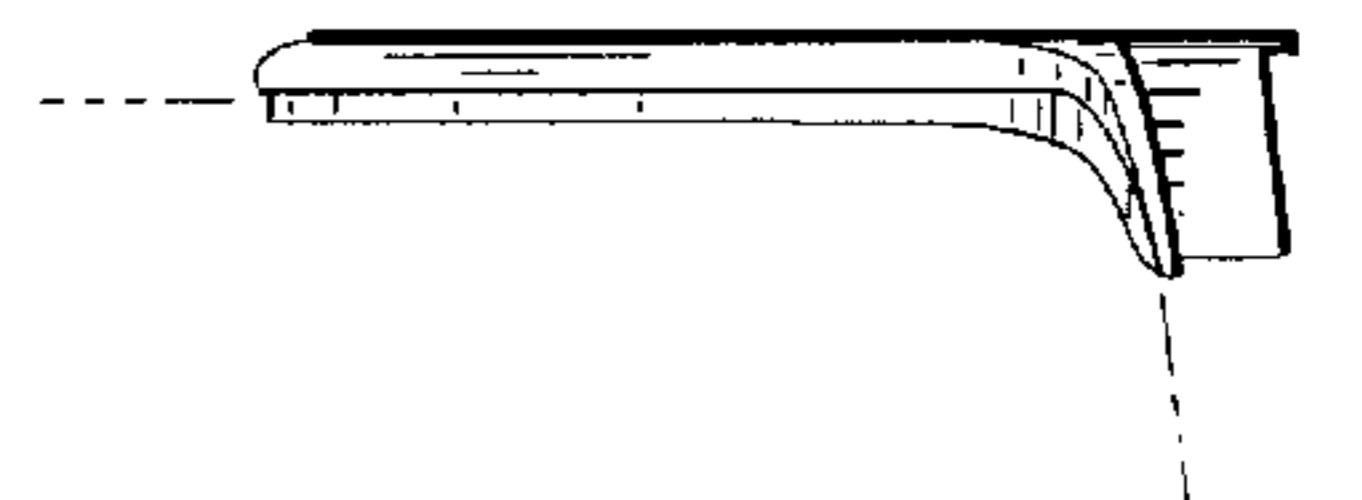

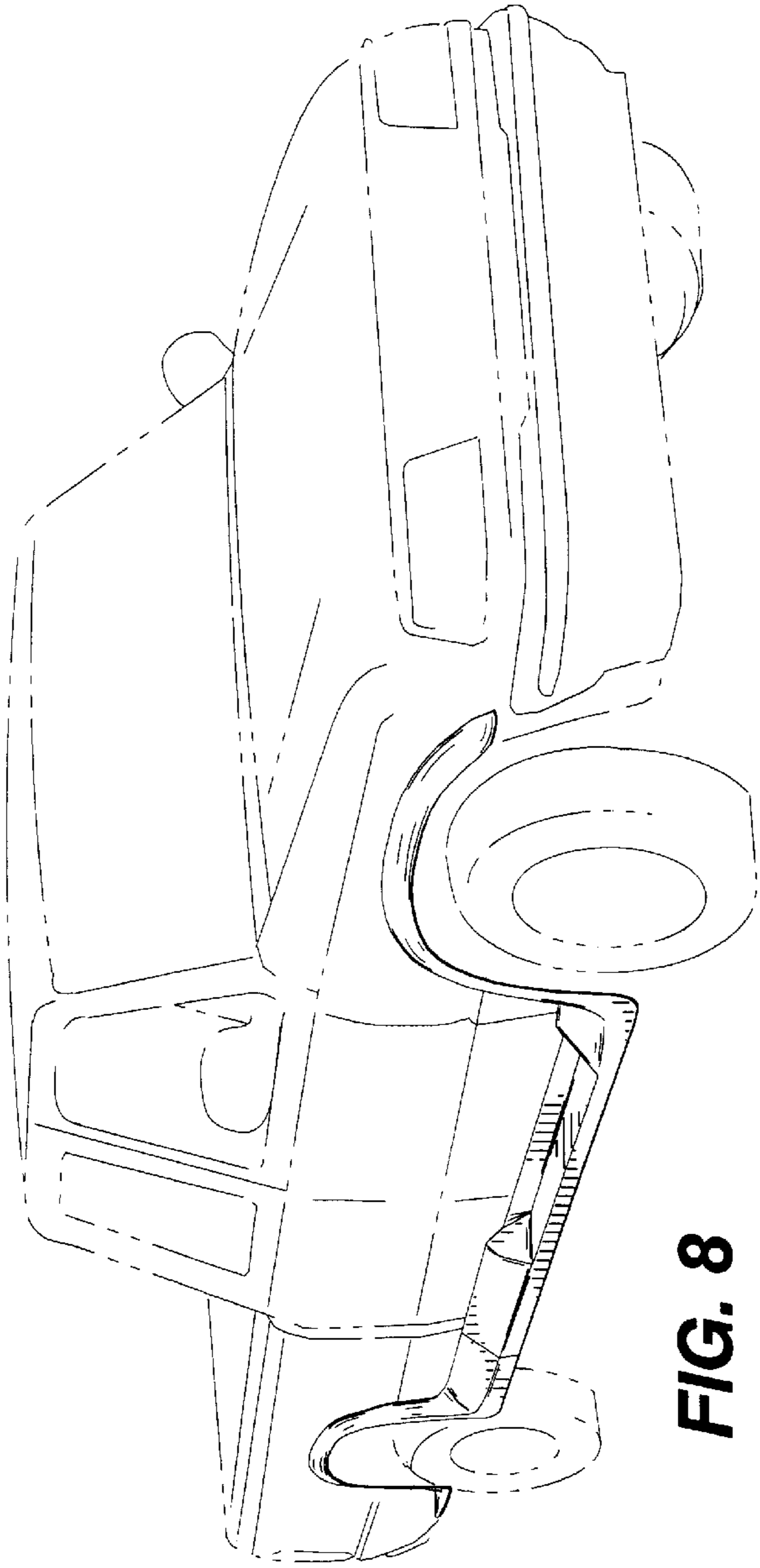

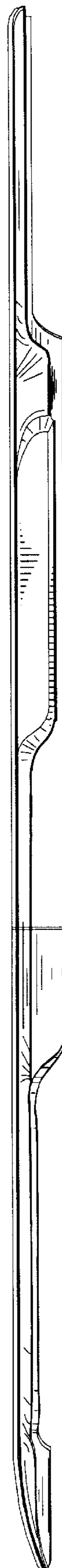

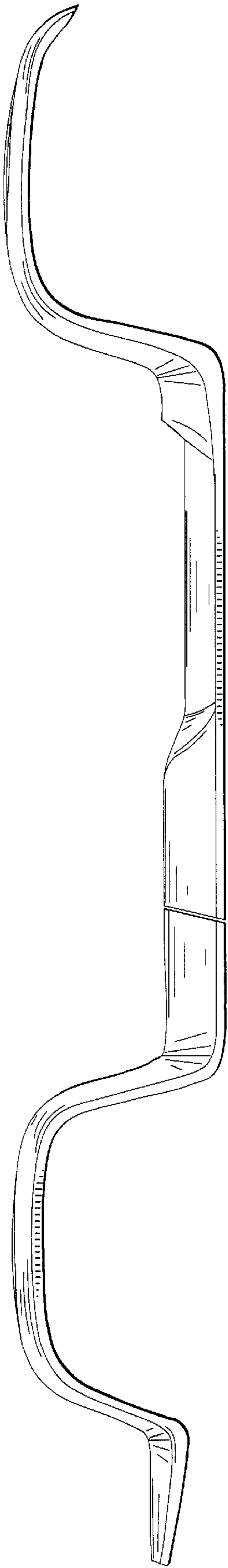

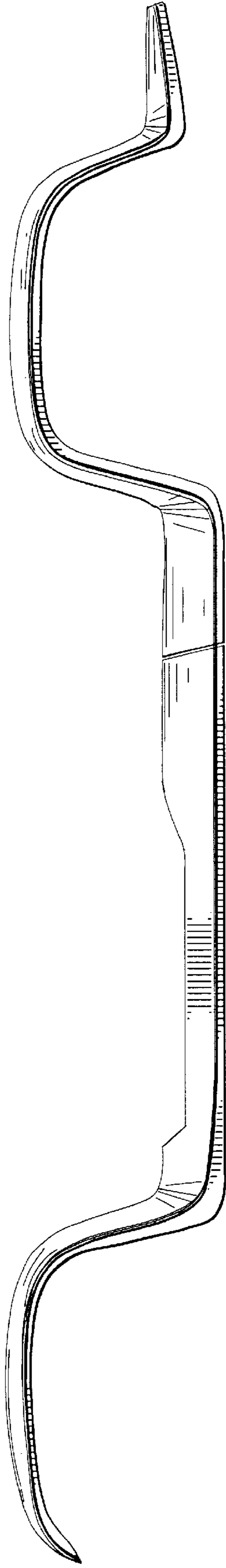

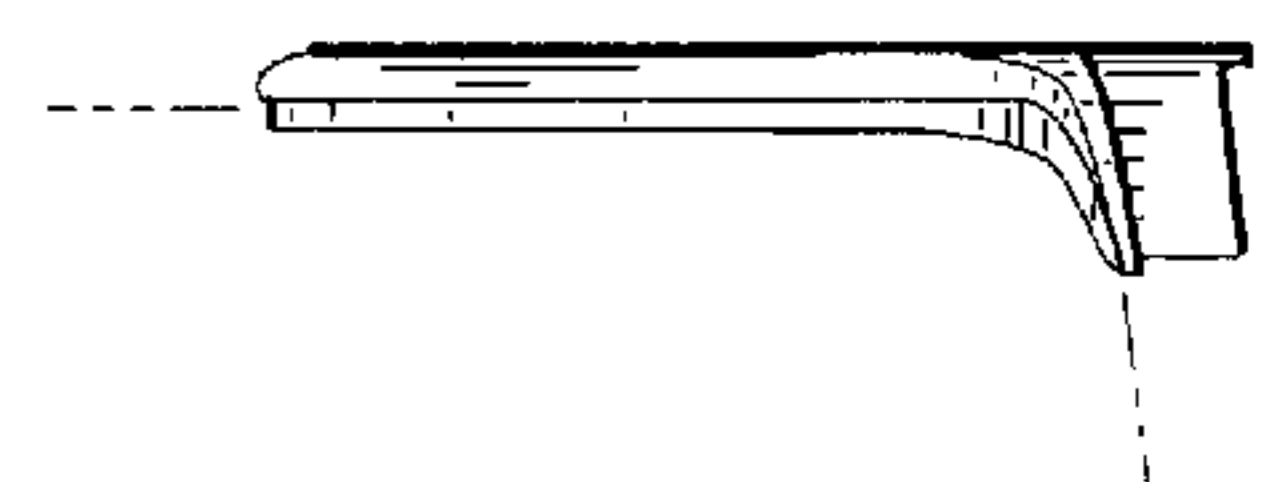
