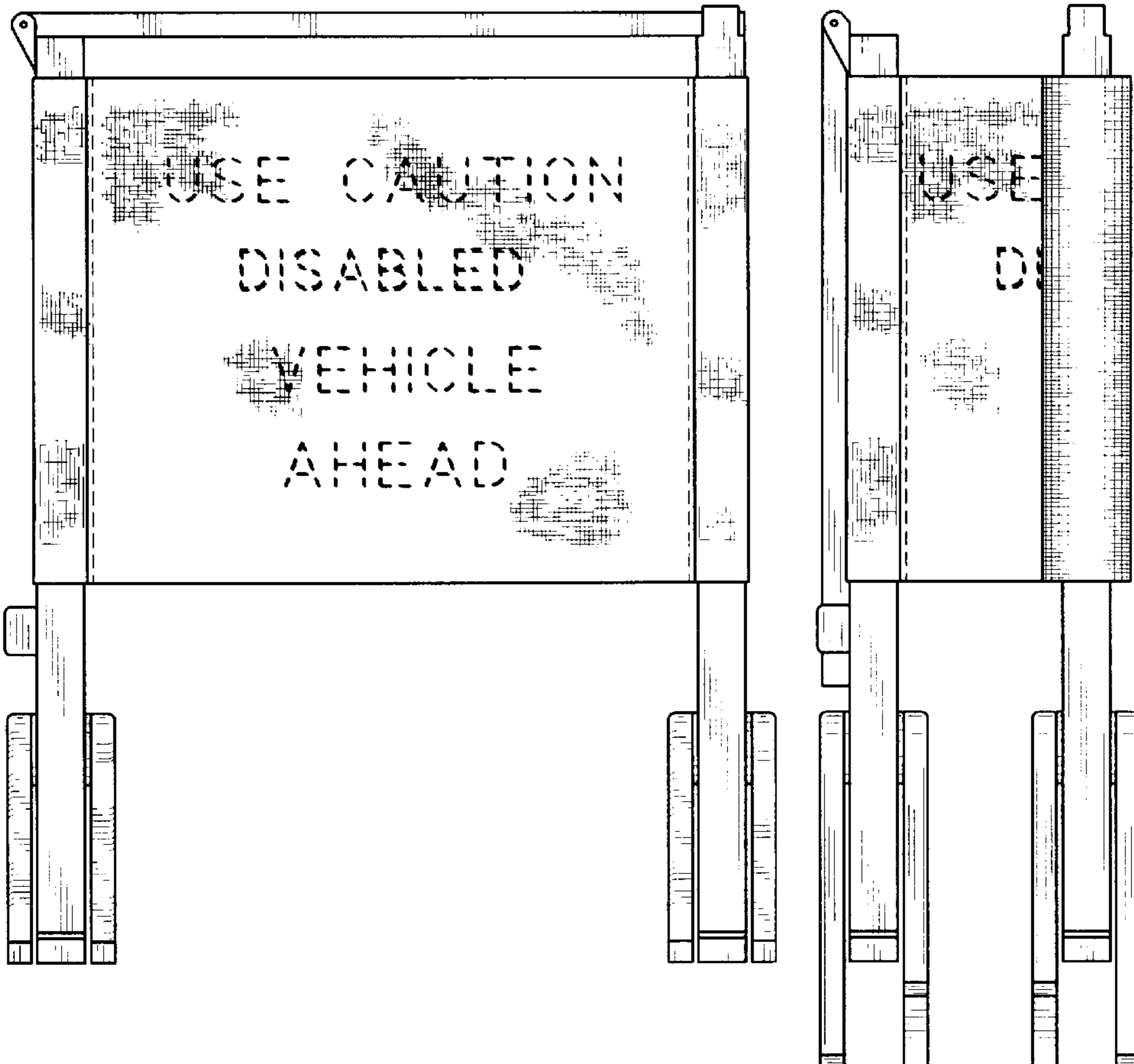
[57] **CLAIM**

The ornamental design for an emergency roadside sign, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of the emergency roadside sign of the present invention;  
 FIG. 2 is a back elevation view of the emergency roadside sign of FIG. 1;  
 FIG. 3 is a left side elevation view of the emergency roadside sign of FIG. 1;  
 FIG. 4 is a right side elevation view of the emergency roadside sign of FIG. 1;  
 FIG. 5 is a top plan view of the emergency roadside sign of FIG. 1;  
 FIG. 6 is a bottom plan view of the emergency roadside sign of FIG. 1; and,  
 FIG. 7 is a front elevation view of the emergency roadside sign of FIG. 1 in a collapsed condition; and,  
 FIG. 8 is a left side elevation view of the emergency roadside sign of FIG. 1 in a collapsed condition; and,  
 FIG. 9 is a right side elevation view of the emergency roadside sign of FIG. 1 in a collapsed condition.  
 The crosshatching is fragmentarily shown for convenience of illustration.  
 The broken lines are shown for illustrative purposes only and form no part of the claimed design.

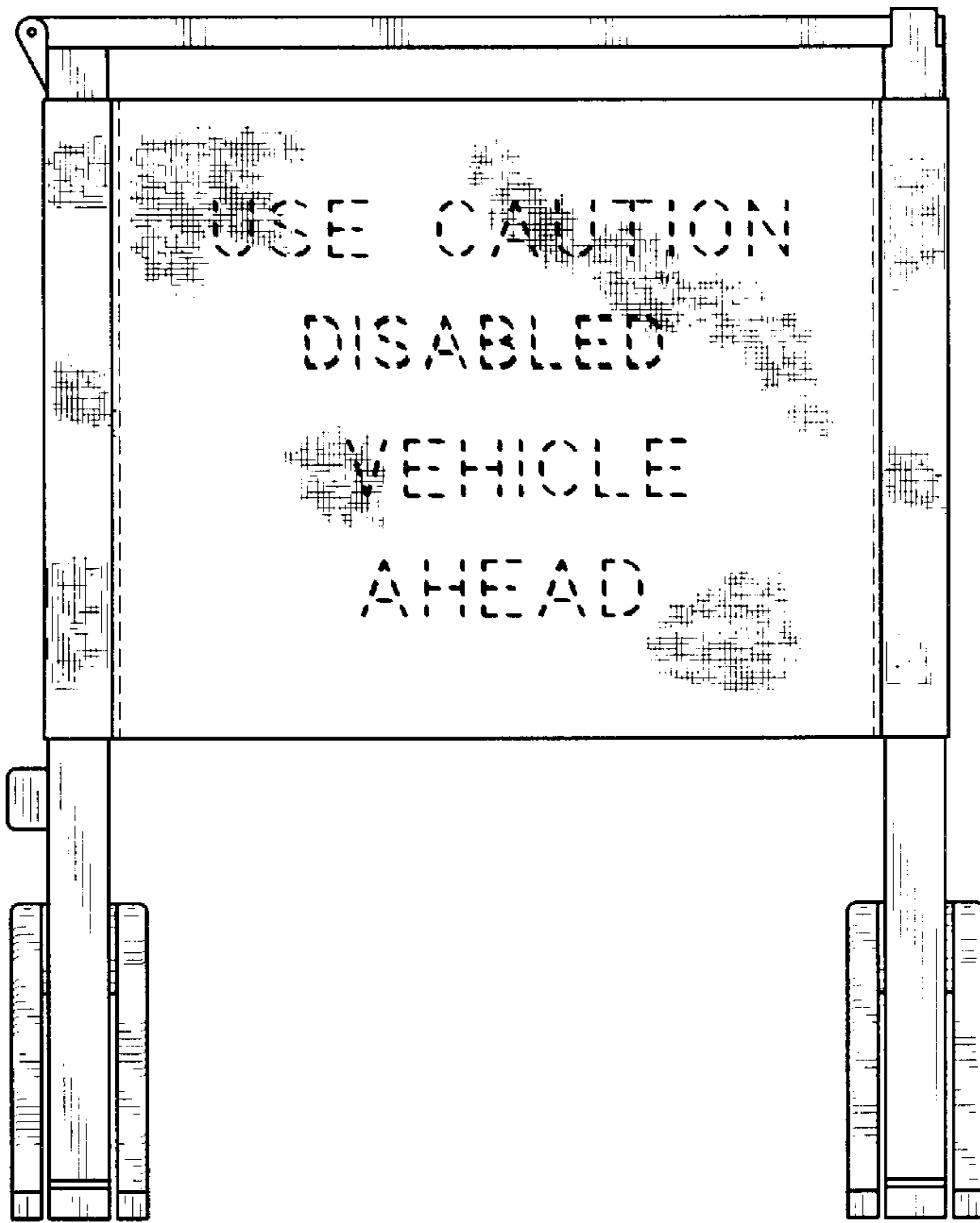

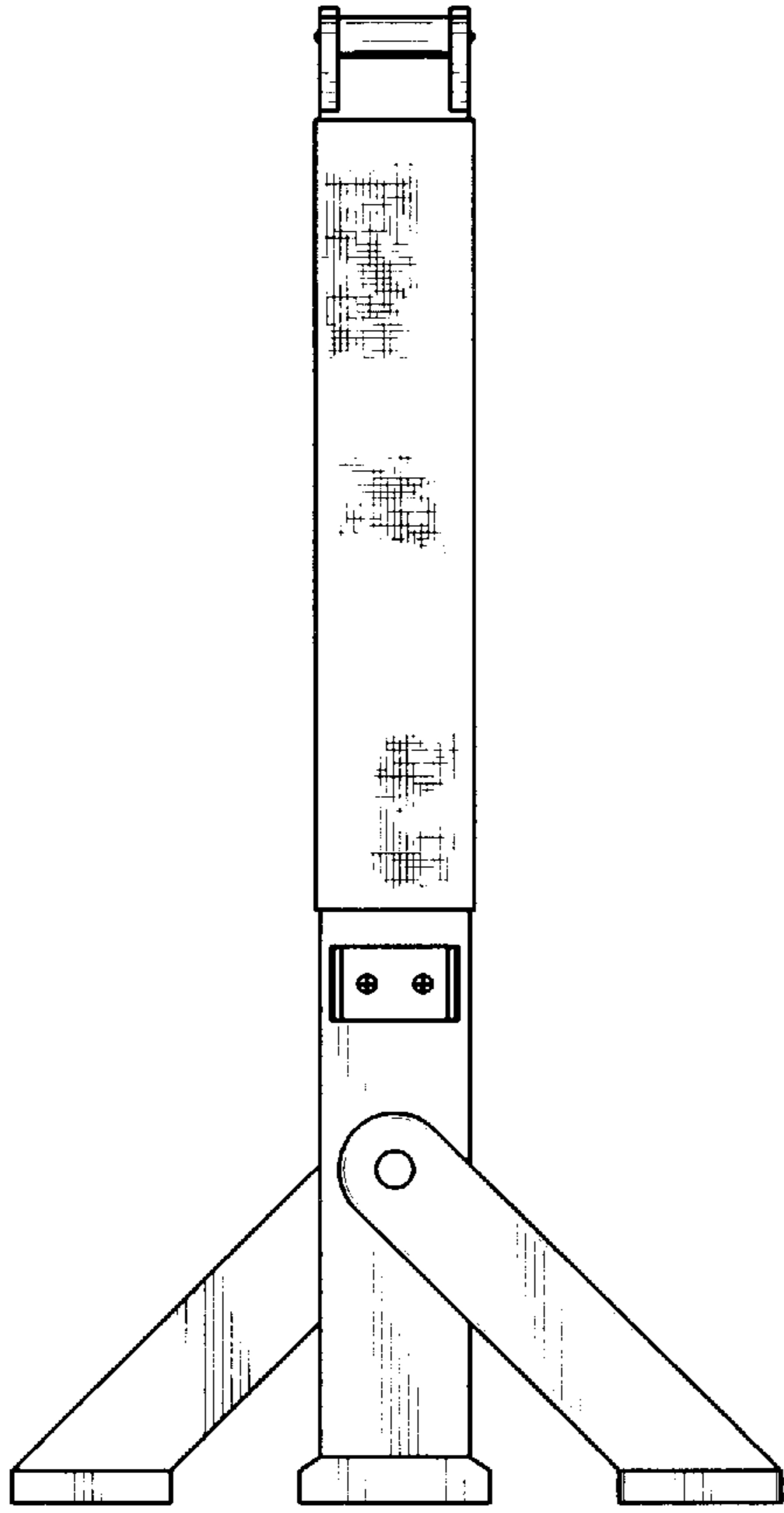

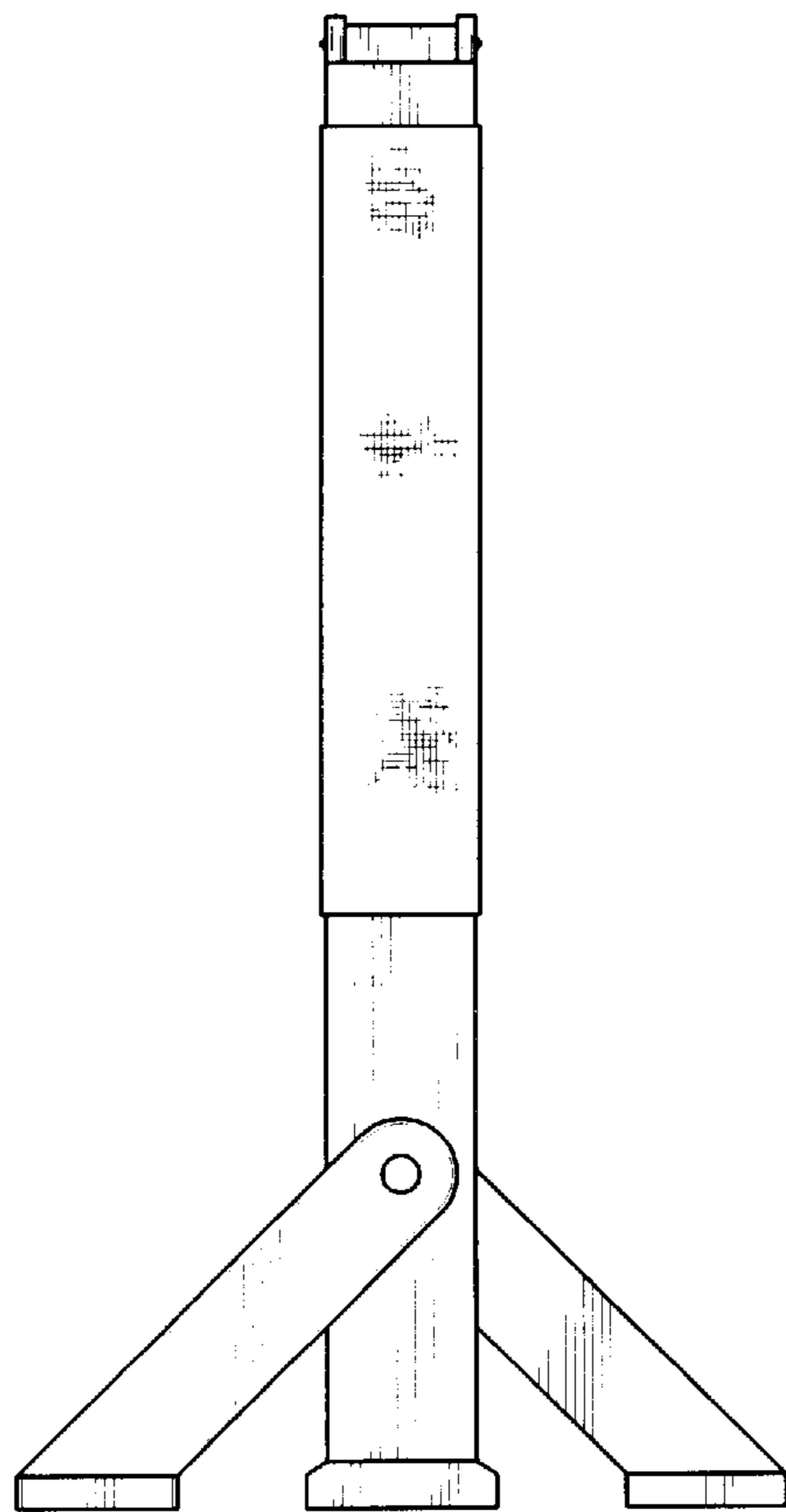

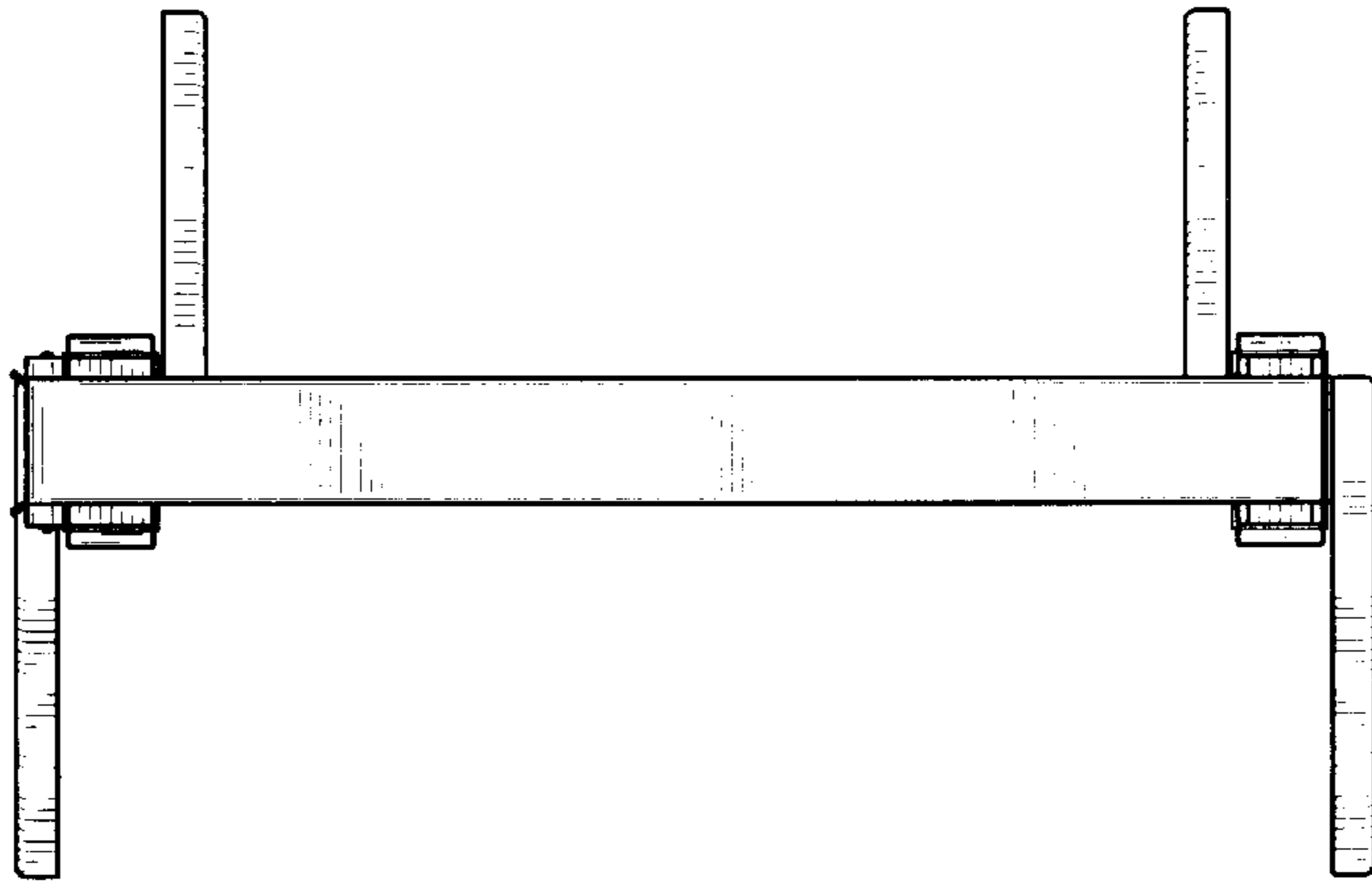

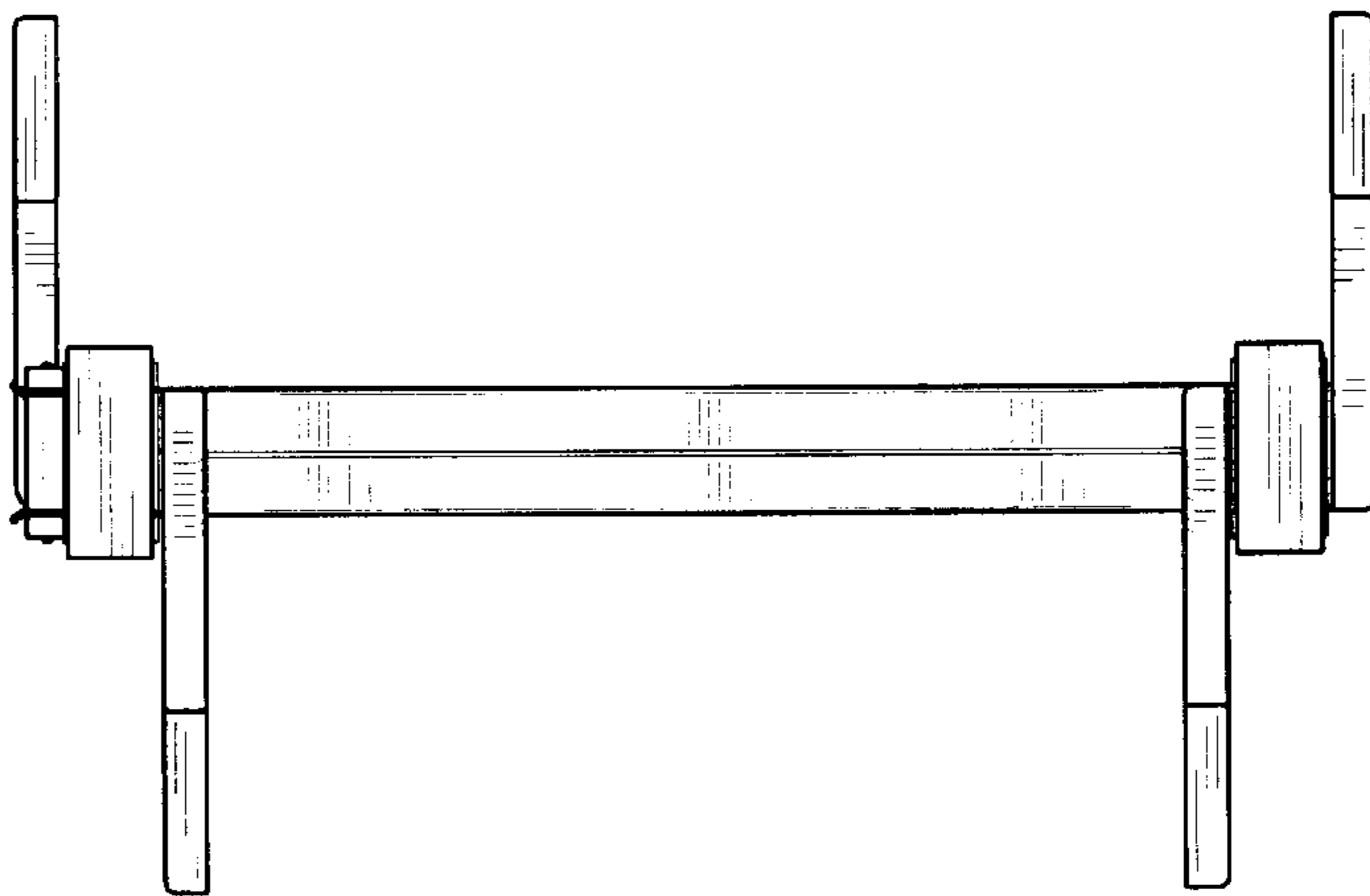

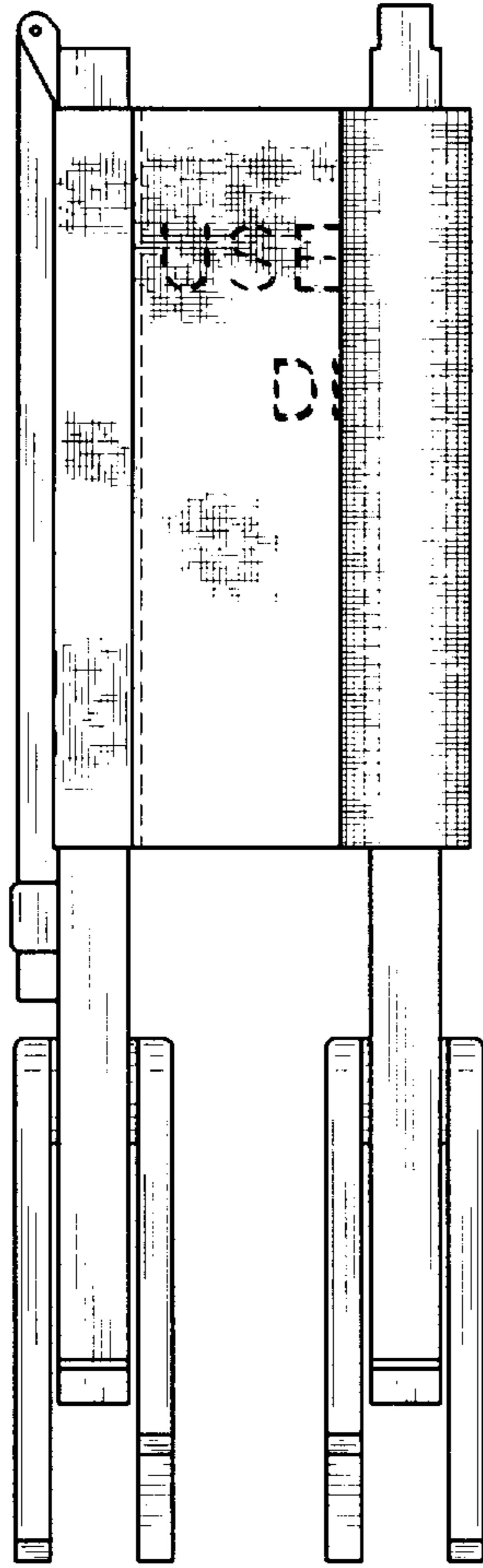

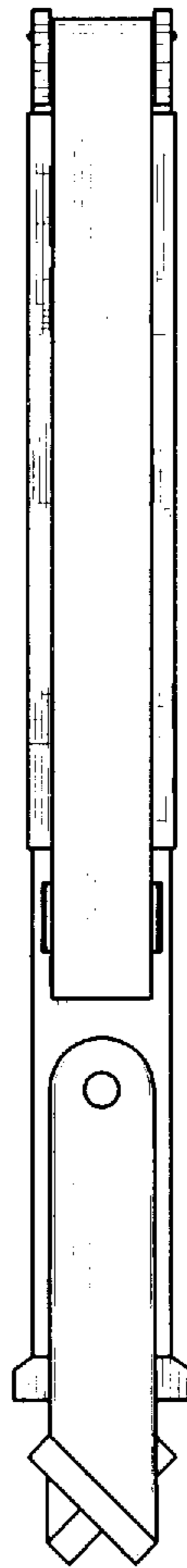

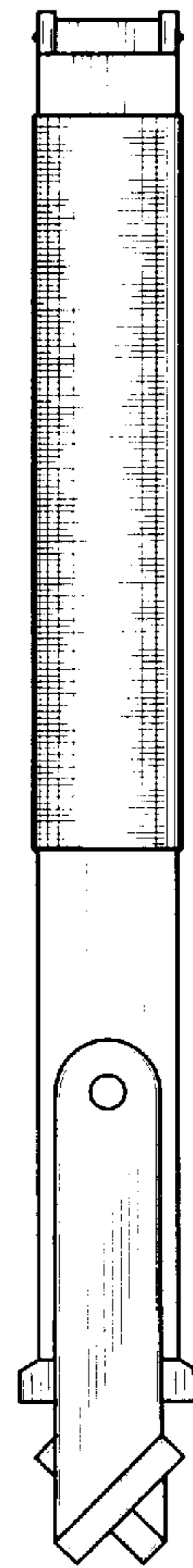
