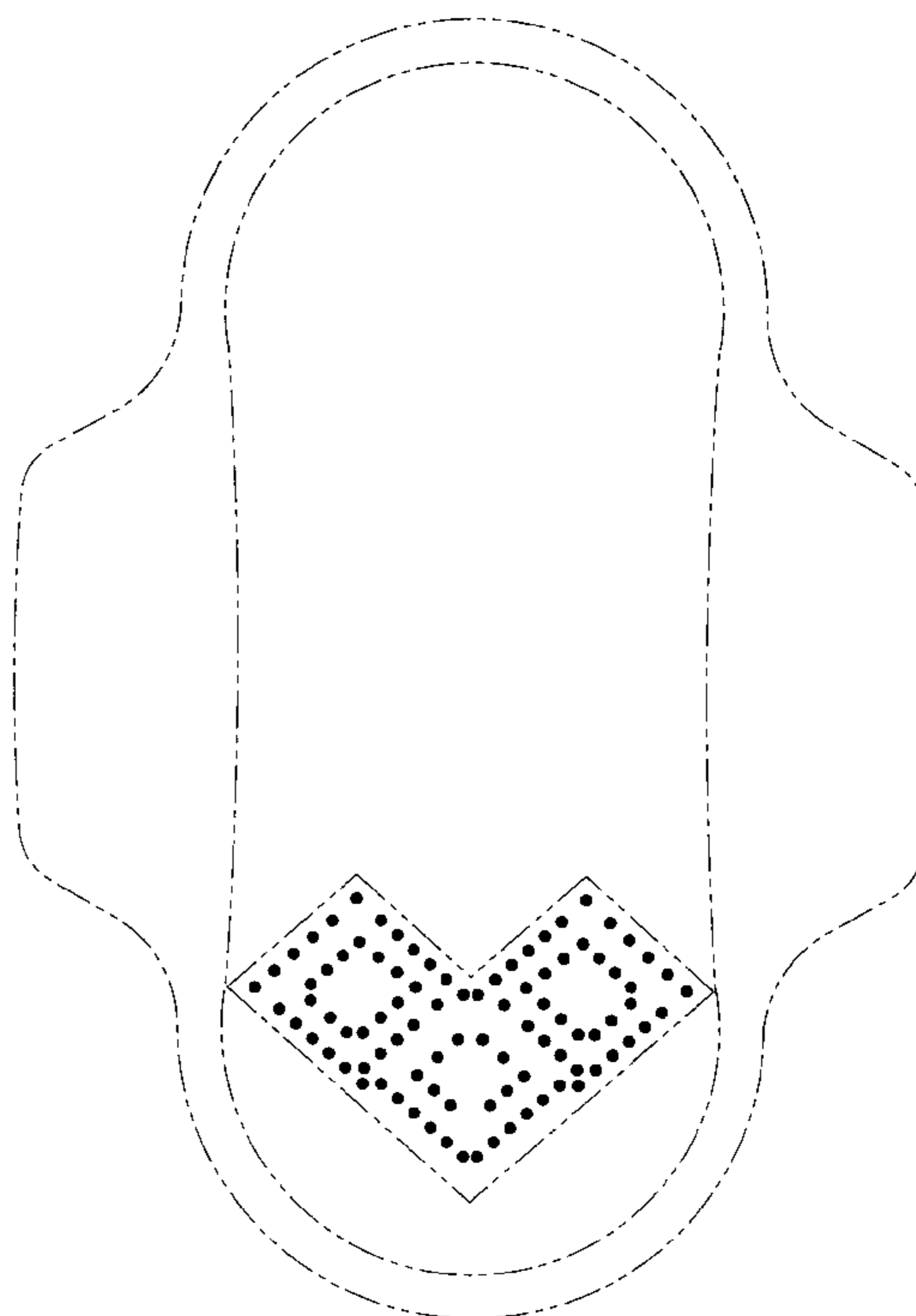
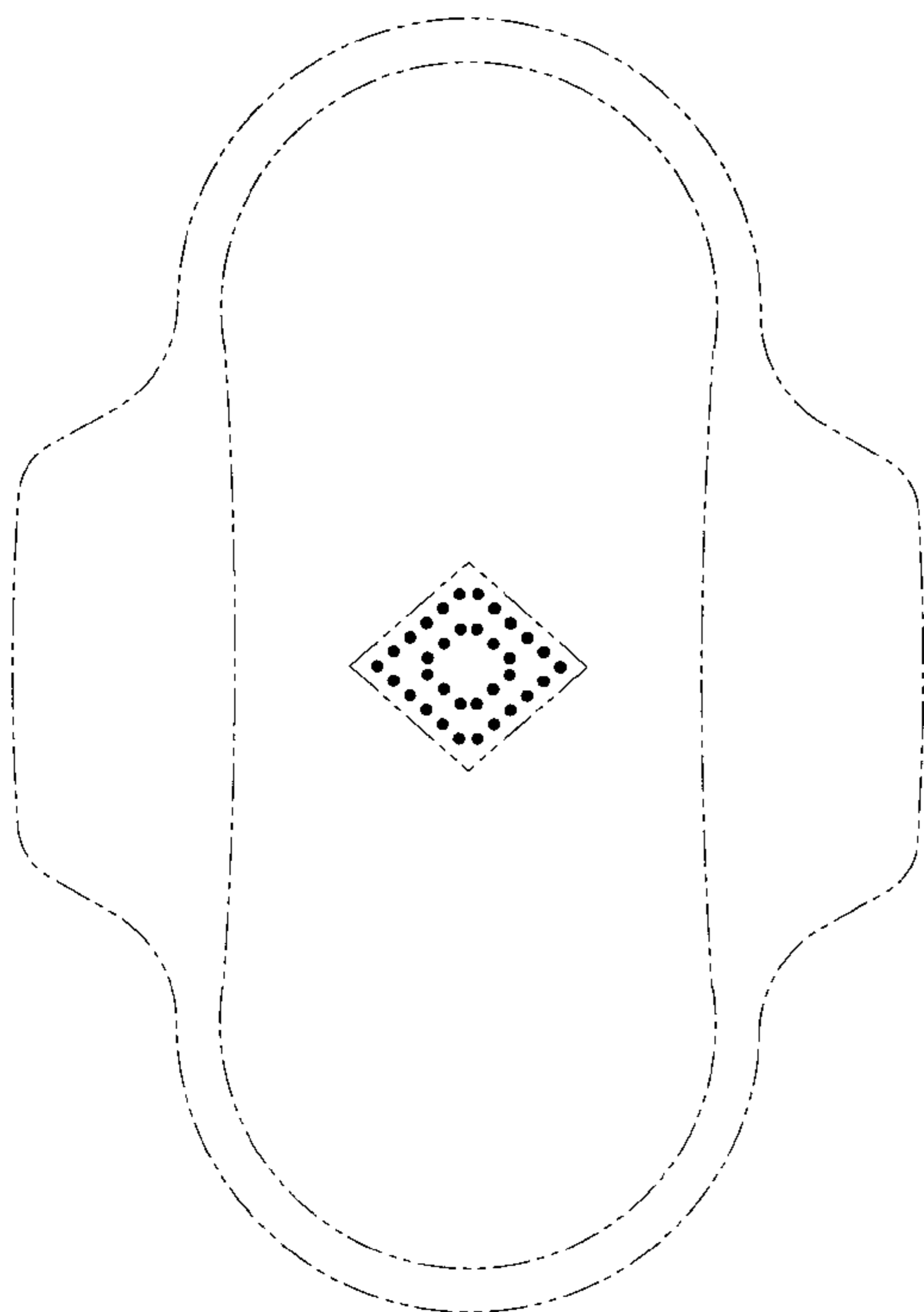
### [57] **CLAIM**

The ornamental design for a surface pattern for disposable absorbent article, as shown and described.

### **DESCRIPTION**

FIG. 1 is a top plan view of a surface pattern for disposable absorbent article, showing our new design; and, FIG. 2 is a top plan view of second embodiment of the surface pattern for disposable absorbent article, showing a portion of a repeating pattern thereon. The broken lines shown along the borders of the figures depict the boundaries of the repeat units of the design. The broken line showing of the disposable absorbent article is for illustrative purposes only and forms no part of the claimed design.

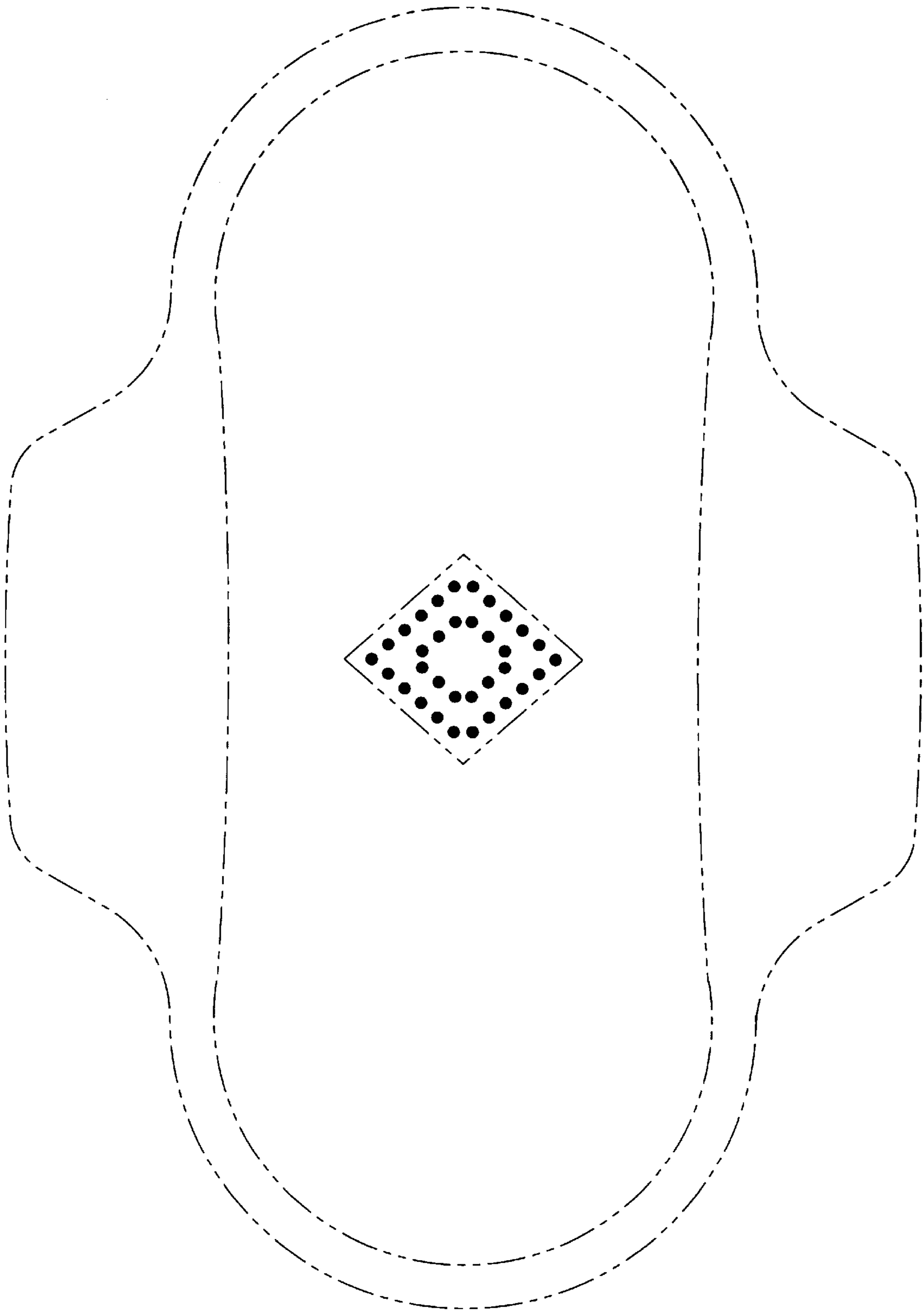

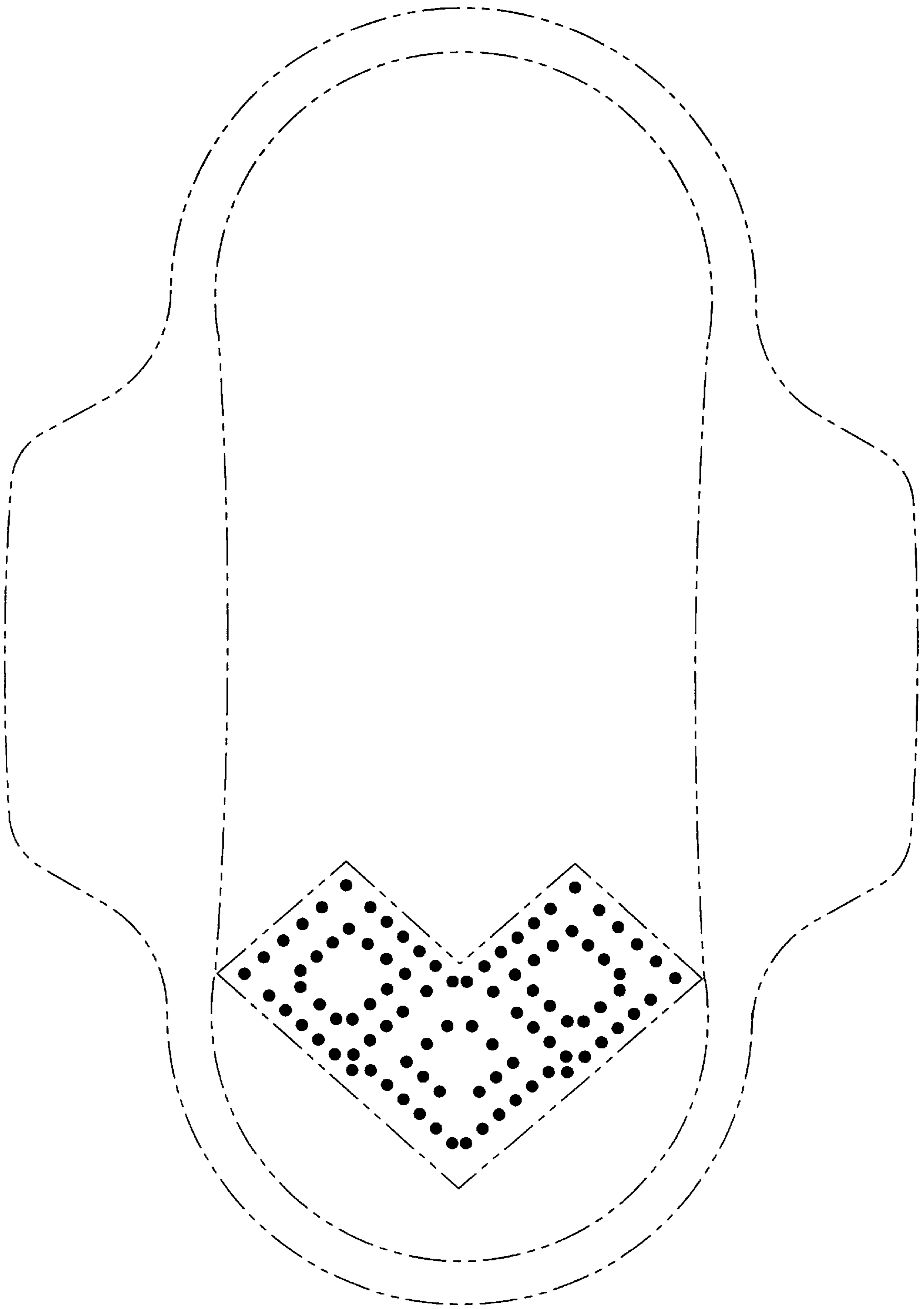
