[57] **CLAIM**

A new original design for diaper cover for absorbent pad insert, as shown and described herein.

DESCRIPTION

FIG. 1 is a perspective view of a diaper cover for absorbent pad insert, showing one embodiment of my new design, carrying an absorbent pad shown in broken line illustration for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is a top view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a side view thereof, the opposite side view being the same;

FIG. 5 is an end view thereof;

FIG. 6 is an opposite end view thereof;

FIG. 7 is a perspective view of a diaper cover for absorbent pad insert, showing my new design in accordance with a second embodiment;

FIG. 8 is a top view thereof;

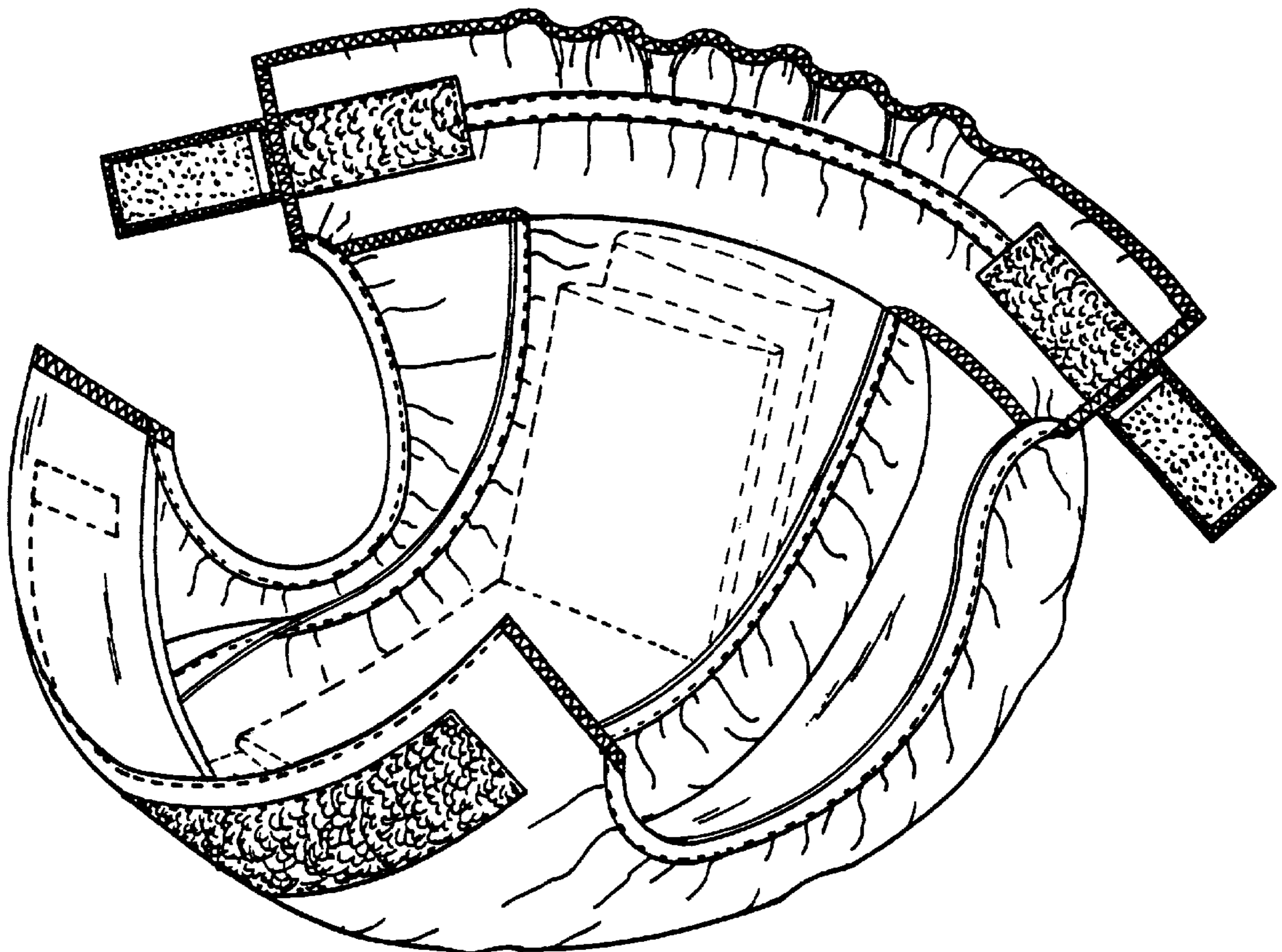
FIG. 9 is a bottom view thereof;

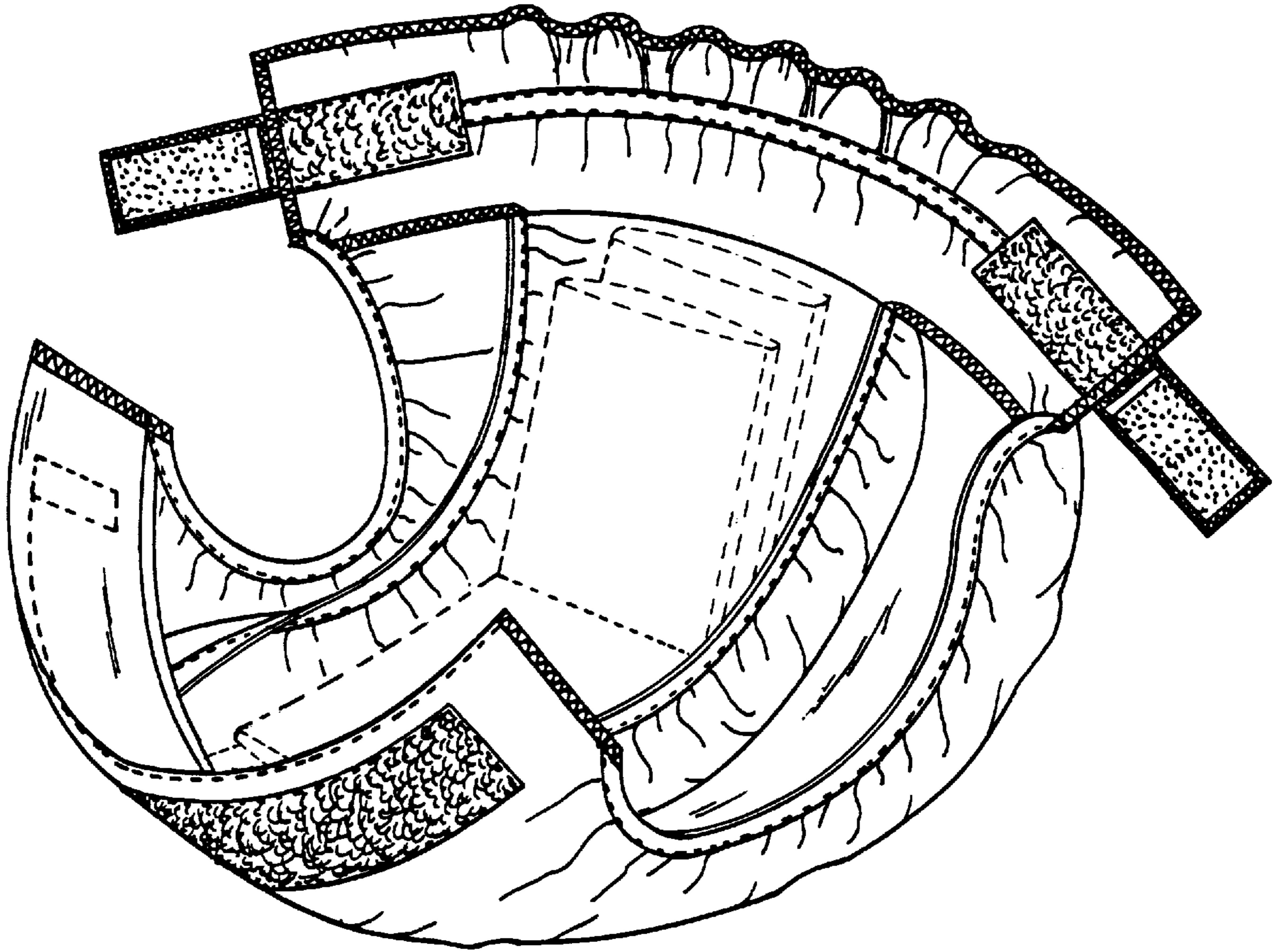

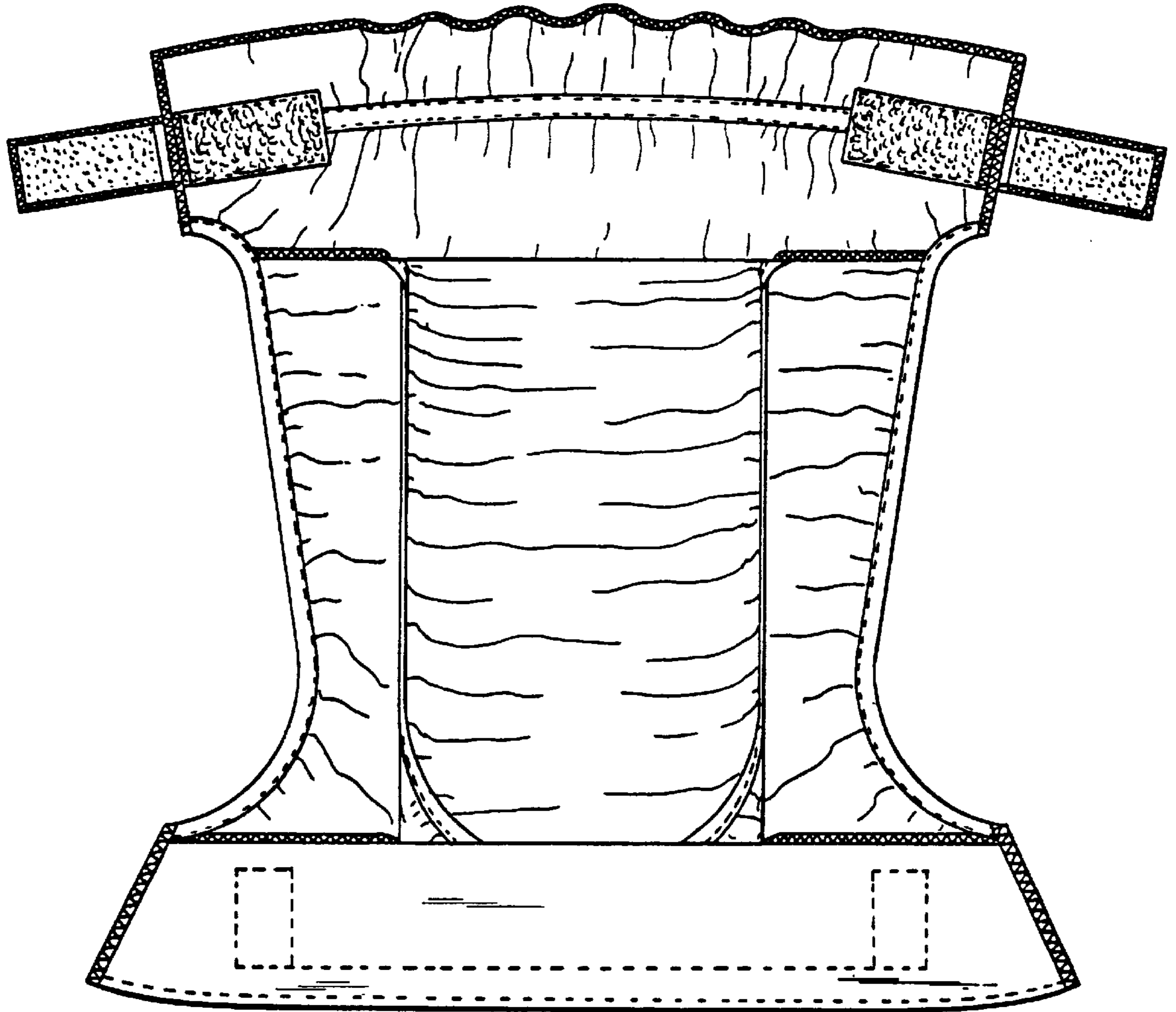

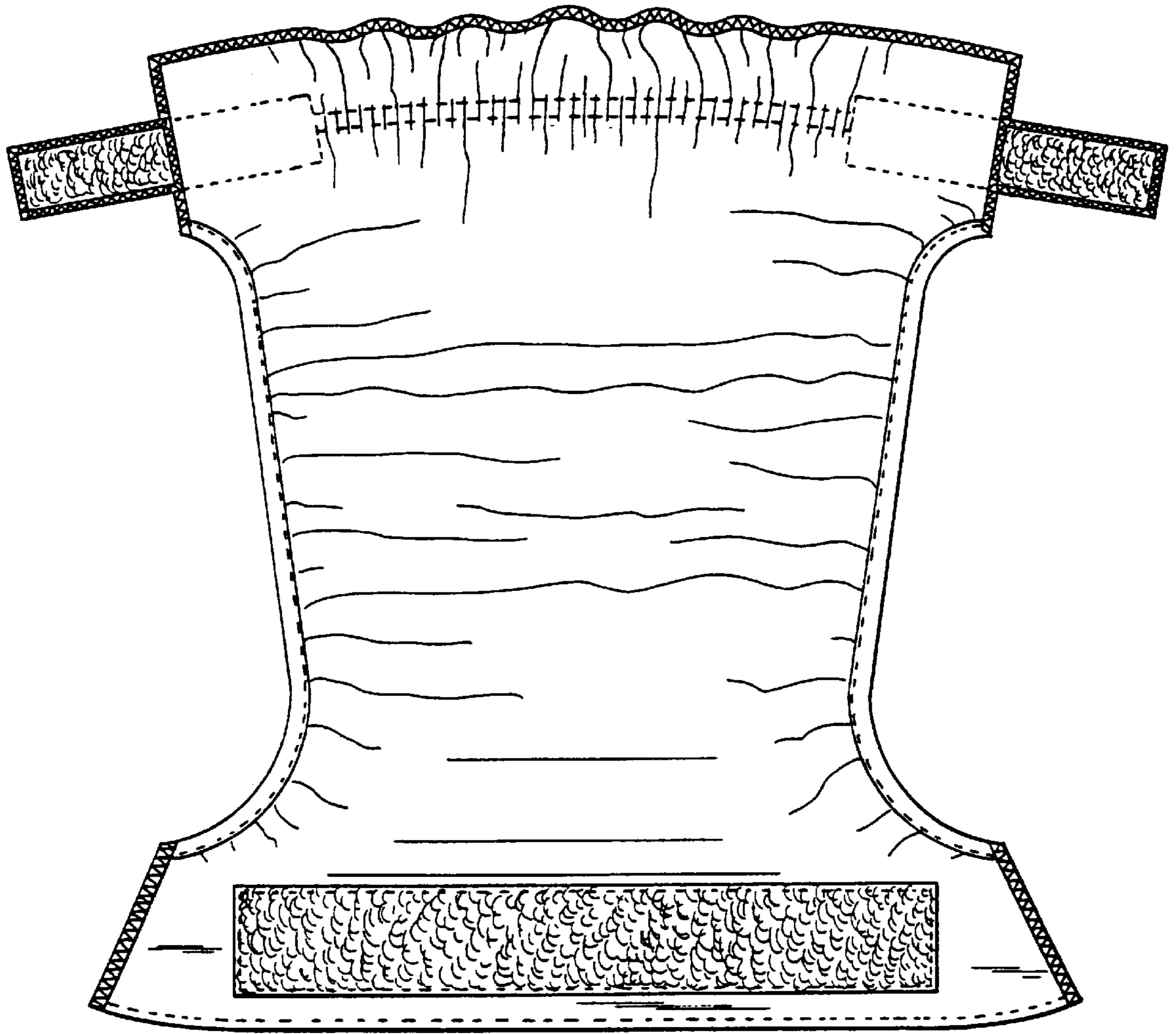

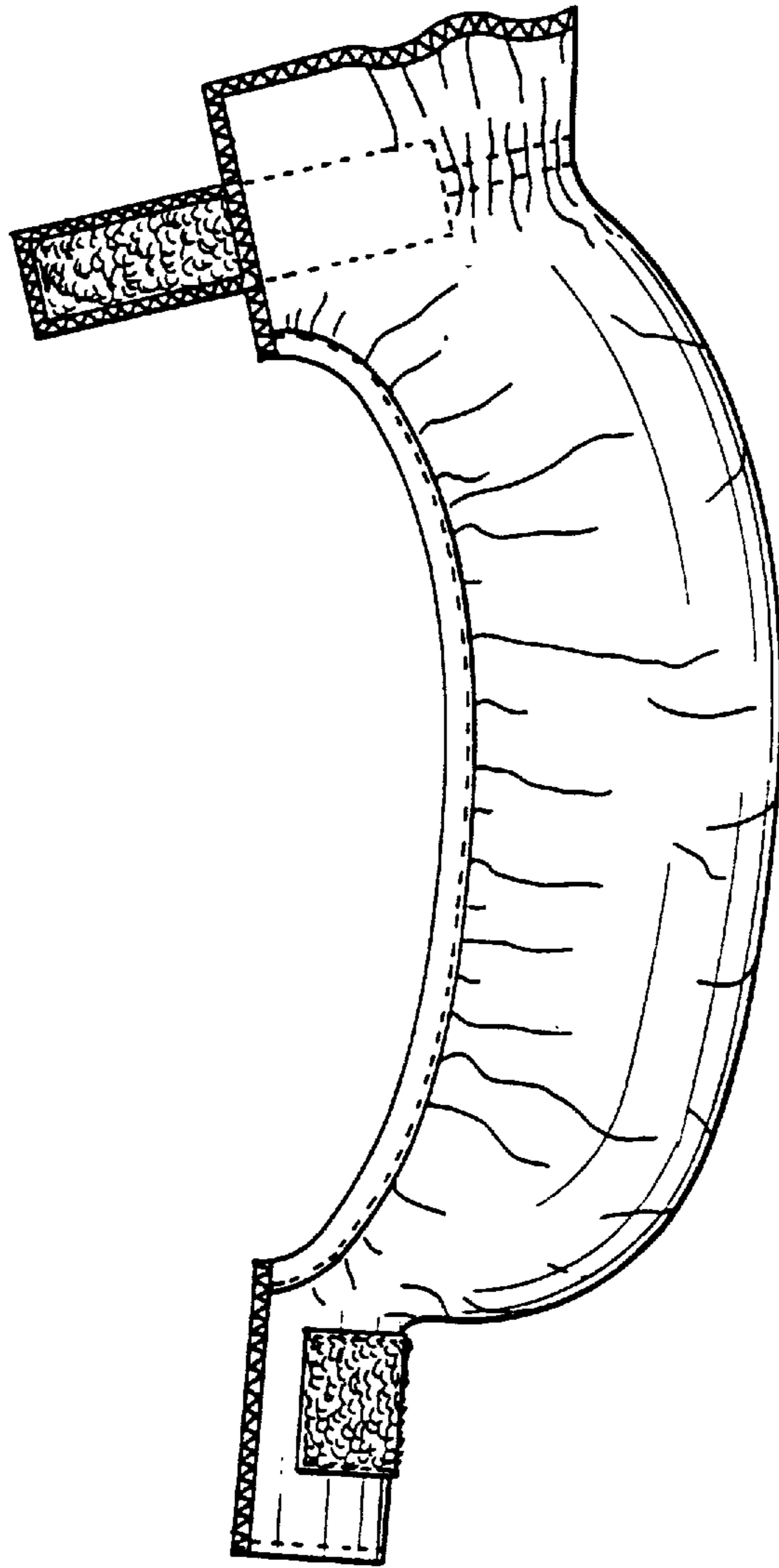

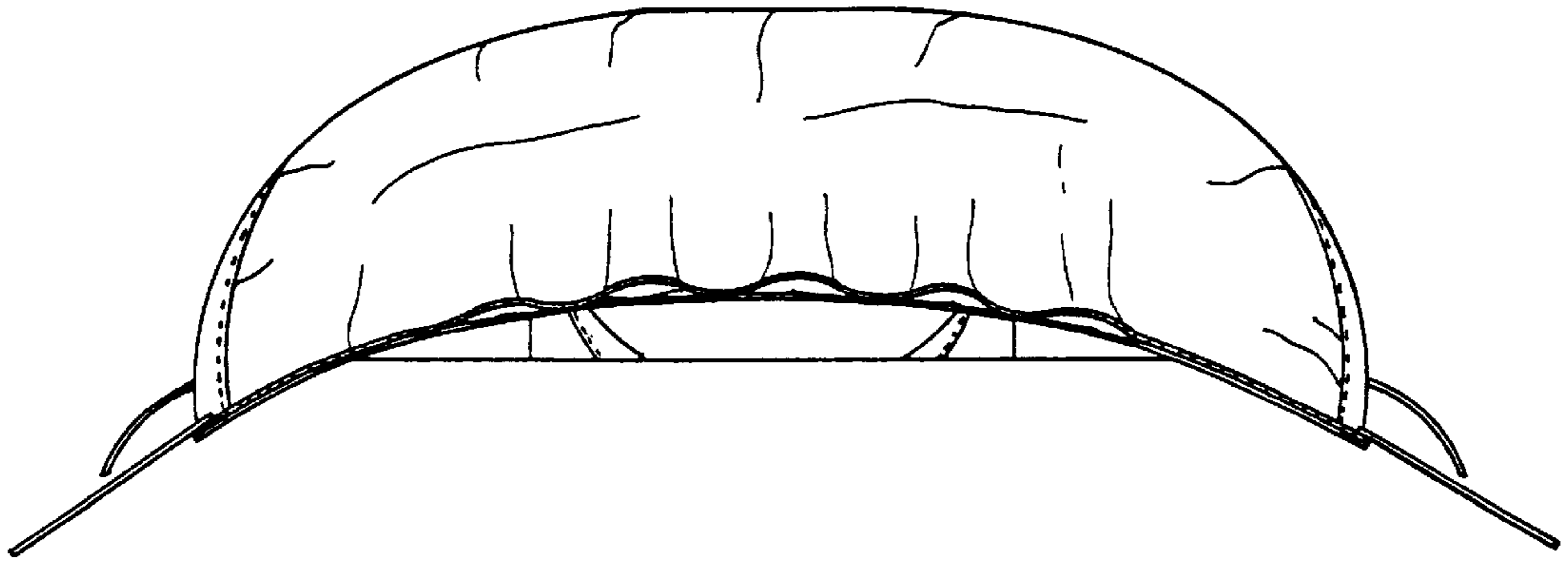

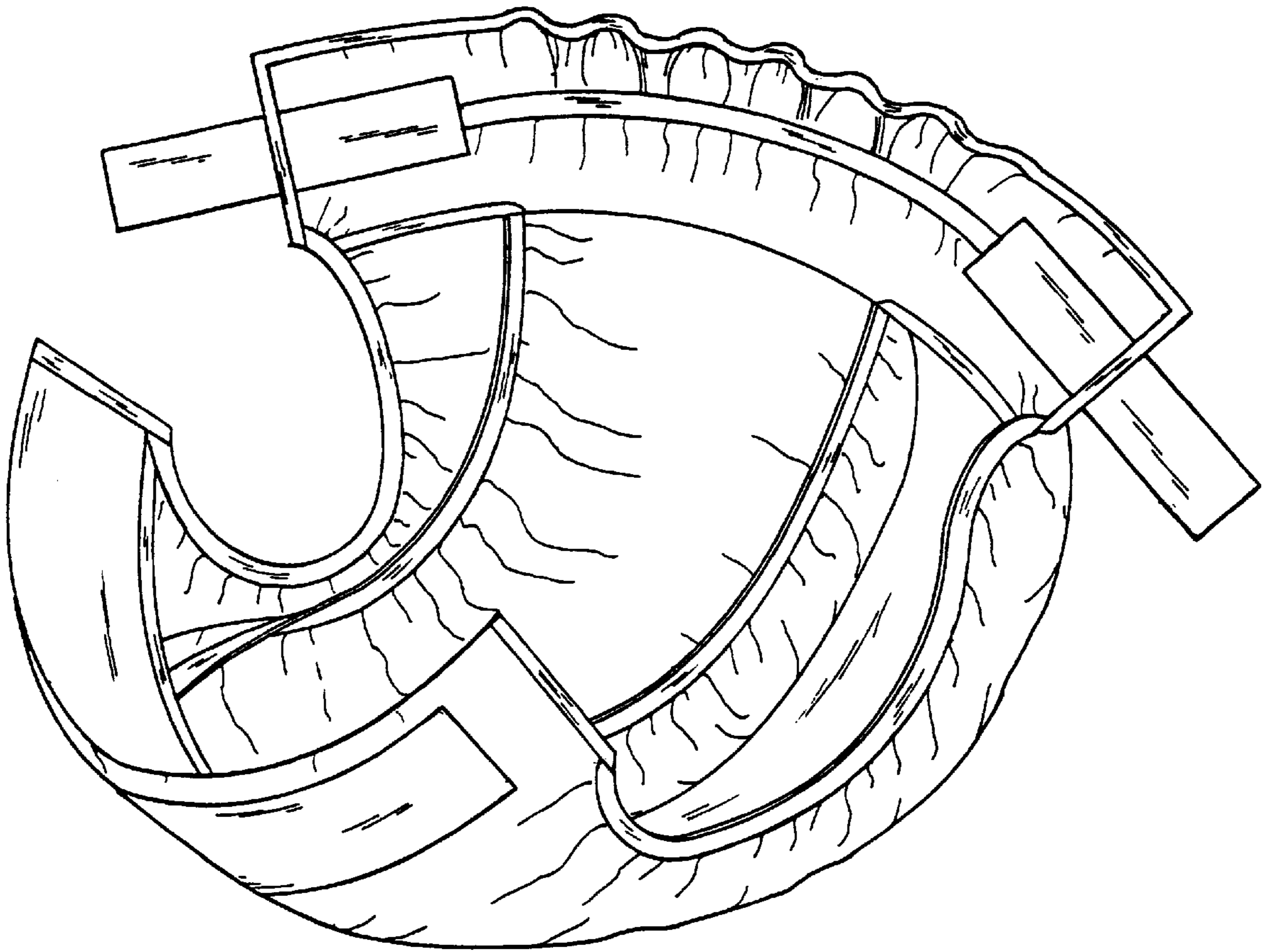

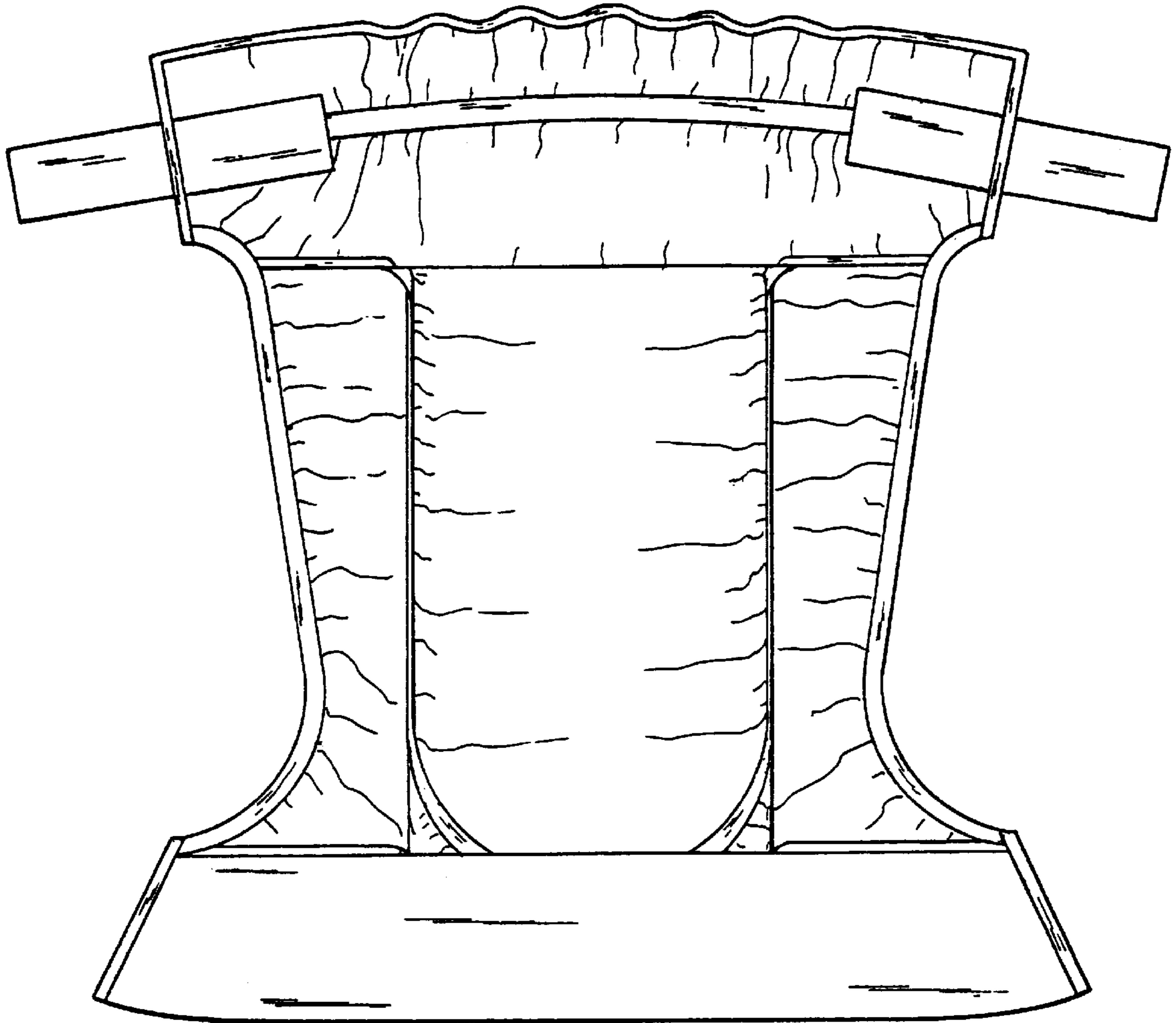

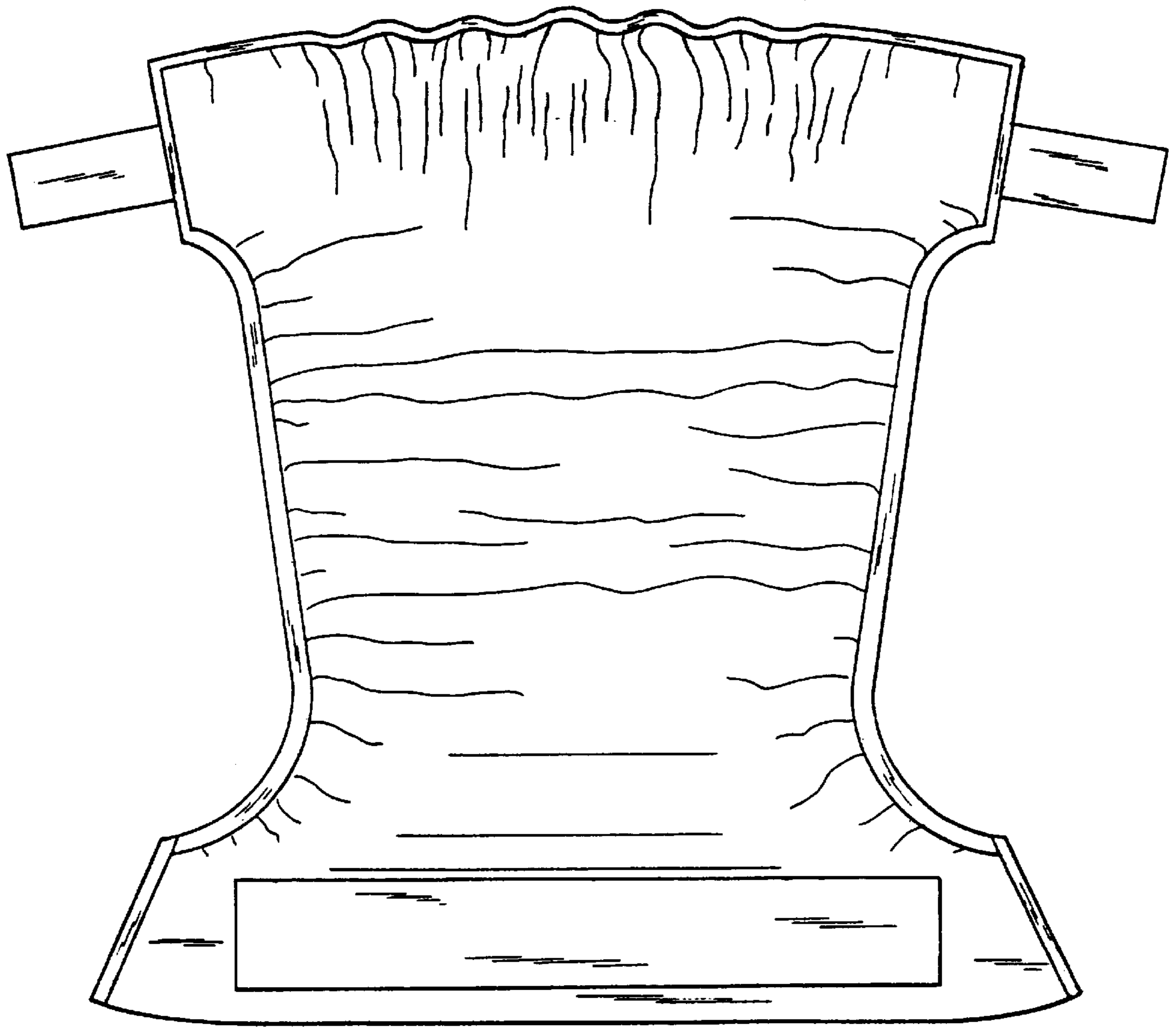

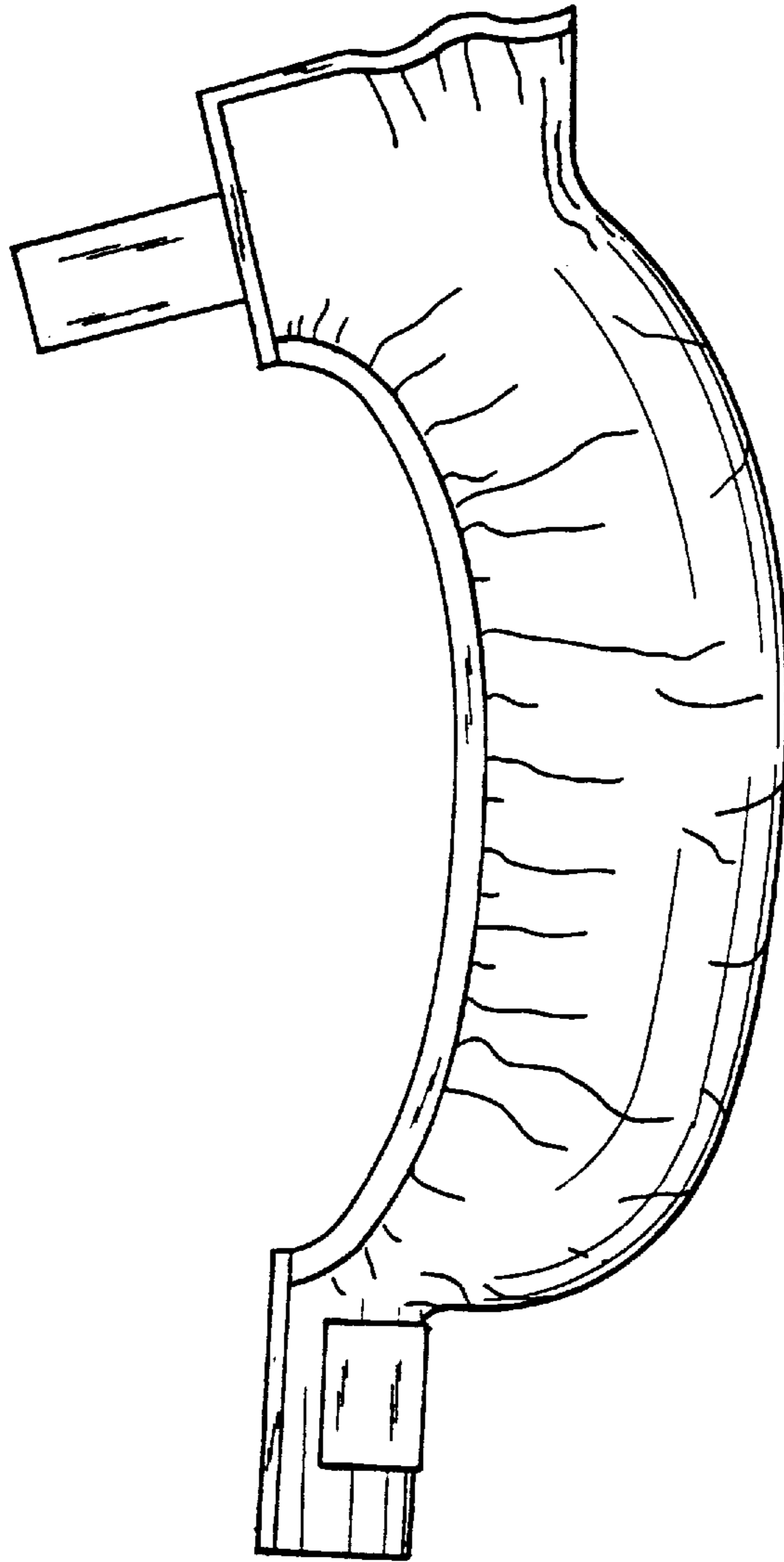

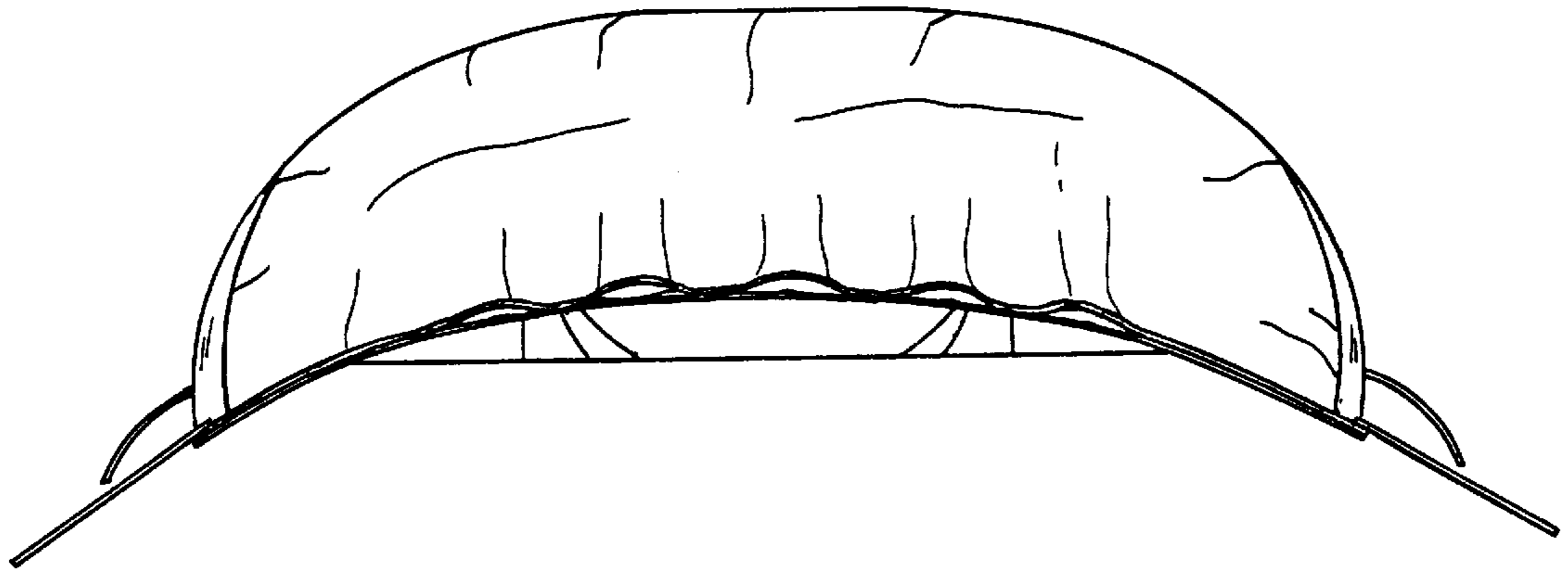

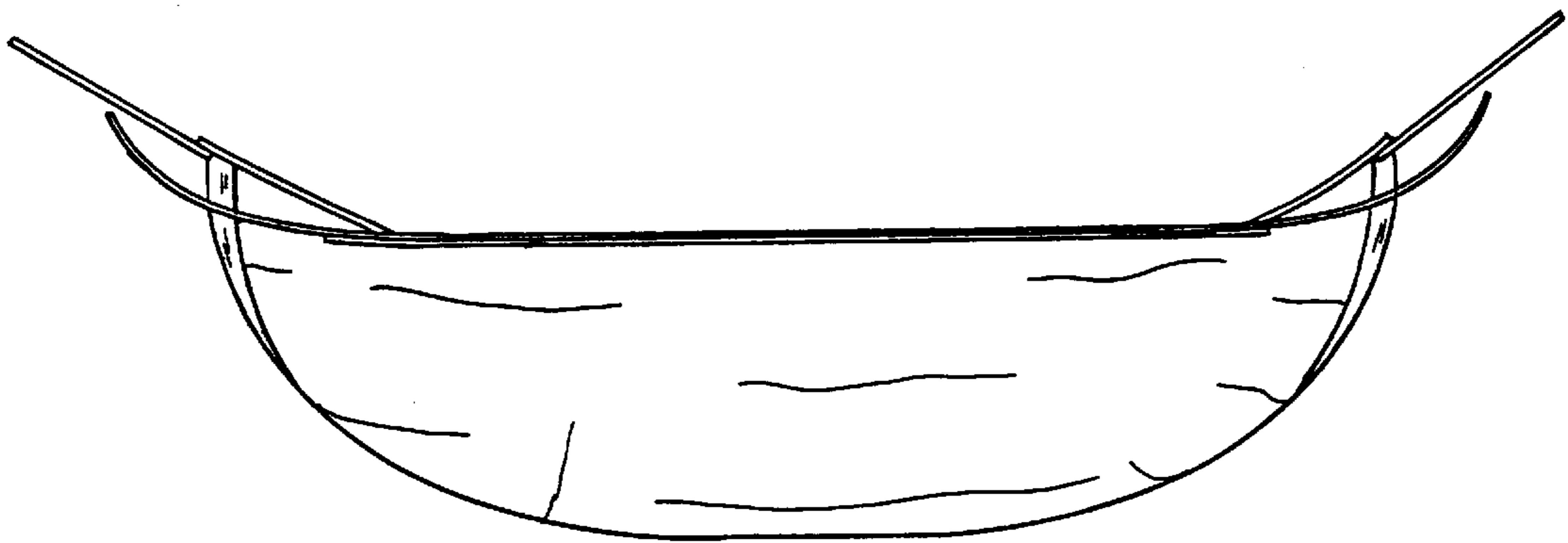
