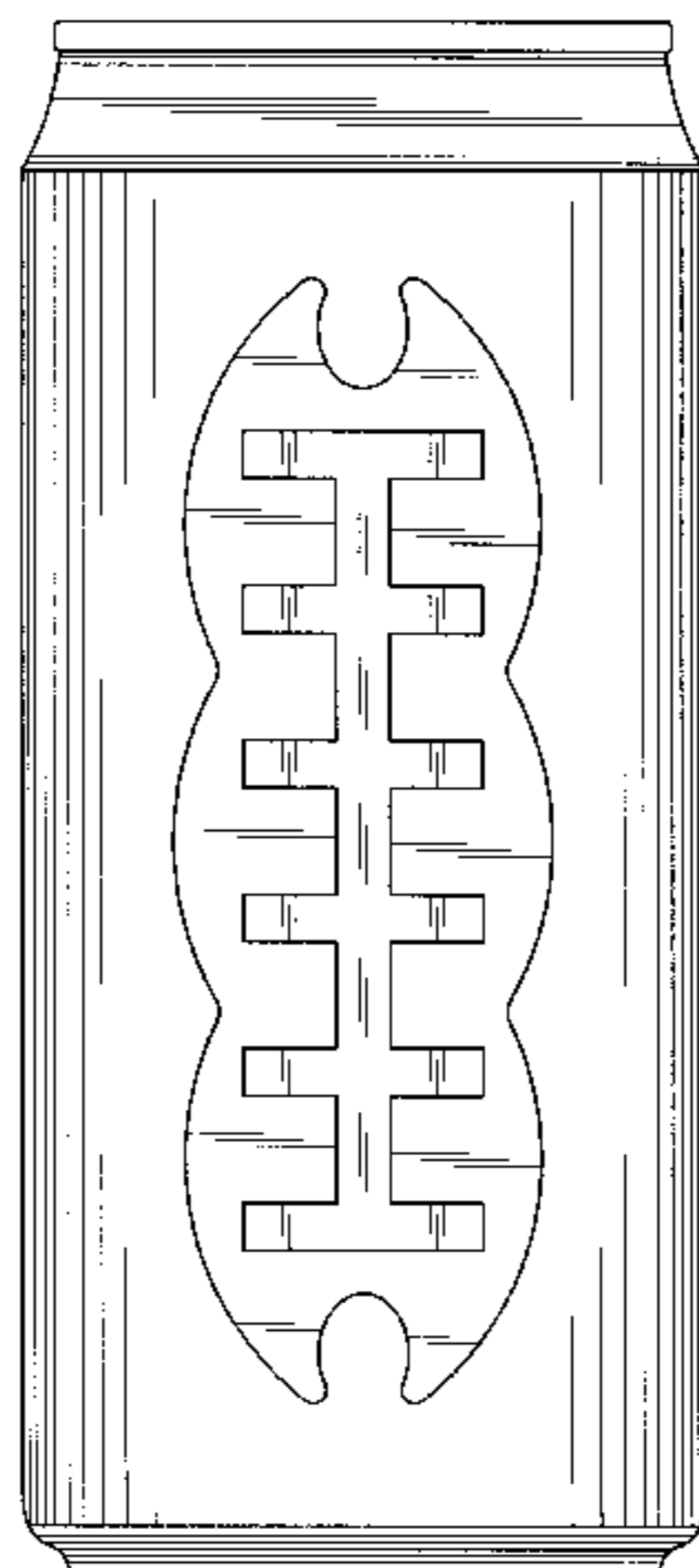

DESCRIPTION

FIG. 1 is an isometric view of a beverage can showing my new design;

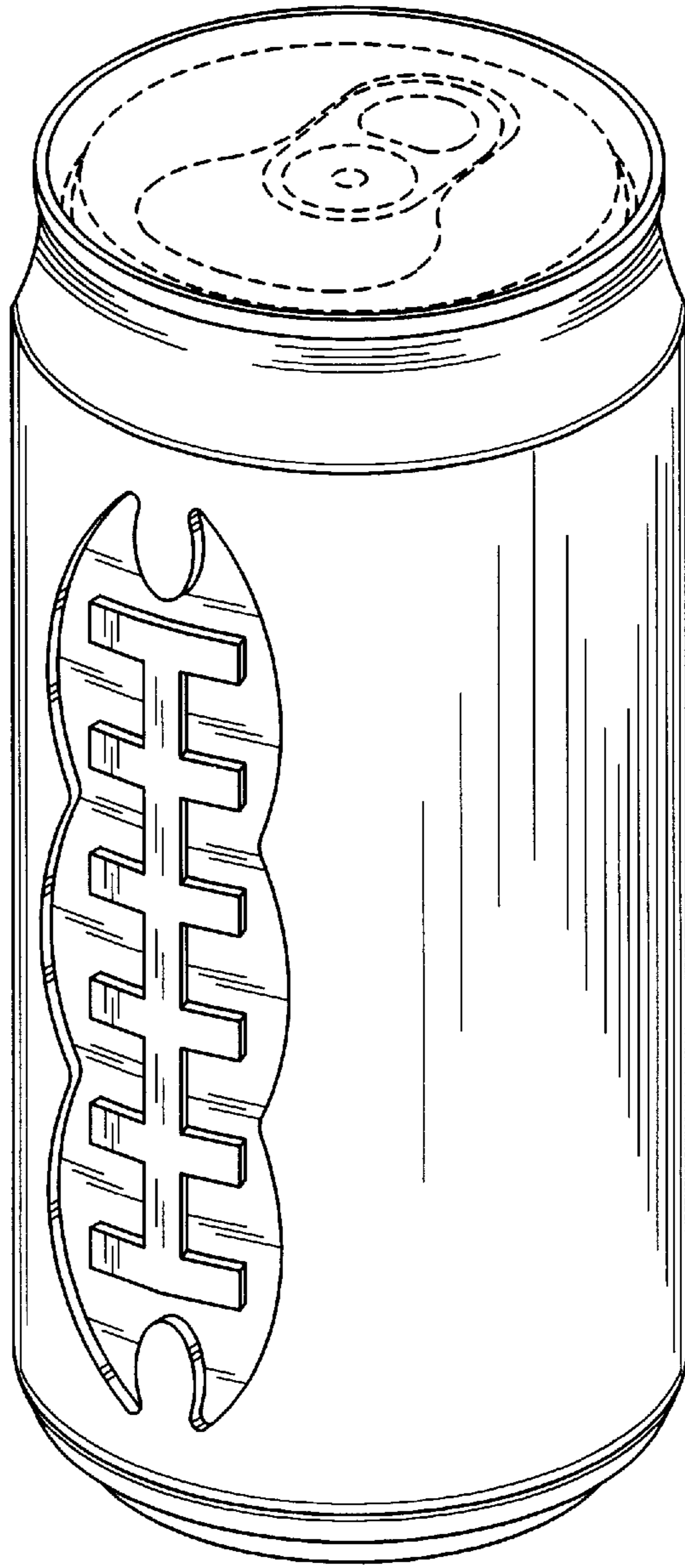

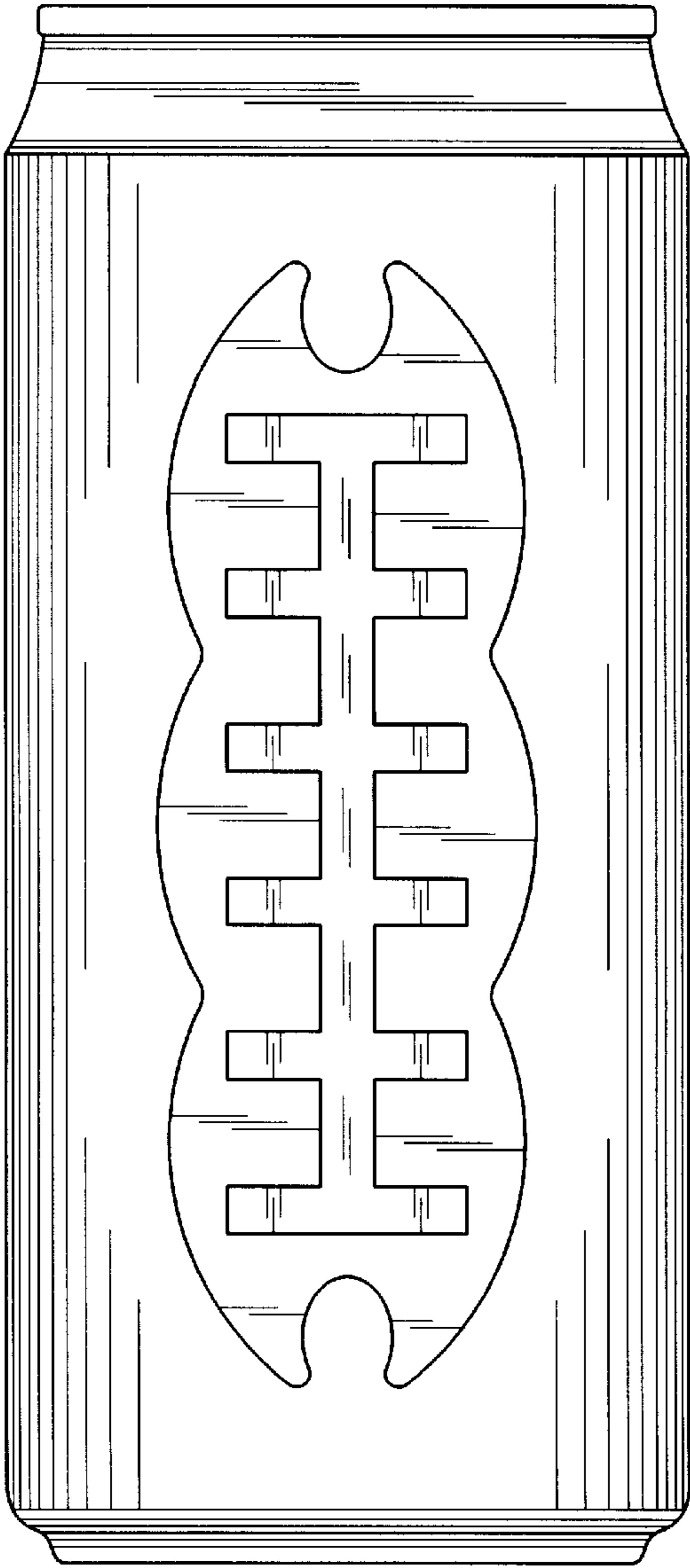

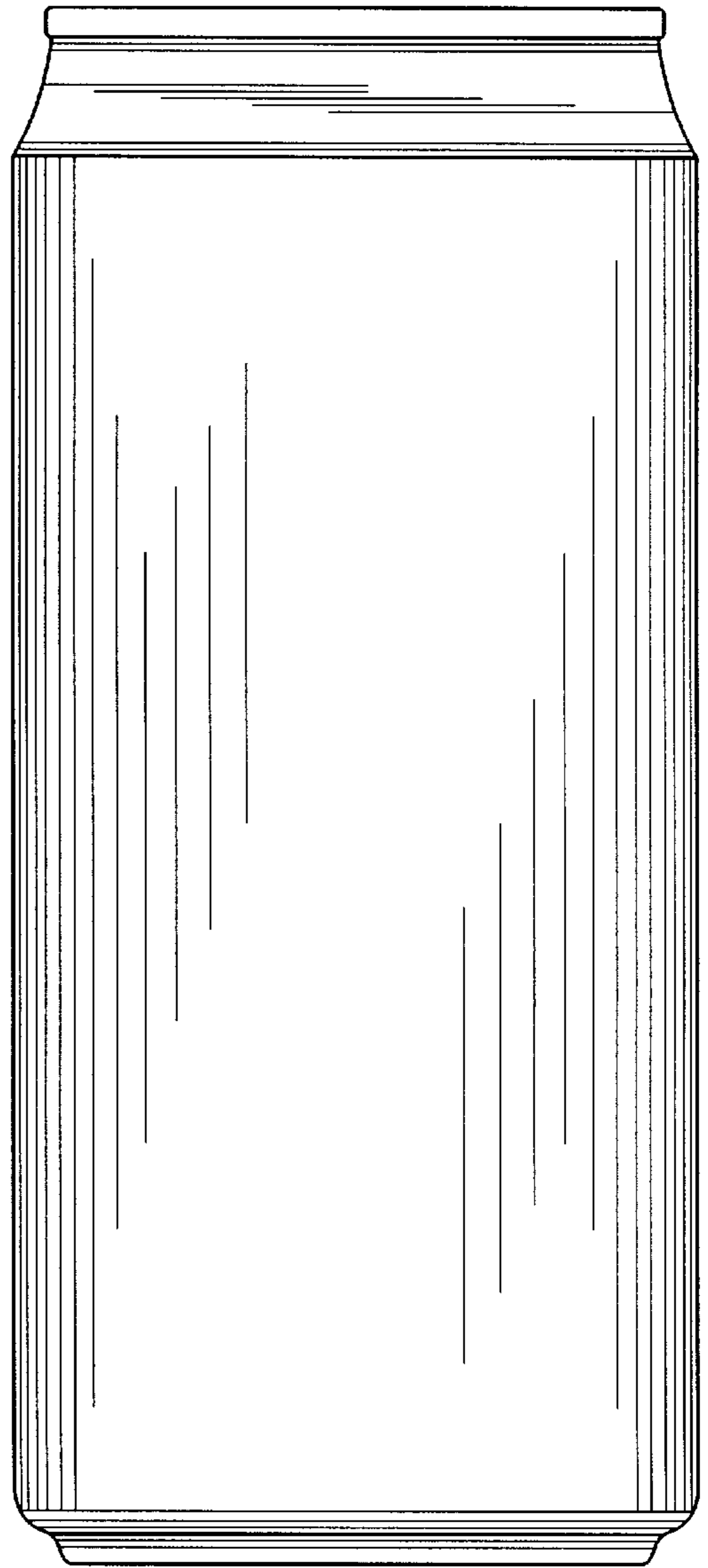

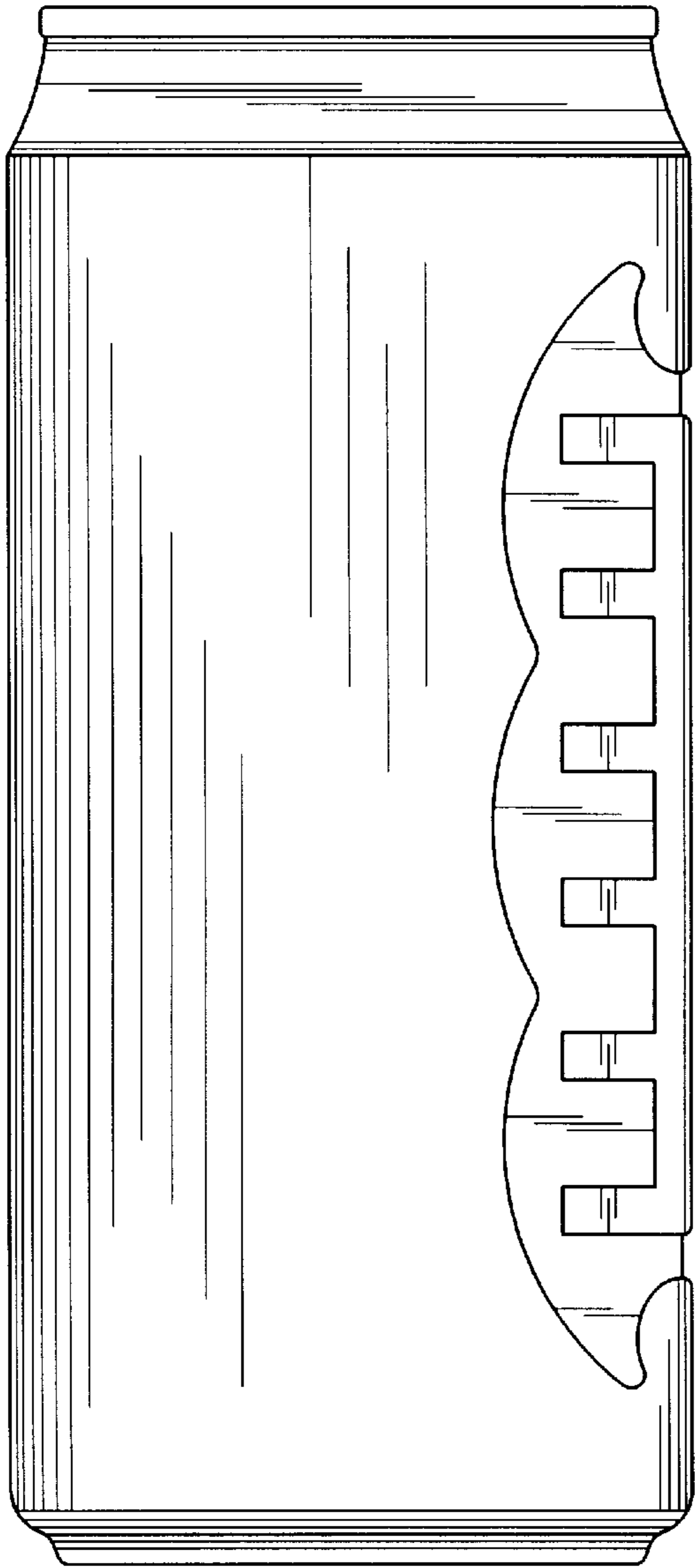

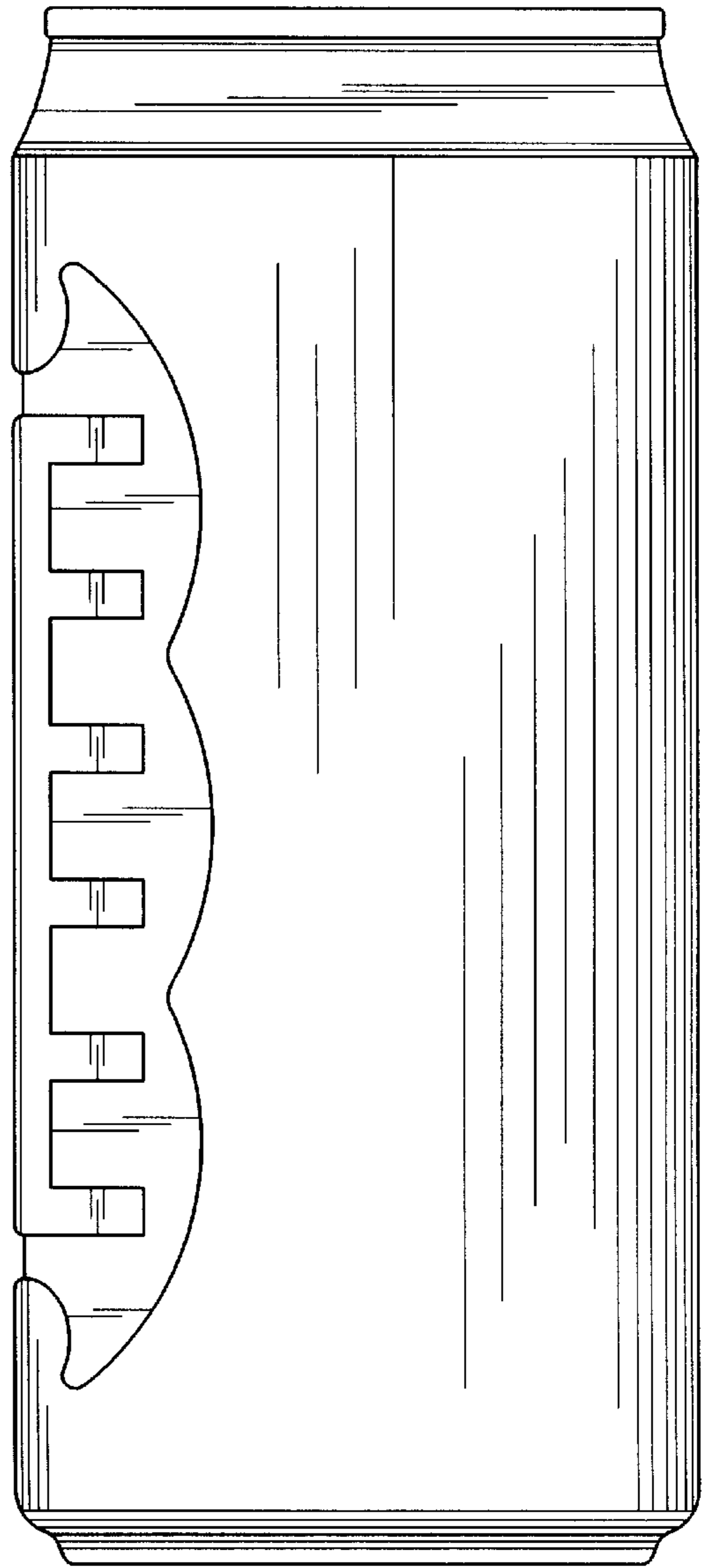

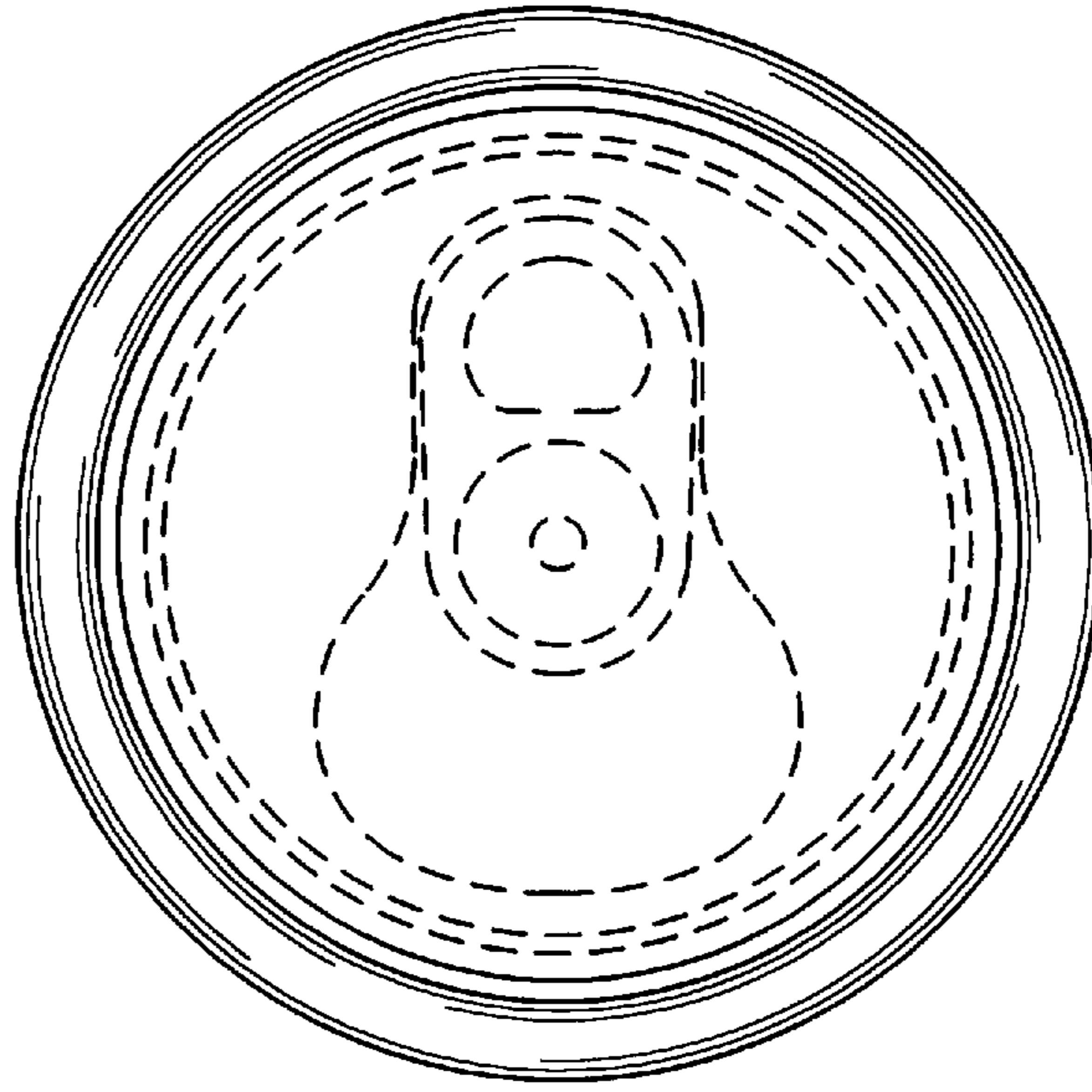

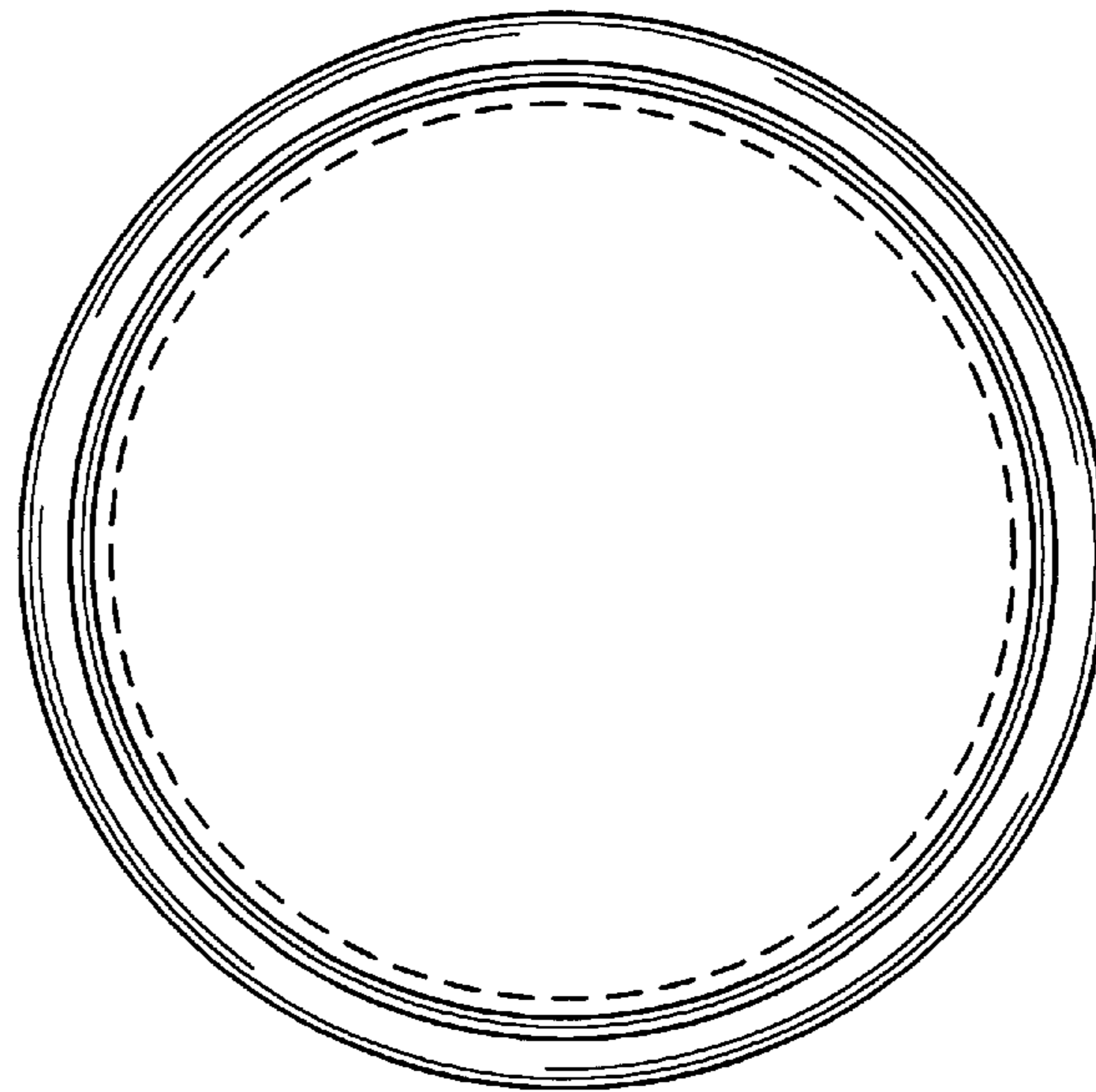
