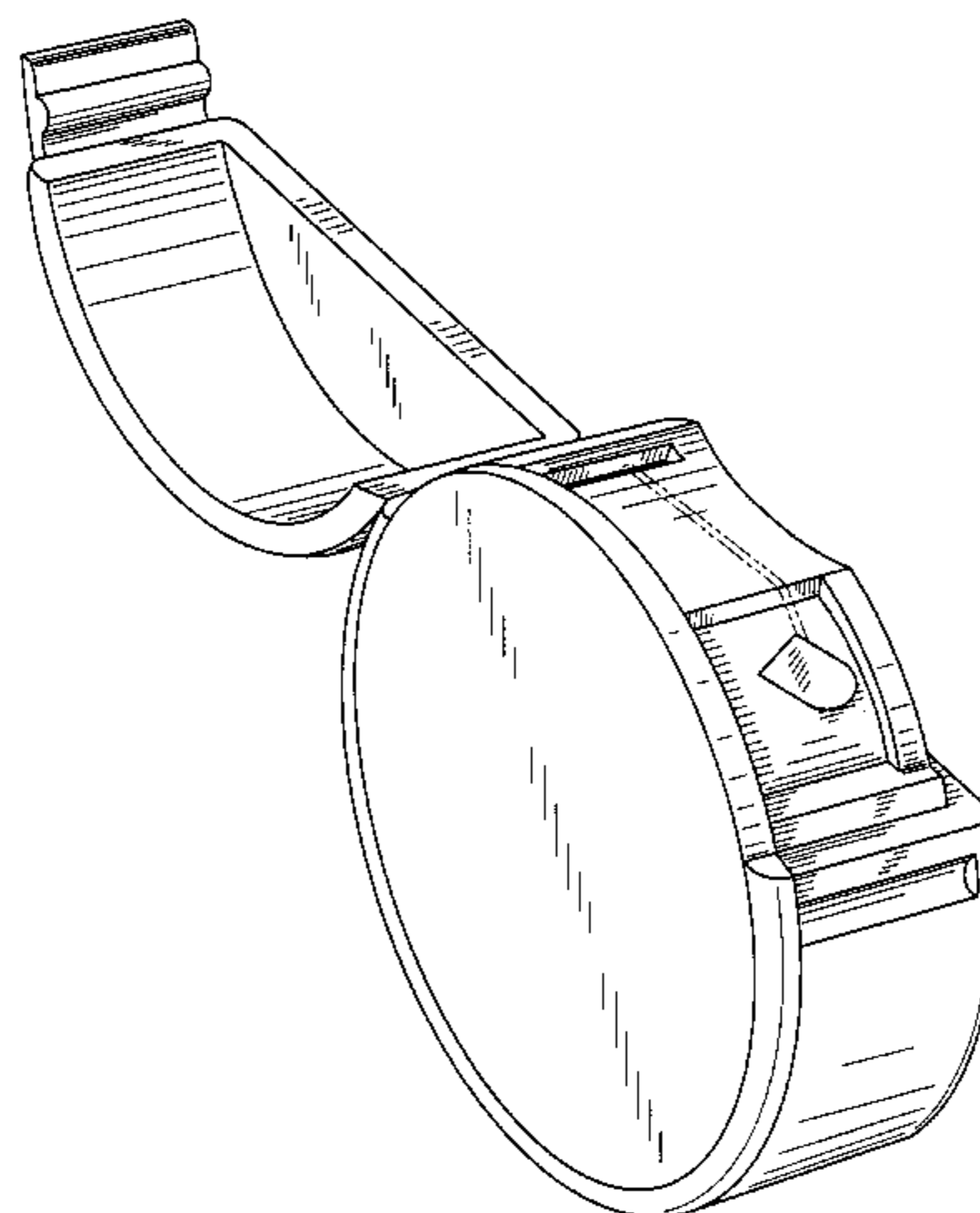
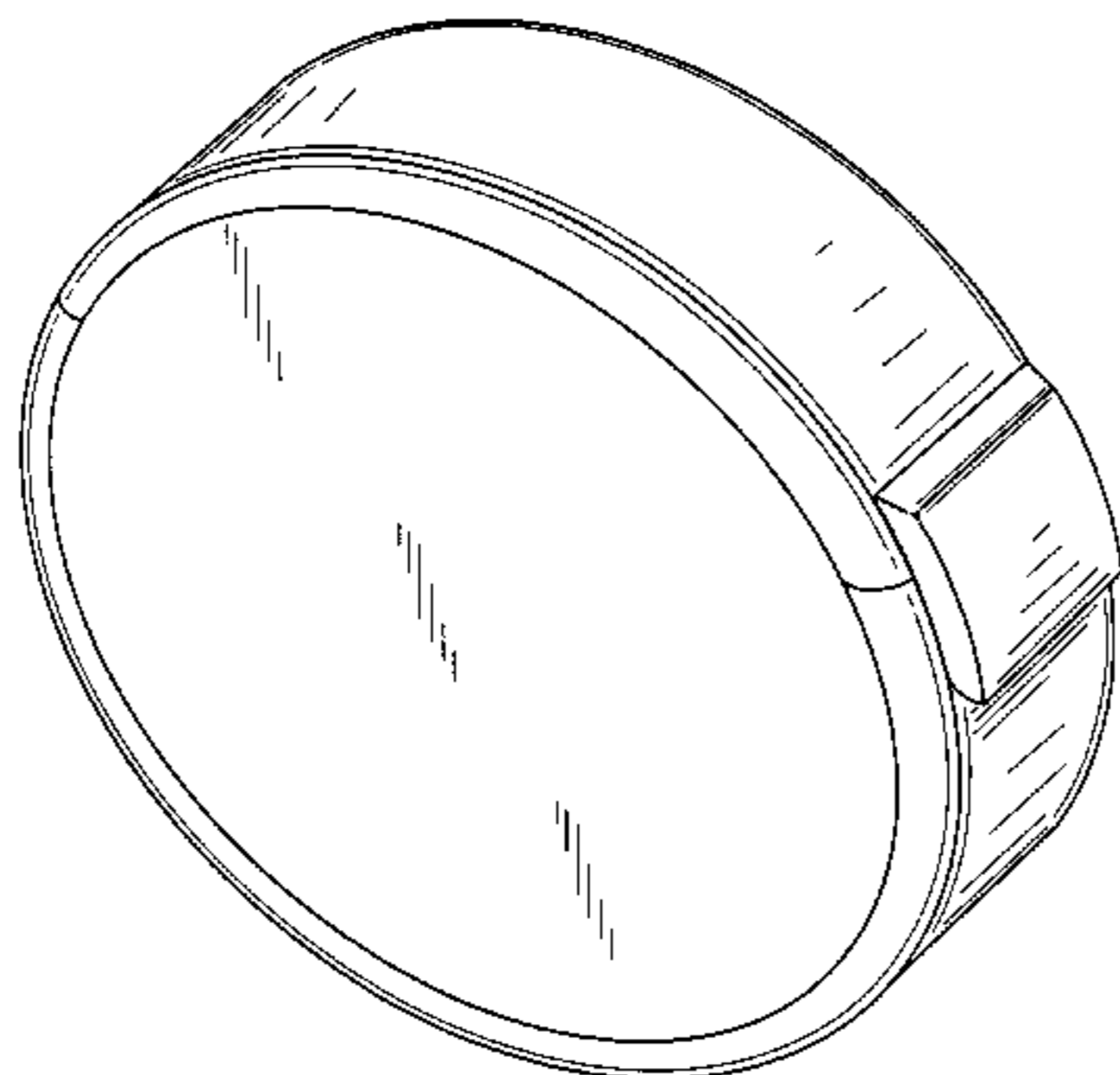
## [57] CLAIM

The ornamental design for a dental floss dispenser, as shown and described.

### DESCRIPTION

FIG. 1 is a top and right front perspective view showing our new design;  
FIG. 2 is a top view thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a rear elevational view thereof;  
FIG. 7 is a bottom view thereof; and,  
FIG. 8 is a front, top and right side perspective view showing our new design opened, the phantom lines representing a floss strand being for illustrative purposes only and forming no part of the claimed design.

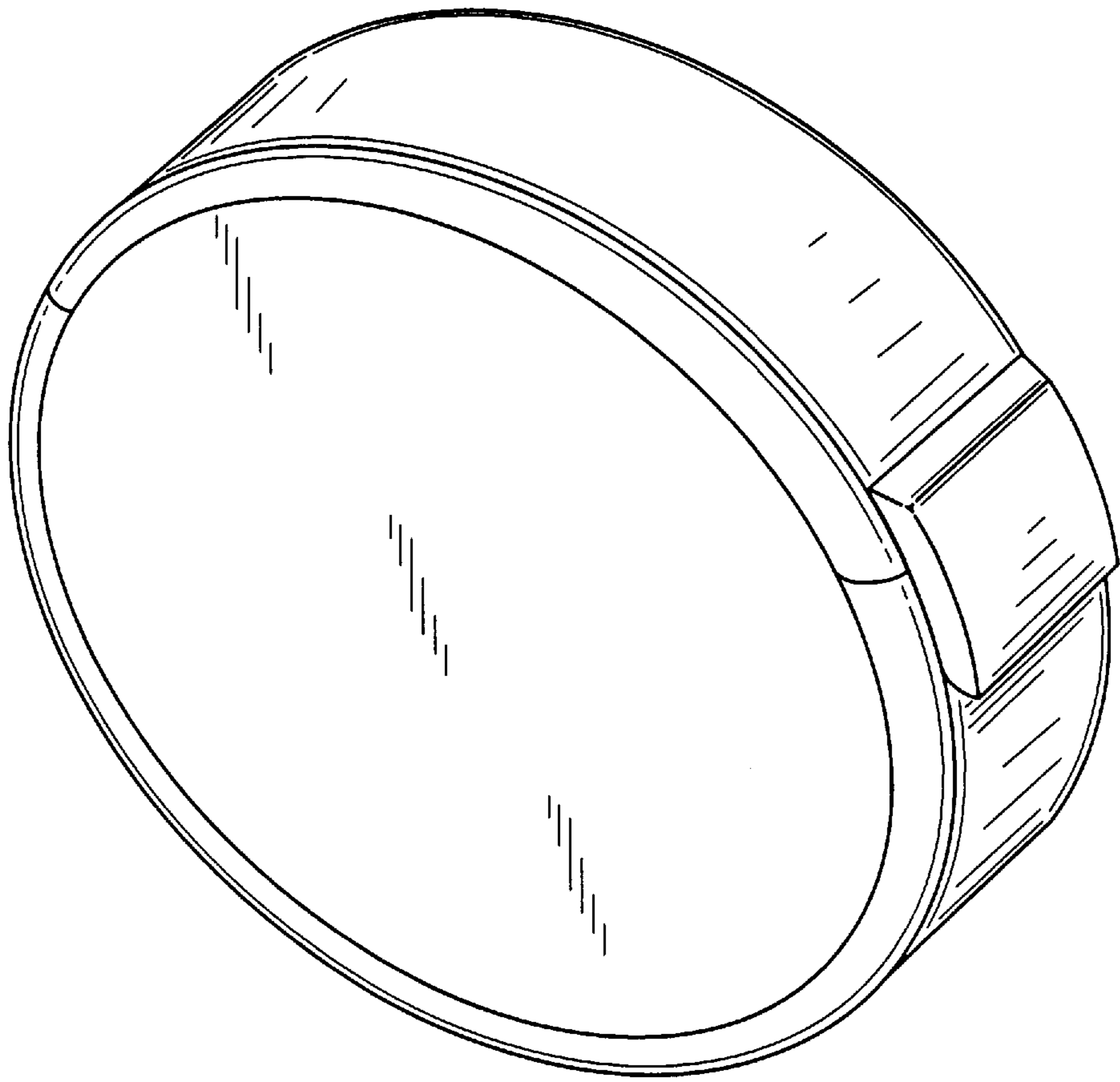

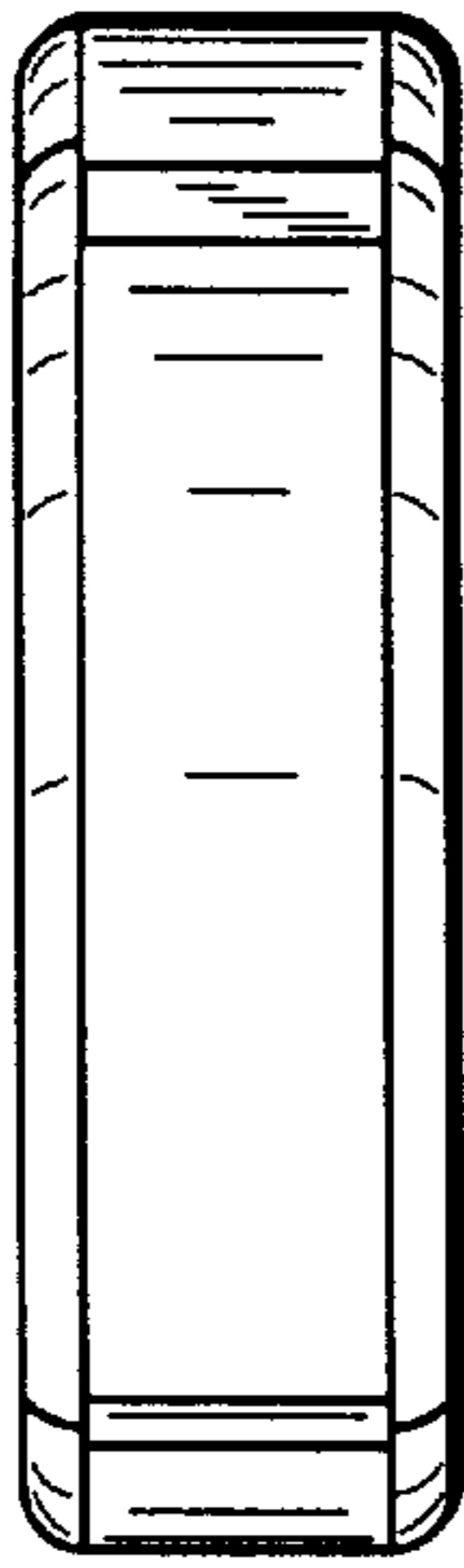

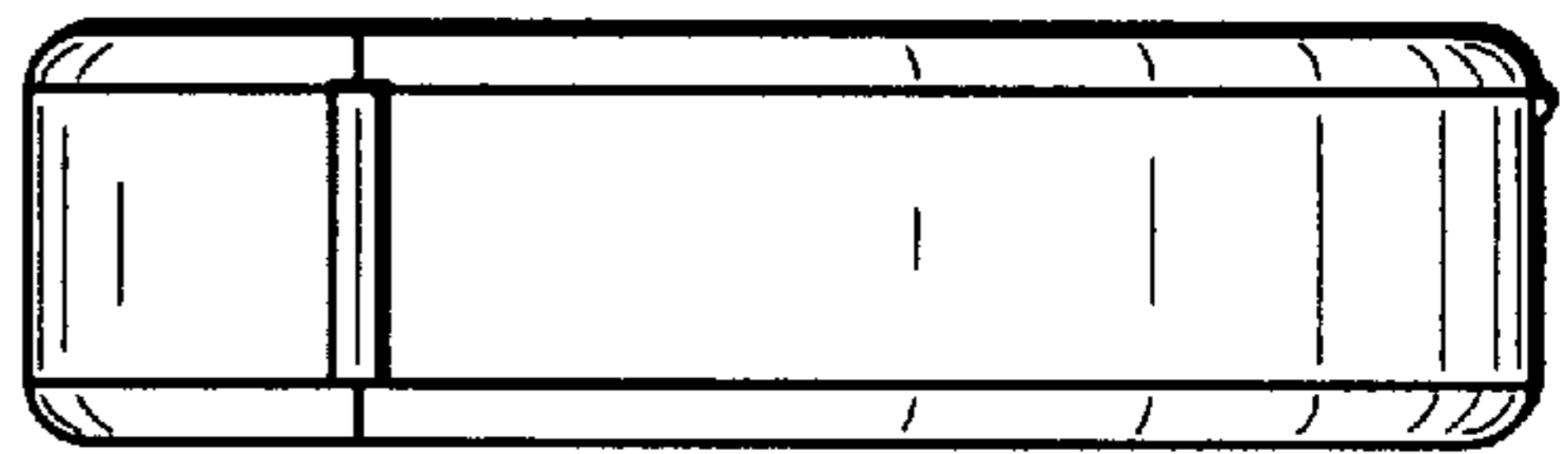

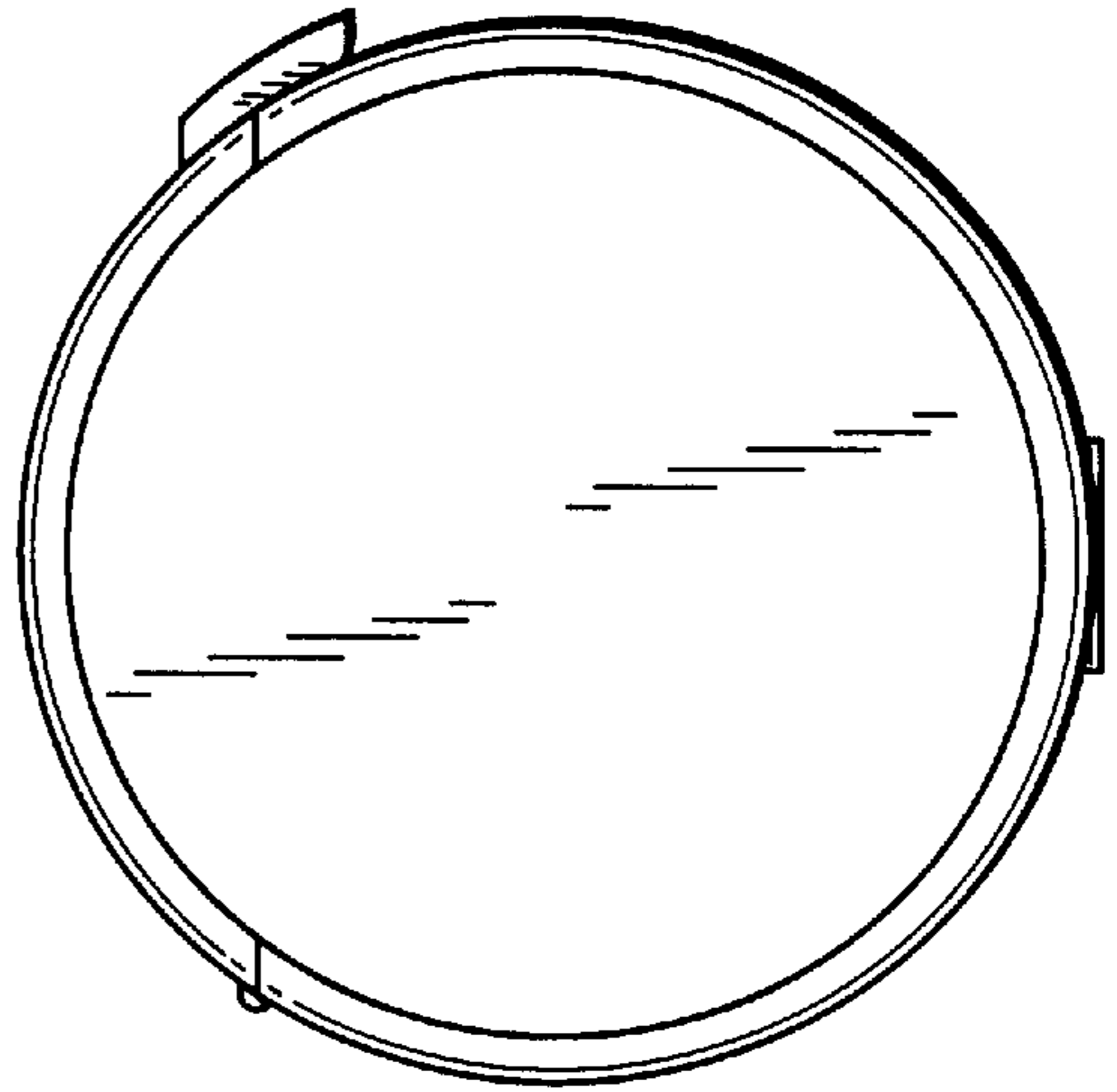

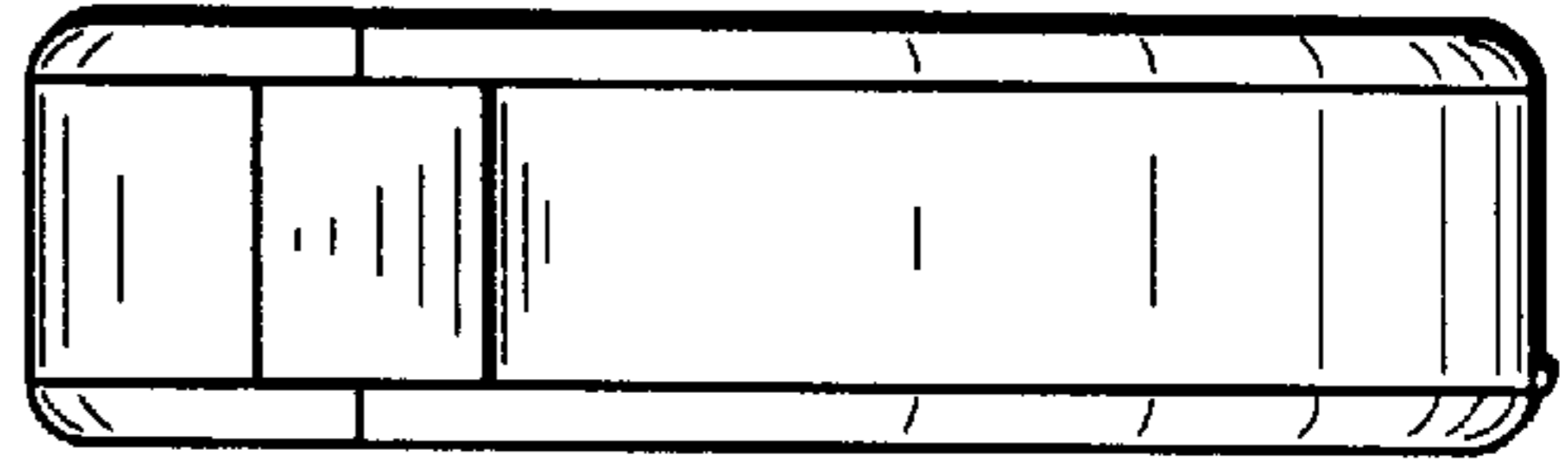

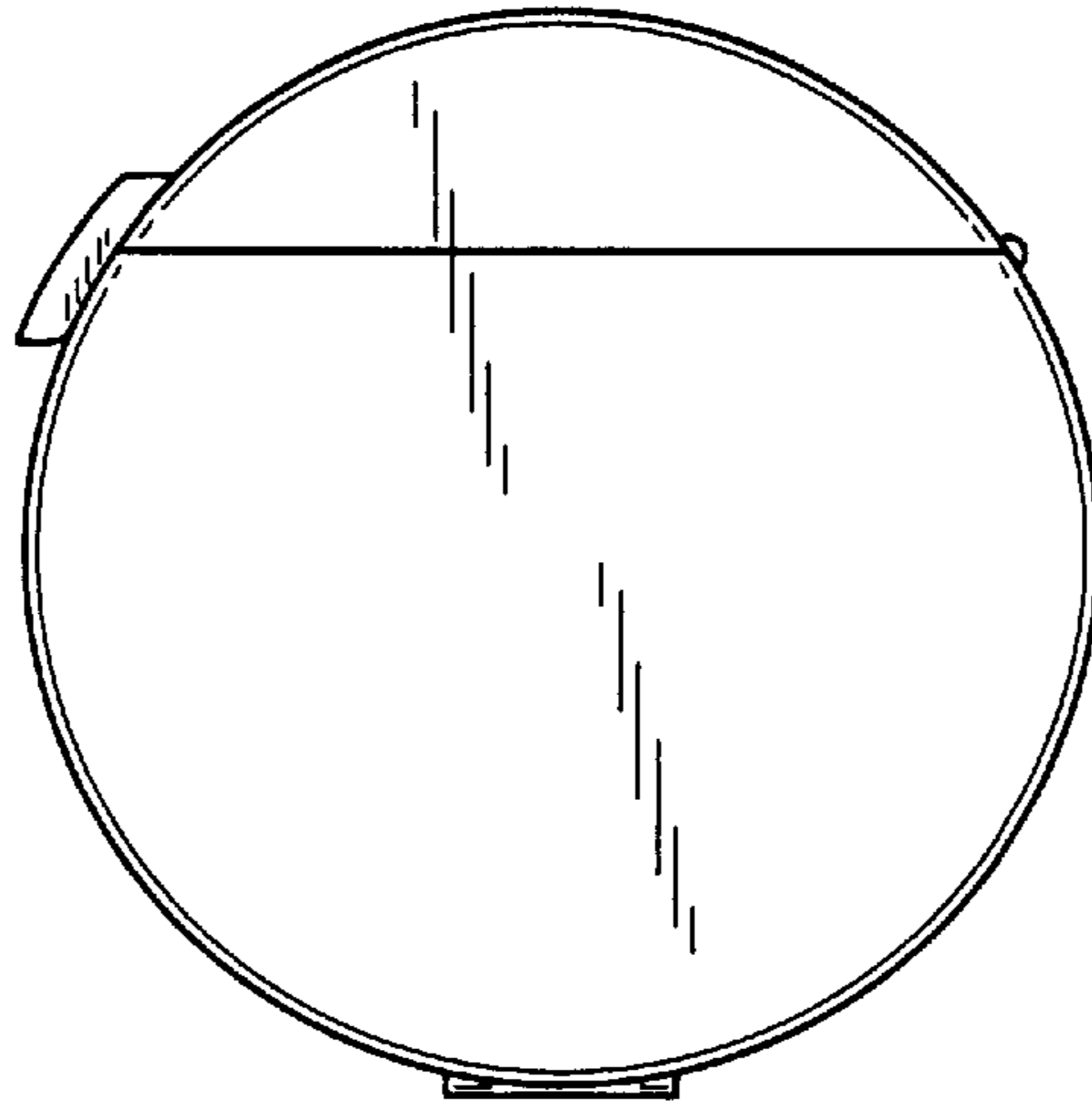

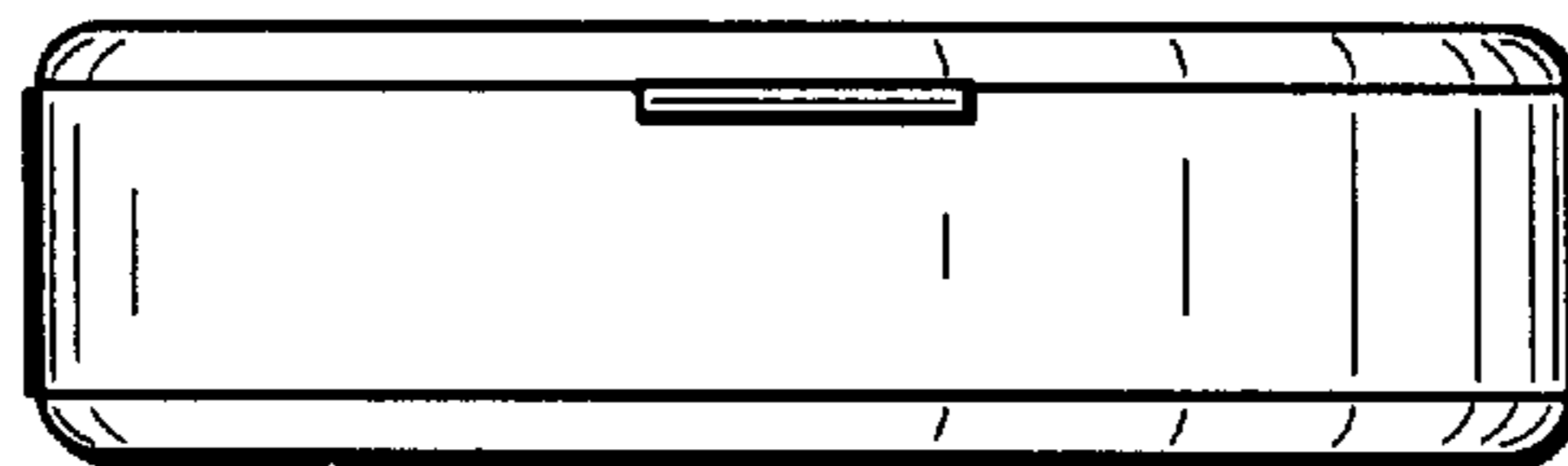
