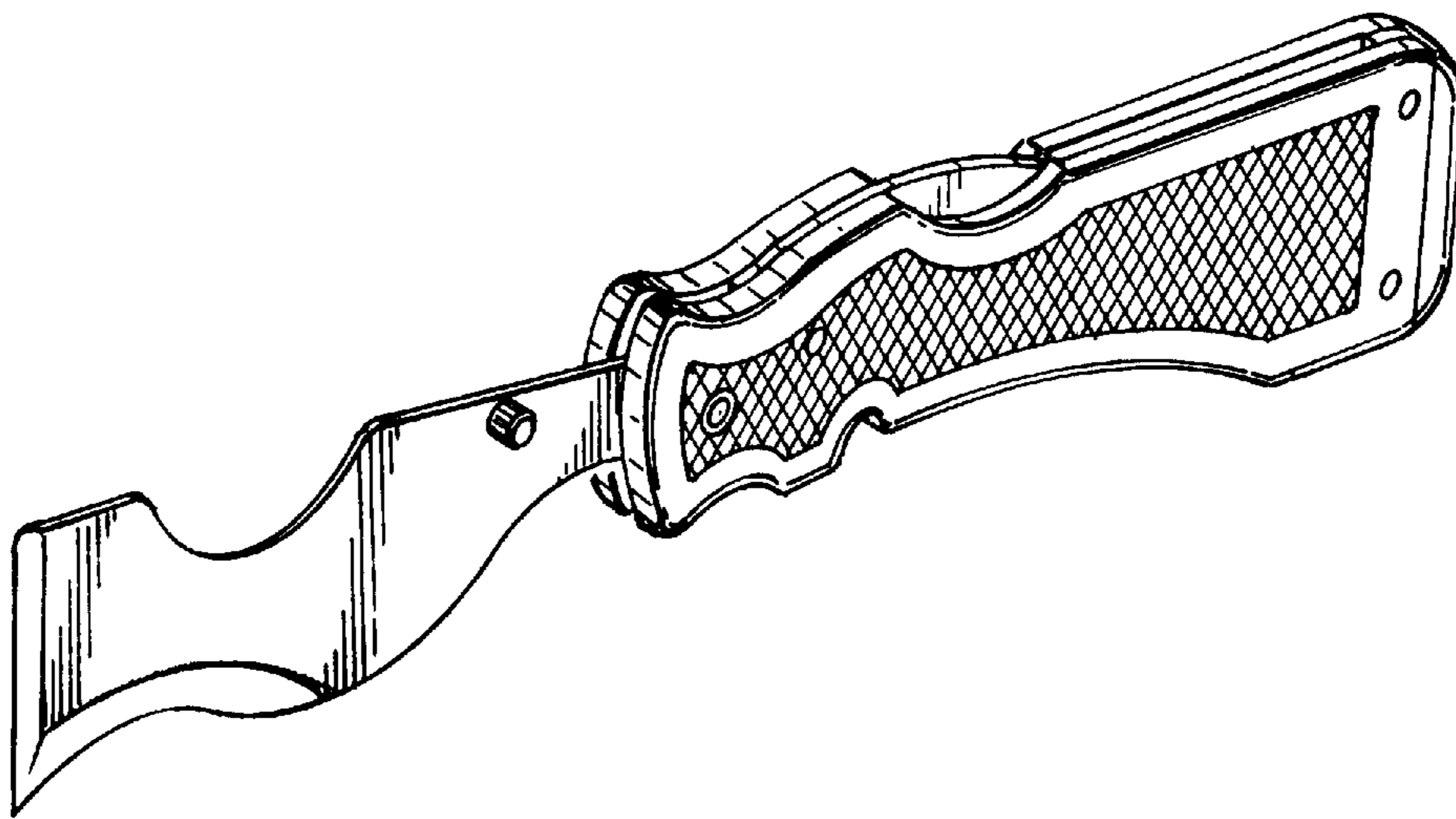
[57] **CLAIM**

The ornamental design for an ergonomic, single hand, folding painter's tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a ergonomic, single hand, folding painter's tool showing my new design; FIG. 2 is an elevational view of one side of the tool; FIG. 3 is an elevational view of the opposite side of the tool; FIG. 4 is a top plan view of the tool; FIG. 5 is a bottom plan view of the tool; FIG. 6 is a front elevational view of the tool; and, FIG. 7 is a rear elevational view of the tool.

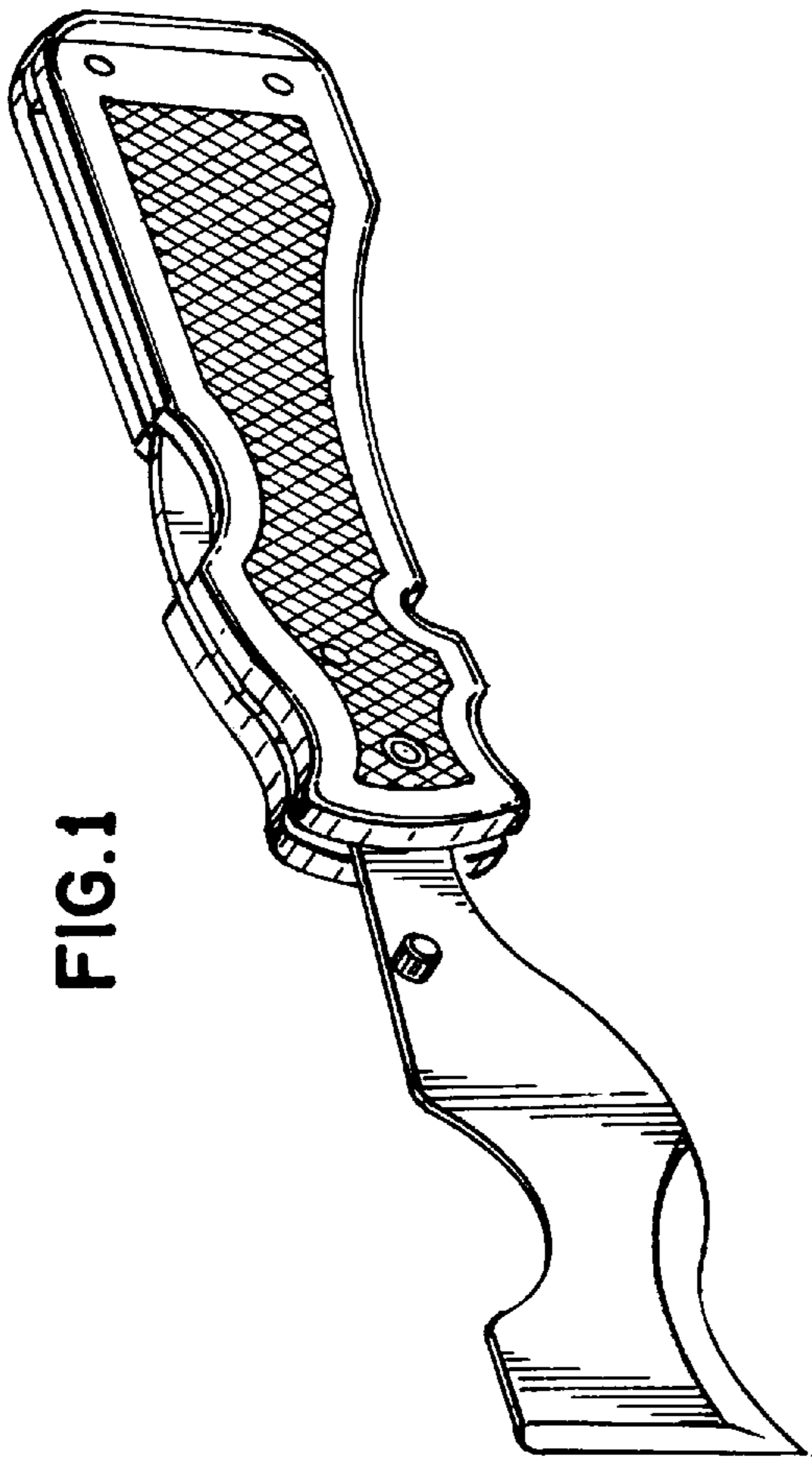

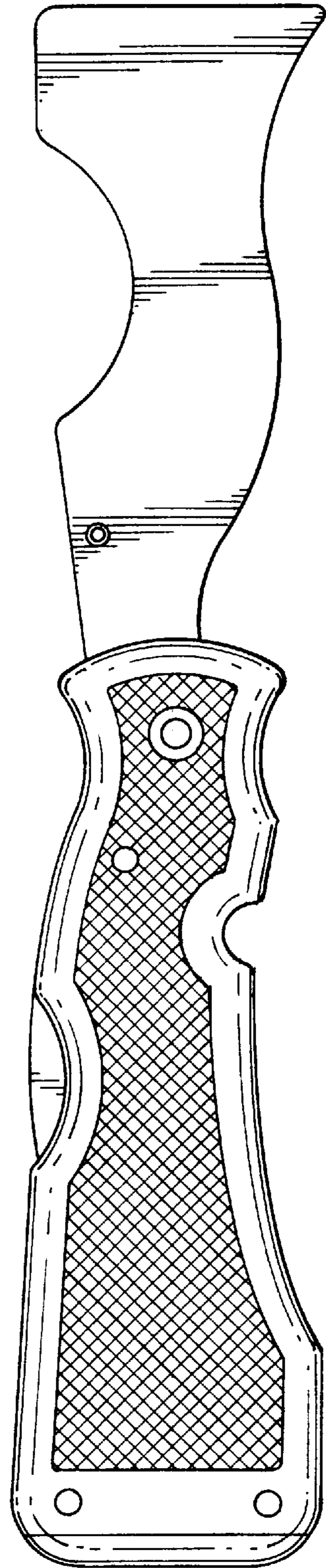

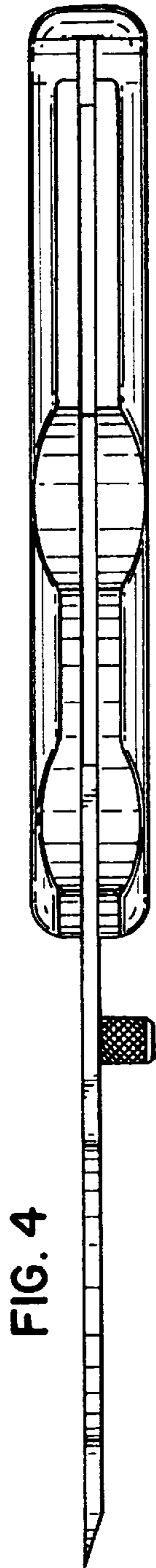

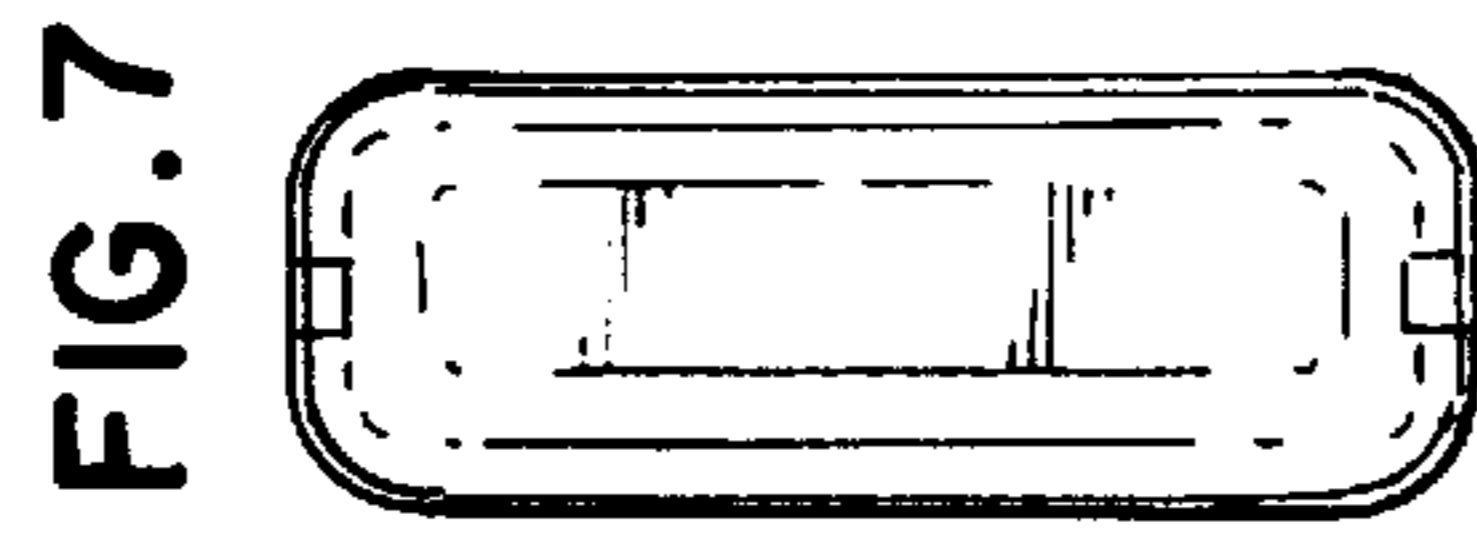

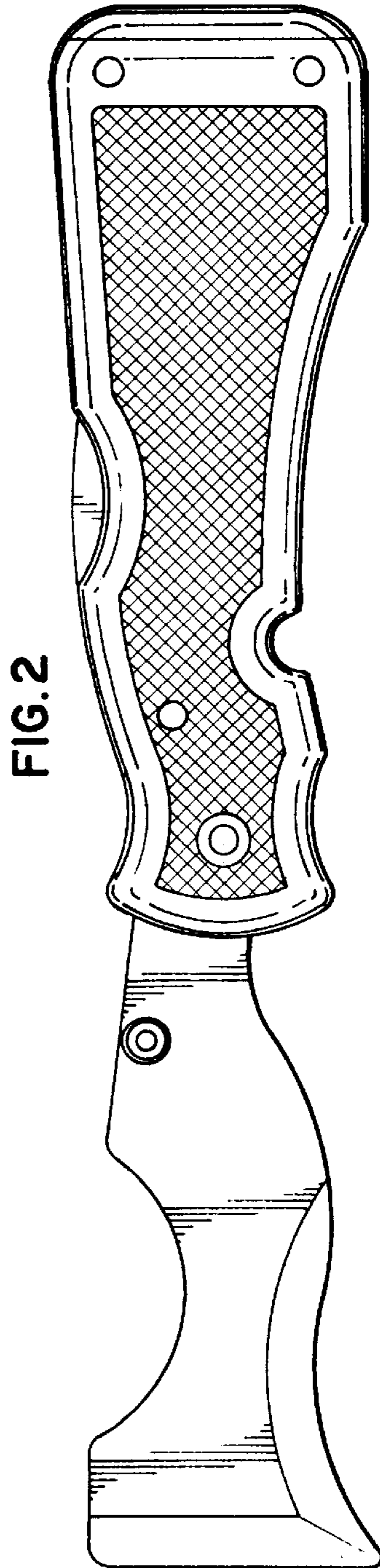

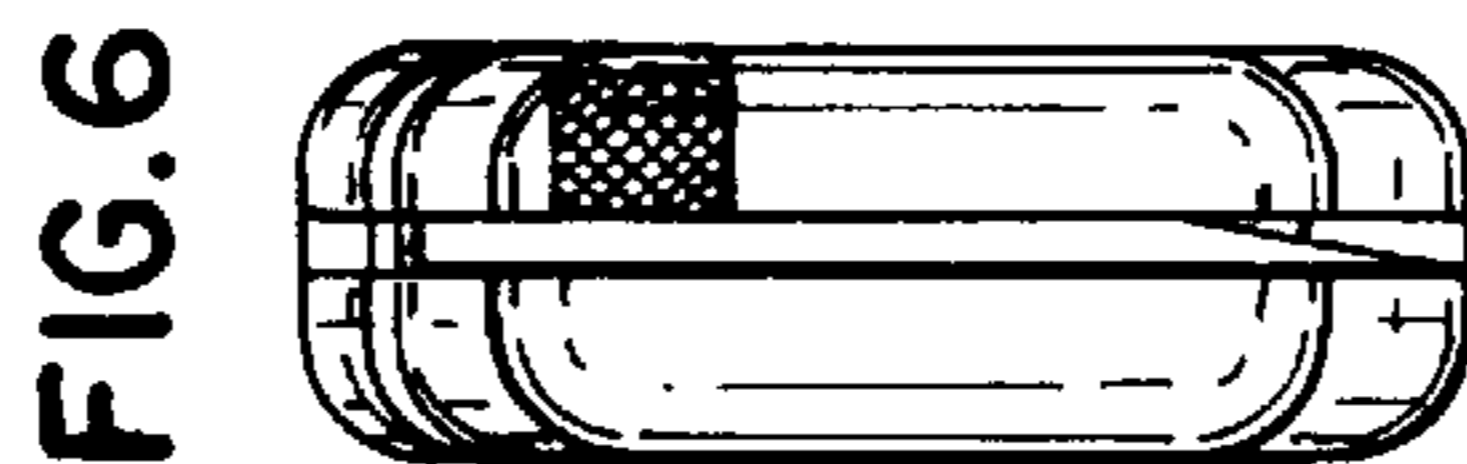

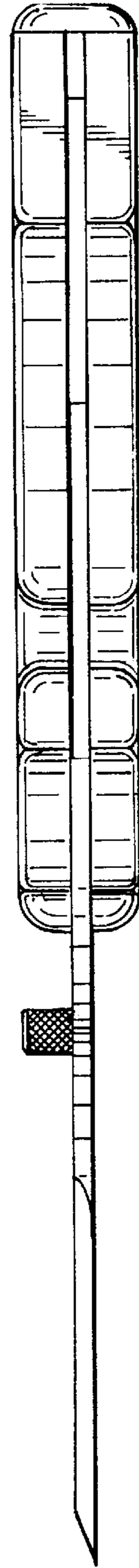
