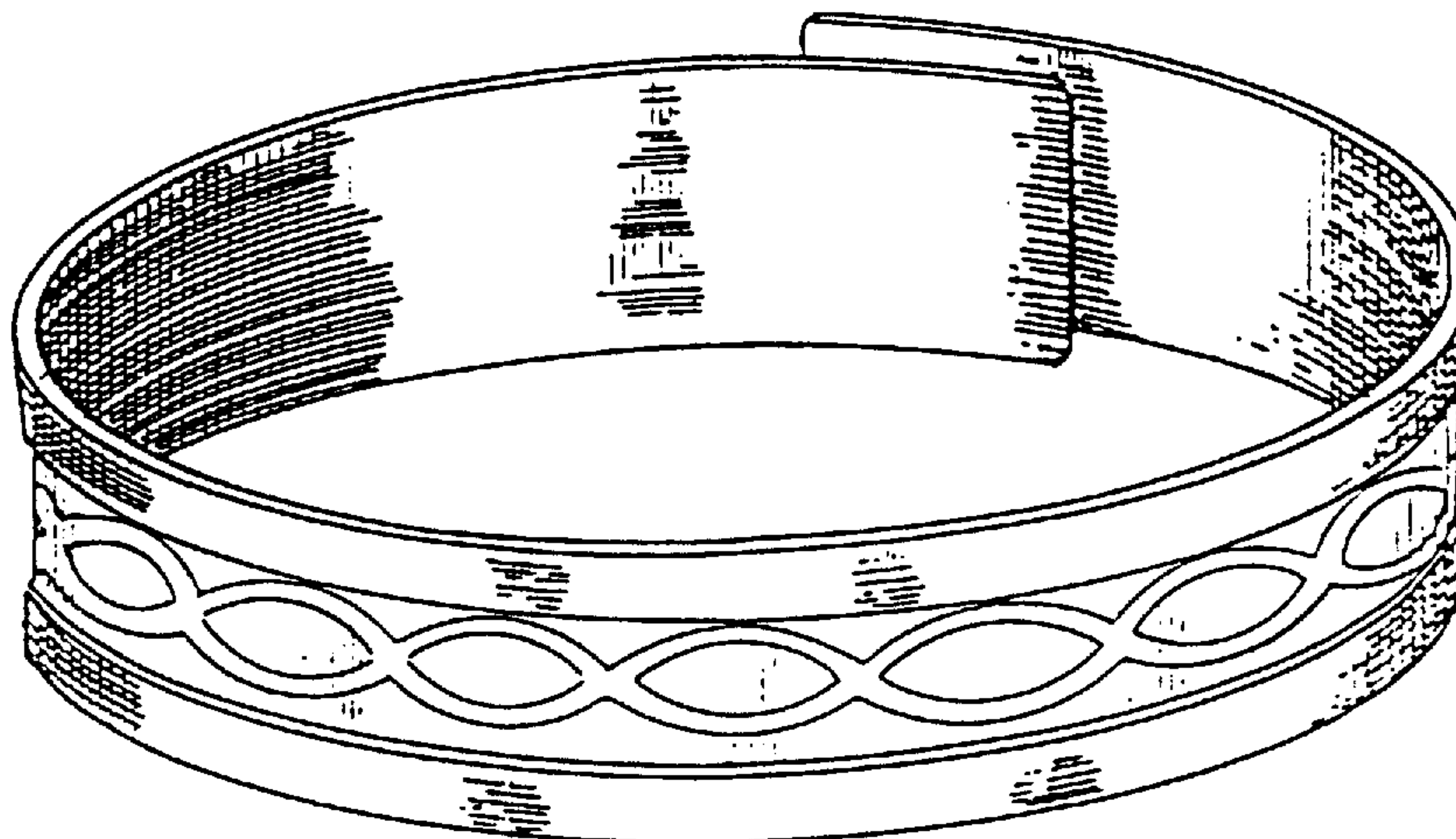

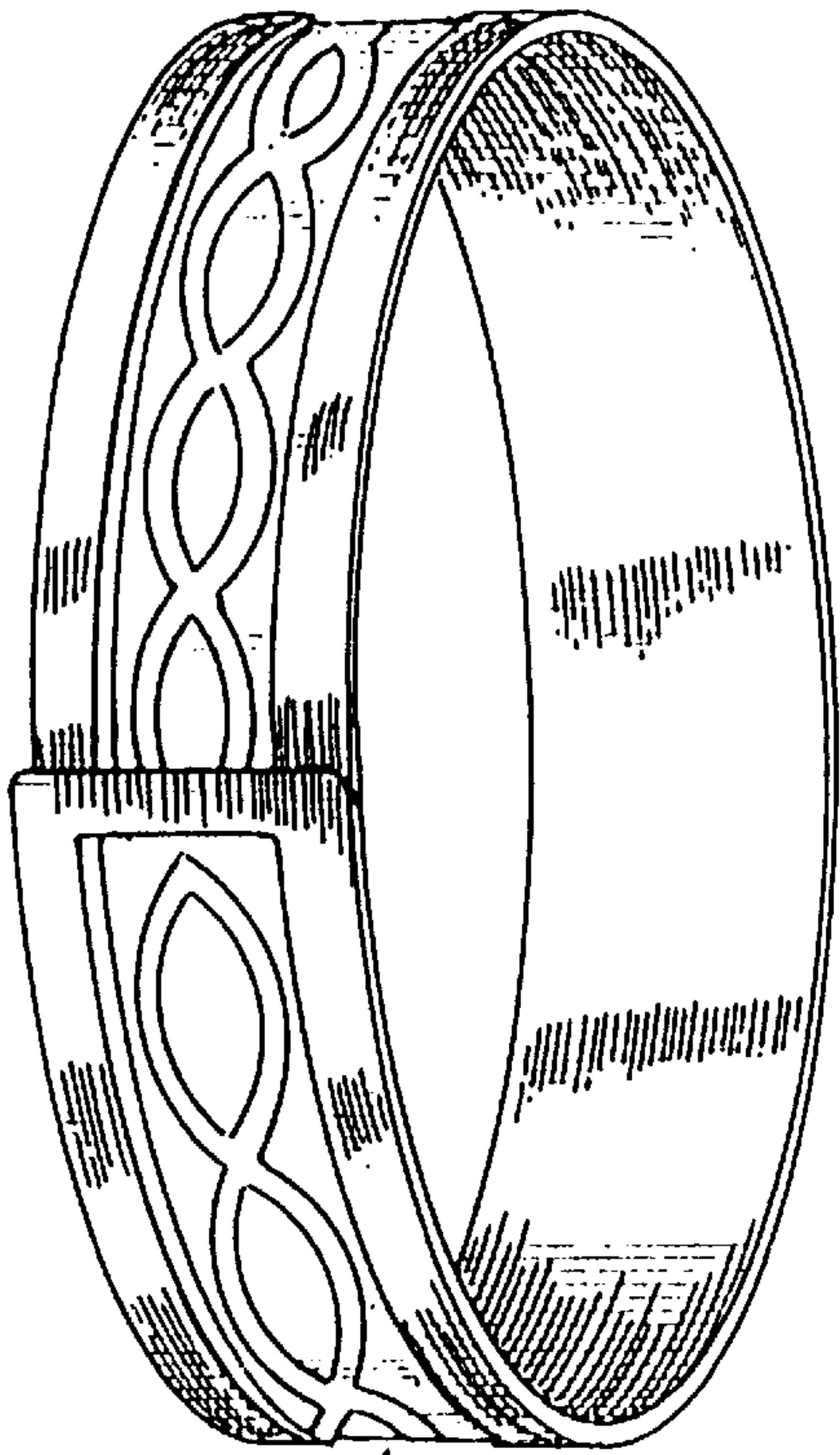
The ornamental design for an illuminated belt, as shown.

**DESCRIPTION**

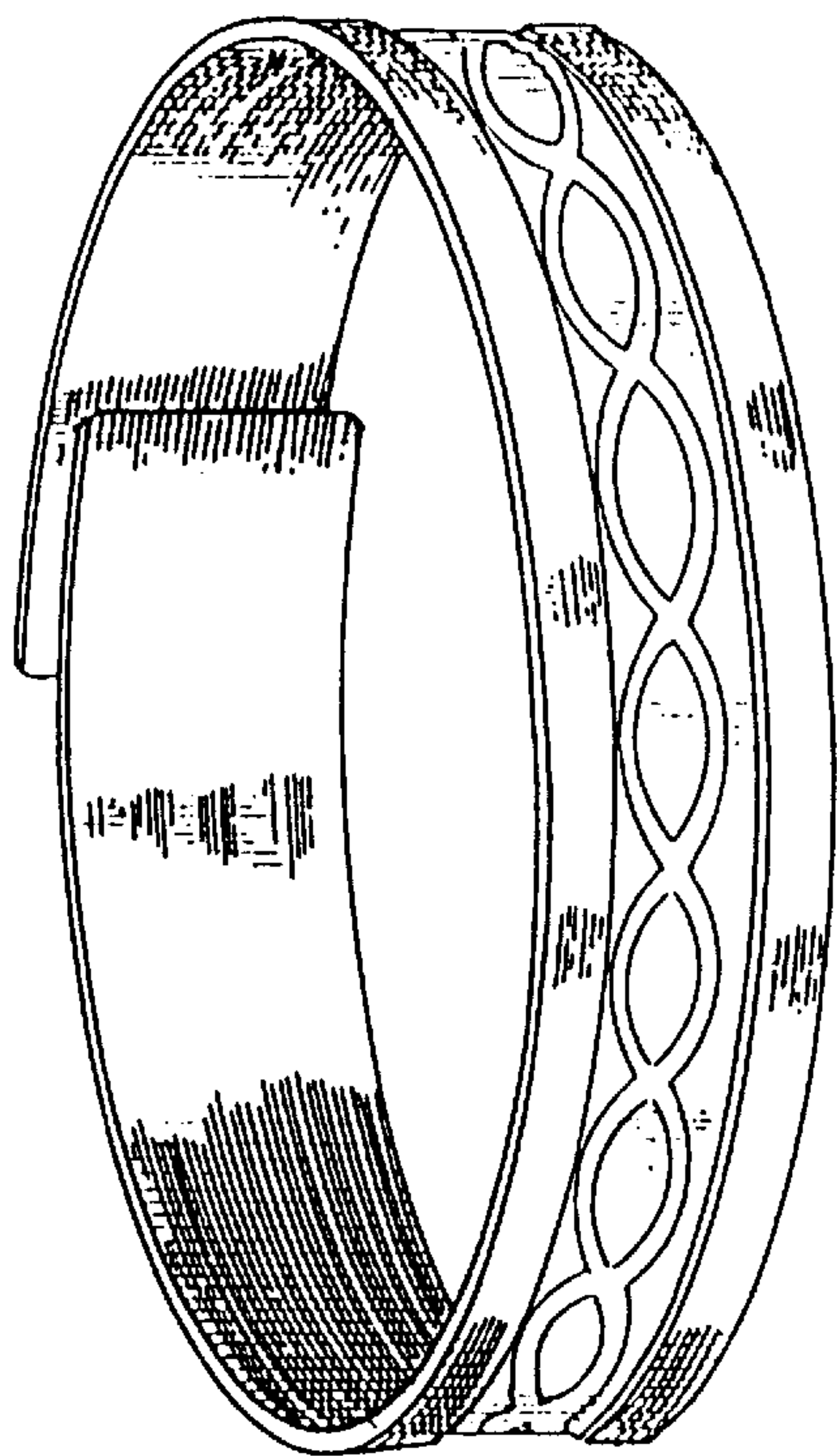
FIG. 1 is a rear perspective view of an illuminated belt showing our new design;

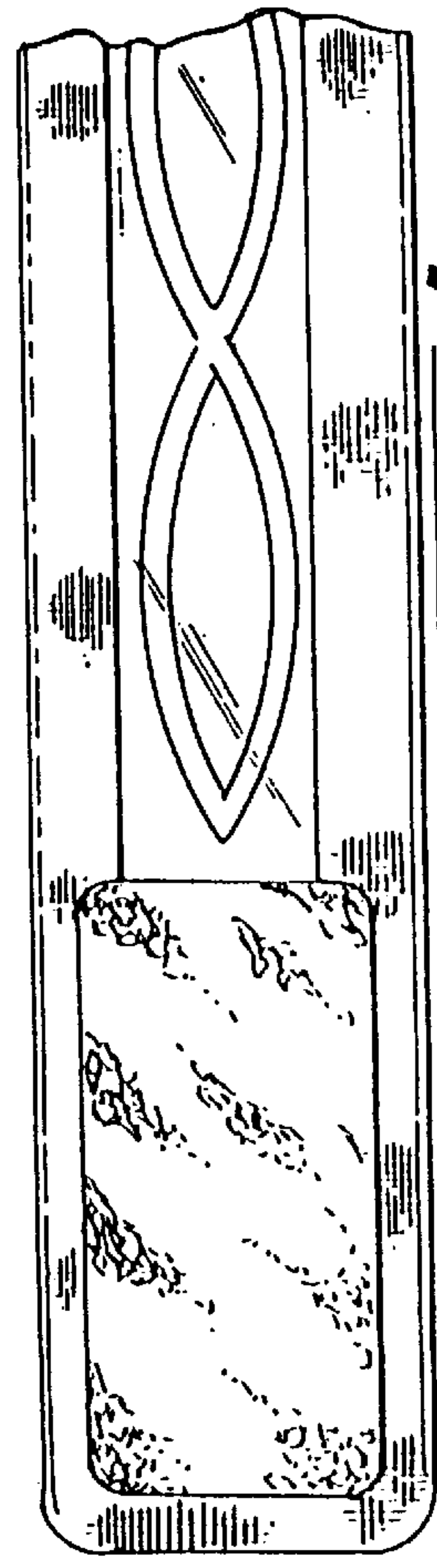
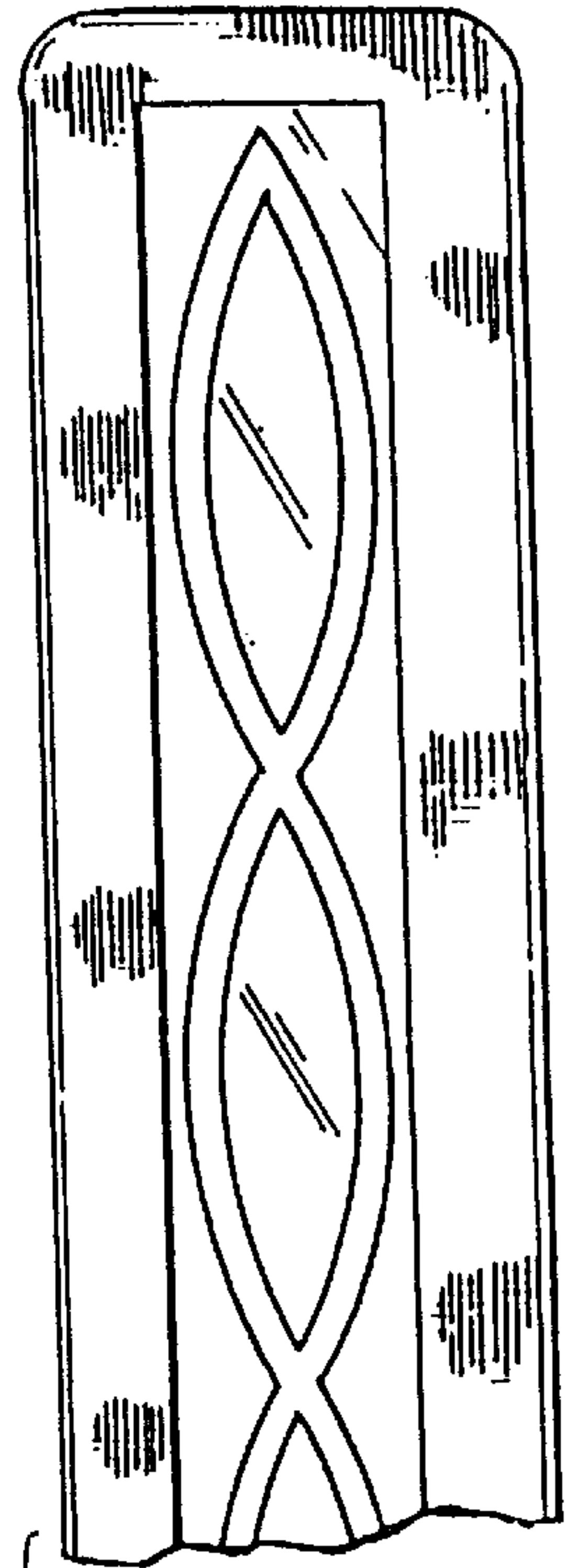

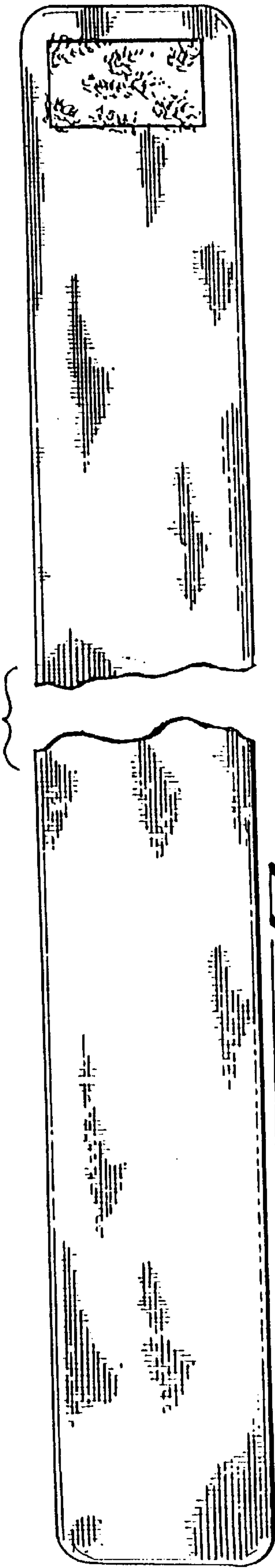

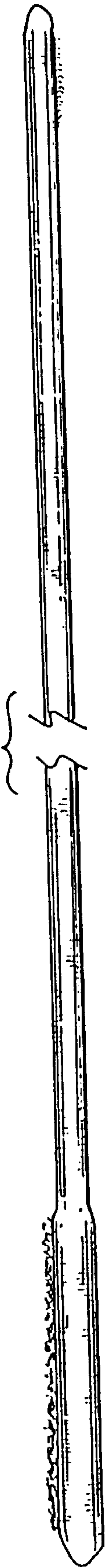

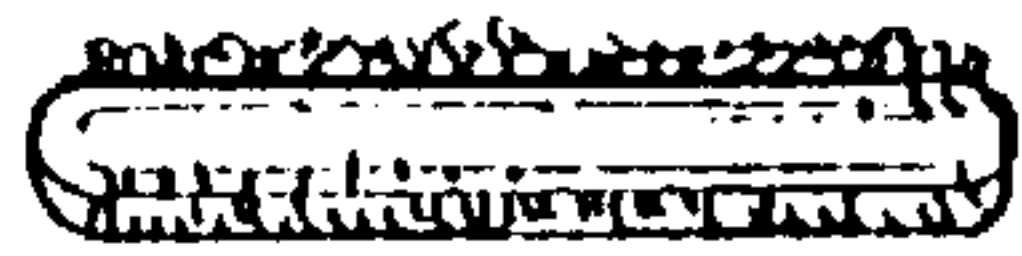

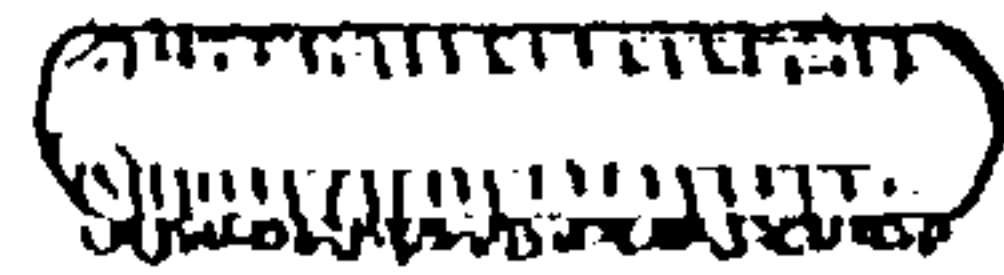
