## [57] CLAIM

We claim the ornamental design for the skate boot, as shown and described.

FIG. 1 is a right side and rear perspective view of a skate boot, showing our new design;

FIG. 2 is a right side, rear and bottom perspective view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a front elevational view thereof;

FIG. 8 is a right side and rear perspective view of a second embodiment;

FIG. 9 is a right side, rear and bottom perspective view thereof;

FIG. 10 is a right side elevational view thereof;

FIG. 11 is a left side elevational view thereof;

FIG. 12 is a bottom plan view thereof;

FIG. 13 is a rear elevational view thereof; and,

FIG. 14 is a front elevational view thereof.

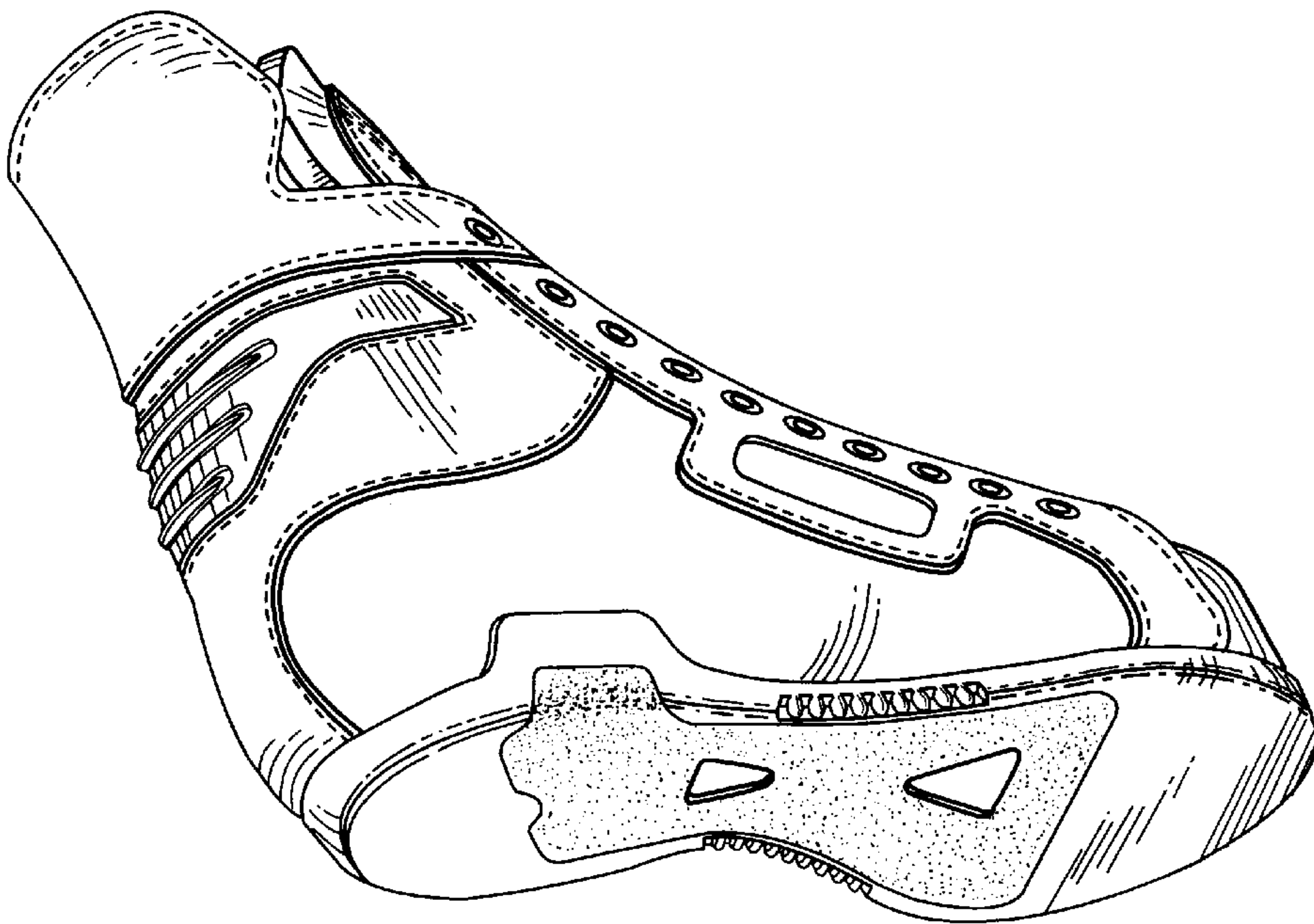

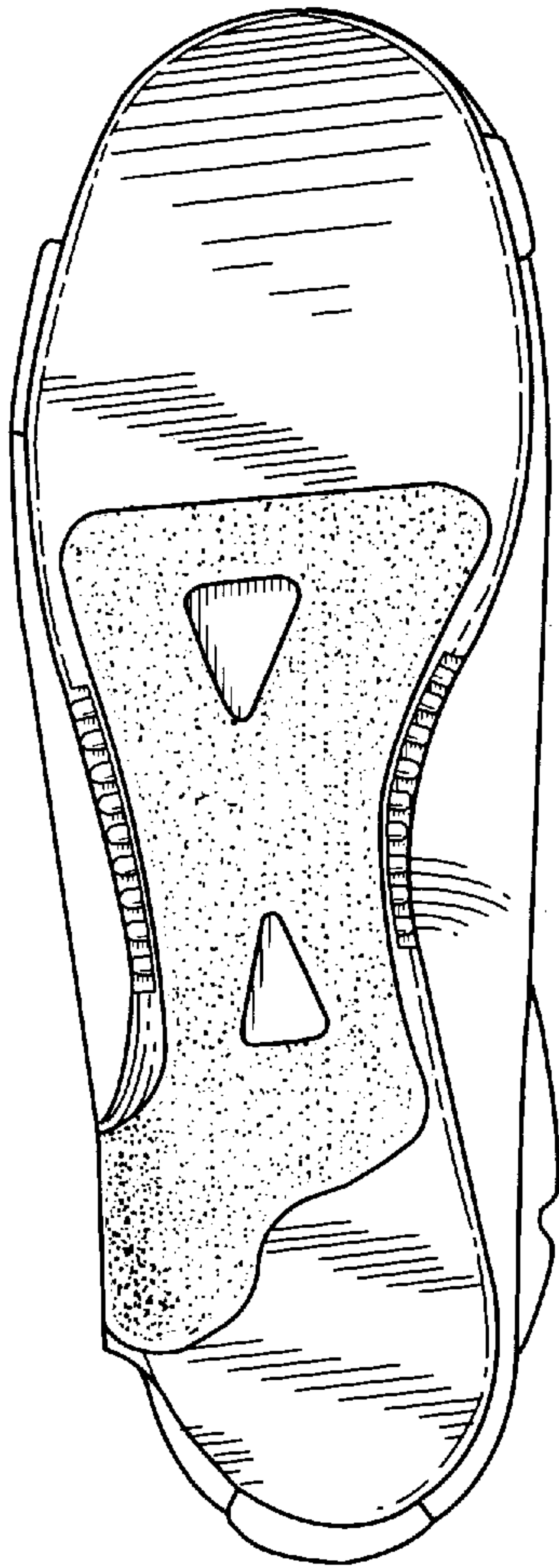

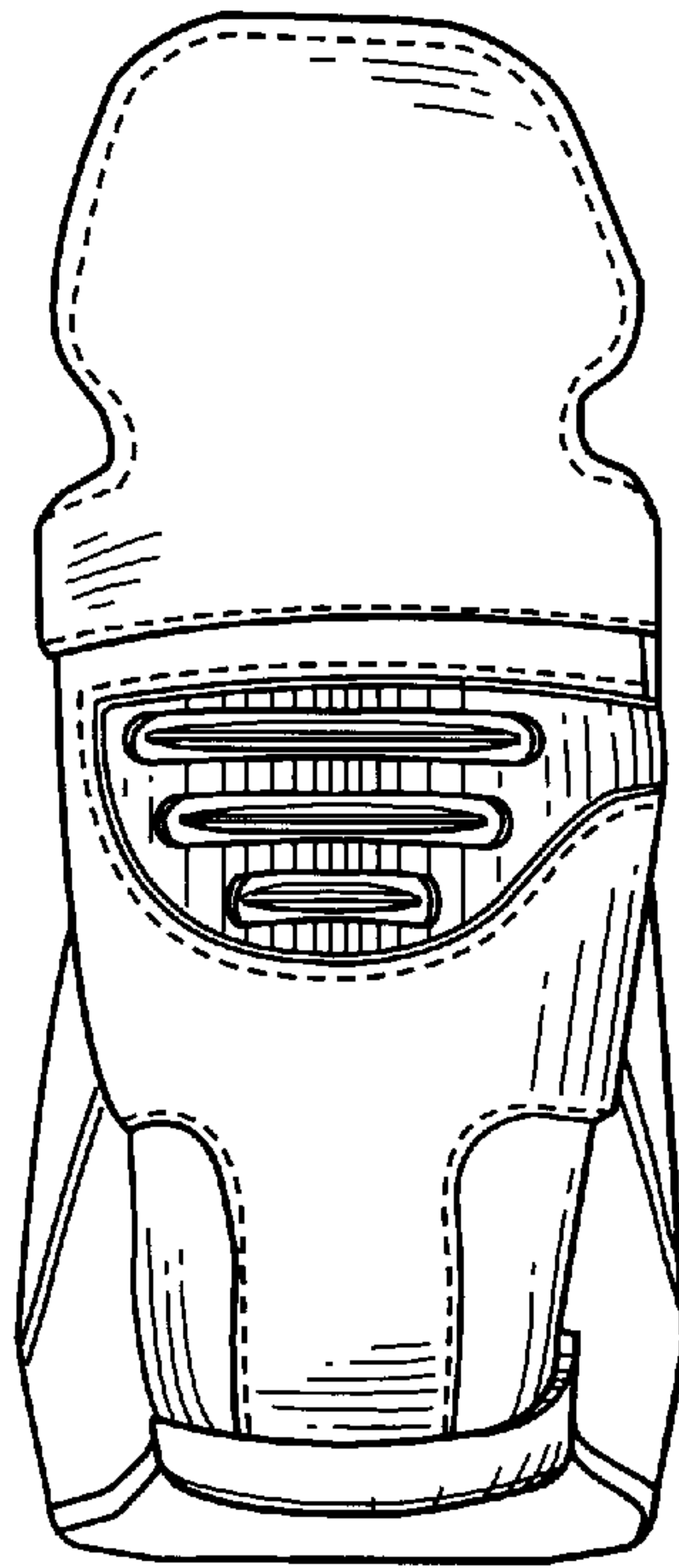

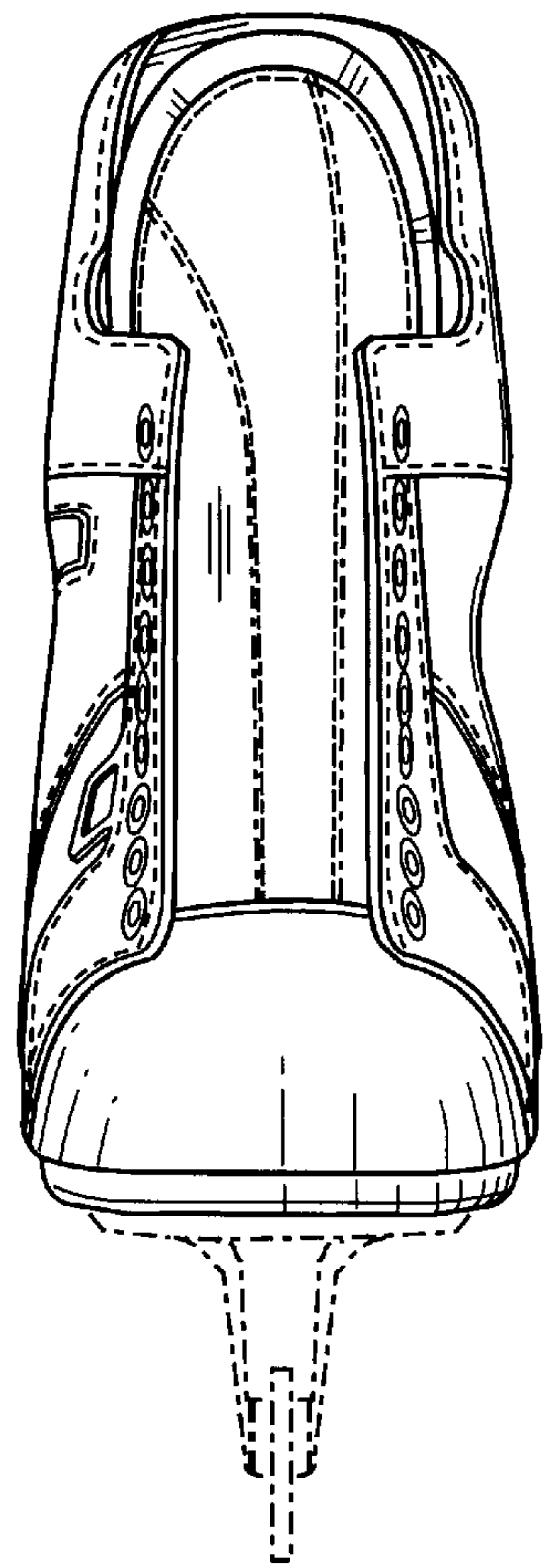

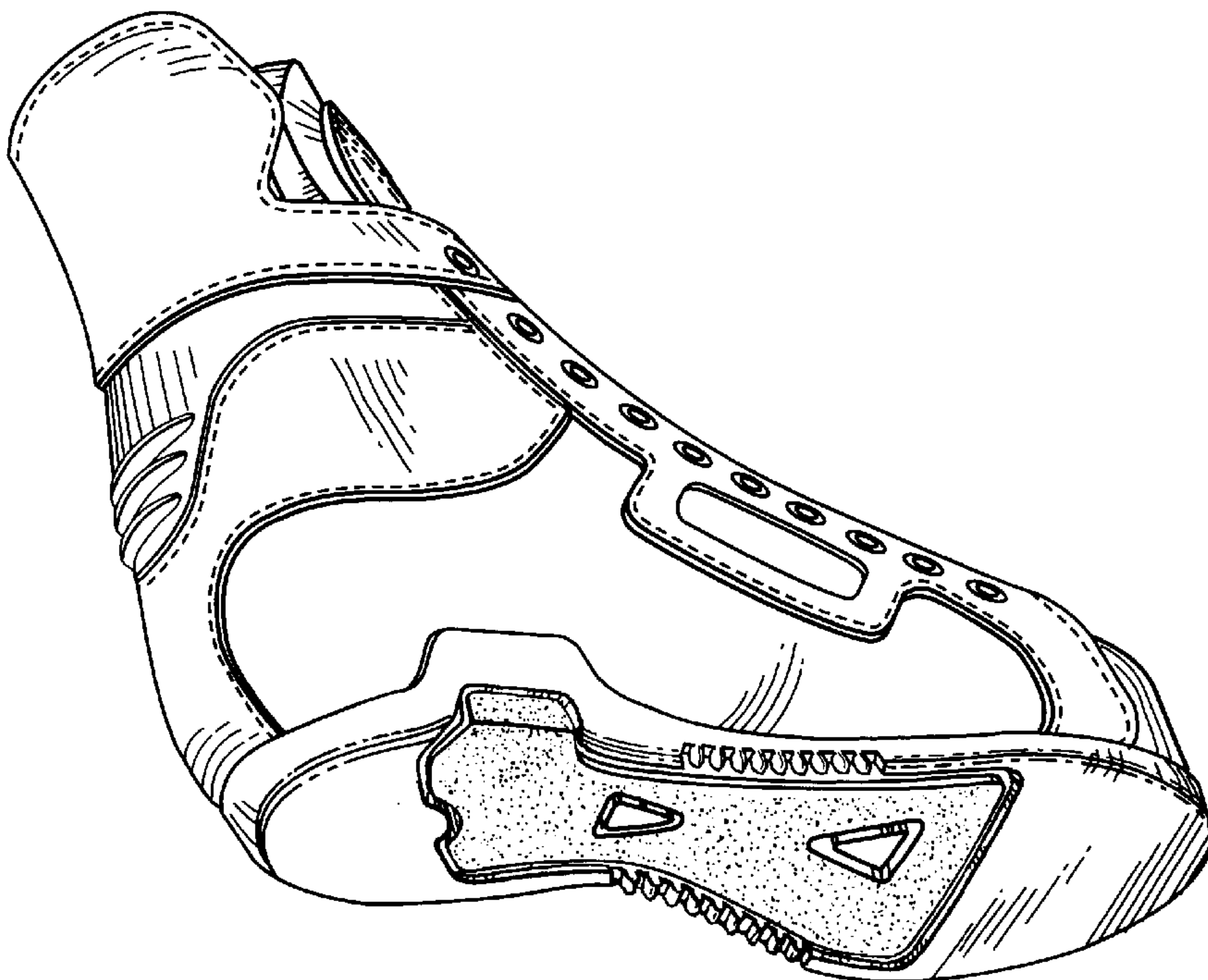

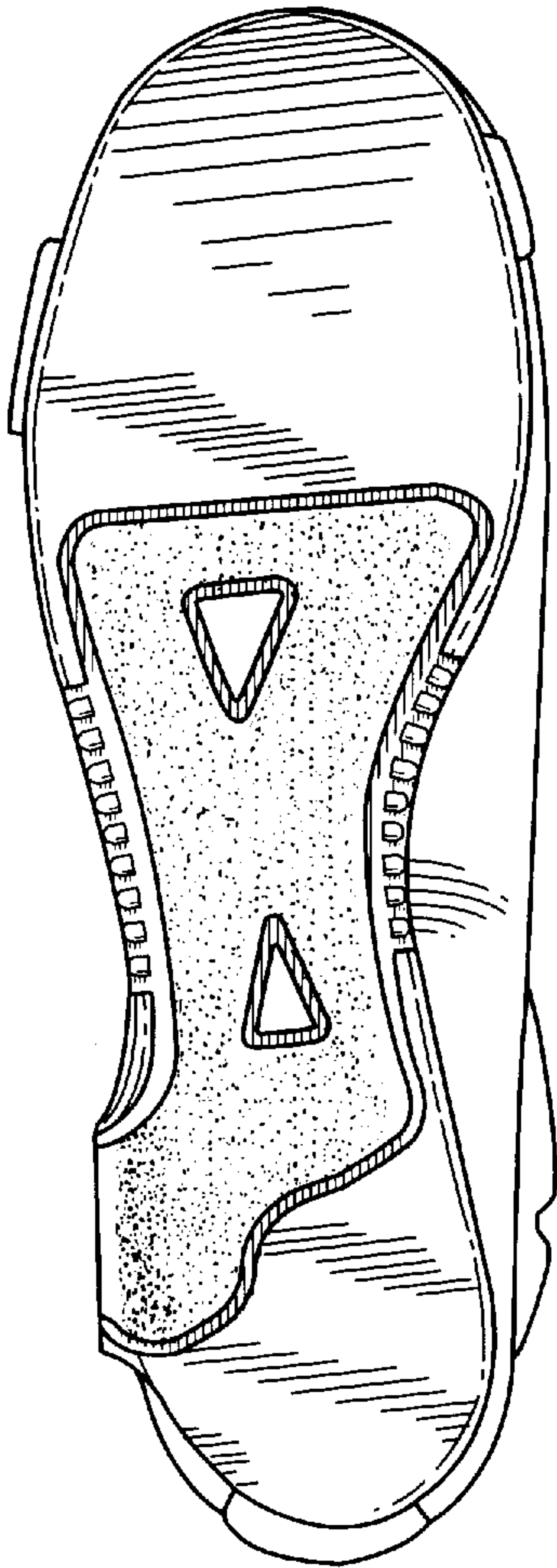

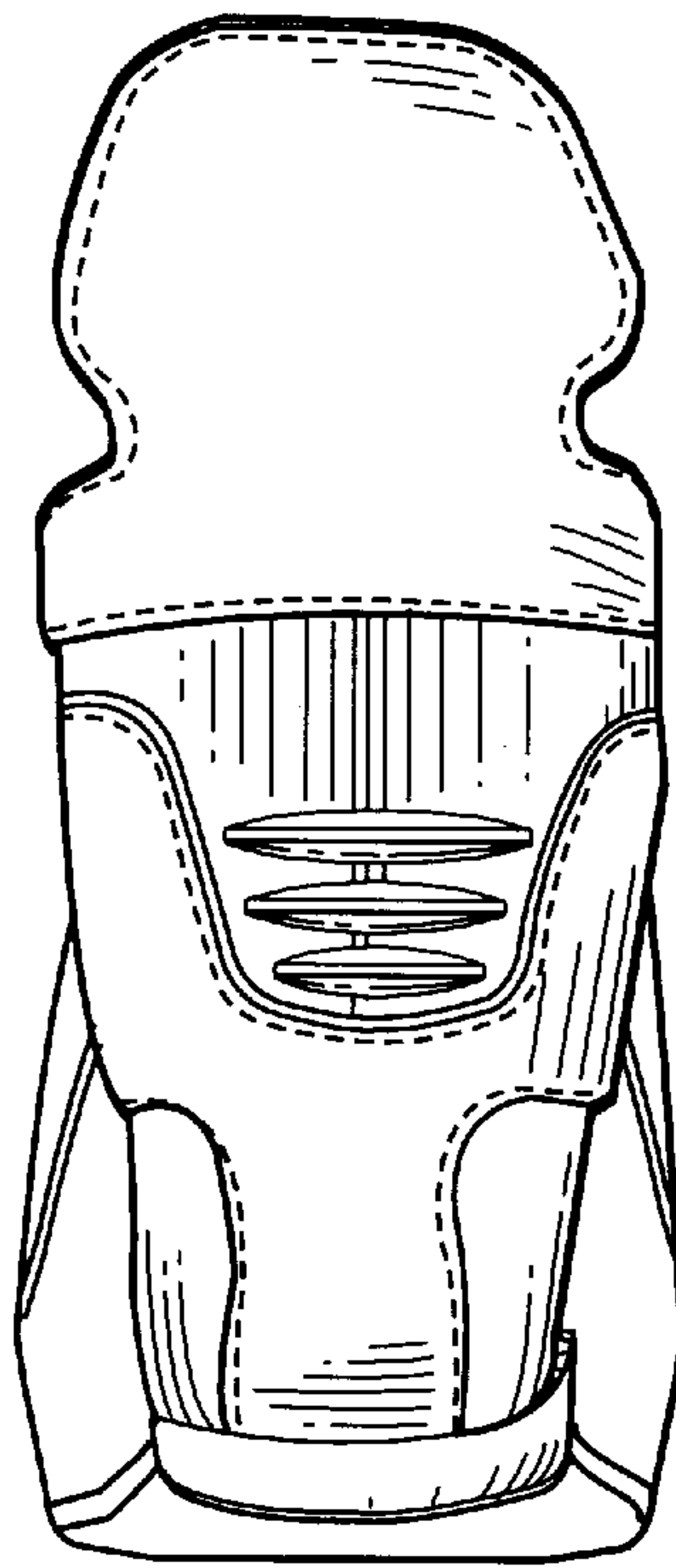

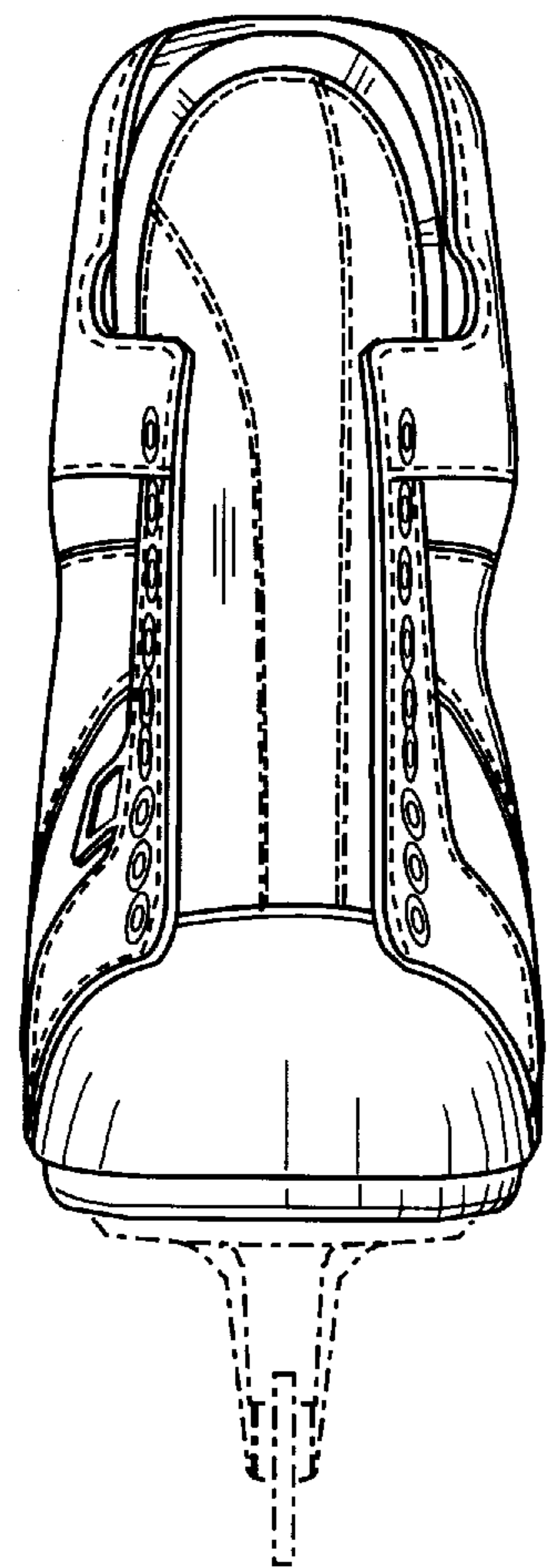
