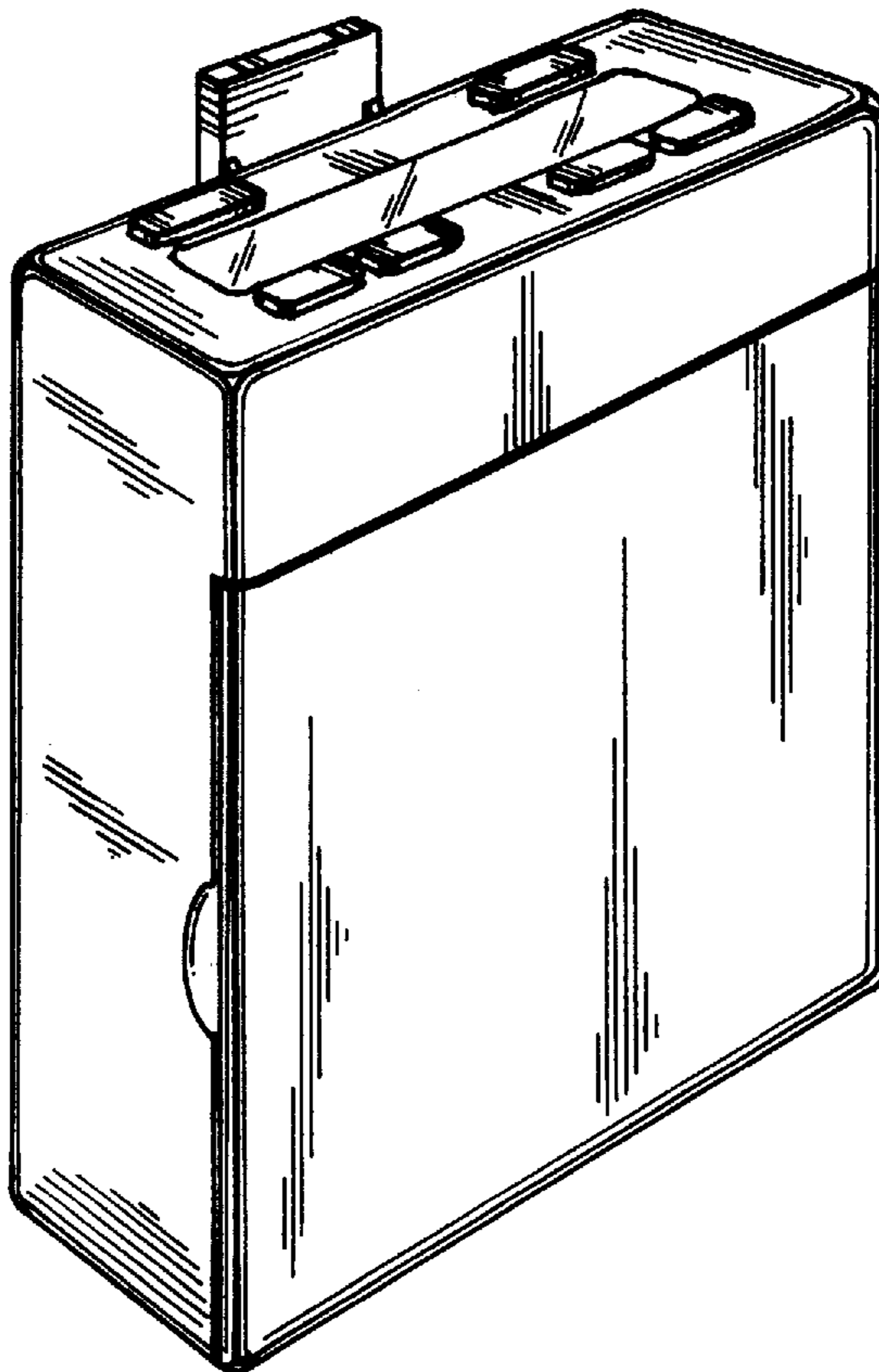
[57] **CLAIM**

The ornamental design for a pager-shaped pill box with clip,
as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a pager-shaped pill box
with clip having an access door in a closed position;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a top plan view thereof illustrating a prominent
display screen;
FIG. 7 is a bottom plan view of embodiments 1 and 2;
FIG. 8 is the front perspective view of a second embodi-
ment;
FIG. 9 is a front elevational view thereof;
FIG. 10 is the right side elevational view thereof;
FIG. 11 is the left side elevational view thereof;
FIG. 12 is the rear elevational view thereof; and,
FIG. 13 is the top plan view.

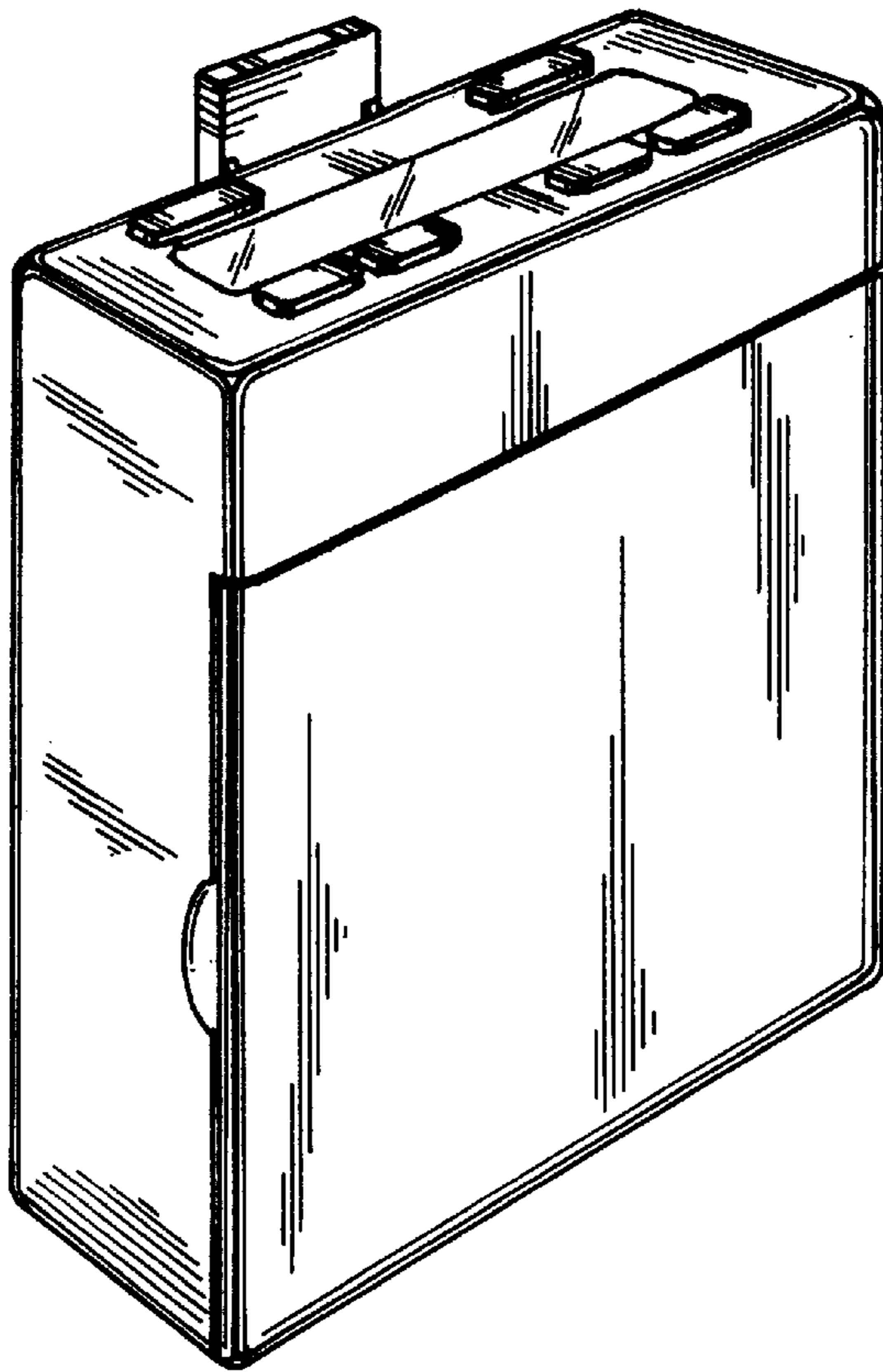

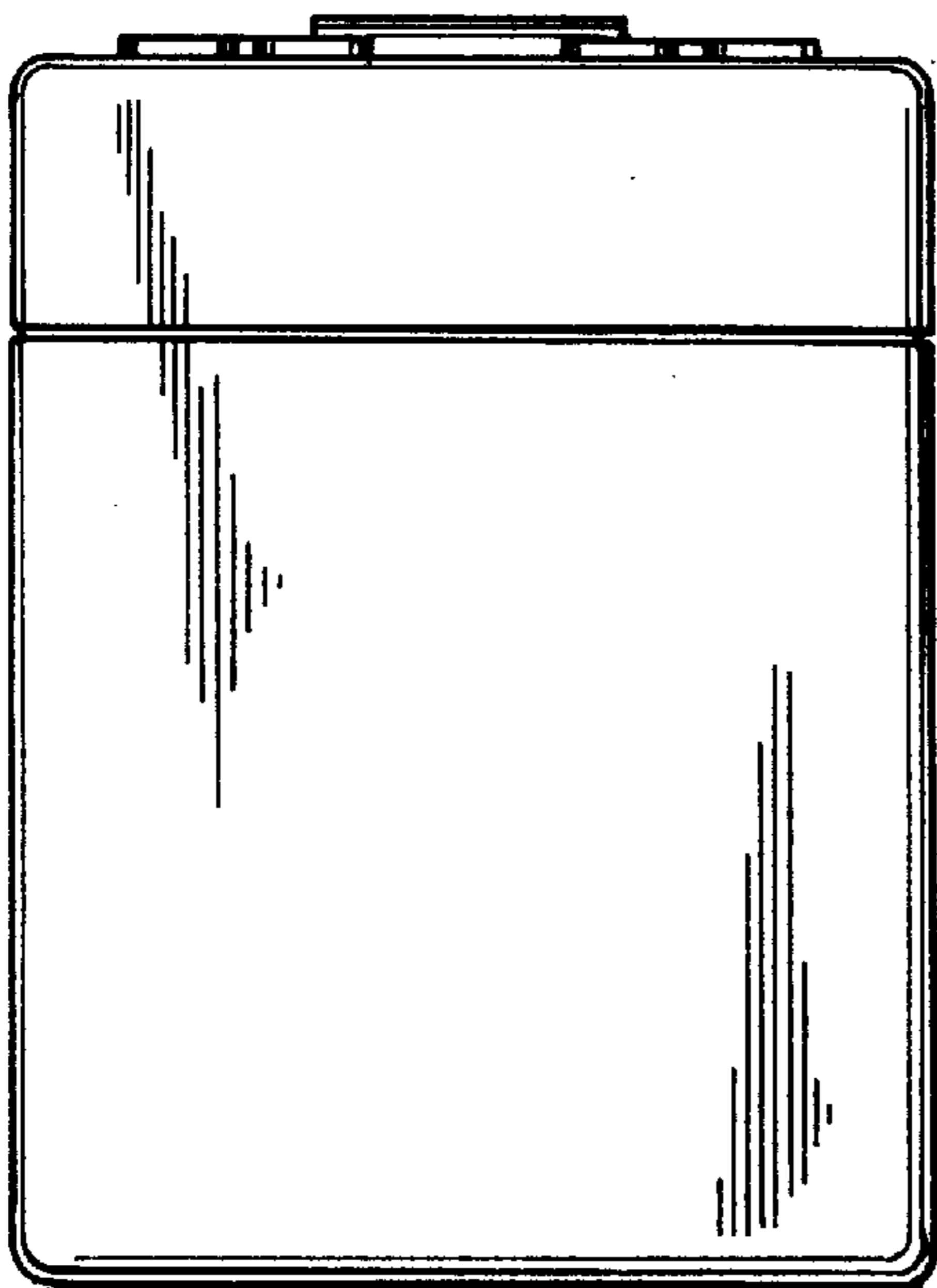

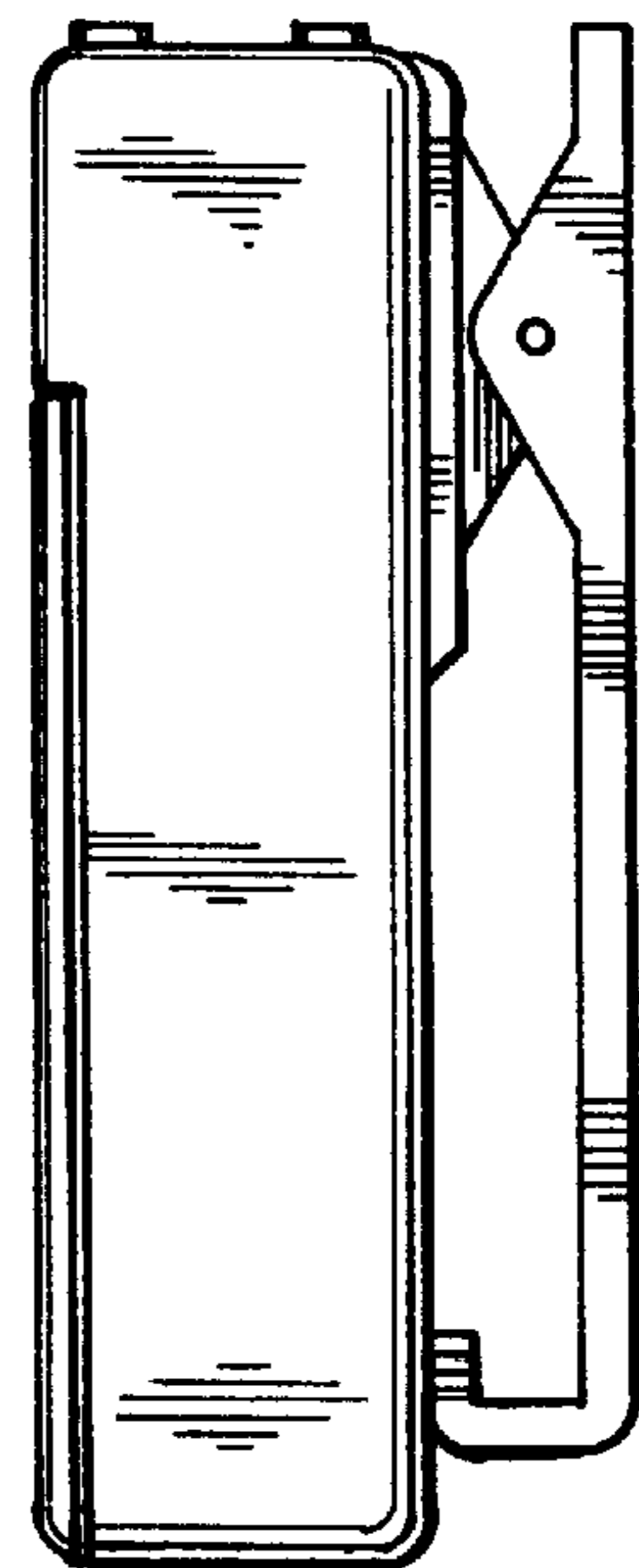

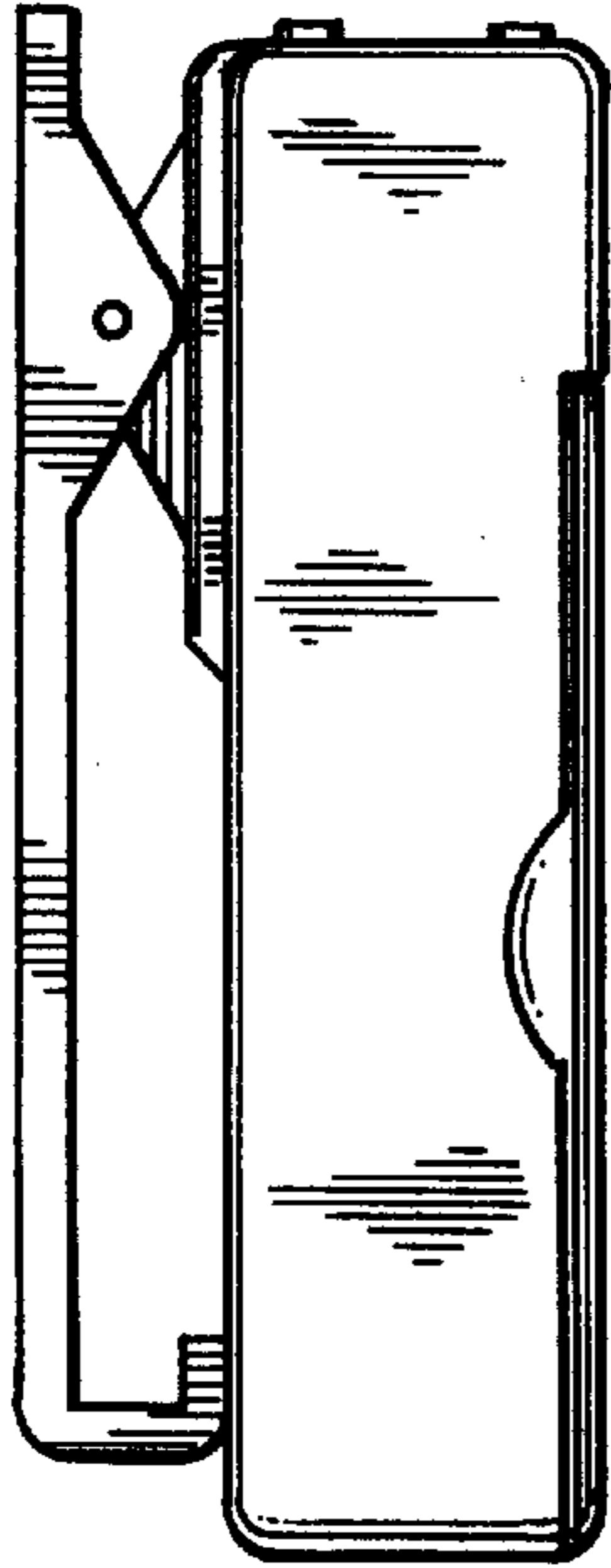

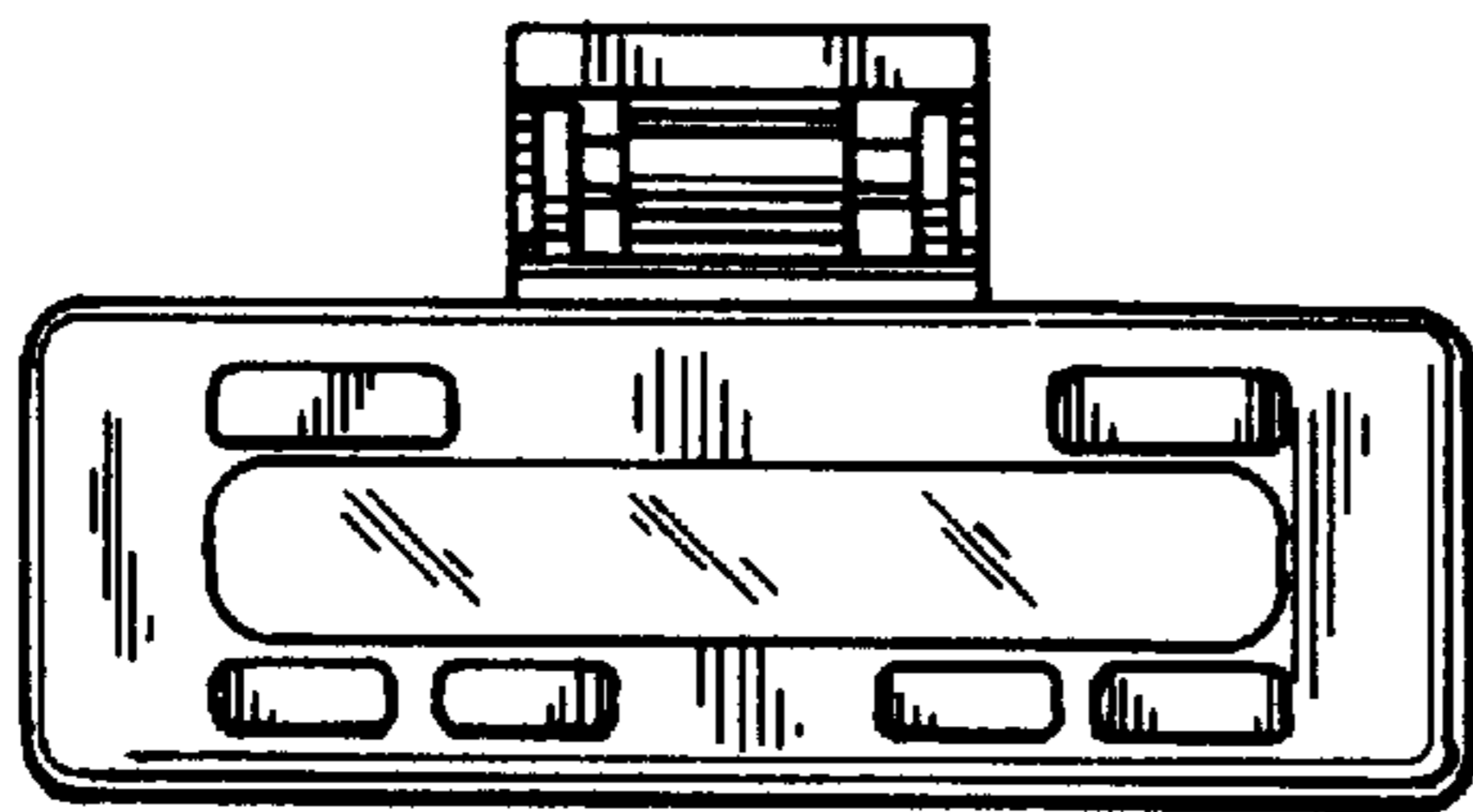
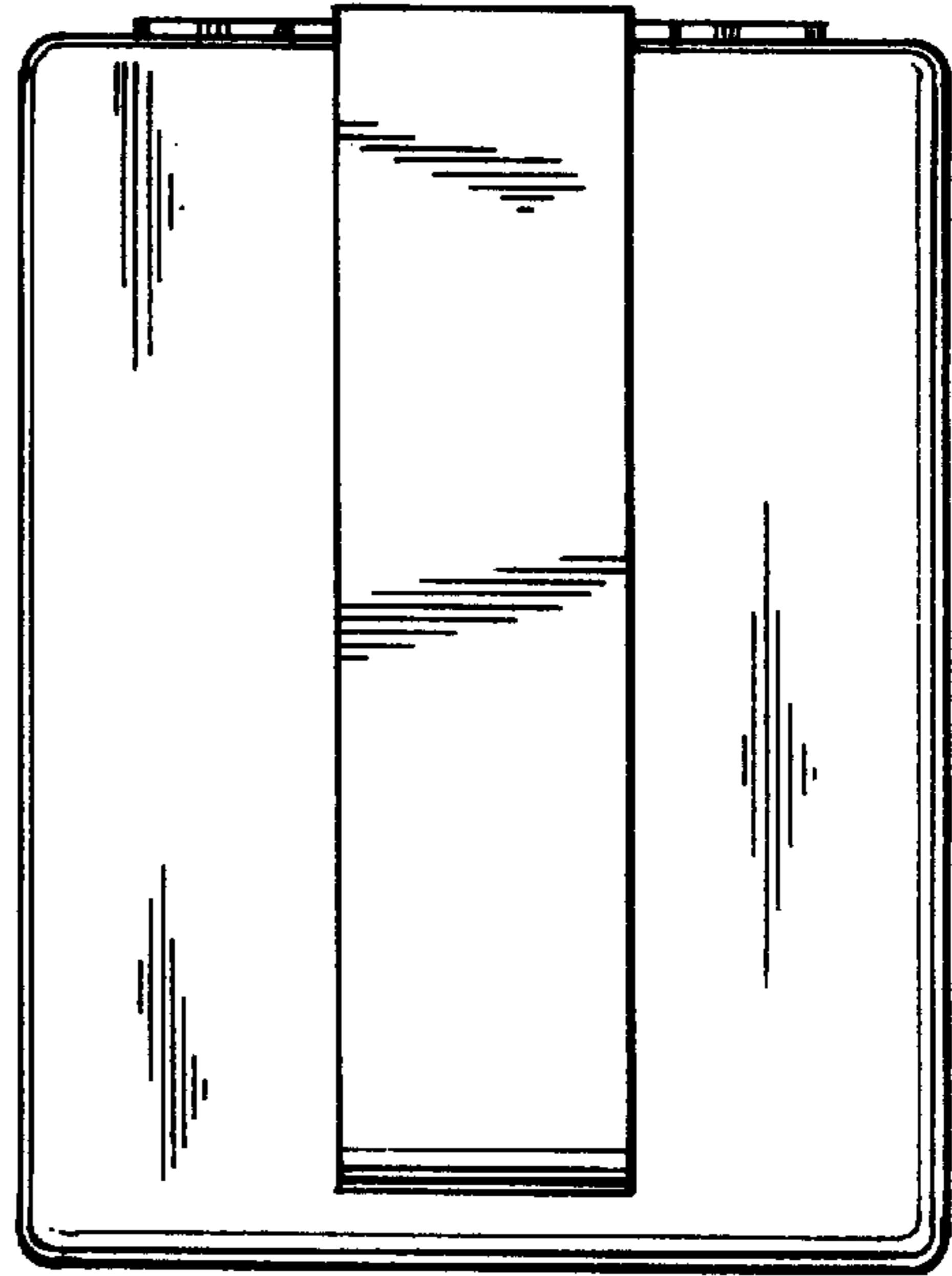

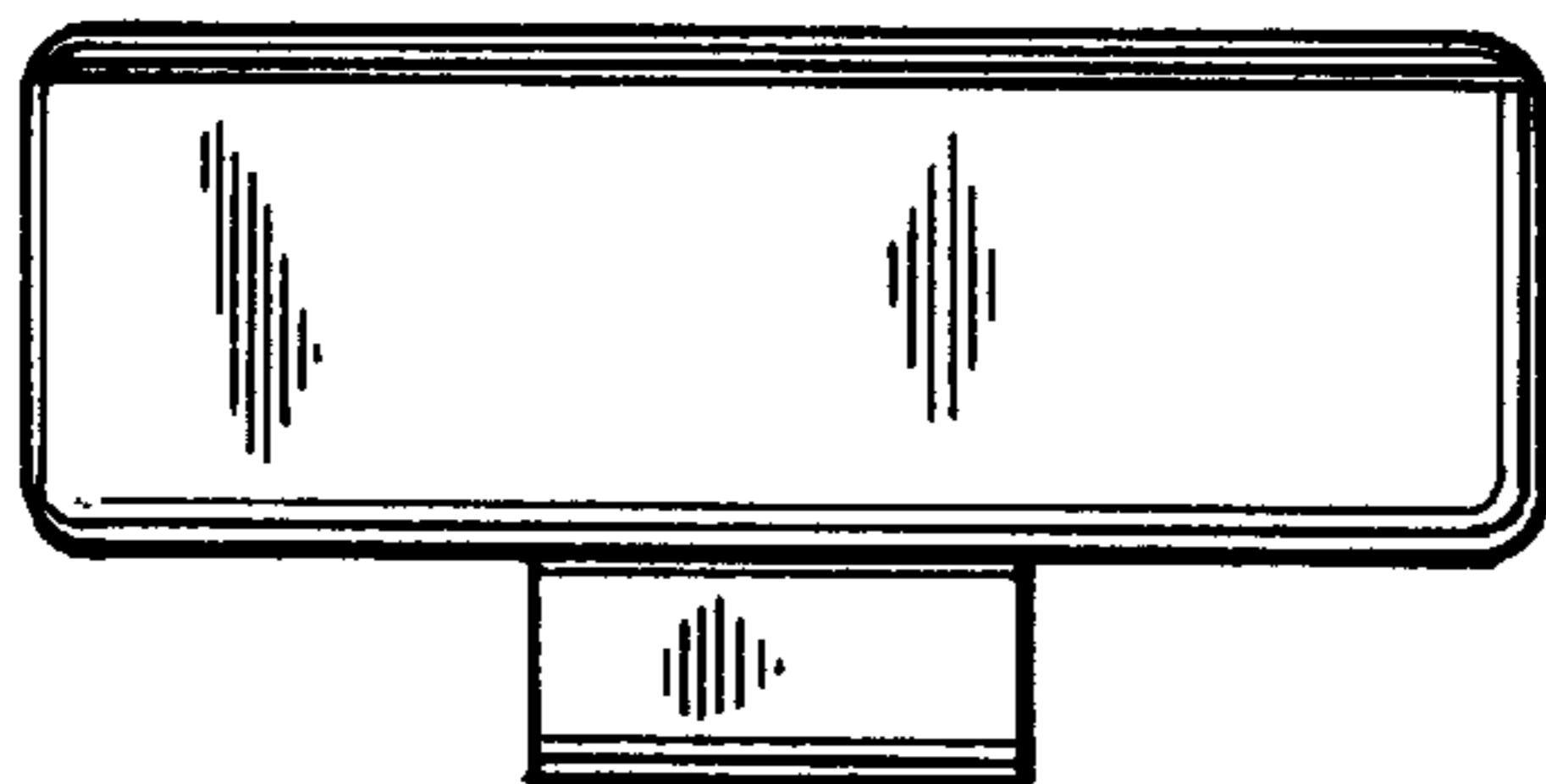

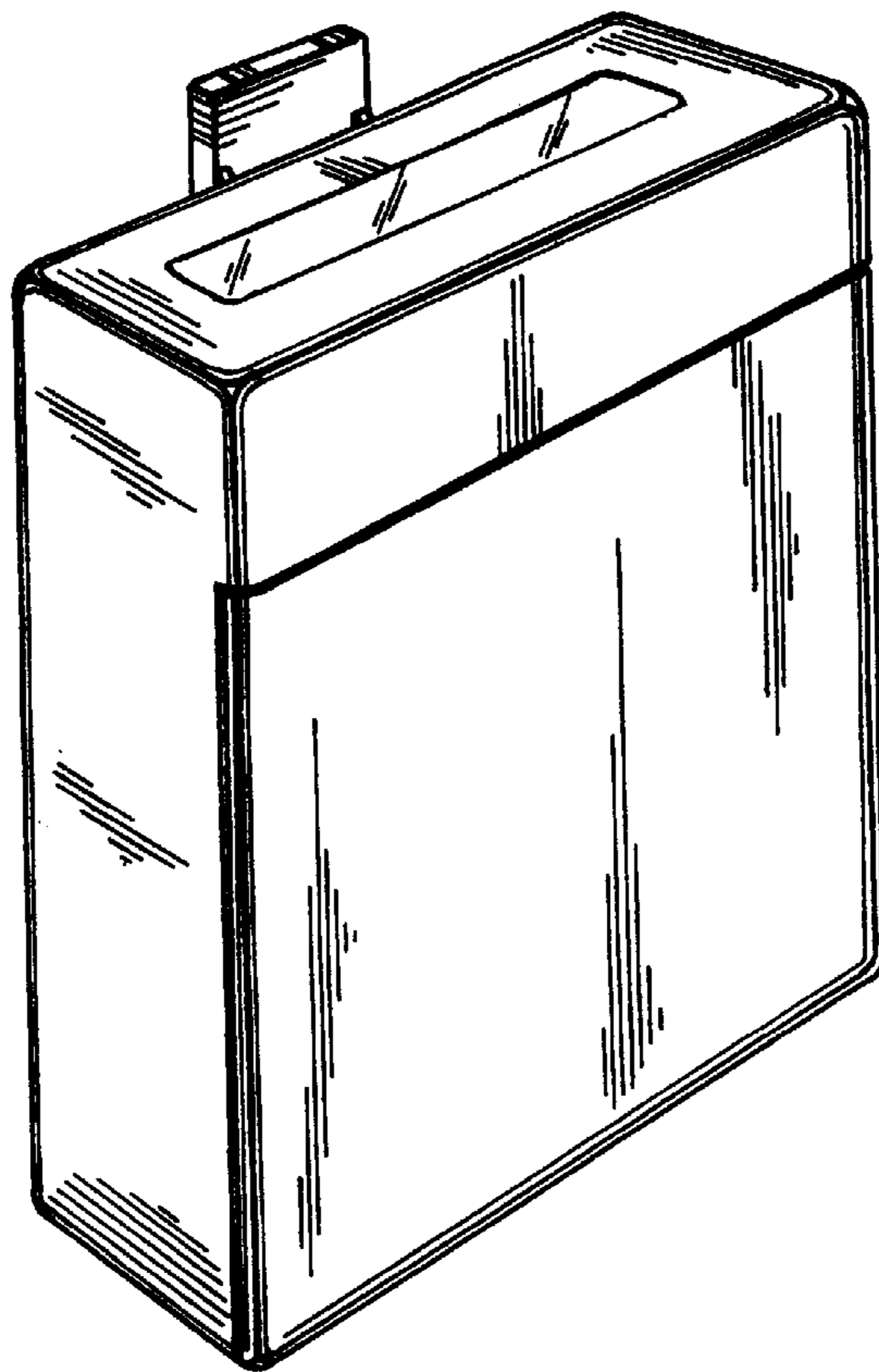

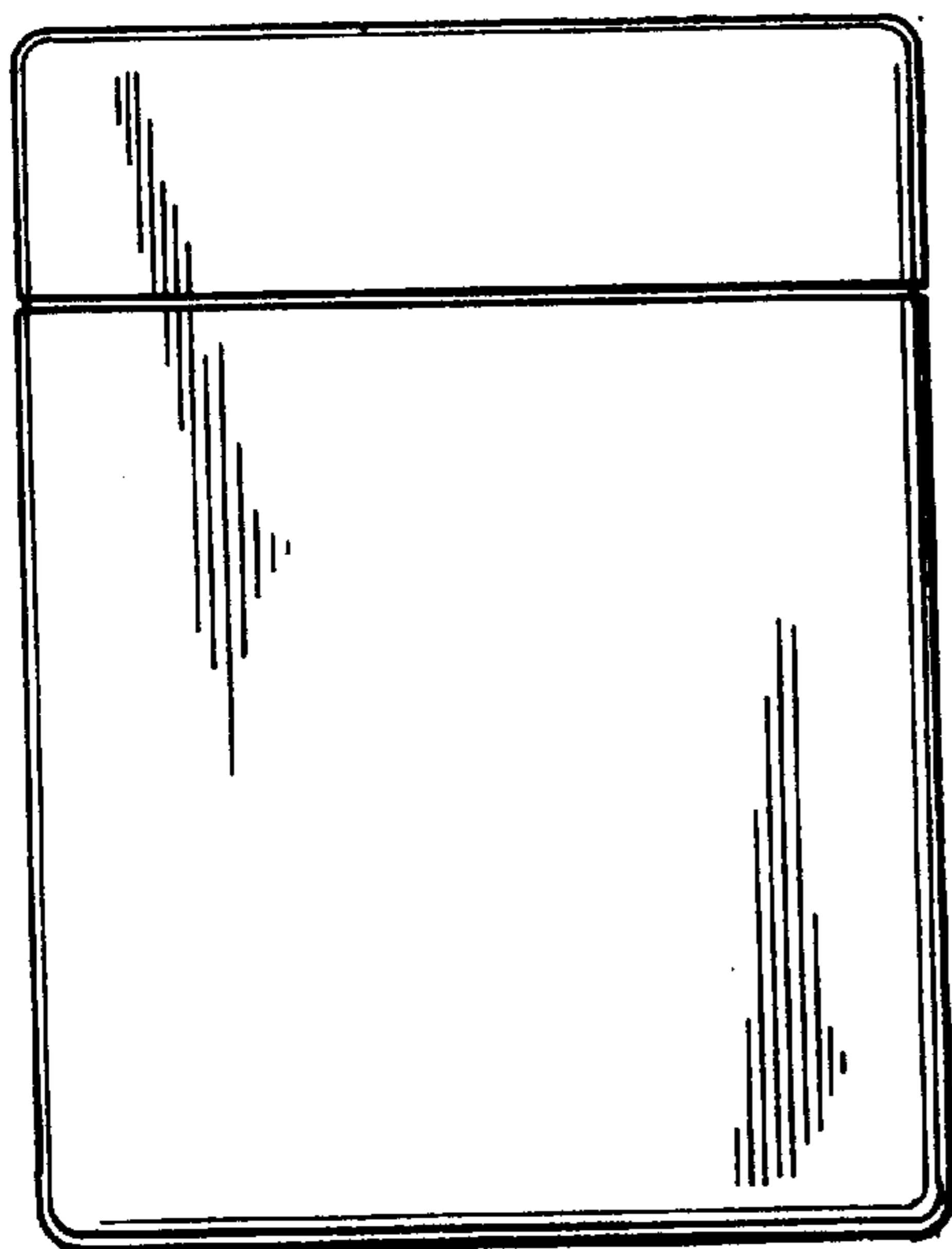

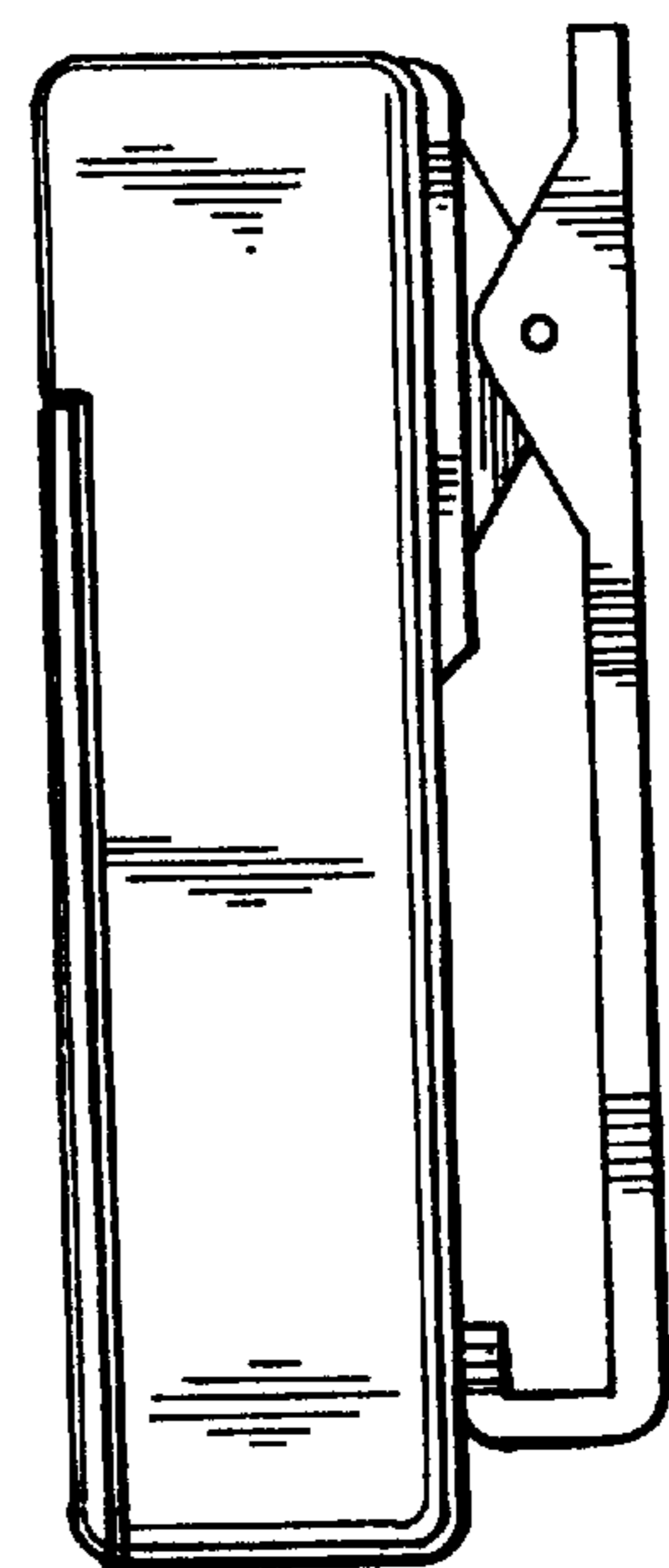

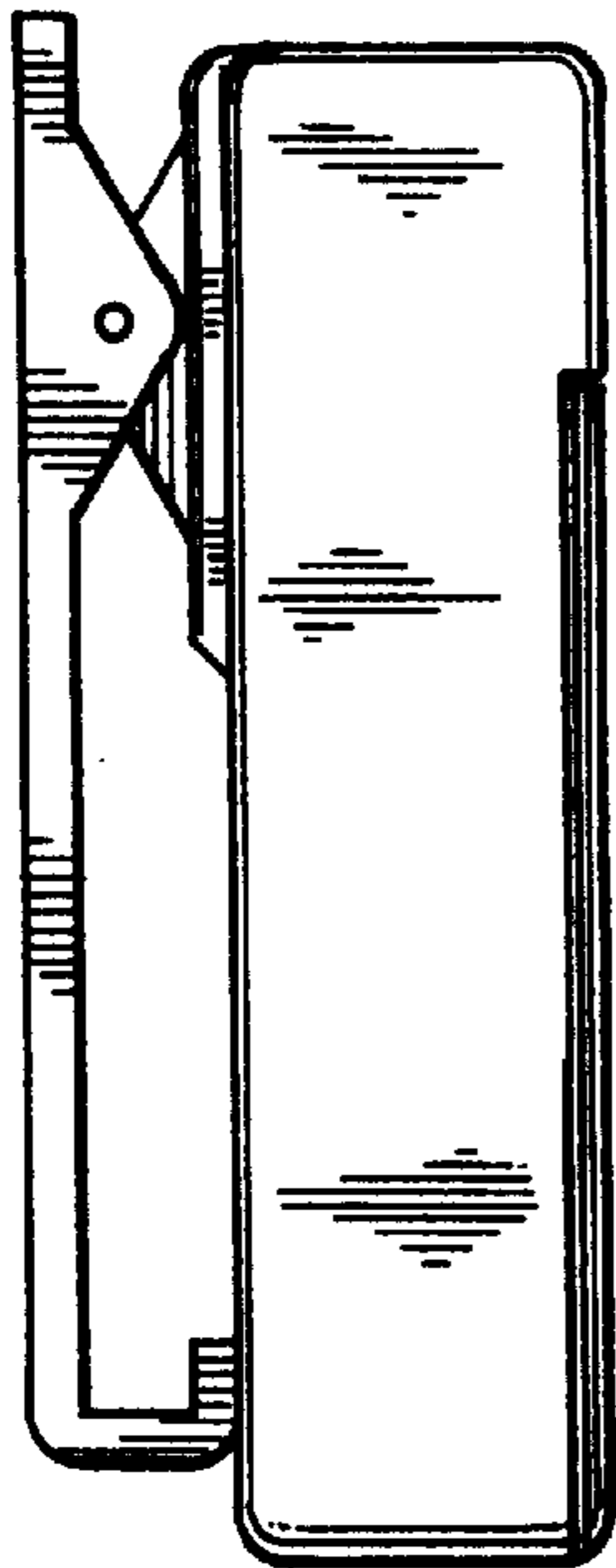

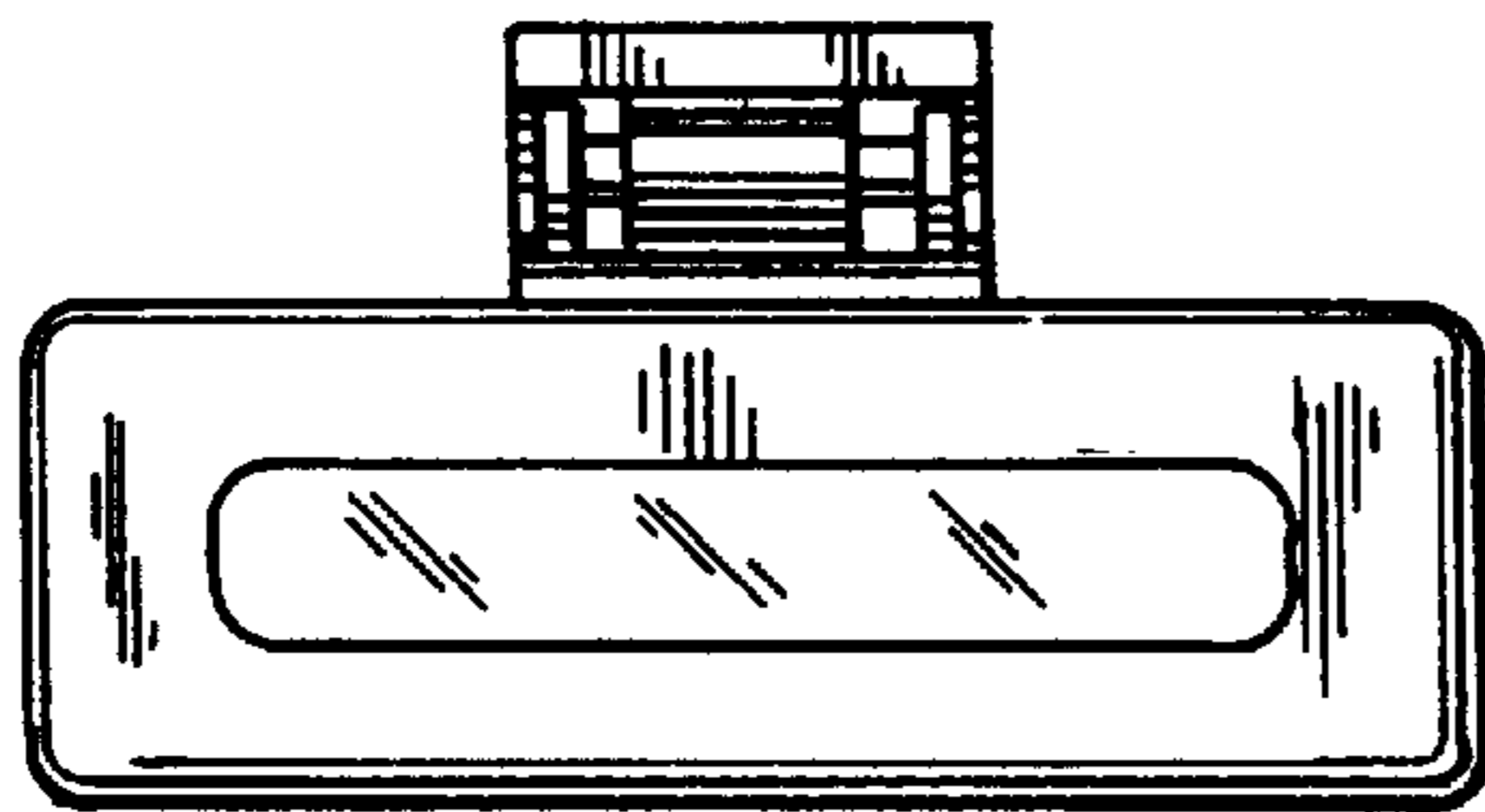
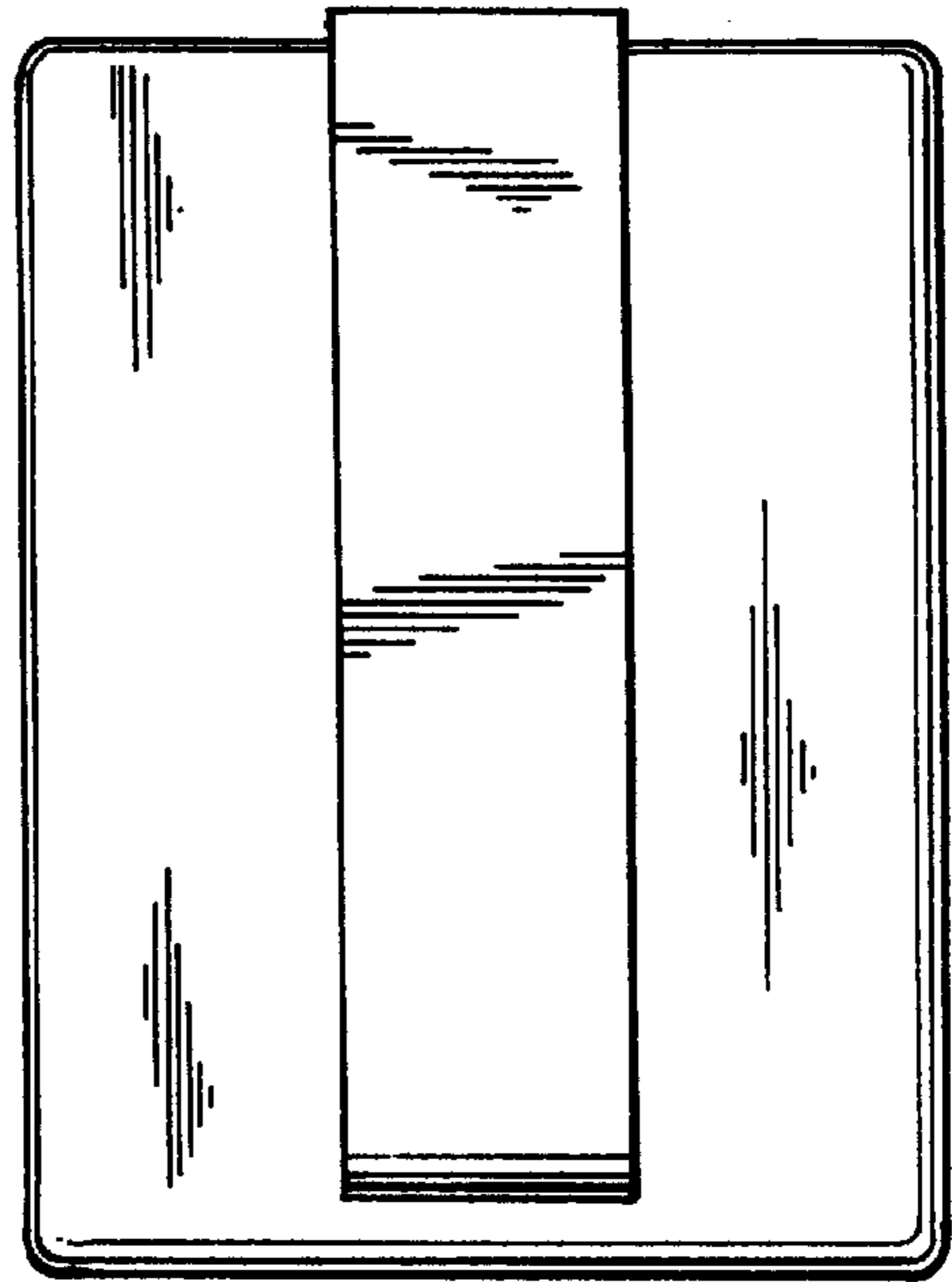
