FIG. 3 is a front elevational view thereof;  
FIG. 4 is an elevational view of one side, the other side being a mirror image thereof;  
FIG. 5 is a bottom plan view thereof; and,  
FIG. 6 is a perspective view of the stackable tray after the glued blank therefor has been erected.  
The broken line showing on FIGS. 1 and 3 represent fold lines.

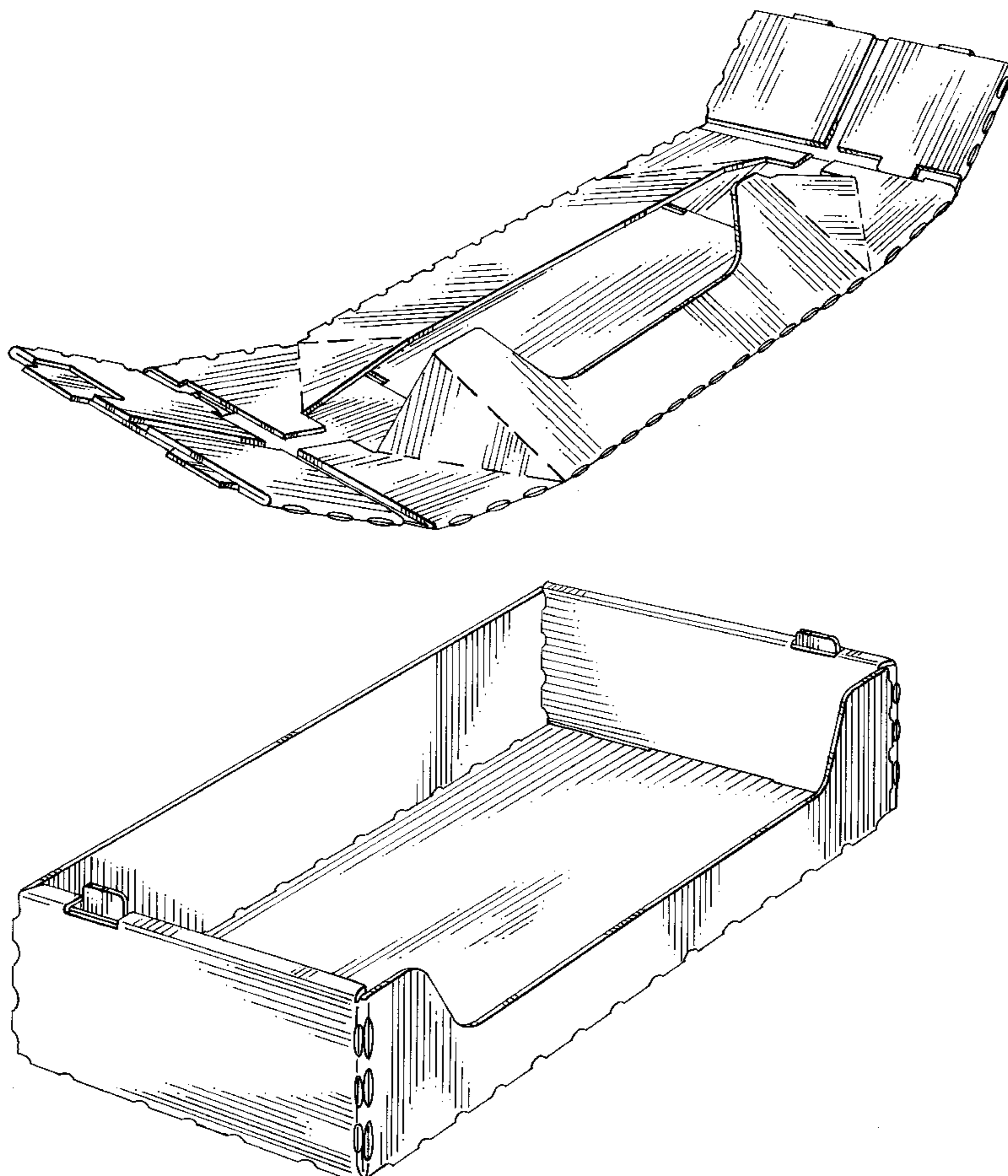

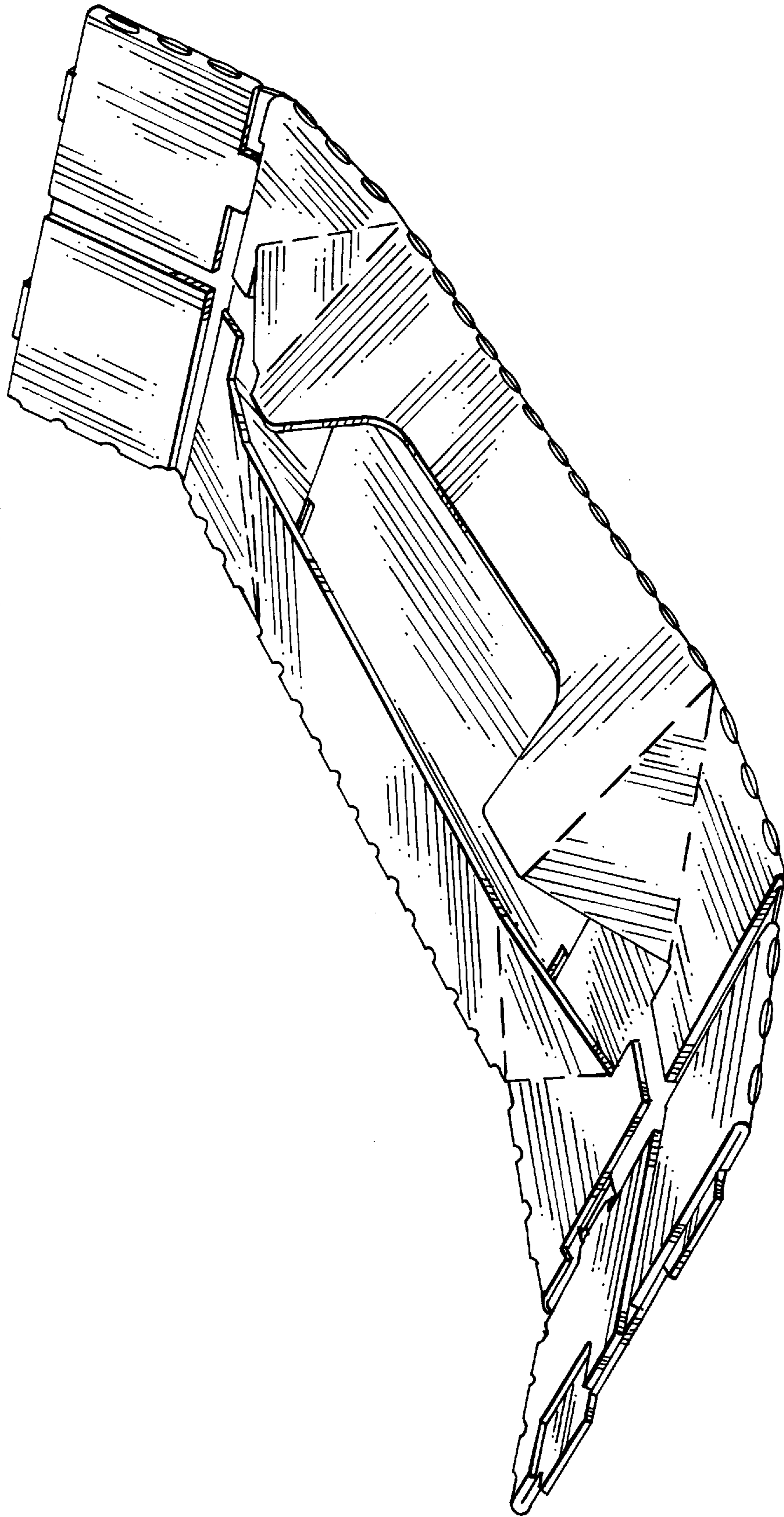

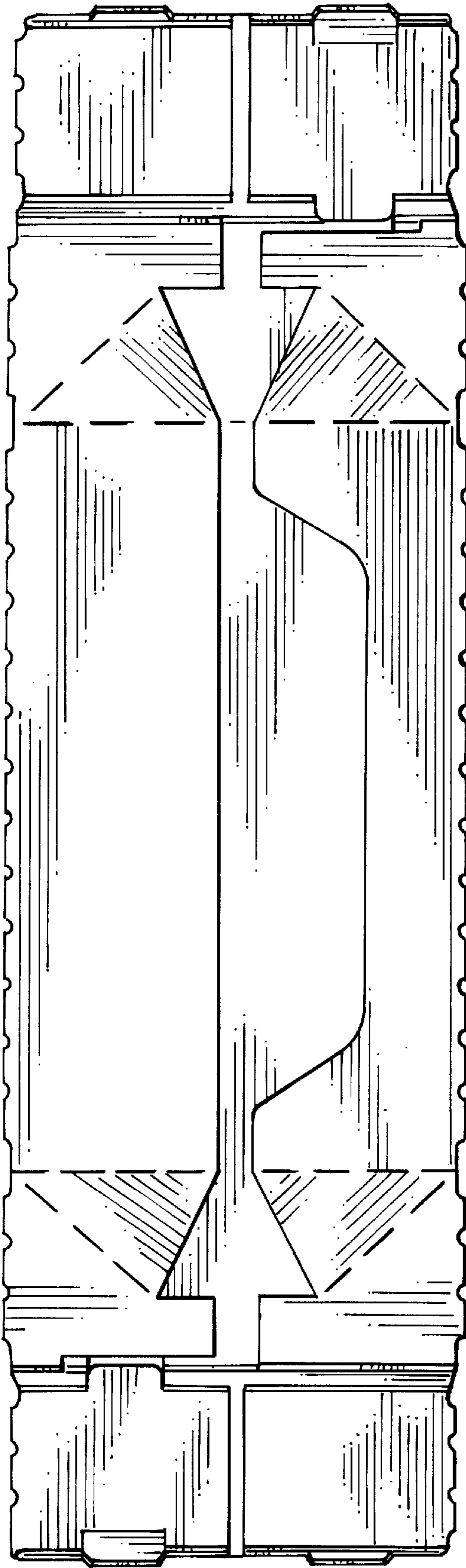

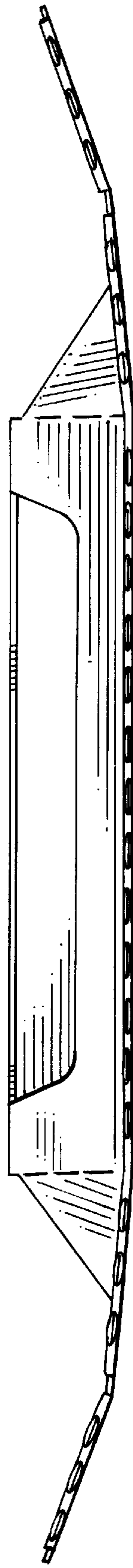

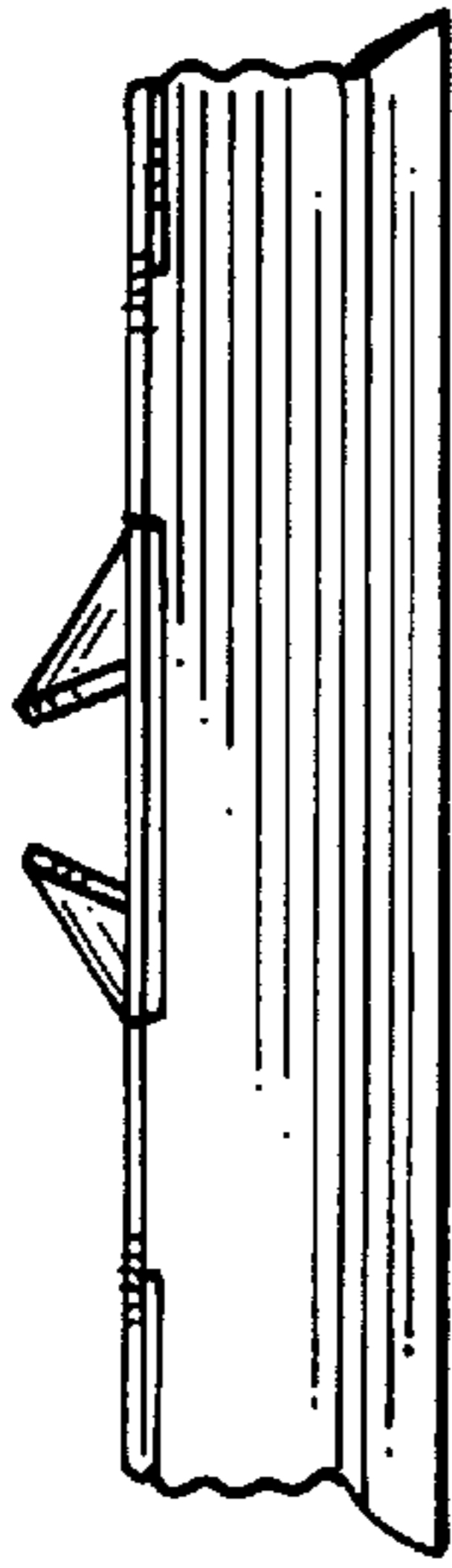

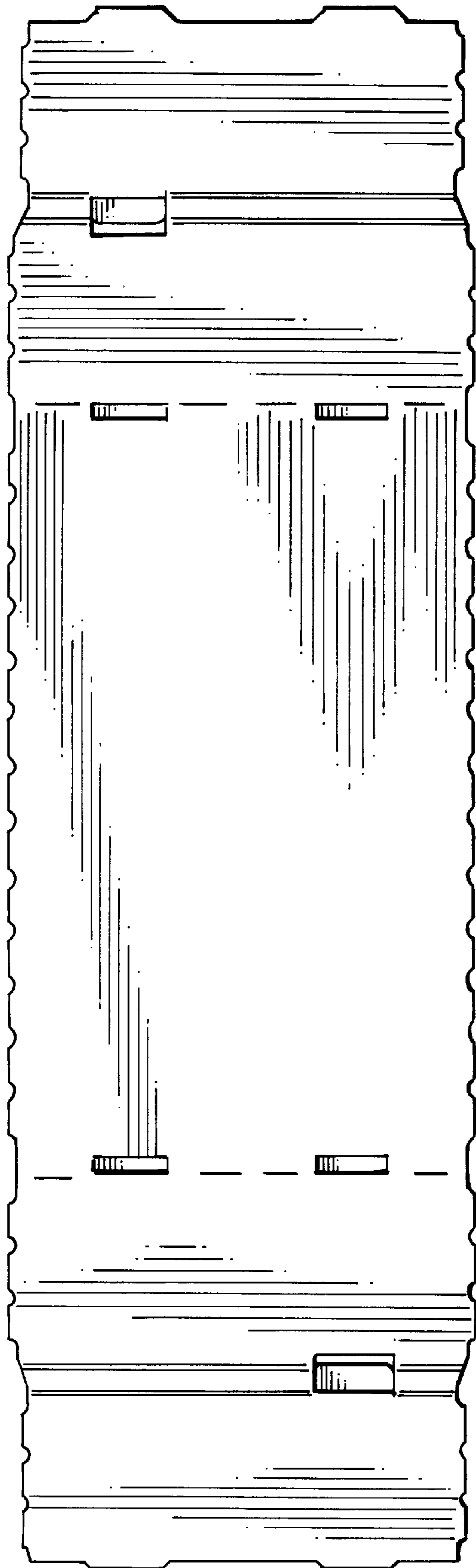
