[57] **CLAIM**

The ornamental design for a hand held electronic game, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a hand held electronic game in accordance with our new design;

FIG. 2 is a front elevational view of the hand held electronic game illustrated in FIG. 1;

FIG. 3 is a rear elevational view of the hand held electronic game illustrated in FIGS. 1 and 2;

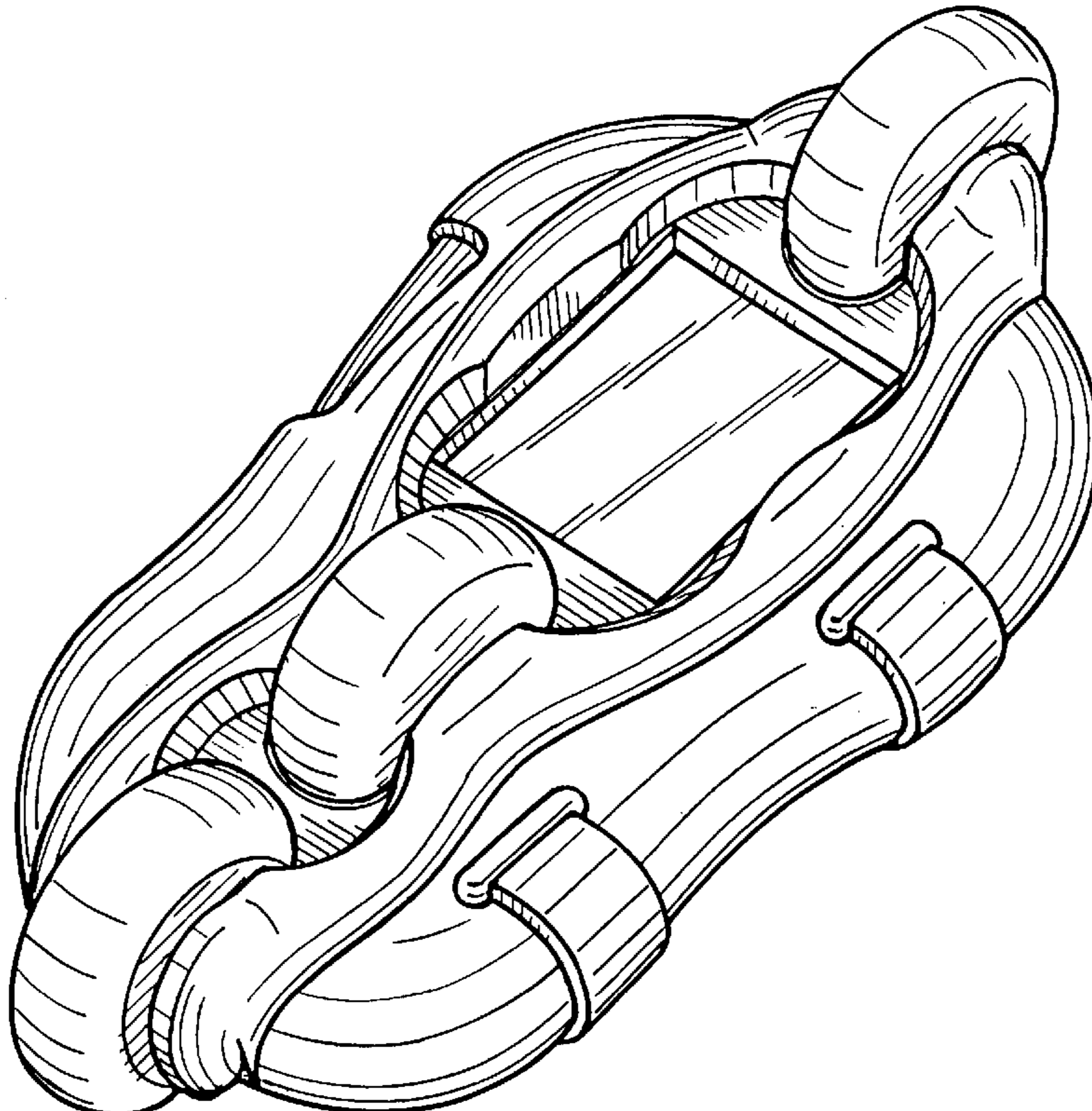
FIG. 4 is a left side elevational view of the hand held electronic game illustrated in FIGS. 1-3;

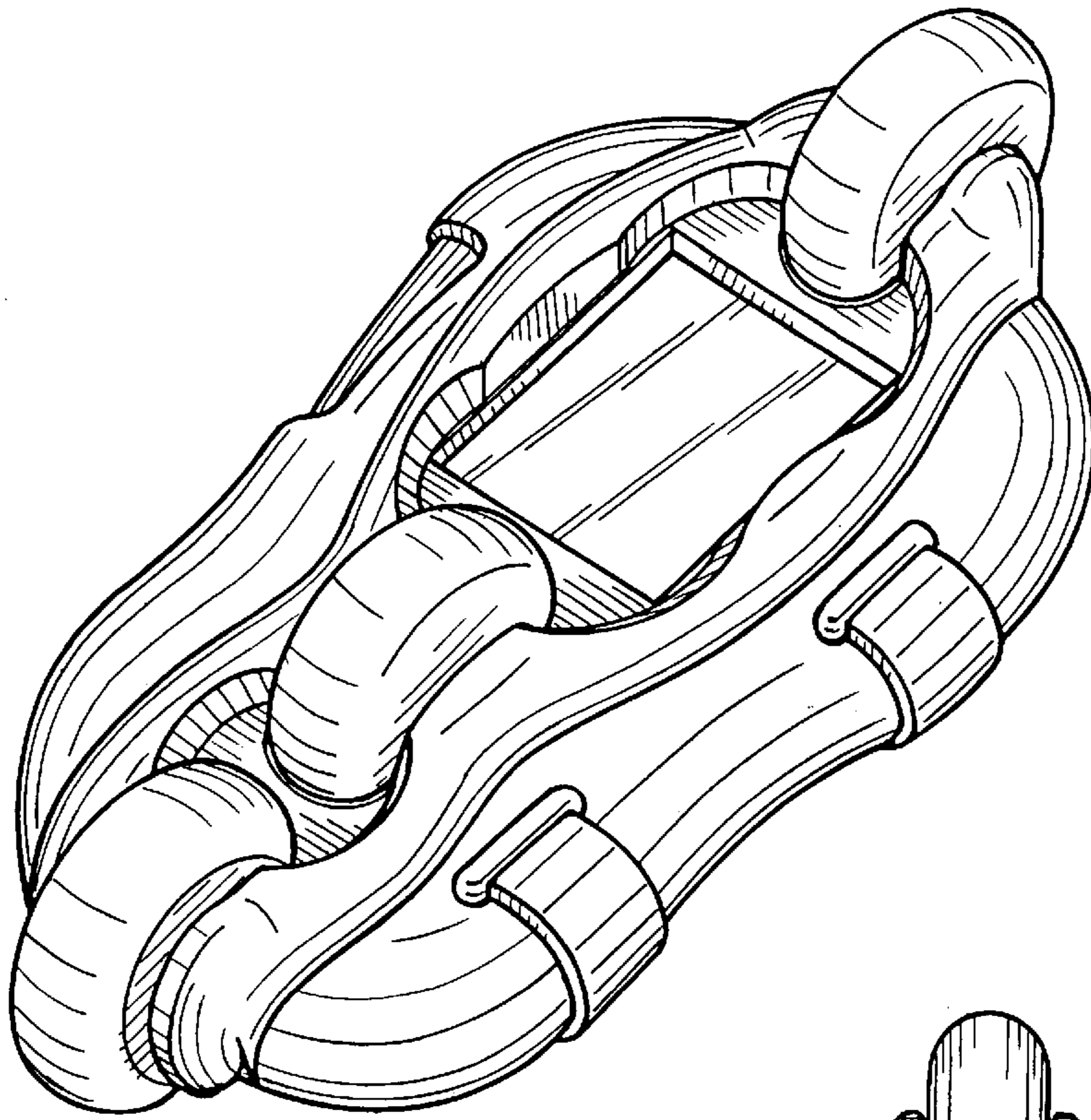

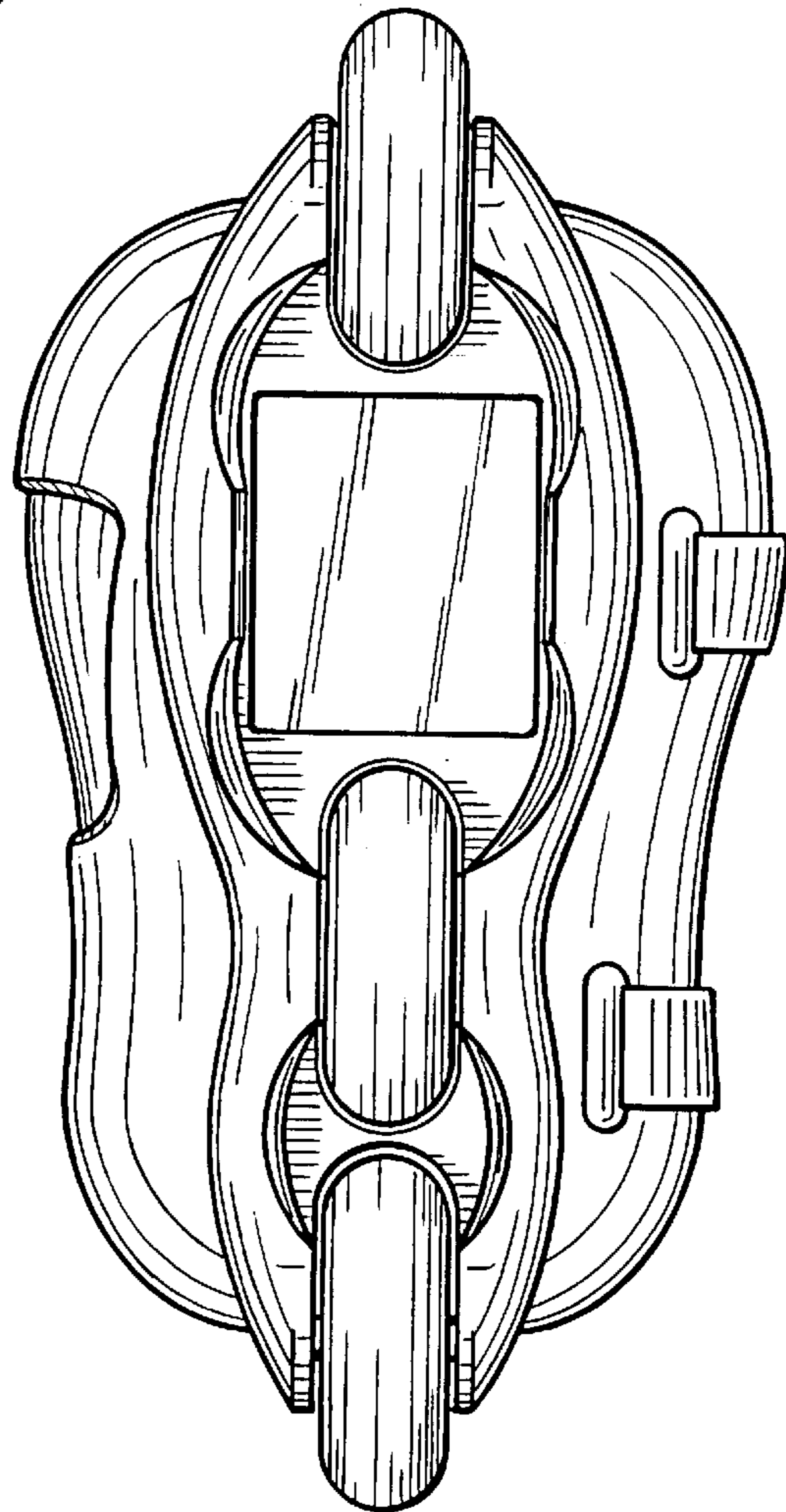

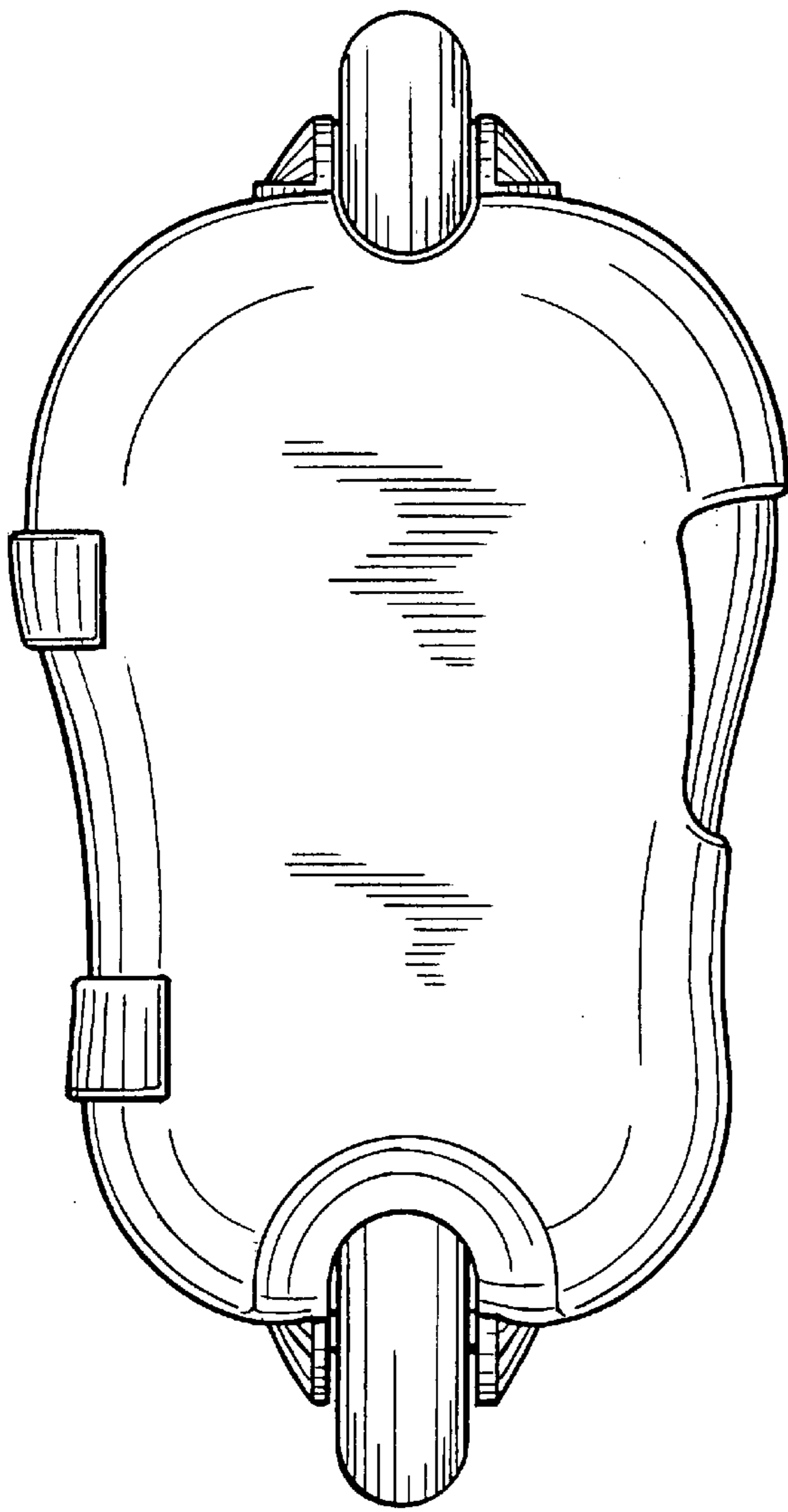

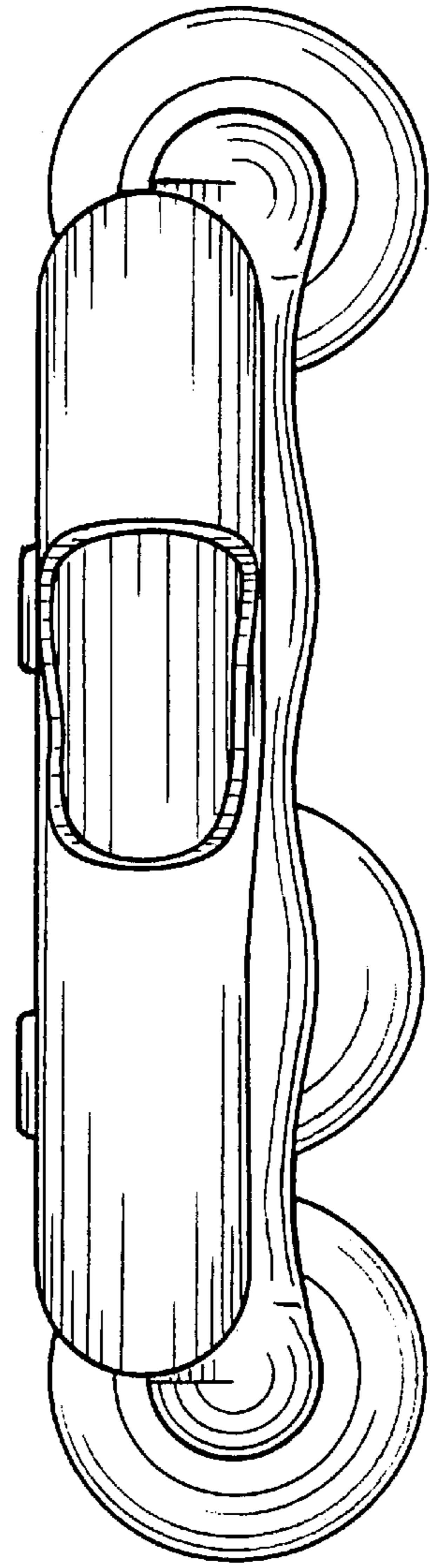

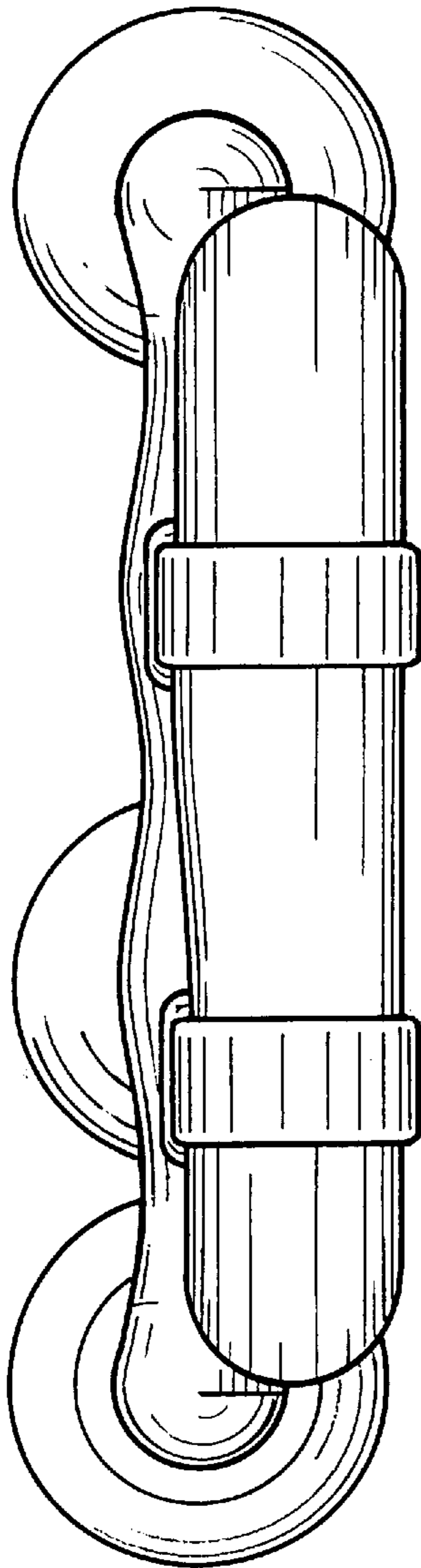

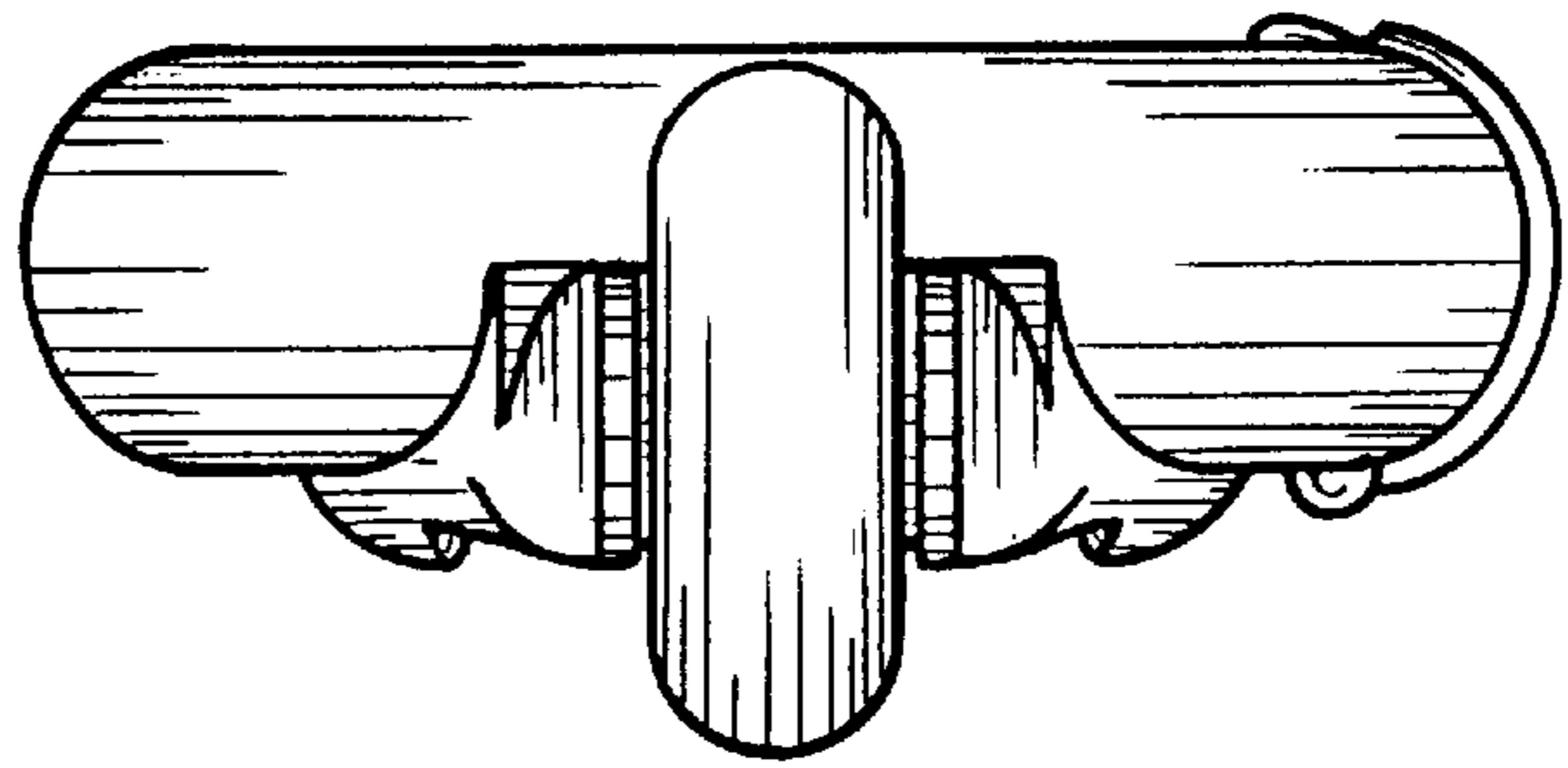

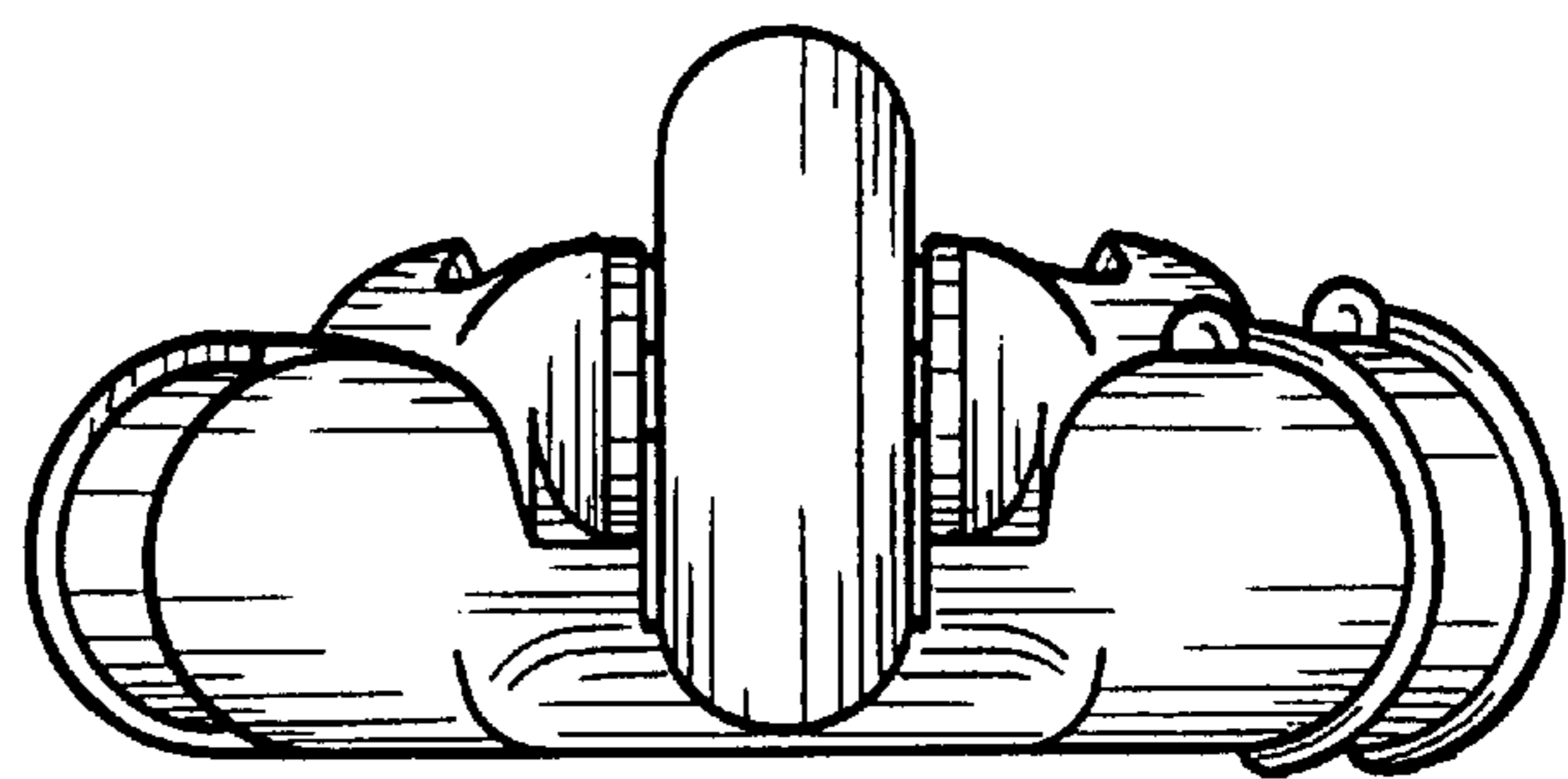
