## [57] **CLAIM**

The ornamental design for a housing for a device for measuring the concentration of an analyte in a sample of blood, as shown and described.

## **DESCRIPTION**

FIG. 1 is a perspective view of the housing for a device for measuring the concentration of an analyte in a sample blood, showing our new design;

FIG. 2 is a perspective view thereof, in open position; the broken line showing of the interior of the housing is for illustrative purposes only and forms no part of the claimed design;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a top view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a left side elevational view thereof; and,

FIG. 8 is a bottom view thereof.

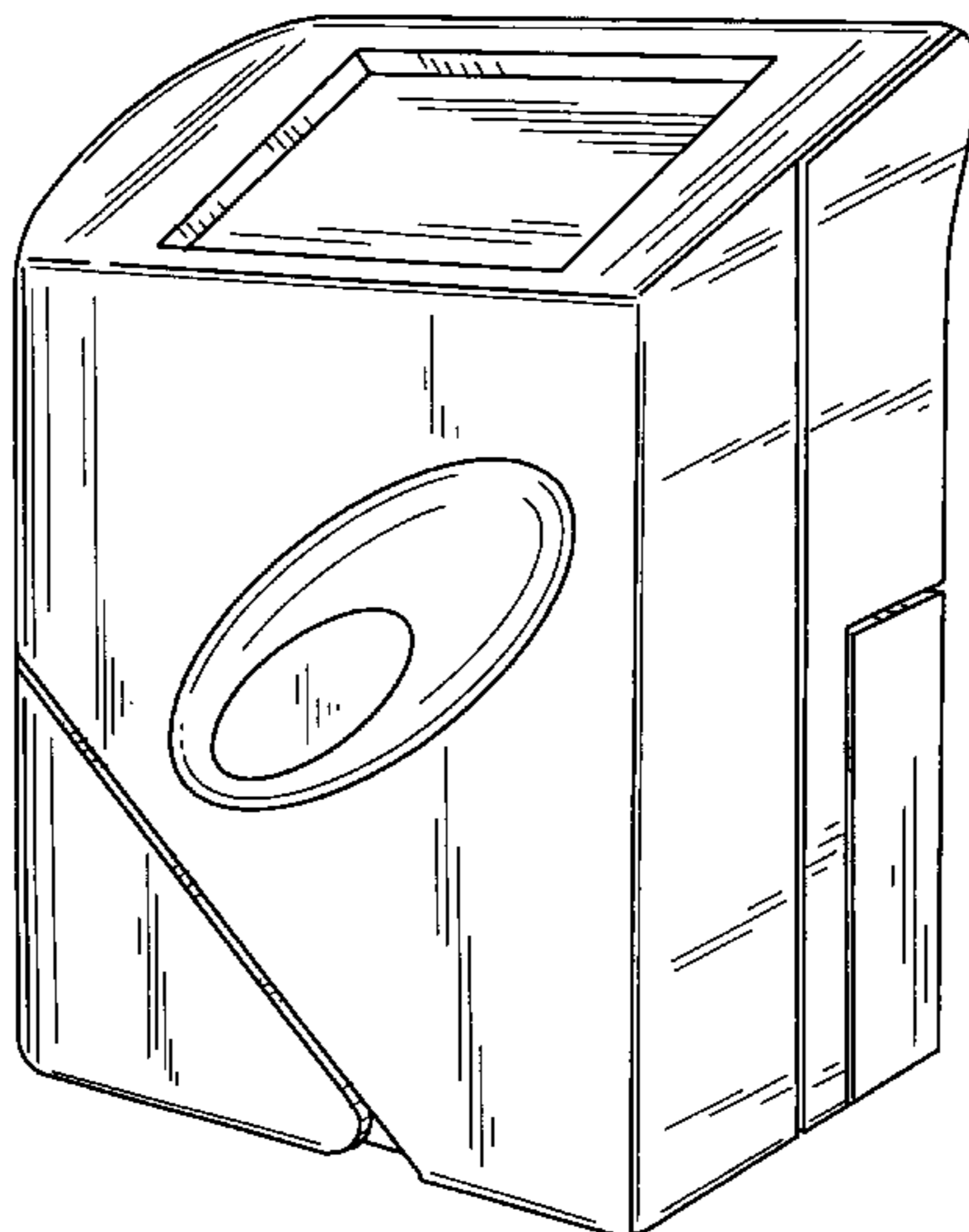

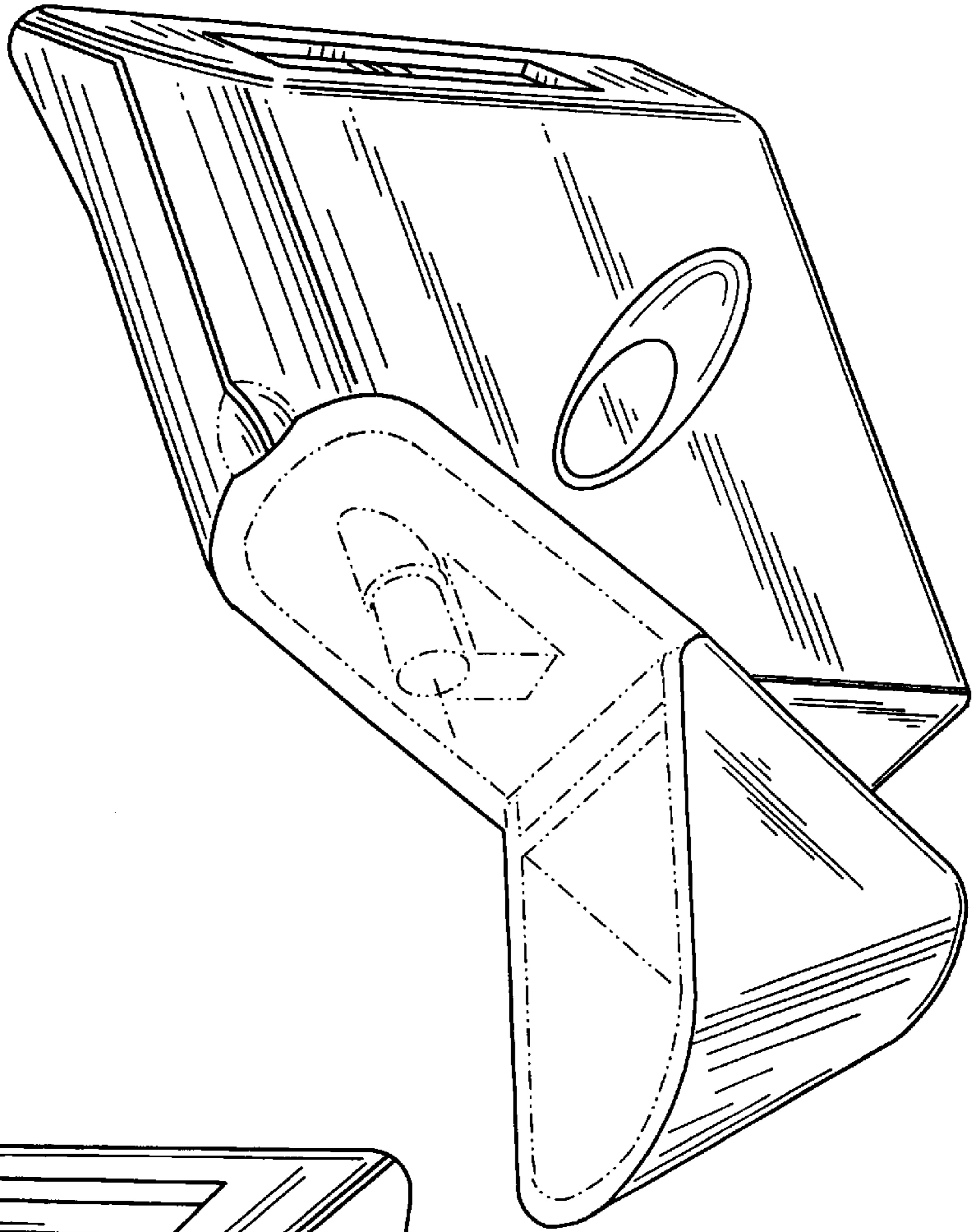

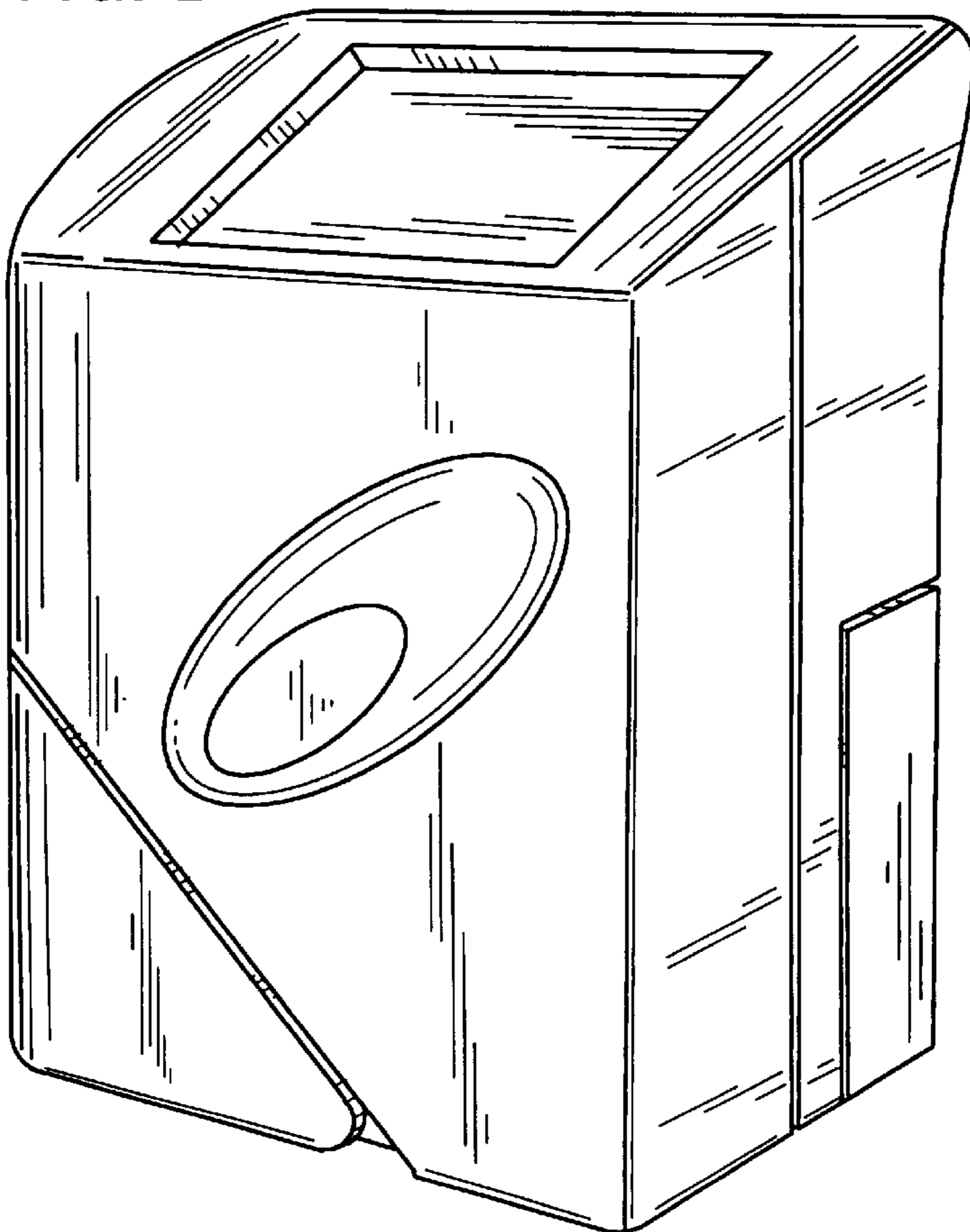

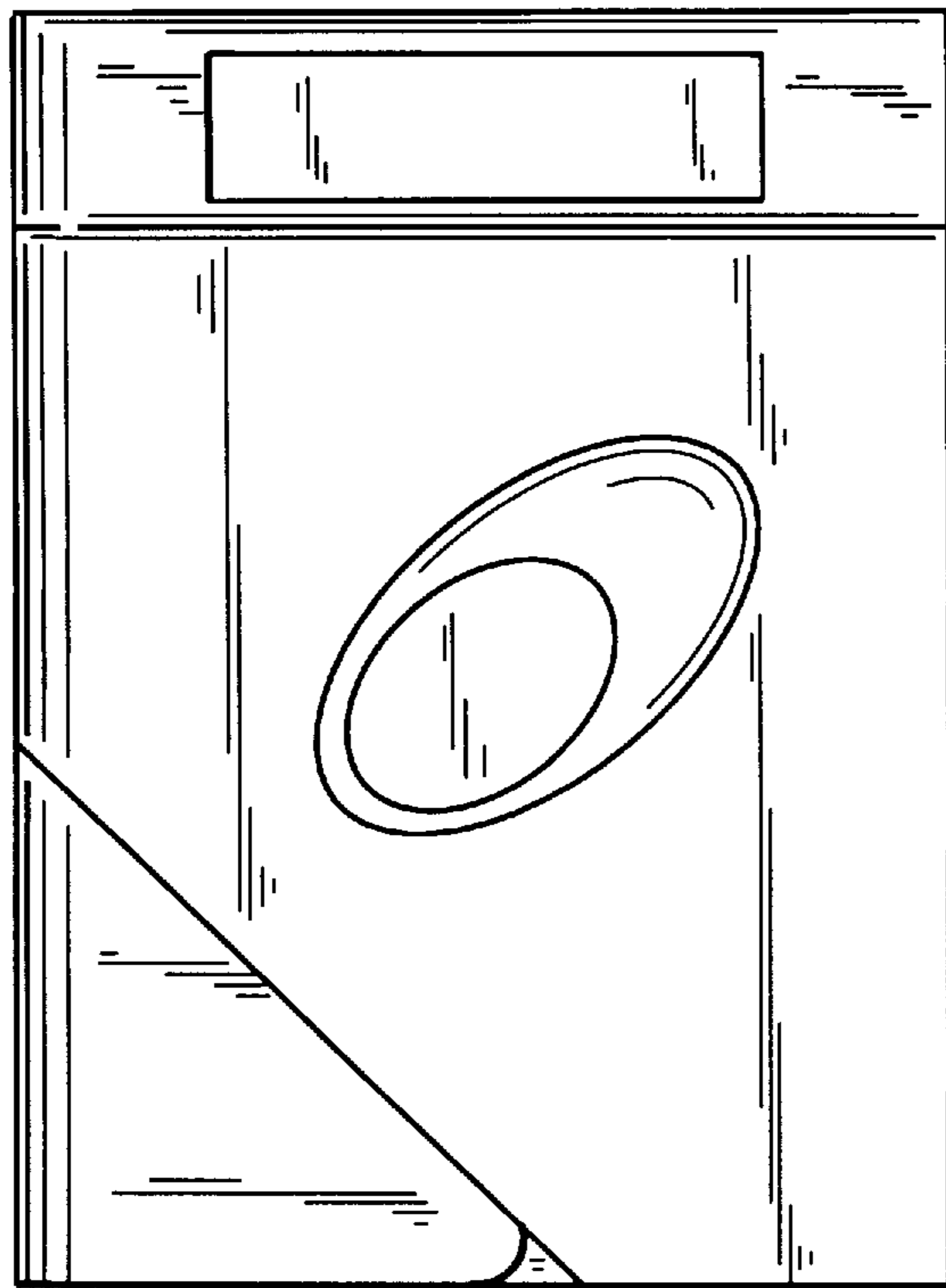
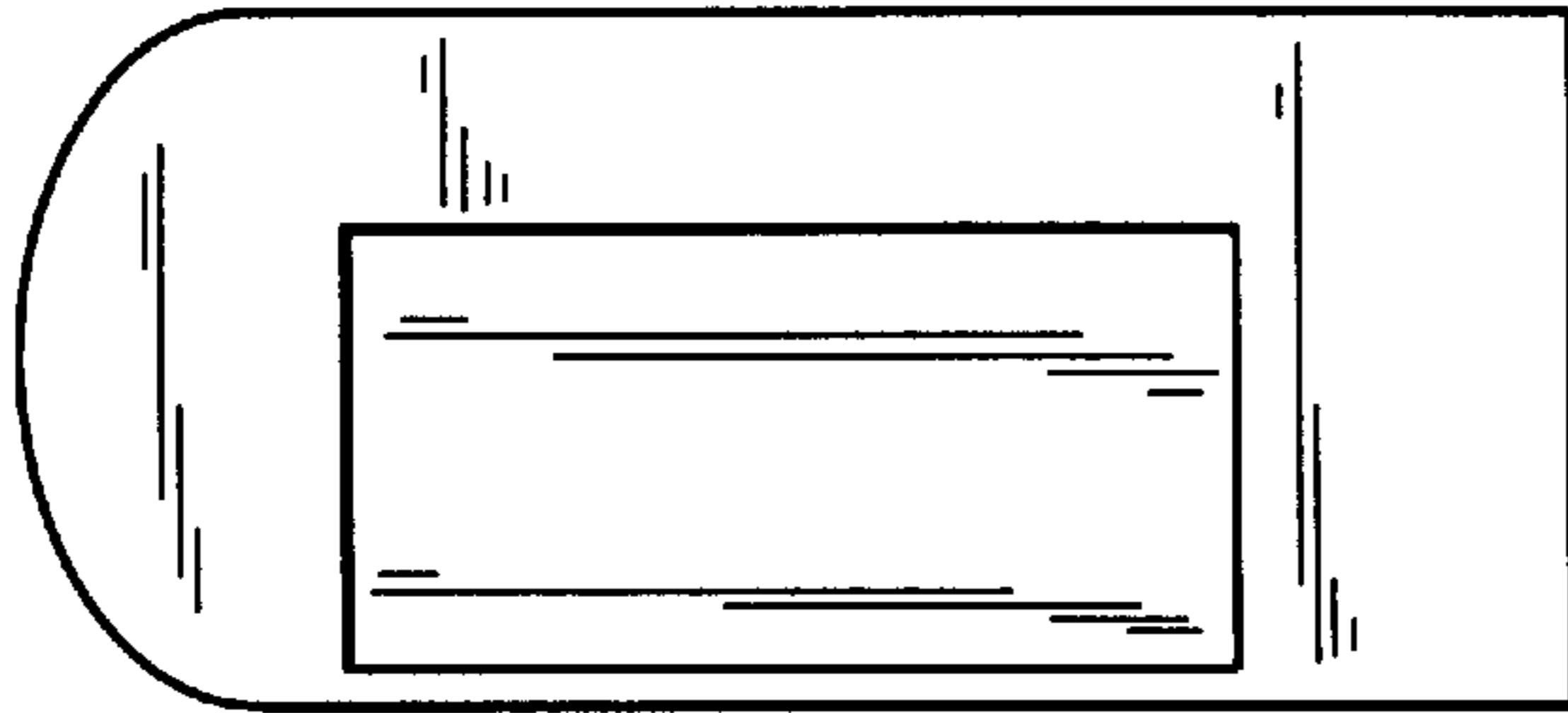

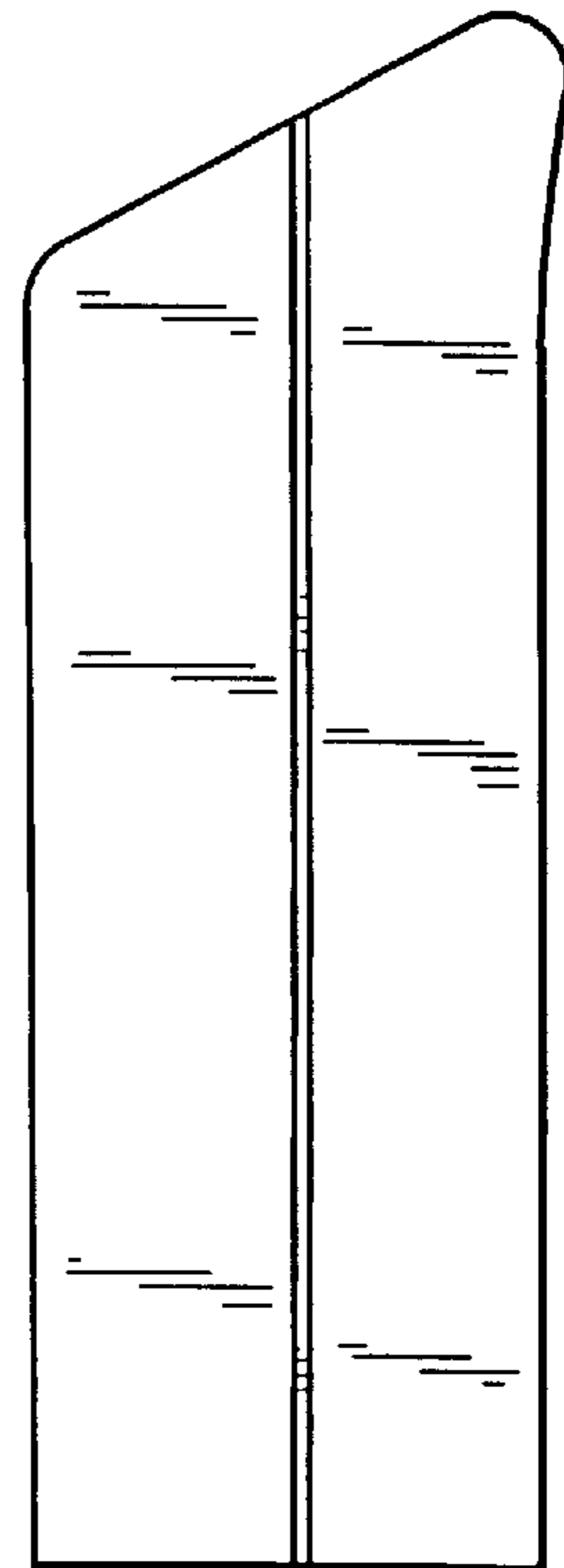

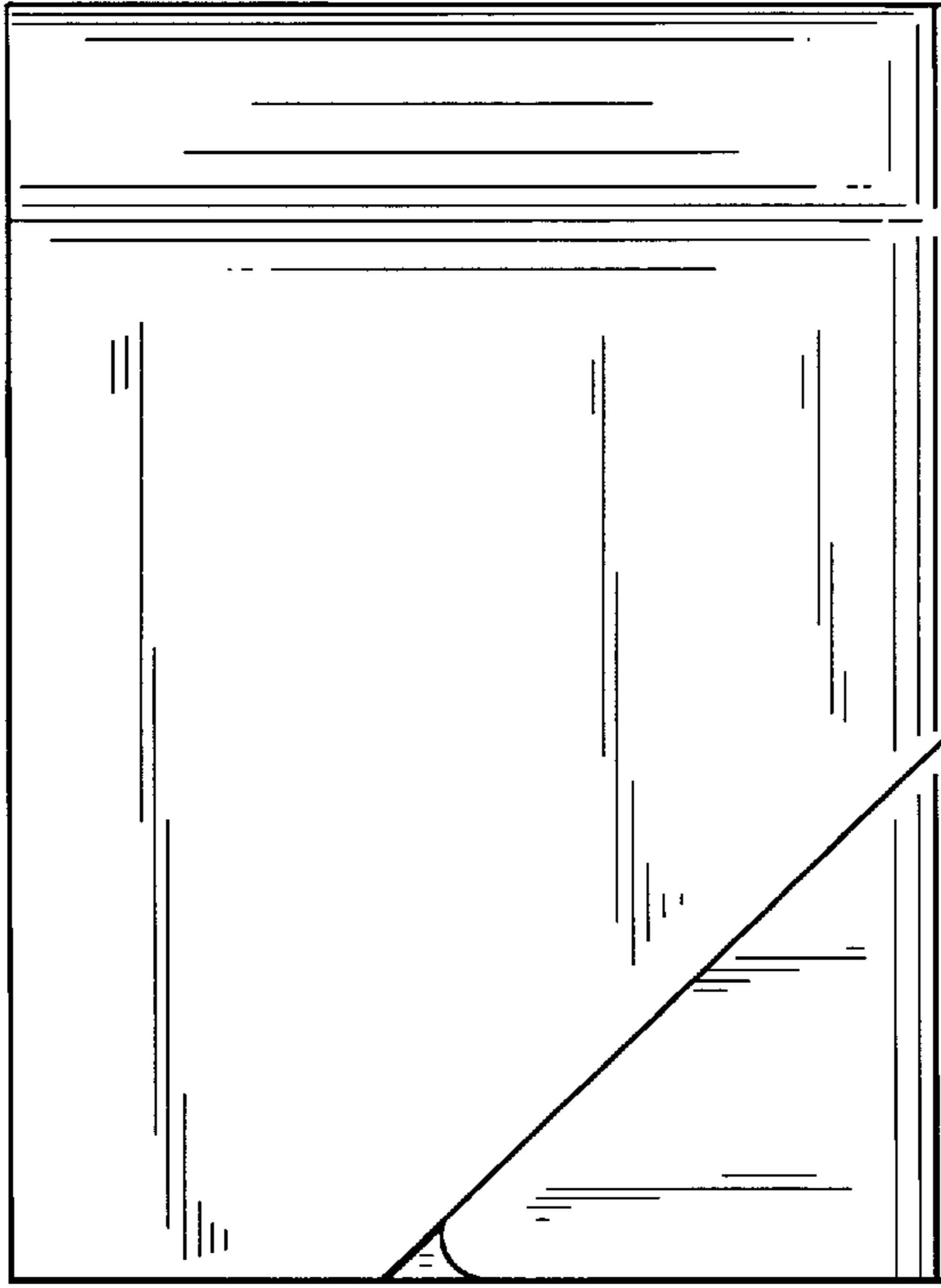

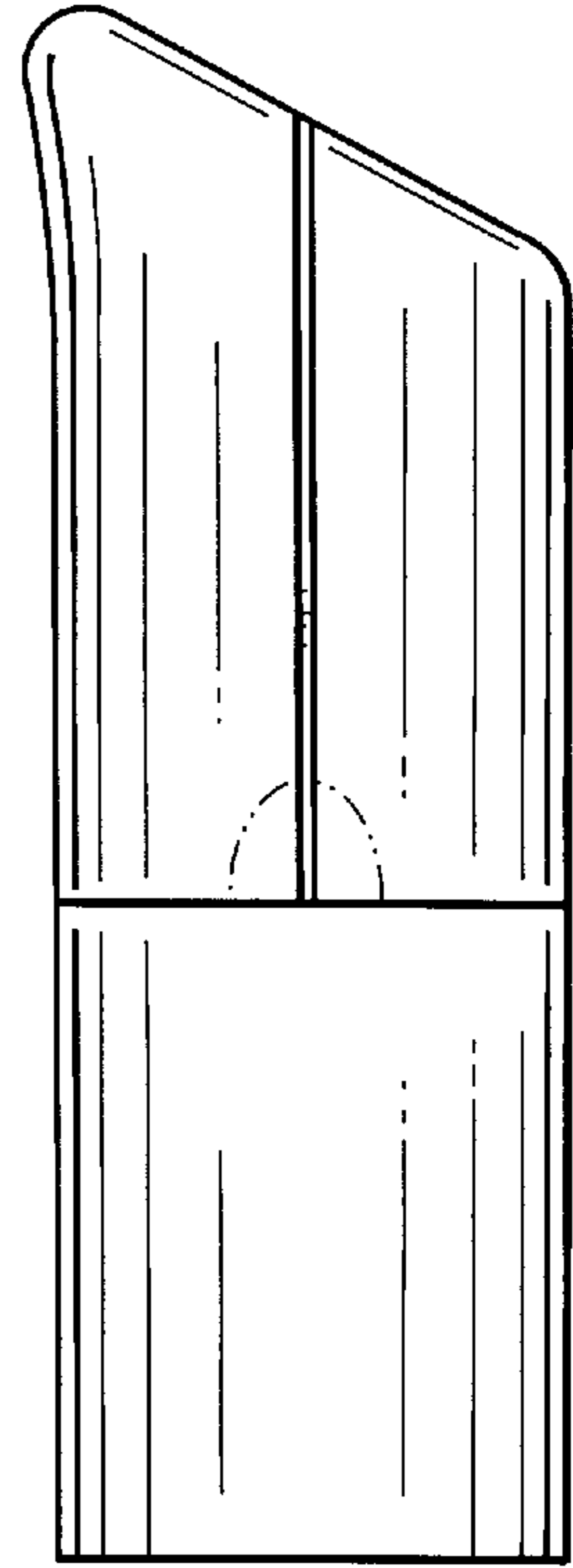

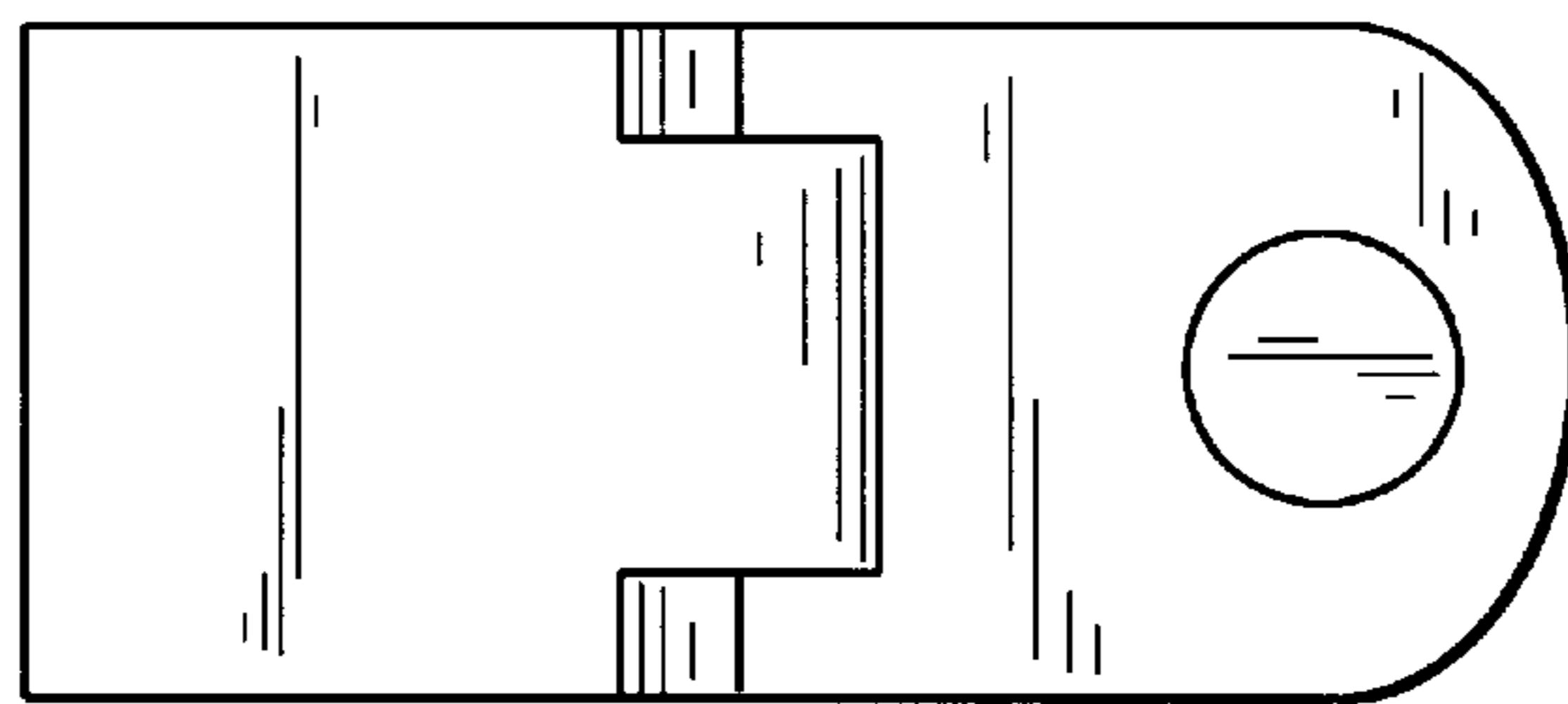
