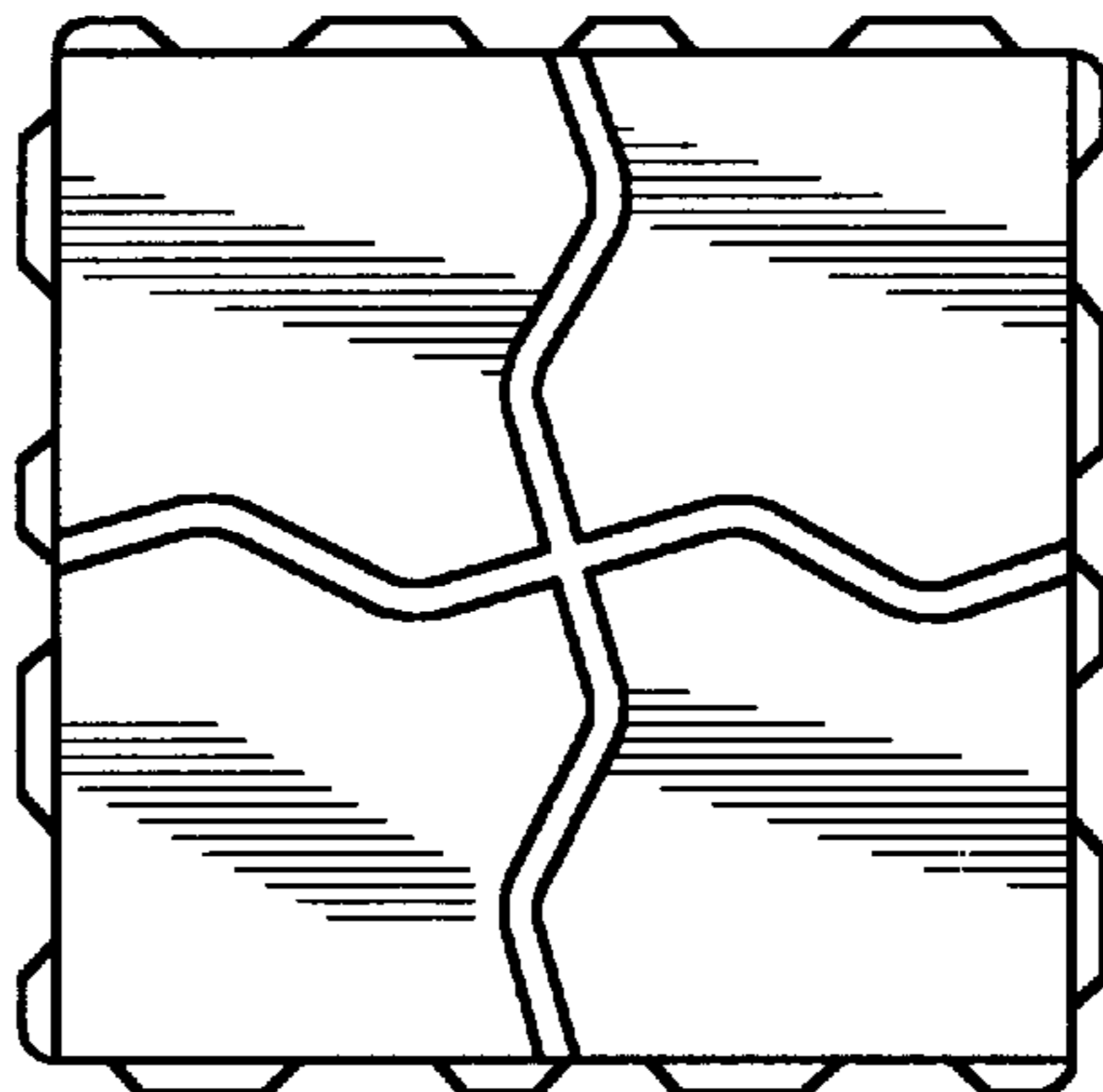
[57] **CLAIM**

We claim the ornamental design for a paving element, as shown and described.

DESCRIPTION

FIG. 1 is a plan view of a first embodiment of our new design;
 FIG. 2 is a side elevation thereof, the other sides being identical;
 FIG. 3 is a plan view of a second embodiment of our new design;
 FIG. 4 is a side elevation thereof, the other sides being identical;
 FIG. 5 is a plan view of a third embodiment of our new design;
 FIG. 6 is a side elevation thereof, the other sides being identical;
 FIG. 7 is a plan view of a fourth embodiment of our new design;
 FIG. 8 is a front elevation thereof, the rear being identical; and,
 FIG. 9 is a side view thereof, the other side being identical.

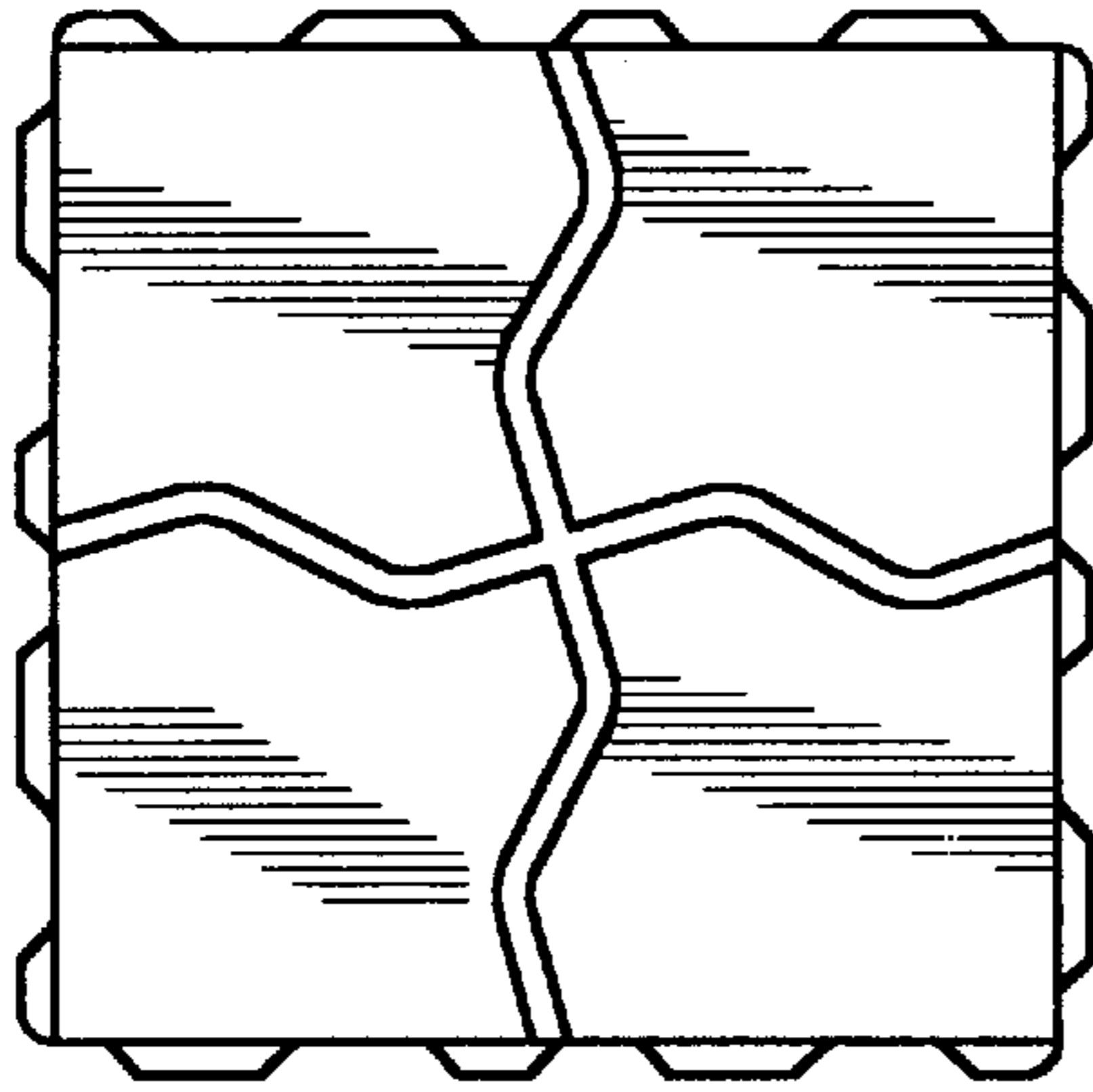

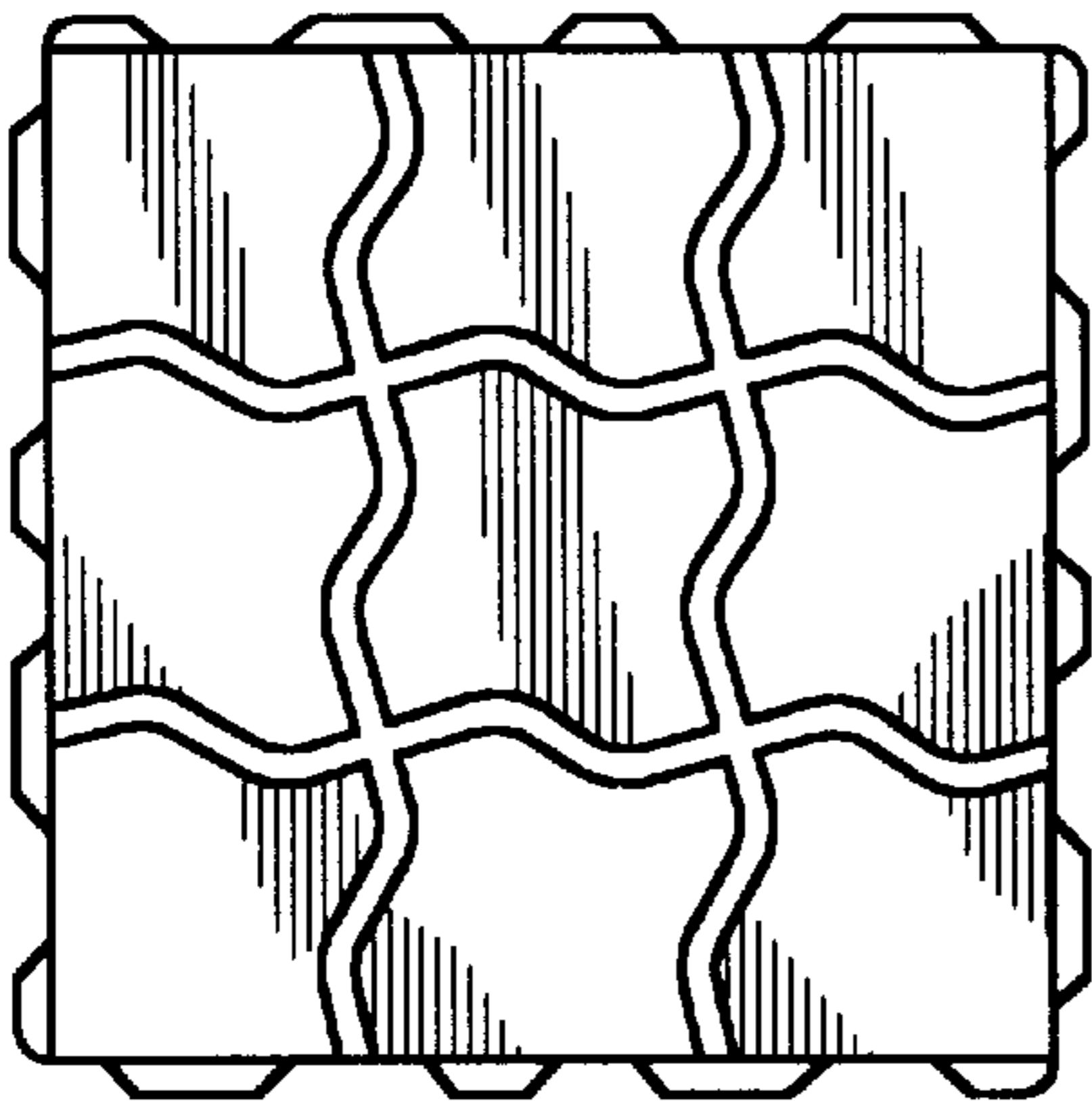

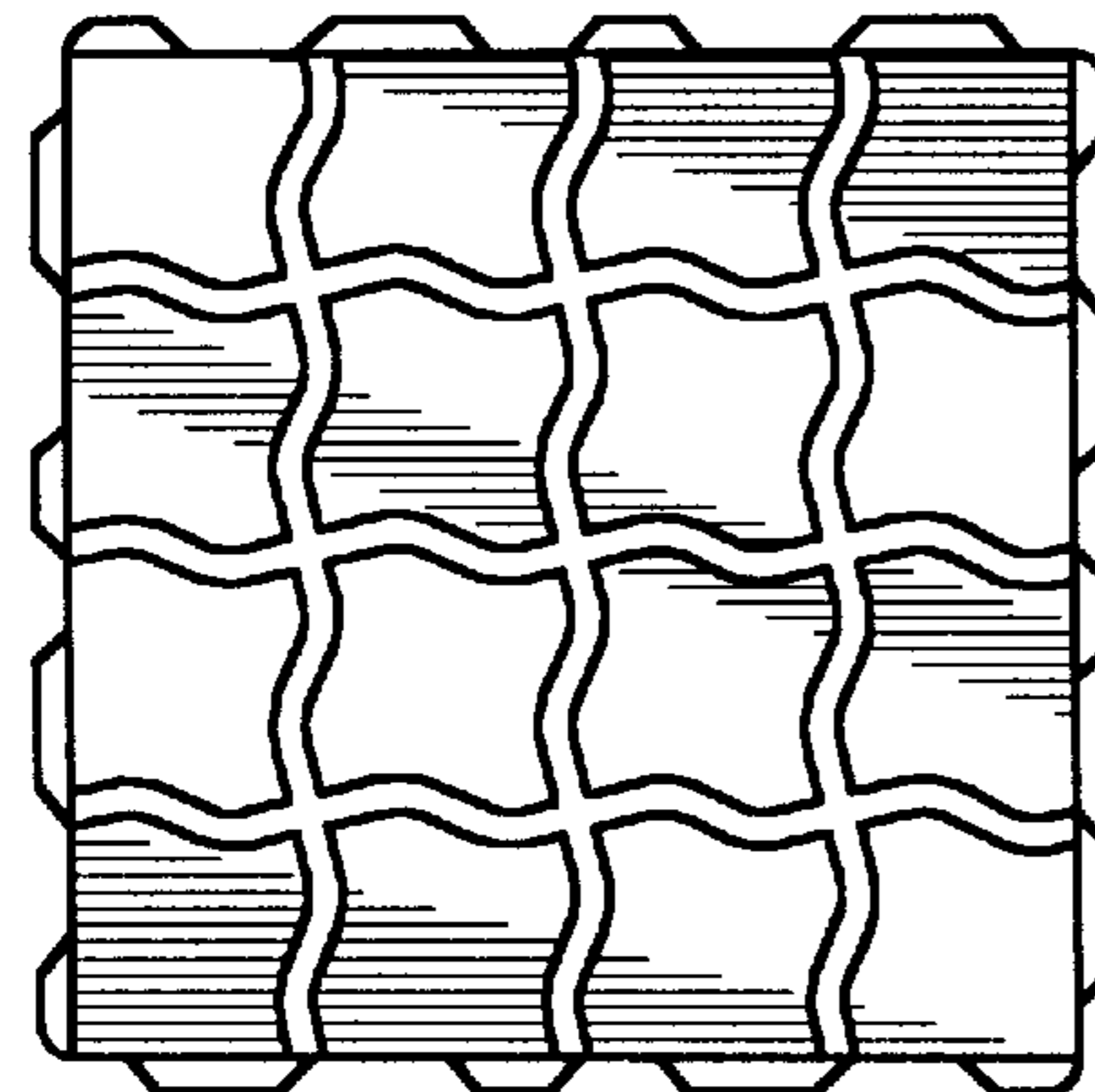

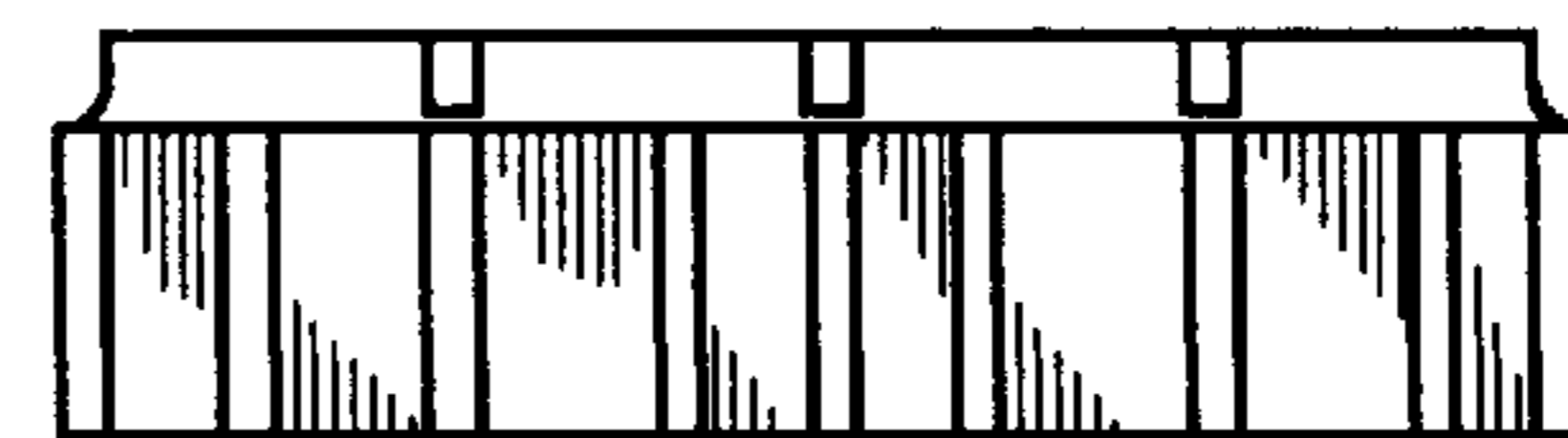

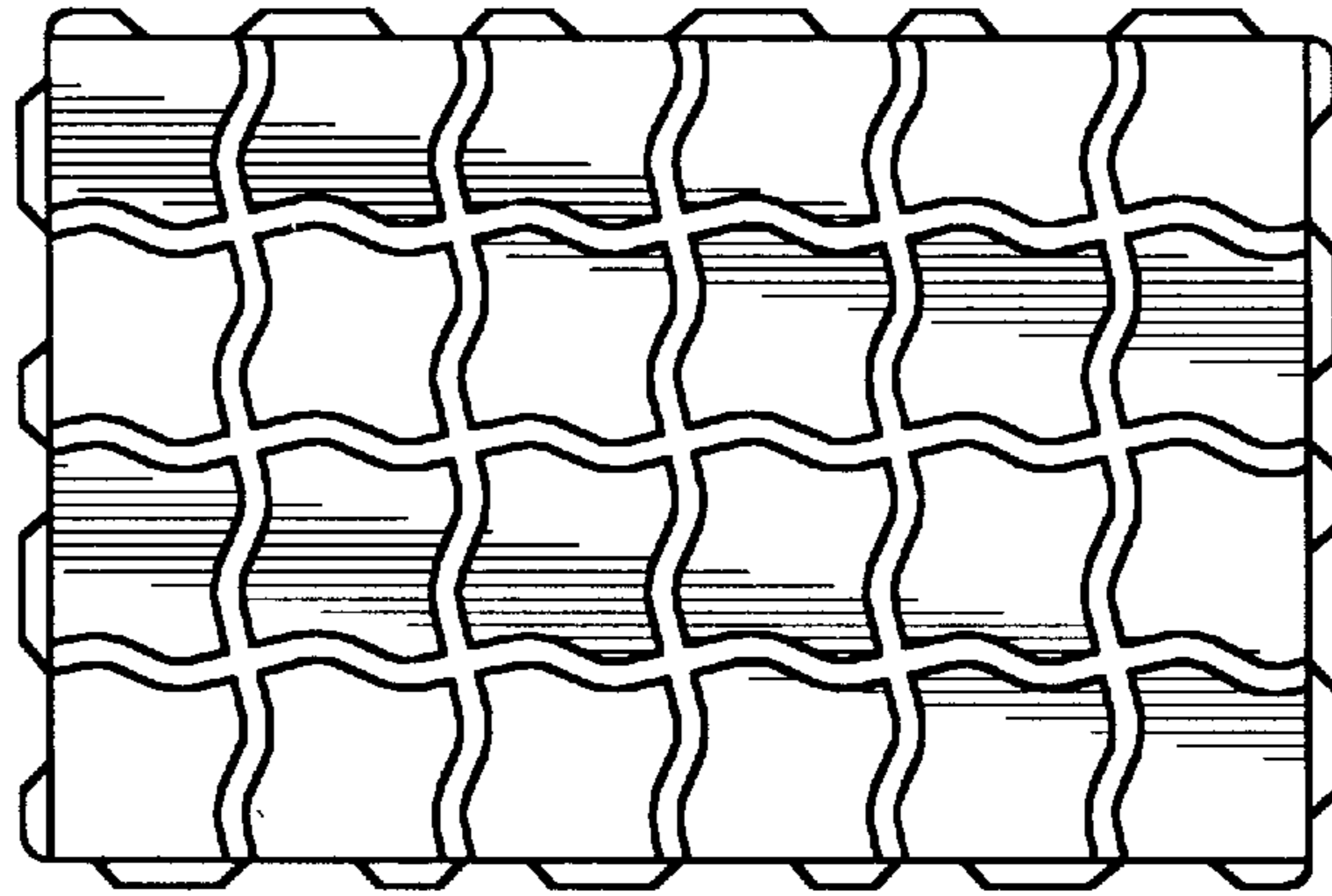

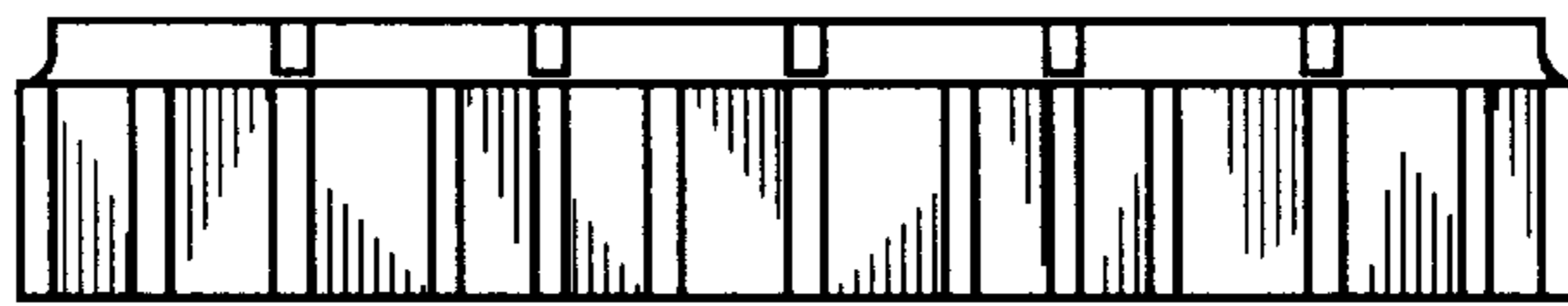

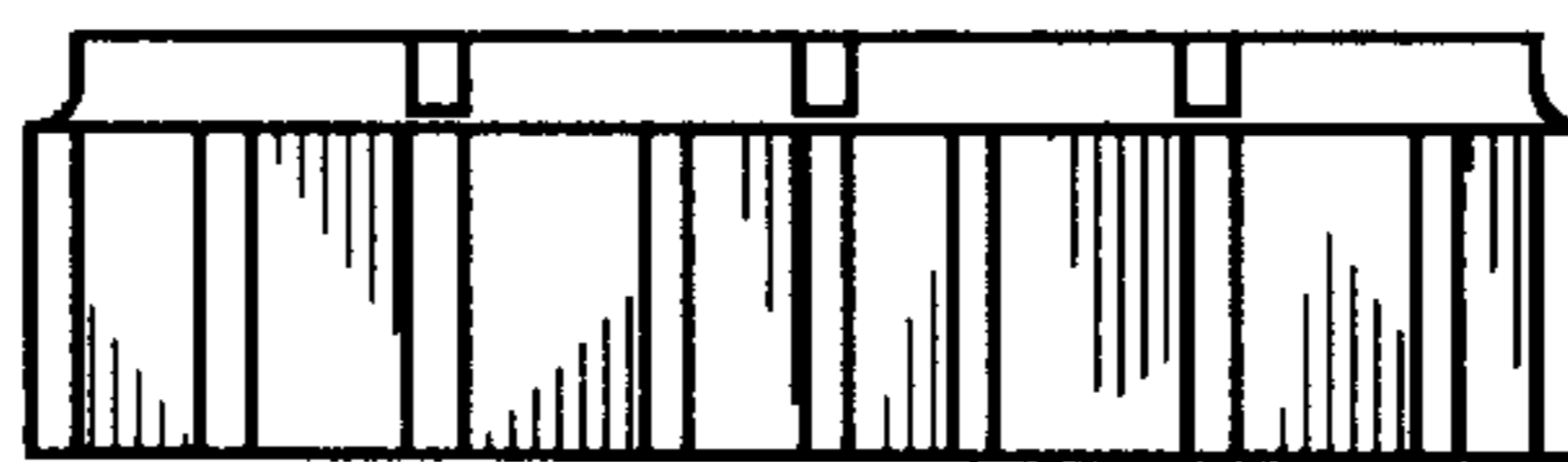
