I claim the ornamental design for tool container, as shown.

### **DESCRIPTION**

FIG. 18 is a front view of the fourth modified embodiment;

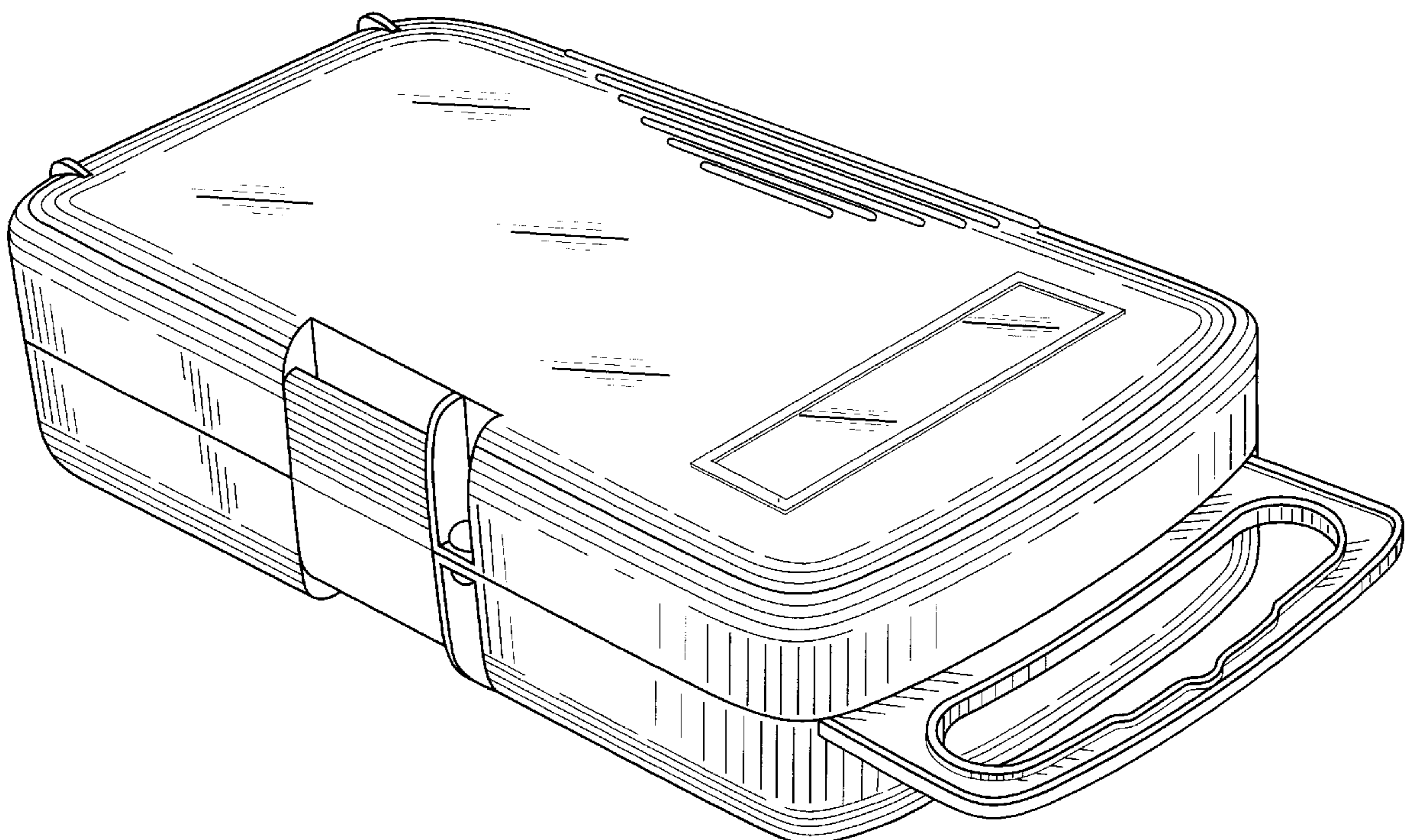
FIG. 19 is a left side view of the fourth modified embodiment;

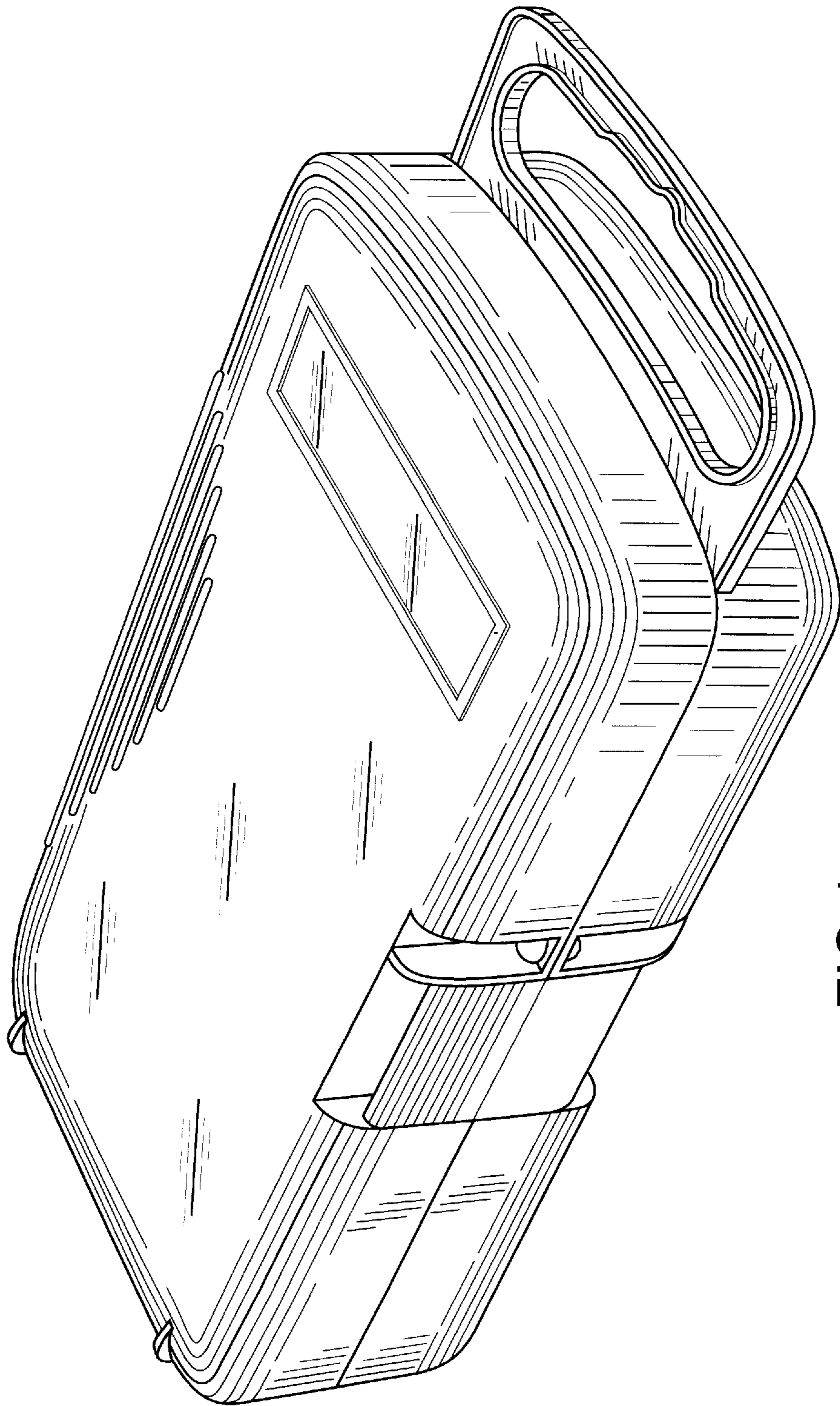

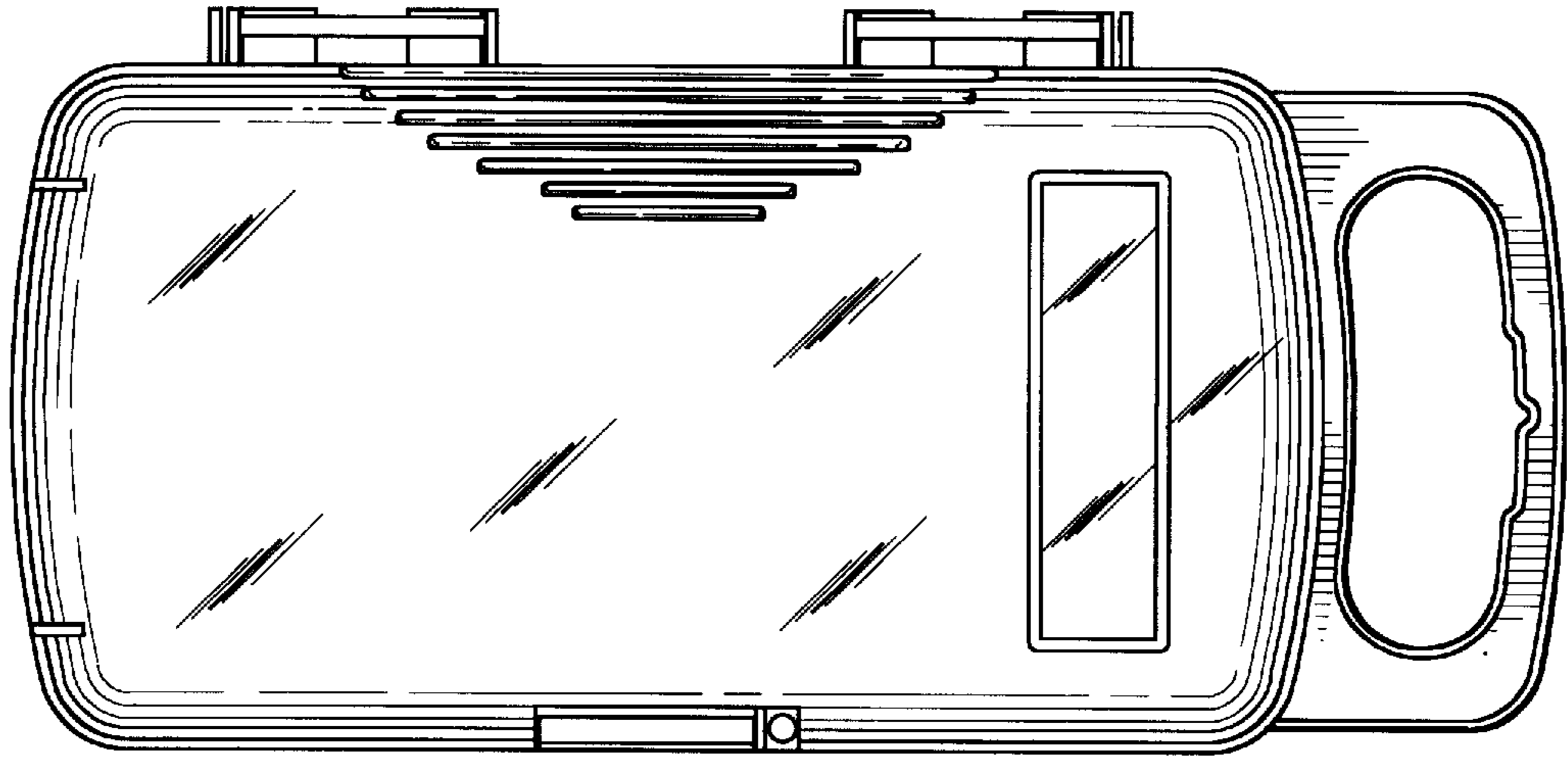

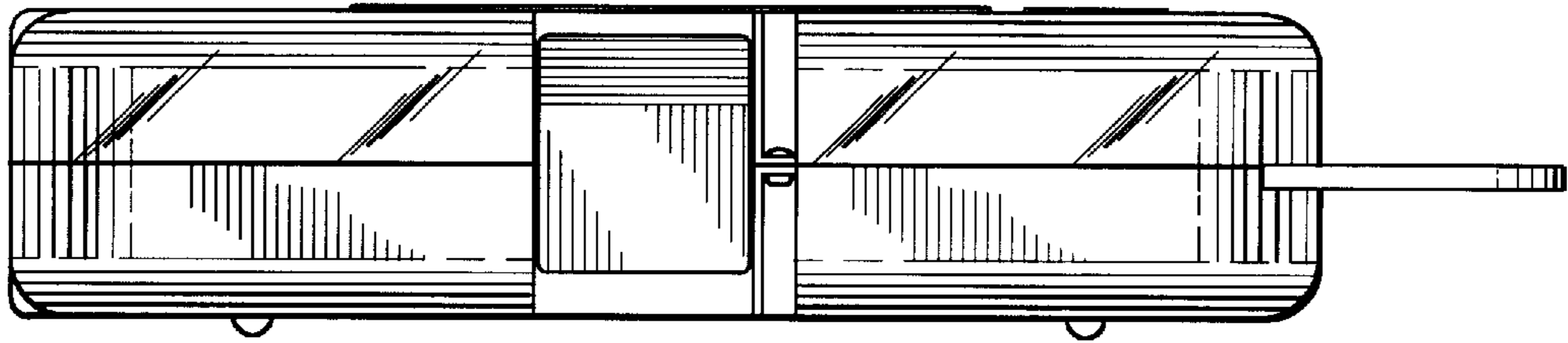

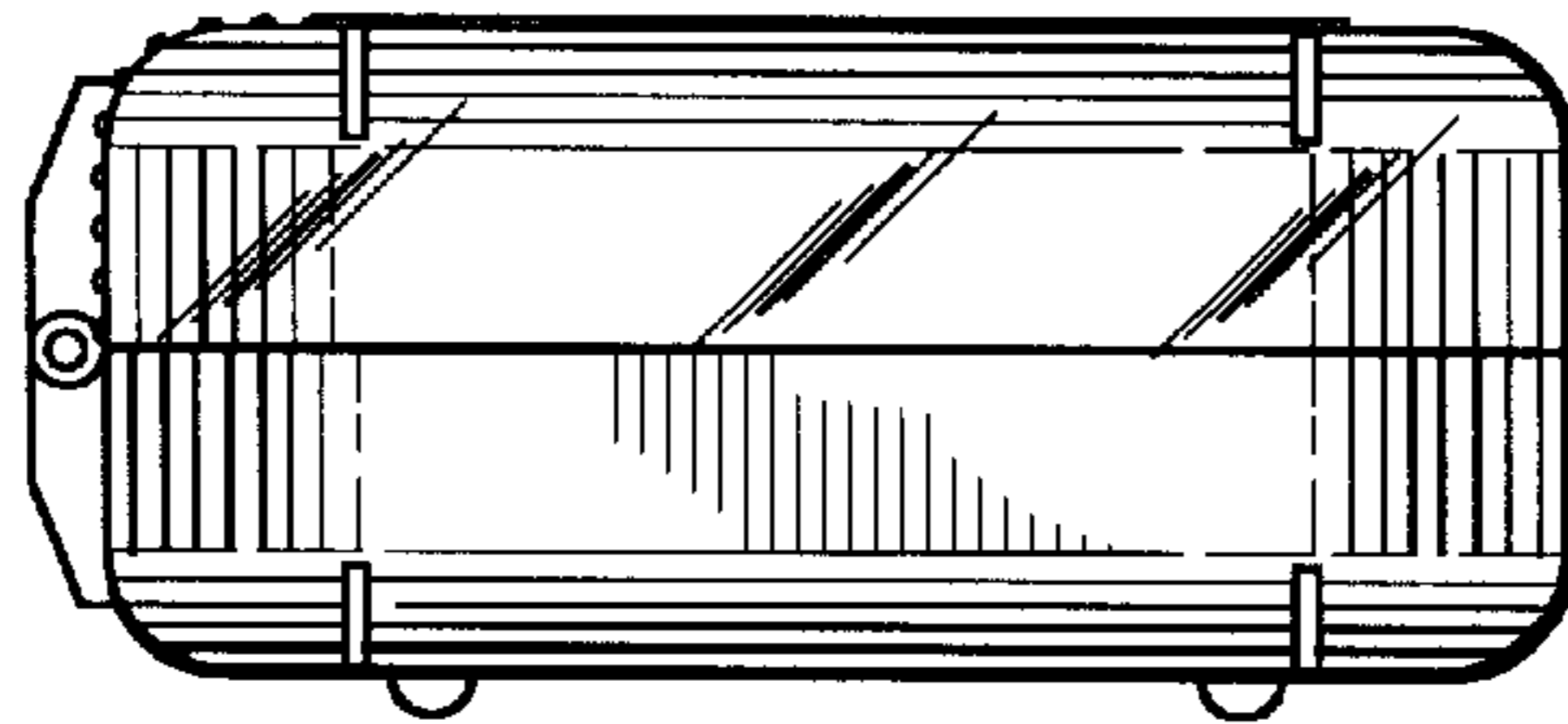

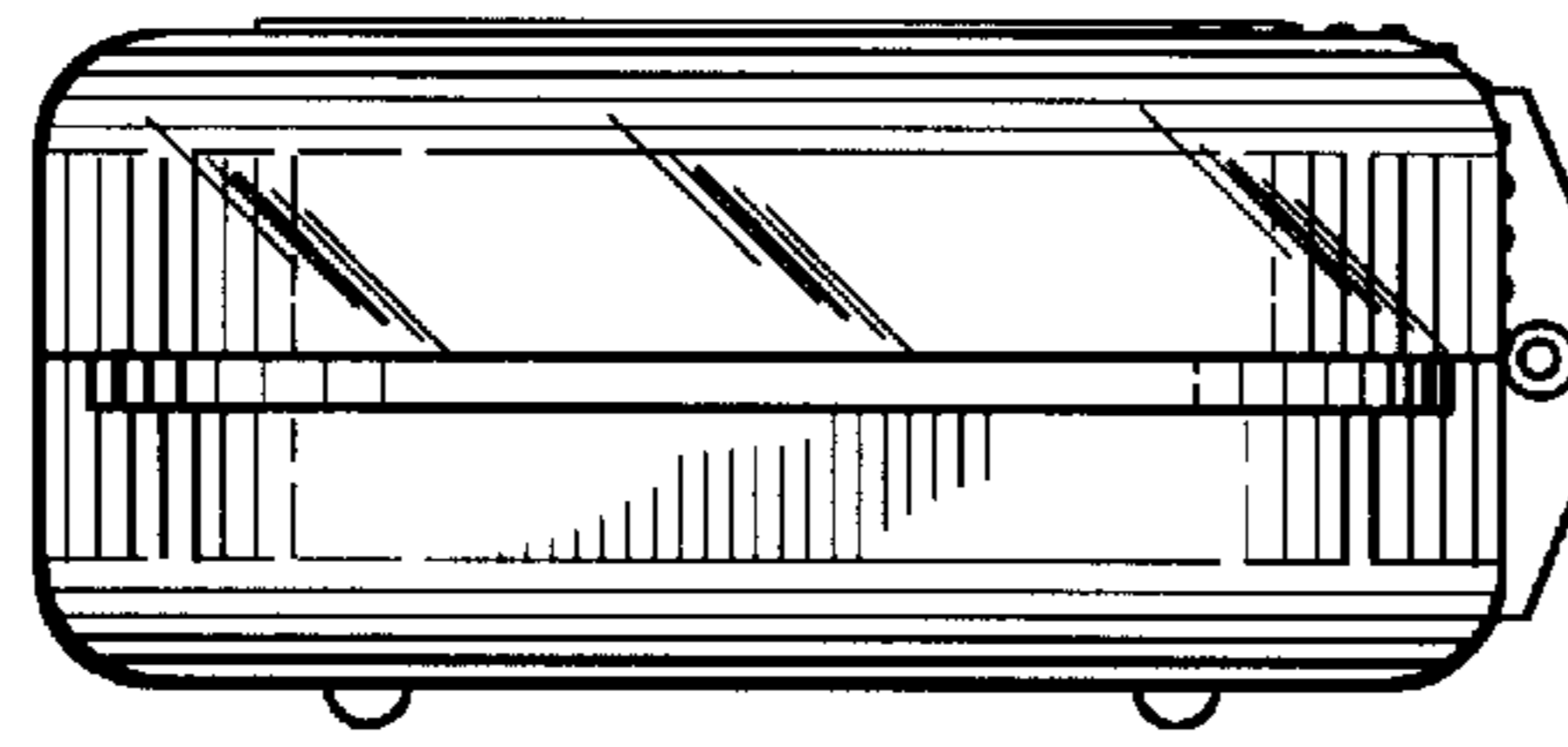

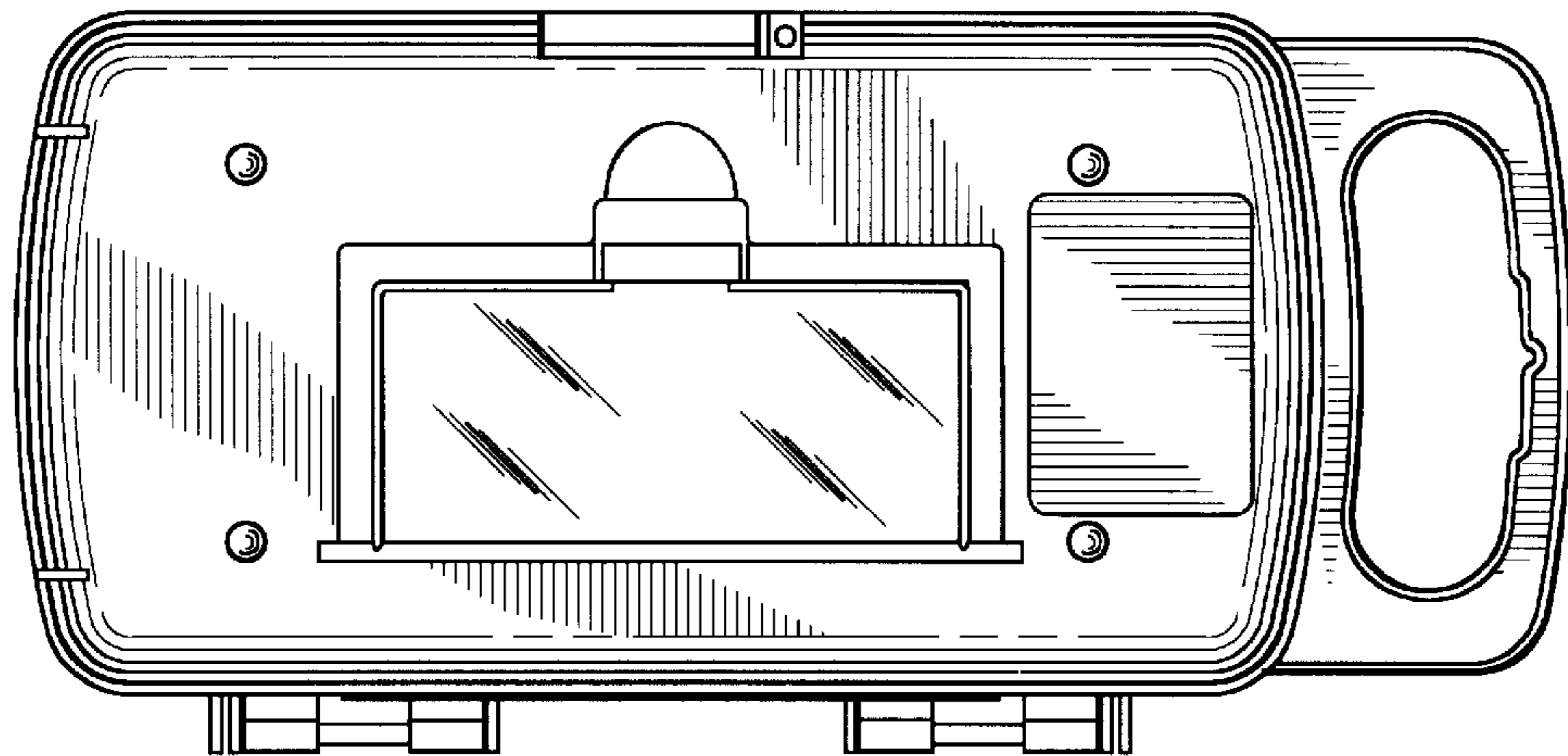

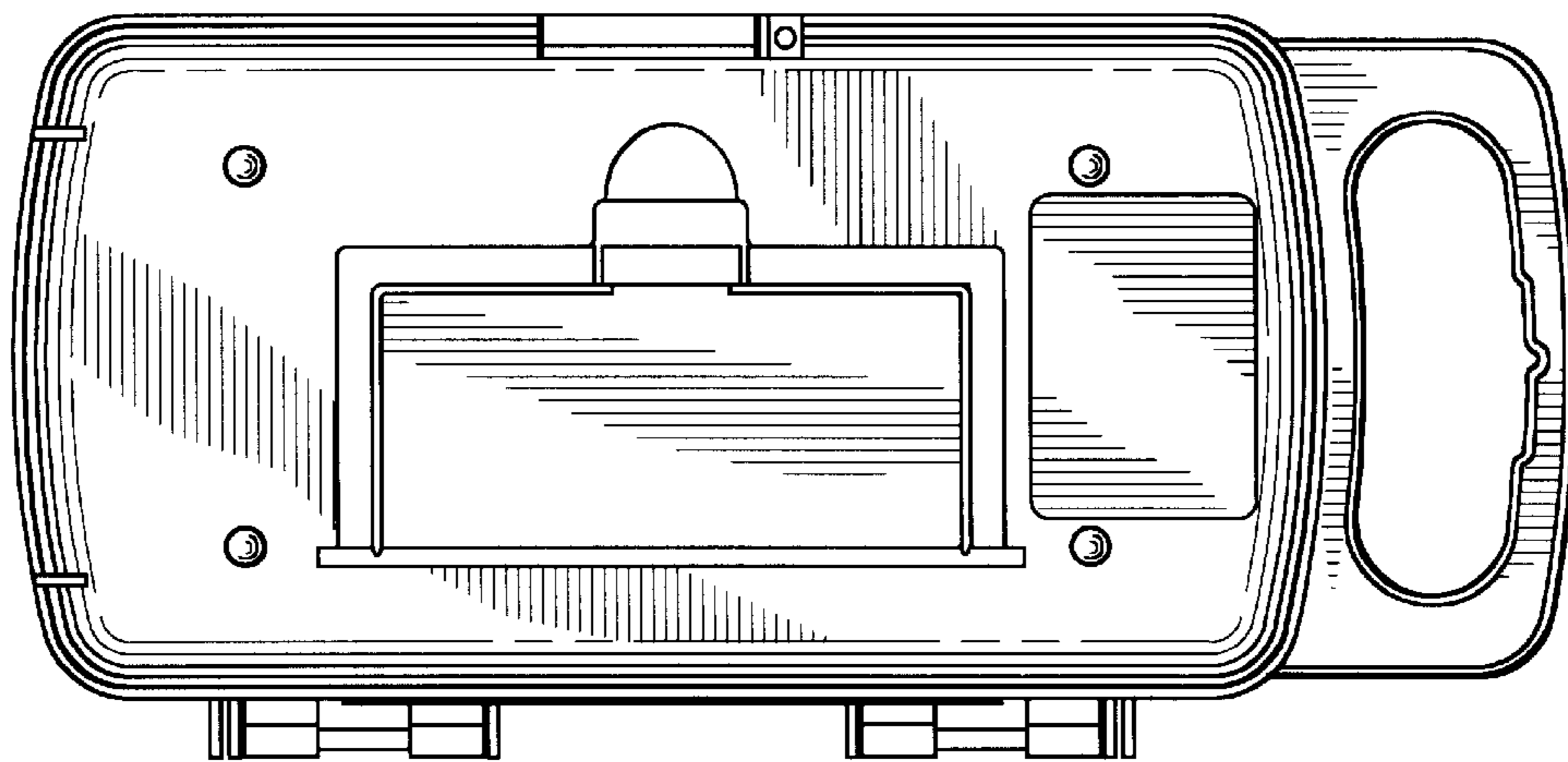

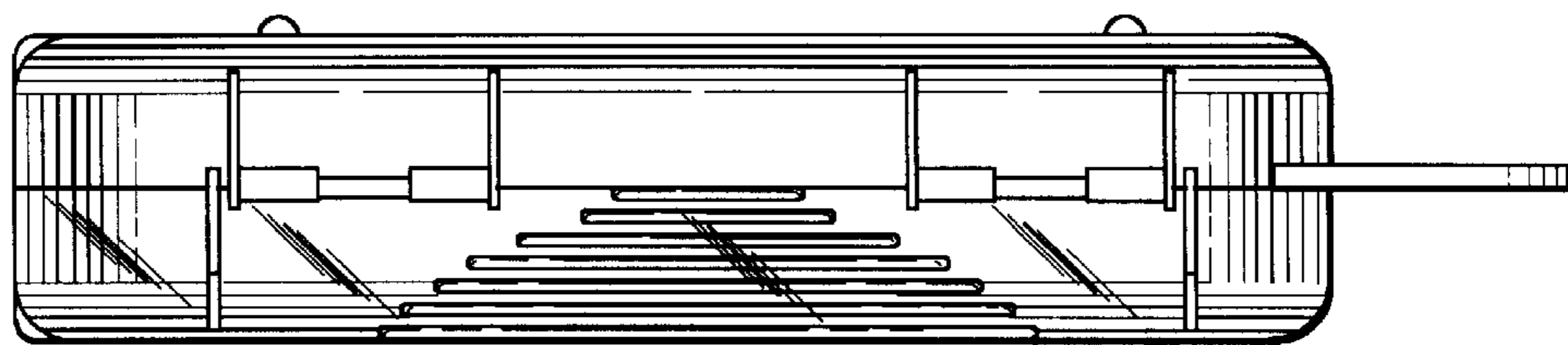

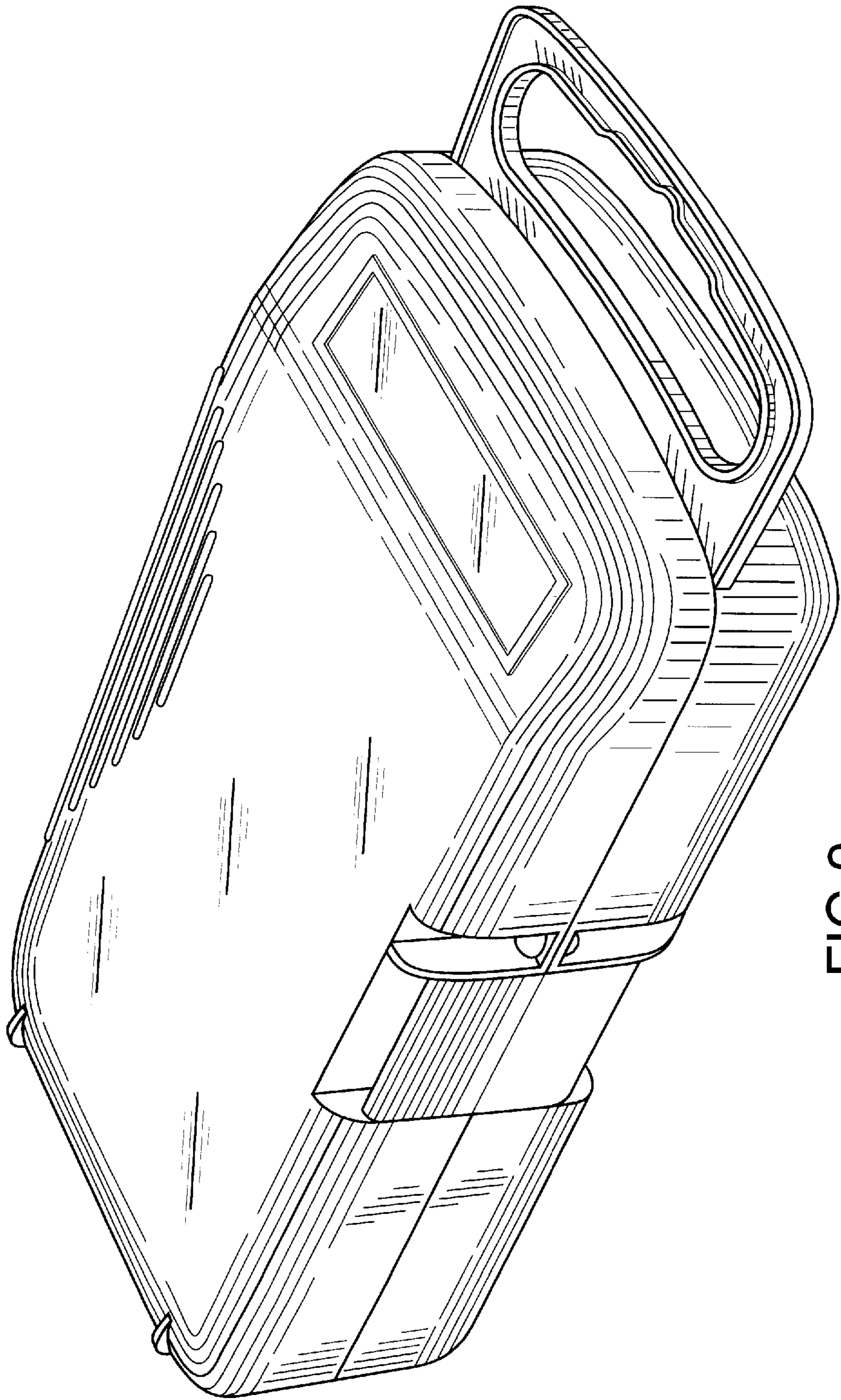

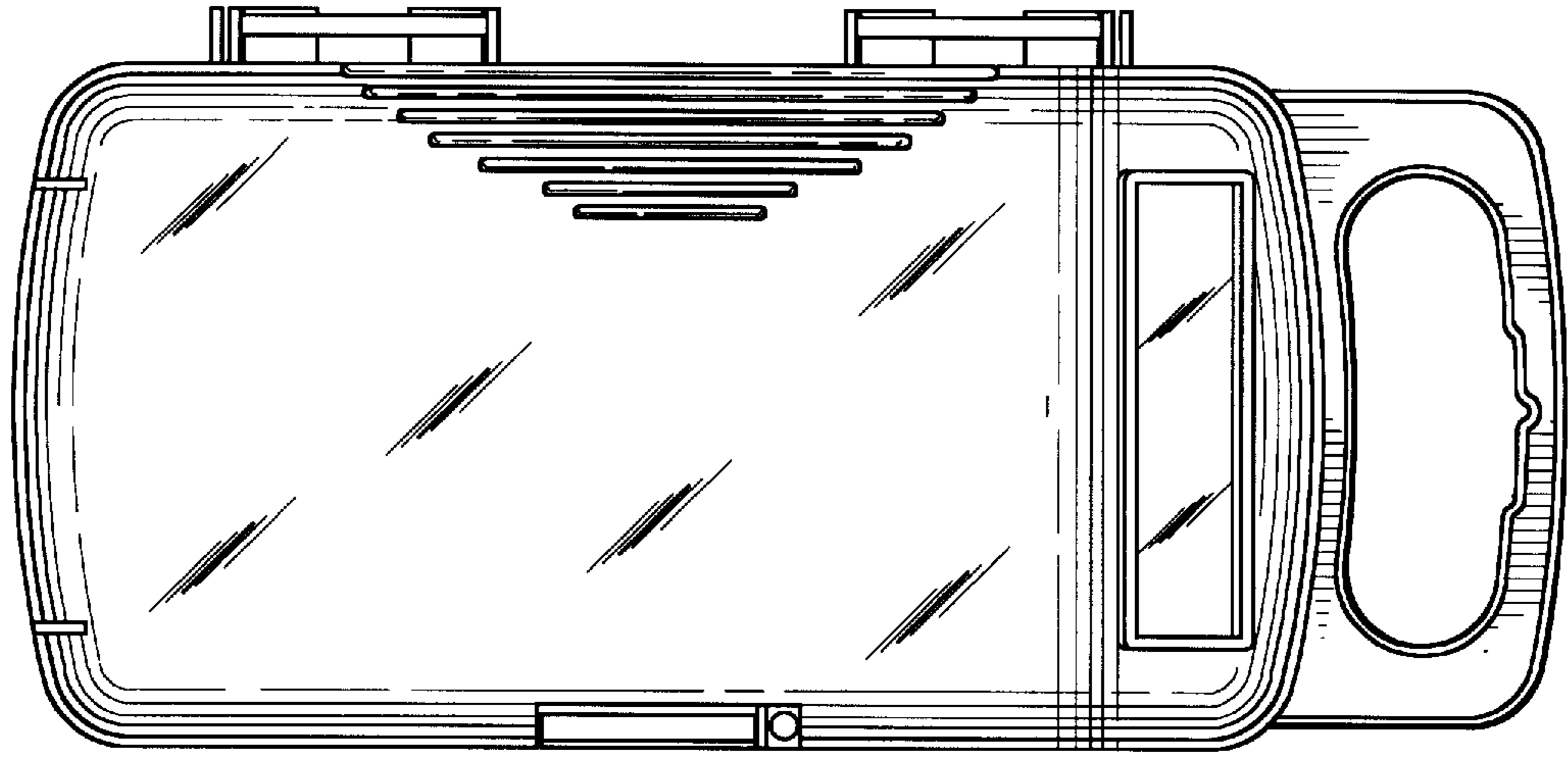

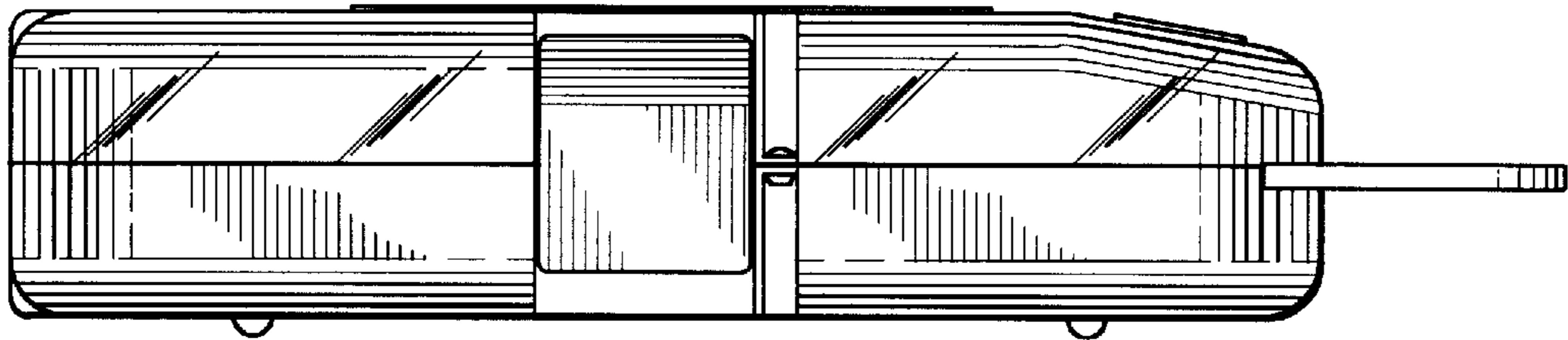

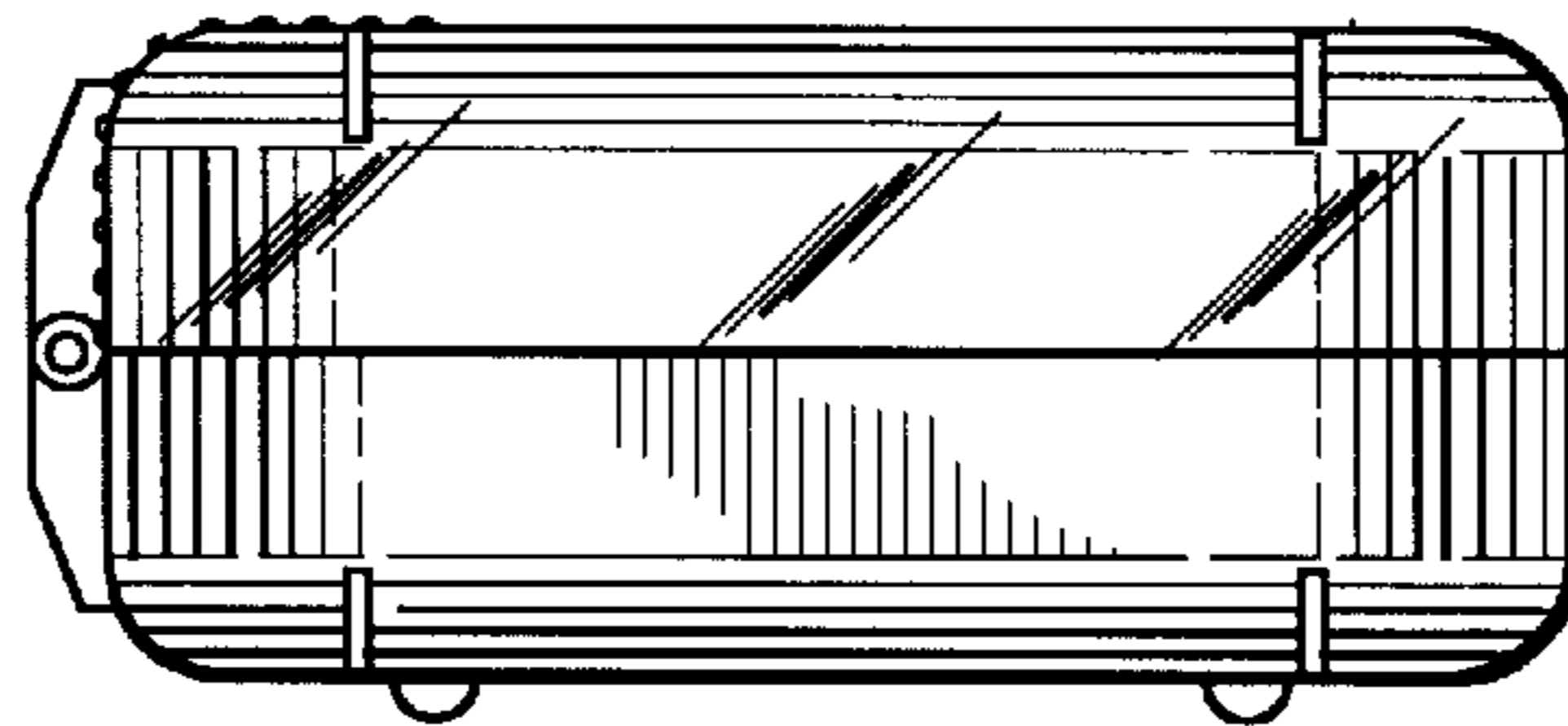

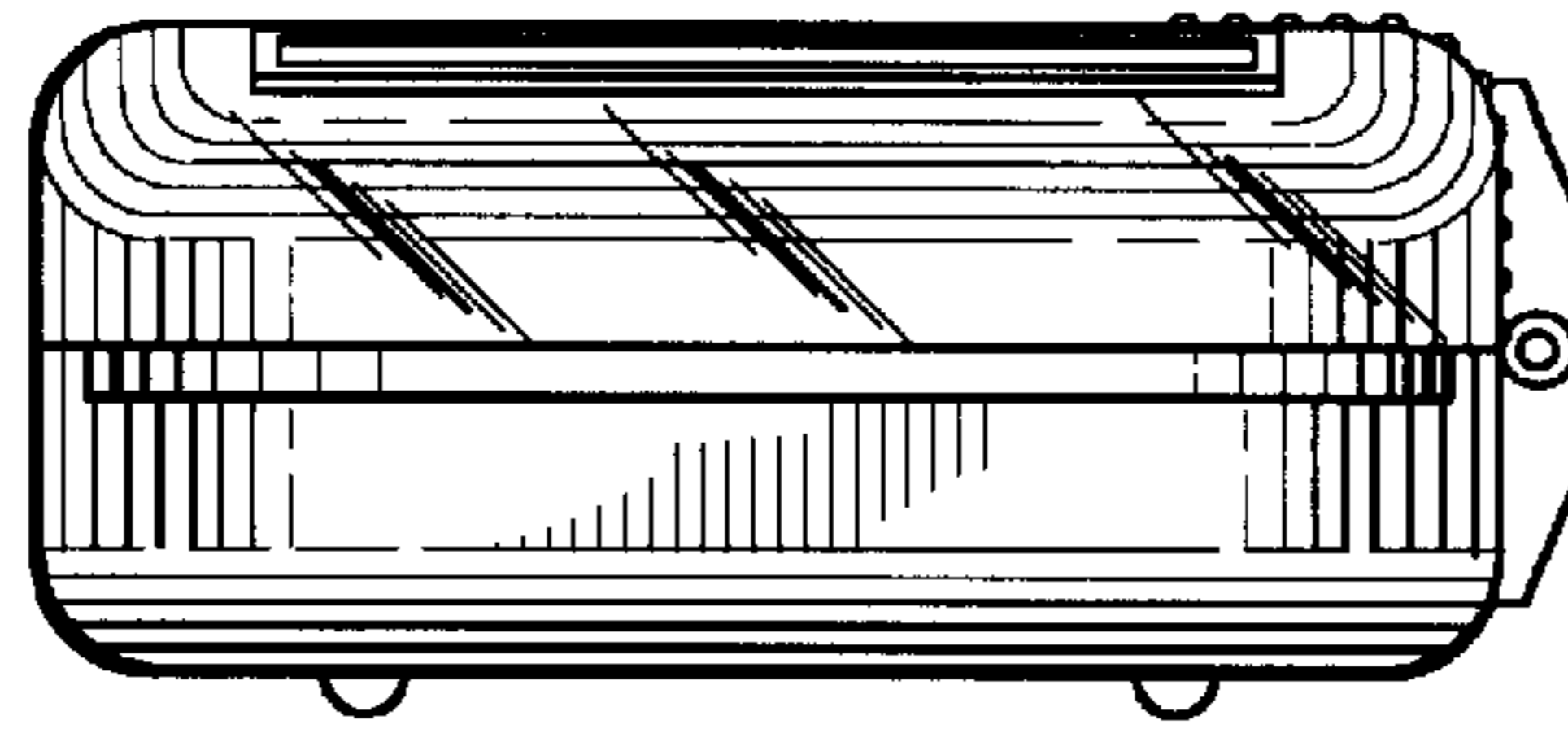

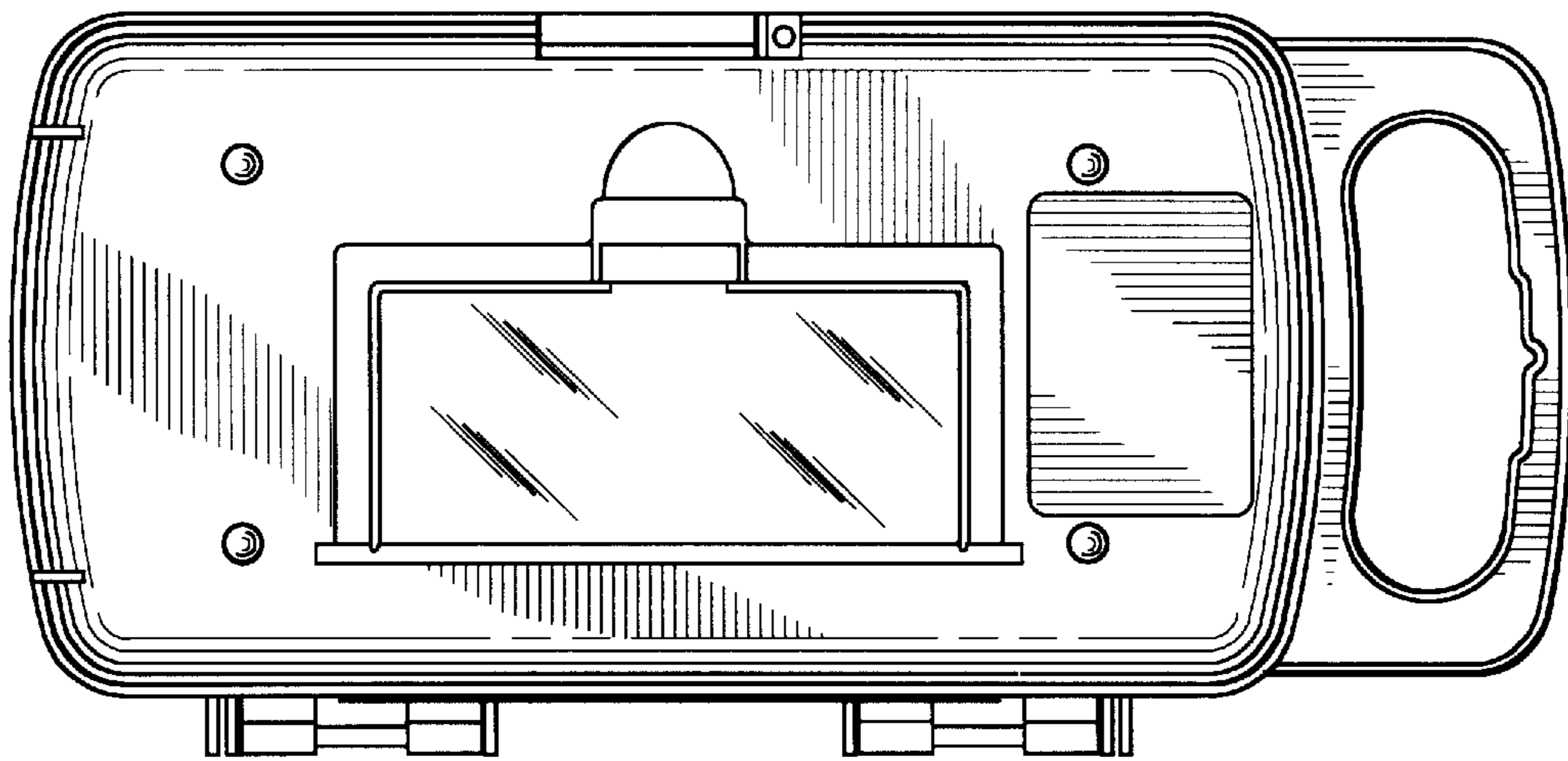

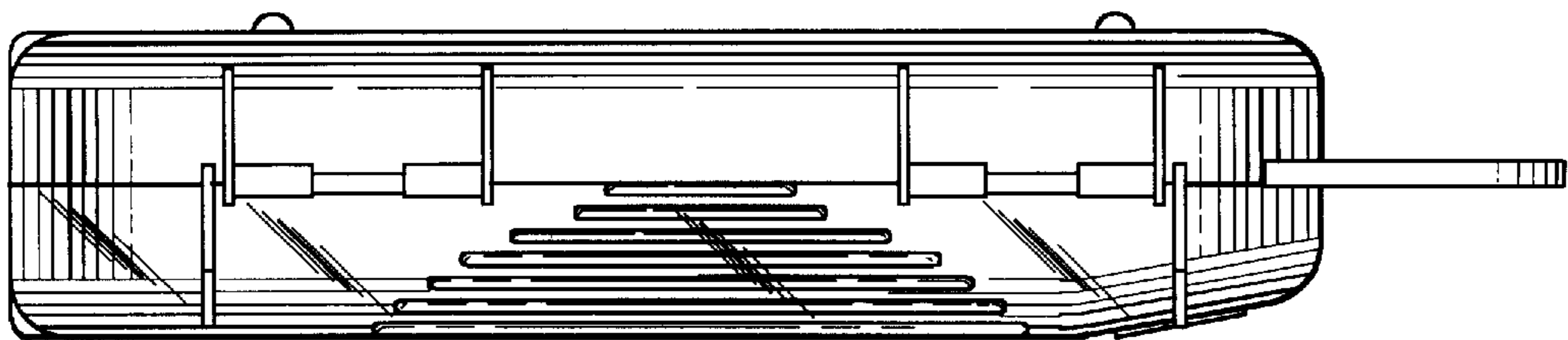

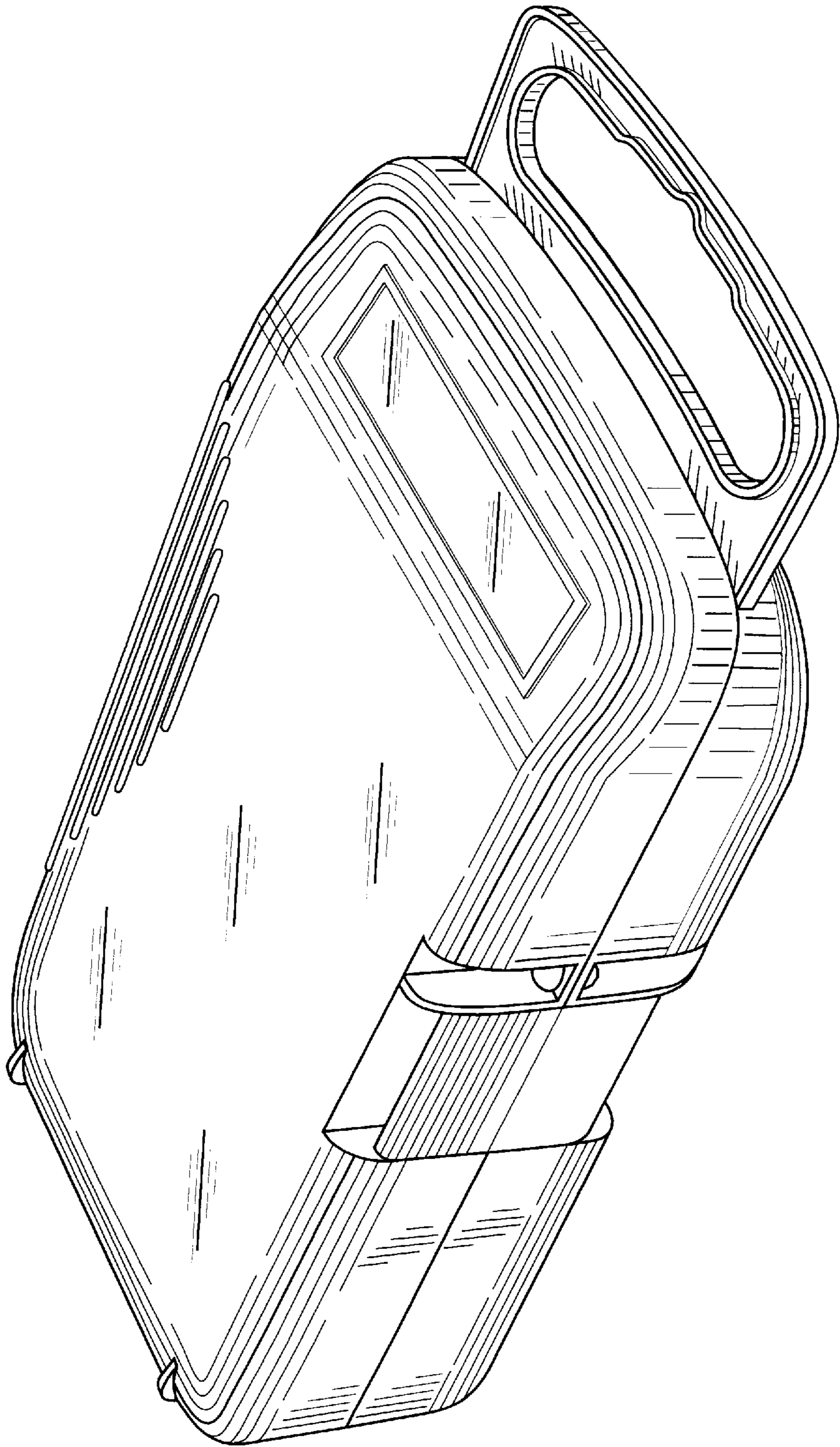

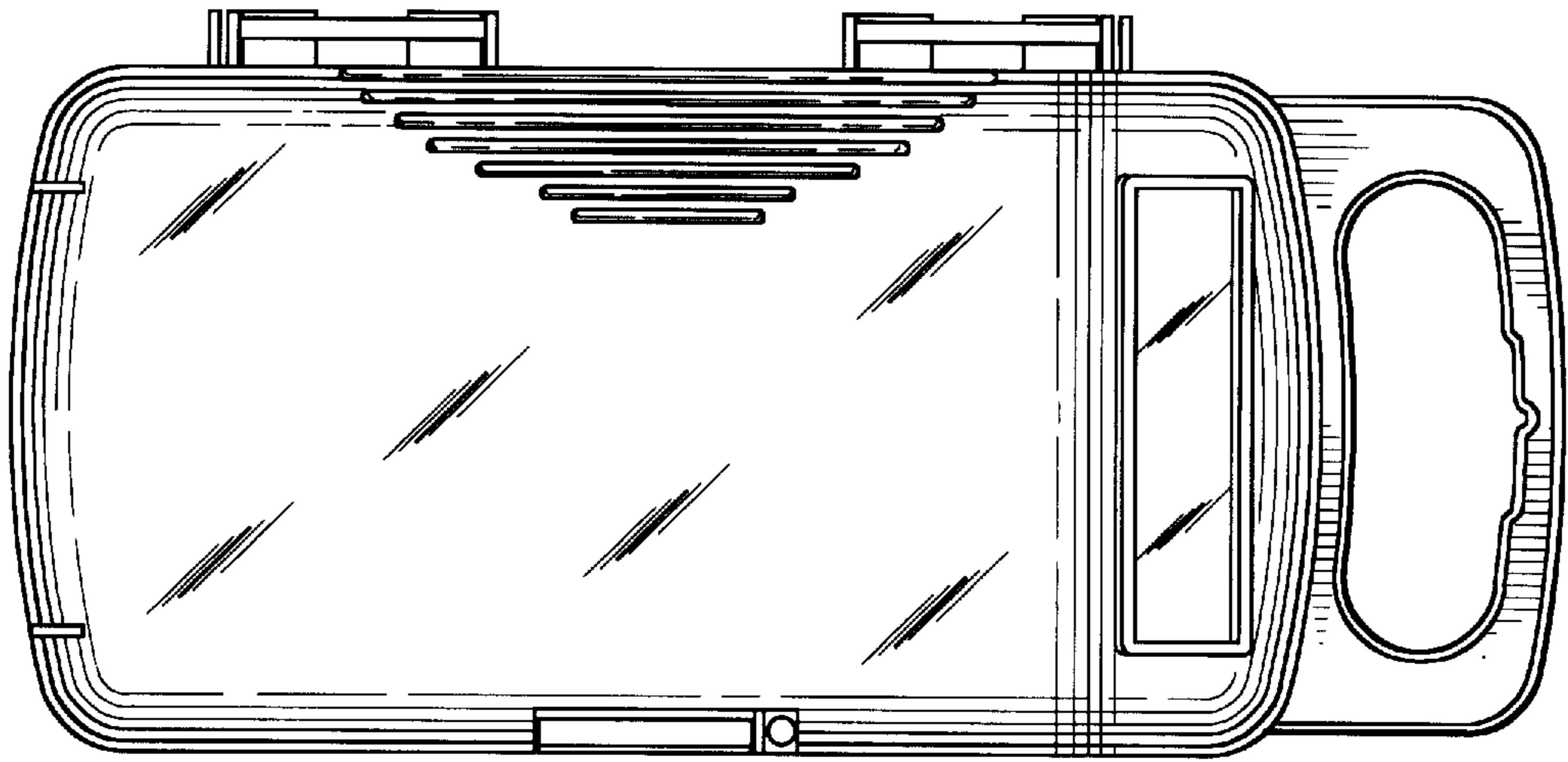

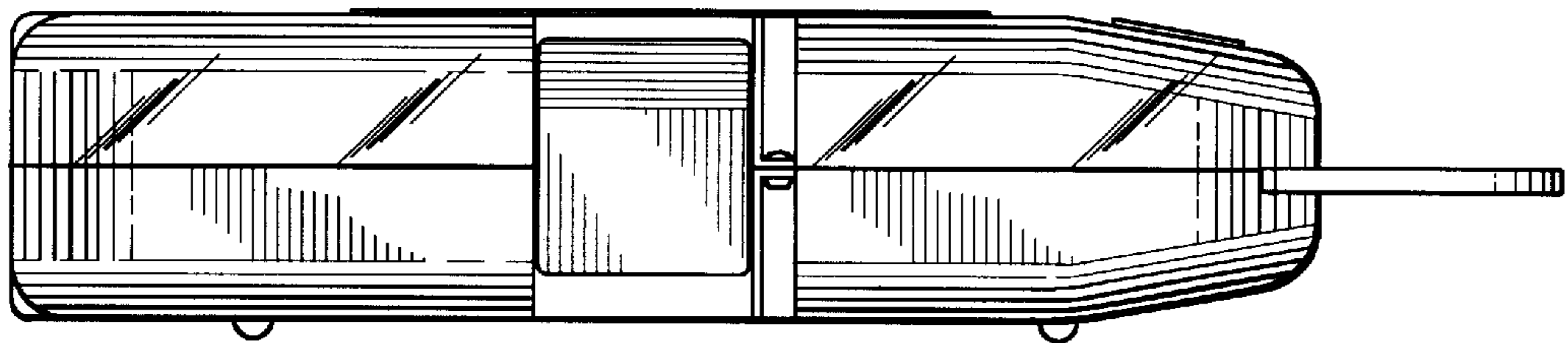

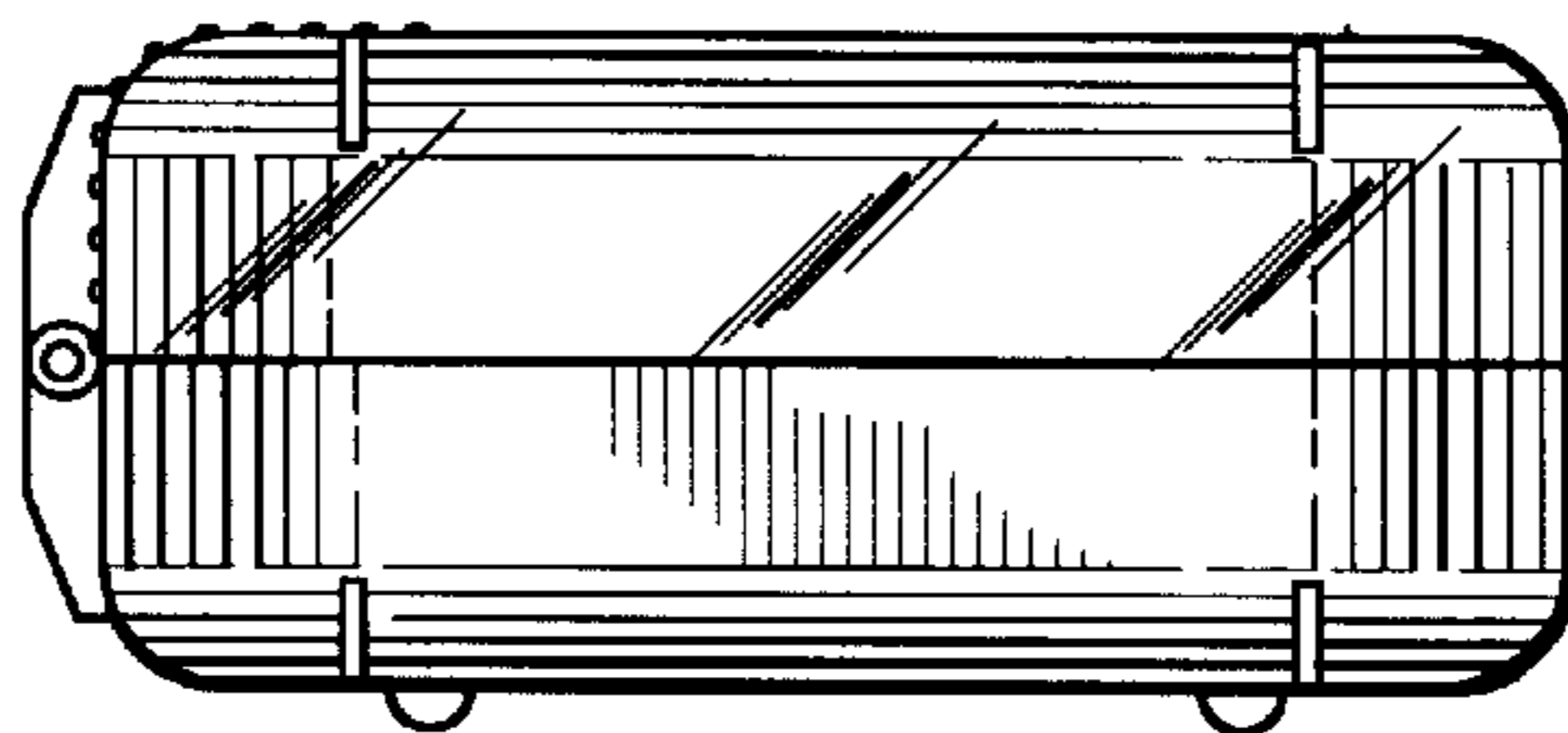

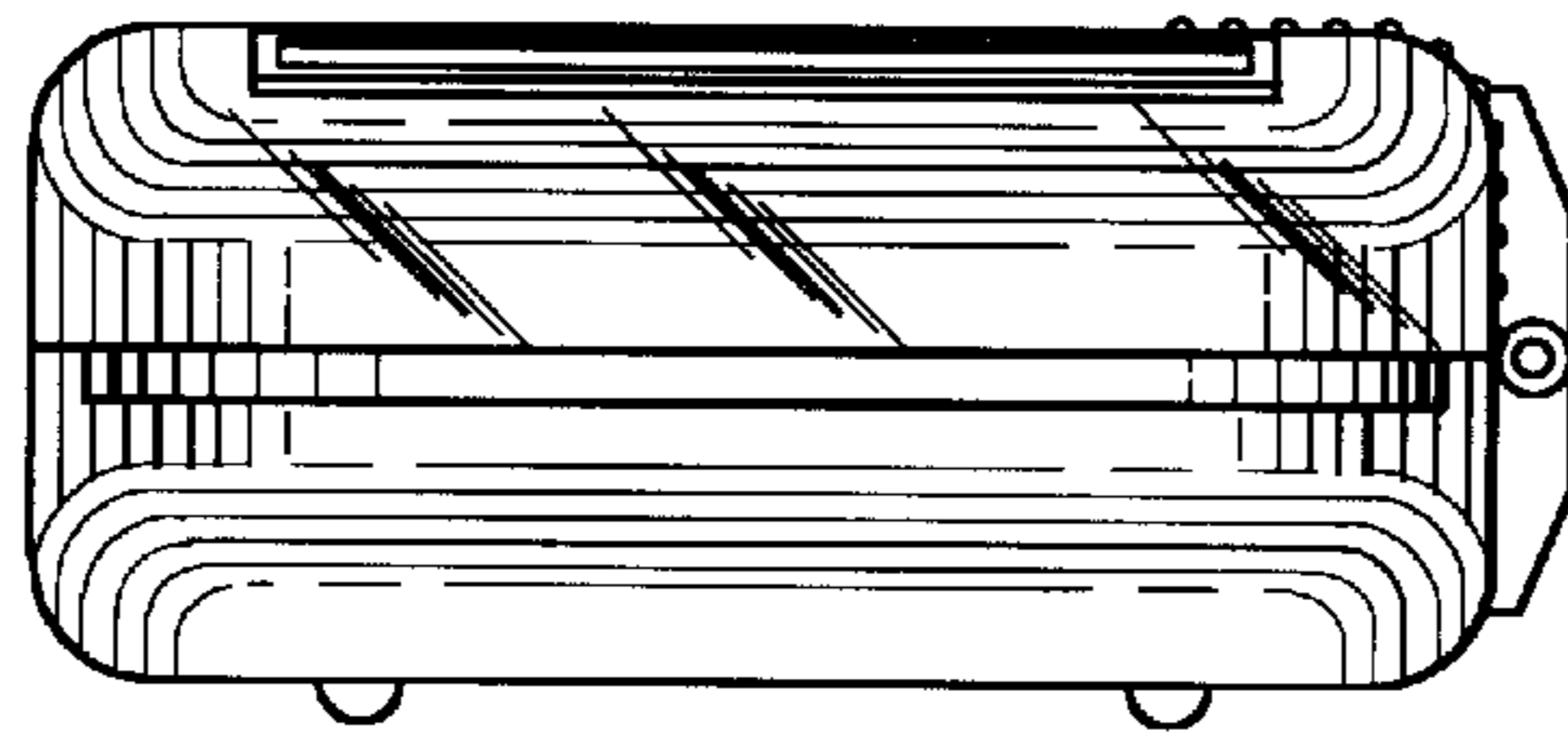

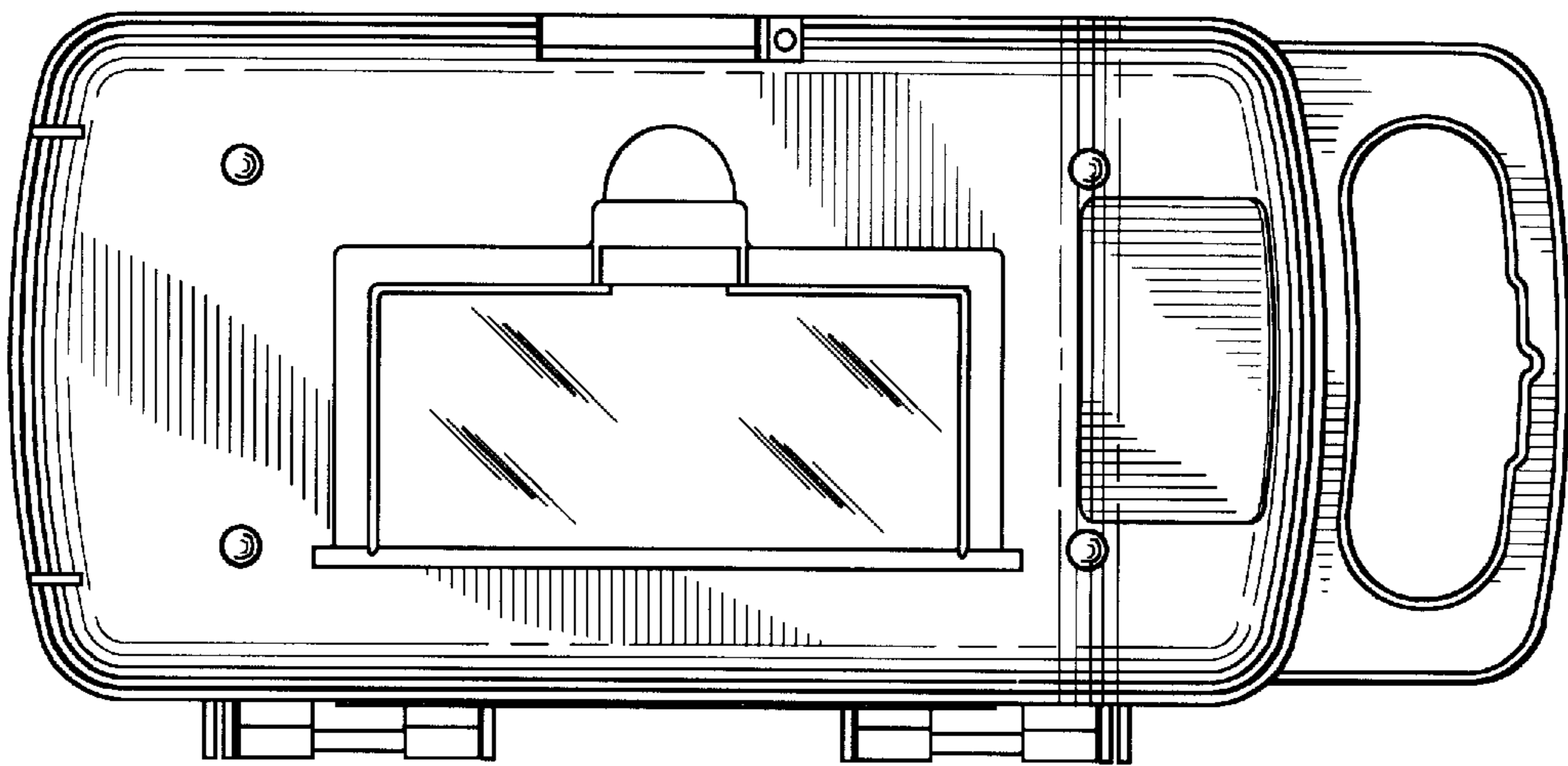

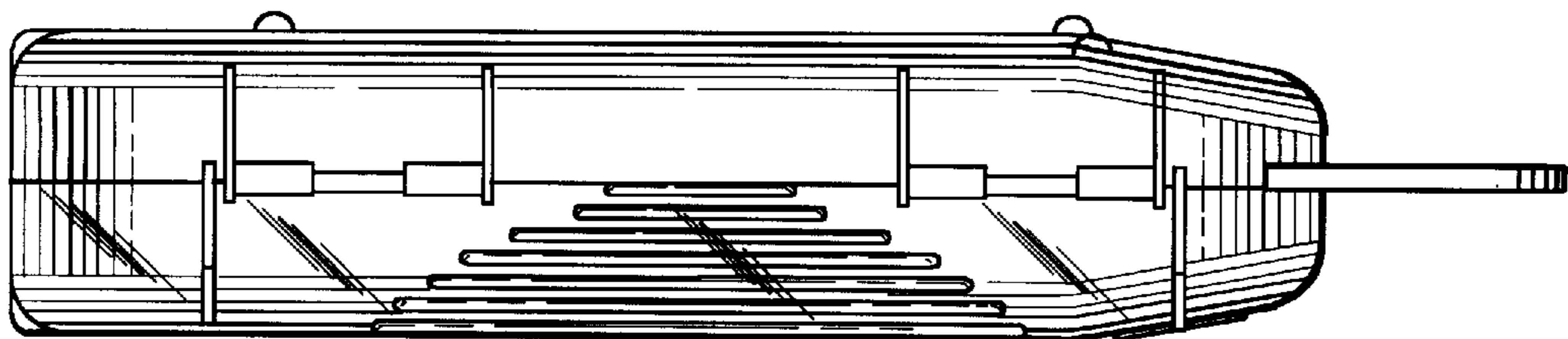
