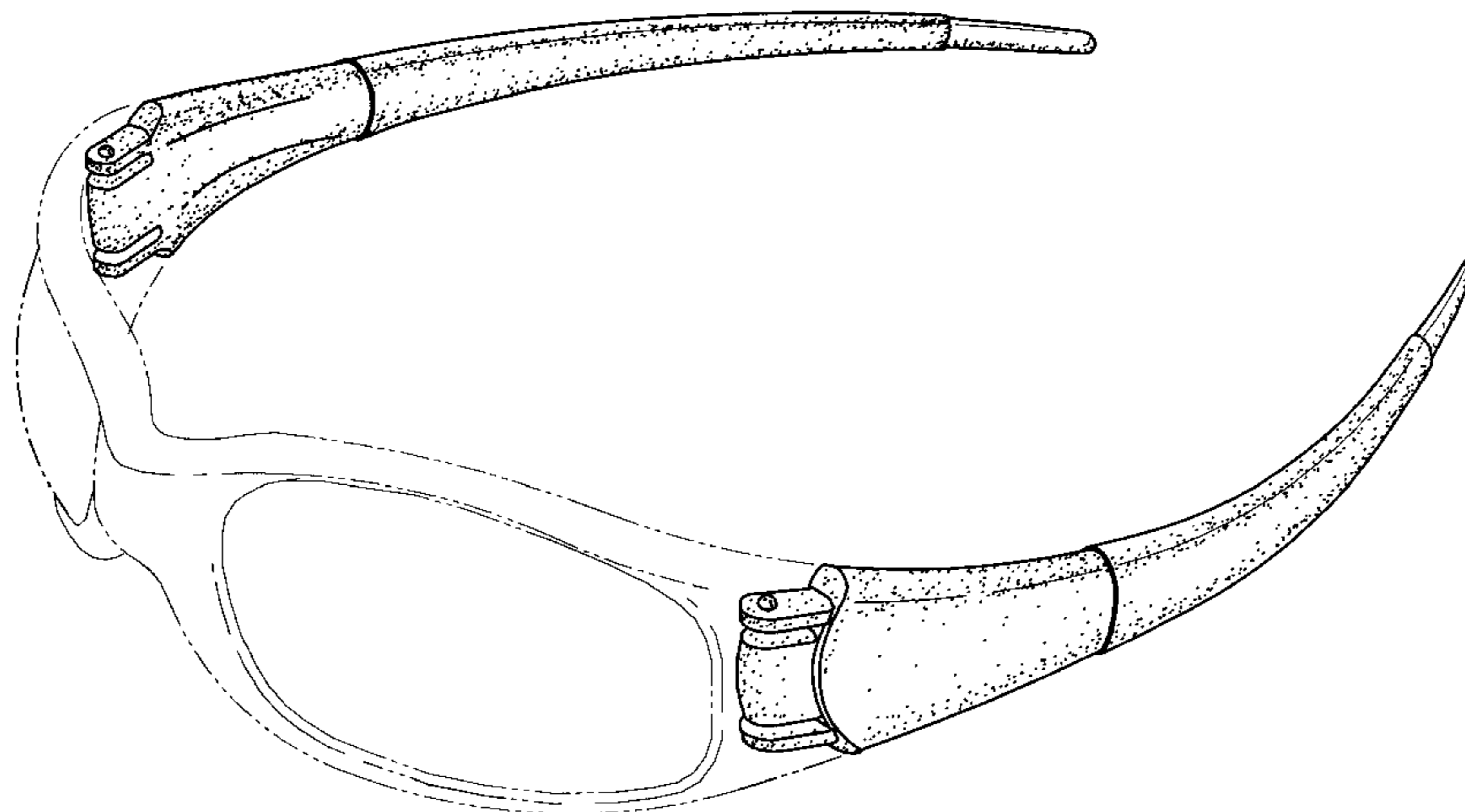
## [57] CLAIM

The ornamental design for earstems, as shown and described.

## DESCRIPTION

FIG. 1 is a perspective view of the earstems showing our new design, the broken lines are for illustrative purposes only and form no part of the claimed design;  
FIG. 2 is a front elevational view of the eyeglass components of FIG. 1;  
FIG. 3 is a rear elevational view of the eyeglass components of FIG. 1;  
FIG. 4 is a right side elevational view of the eyeglass components of FIG. 1, the left side elevational view being a mirror image thereof;  
FIG. 5 is a view taken along line 5—5 of FIG. 2;  
FIG. 6 is a bottom plan view of the eyeglass components of FIG. 1; and,  
FIG. 7 is a top plan view of the eyeglass components of FIG. 1.

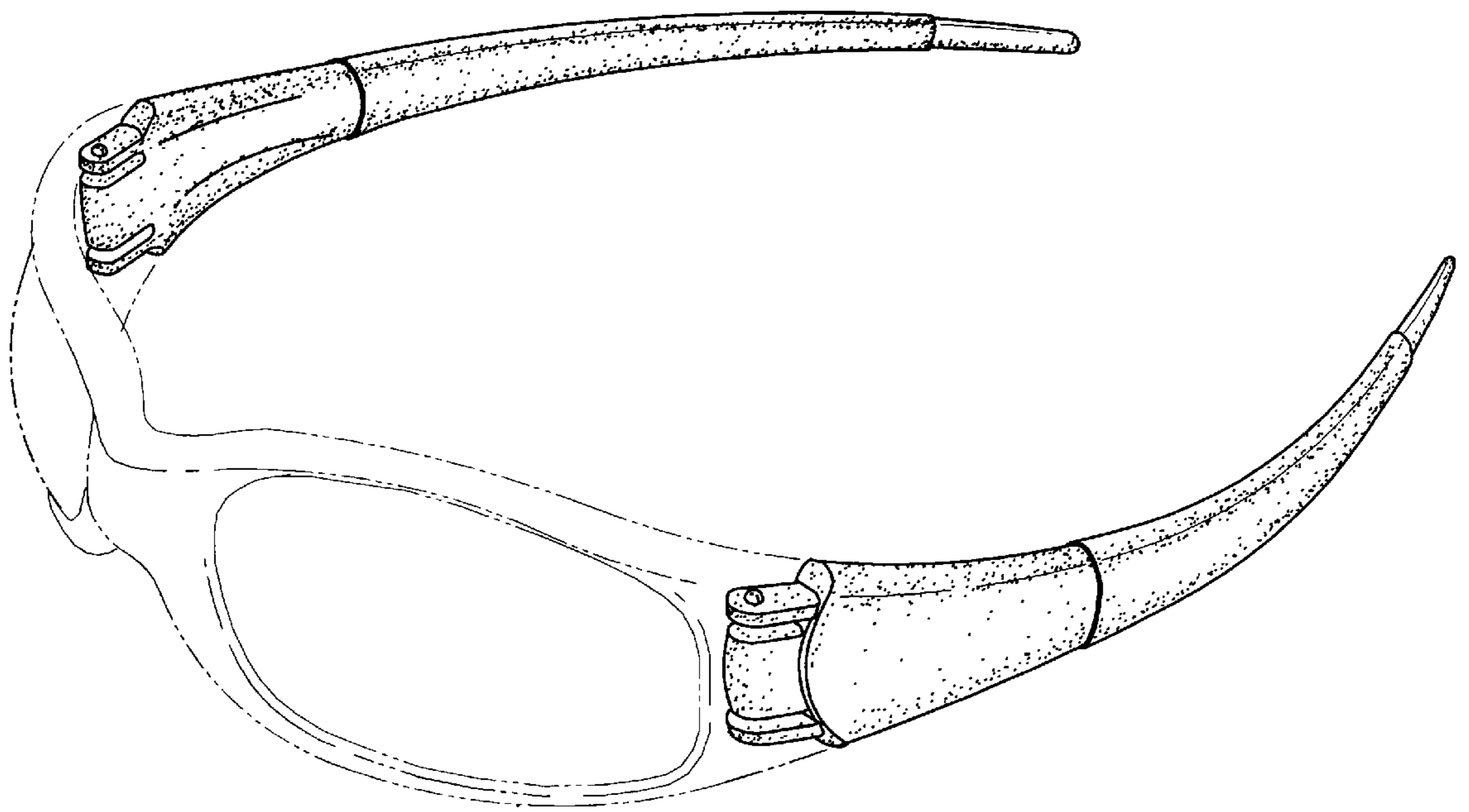

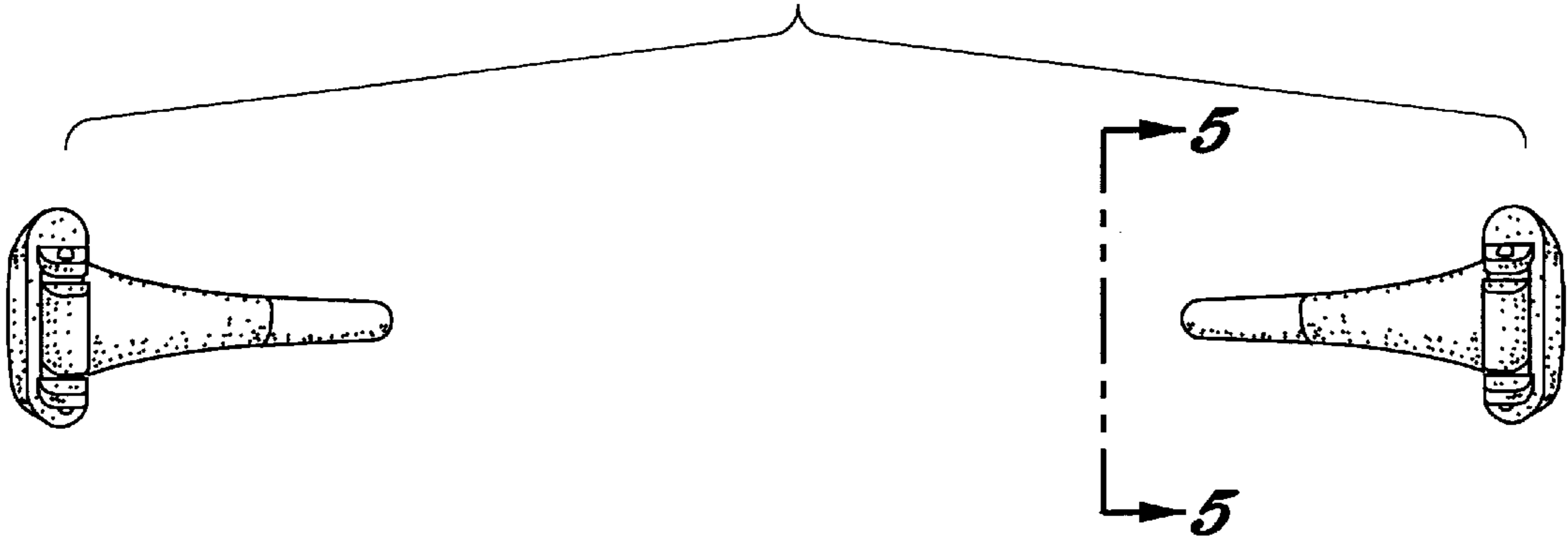

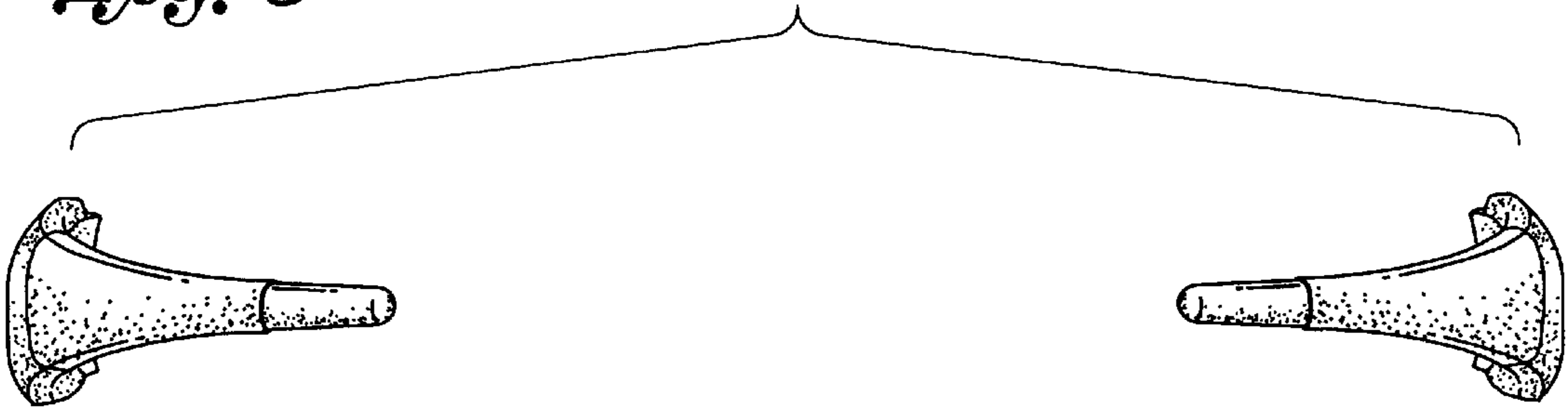

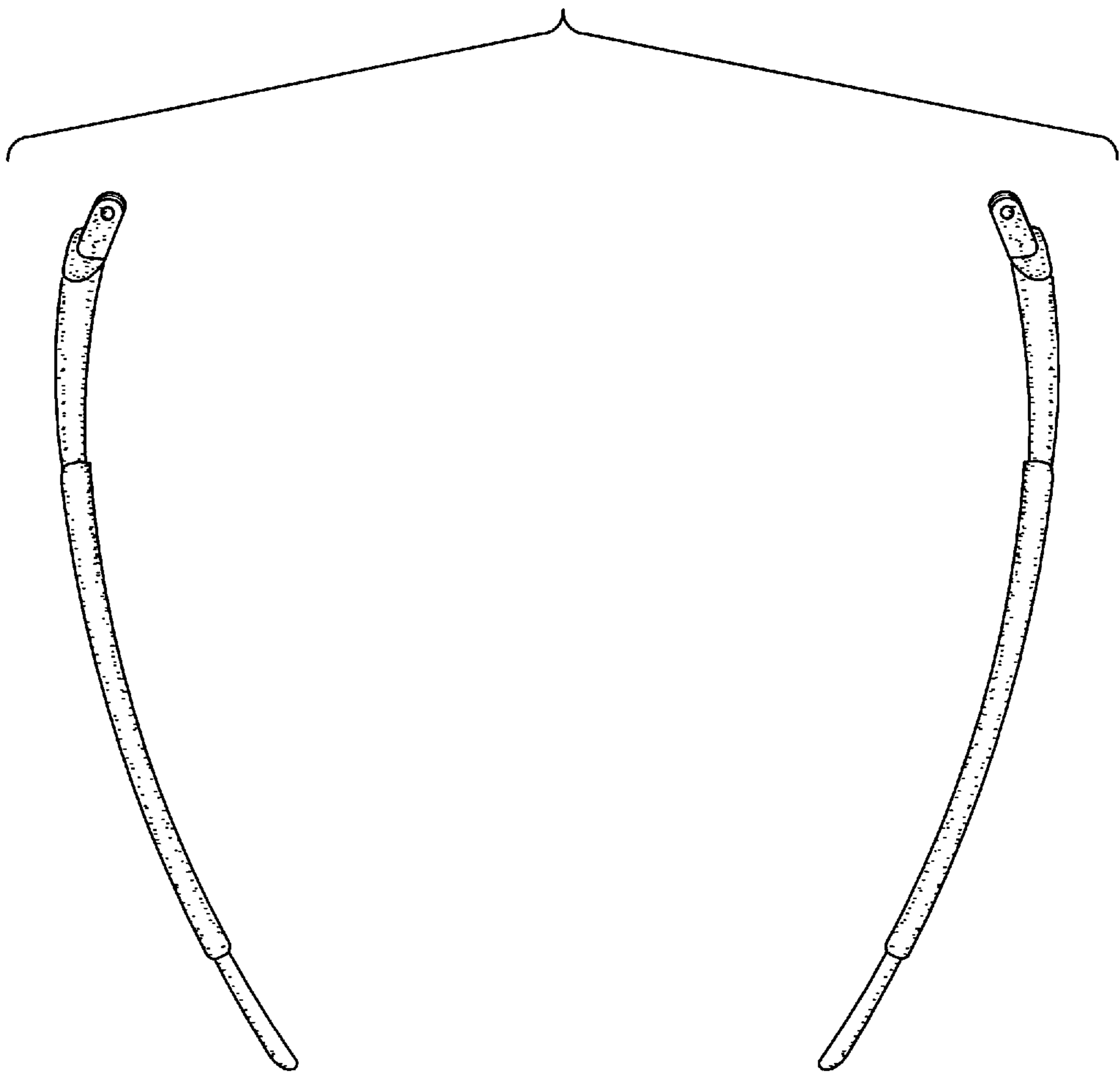
