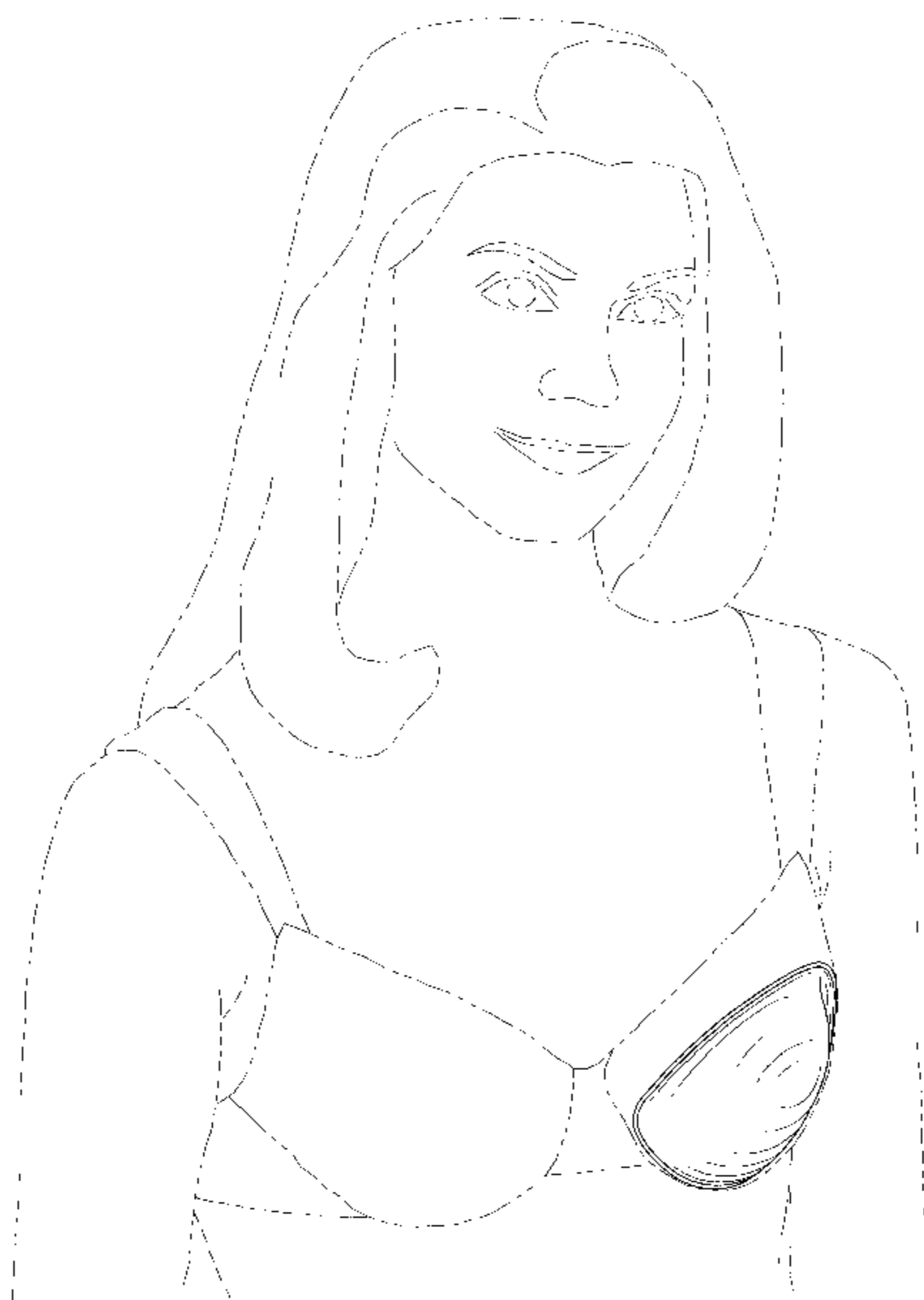
[57] **CLAIM**

The ornamental design for a breast enhancer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the breast enhancer; FIG. 2 is a front view of the breast enhancer; FIG. 3 is a left side view of the breast enhancer; FIG. 4 is a right side view of the breast enhancer; FIG. 5 is a rear view of the breast enhancer; FIG. 6 is a top view of the breast enhancer; and, FIG. 7 is a bottom view of the breast enhancer. The broken line showing of a woman in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

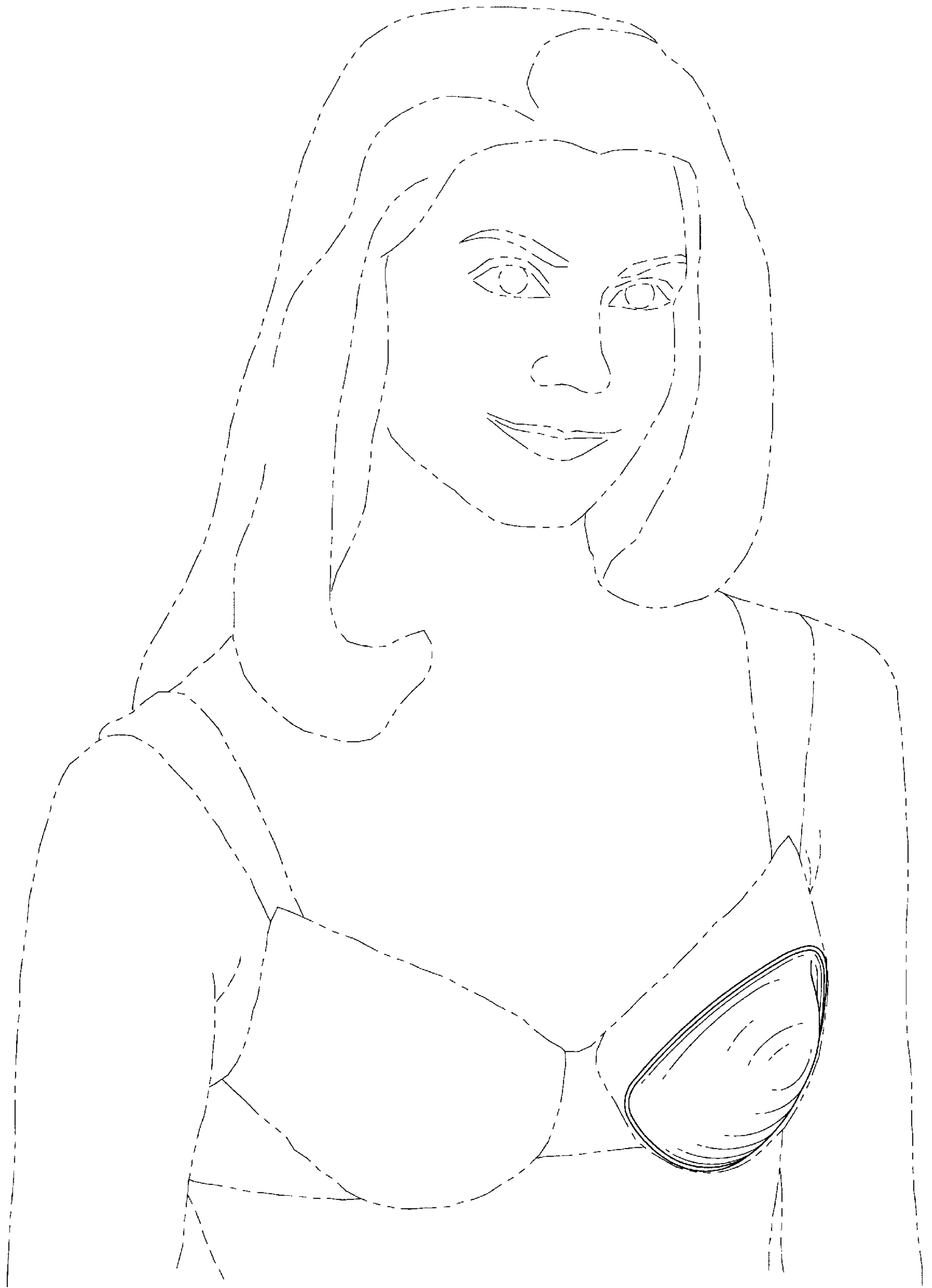

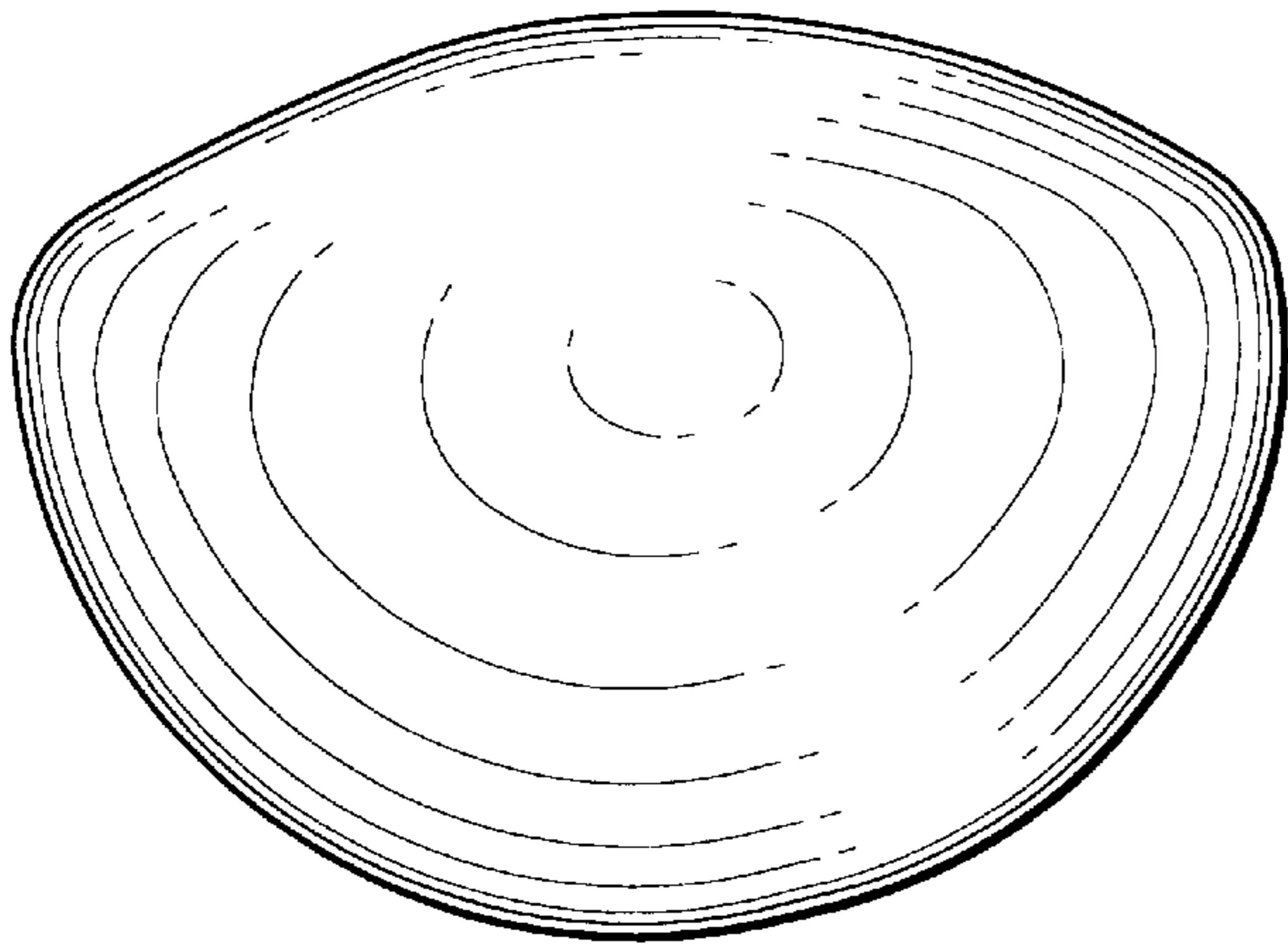

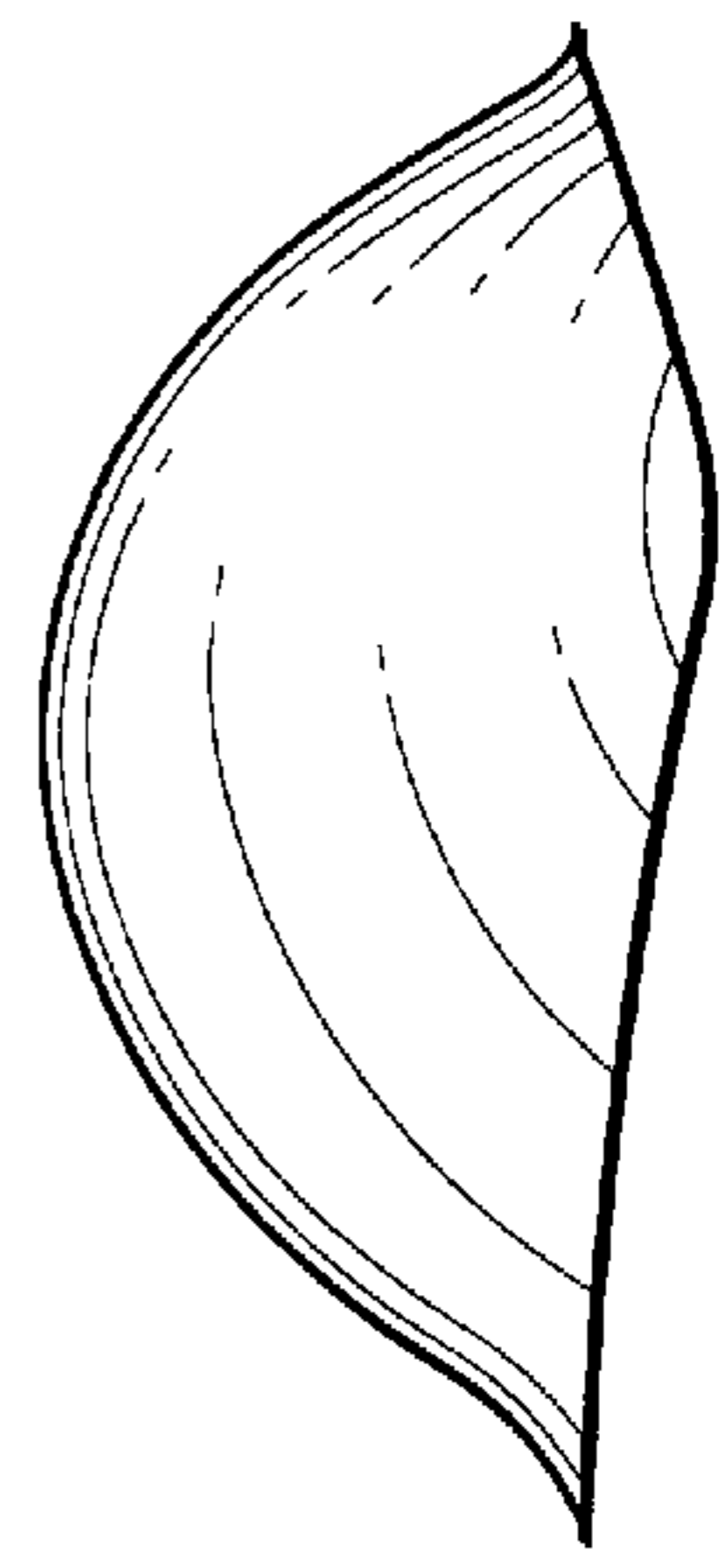

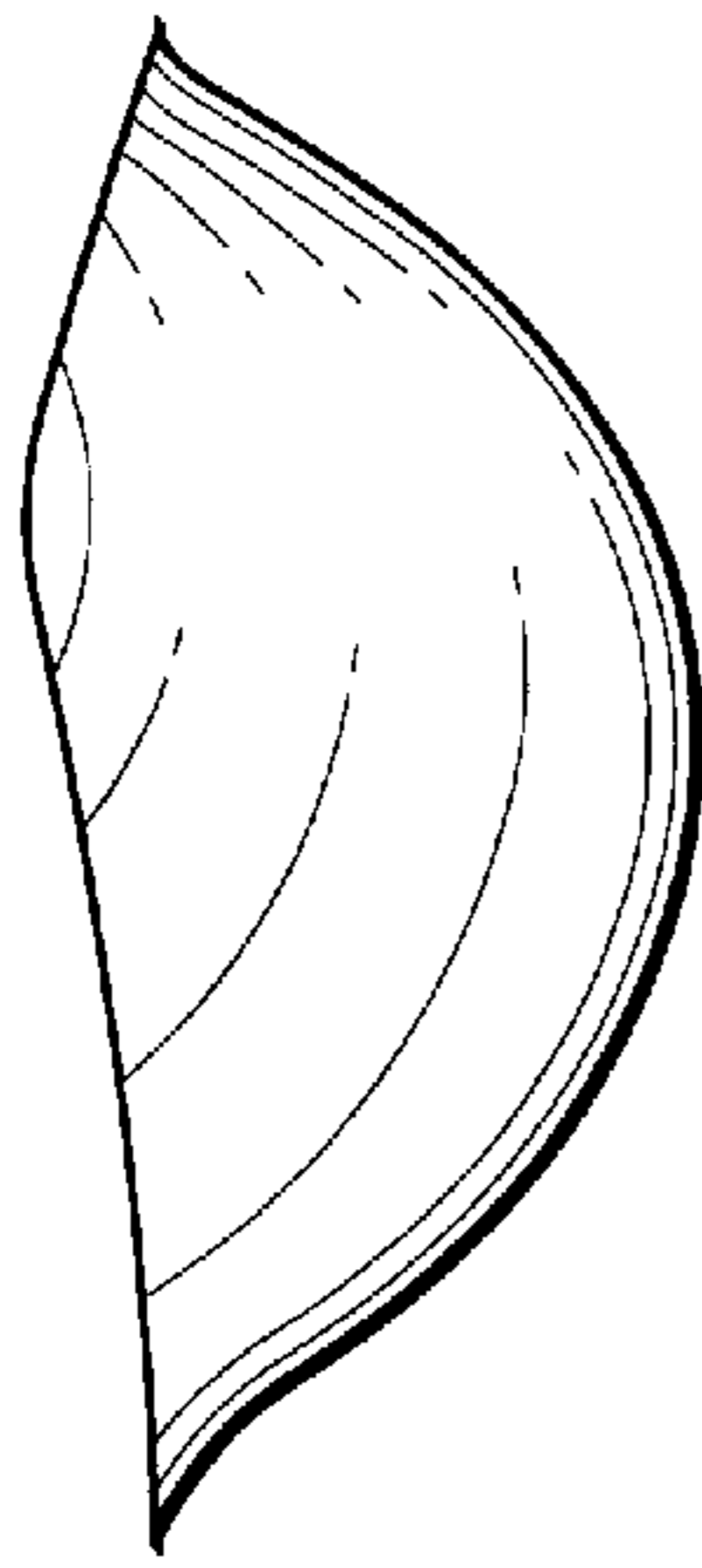

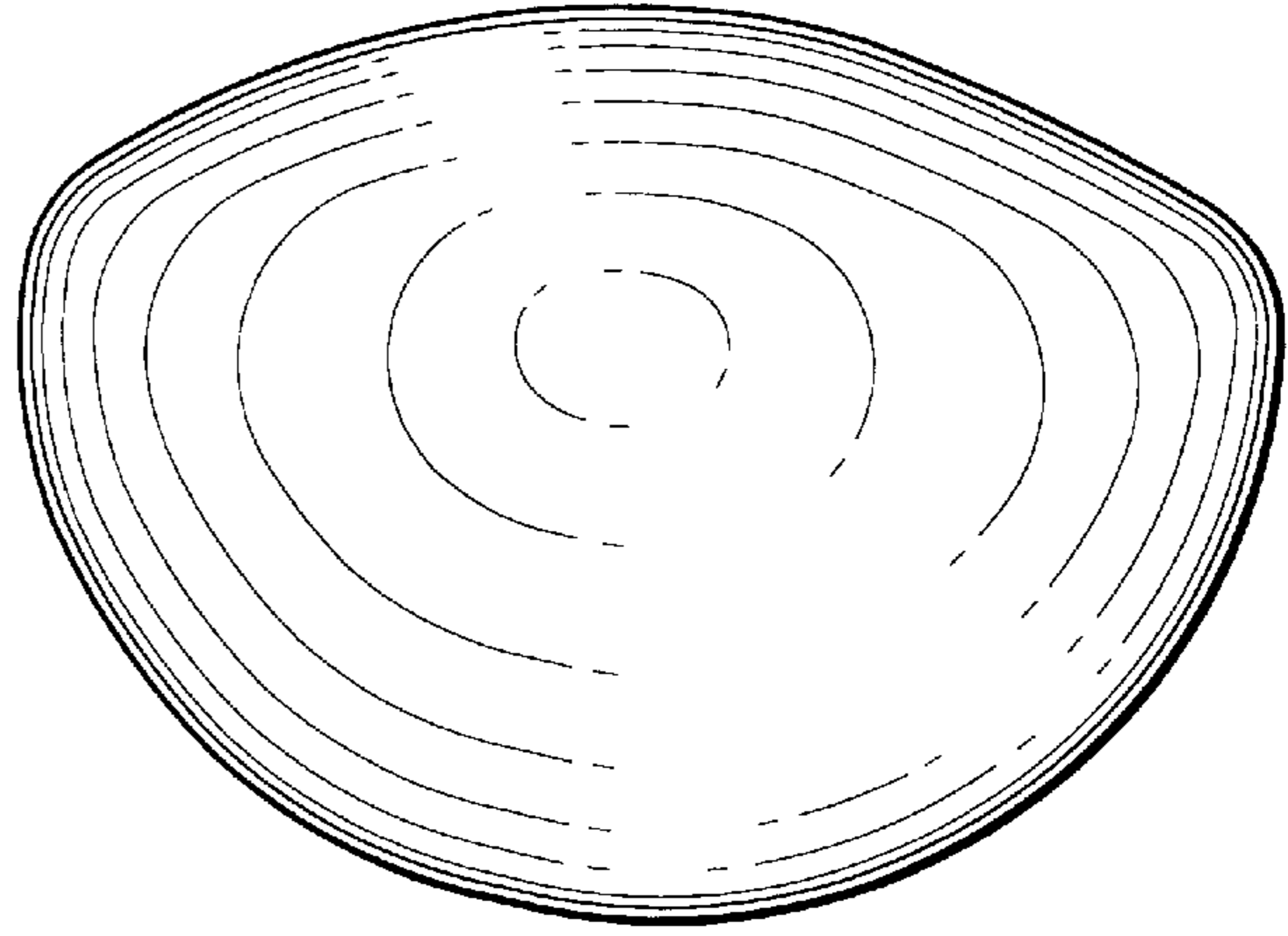

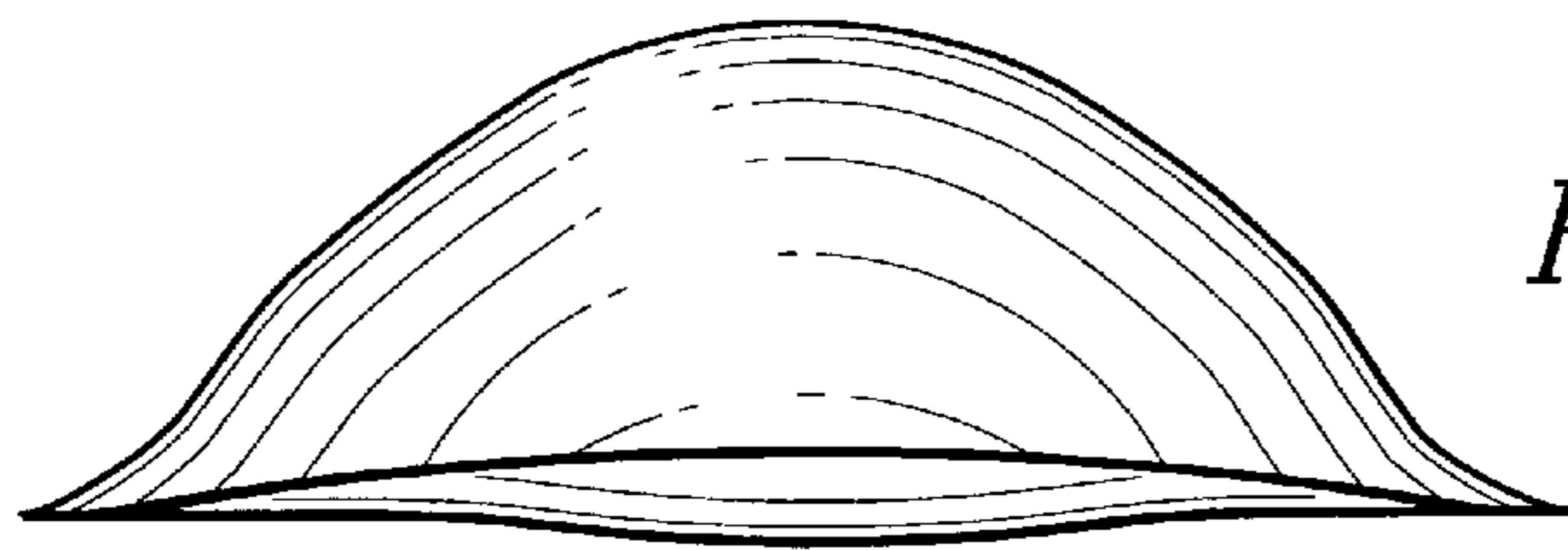

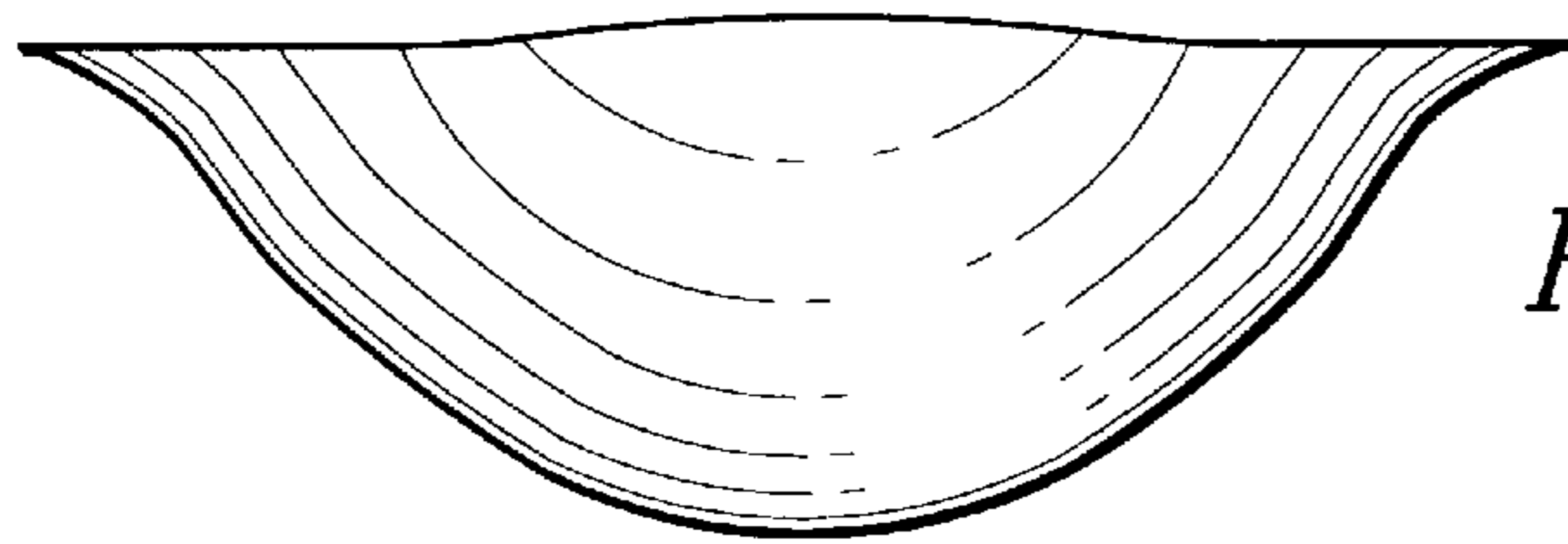
