### [57] CLAIM

The ornamental design for a portion of a shoe outsole, as shown and described.

### DESCRIPTION

FIG. 1 is a first perspective view of a portion of a shoe outsole showing my new design;

FIG. 2 is a plan view of the portion of a shoe outside in FIG. 1;

FIG. 3 is a cross-sectional view of the portion of a shoe outsole taken along line 3—3 of FIG. 2;

FIG. 4 is a cross-sectional view of the portion of a shoe outsole taken along line 4—4 of FIG. 2;

FIG. 5 is a cross-sectional view of the portion of a shoe outsole taken along line 5—5 of FIG. 2;

FIG. 6 is a cross-sectional view of the portion of a shoe outsole taken along line 6—6 of FIG. 2; and,

FIG. 7 is a second perspective view of the portion of a shoe outsole taken from viewpoint is diagonal from that of FIG. 2.

The broken line showing of the remainder of the shoe is for illustration purposes only and forms no part of the claimed design.

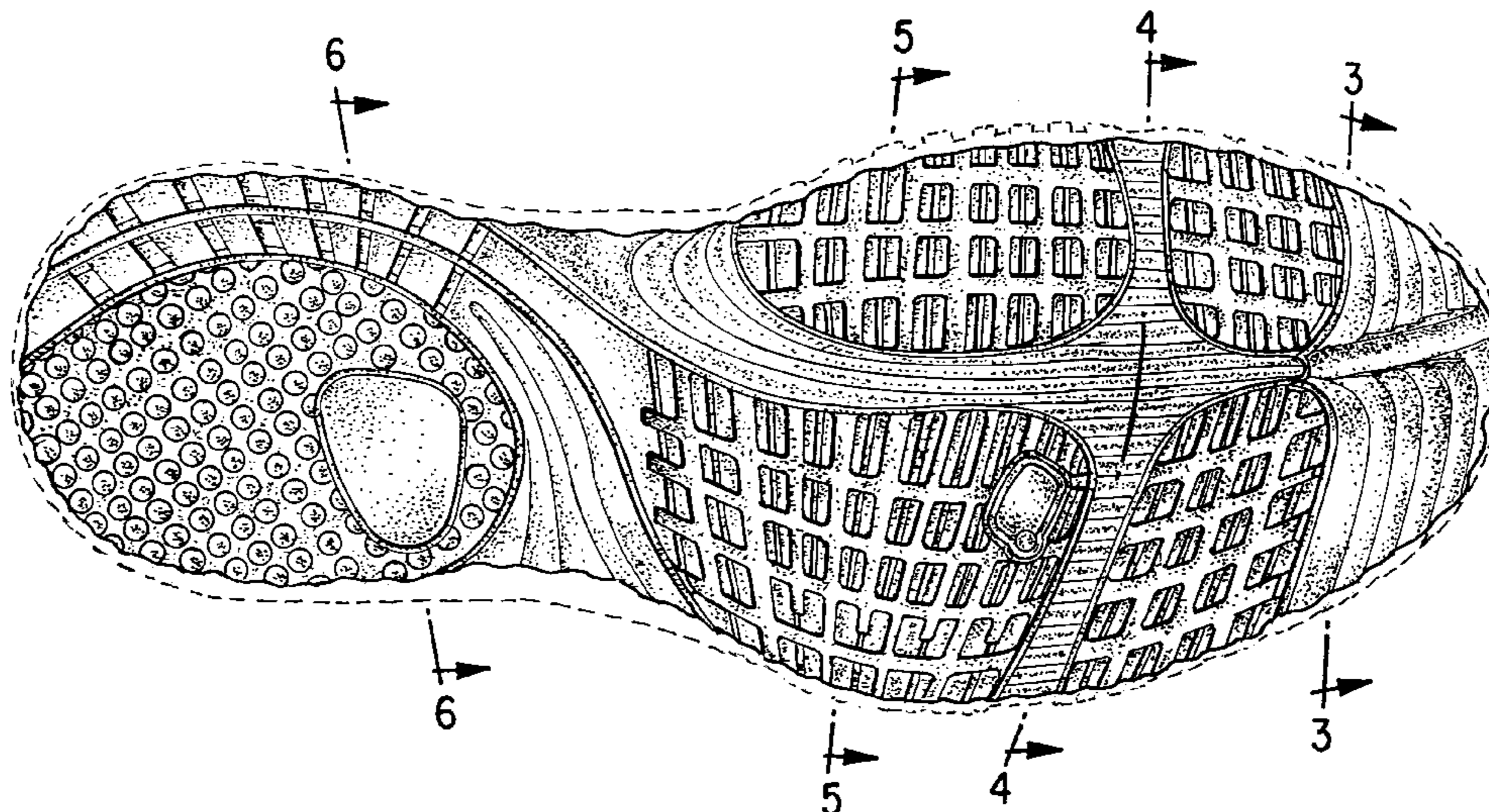

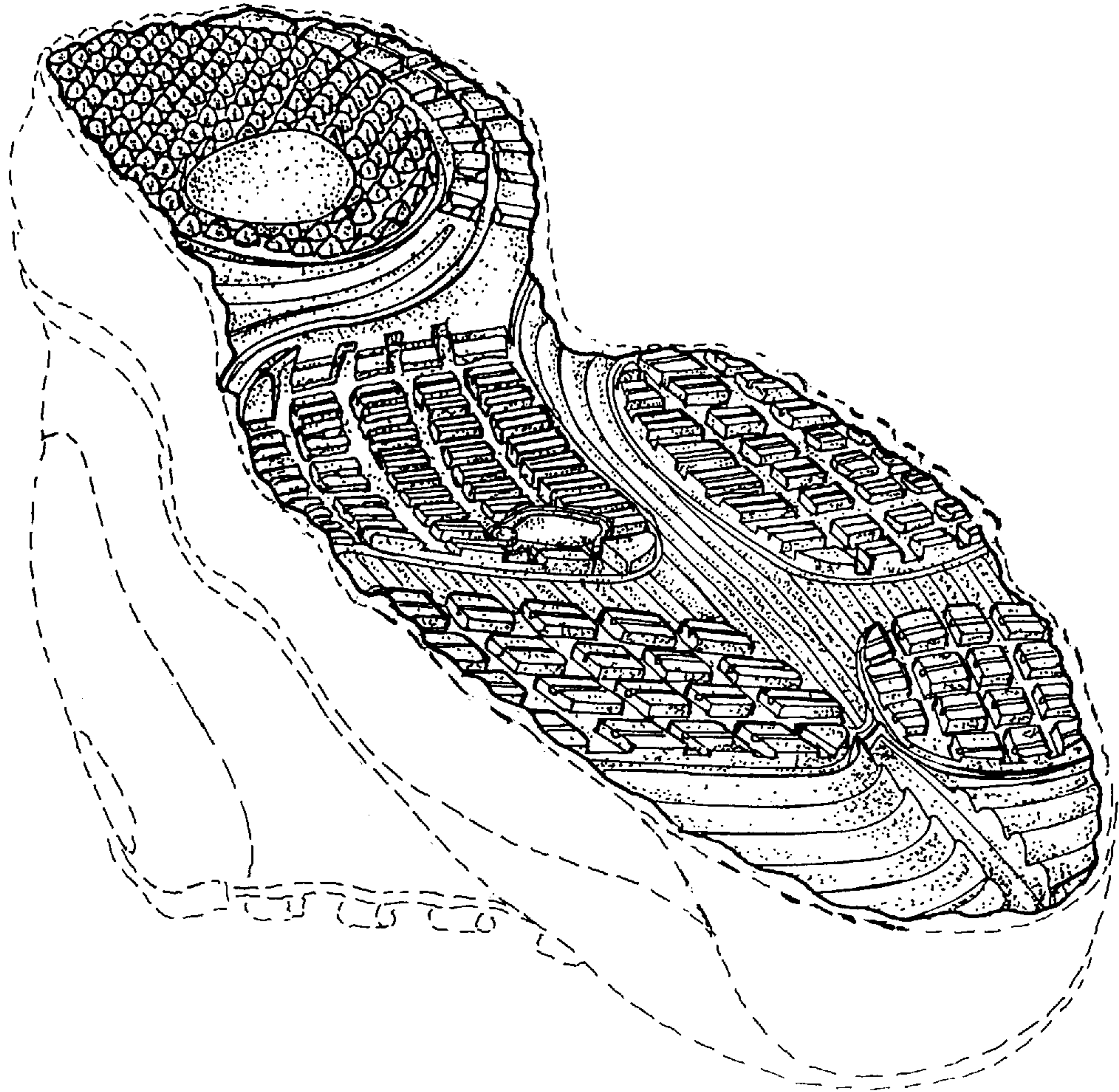

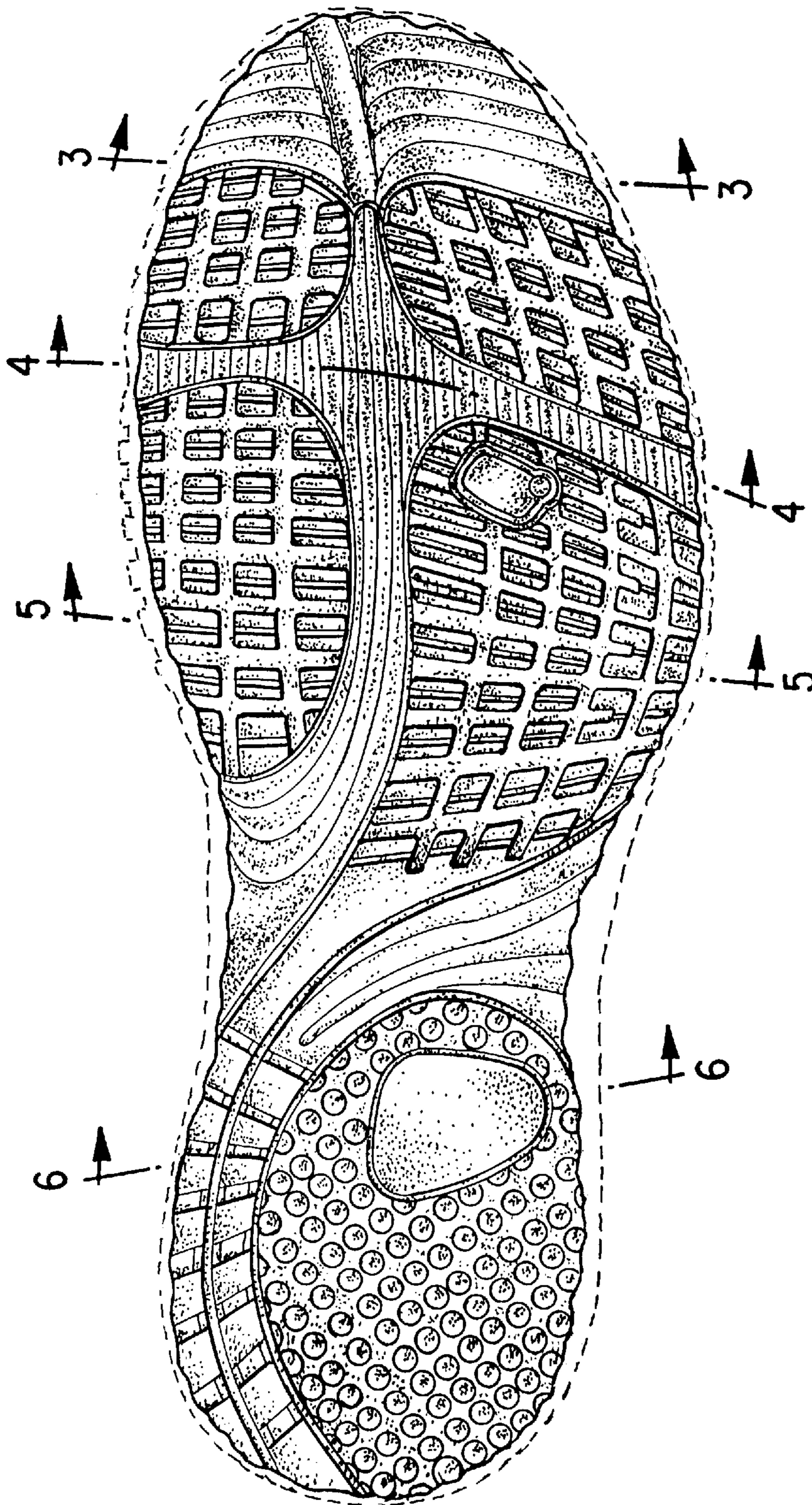

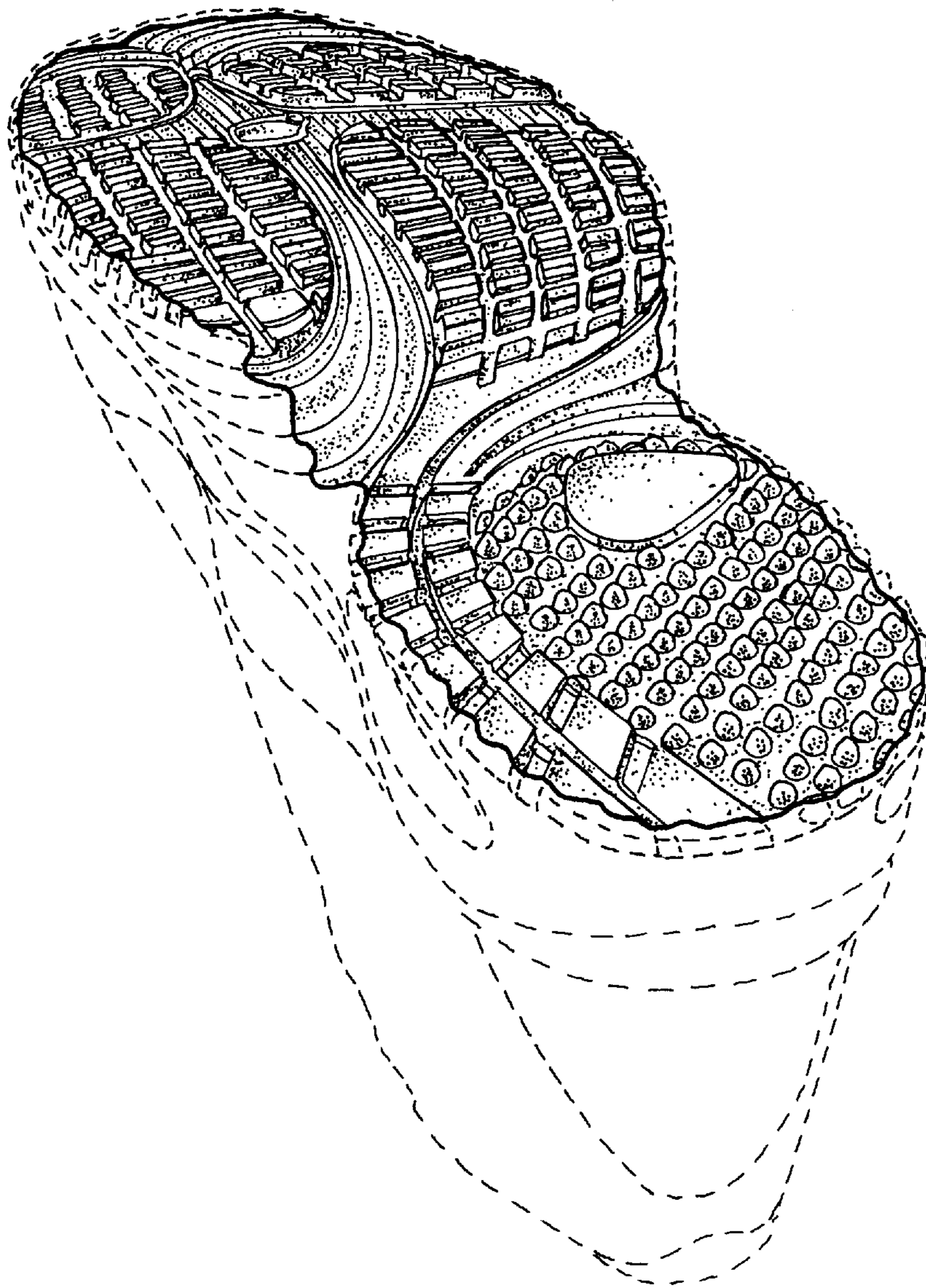
