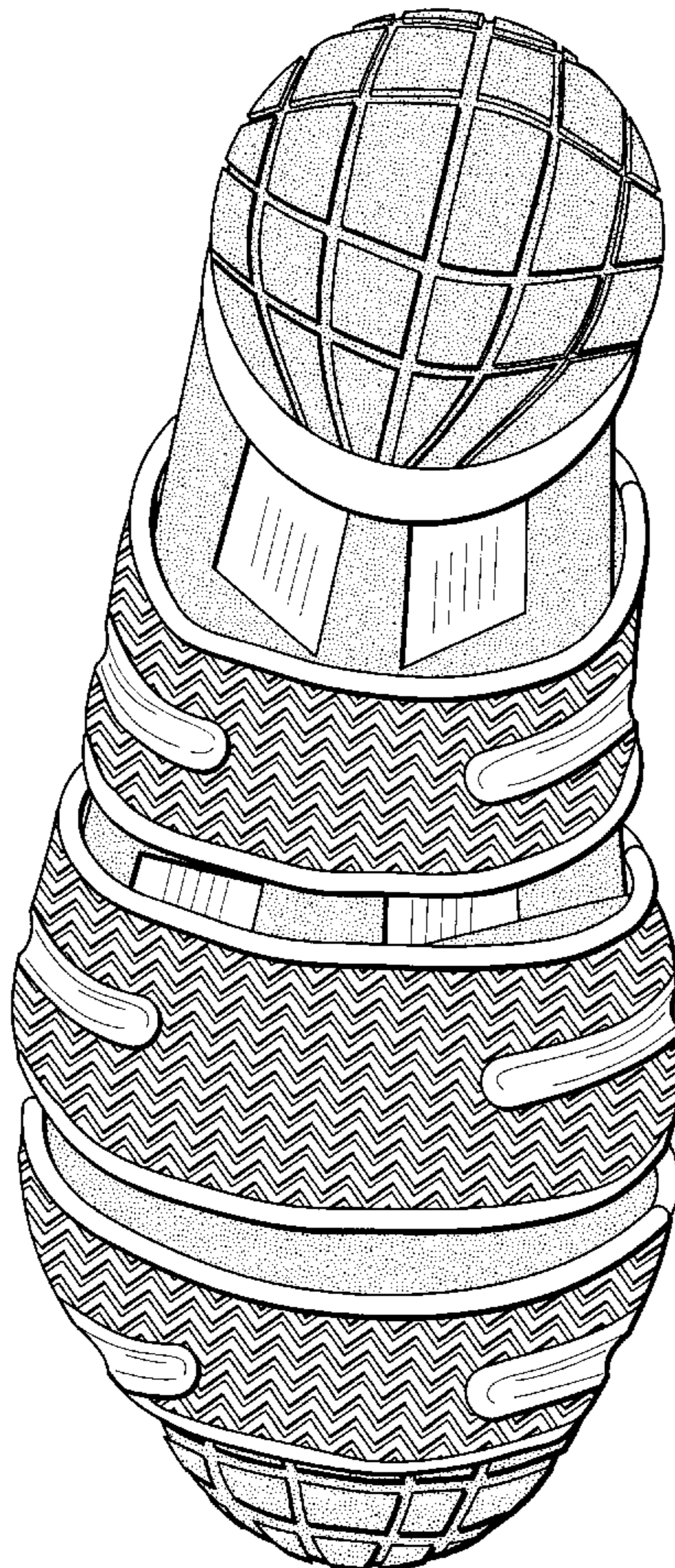
[57] **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a shoe outsole, showing my new design;
FIG. 2 is a front and left side perspective view thereof;
FIG. 3 is a front and right side perspective view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a right side elevational view thereof; and,
FIG. 7 is a left side elevational view thereof.
The broken line showing of a shoe upper in FIGS. 2-7 is for illustrative purposes only and forms no part of claimed design;

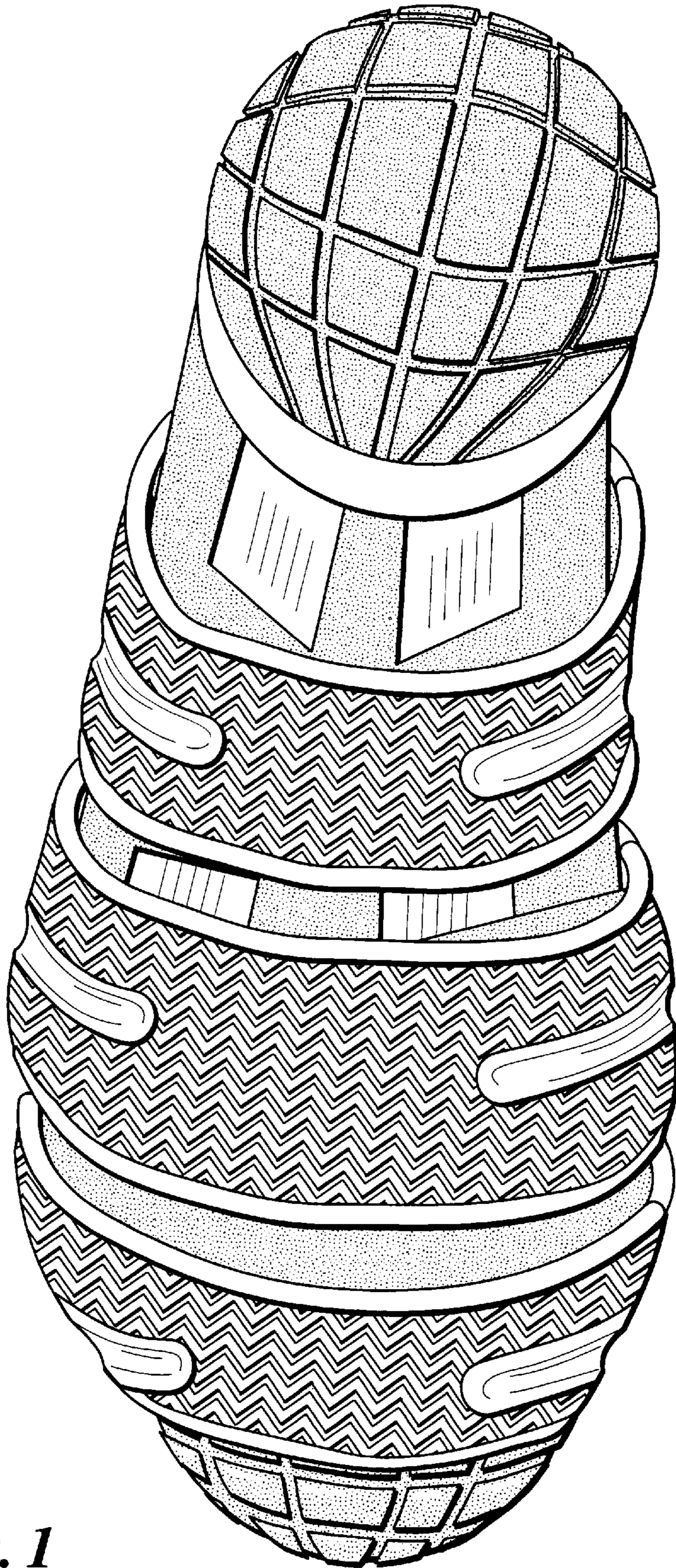
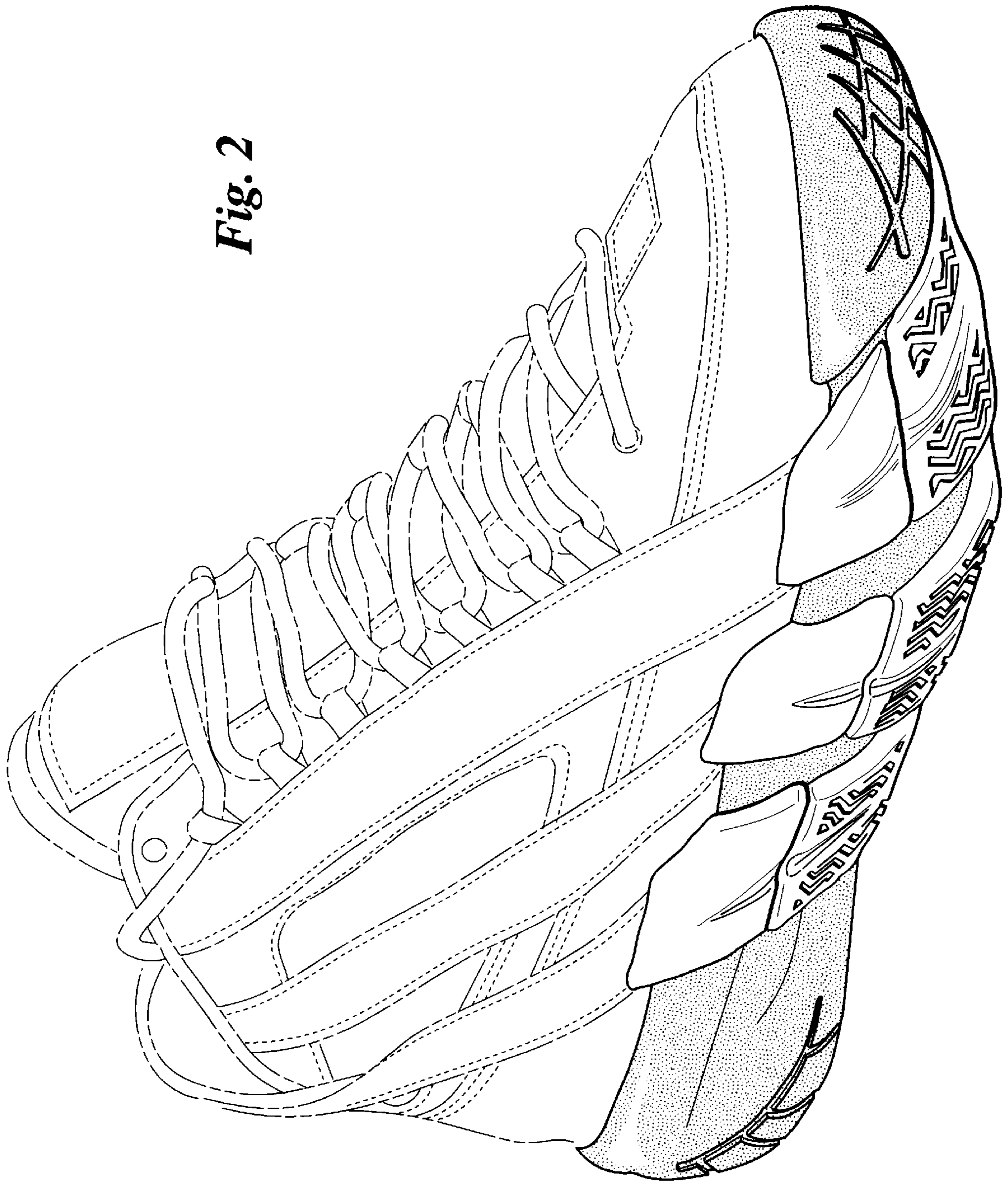

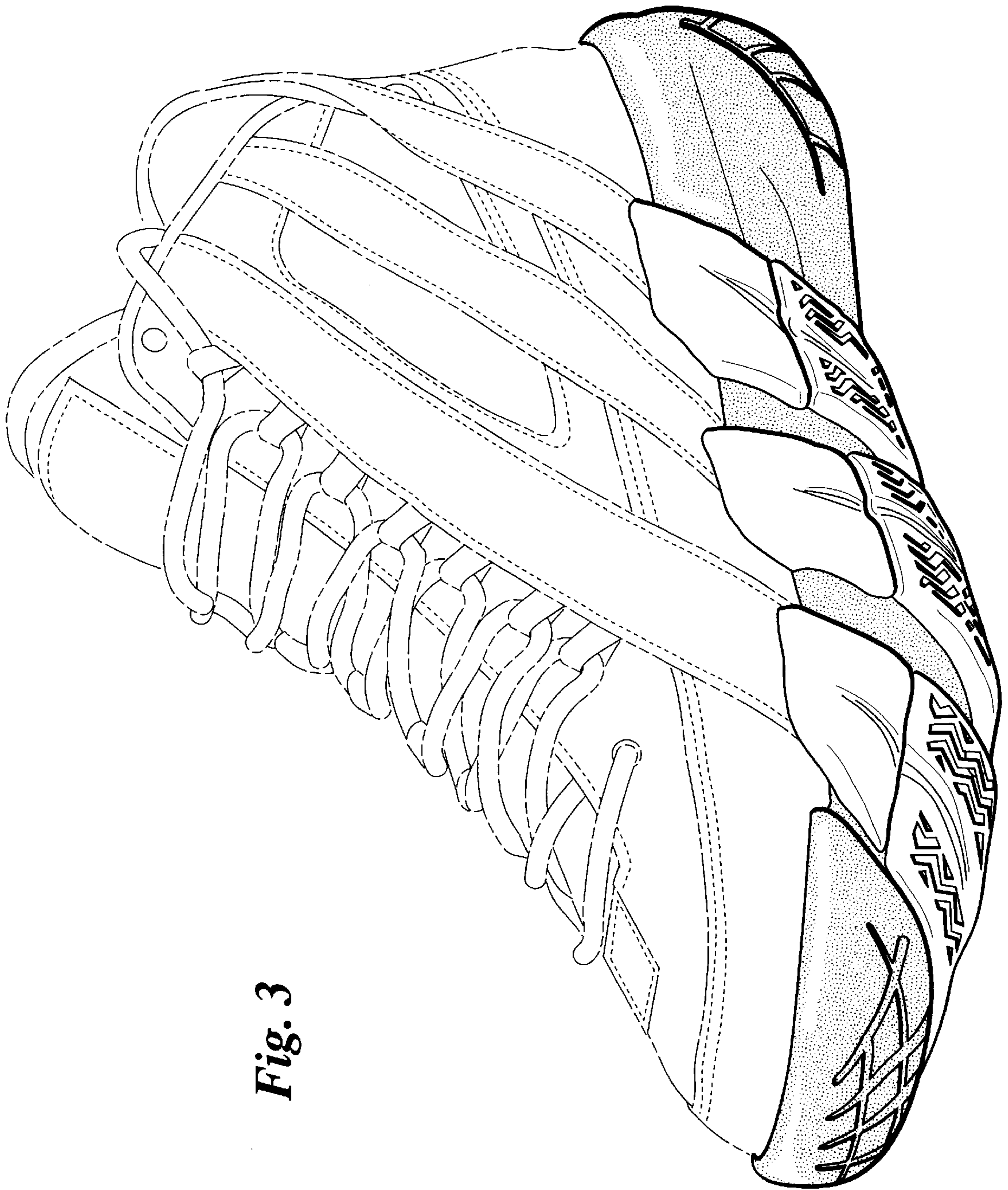

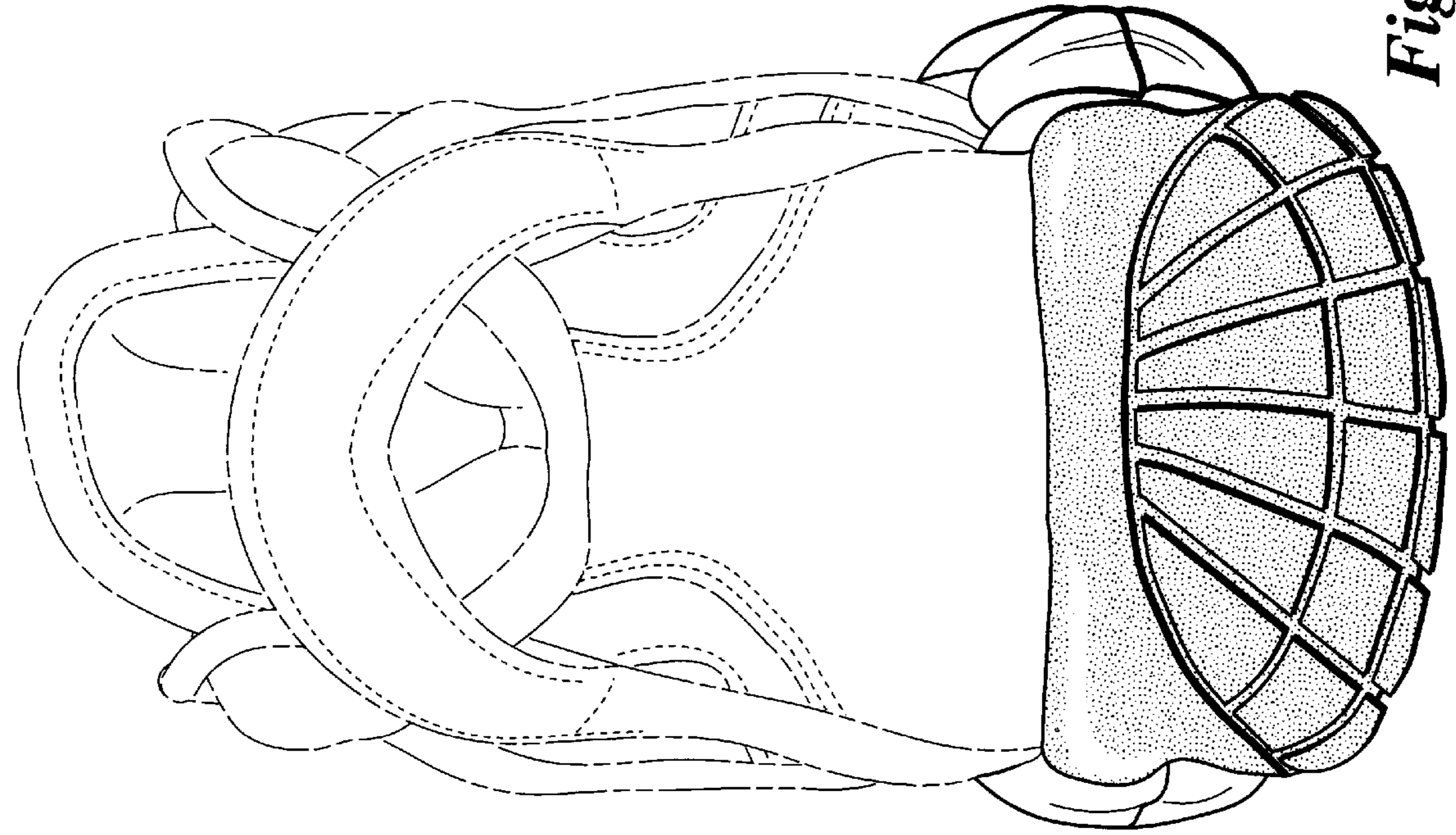

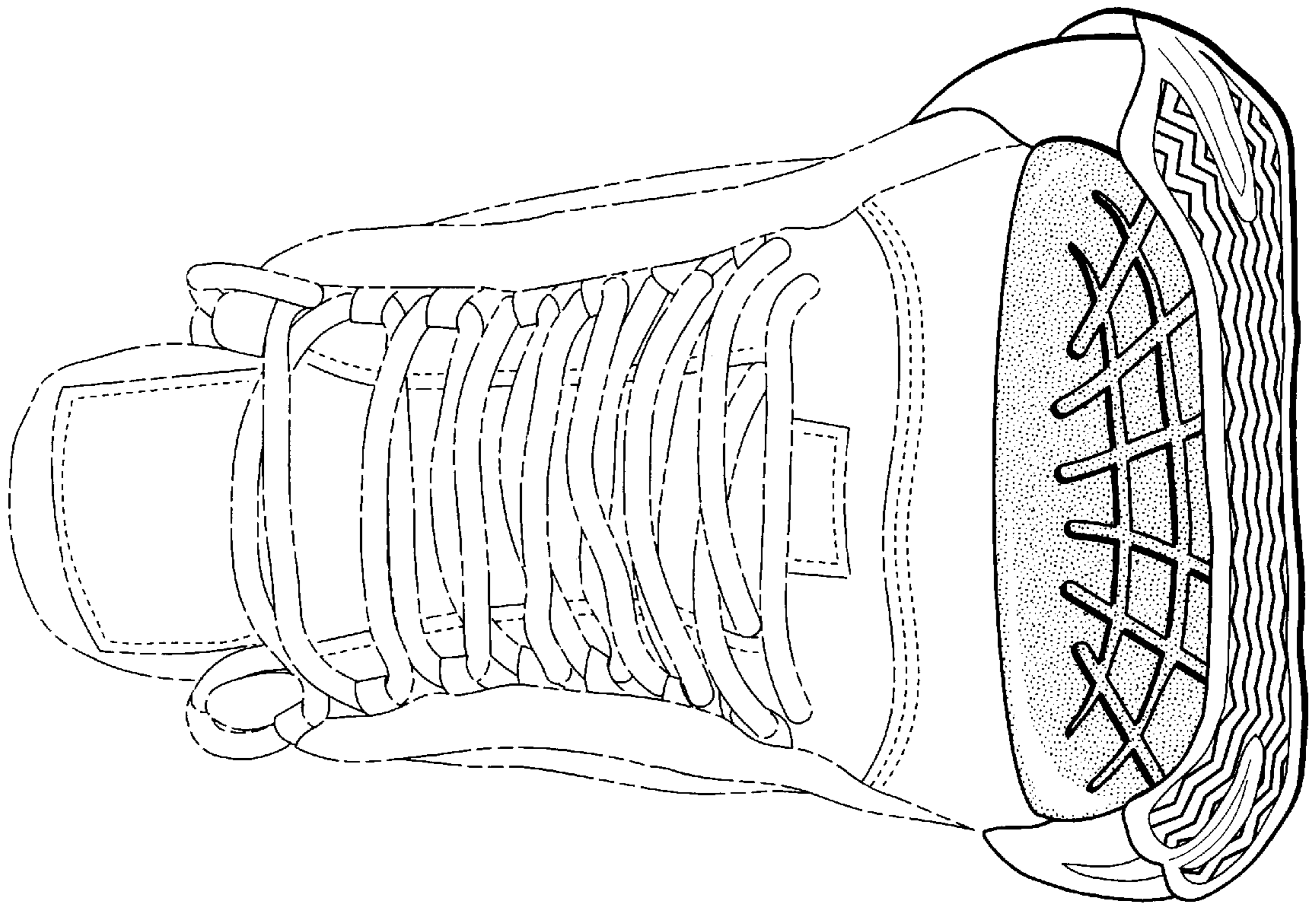

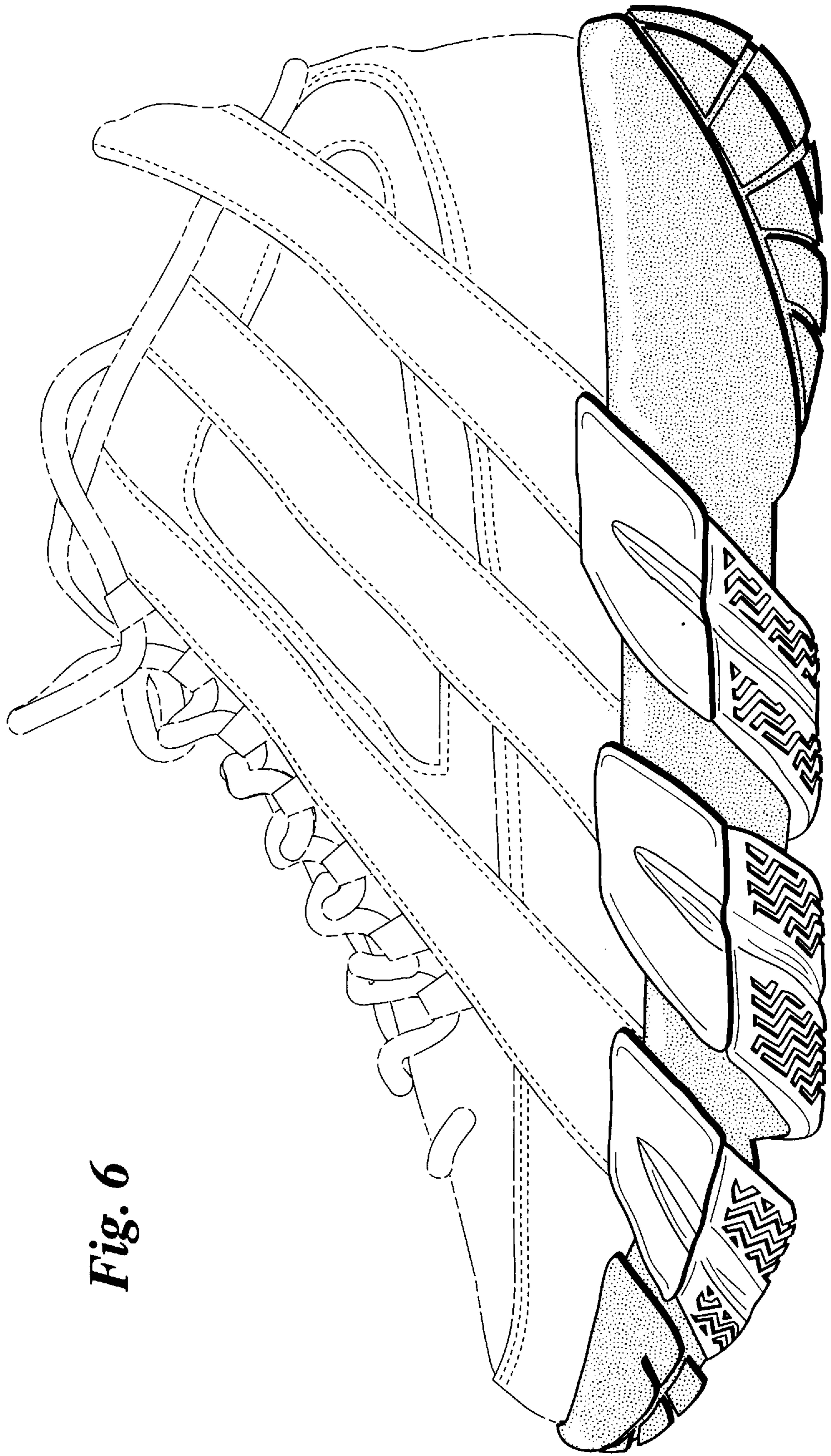
