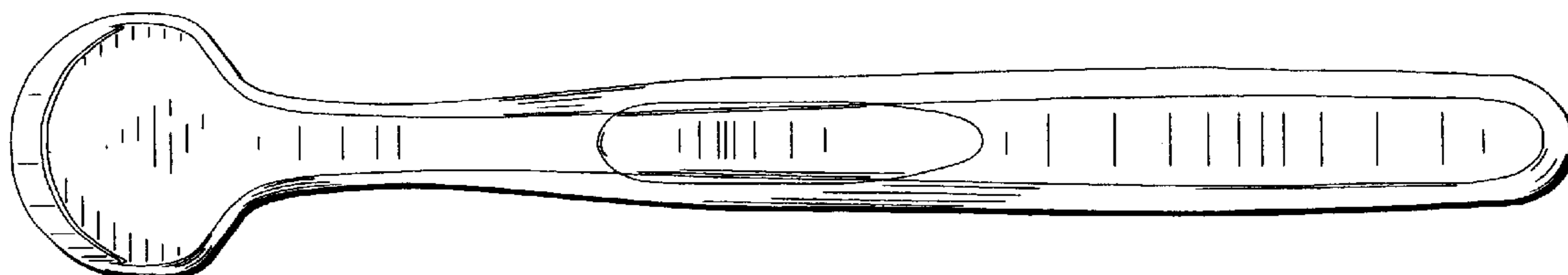
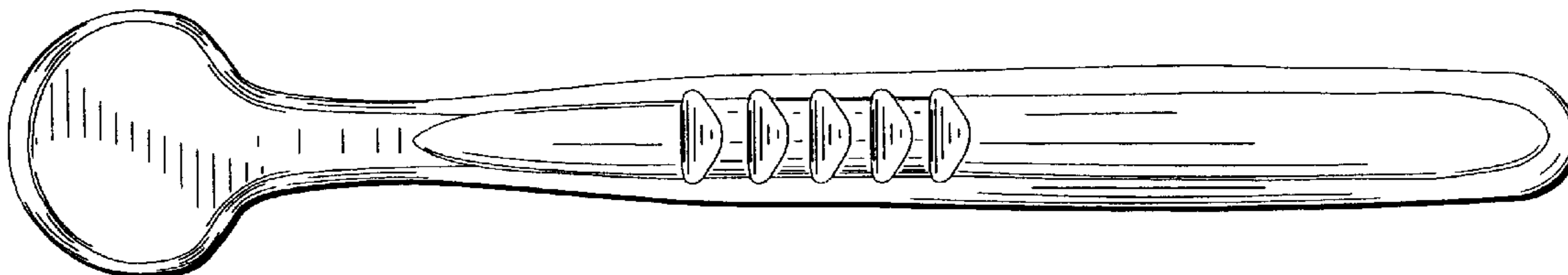
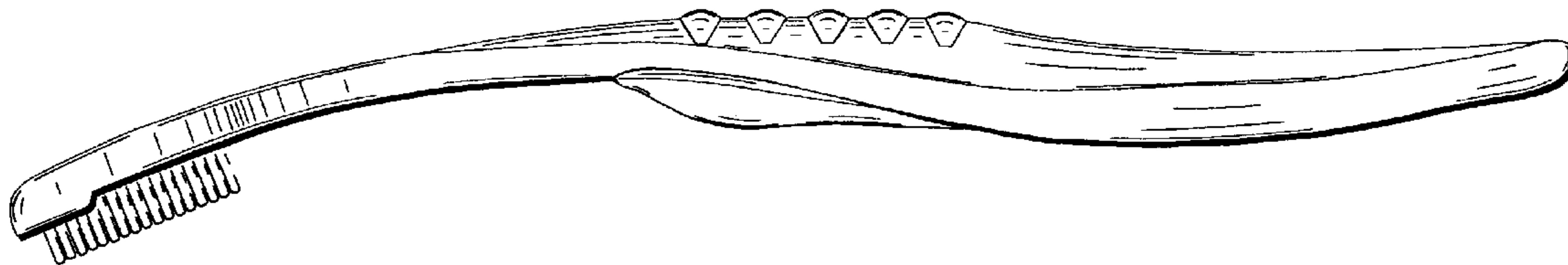
[57] **CLAIM**

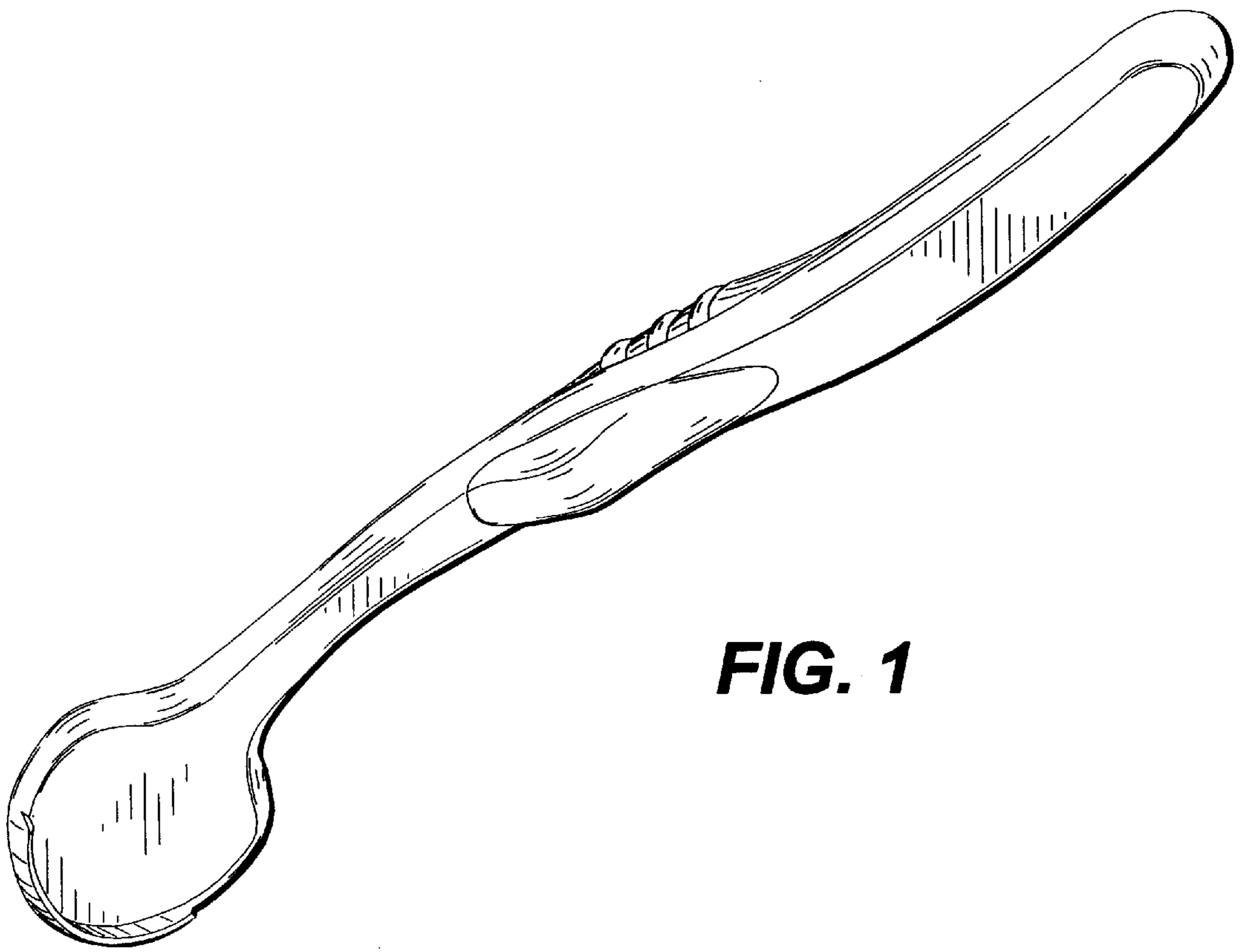
The ornamental design for a tongue brush head and handle unit, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tongue brush head and handle unit showing my new design;  
FIG. 2 is a right side elevational view thereof, the left side being a mirror image;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a bottom plan view thereof; and,

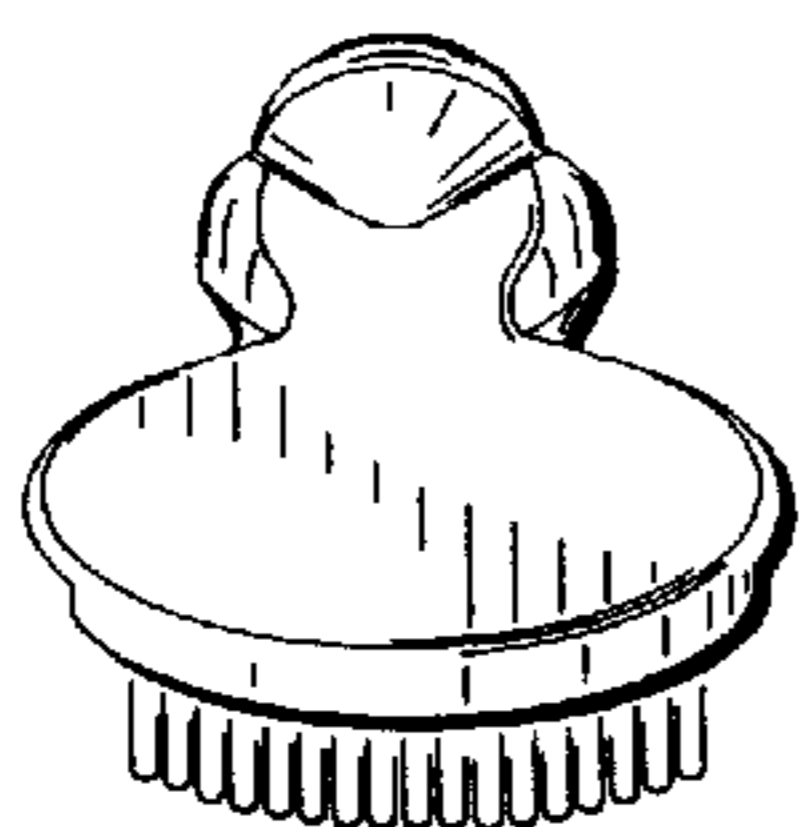




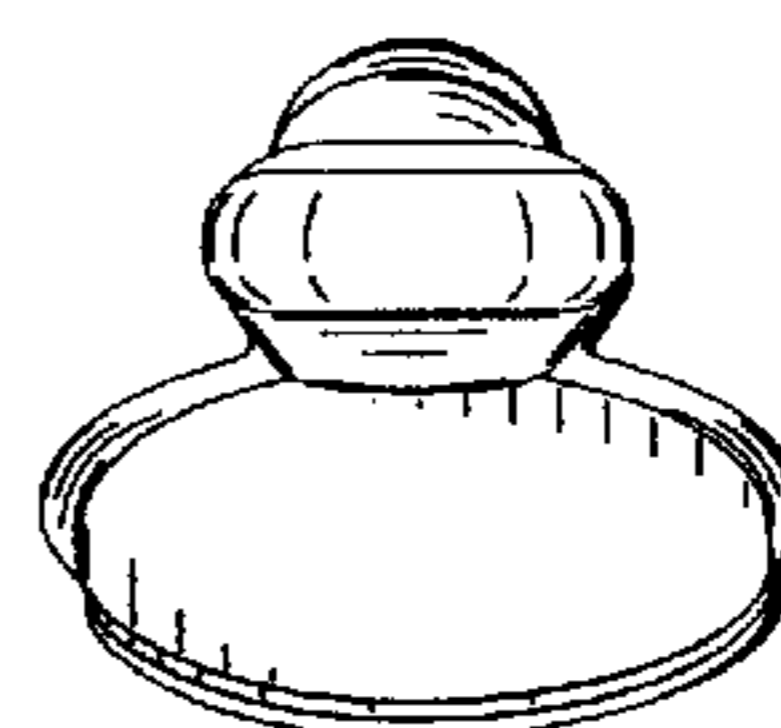

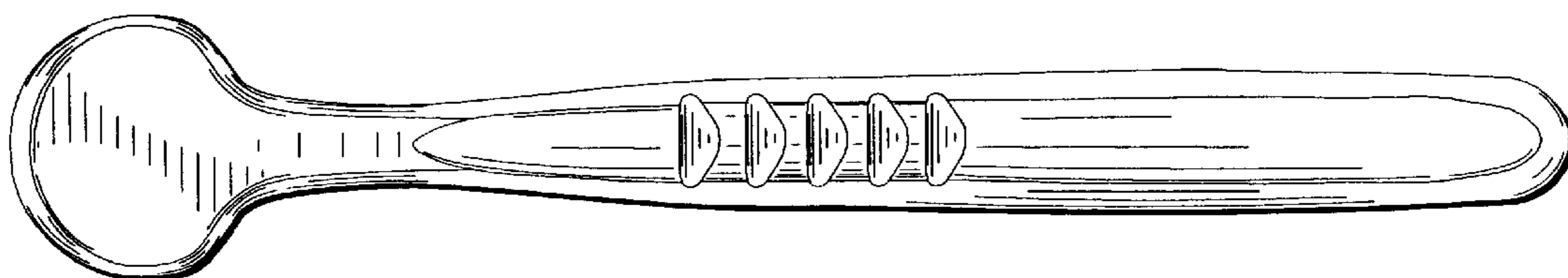

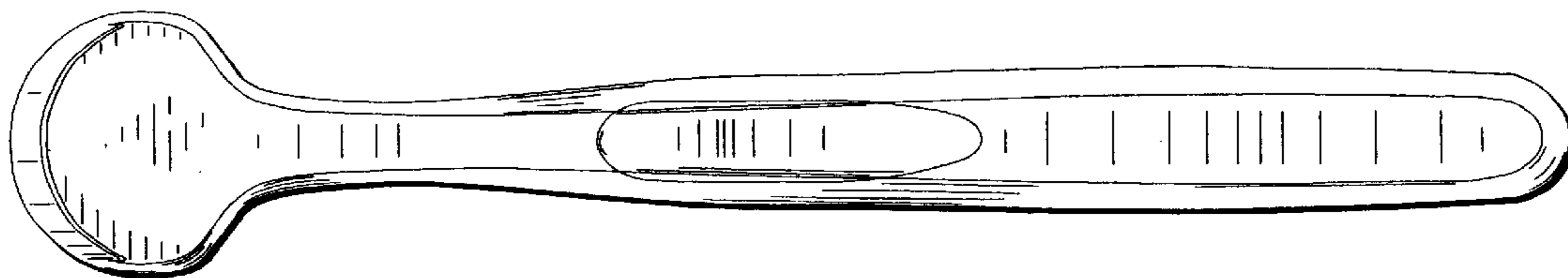
