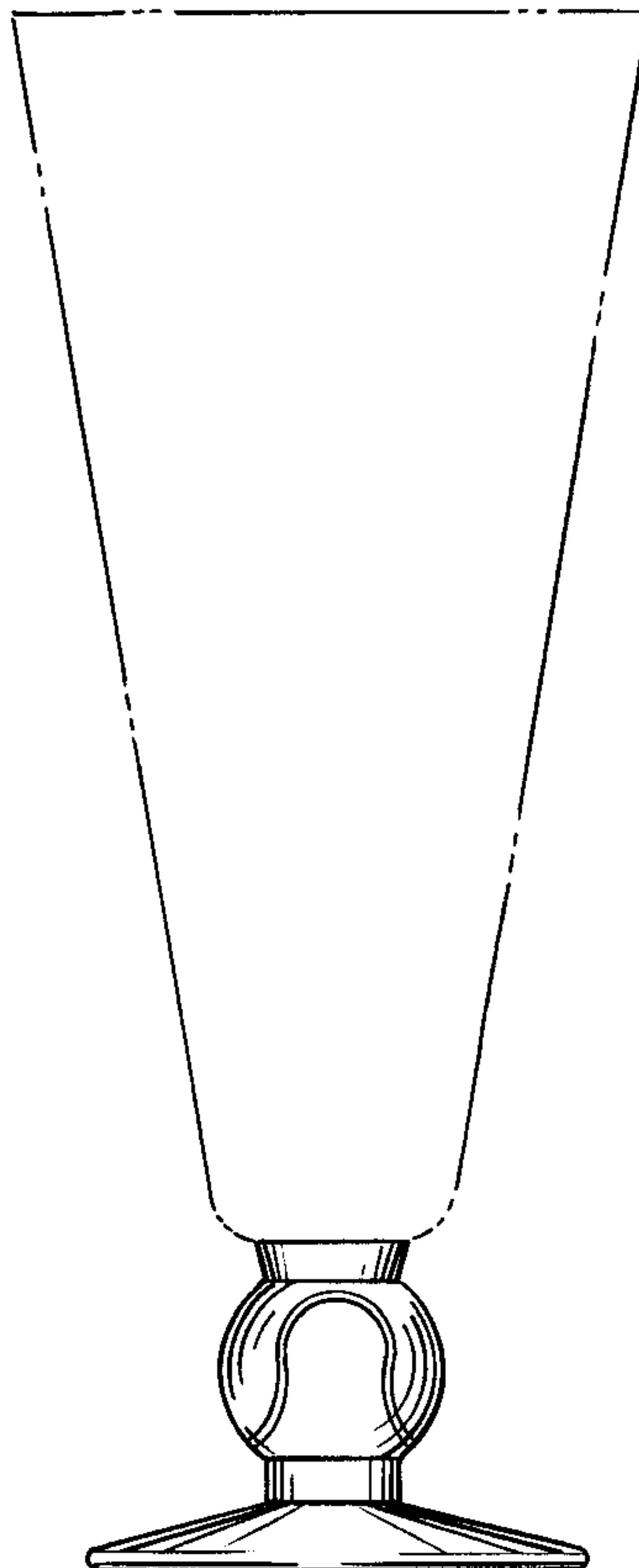
The ornamental design for a stem for an article of glassware, as shown and described.

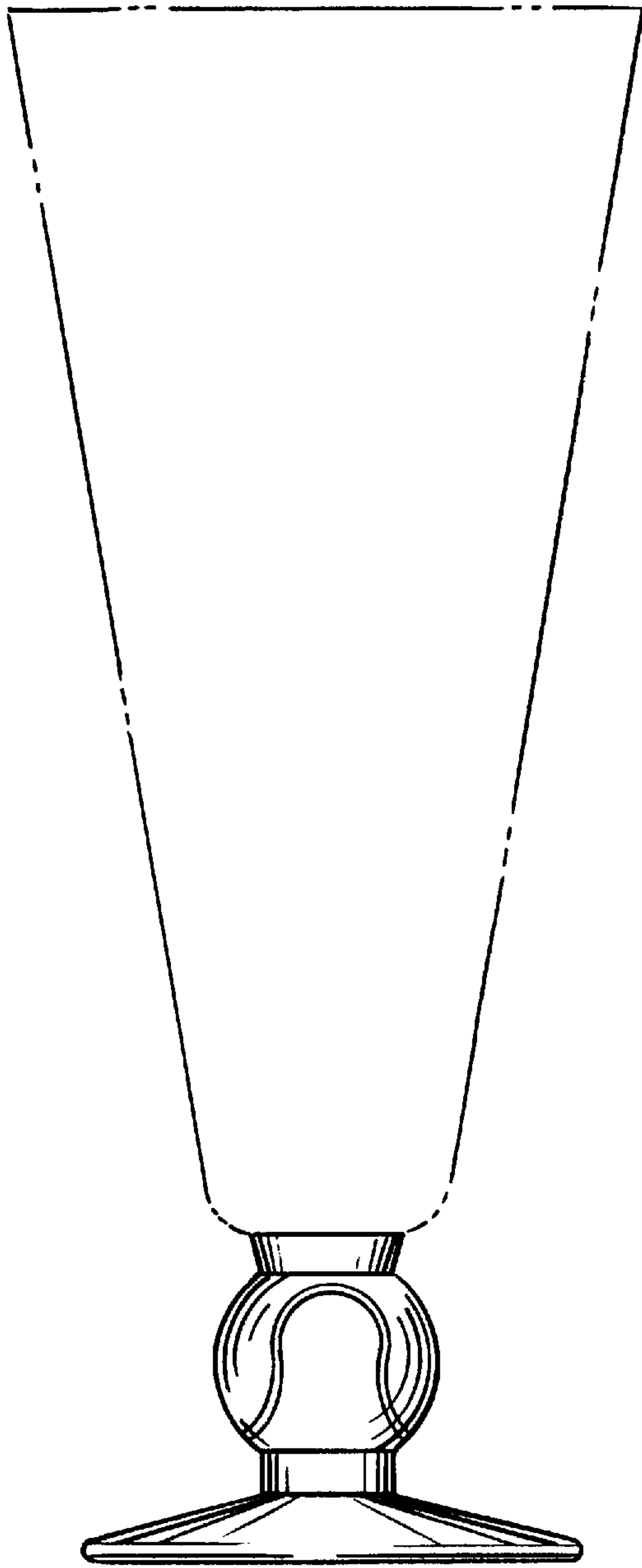
DESCRIPTION

FIG. 1 is a front elevational view of the present design; the rear elevational view being a mirror image thereof; FIG. 2 is a side elevational view thereof; the opposite side elevational view being a mirror image thereof; FIG. 3 is a top view thereof; and, FIG. 4 is a bottom view thereof.

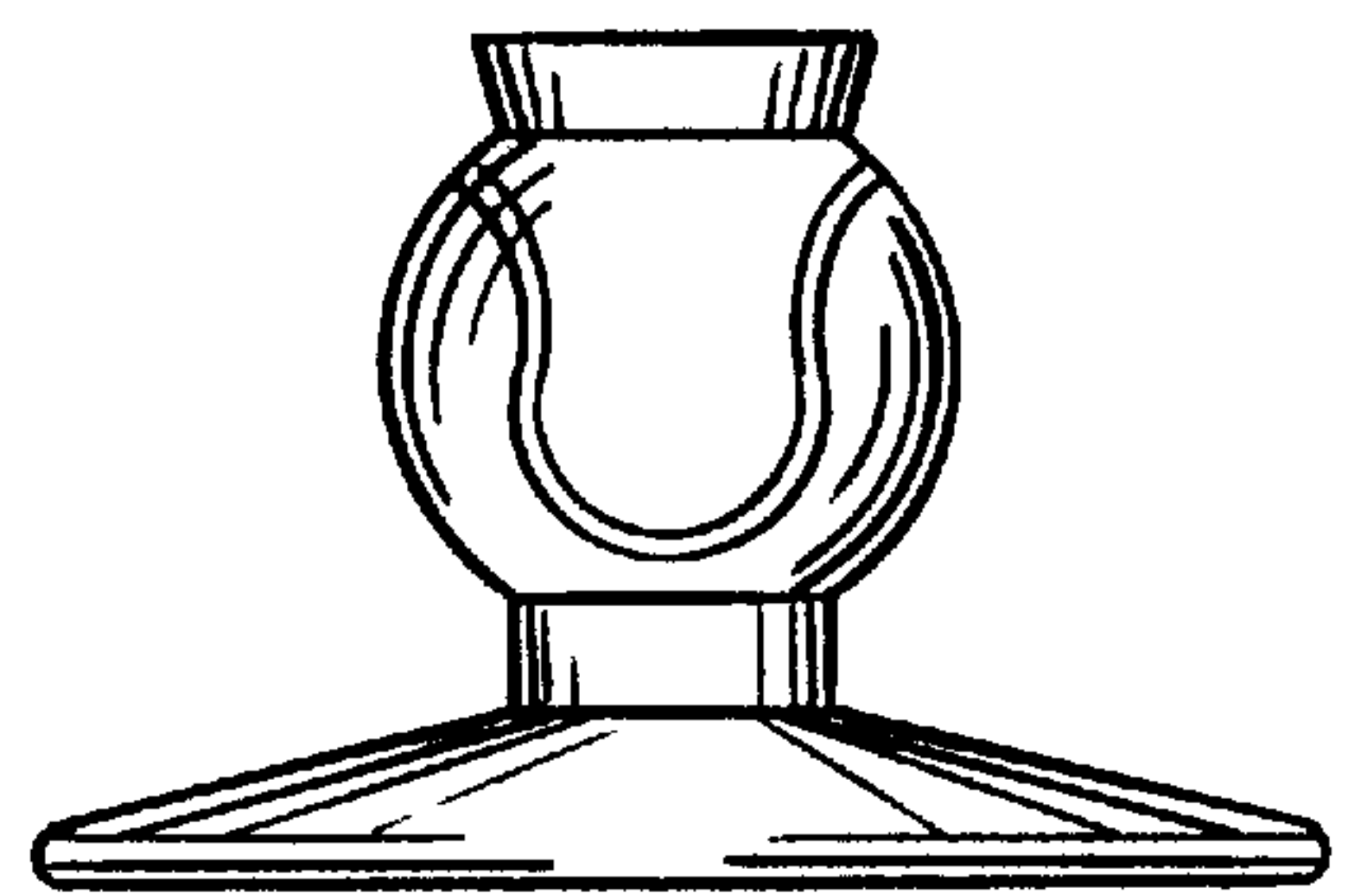
The broken line showing the bowl in FIG. 1 is illustrative of environmental structure only and forms no part of the claimed design.

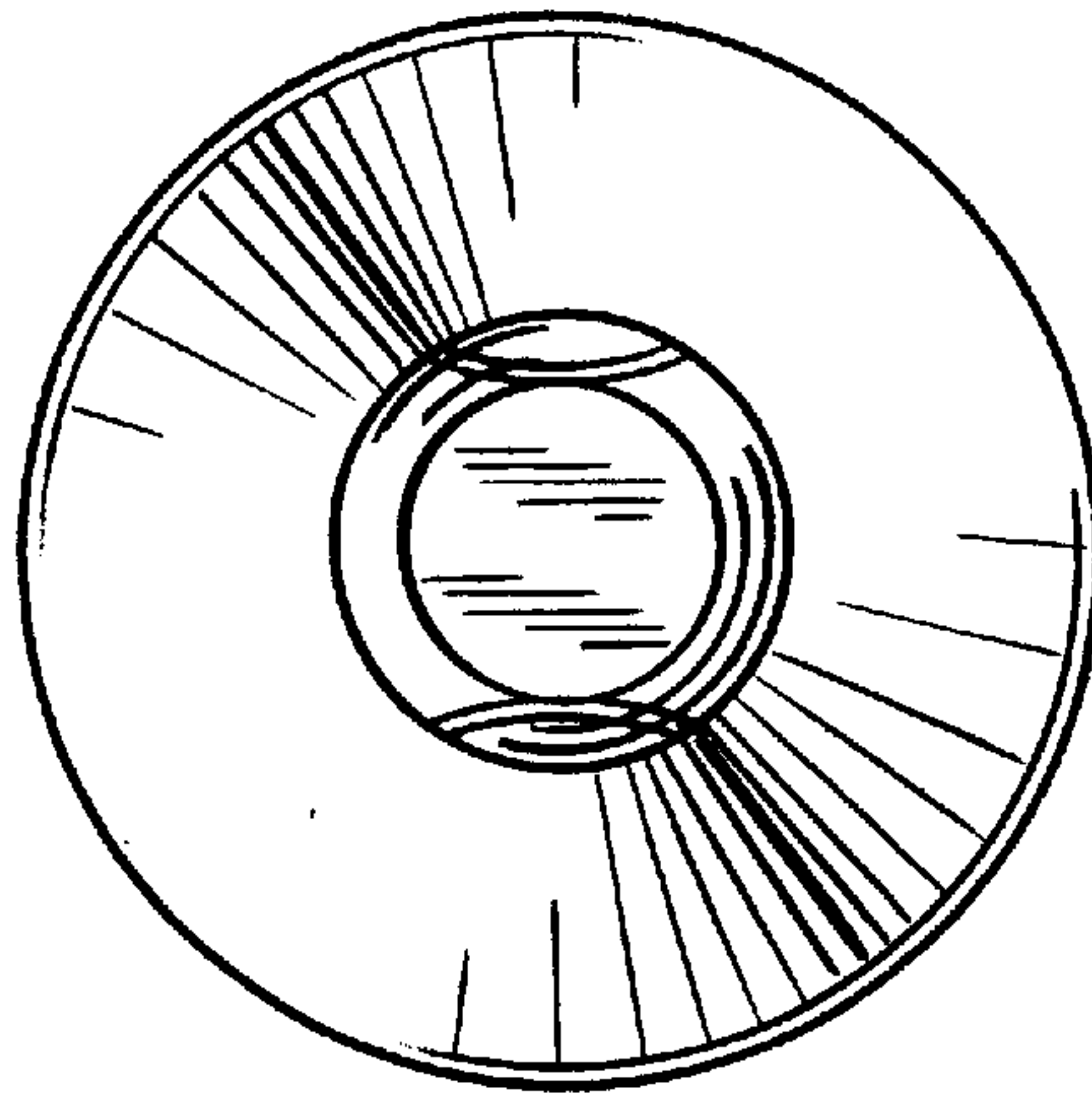




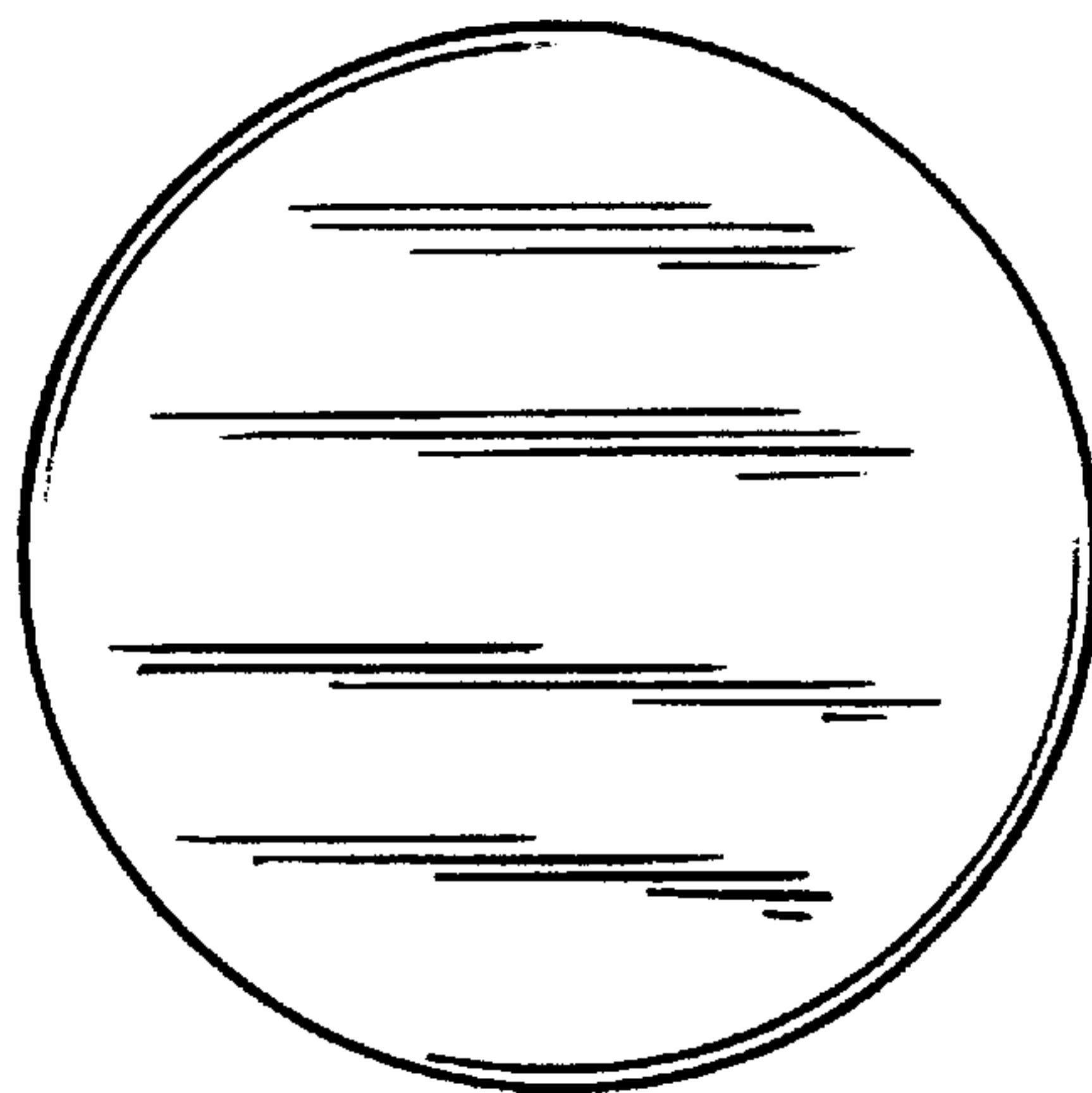
