The ornamental design for a fob, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of one preferred embodiment of the fob of my invention;

FIG. 2 is a front elevation of the fob shown in FIG. 1;

FIG. 3 is a rear elevation of the fob shown in FIG. 1;

FIG. 4 is a left side elevation of the fob shown in FIG. 1;

FIG. 5 is a bottom plan view of the fob shown in FIG. 1;

FIG. 6 is a right side elevation of the fob shown in FIG. 1;

FIG. 7 is a top plan view of the fob shown in FIG. 1;

FIG. 8 is a front elevation of a first alternate embodiment of a fob in accordance with my invention;

FIG. 11 is a bottom plan view of the fob shown in FIG. 8;

FIG. 15 is a rear elevation of the fob shown in FIG. 14;

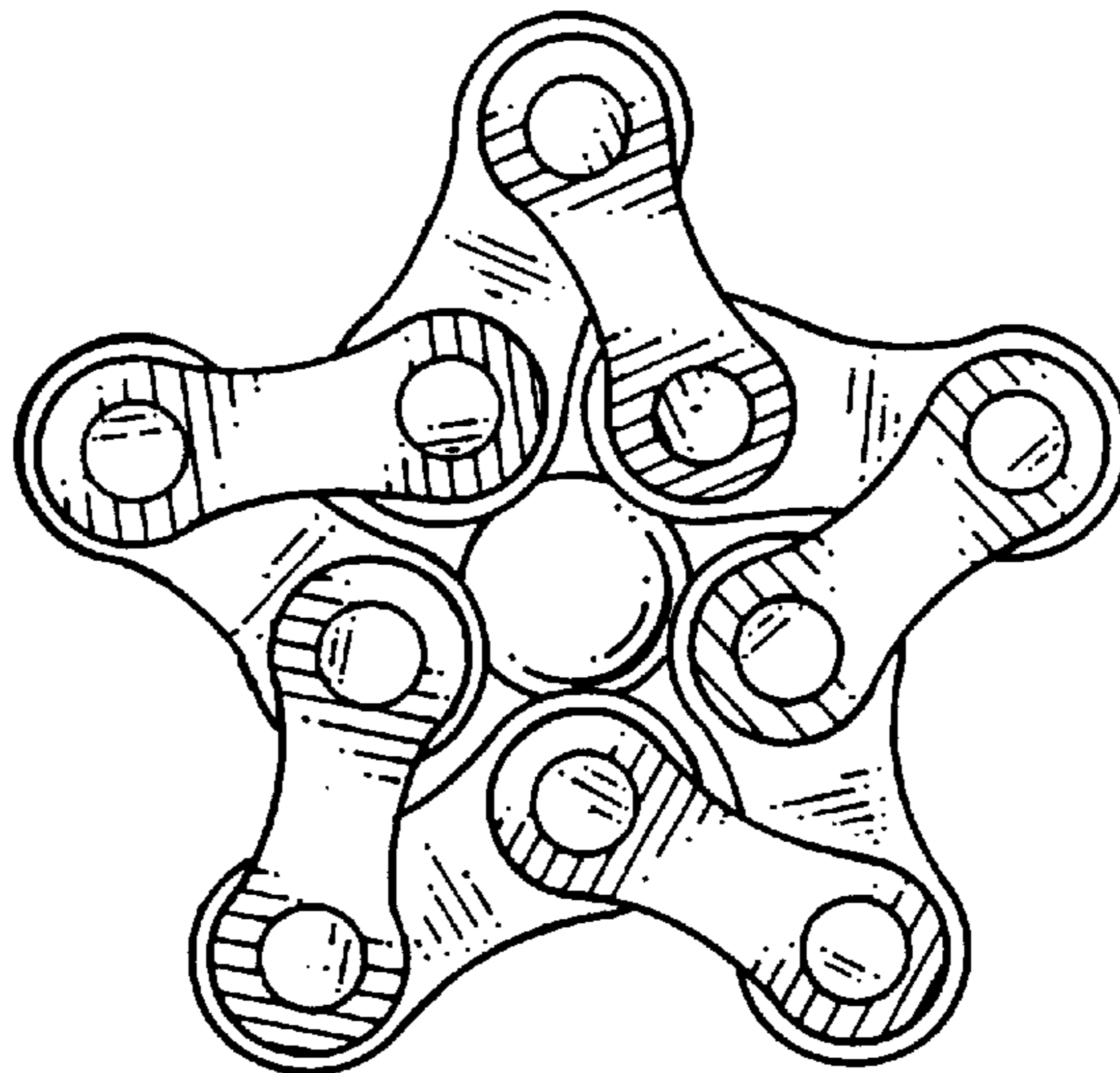
FIG. 16 is a left side elevation of the fob shown in FIG. 14;

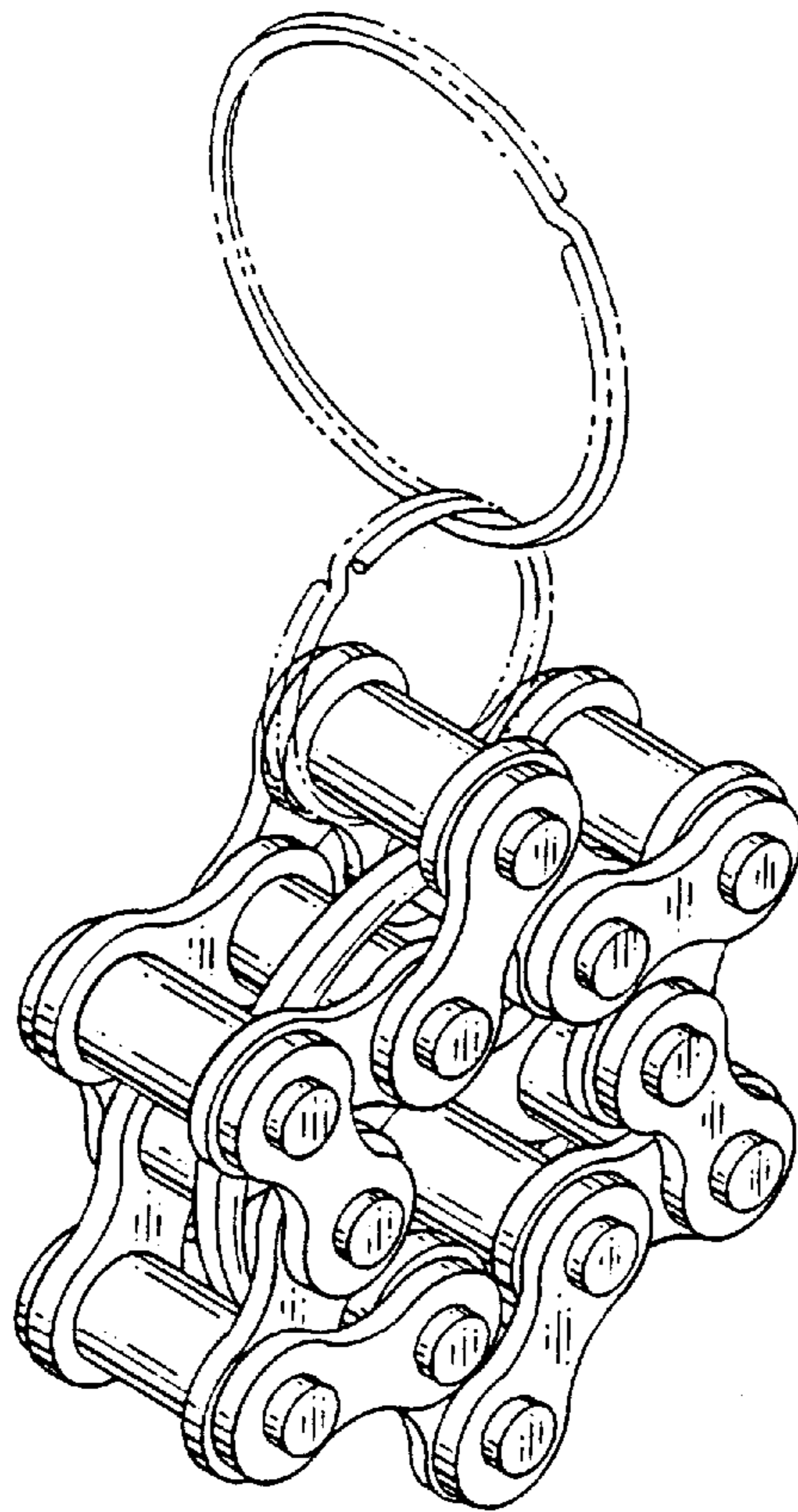

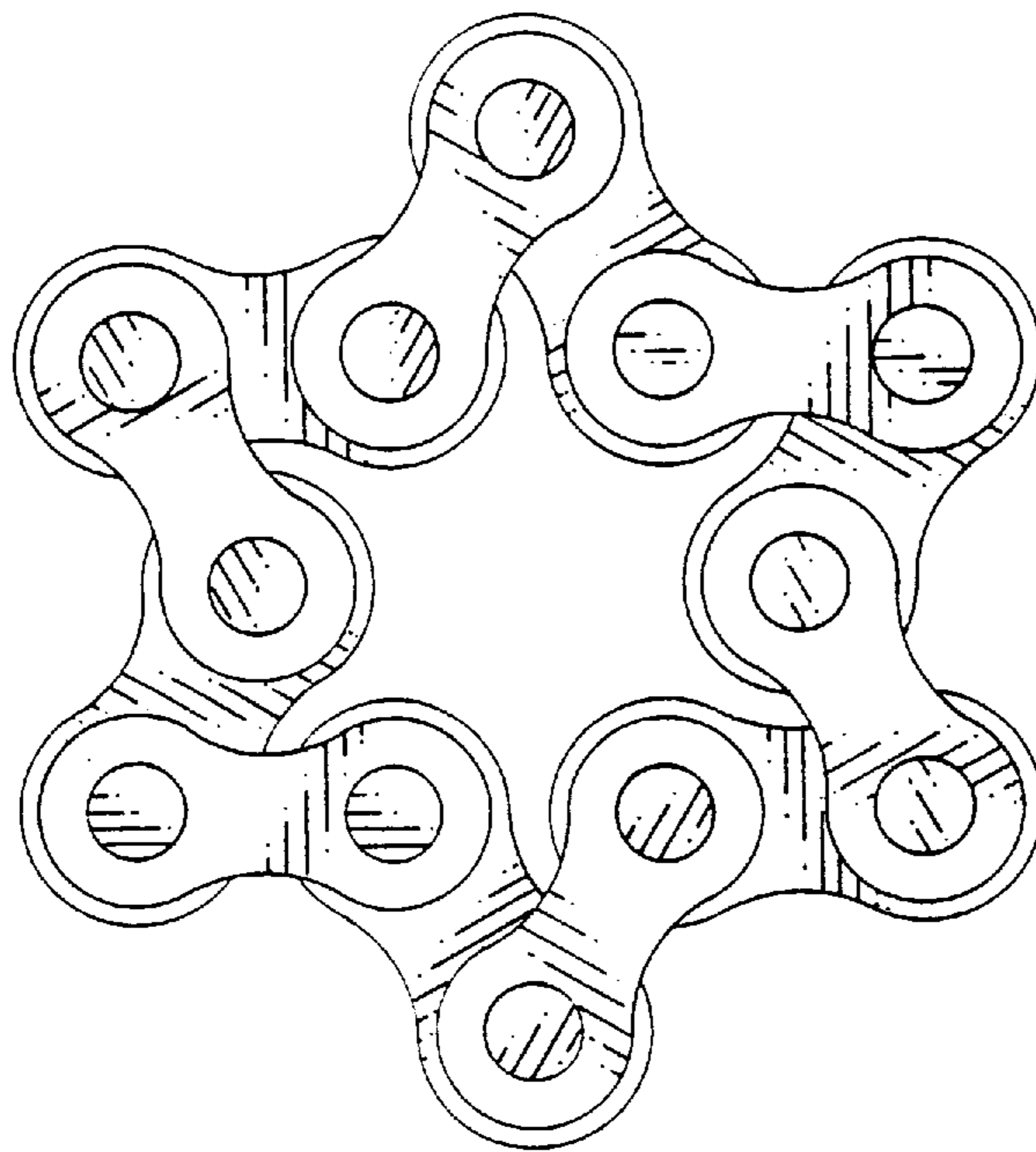

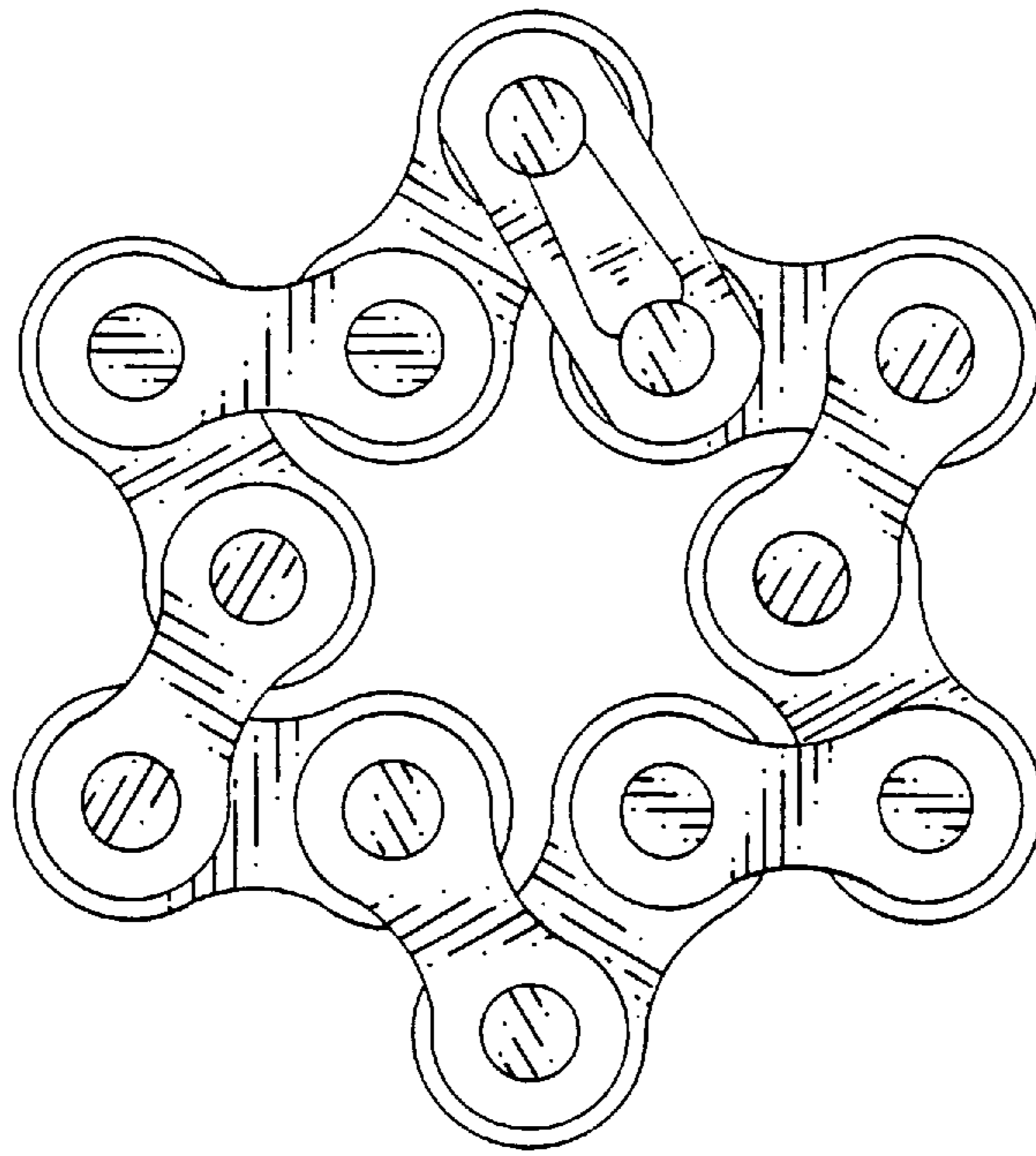

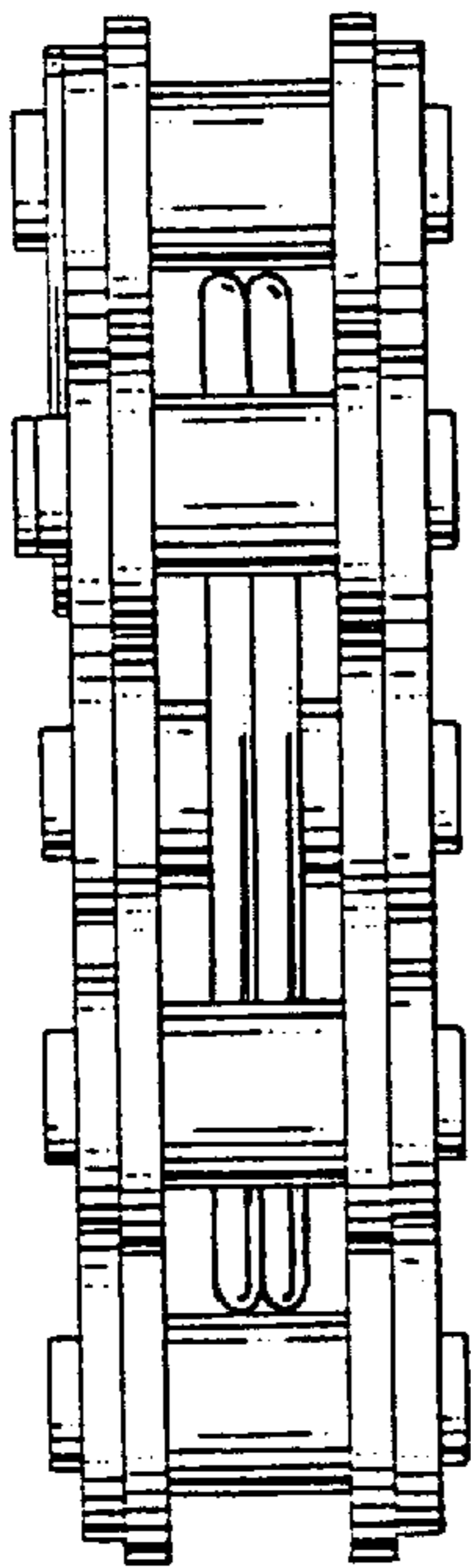

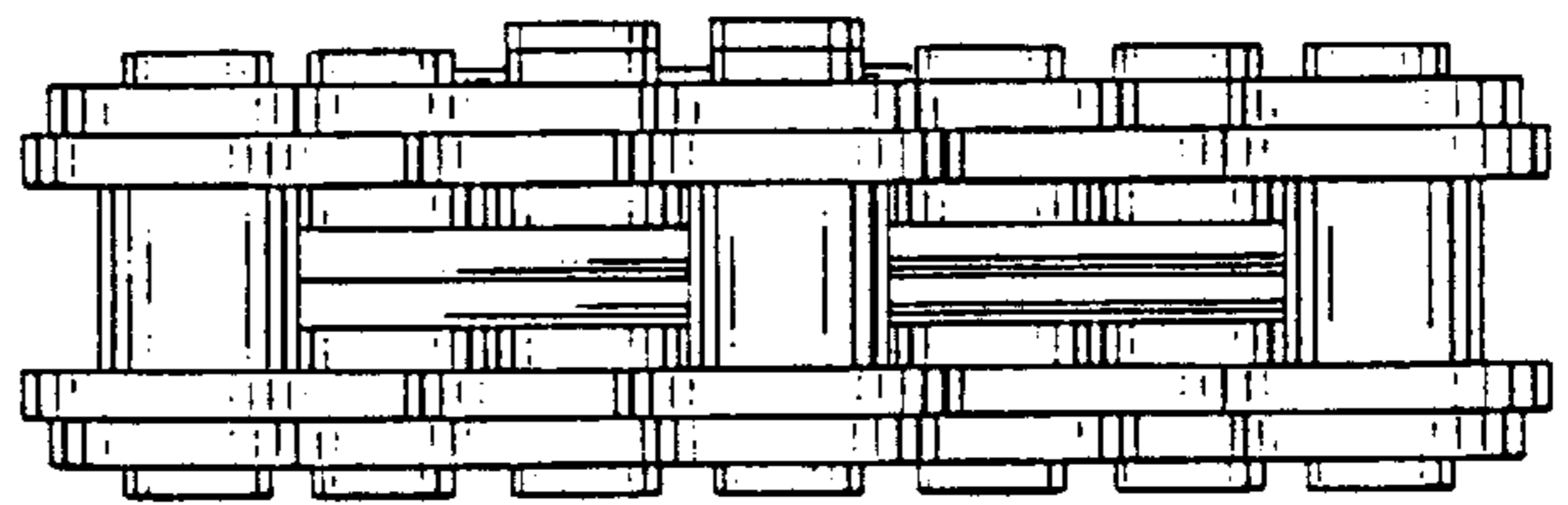

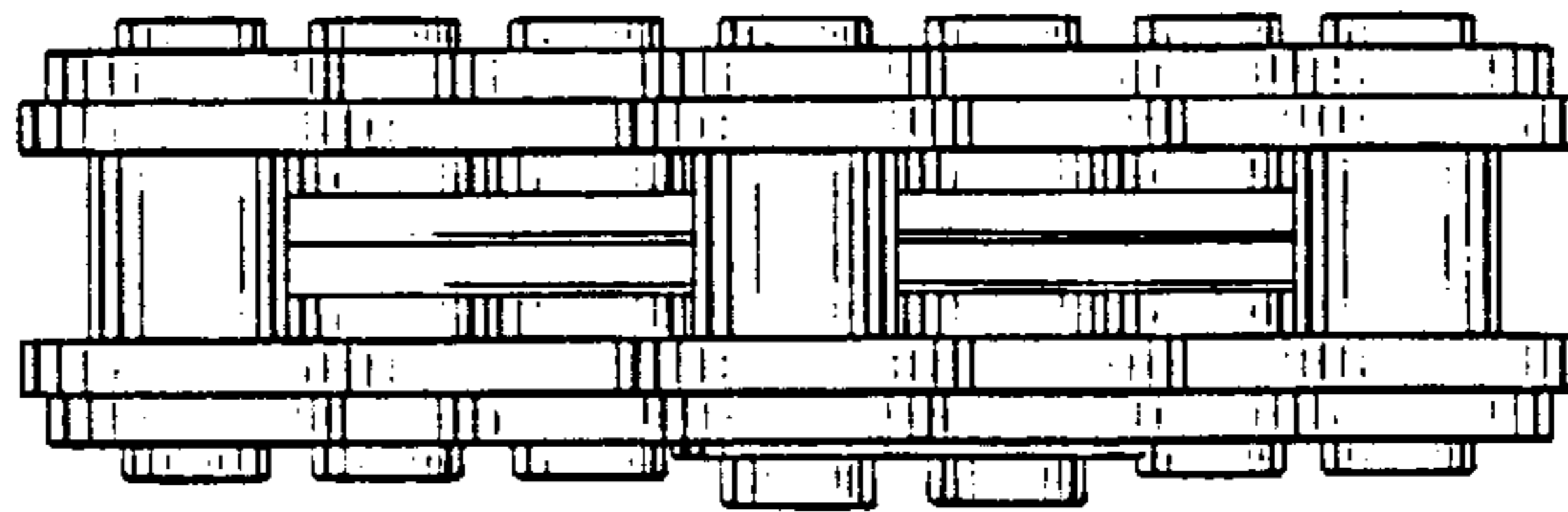
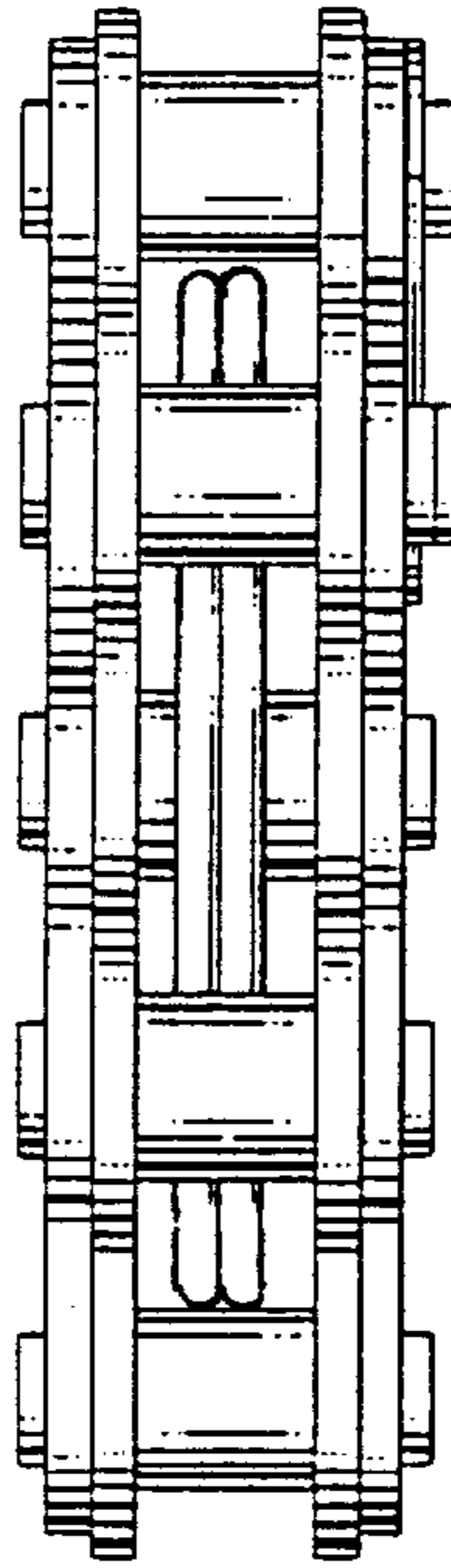

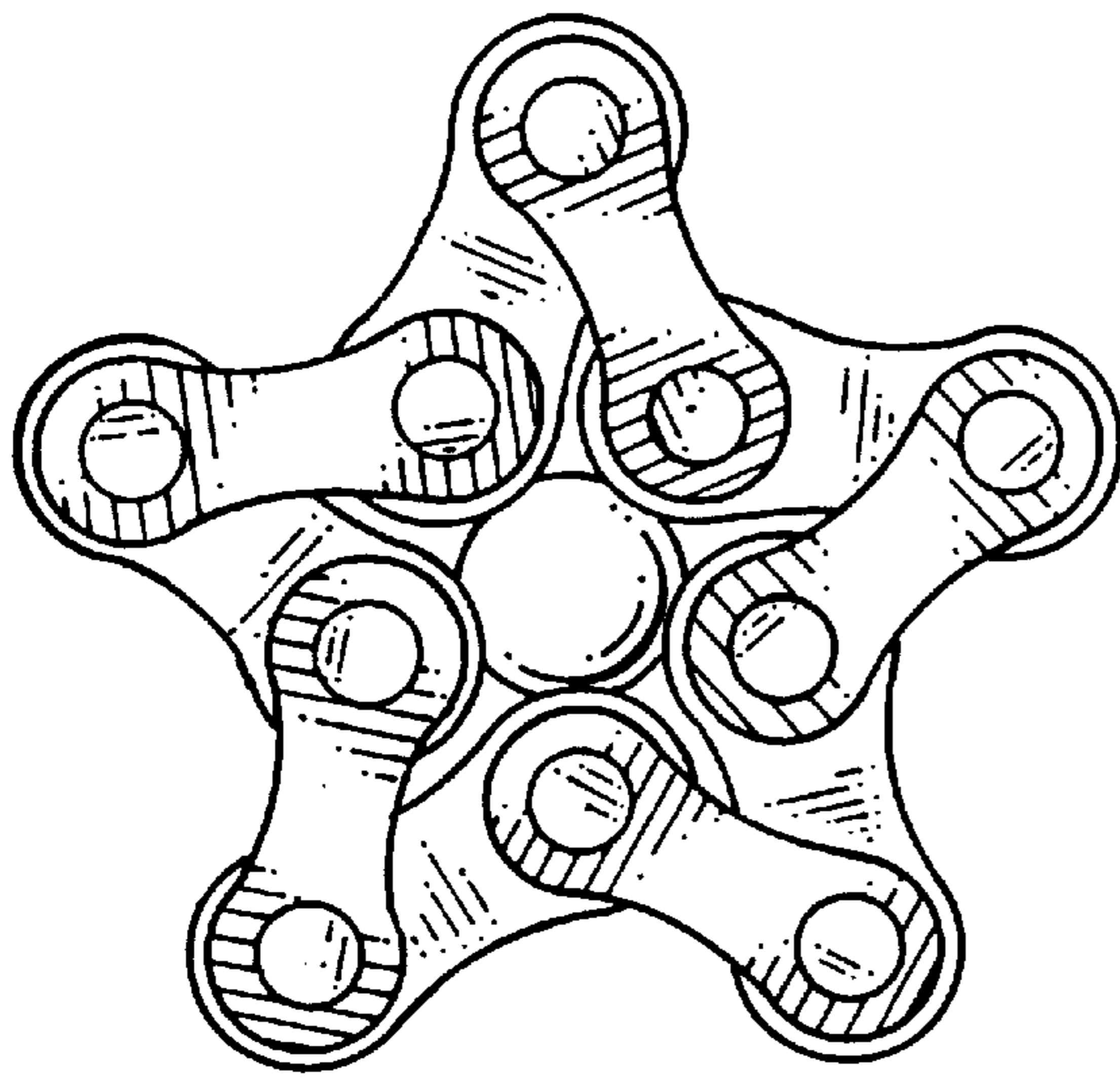

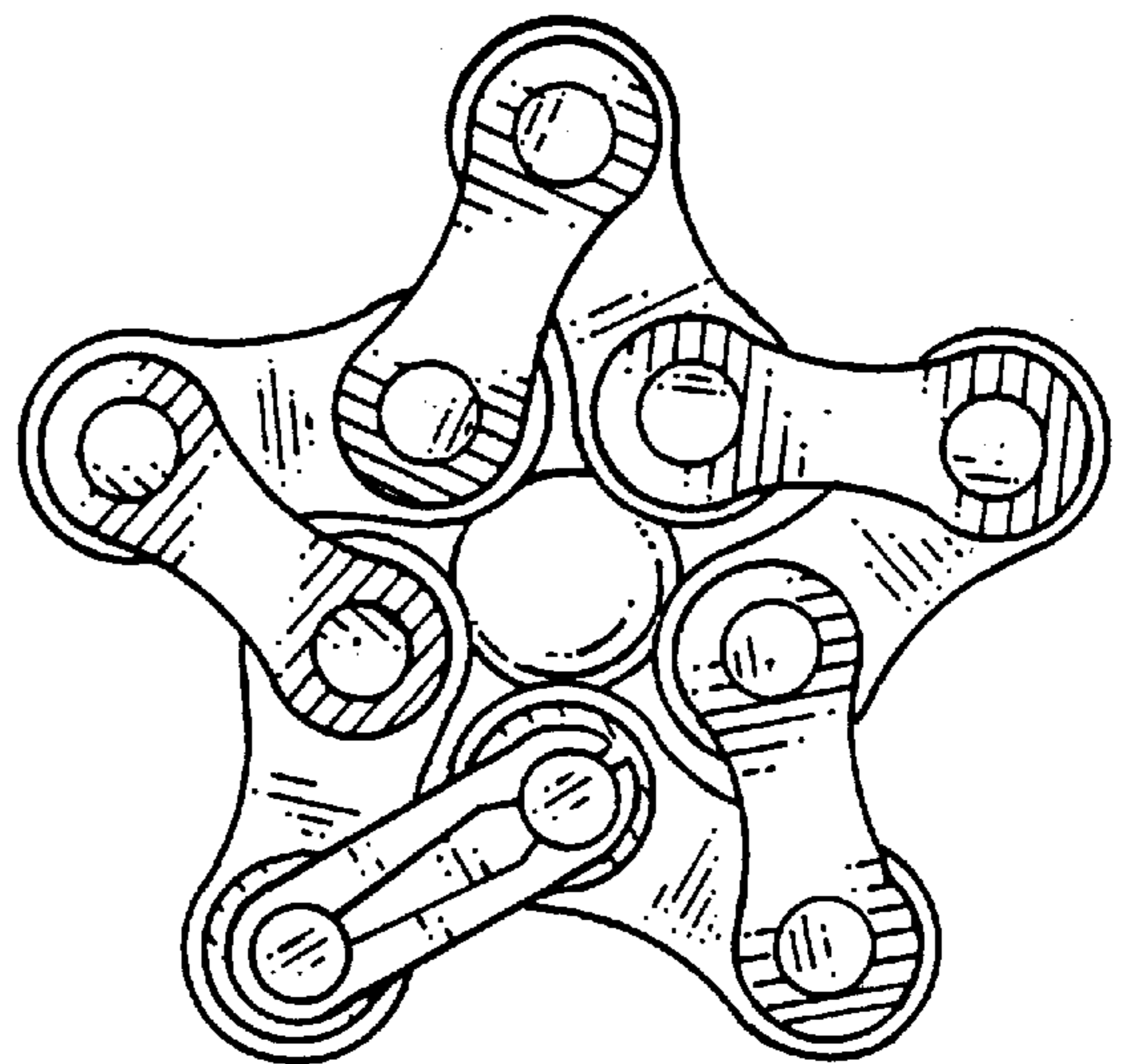

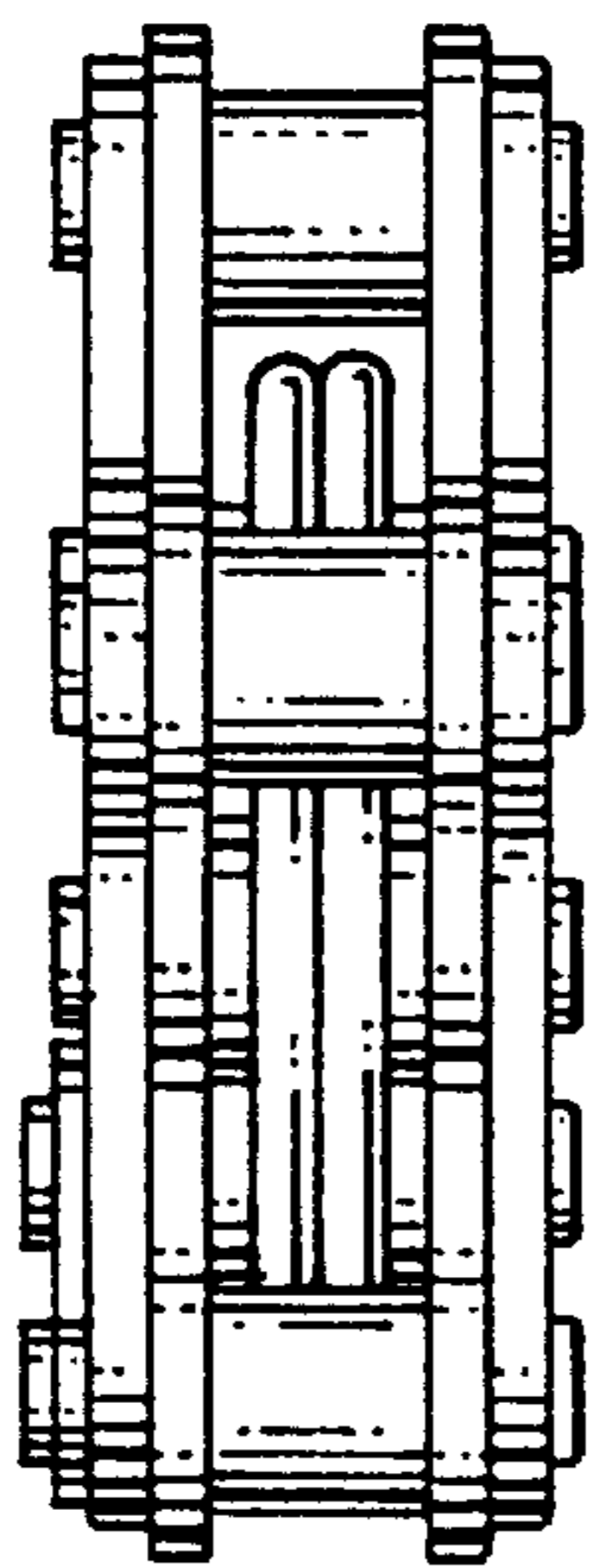

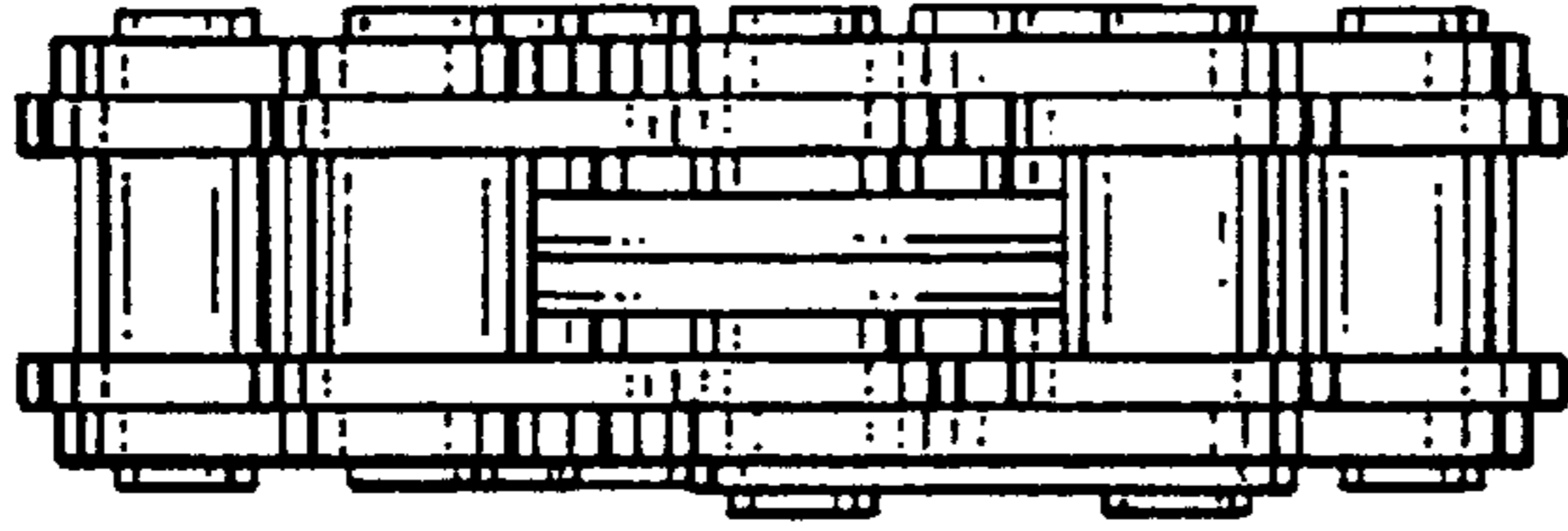

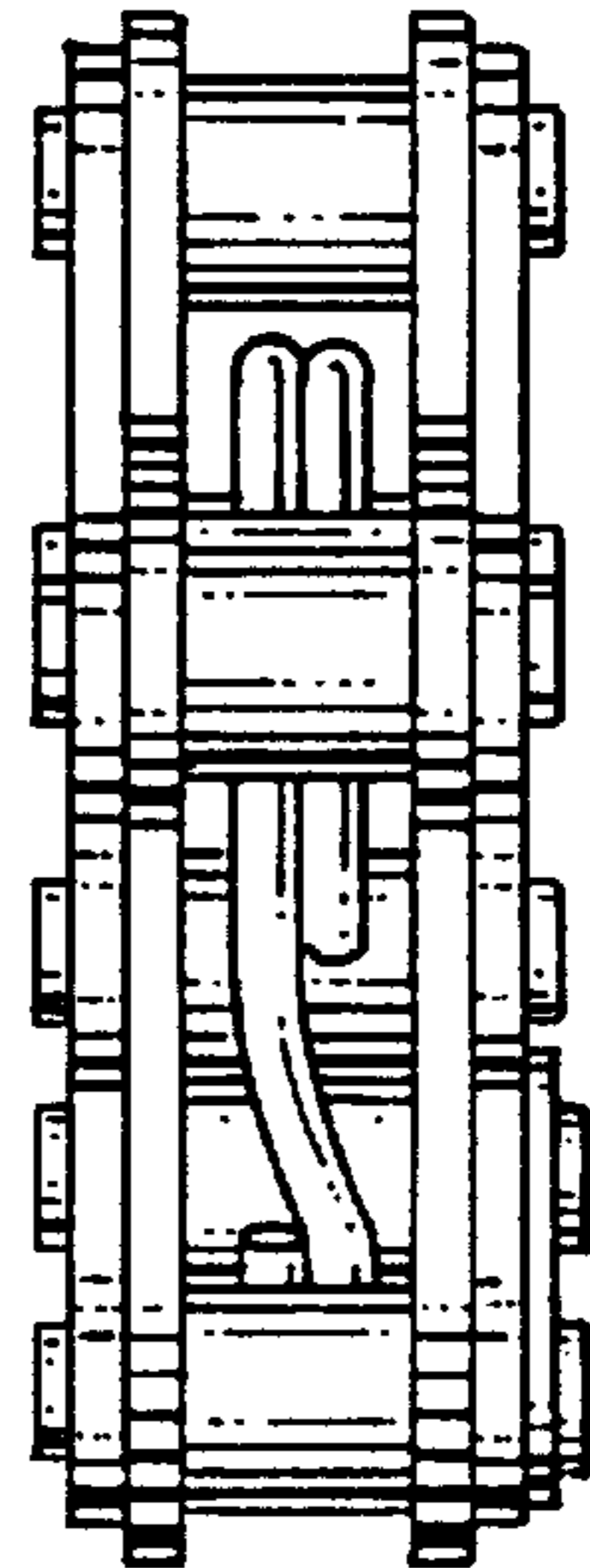

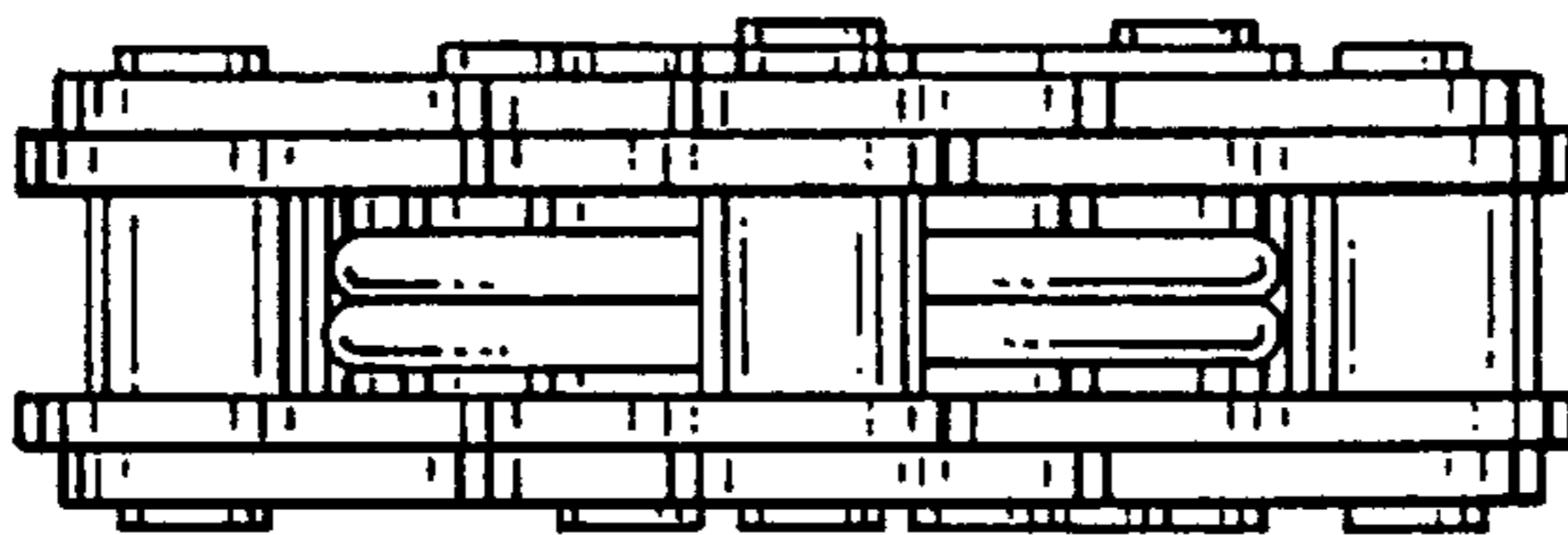

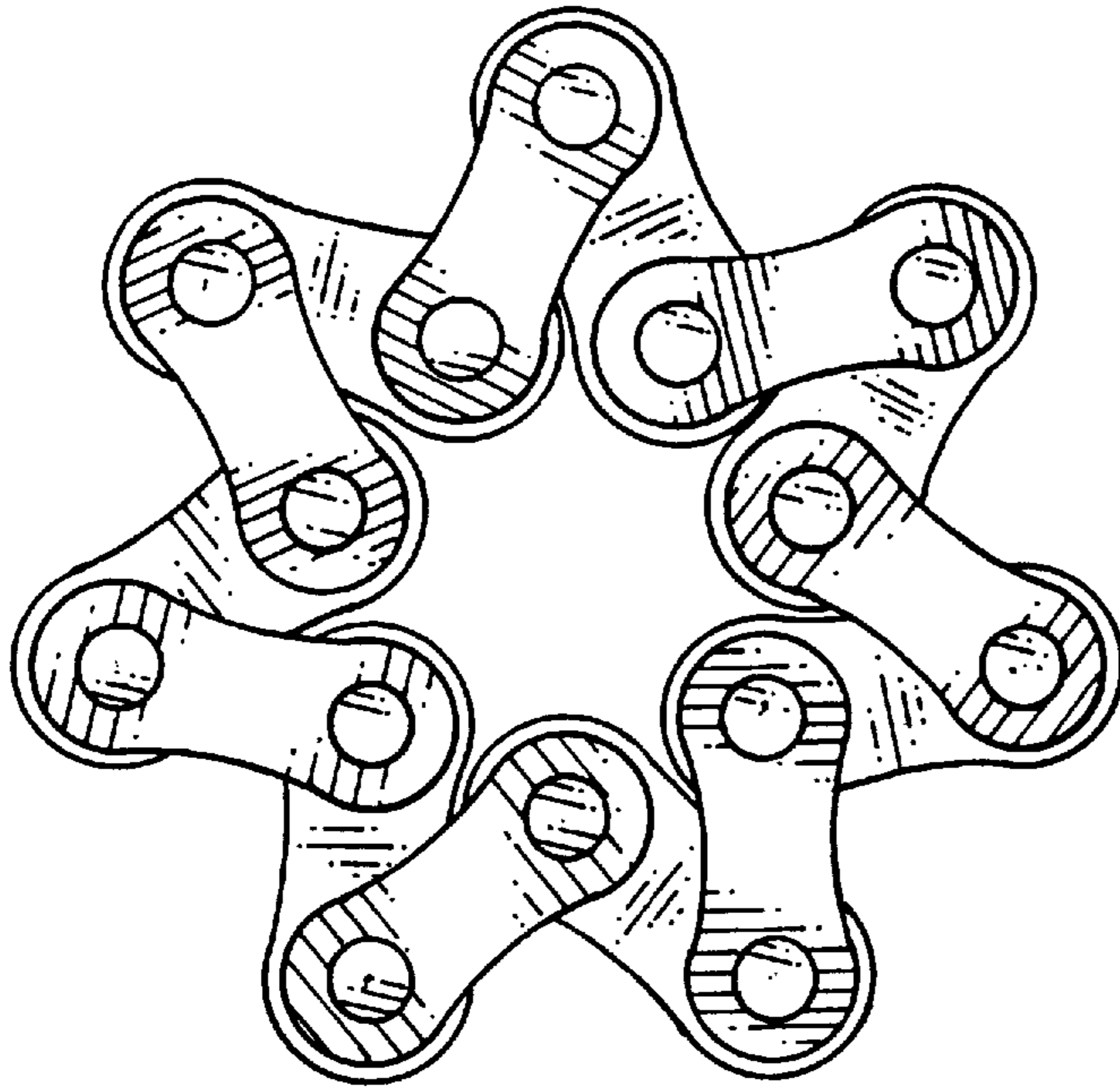

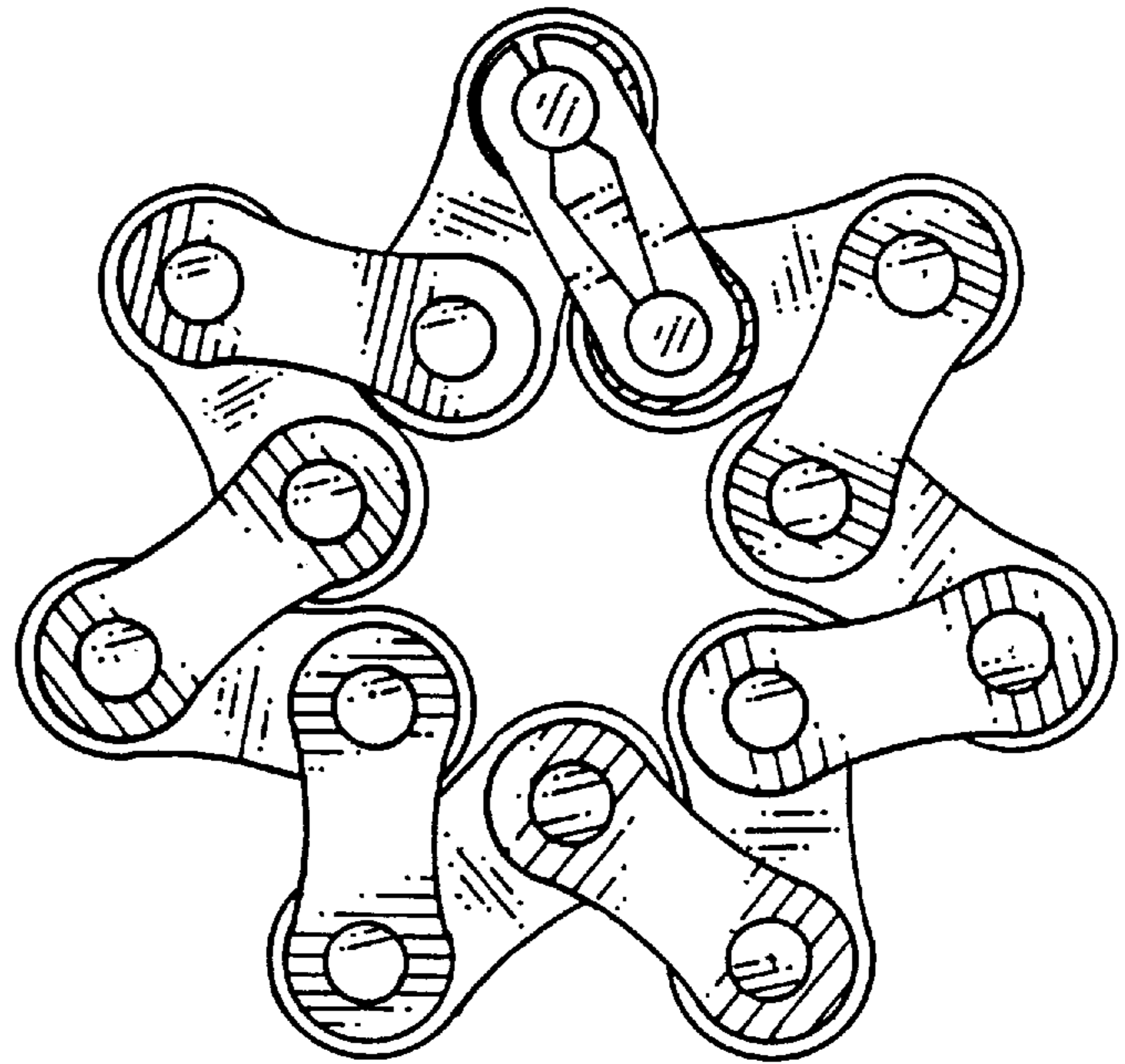

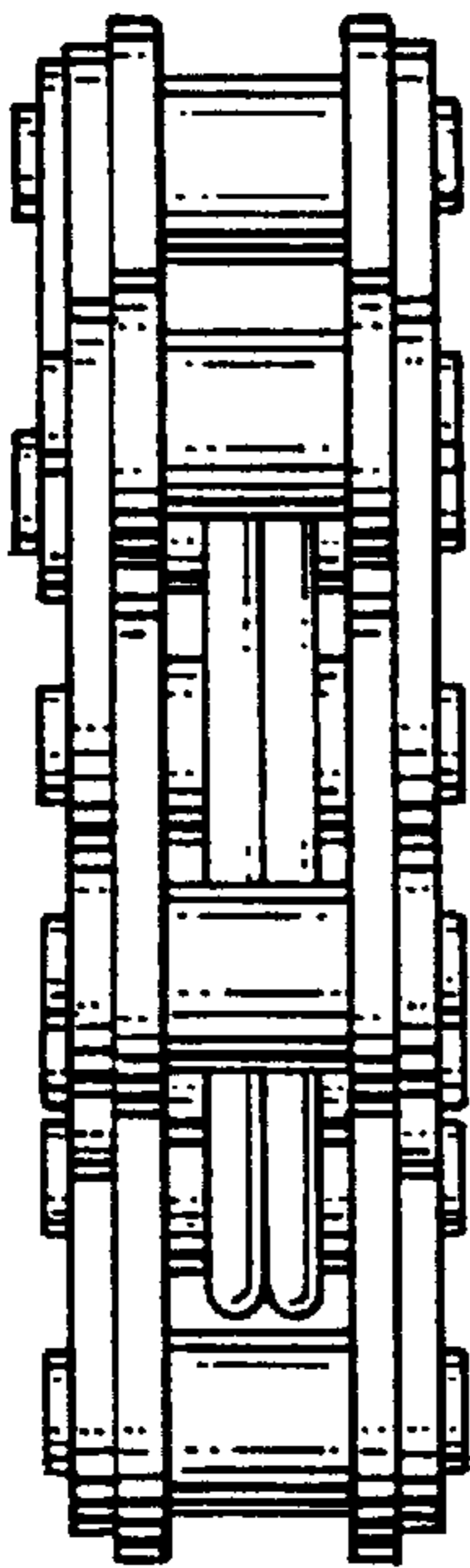

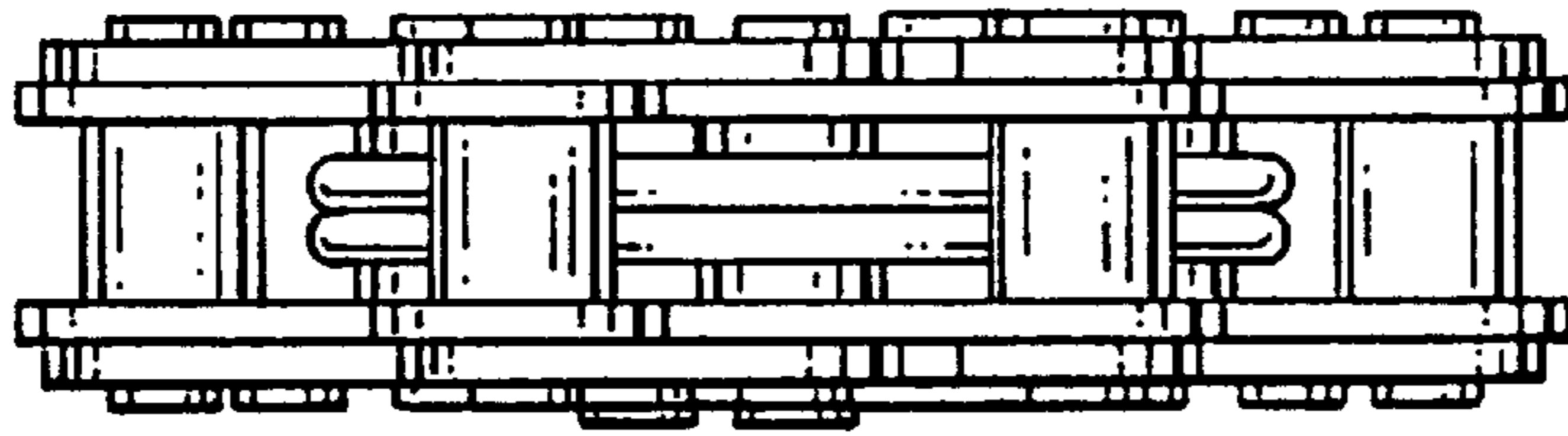

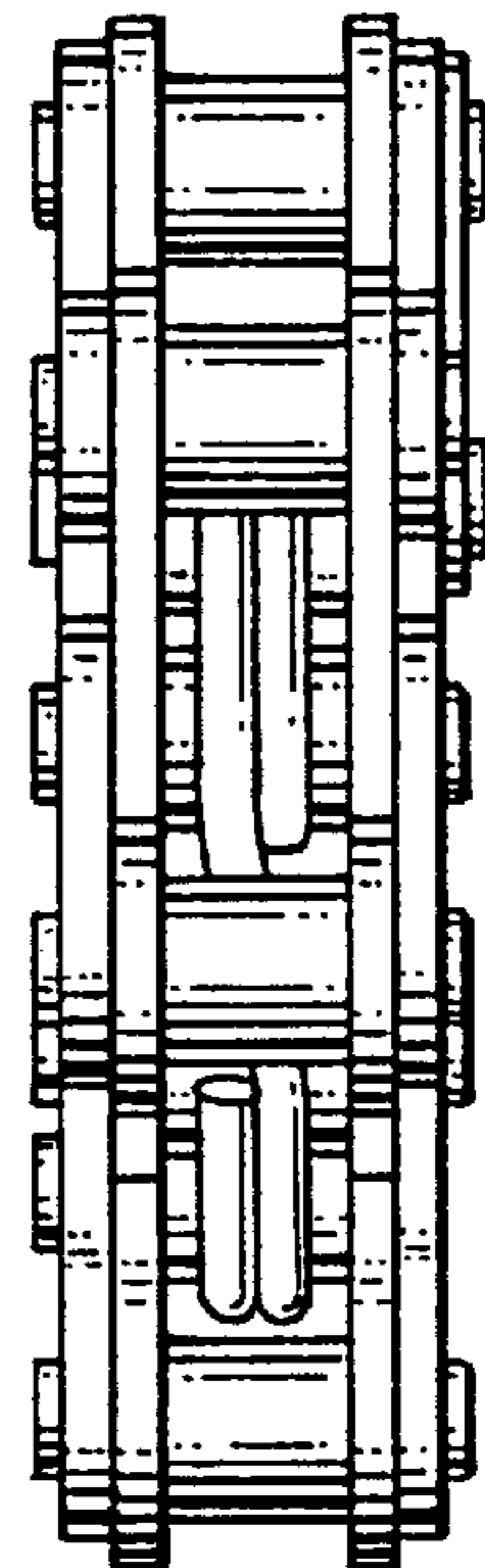

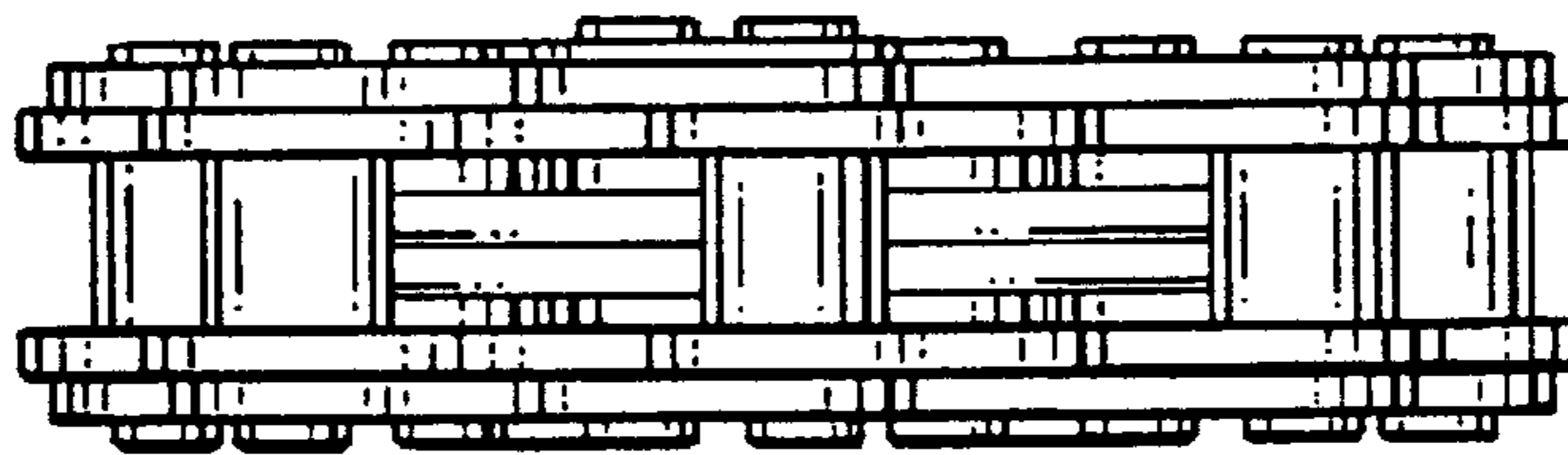
