[57] **CLAIM**

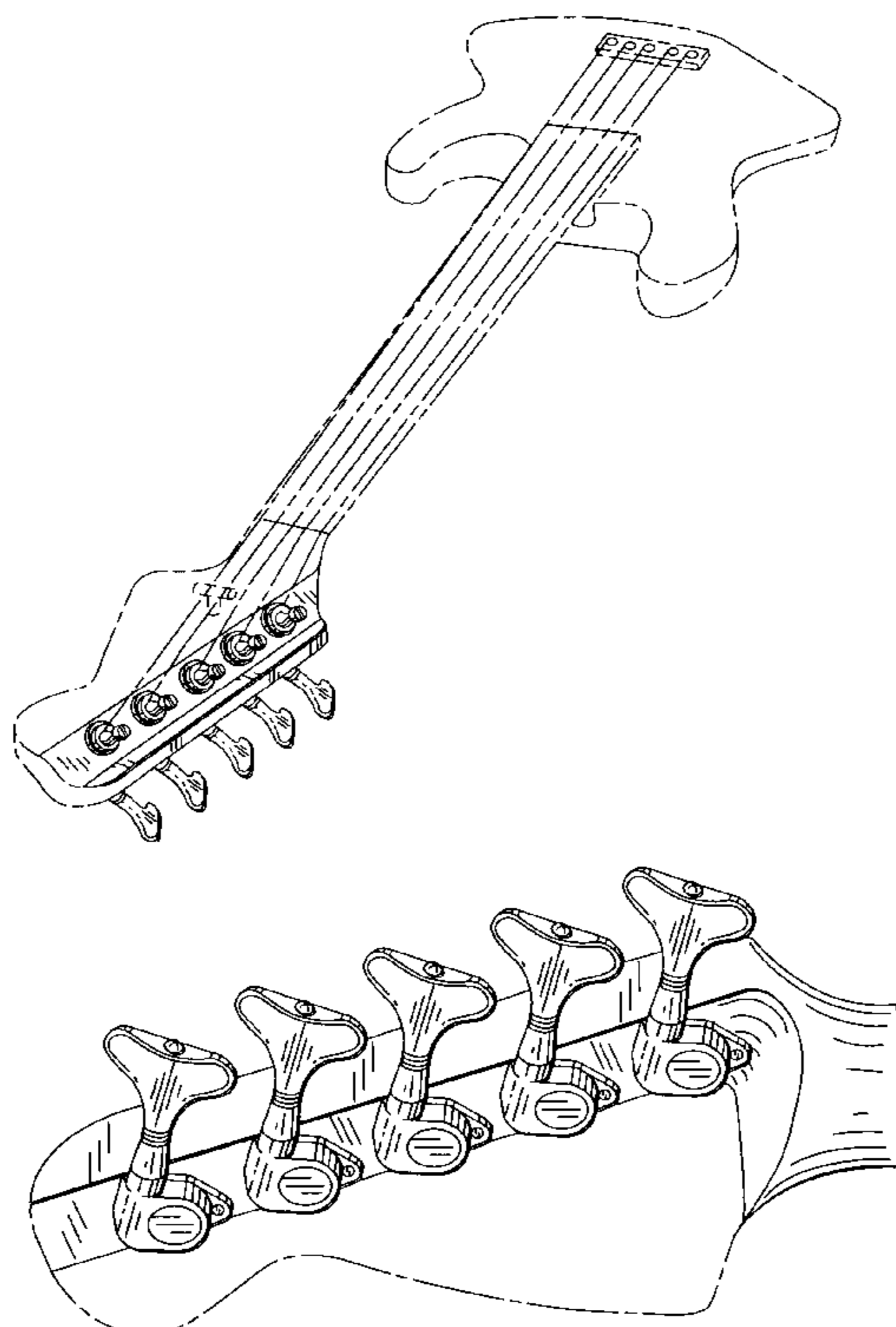
The ornamental design for a headstock for a string musical instrument, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a headstock for a string musical instrument and shows my new design; FIG. 2 is an enlarged top plan view of the headstock of the headstock for a string musical instrument; FIG. 3 is an enlarged side elevational view of the headstock of the headstock for a string musical instrument as viewed from the right in FIG. 1; FIG. 4 is an enlarged bottom plan view of the headstock of the headstock for a string musical instrument; and, FIG. 5 is an enlarged side elevational view of the headstock of the headstock for a string musical instrument as viewed from the left side in FIG. 1.

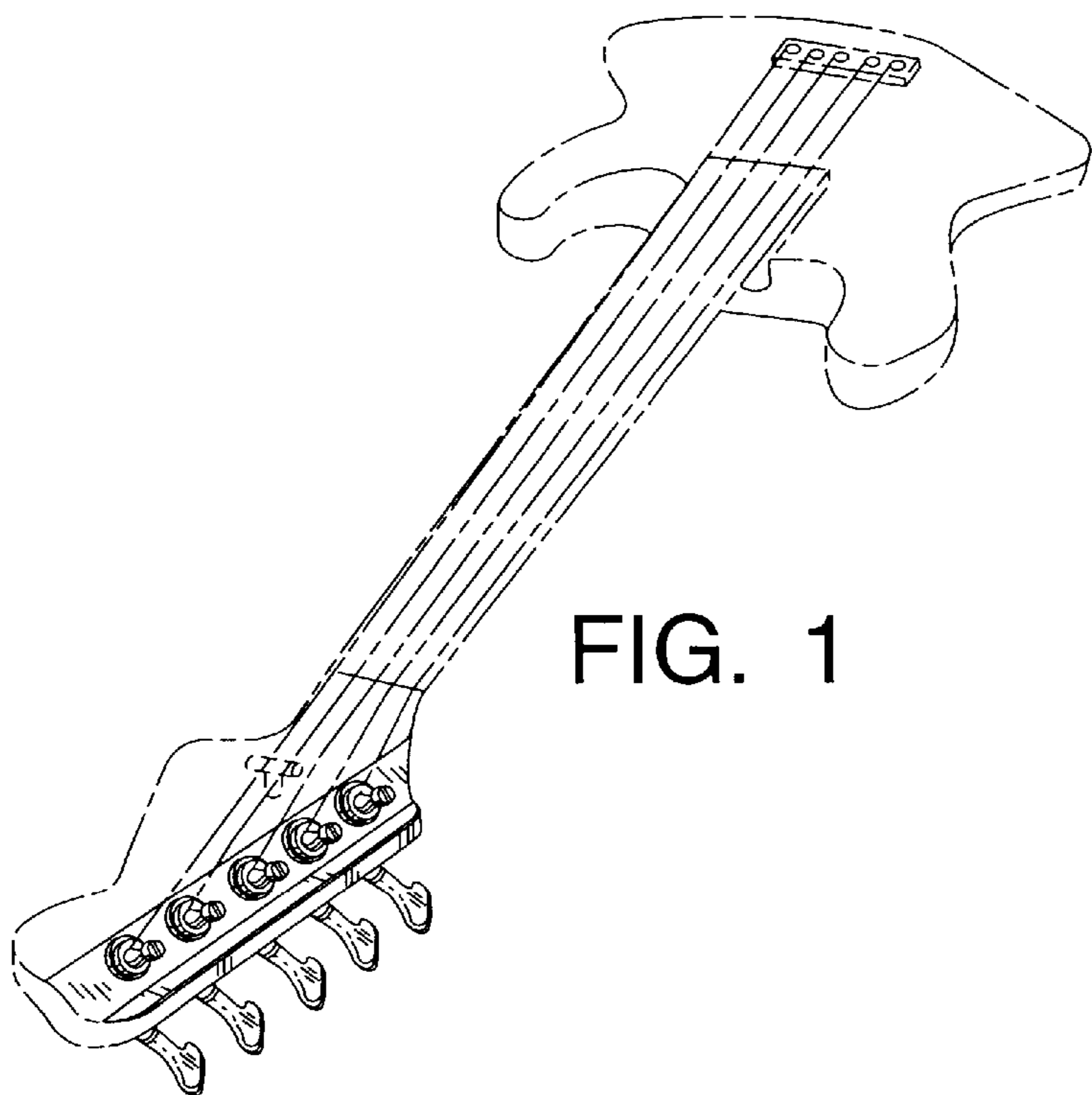

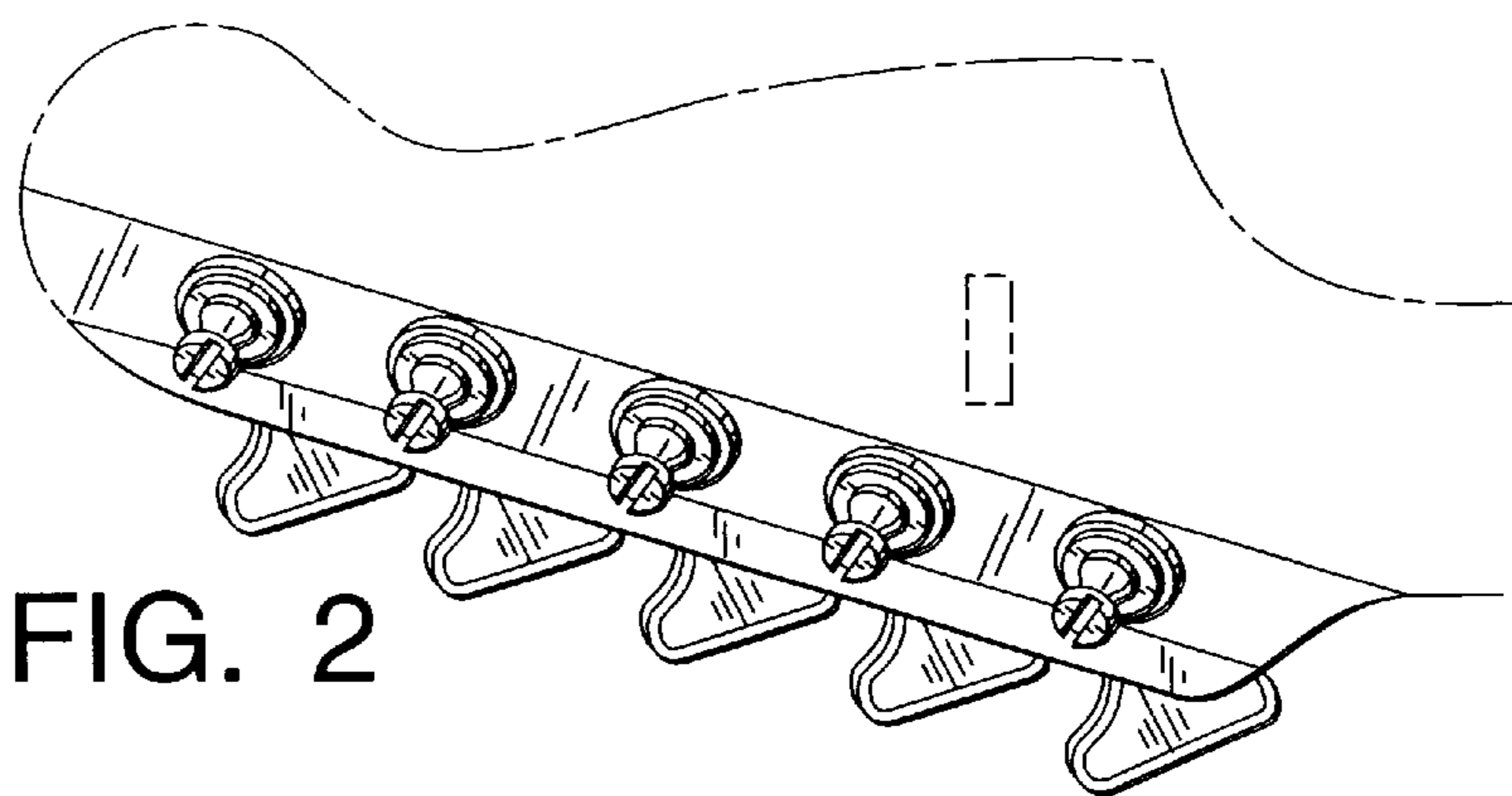

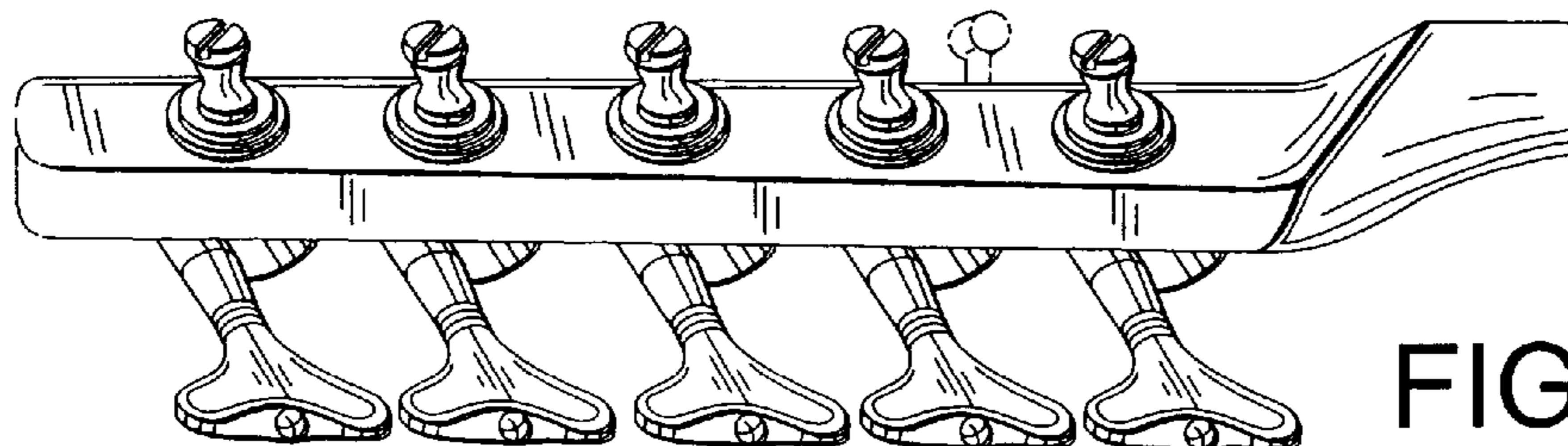

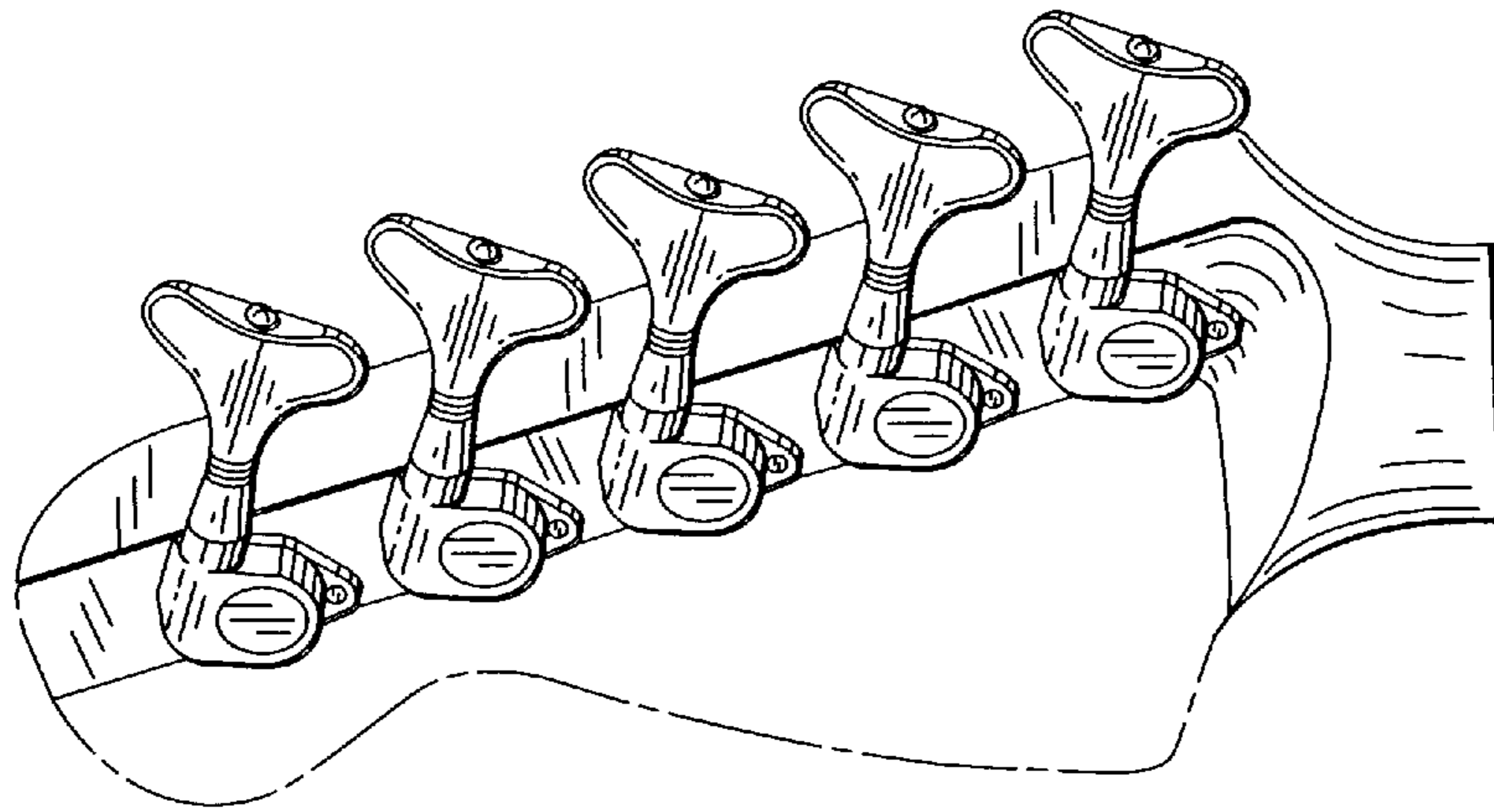

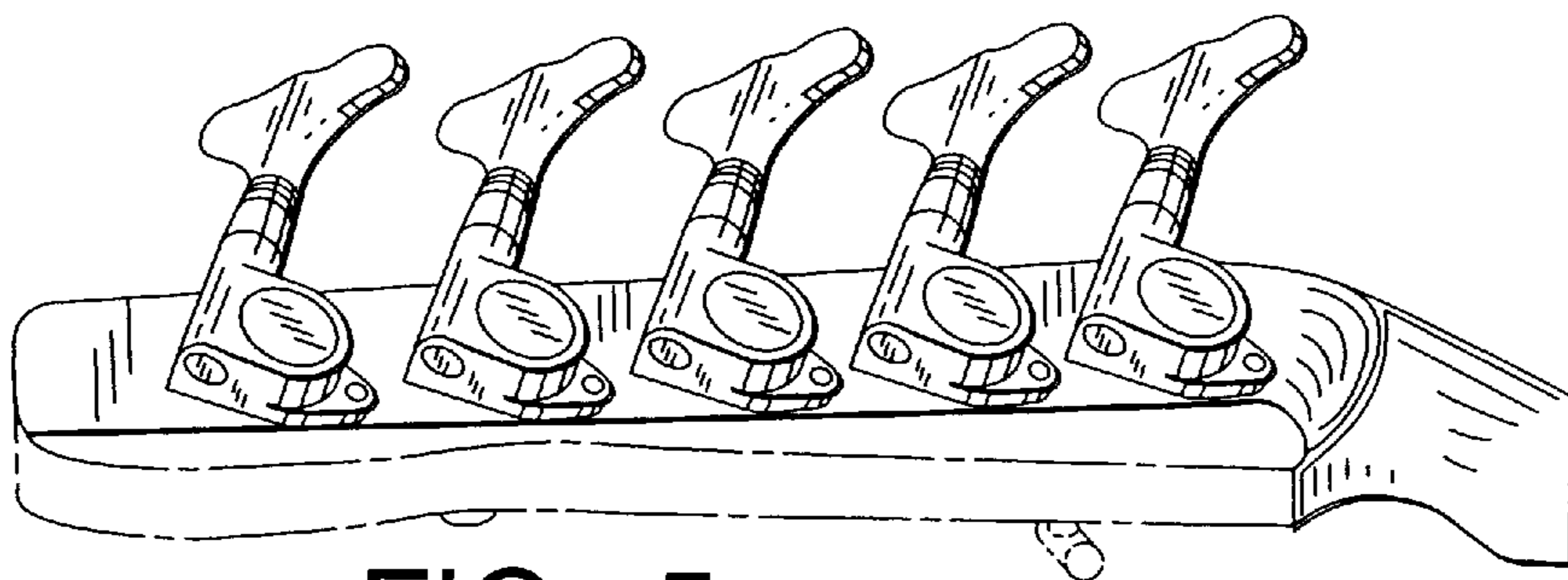
