The ornamental design for a data pen, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a data pen, showing my new design therefor;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a right side elevational view of a data pen showing a second embodiment of my design;

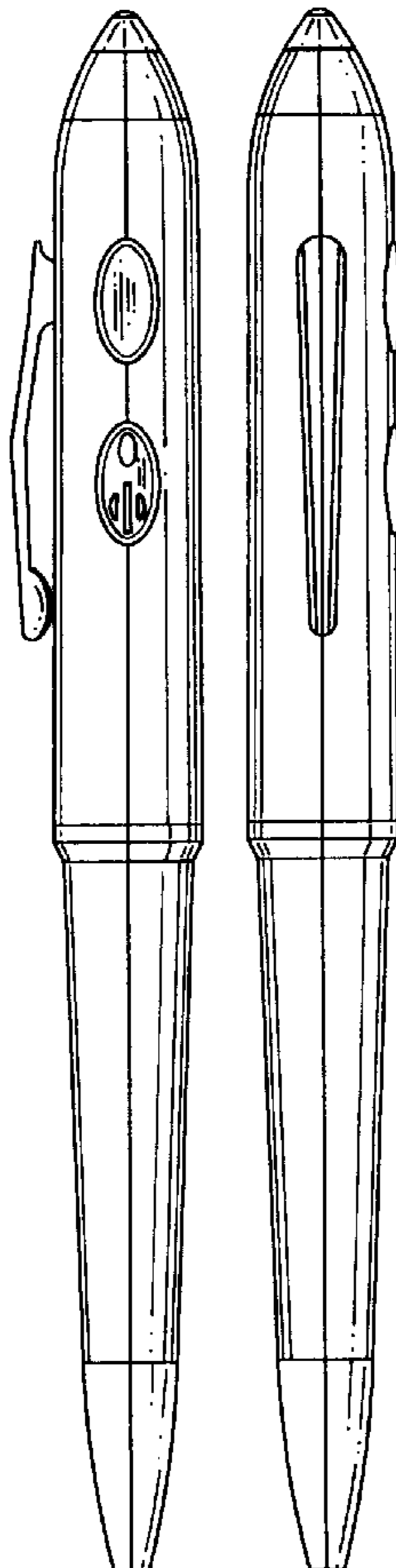

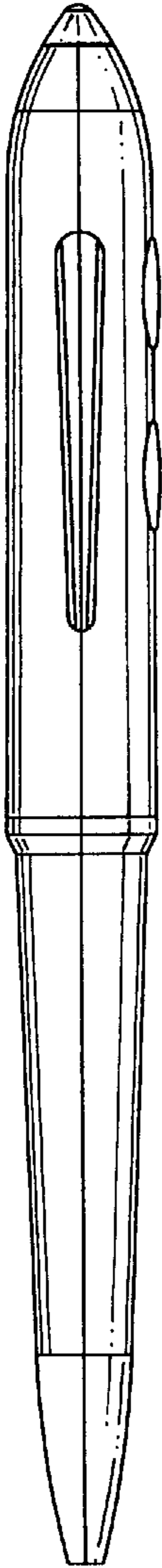
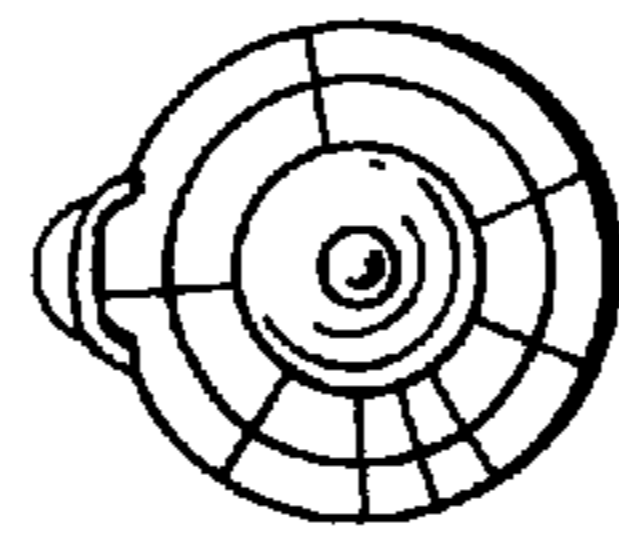

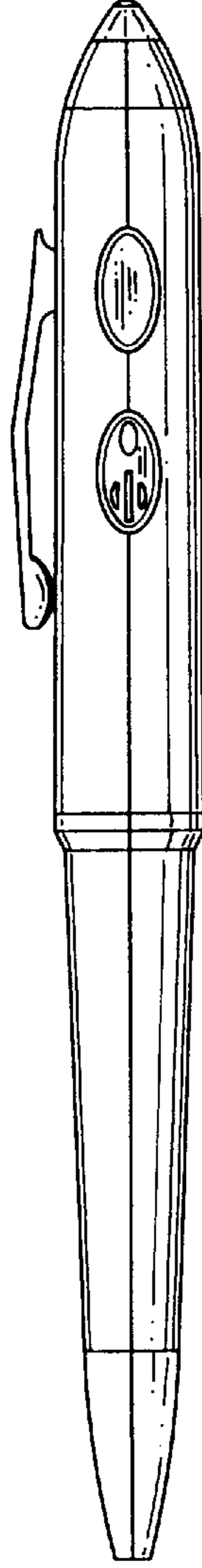

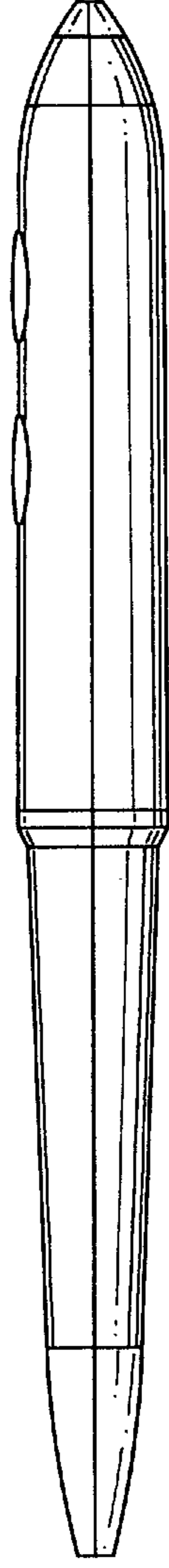

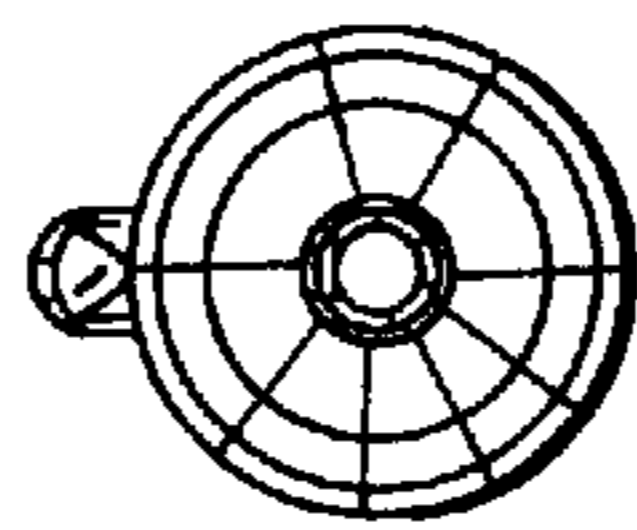

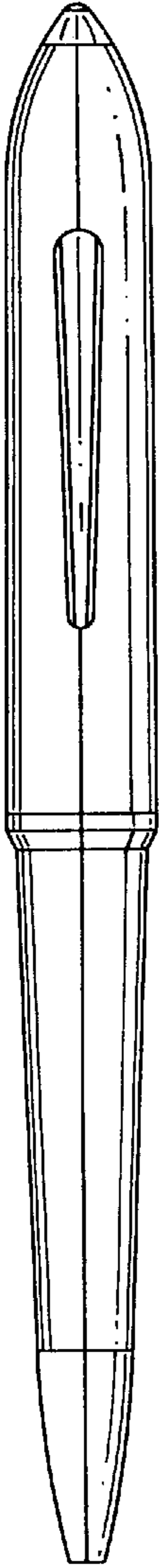
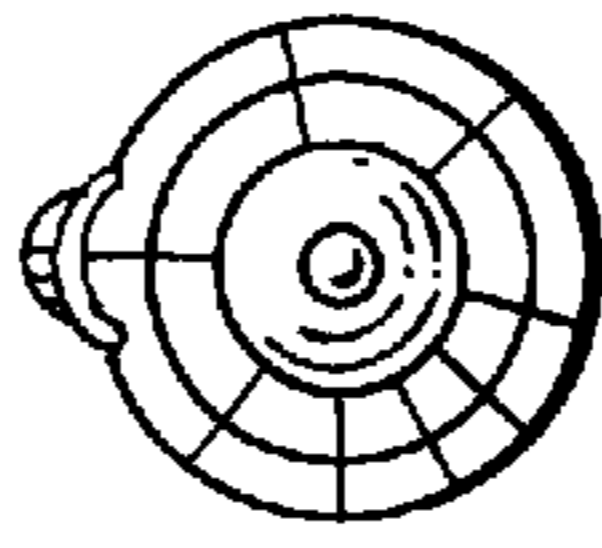

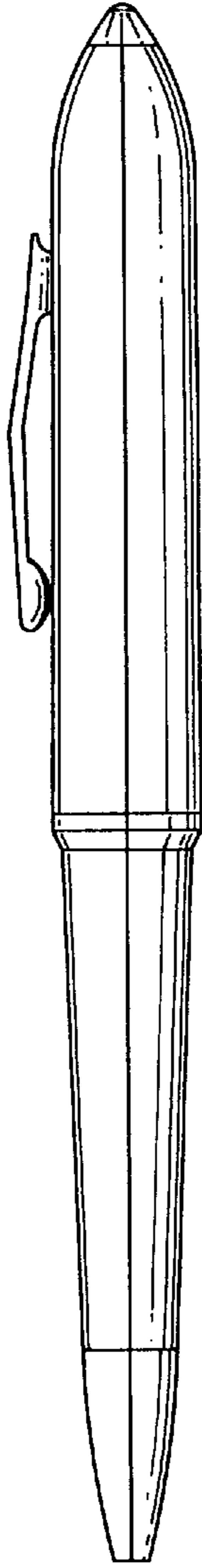

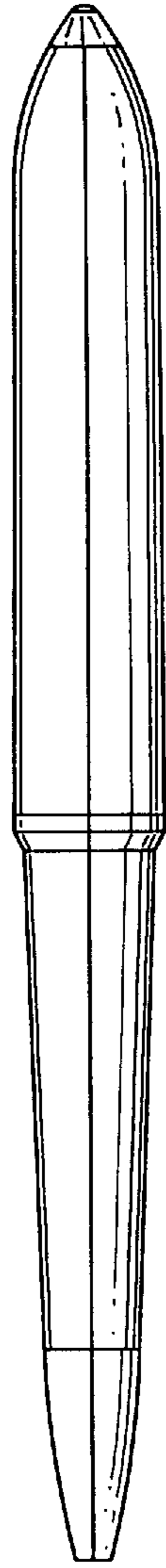

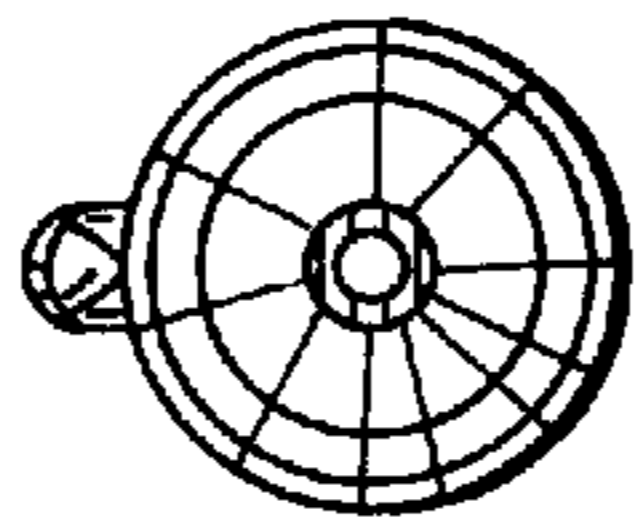

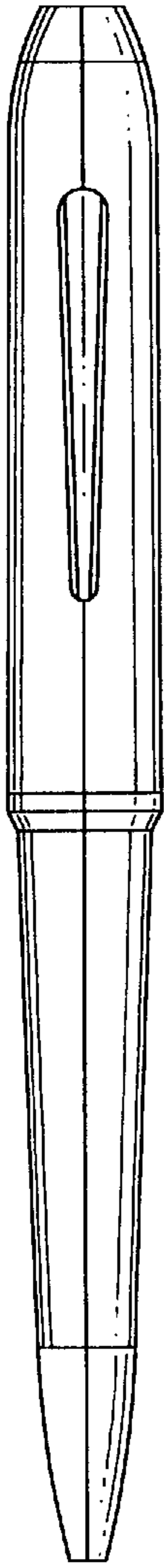
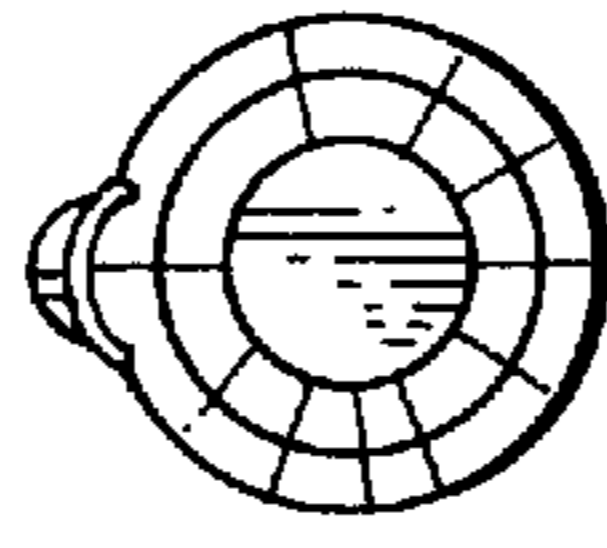

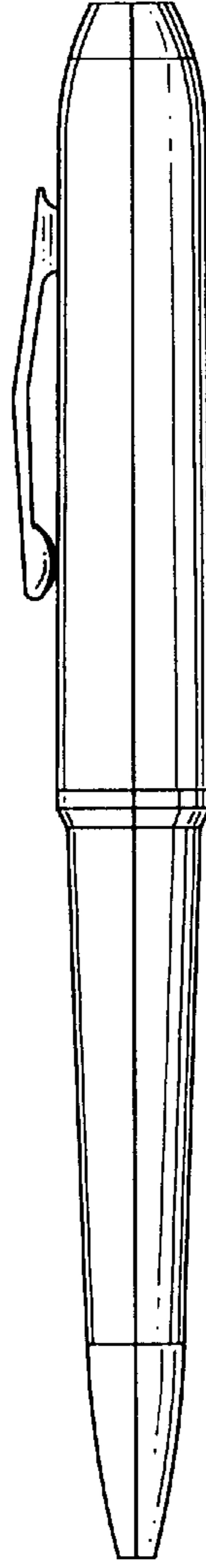

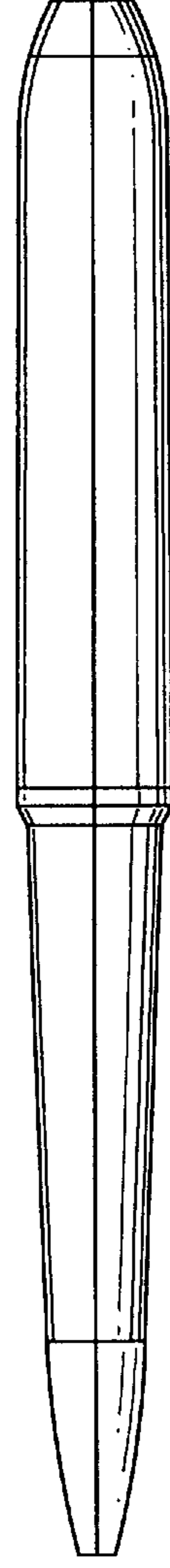
