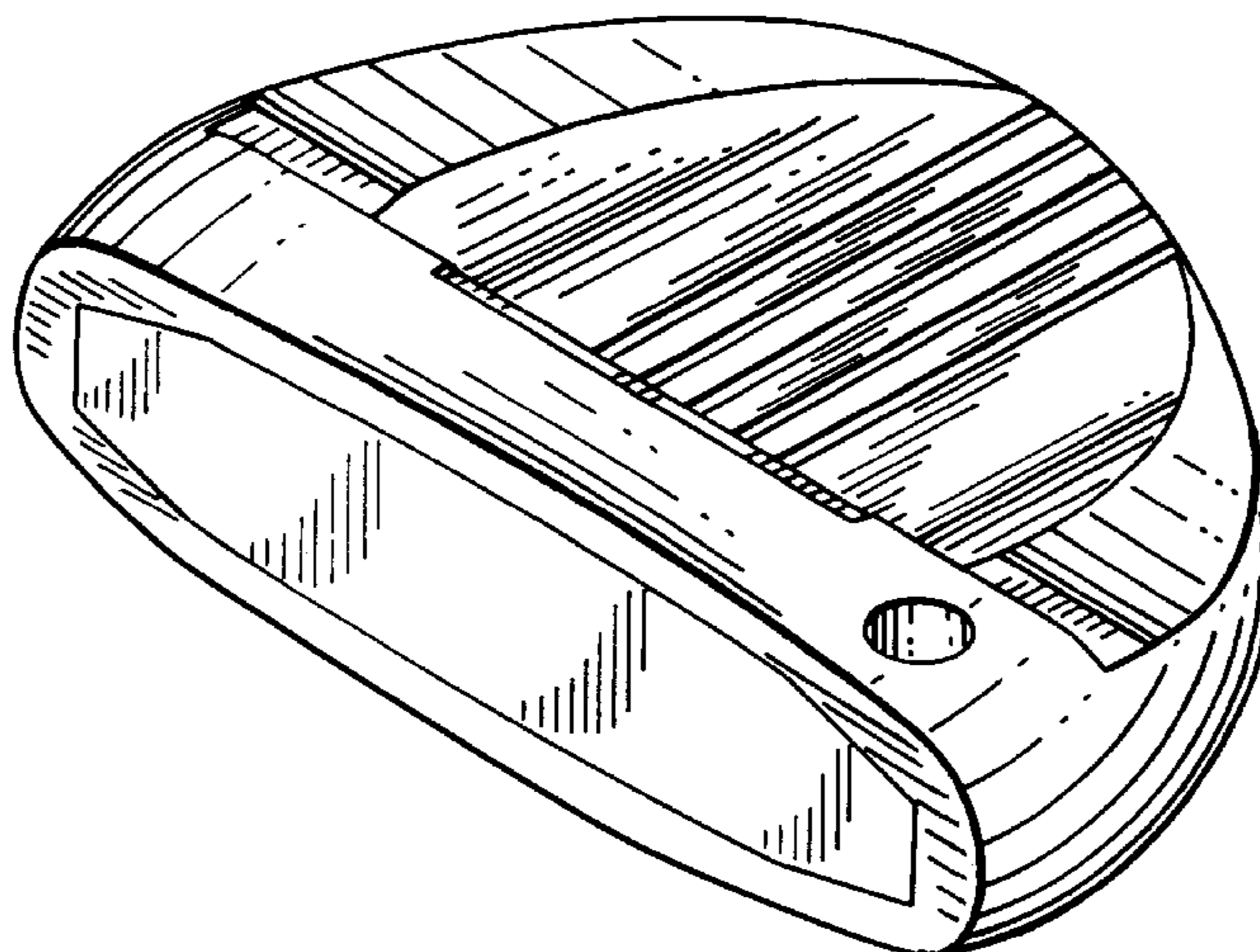
[57] **CLAIM**

The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view, of the golf club head of the present invention;
FIG. 2 is a top elevational view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a toe side elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a heel side elevational view thereof;
FIG. 7 is a bottom elevational view thereof;
FIG. 8 is a front perspective view of the second embodiment of the golf club head of the present invention;
FIG. 9 is a top elevational view of FIG. 8;
FIG. 10 is a front elevational view of FIG. 8;
FIG. 11 is a toe side elevational view of FIG. 8;
FIG. 12 is a rear elevational view of FIG. 8;
FIG. 13 is a heel side elevational view of FIG. 8; and,
FIG. 14 is a bottom elevational view of FIG. 8.

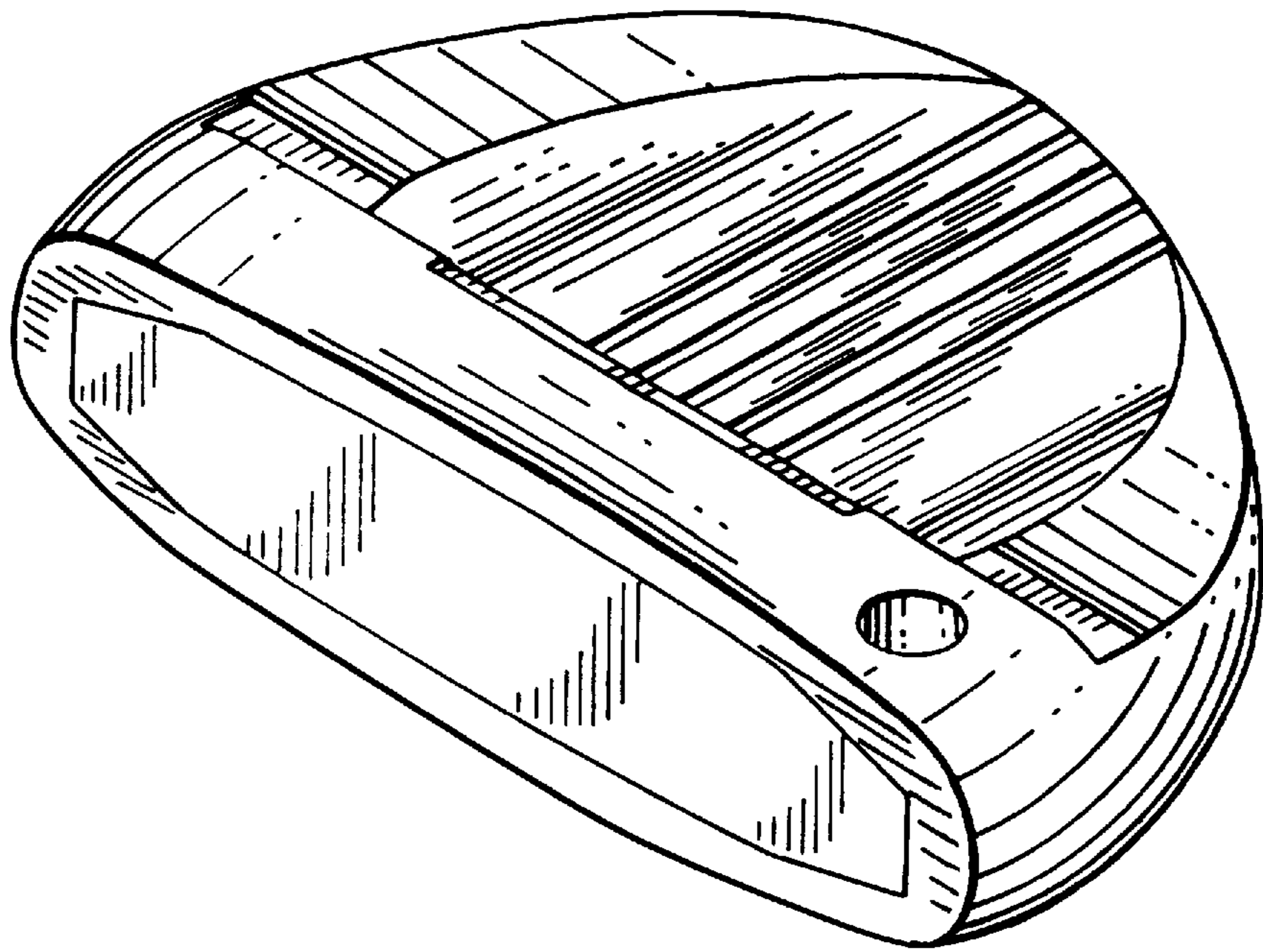

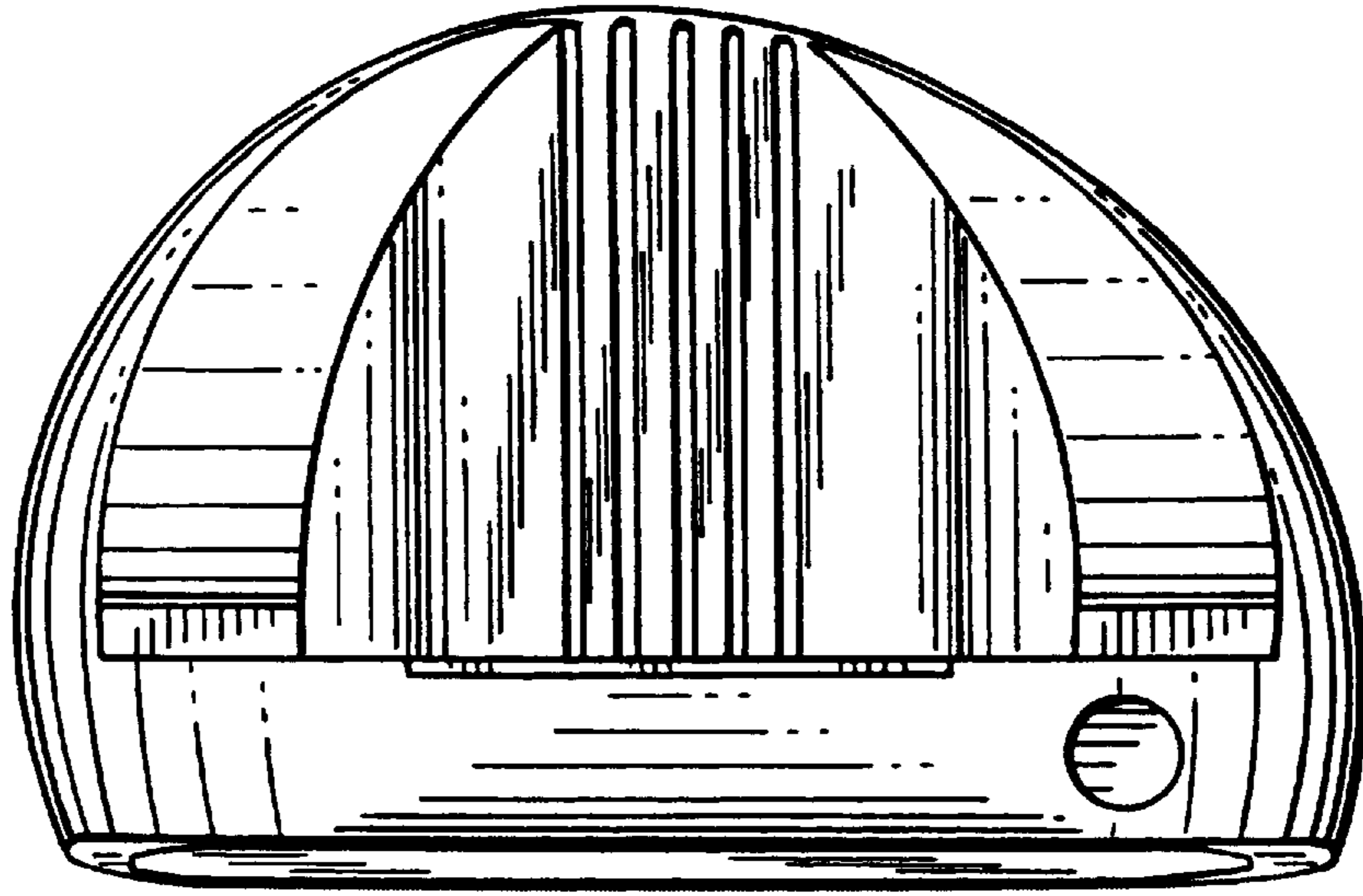

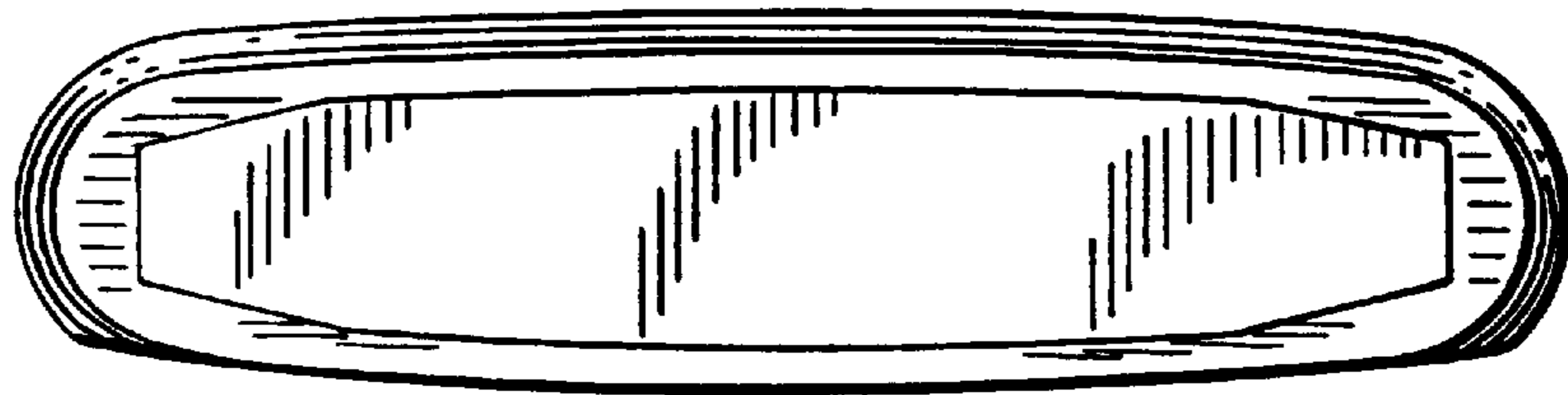

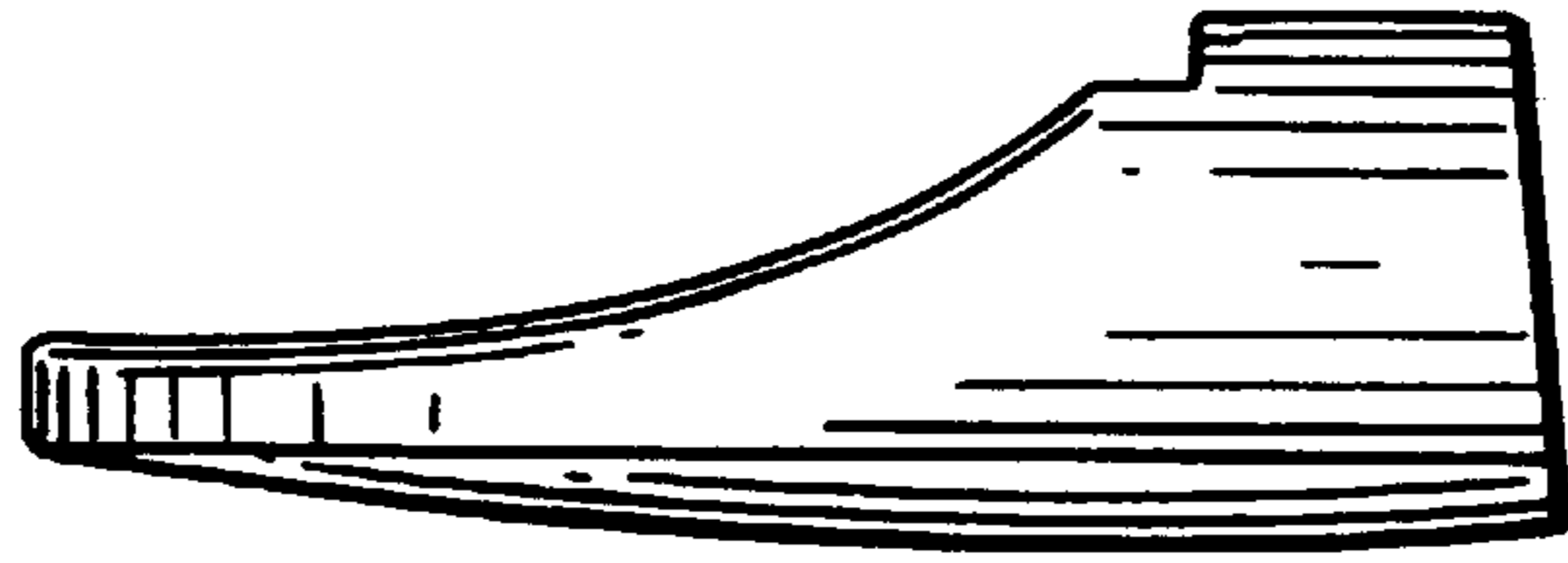

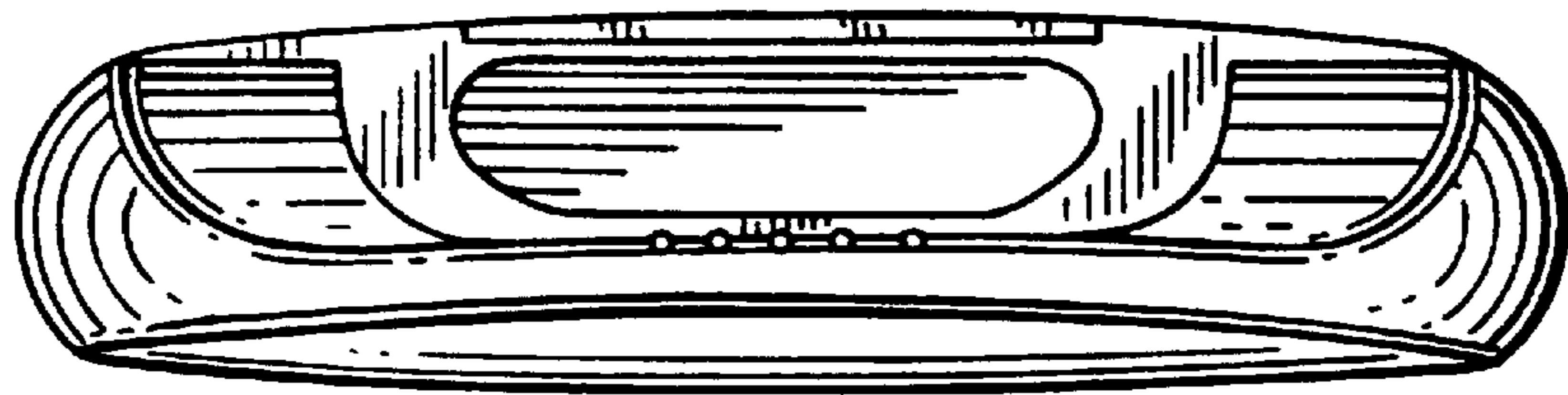

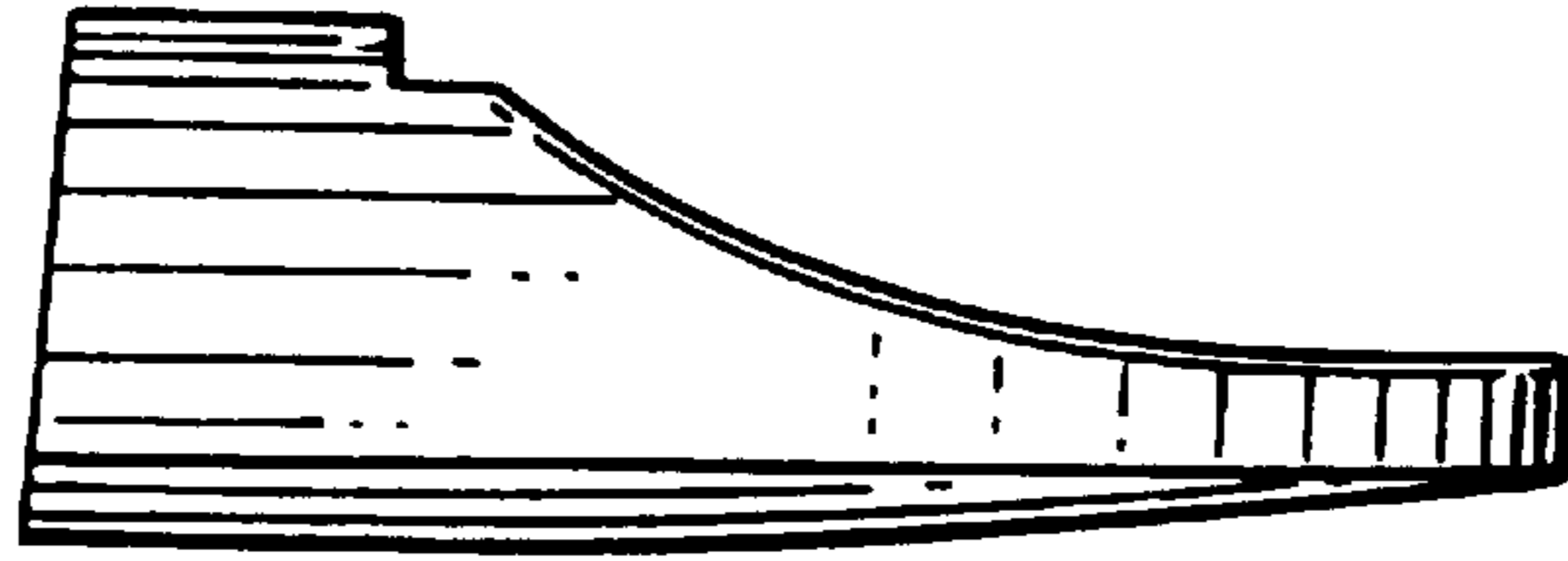

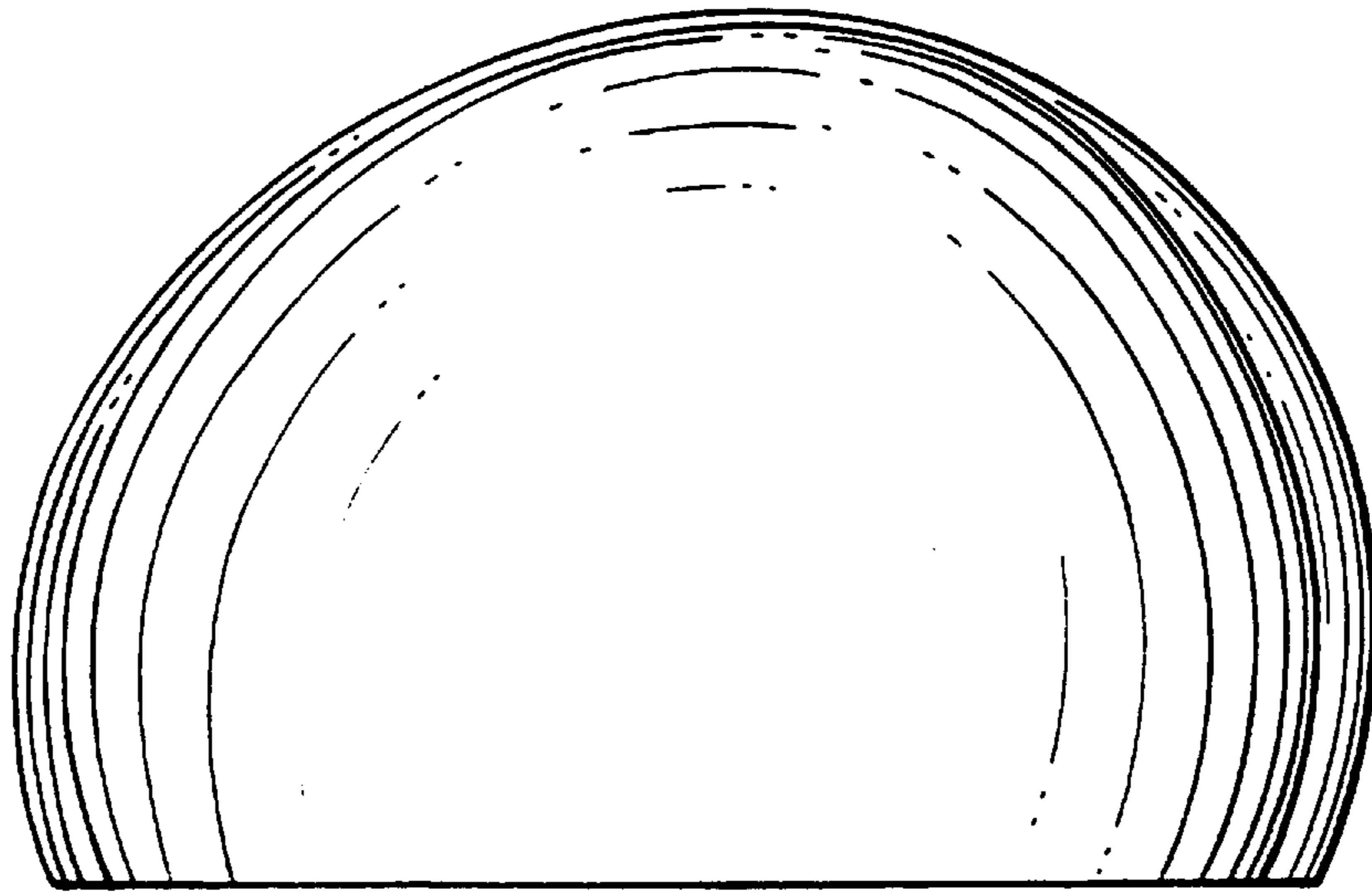

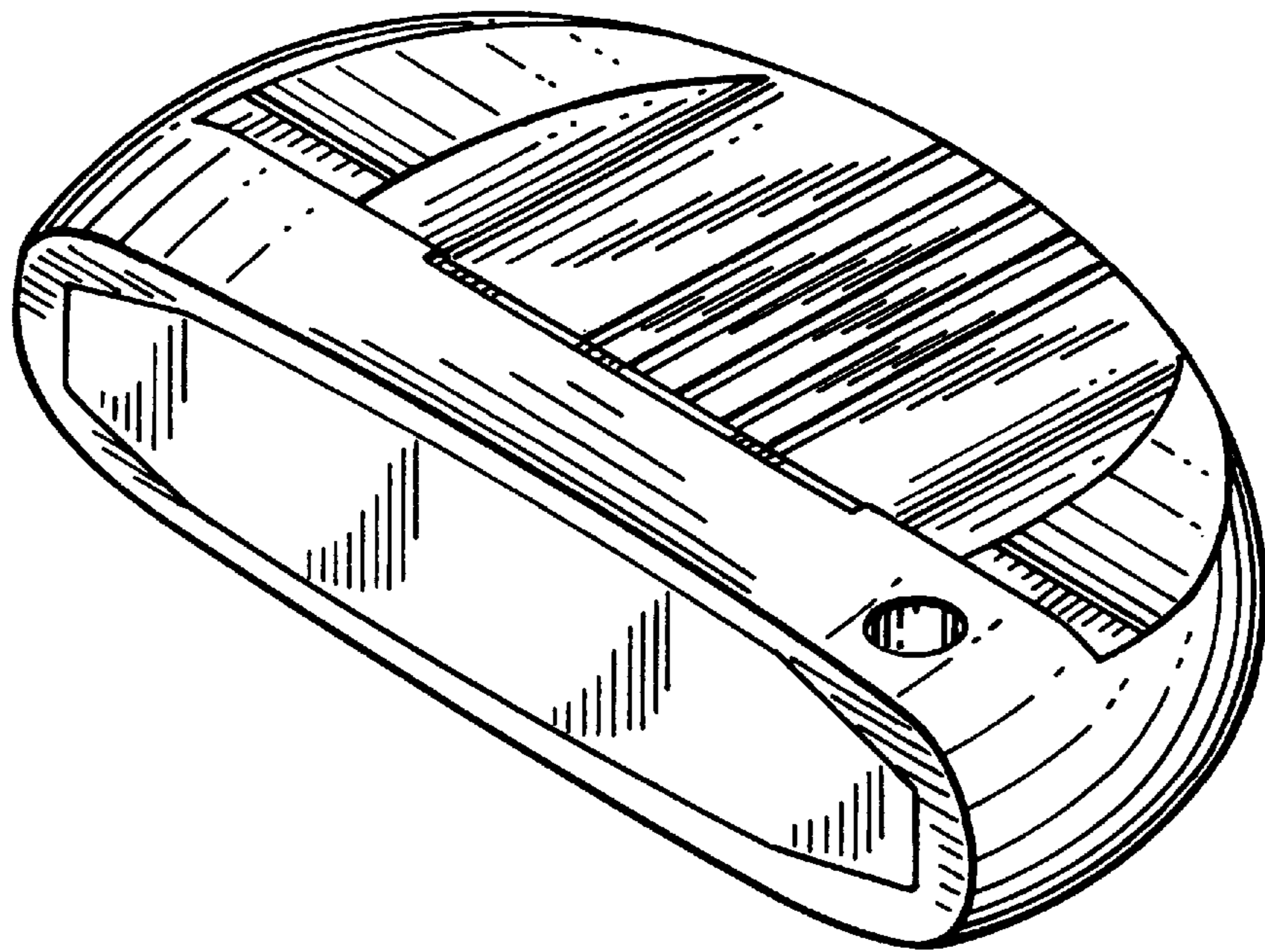

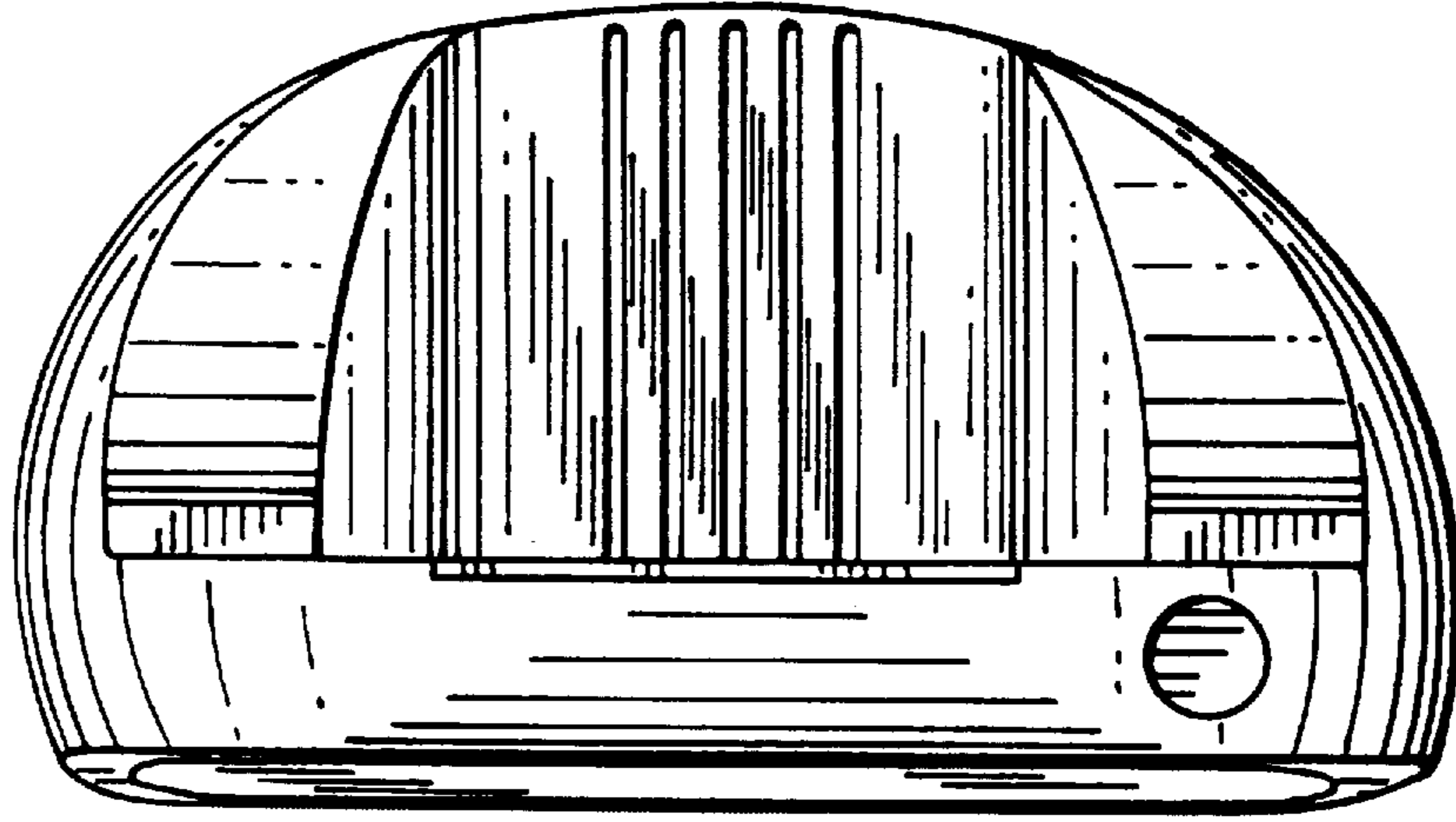

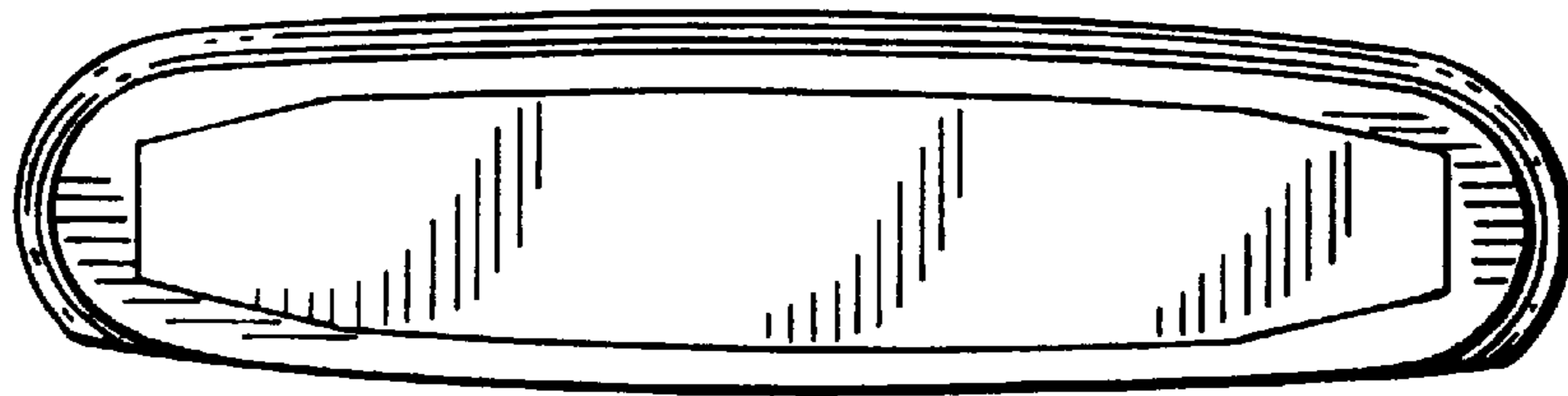

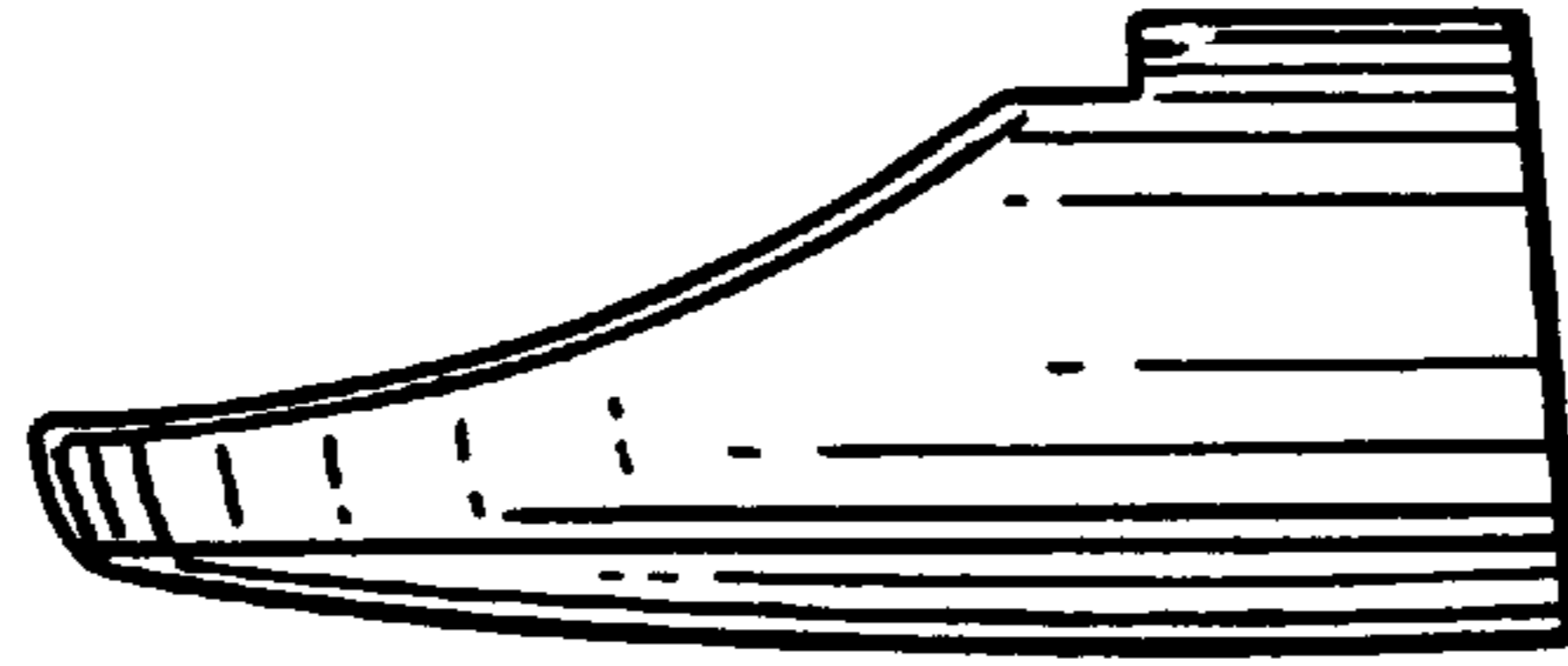

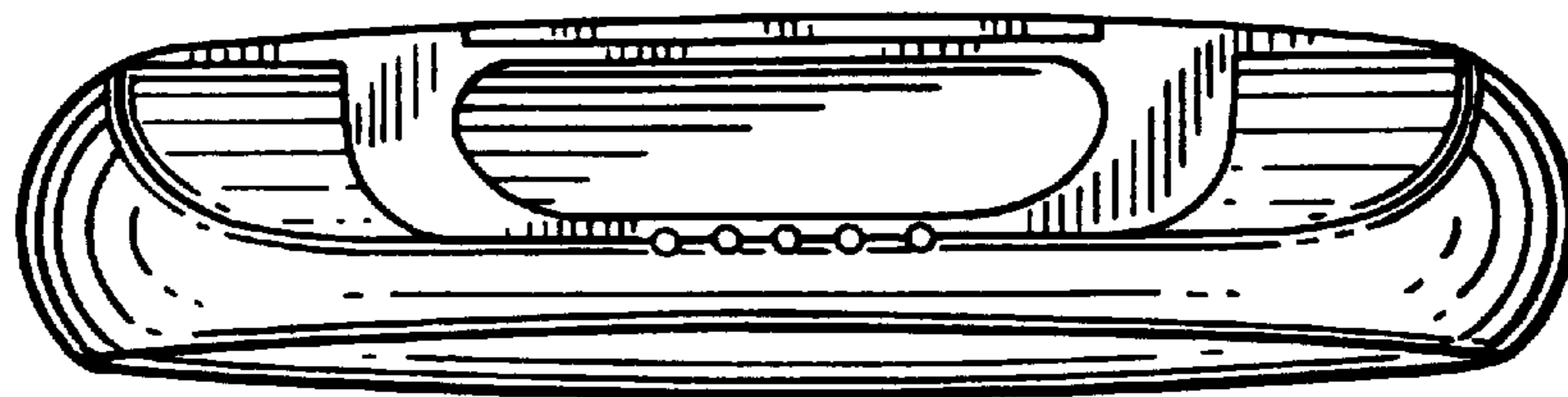

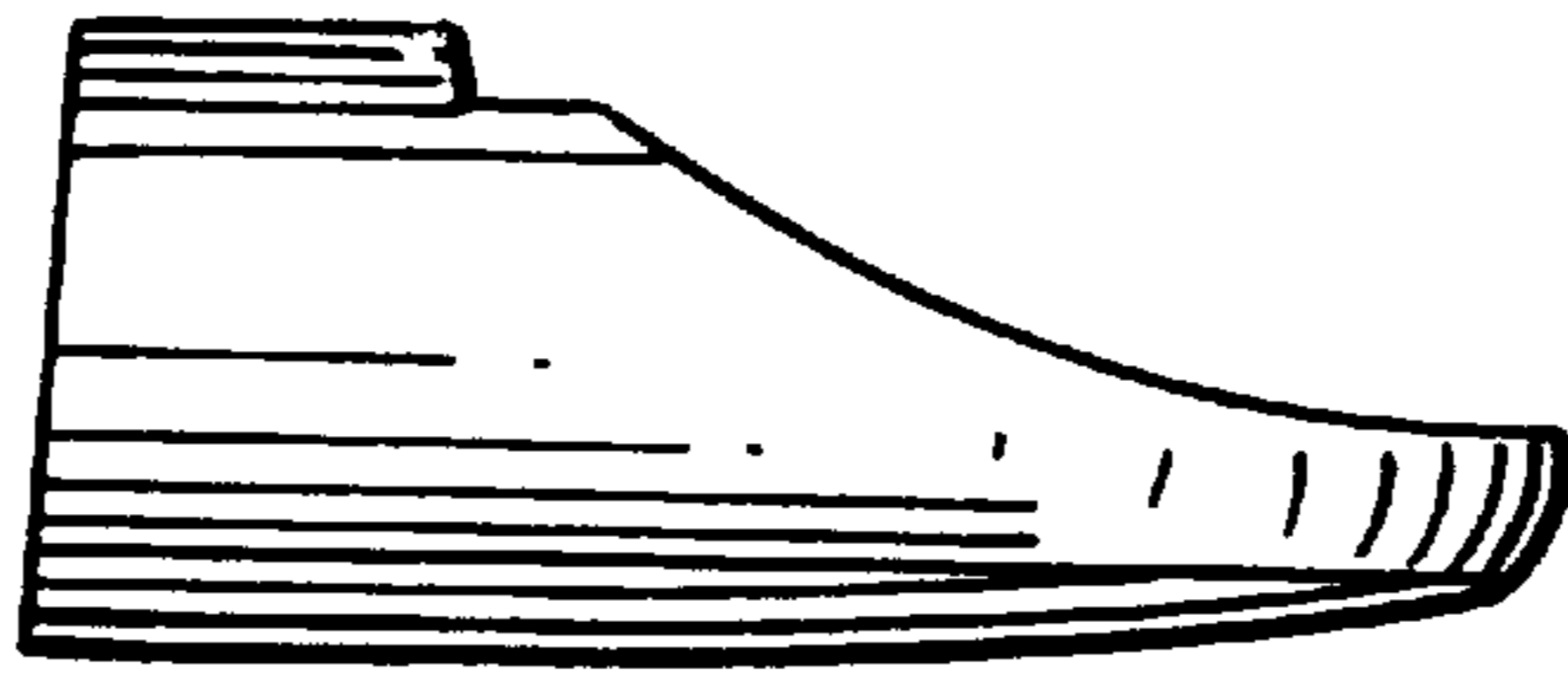

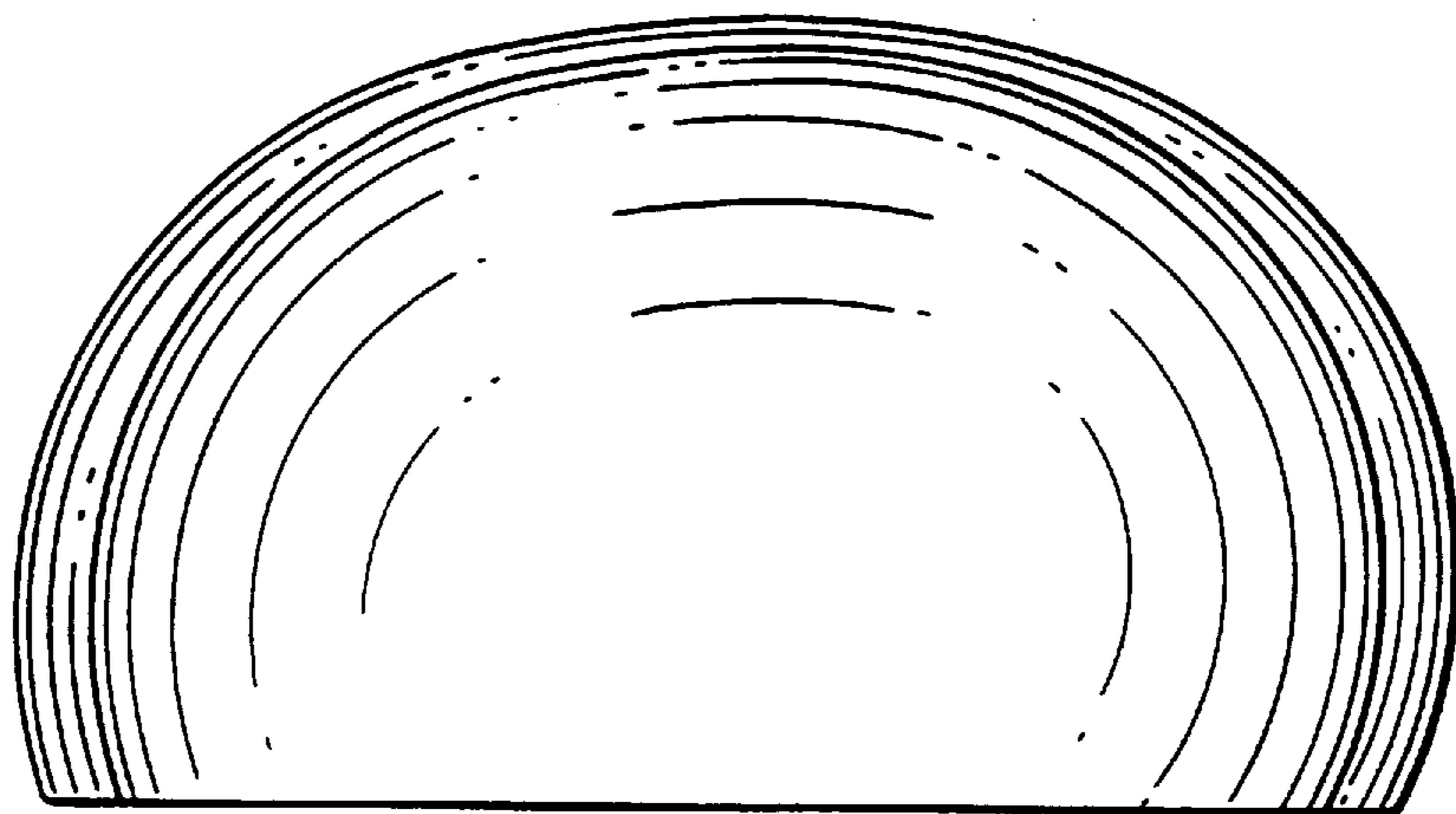
