The ornamental design for a golf club stand, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the present invention; FIG. 2 is an enlarged front elevational view of the present invention, the undisclosed opposite side being a mirror image; FIG. 3 is a left side elevational view of the present invention of FIG. 2; FIG. 4 is a right side elevational view of the present invention of FIG. 2; FIG. 5 is a top view of the present invention of FIG. 2; and, FIG. 6 is a bottom view of the present invention of FIG. 2; The broken line showing on FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

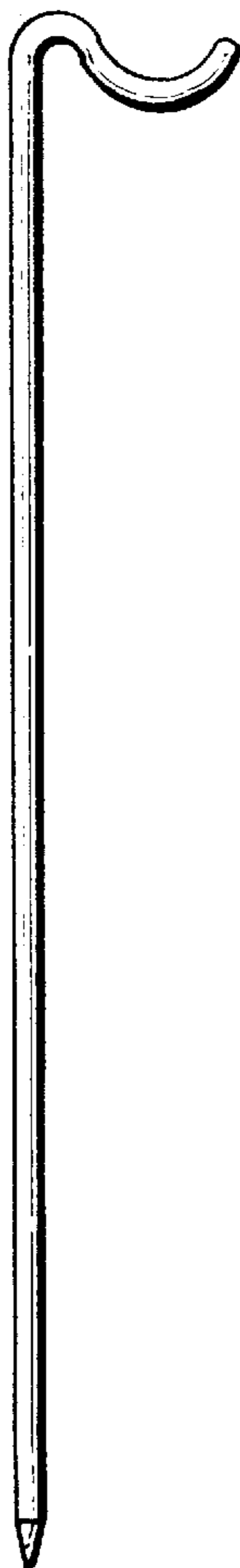

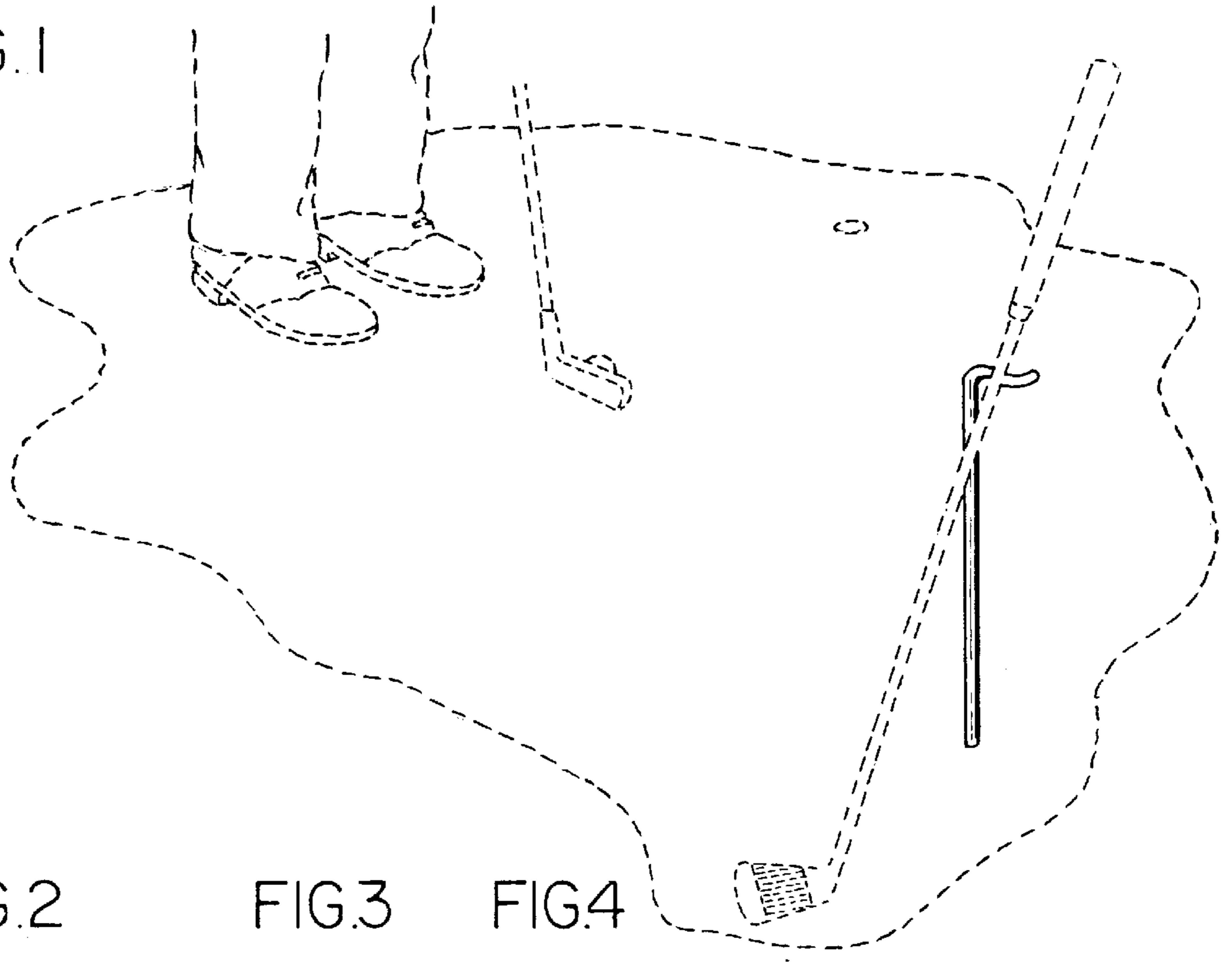

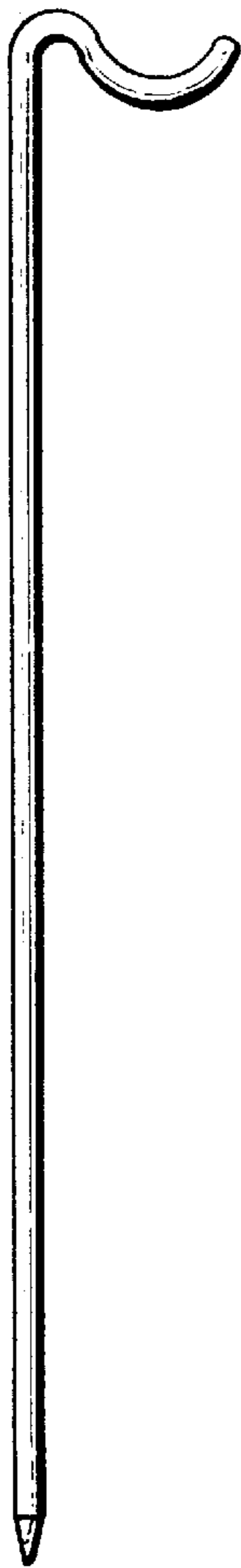
