**DESCRIPTION**

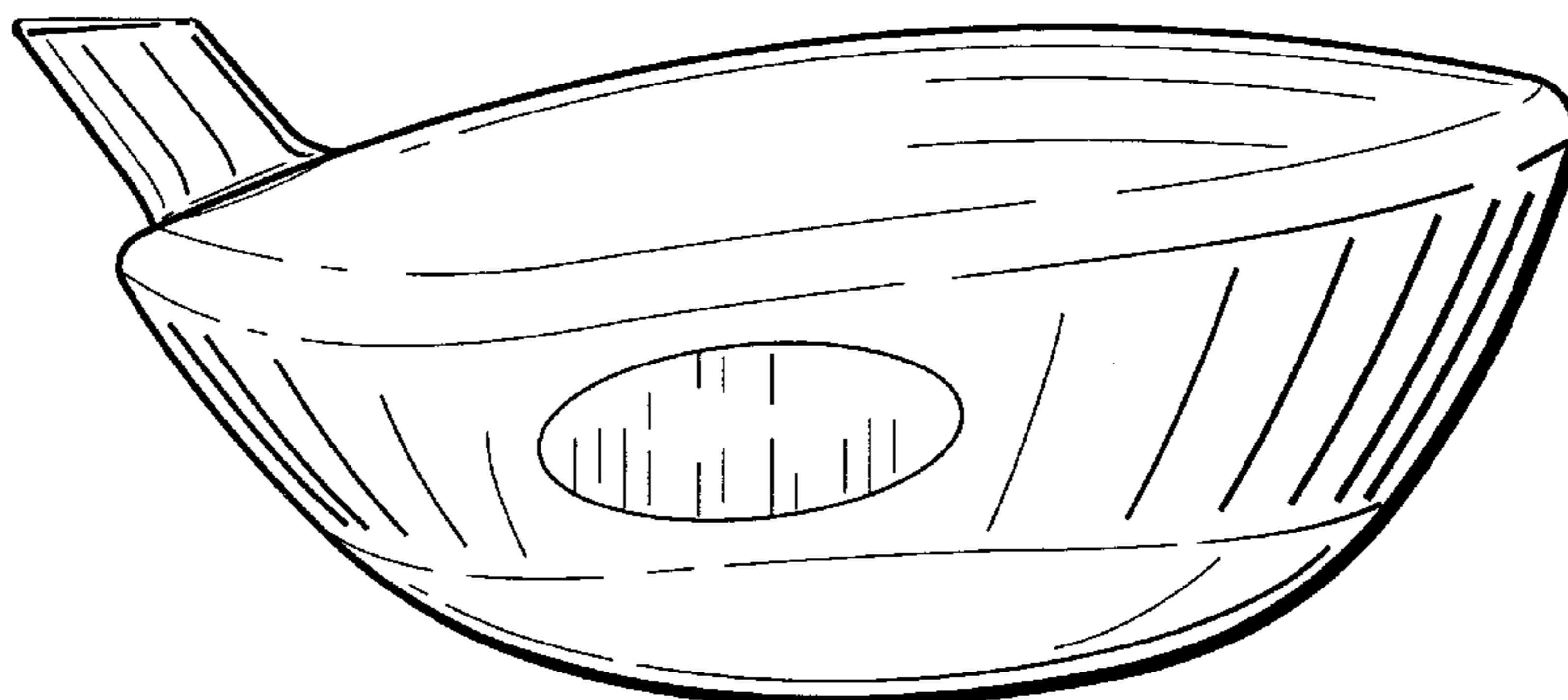
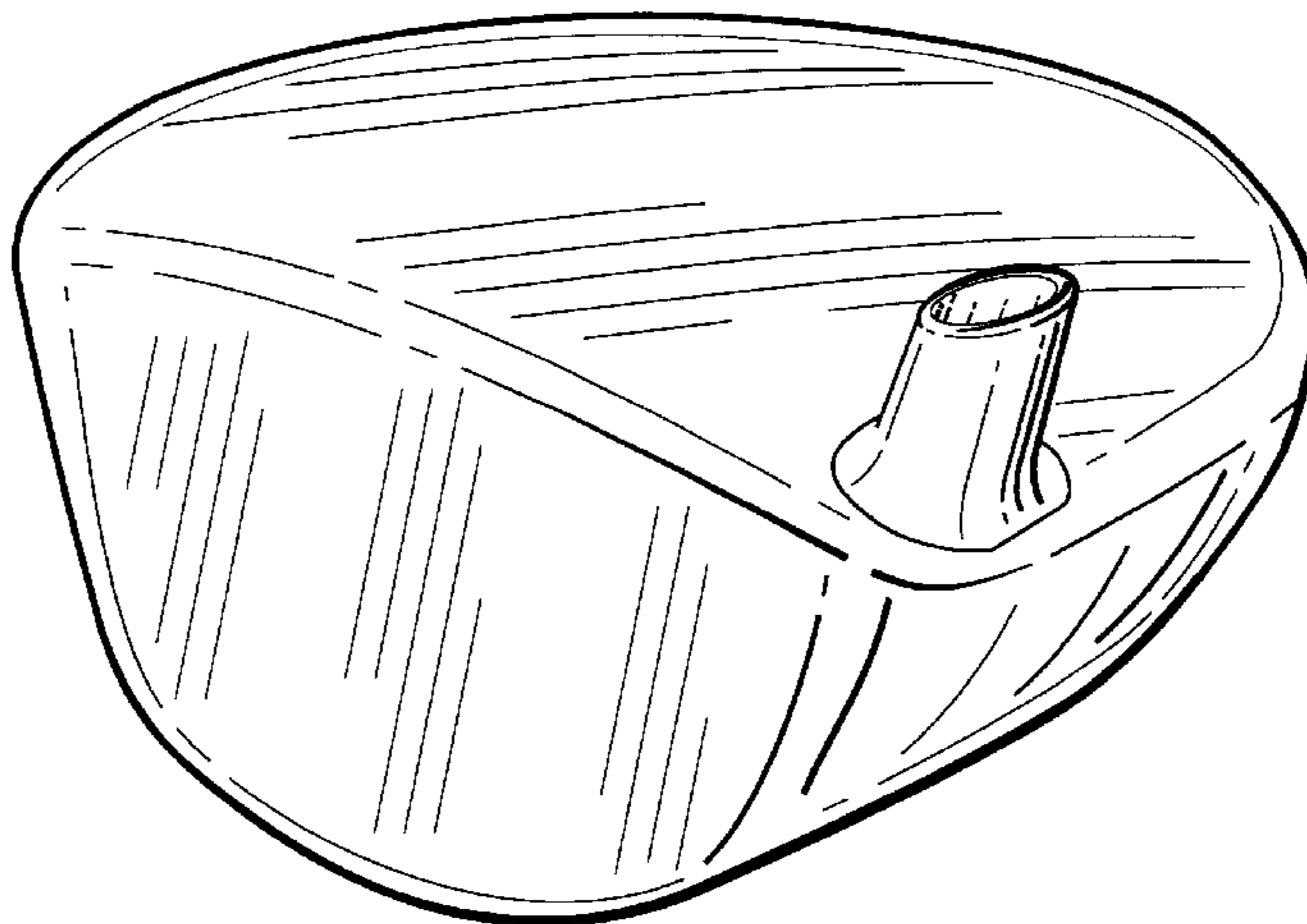
FIG. 1 is a perspective view of a golf club head showing our new design;

FIG. 7 is a toe end view of the golf club head.

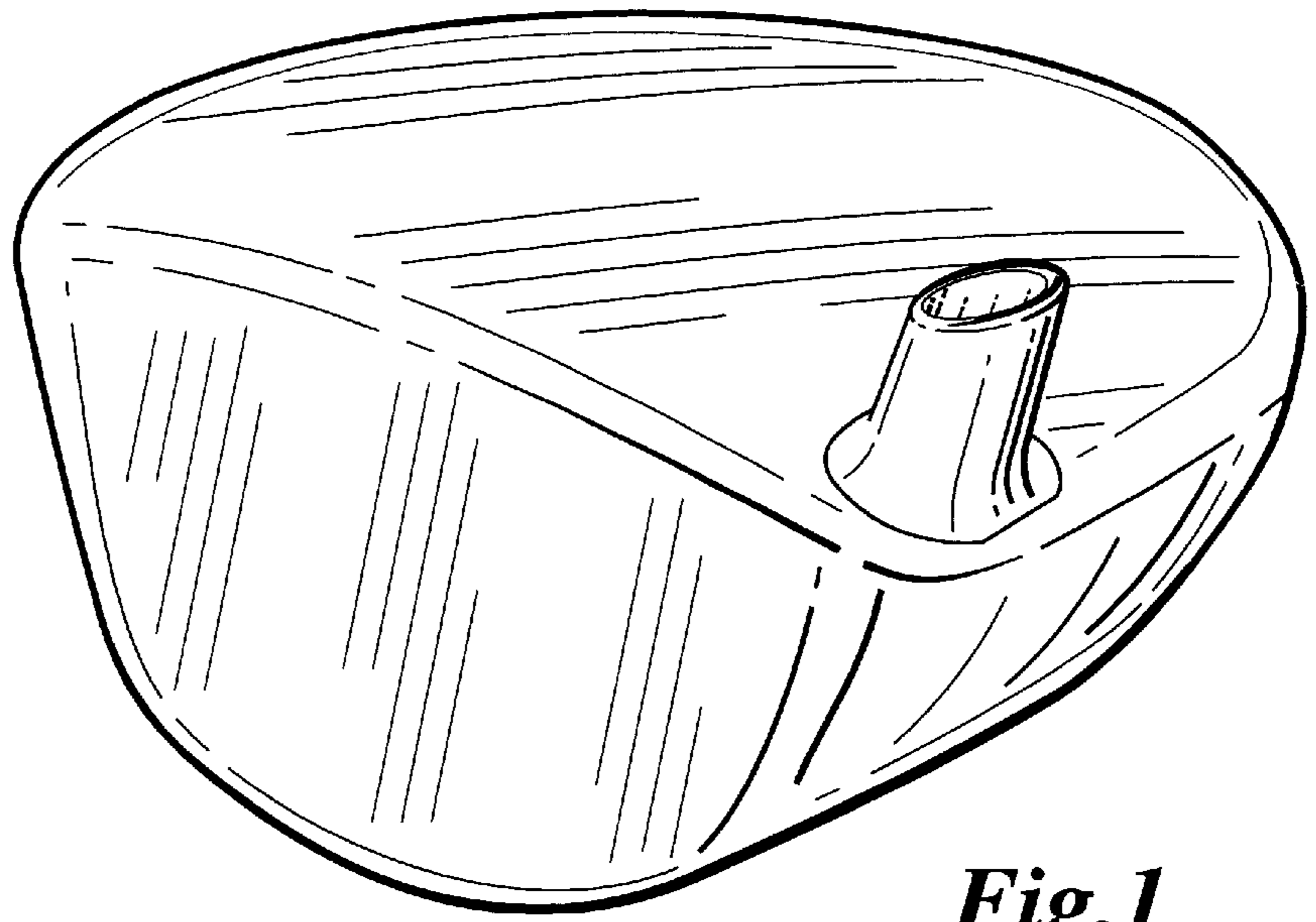

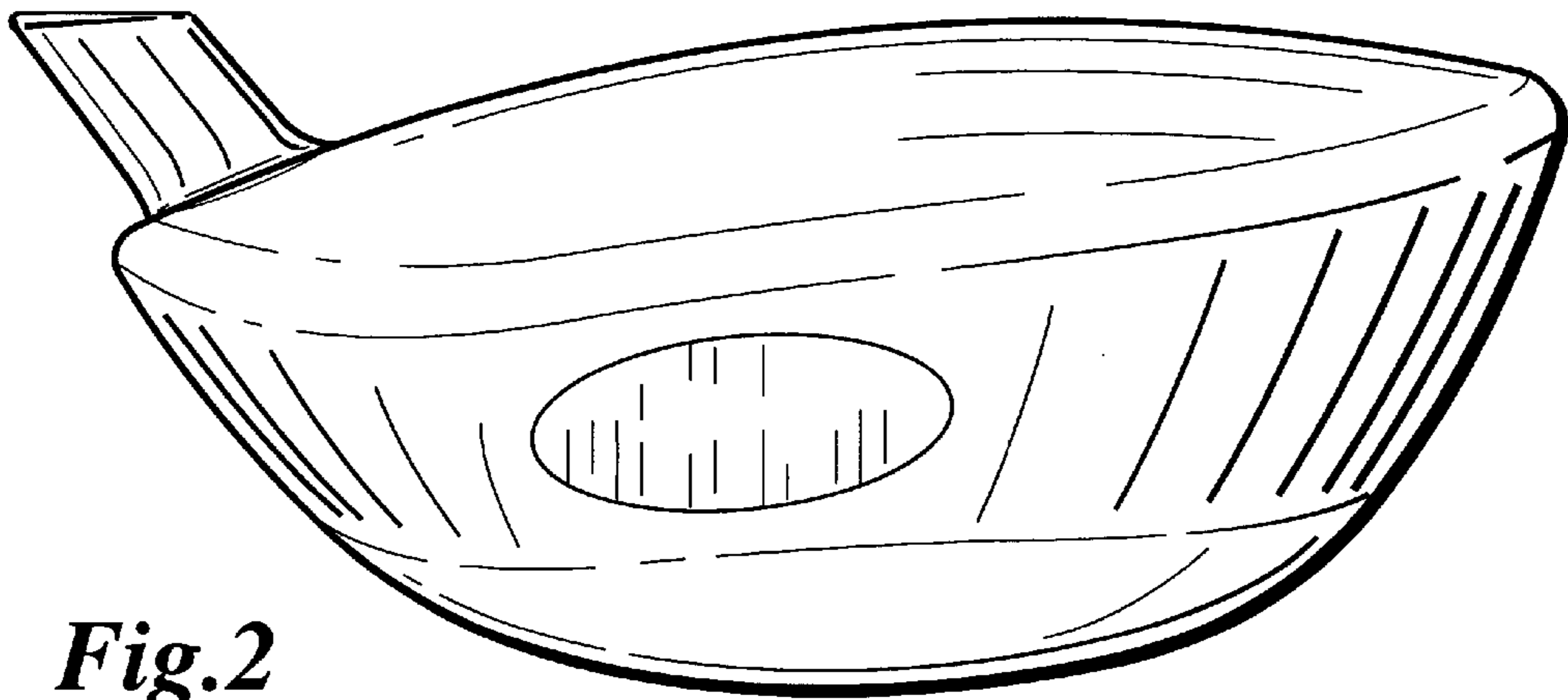

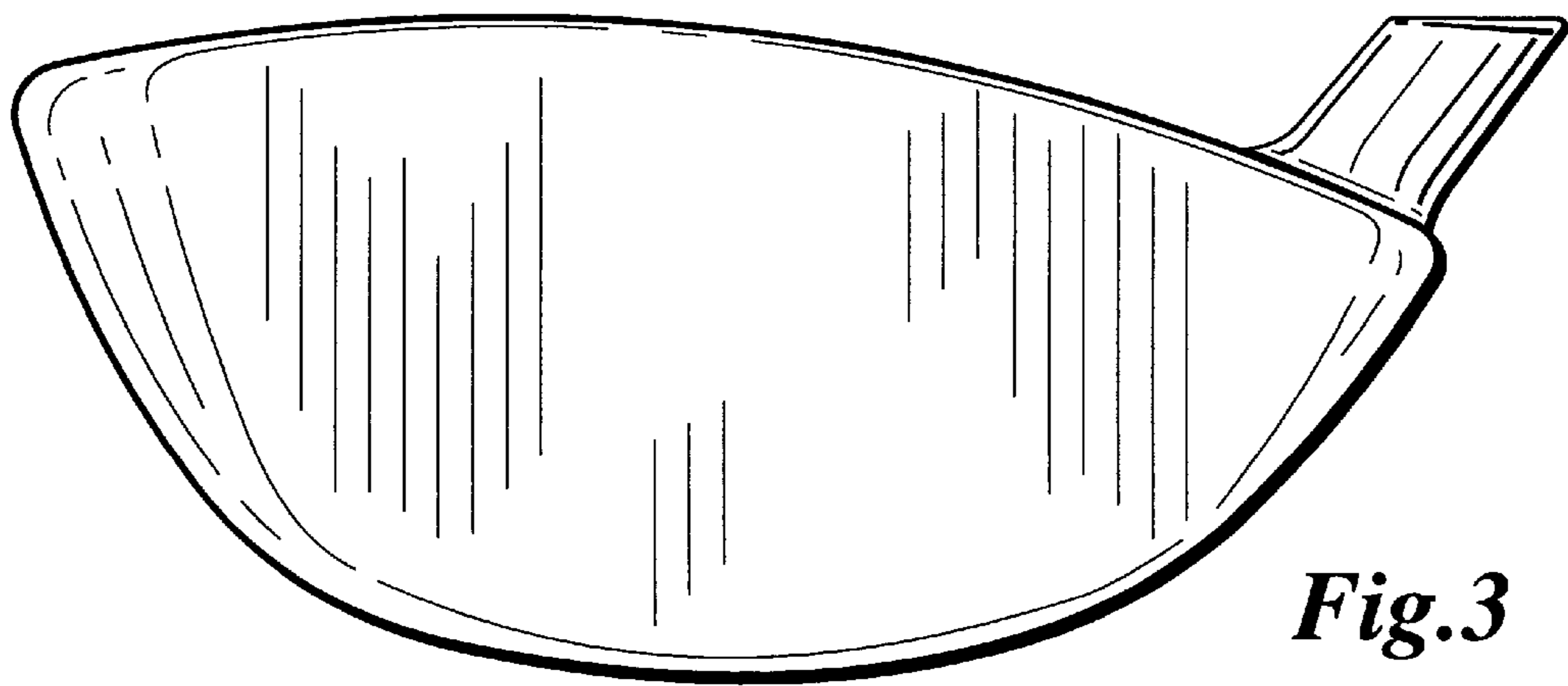




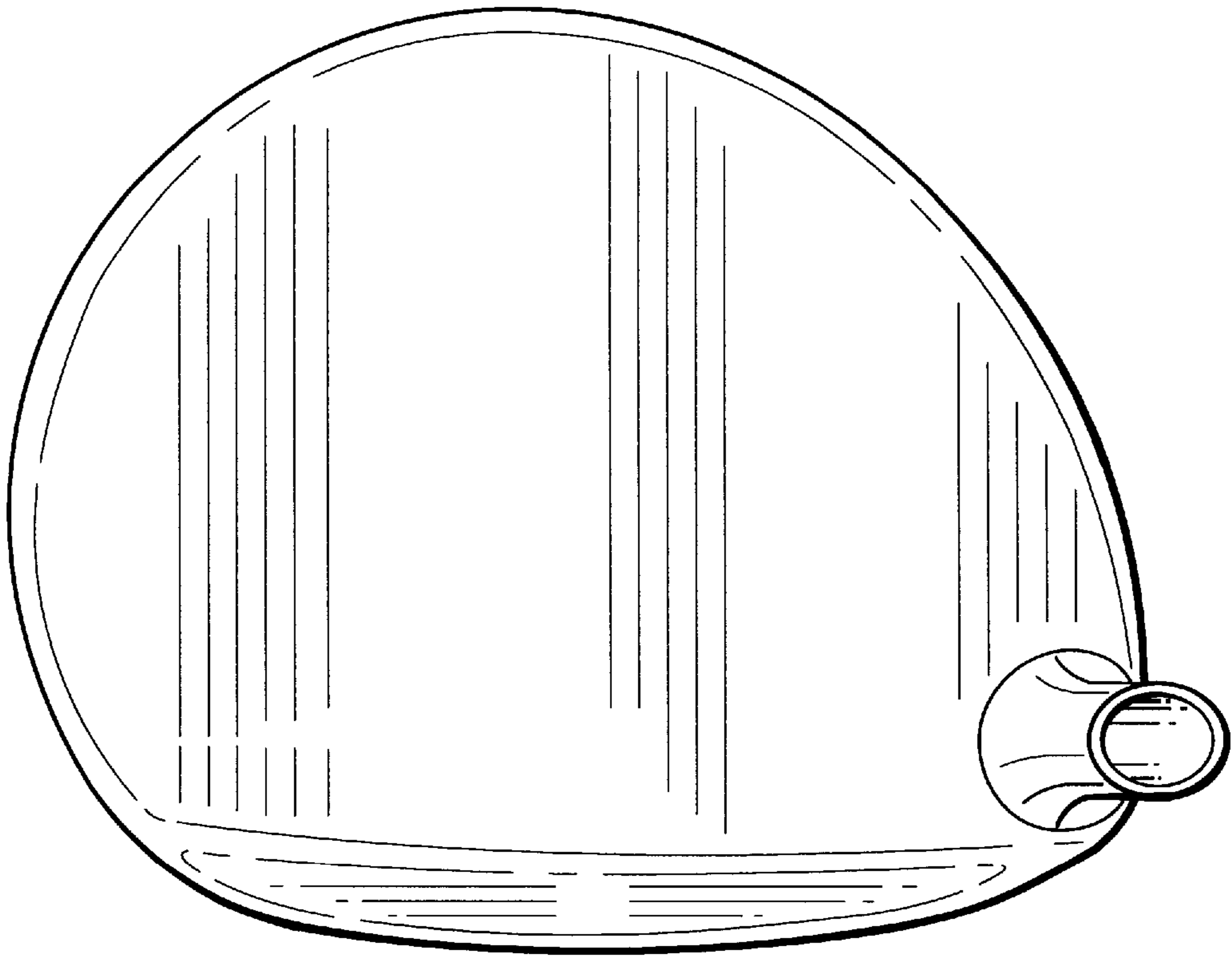

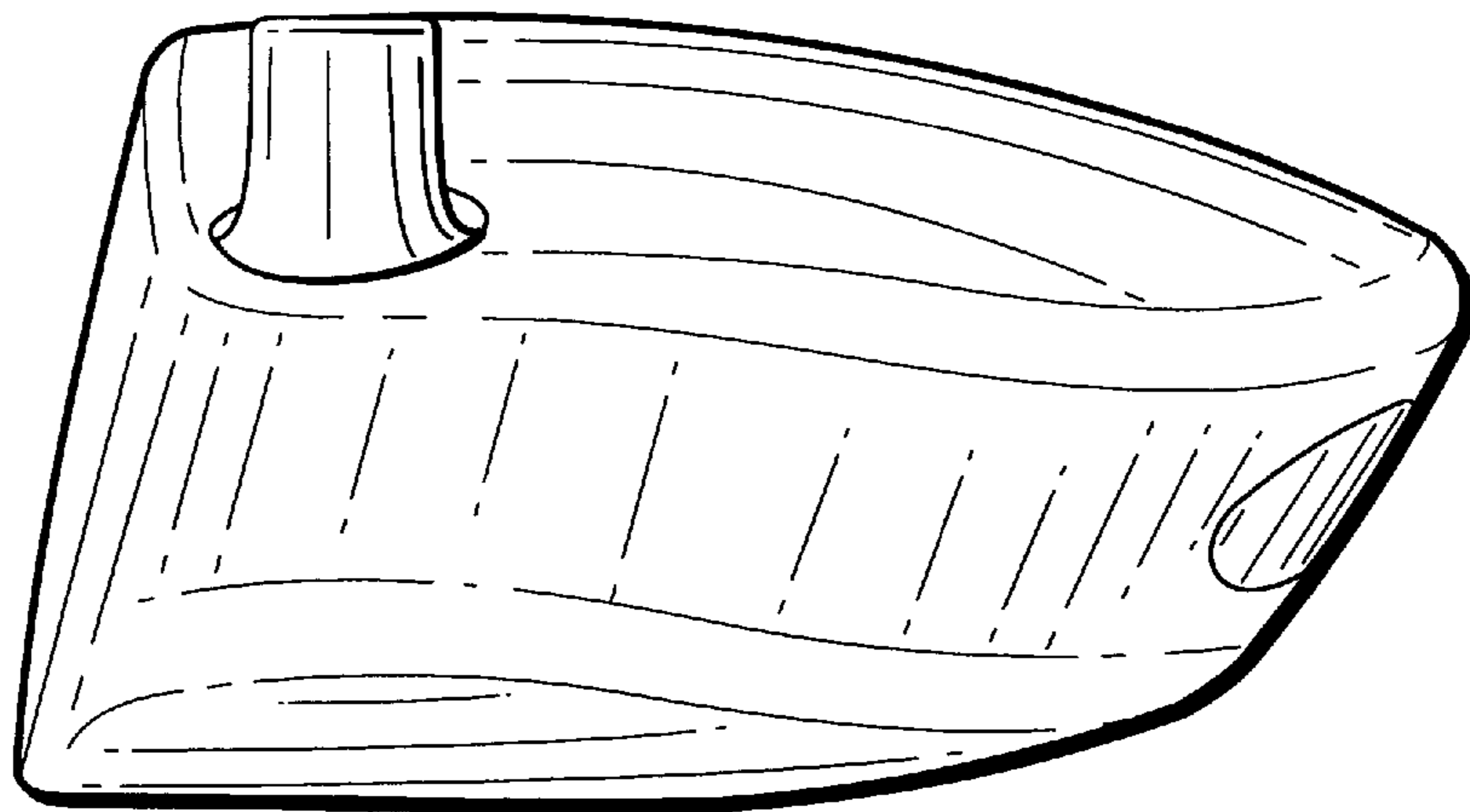

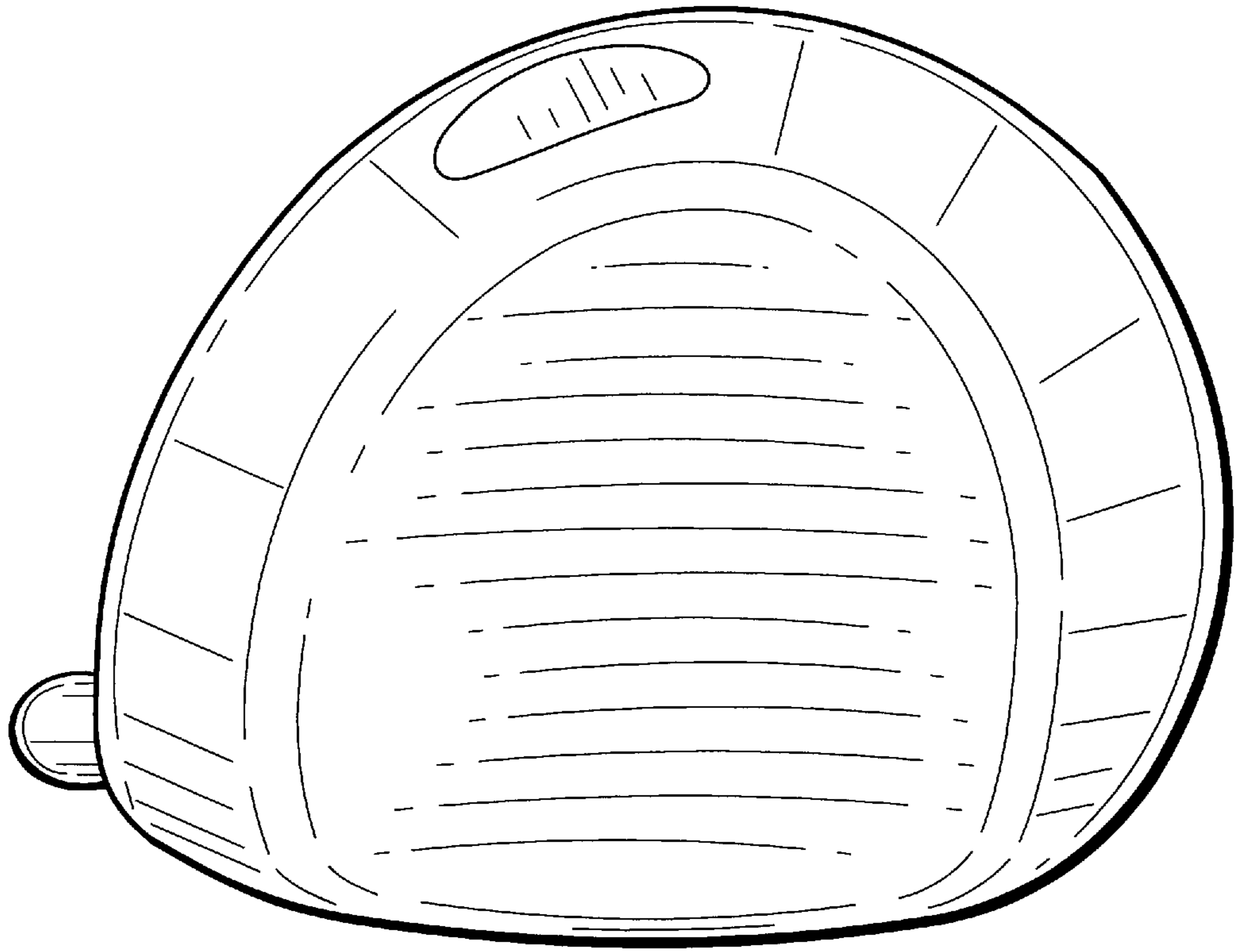

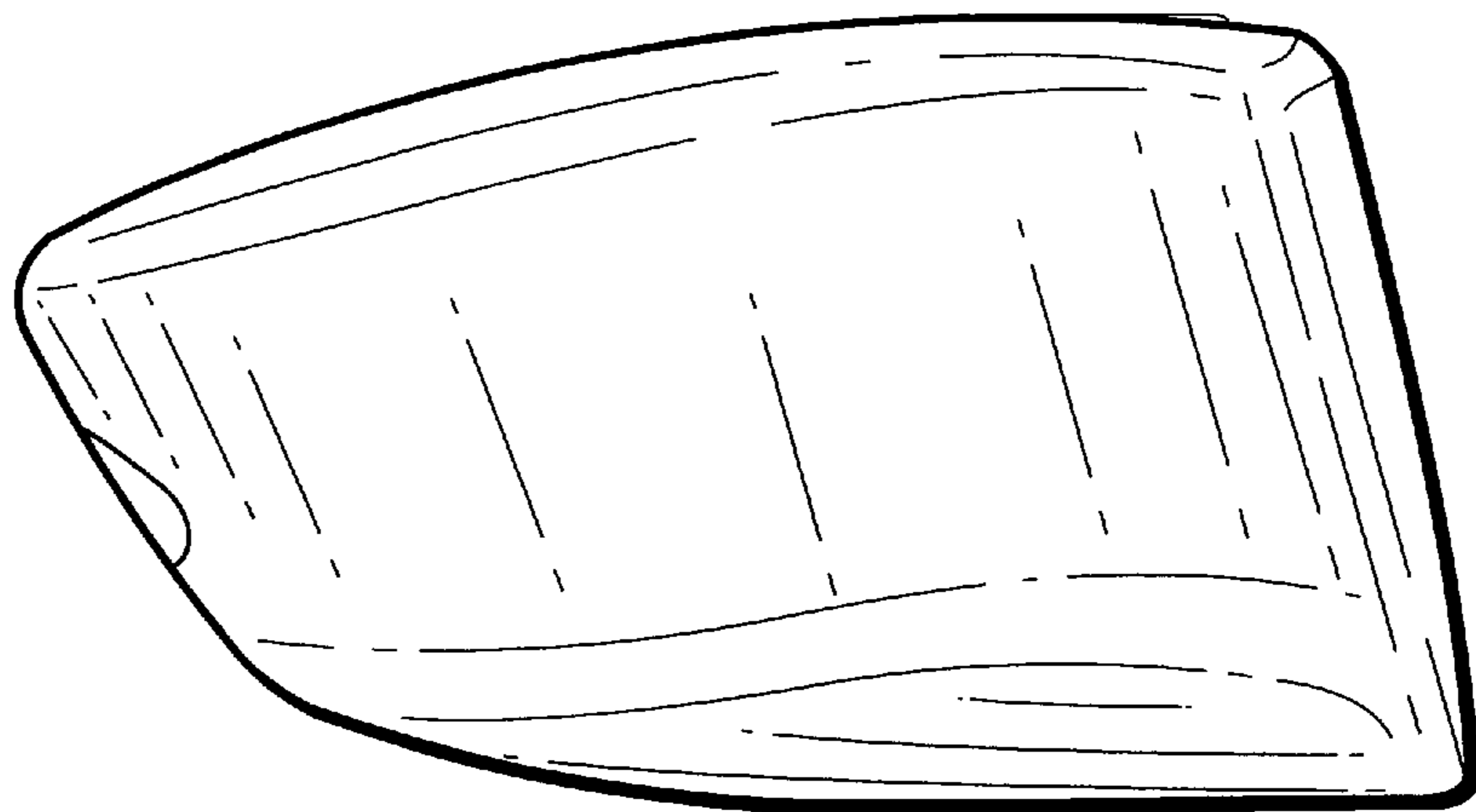
