[57] **CLAIM**

The ornamental design for a pair of shoe soles, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view of the design of the pair of shoe soles of the invention;
 FIG. 2 is a top view of the design of the pair of shoe soles of FIG. 1;
 FIG. 3 is a side view of the outer portion of the shoe sole of the left shoe of FIG. 1;
 FIG. 4 is a side view of the inner portion of the shoe sole of the left shoe of FIG. 1;
 FIG. 5 is a side view of the outer portion of the right shoe of FIG. 1;
 FIG. 6 is a side view of the inner portion of the shoe sole of the right shoe of FIG. 1;
 FIG. 7 is a front view of the design of the pair of shoe soles of FIG. 1;
 FIG. 8 is a rear view of the design of the pair of shoe soles of FIG. 1; and,
 FIG. 9 is a bottom perspective view of the design of the pair of shoe soles of FIG. 1.

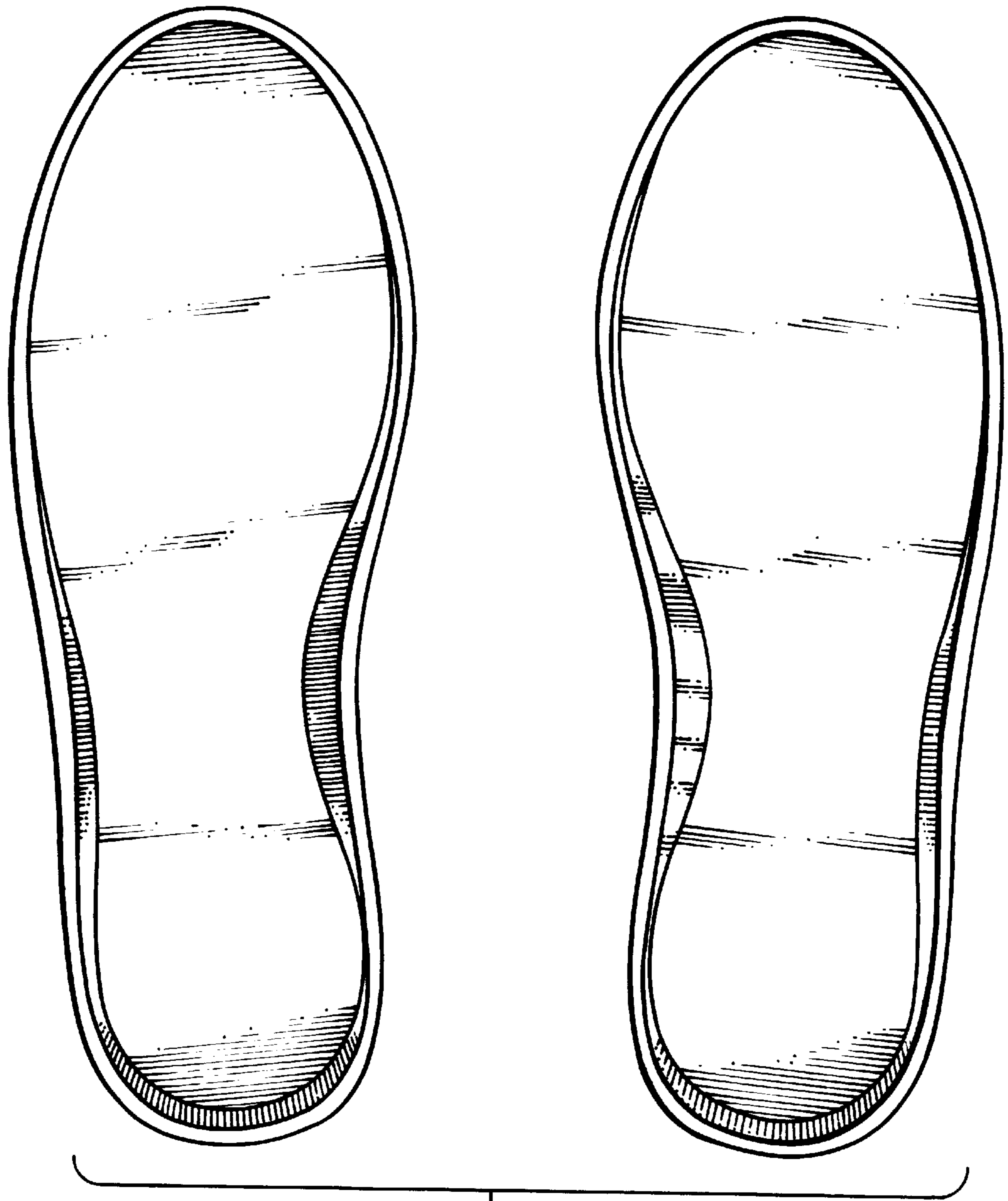

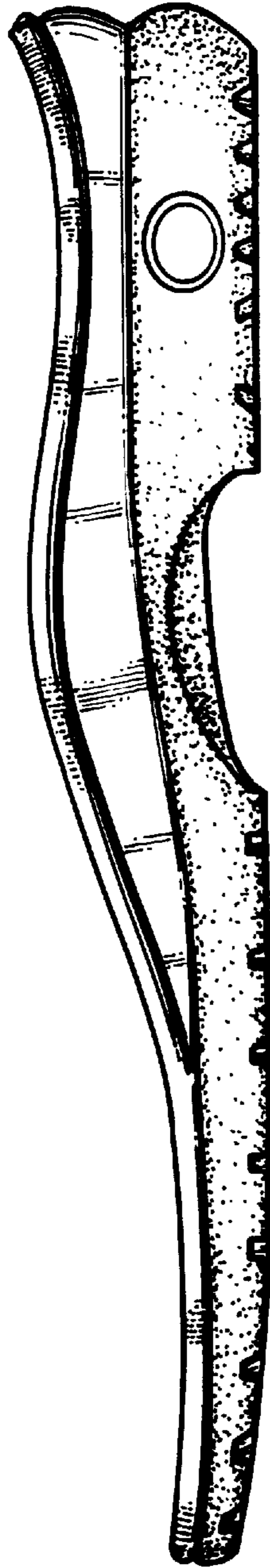

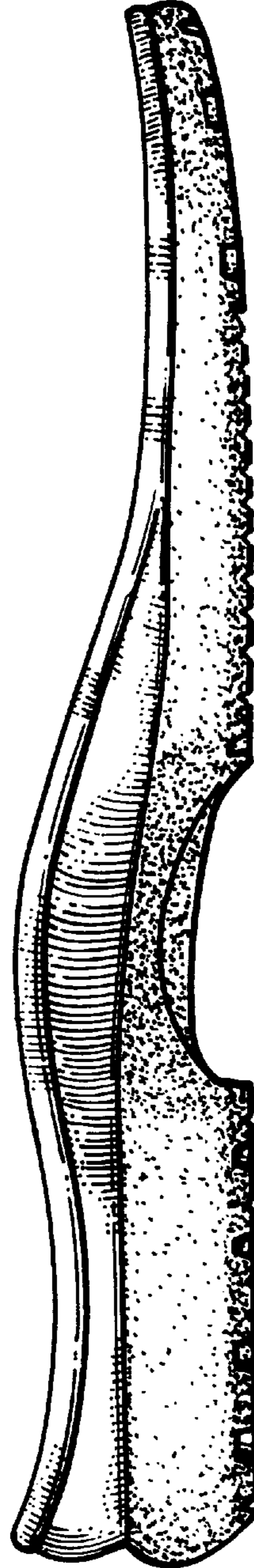

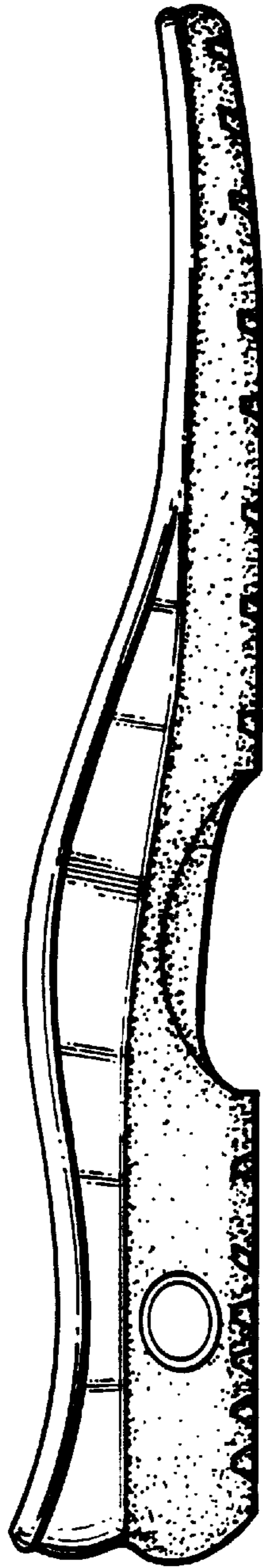

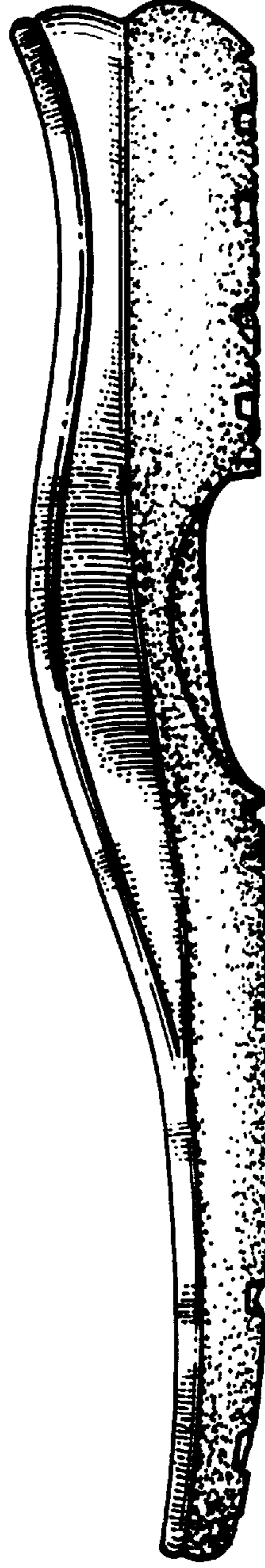

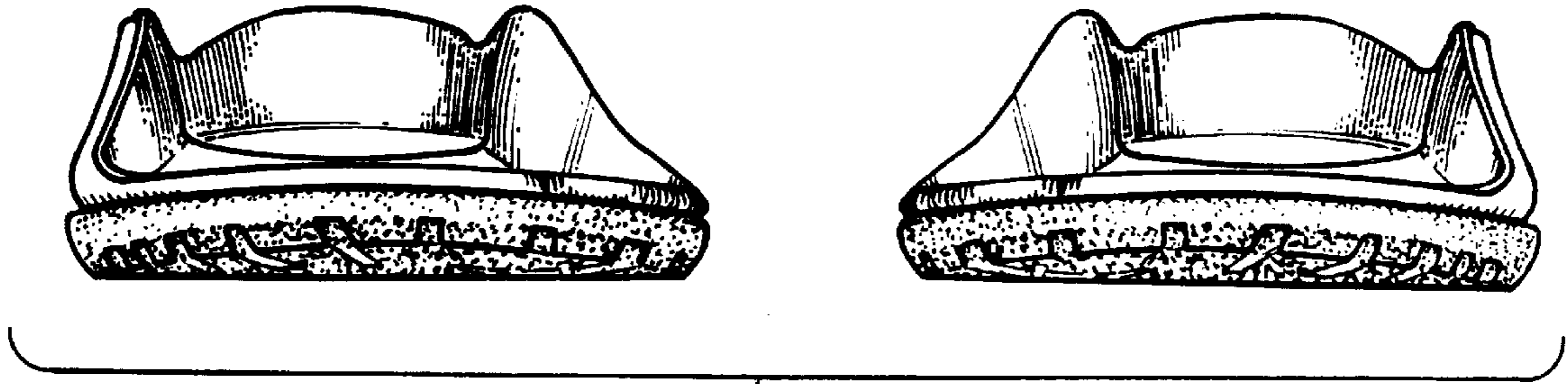

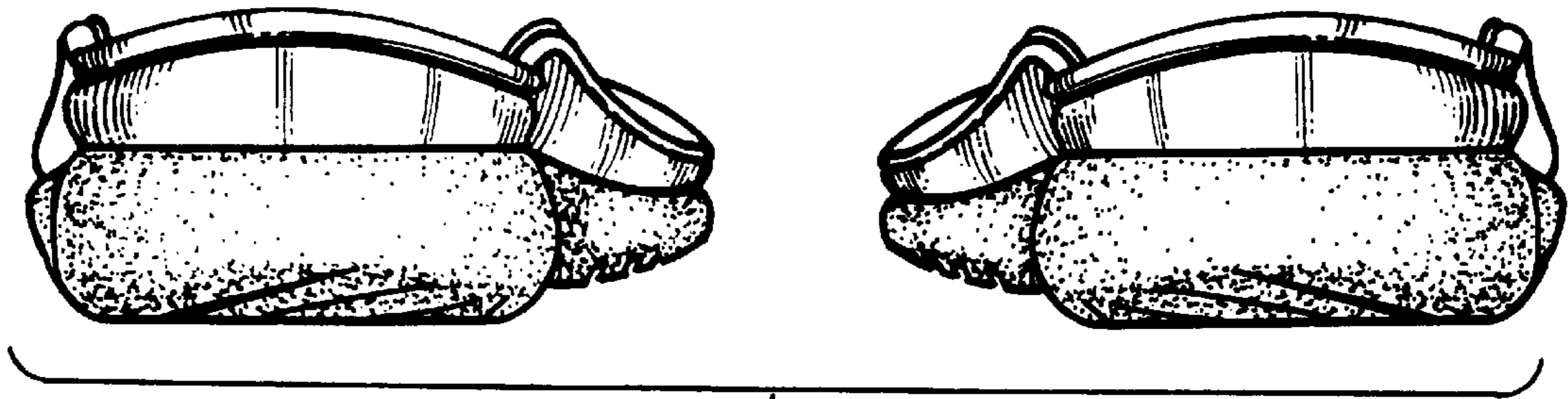
