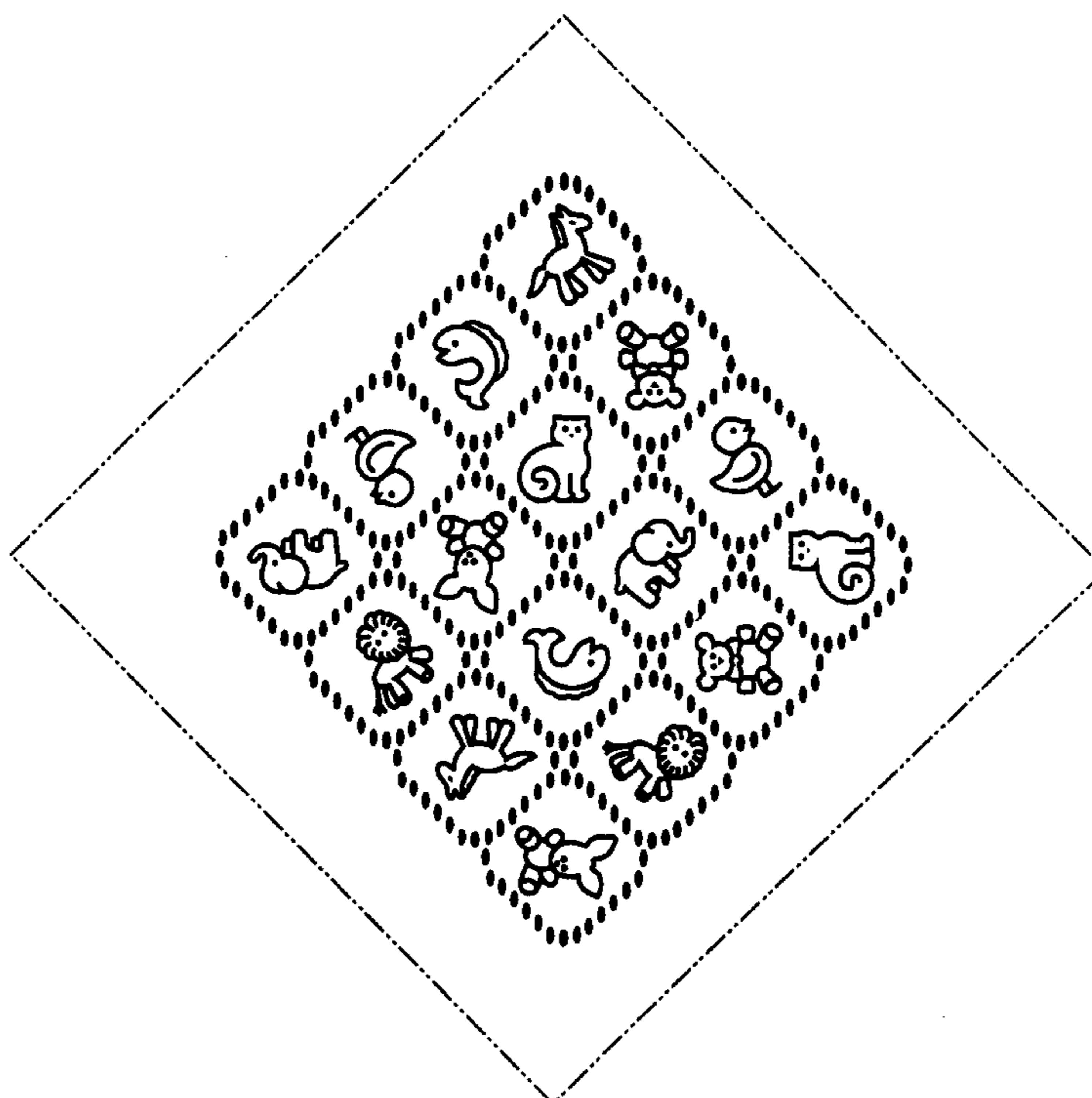
[57] **CLAIM**

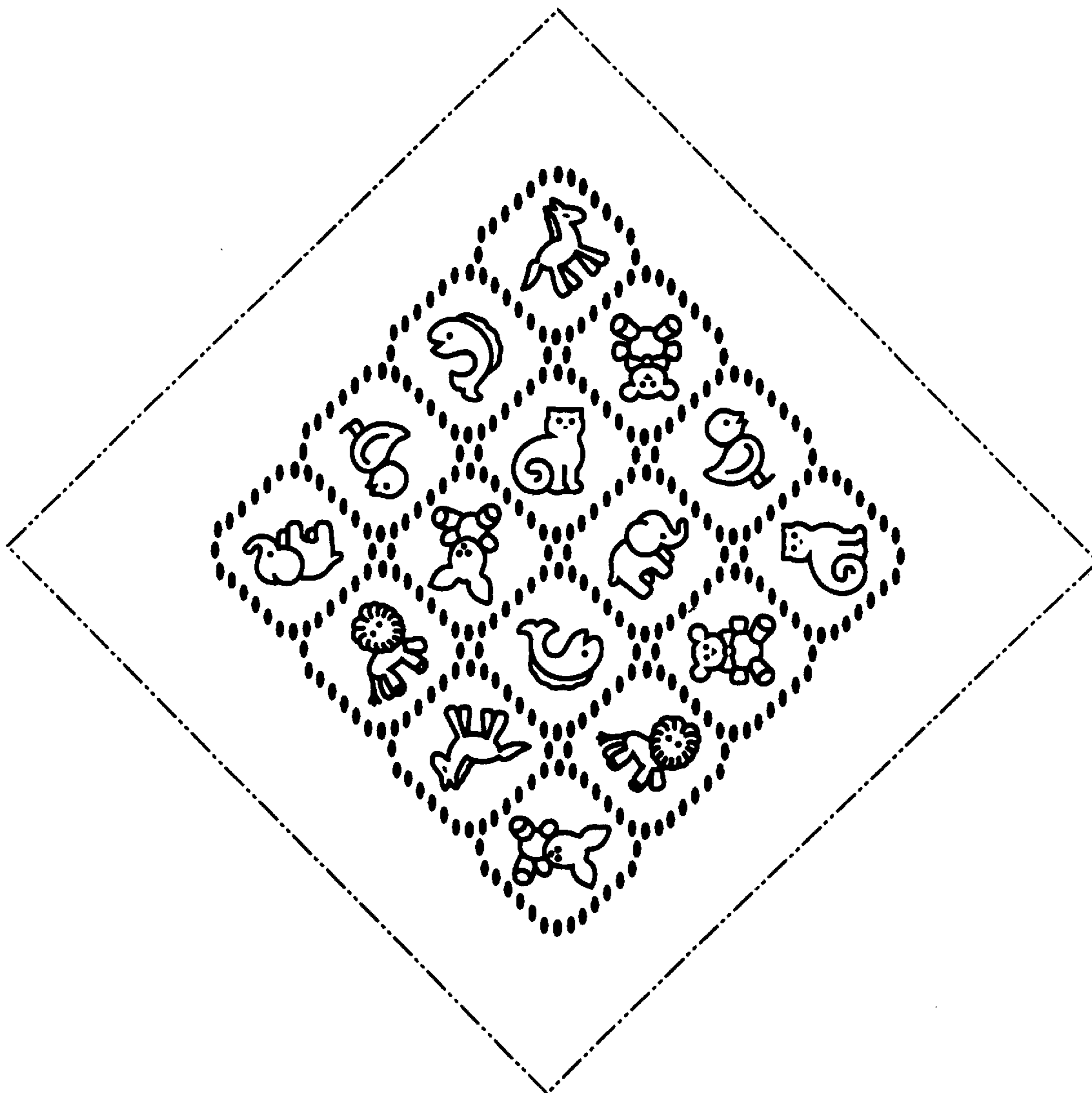
The ornamental design for pattern for a nonwoven wipe, as shown and described.

**DESCRIPTION**

The sole FIGURE is a top plan view of pattern for a nonwoven wipe embodying our new design. The broken line shown in the FIGURE depicts the non nonwoven wipe to which the pattern is applied, and encloses a repeat unit of the embossed pattern.
