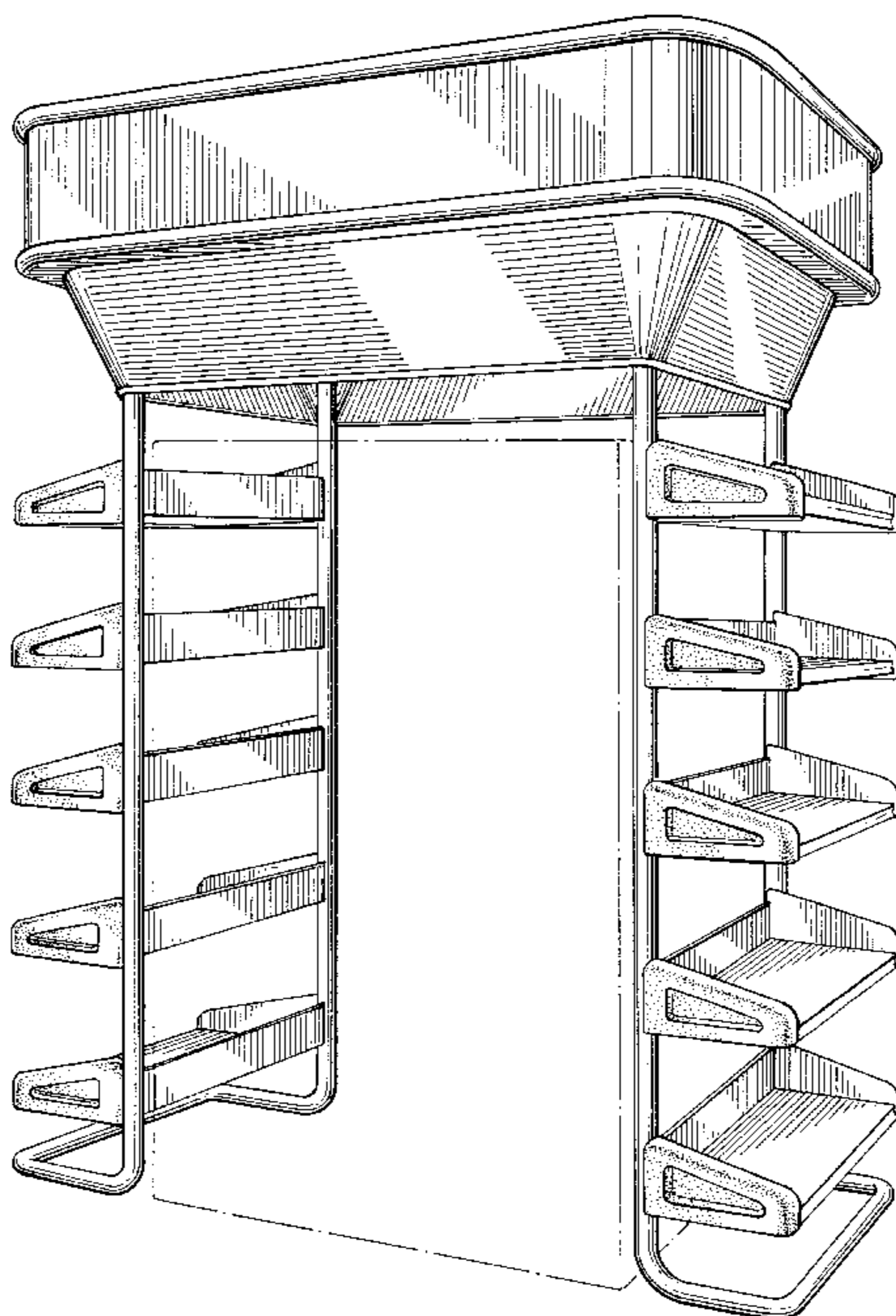
### [57] CLAIM

The ornamental design for a side saddle merchandiser, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a side saddle merchandiser showing our new design, with environmental structure shown in broken lines for purposes of illustration only and forming no part of the claimed design; FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof; FIG. 3 is a side elevational view thereof, the opposite side being a mirror image thereof; FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom plan view thereof.

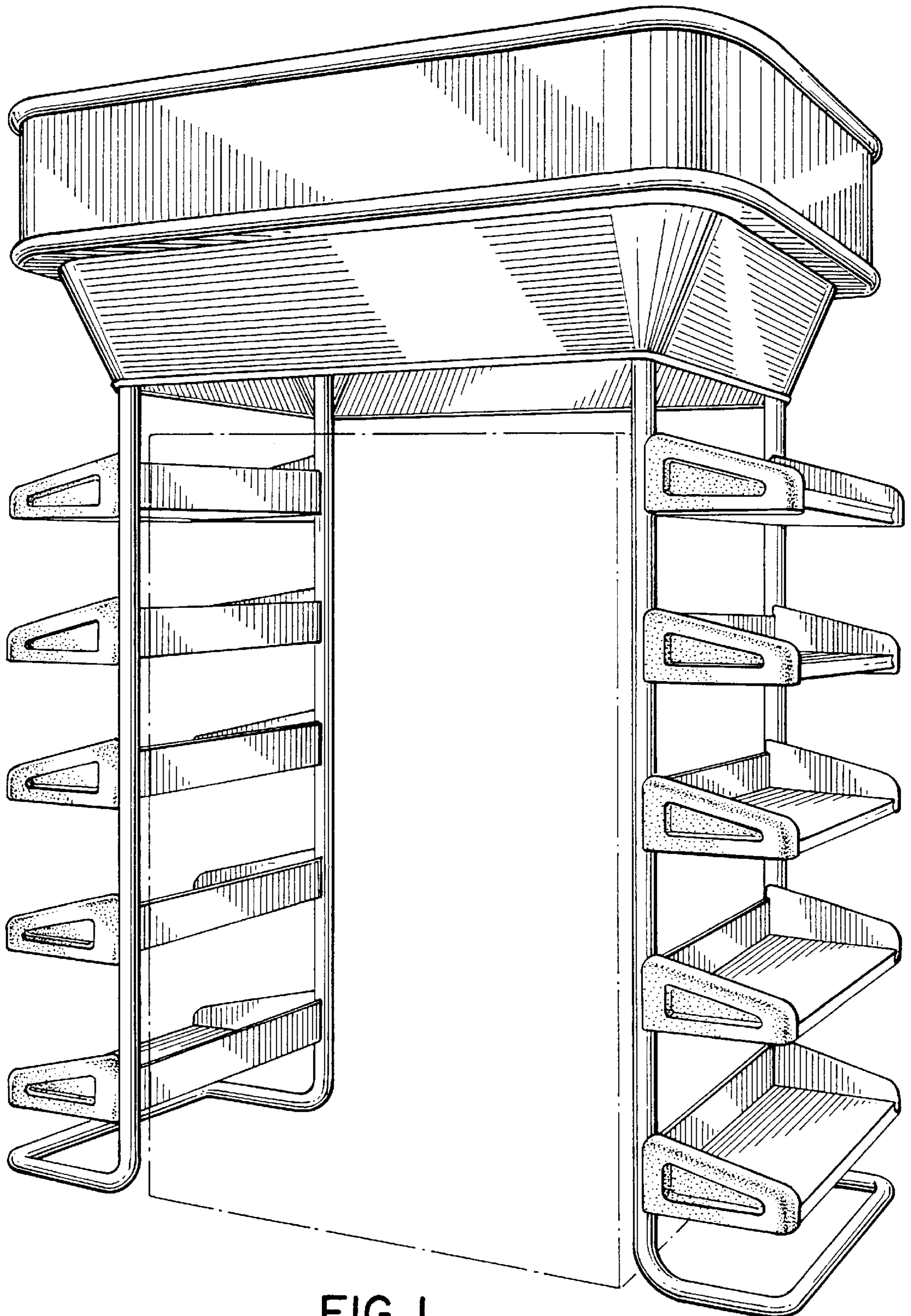

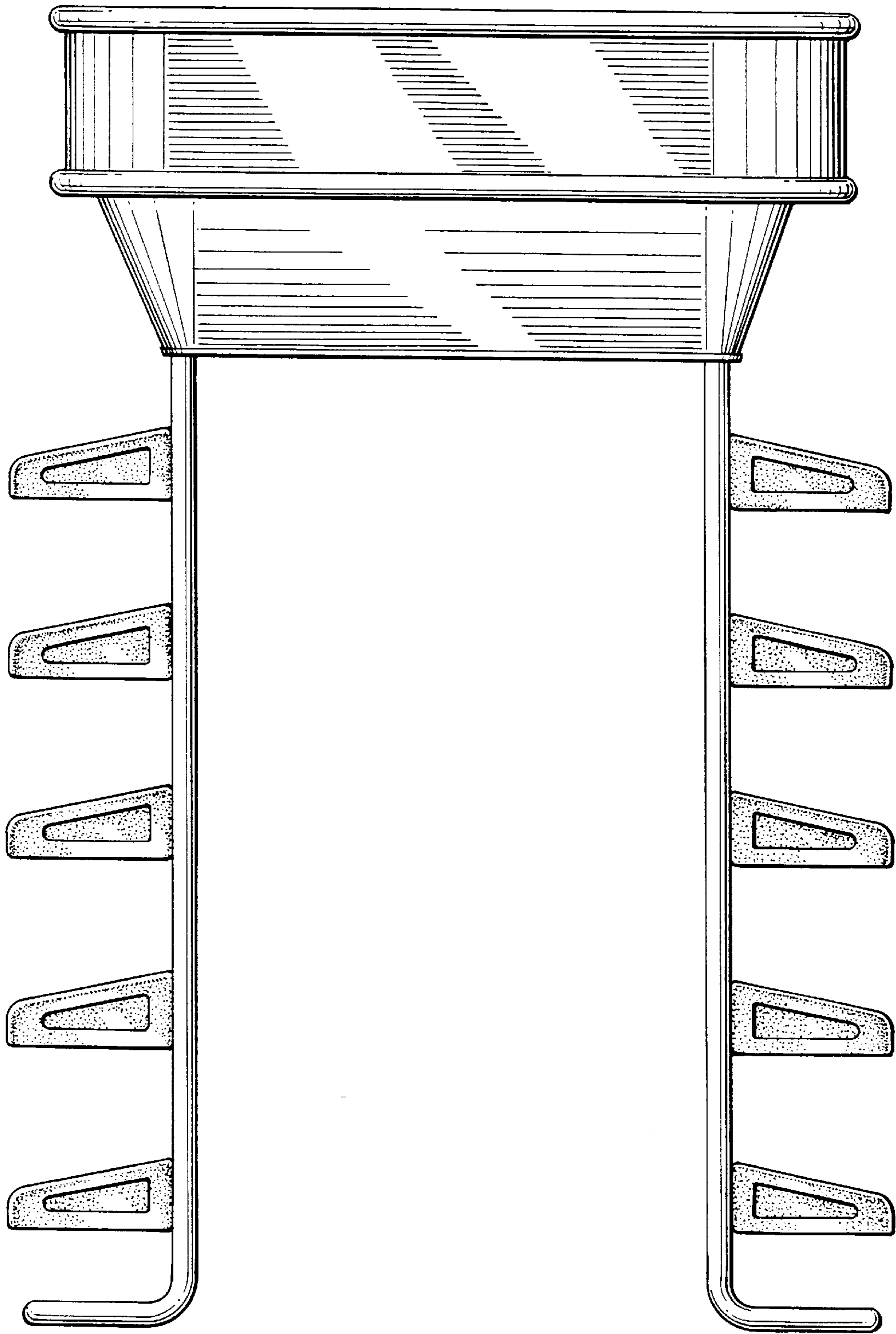

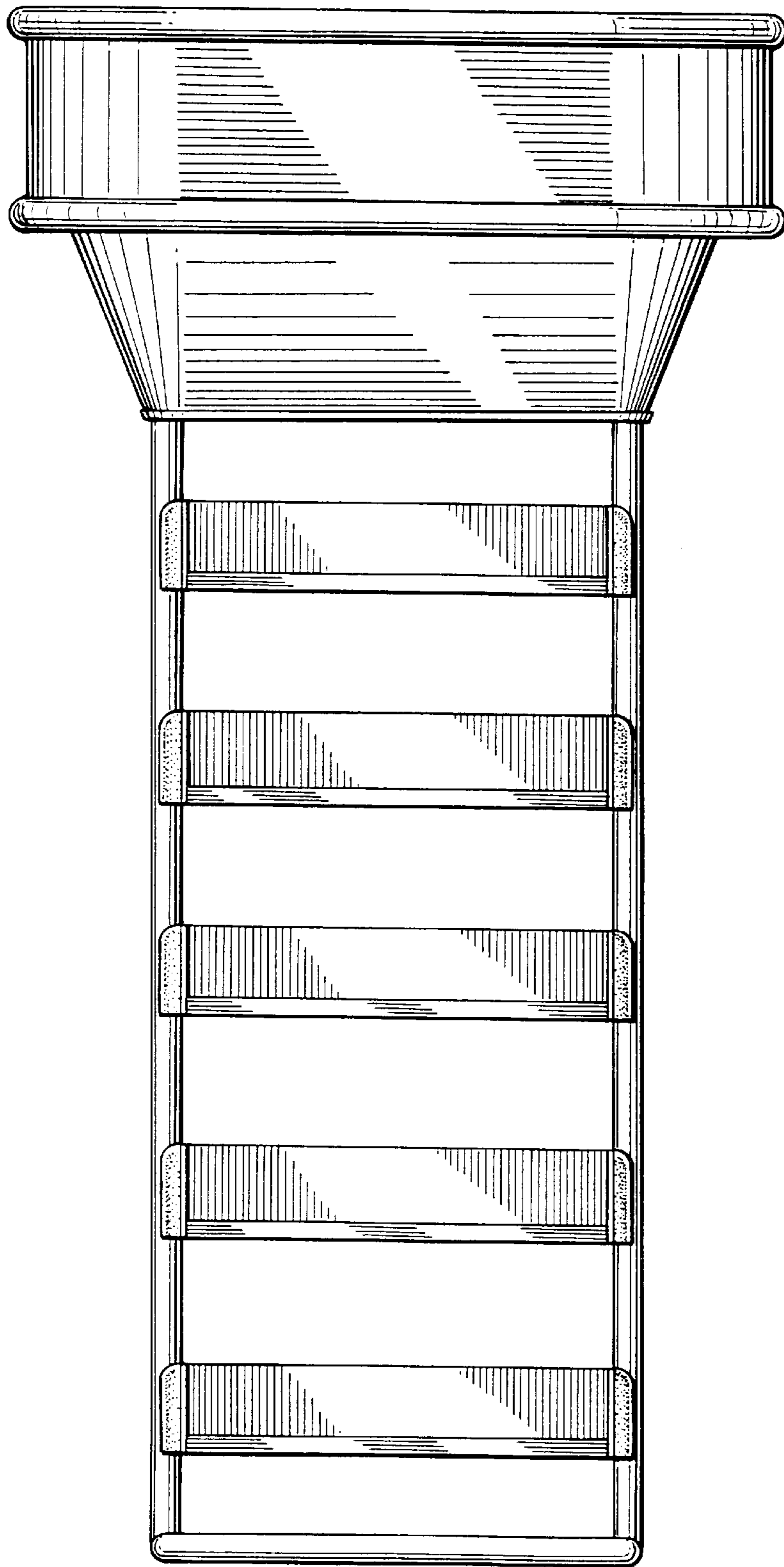

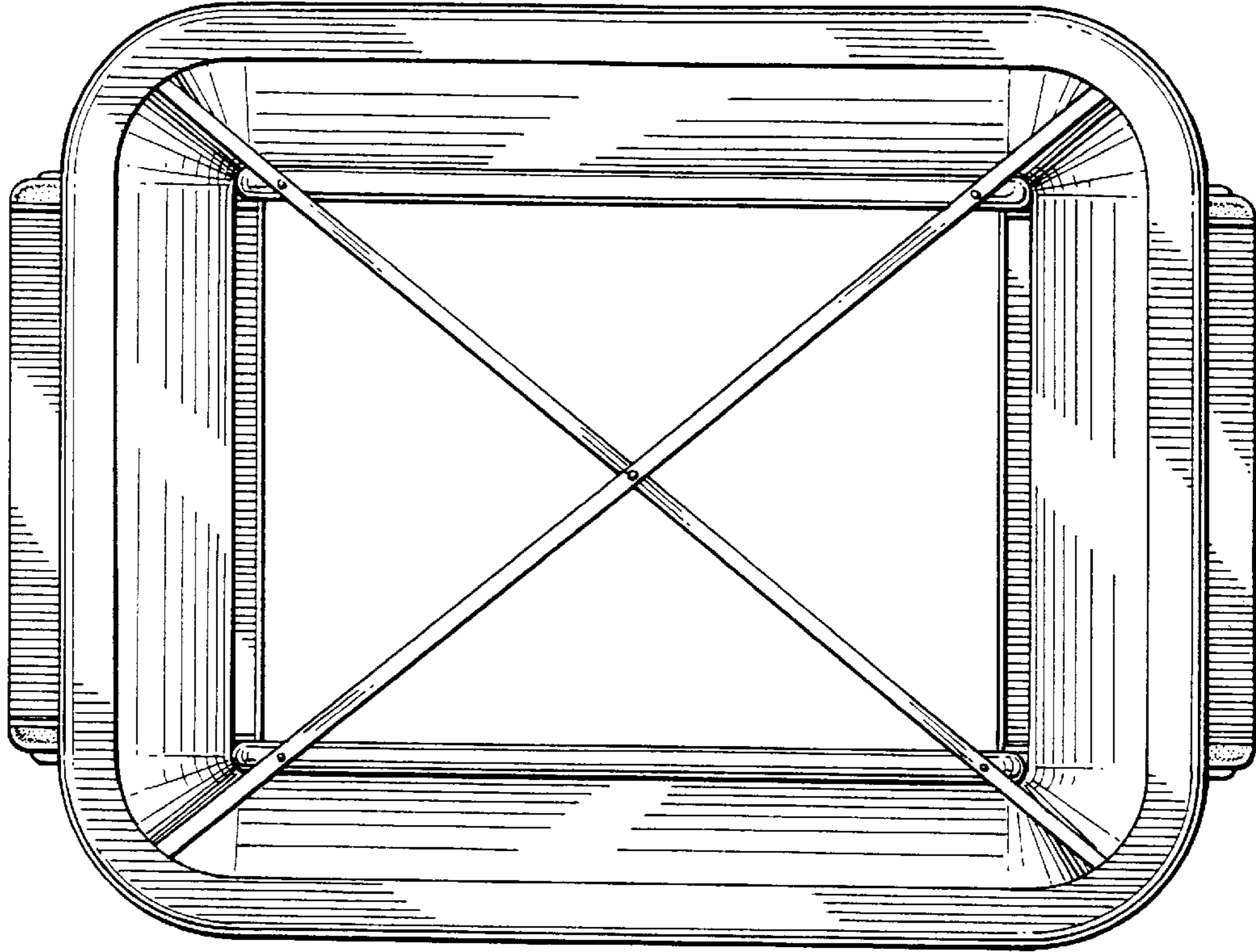

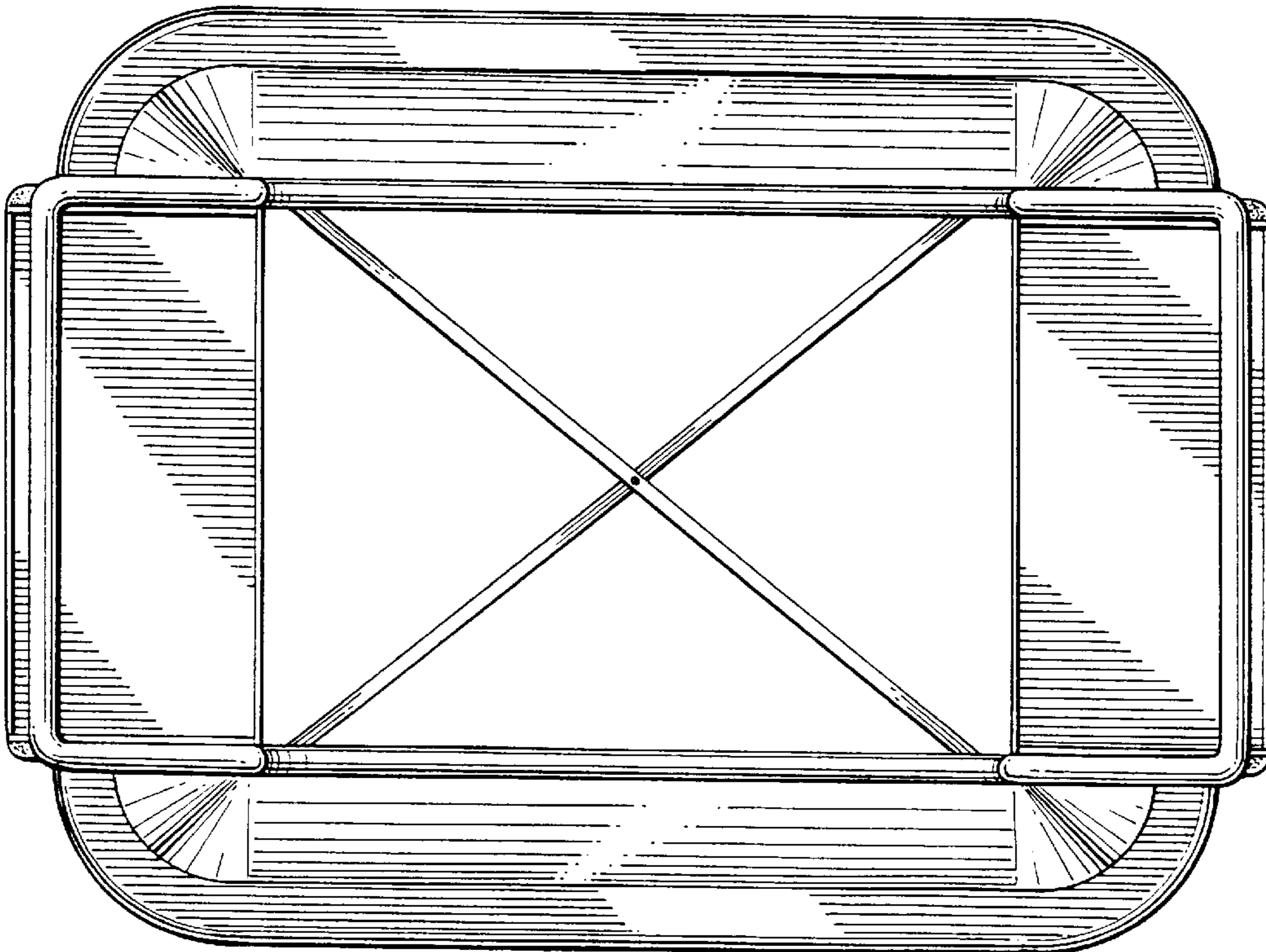
