[57] **CLAIM**

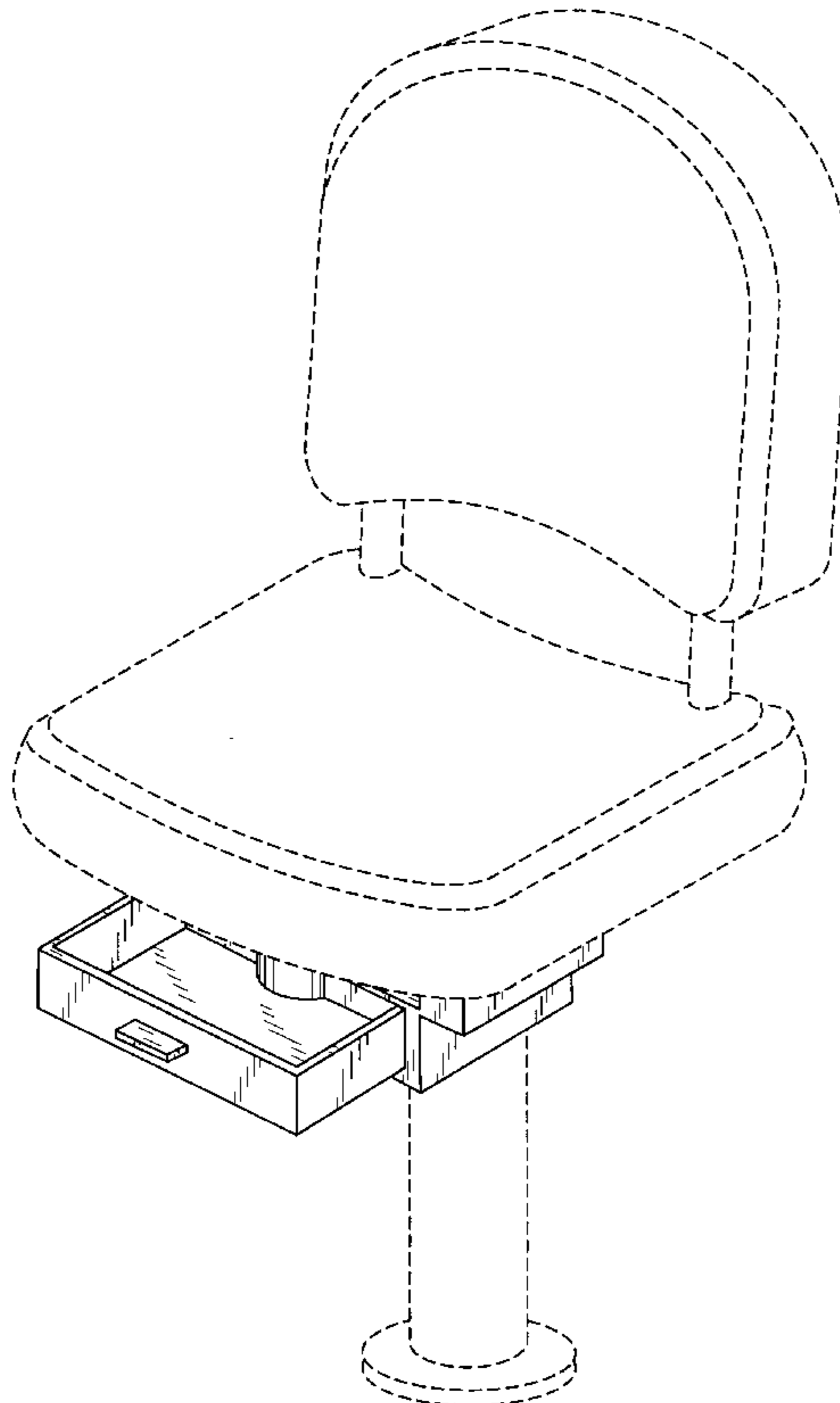
The ornamental design for an under seat tackle box, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an under seat tackle box showing my new design;
FIG. 2 is a perspective view thereof, shown without the environmental structure;
FIG. 3 is a right side elevational view thereof, the opposite side being a mirror image;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is a perspective view thereof, shown with the drawer closed.

The broken line illustration shows environmental structure and forms no part of the claimed invention.
The portions of the under seat tackle box which have not been shown or described form no part of the claimed design.
FIGS. 2 through 8 have been shown on an enlarged scale with respect to FIG. 1.

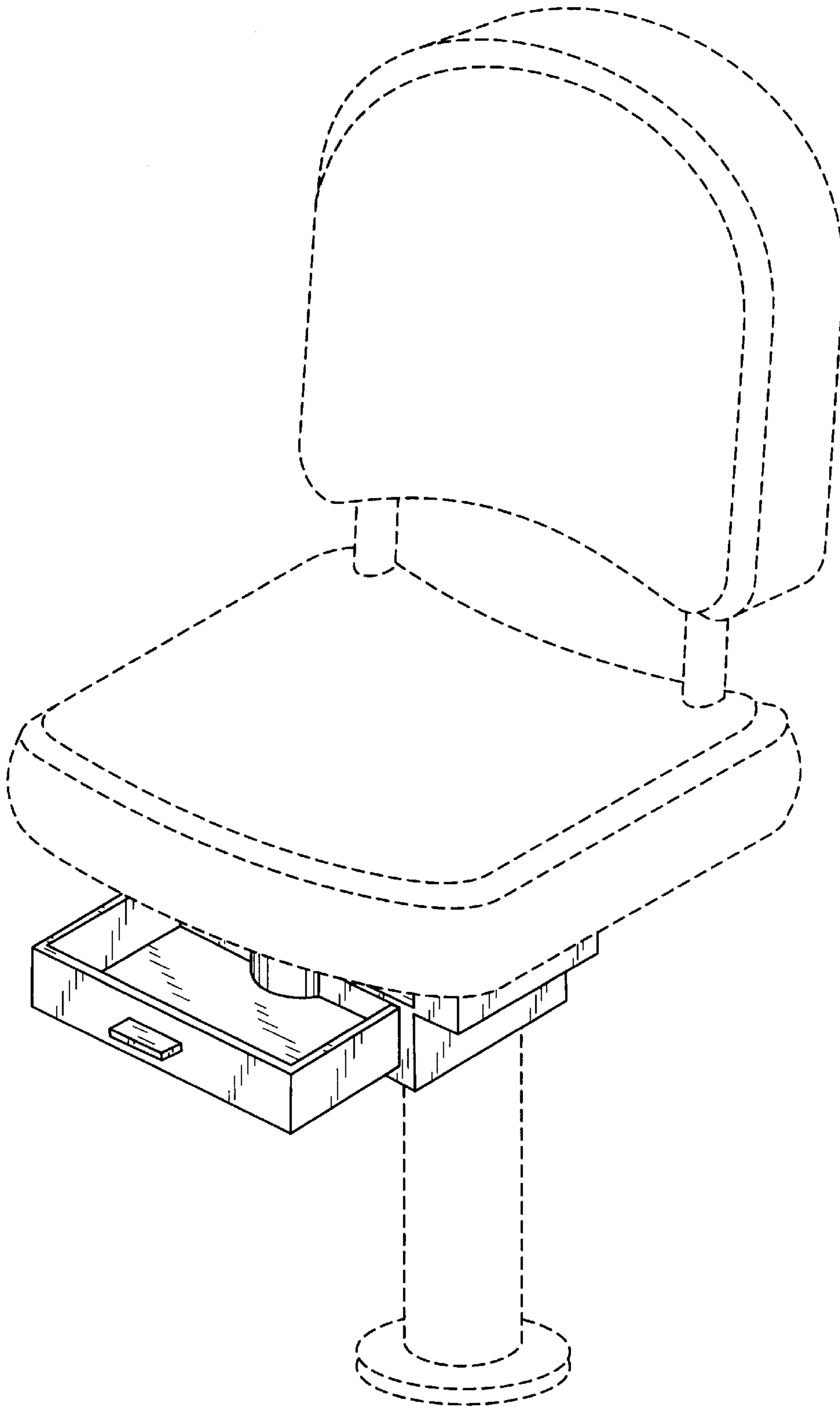

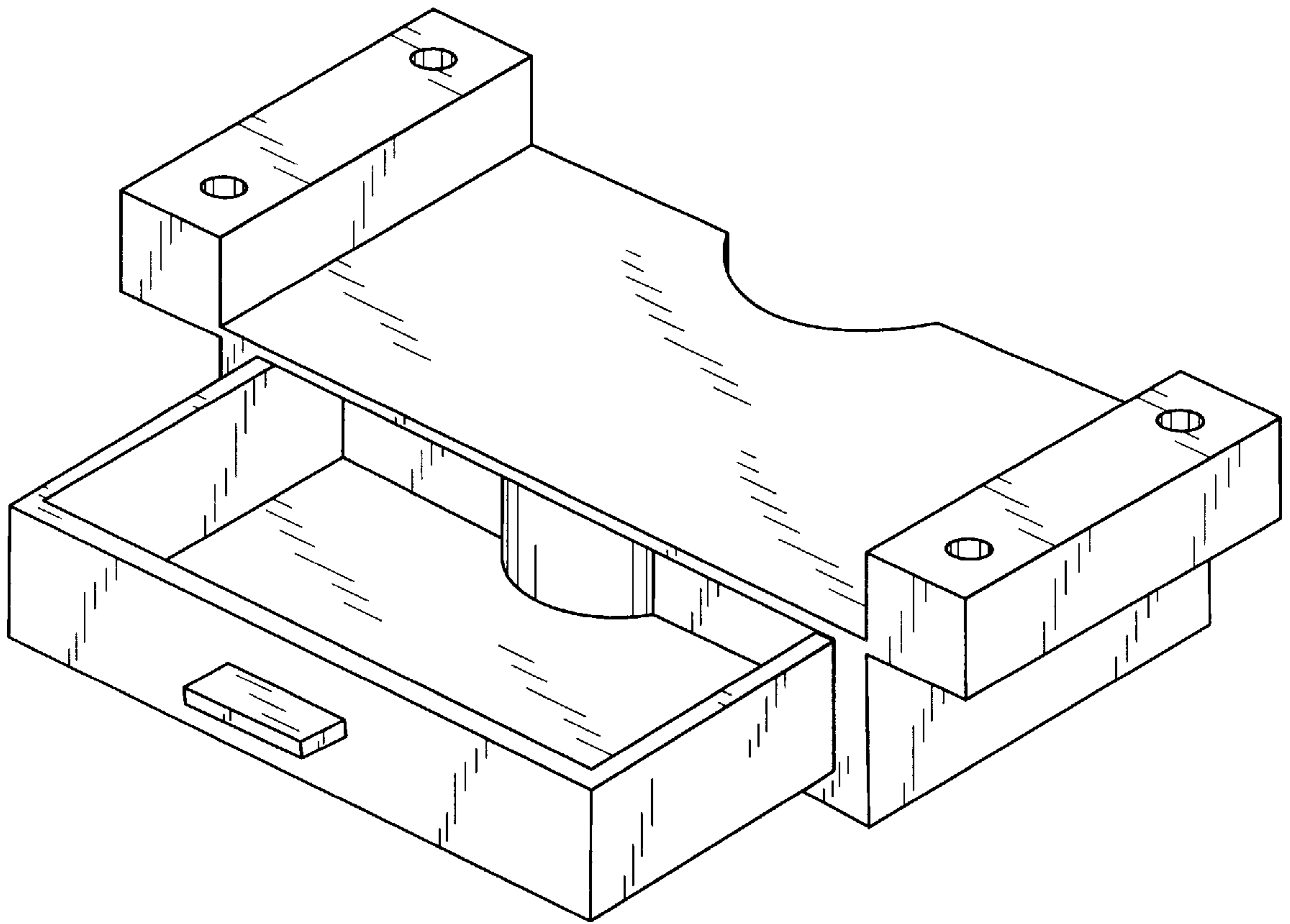

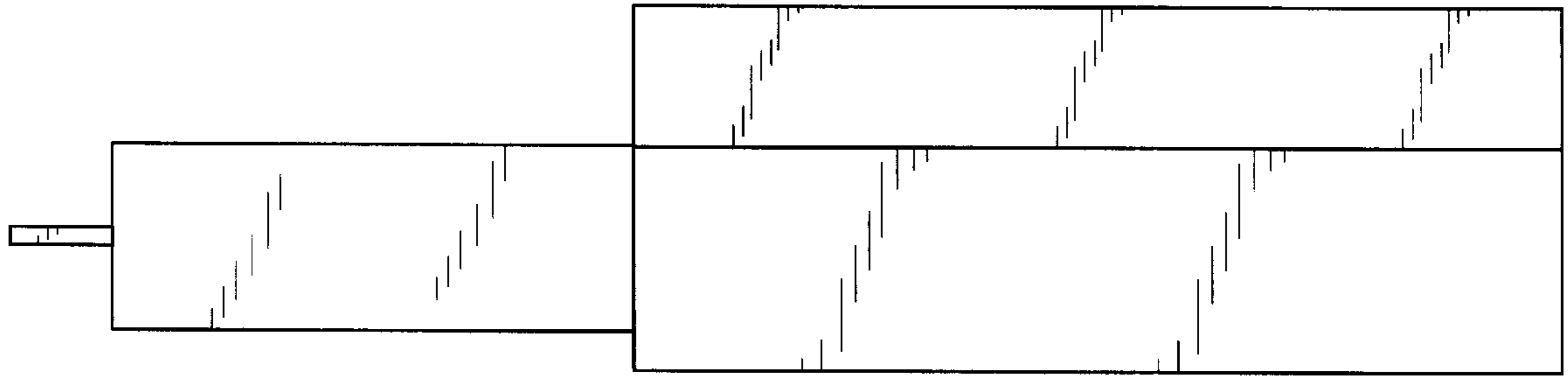

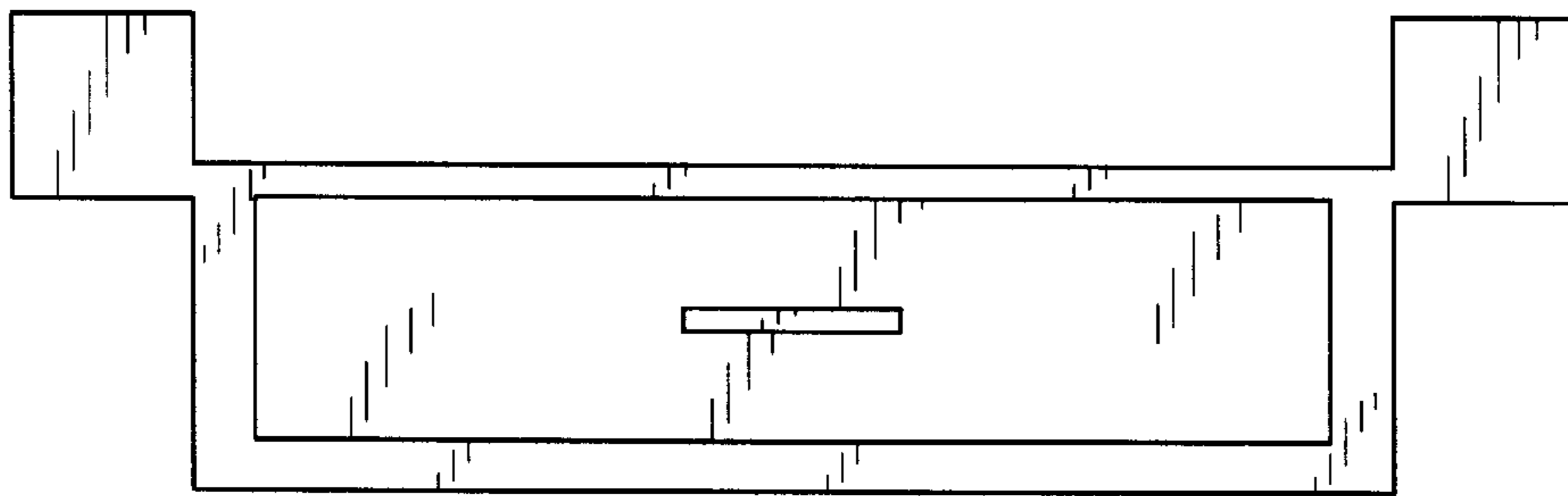

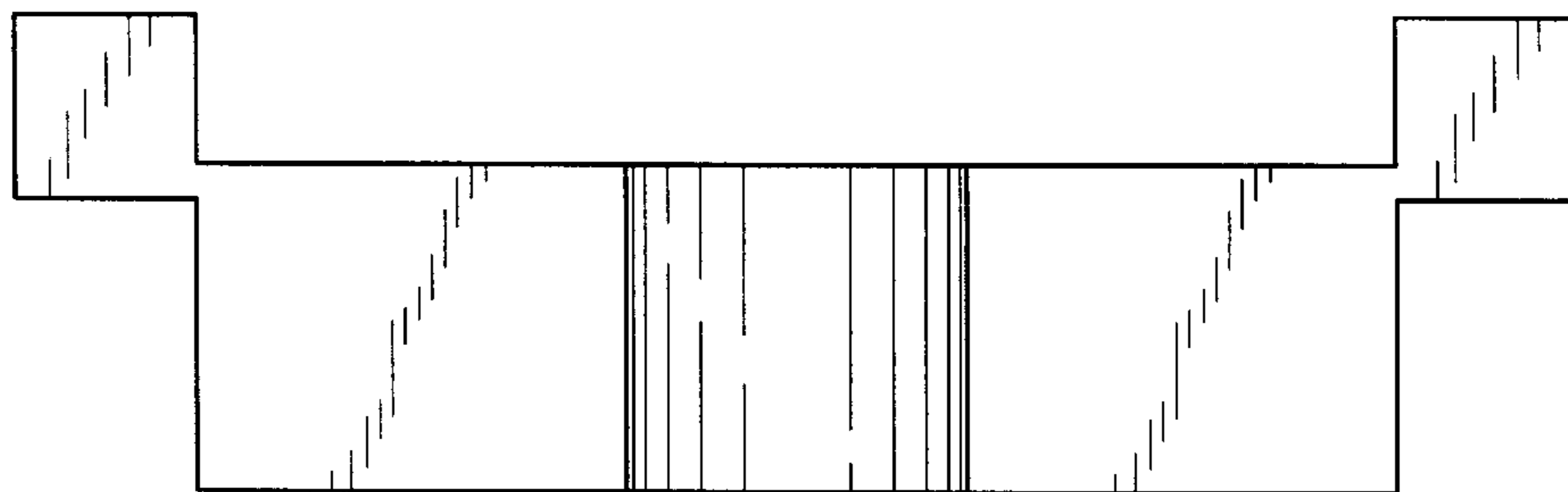

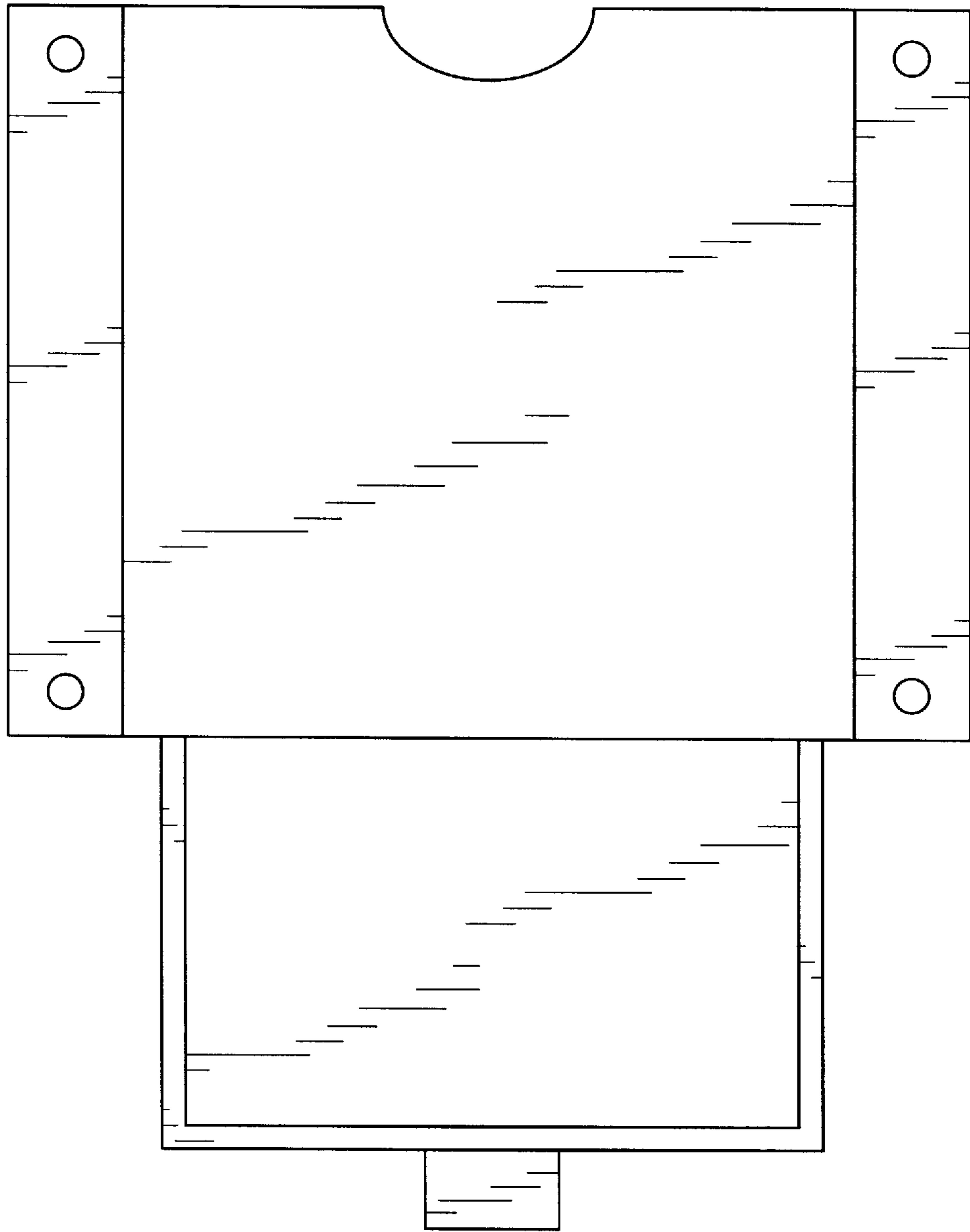

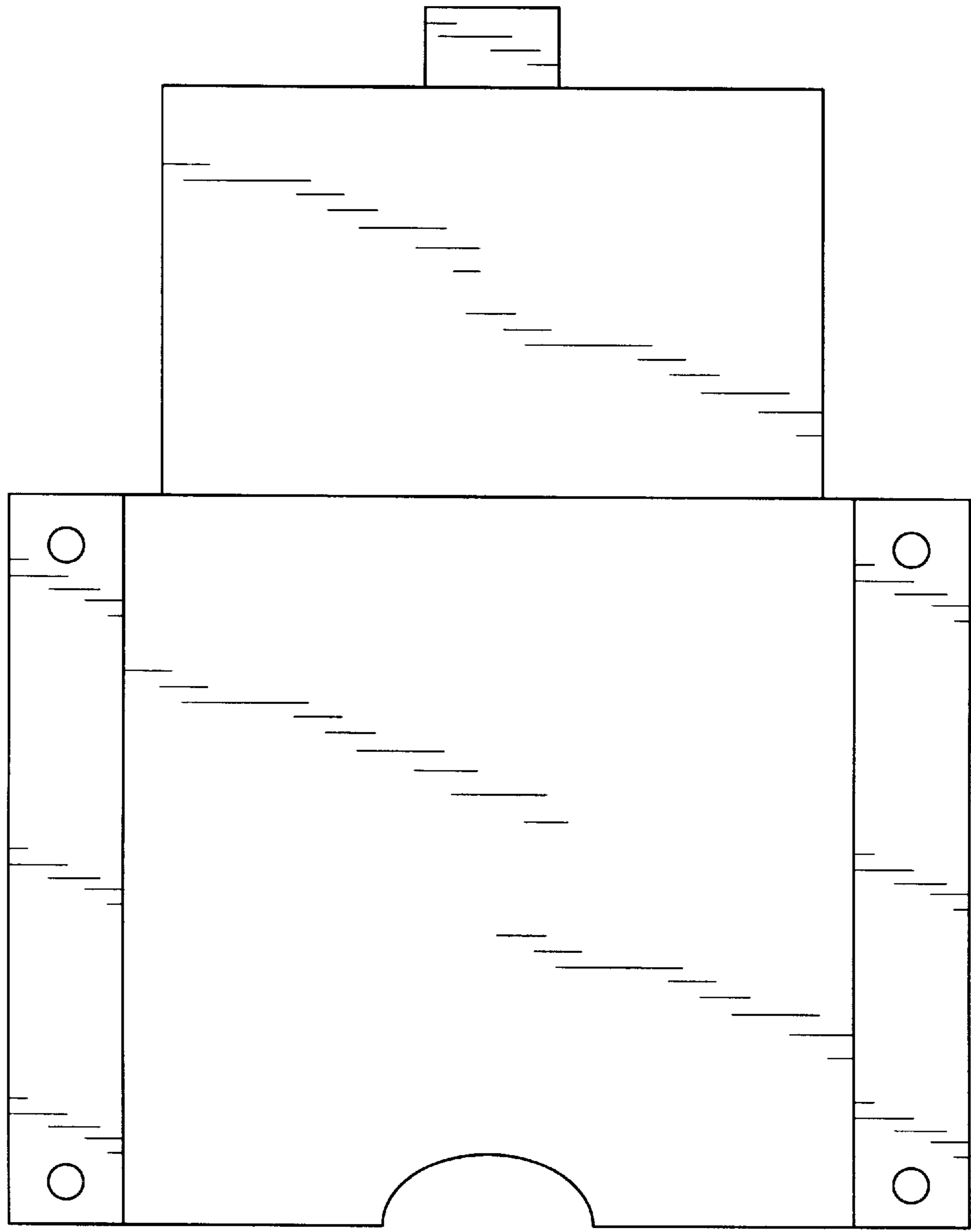

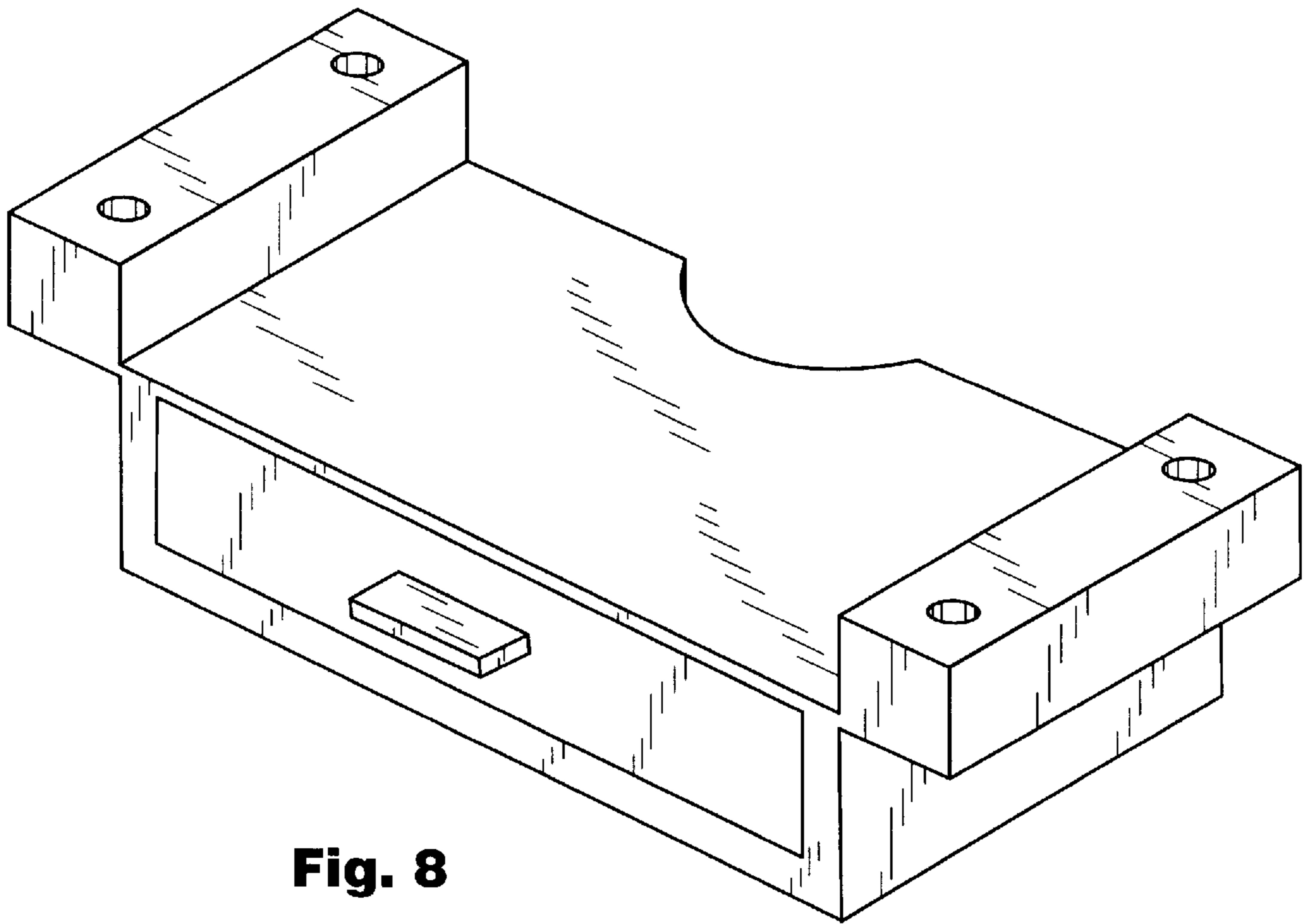
