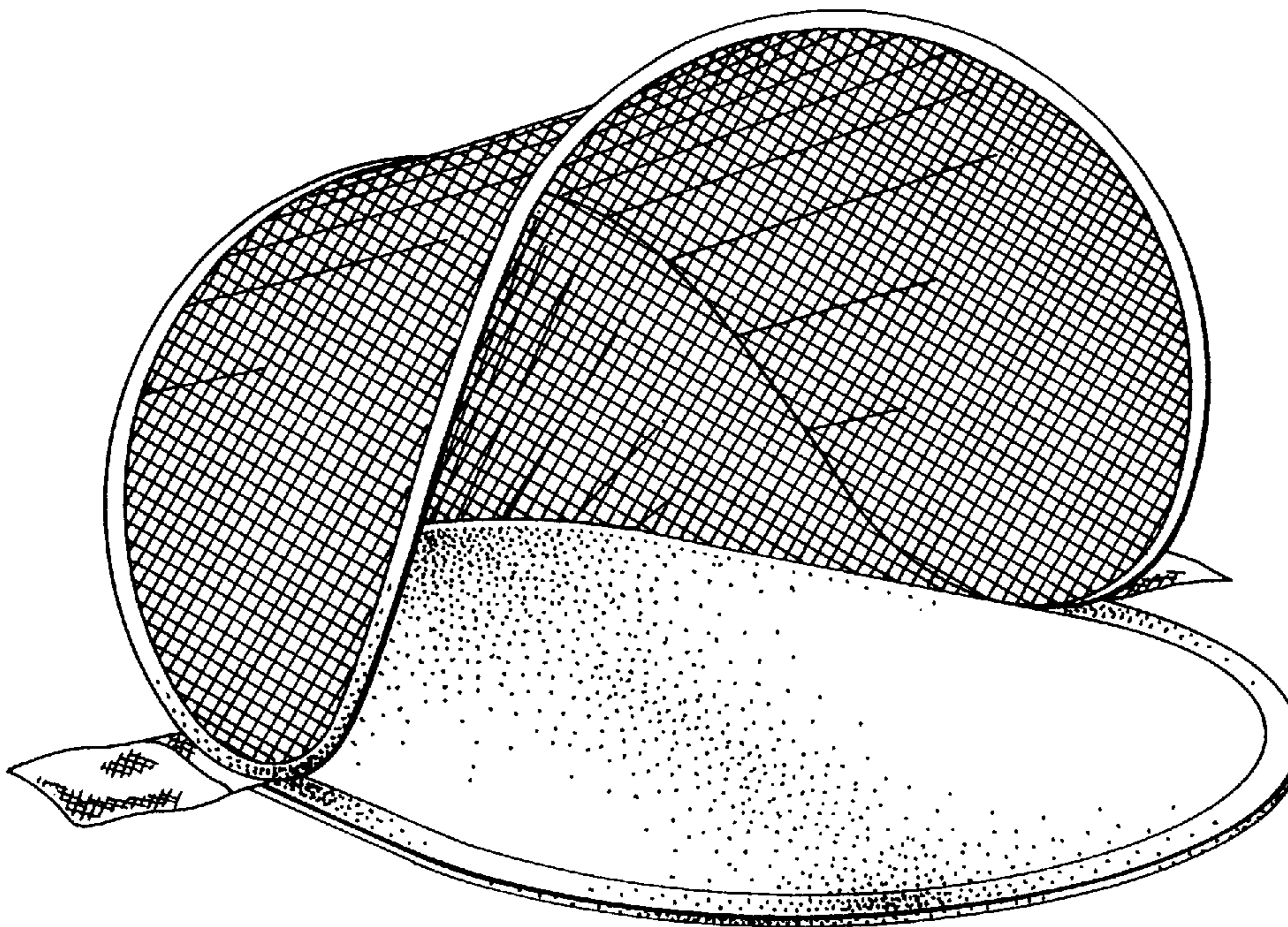
[57] **CLAIM**

The ornamental design for a portable shade structure, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portable shade structure in accordance with my design;
FIG. 2 is a top plan view;
FIG. 3 is a bottom plan view;
FIG. 4 is a right side elevation, of which the left side elevation is a mirror image;
FIG. 5 is a front elevation; and,
FIG. 6 is a rear elevation view.

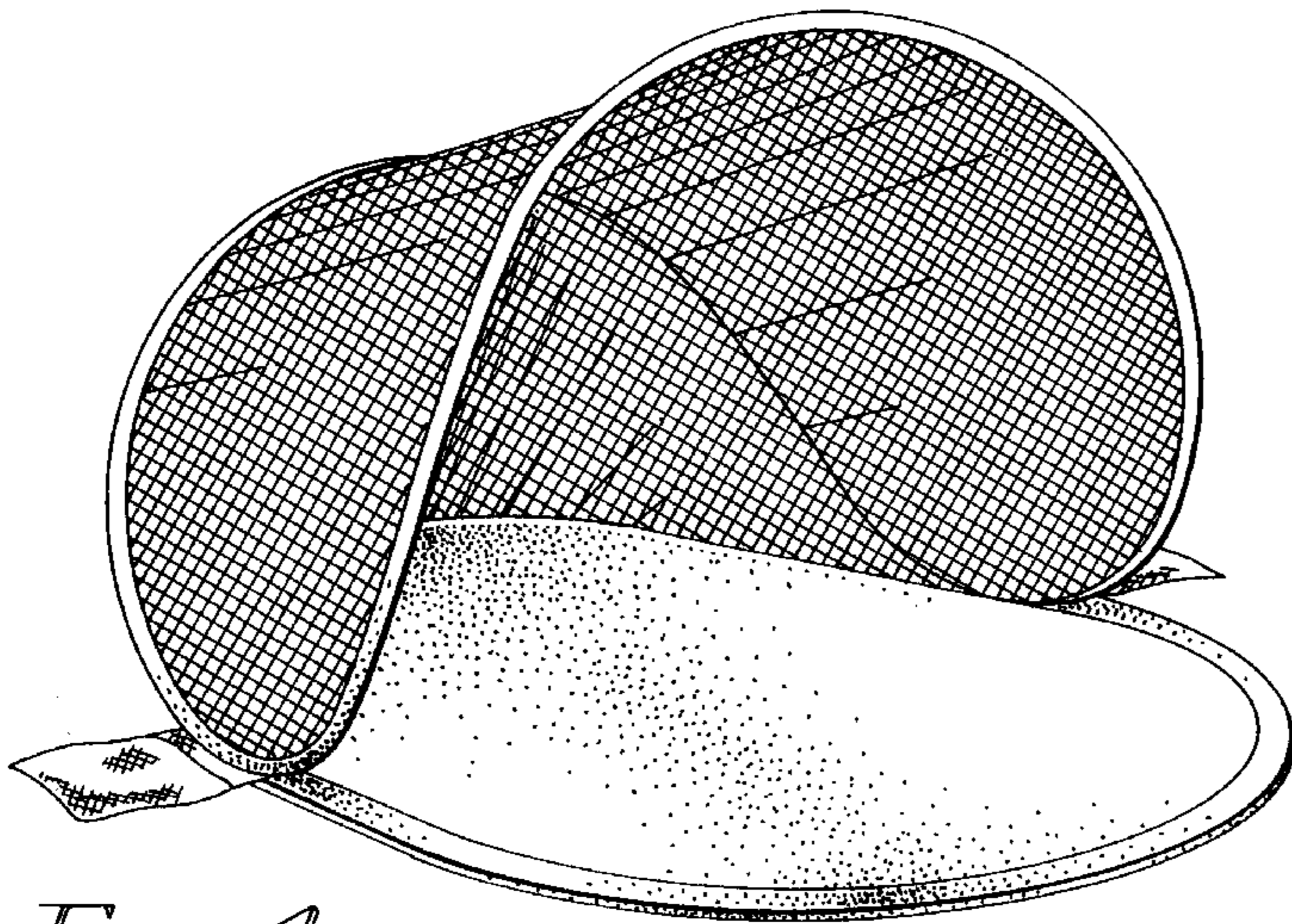

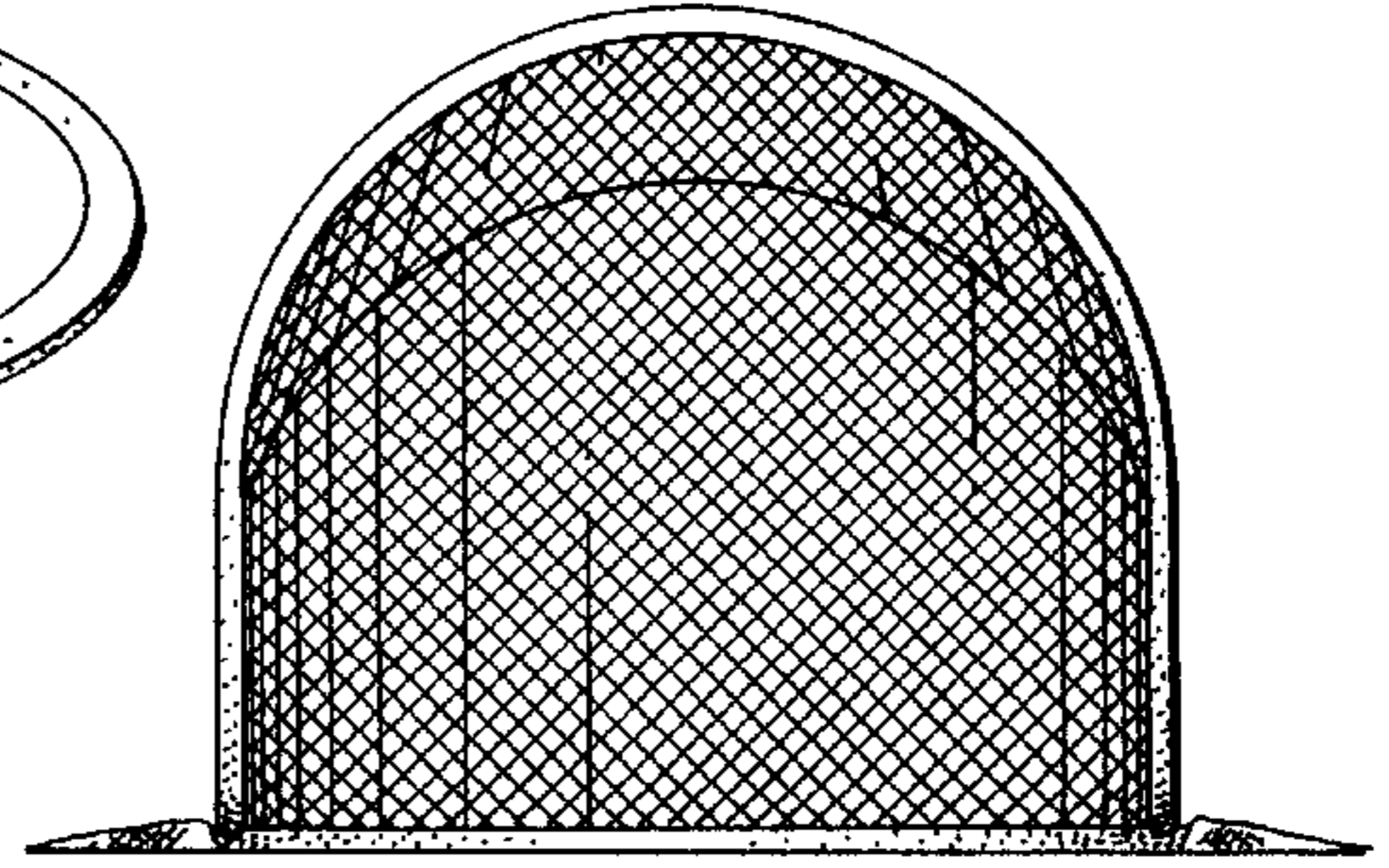

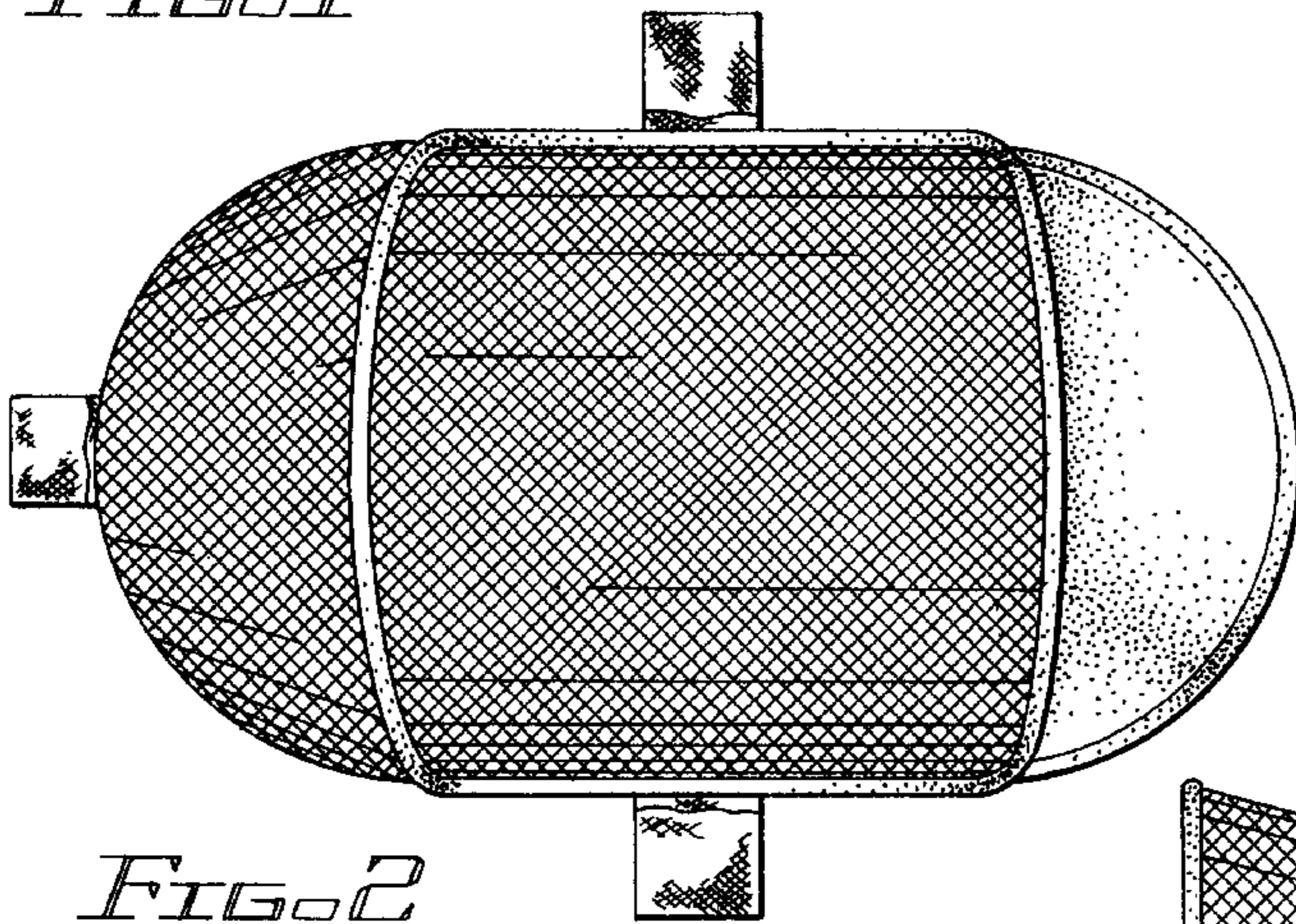

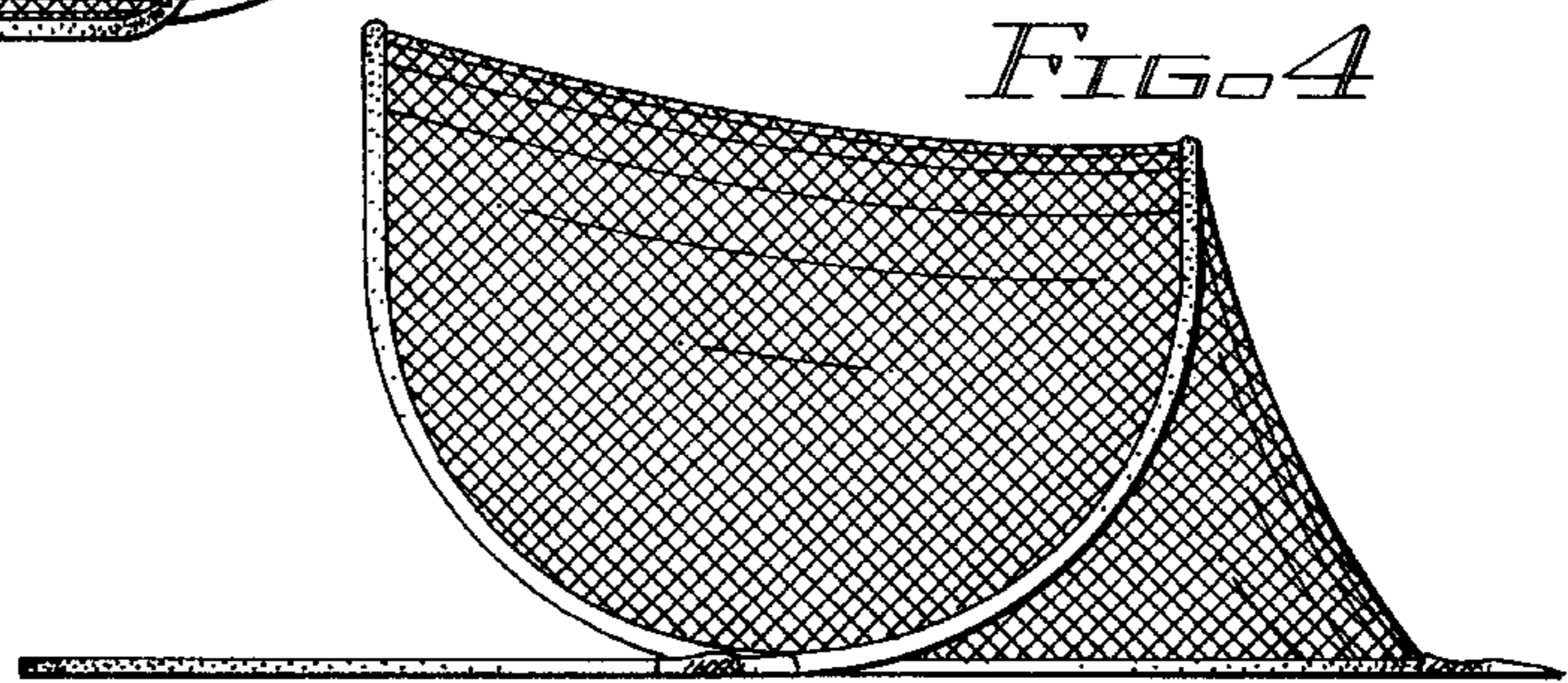

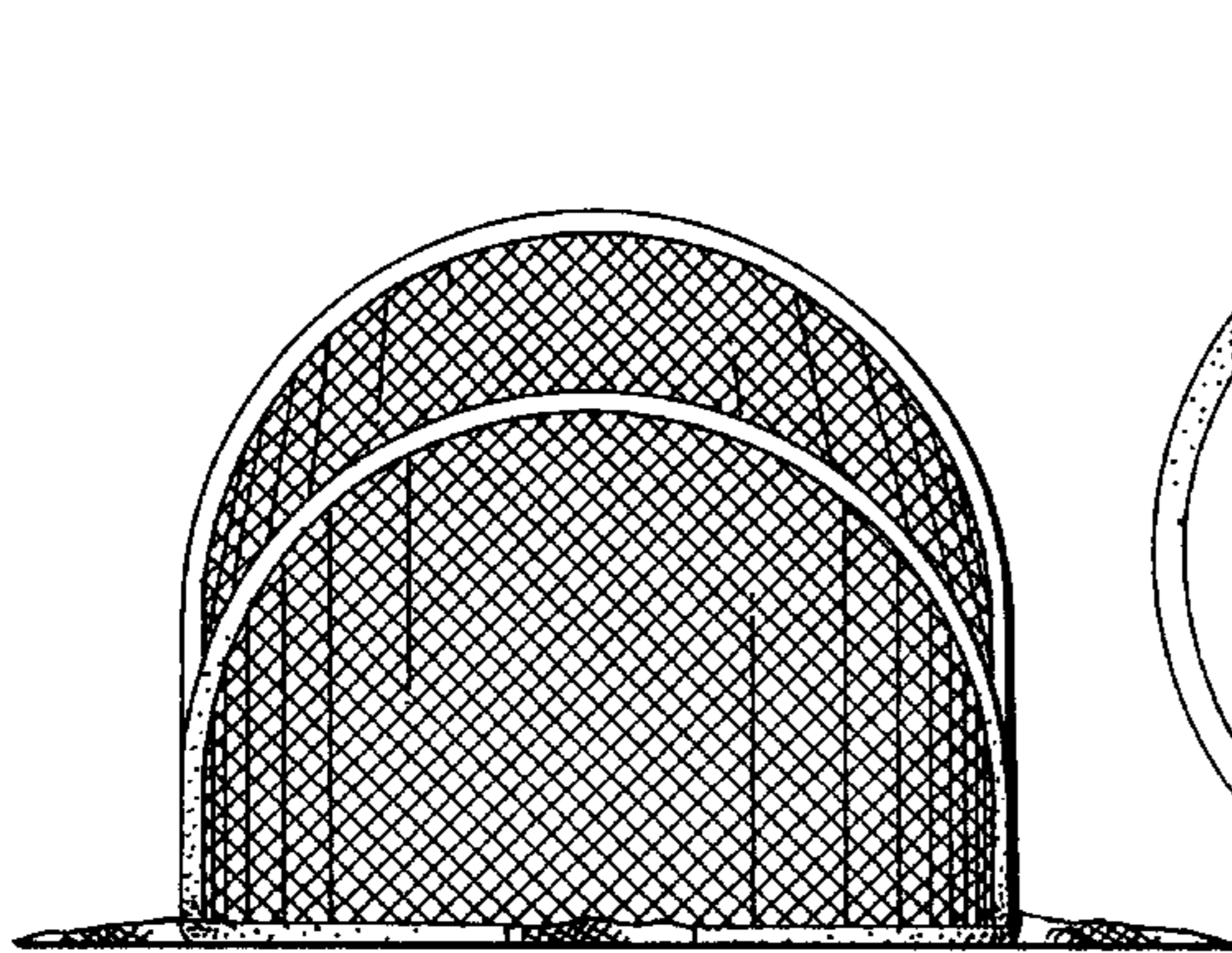

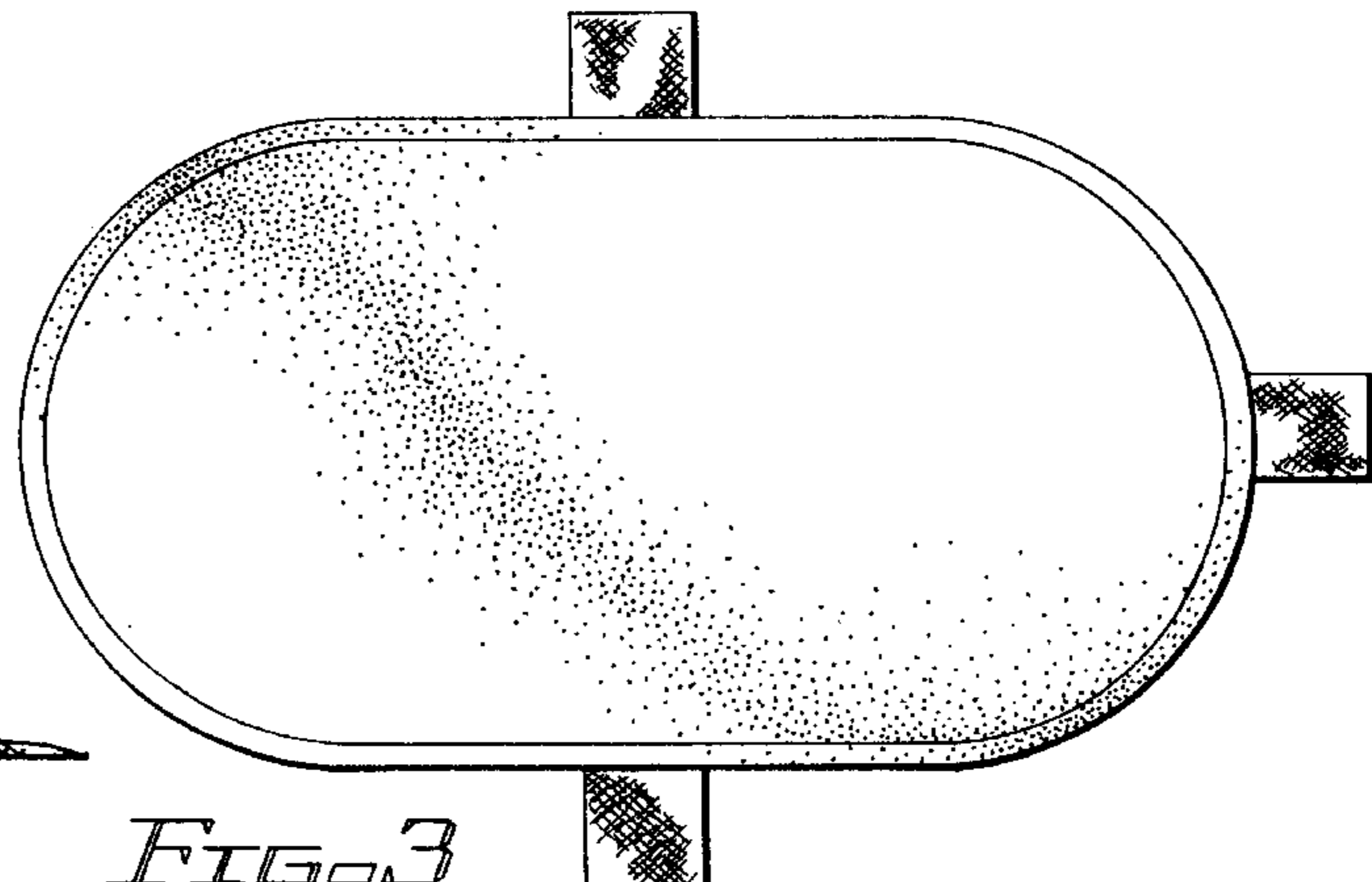
