DESCRIPTION

FIG. 1 is a rear environmental perspective view of a jacket having a decoration accessory, showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a left side elevational view thereof, the right side being a mirror image; FIG. 4 is a rear elevational view thereof; FIG. 5 is a rear elevational view thereof, with the accessory in an optional folded or stowed condition; FIG. 6 is a top view of the jacket, again with the accessory displayed or erected; and, FIG. 7 is a bottom view thereof, with the accessory displayed.

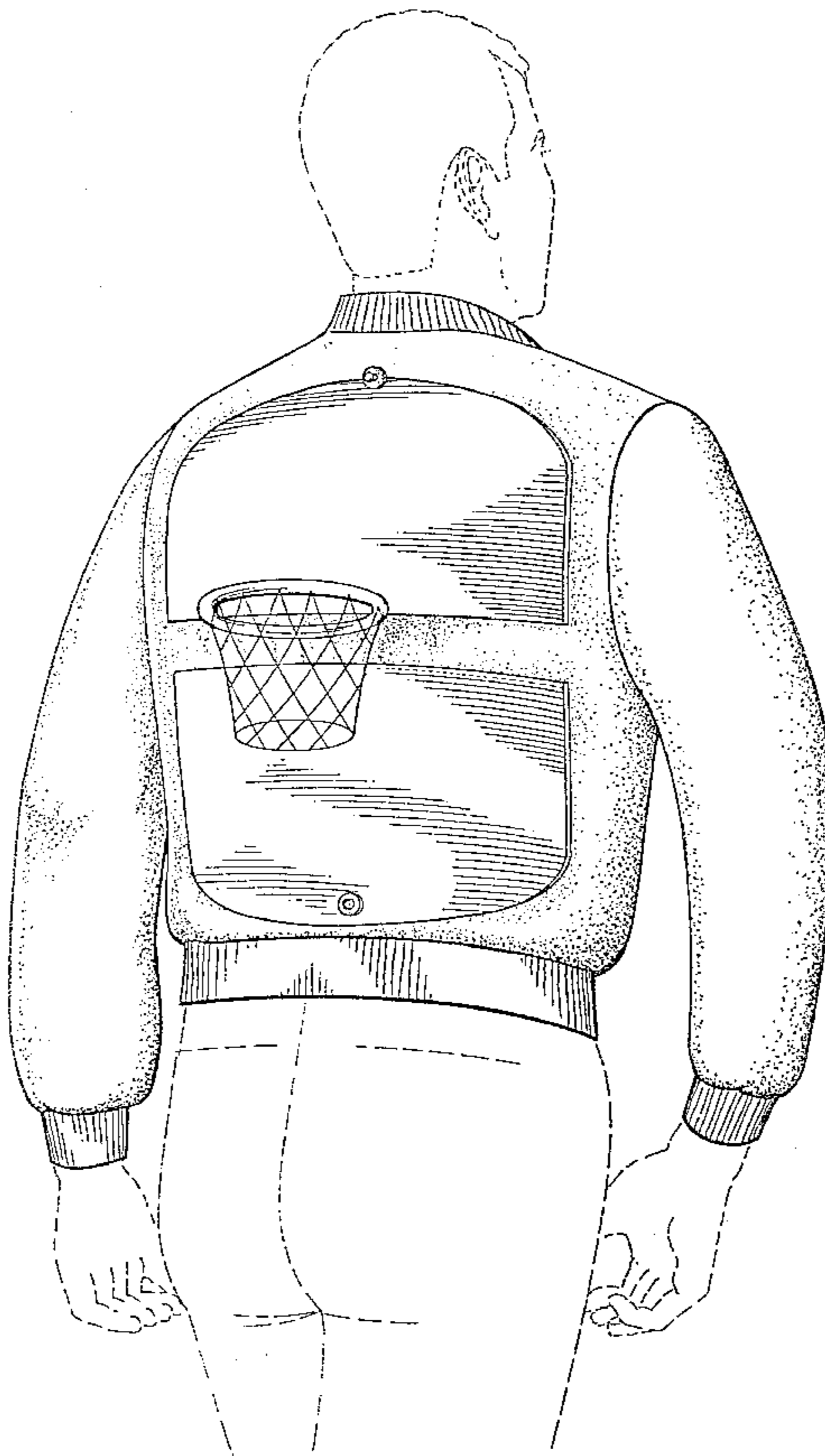
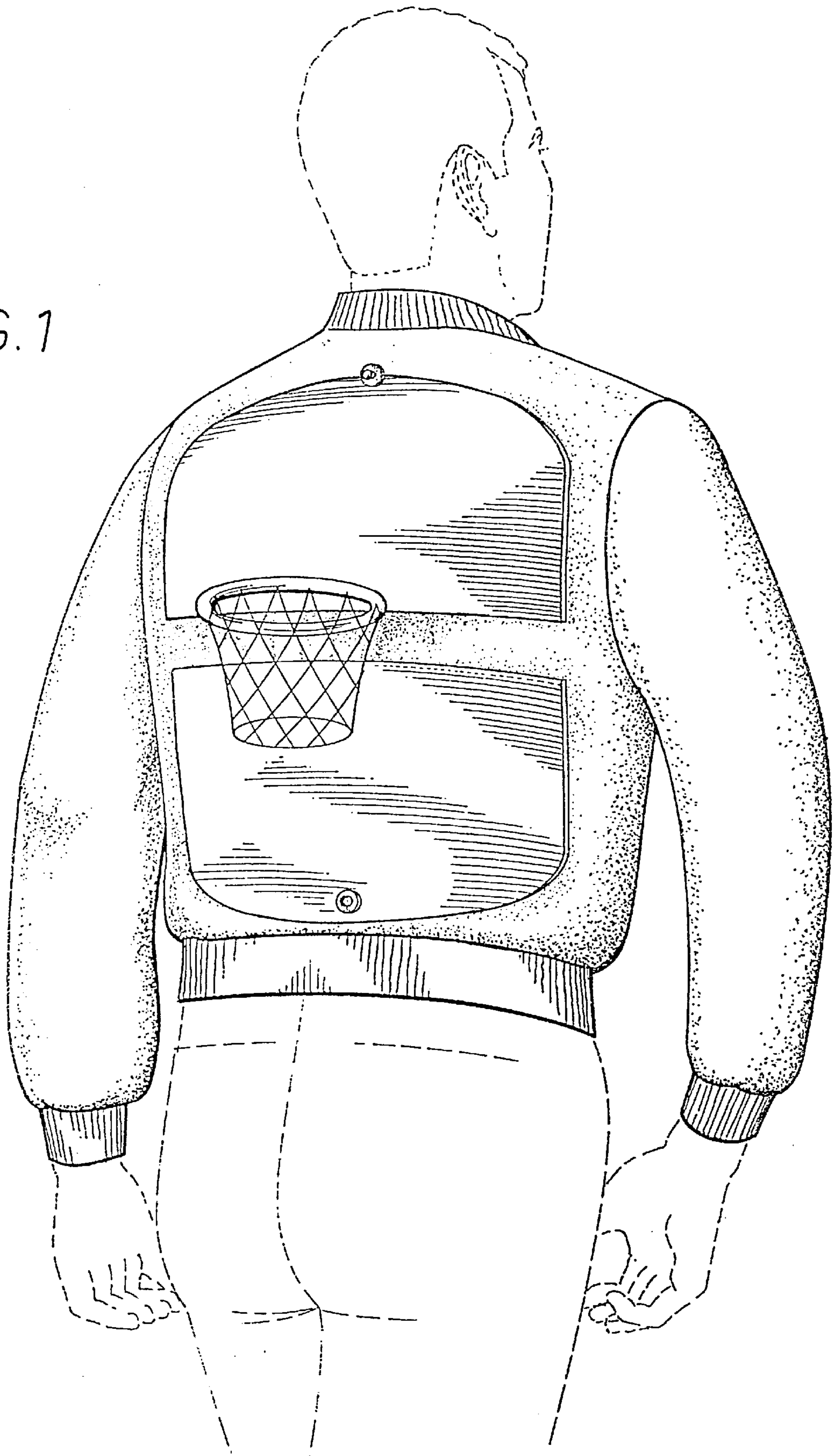

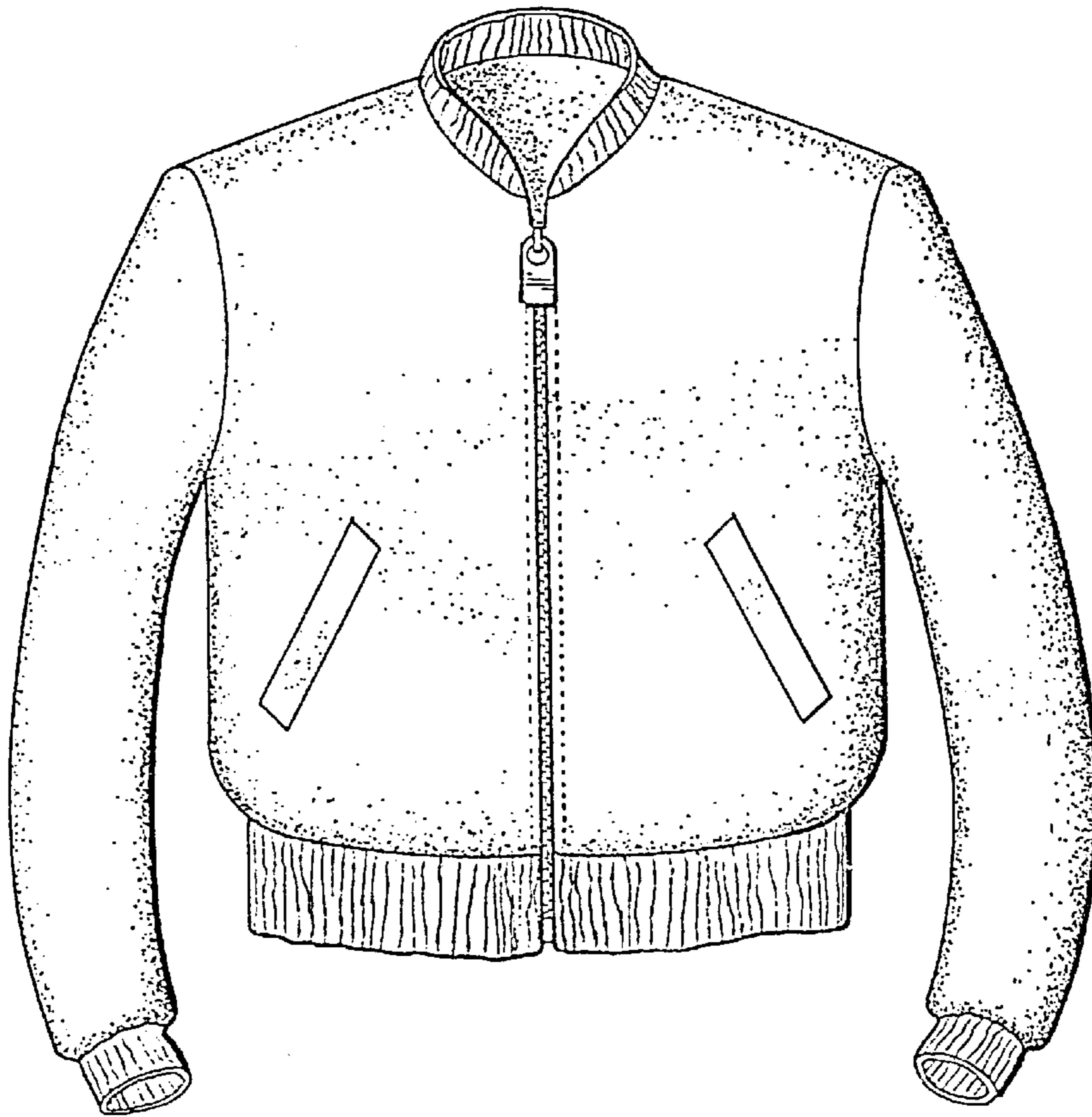

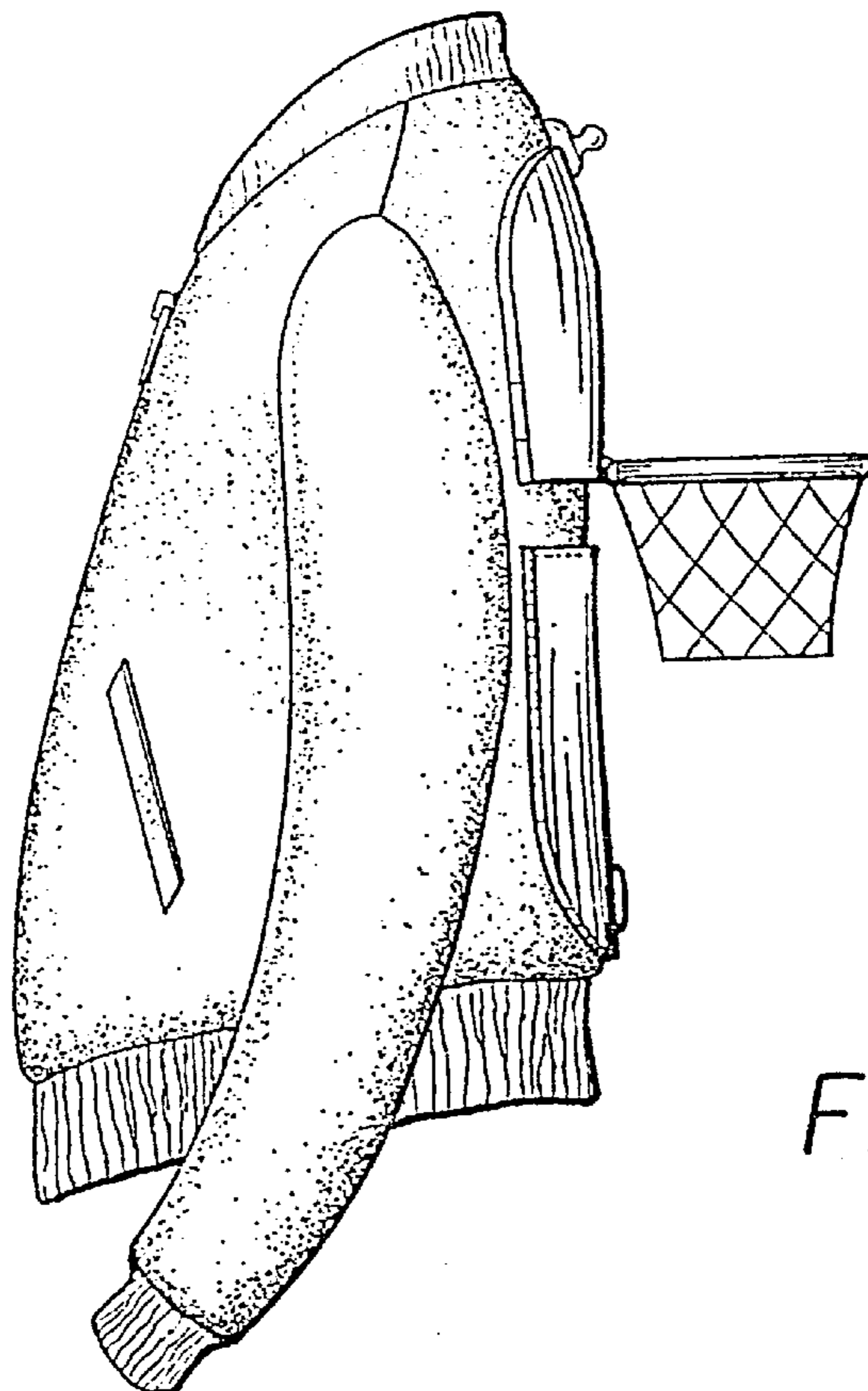

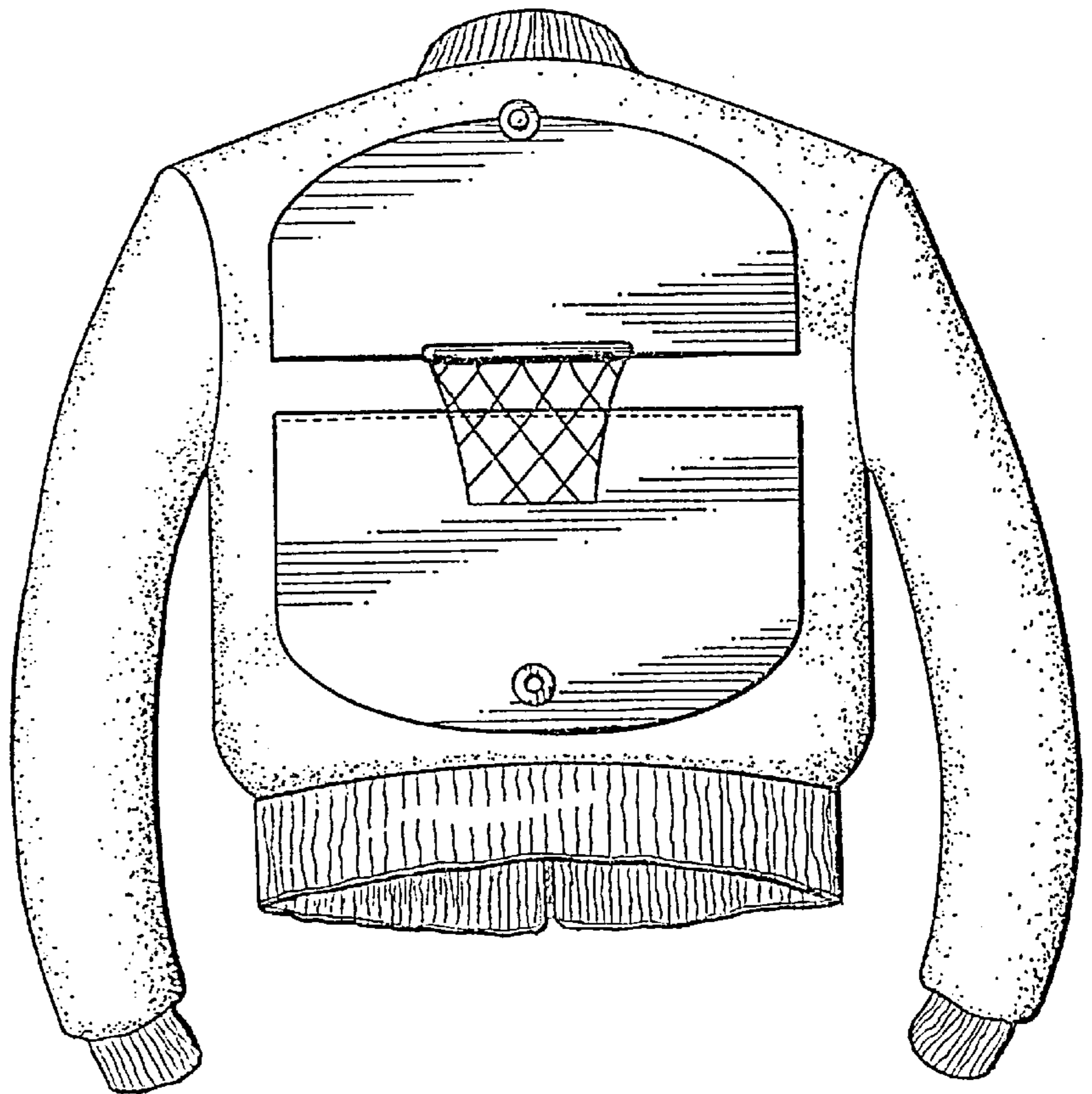

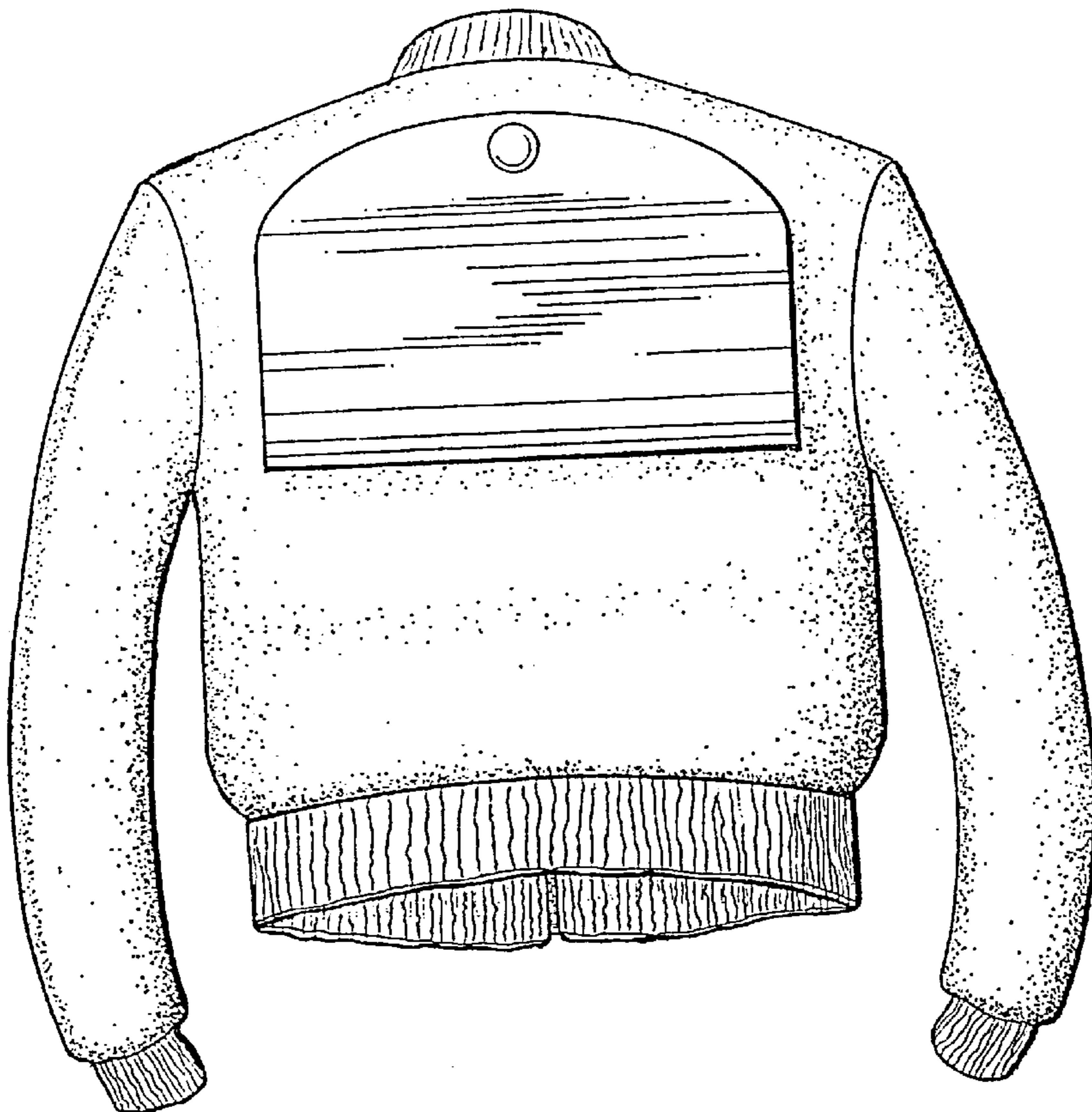

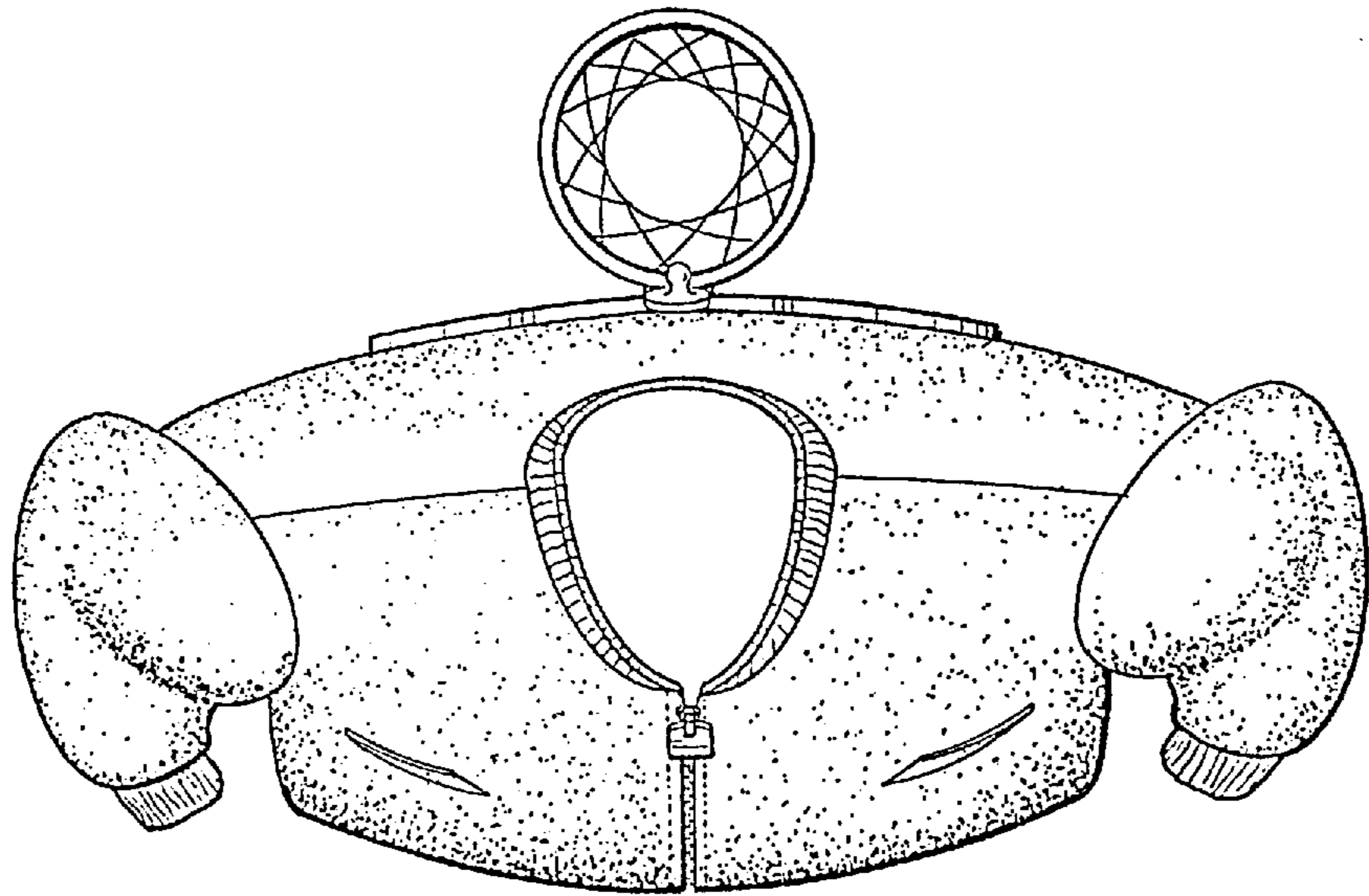

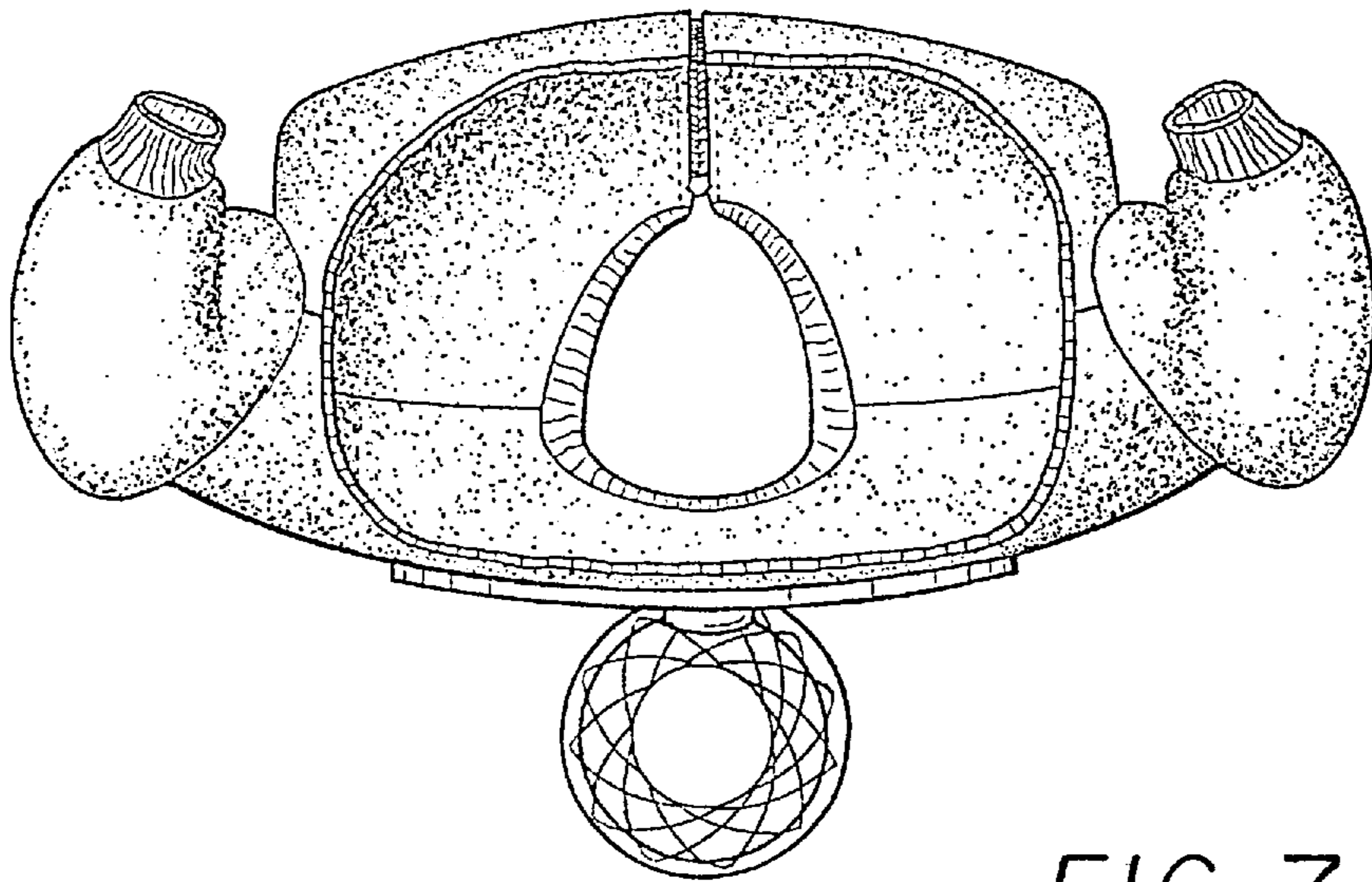
