**DESCRIPTION**

FIG. 1 is front, side perspective view of a zippered carrying case, showing our design;  
FIG. 2 is a front elevational view thereof;

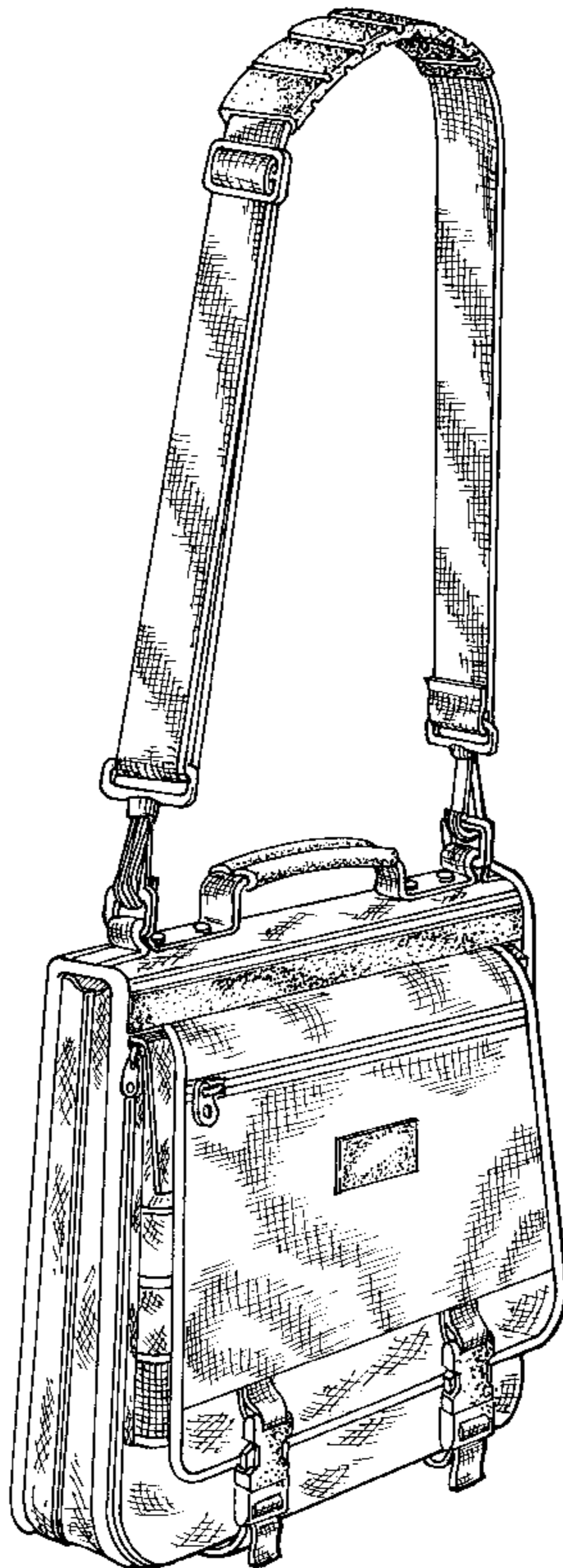

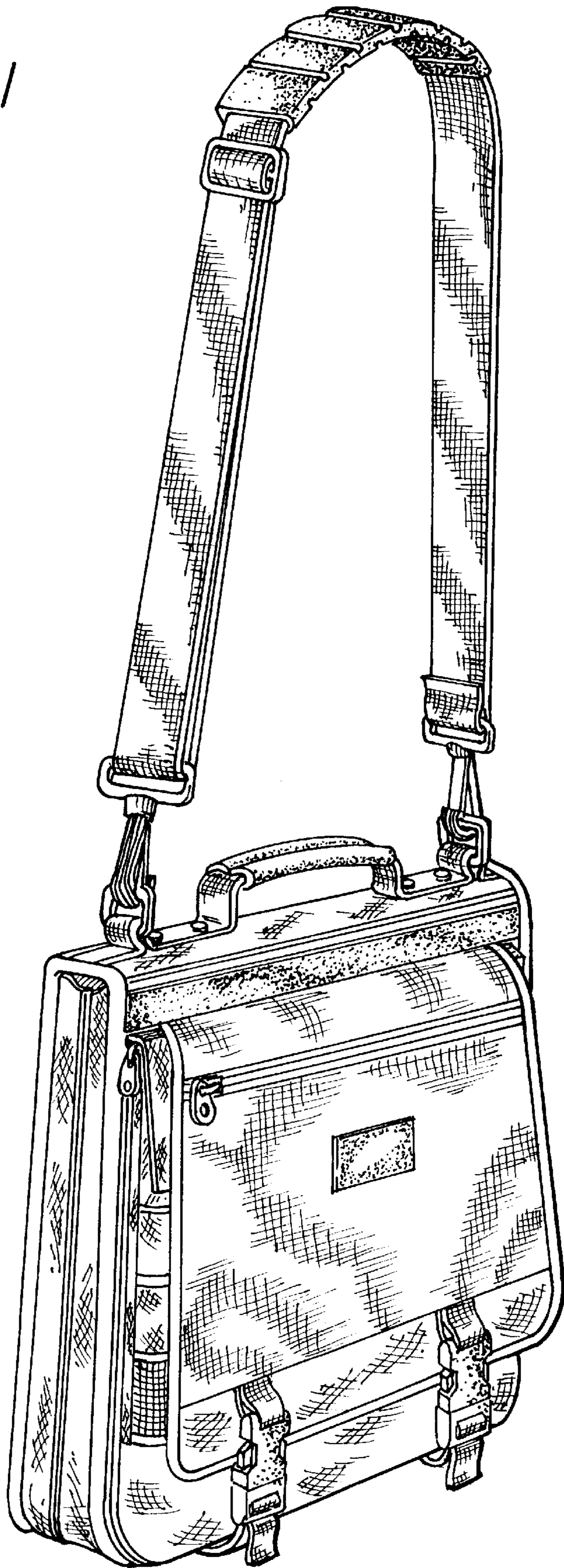

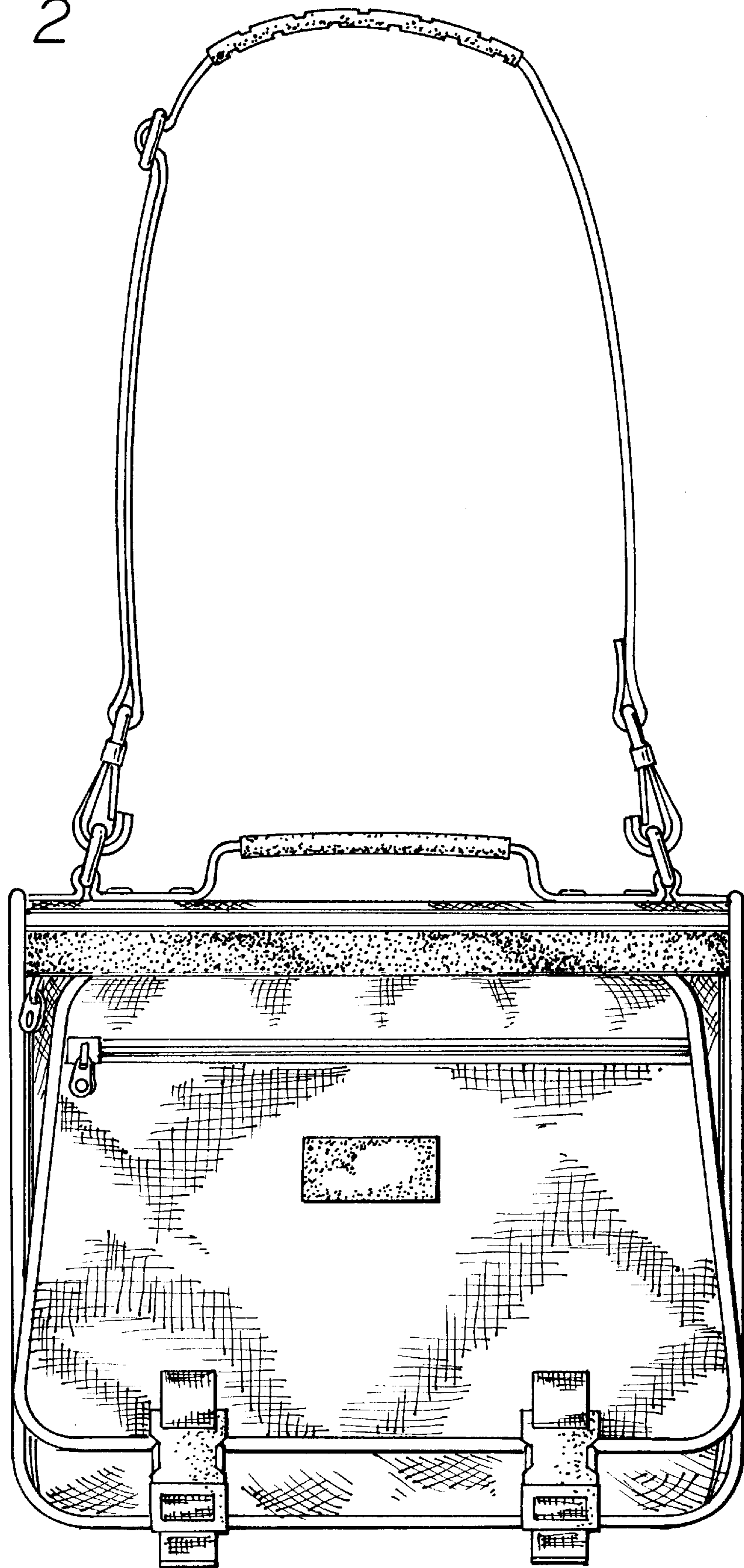

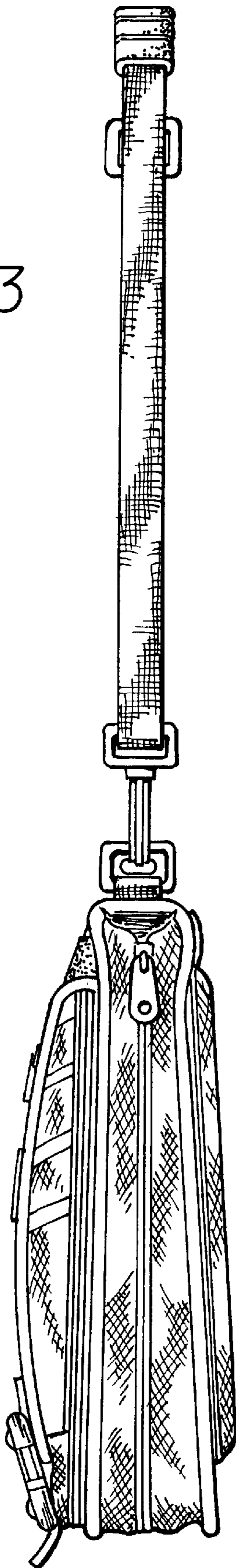

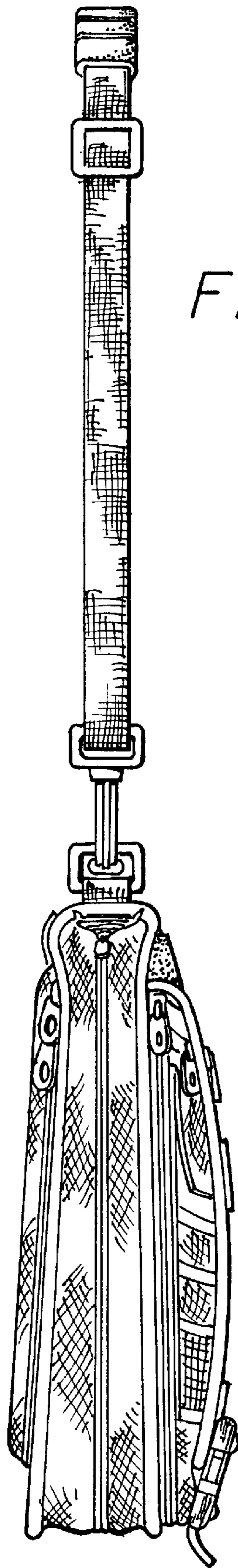

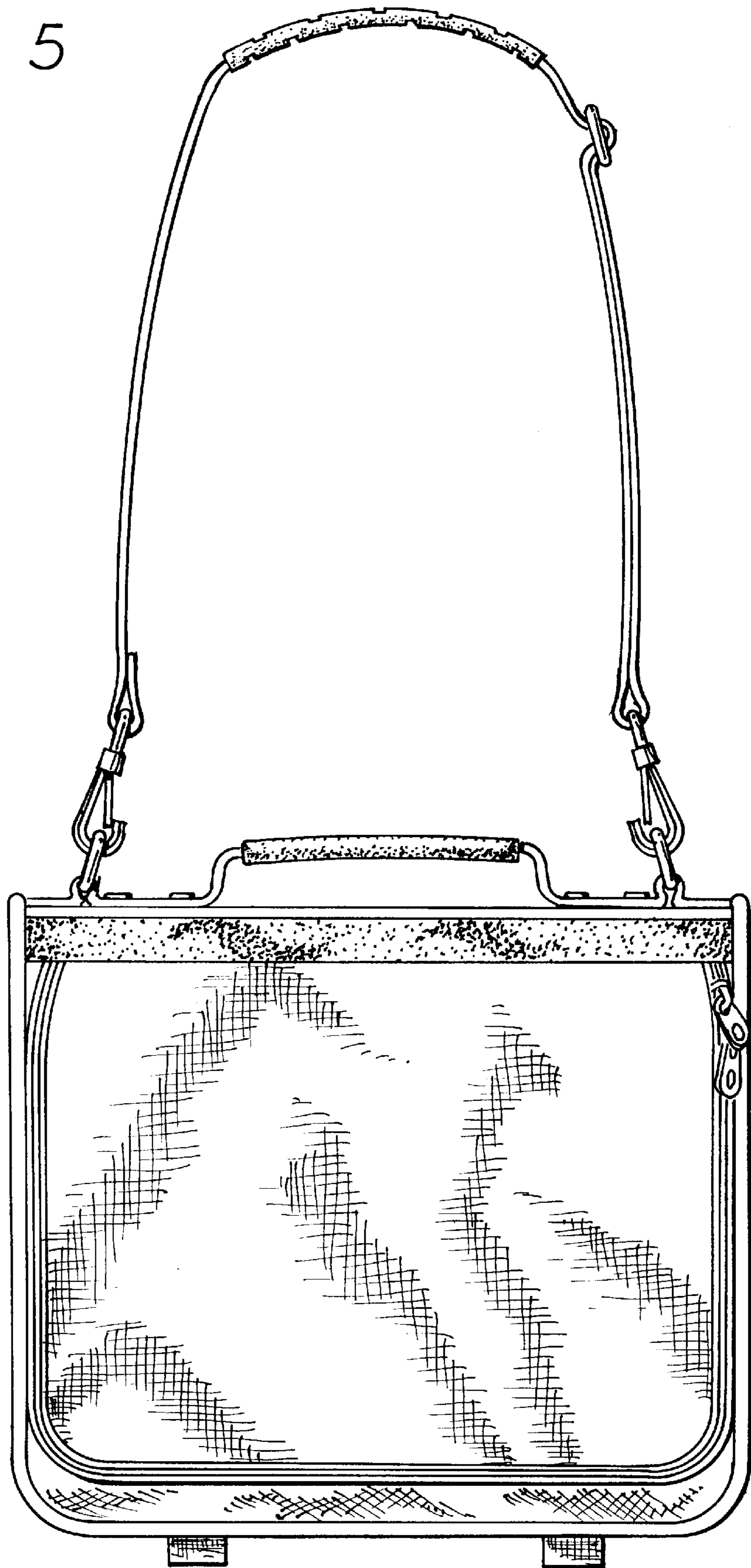

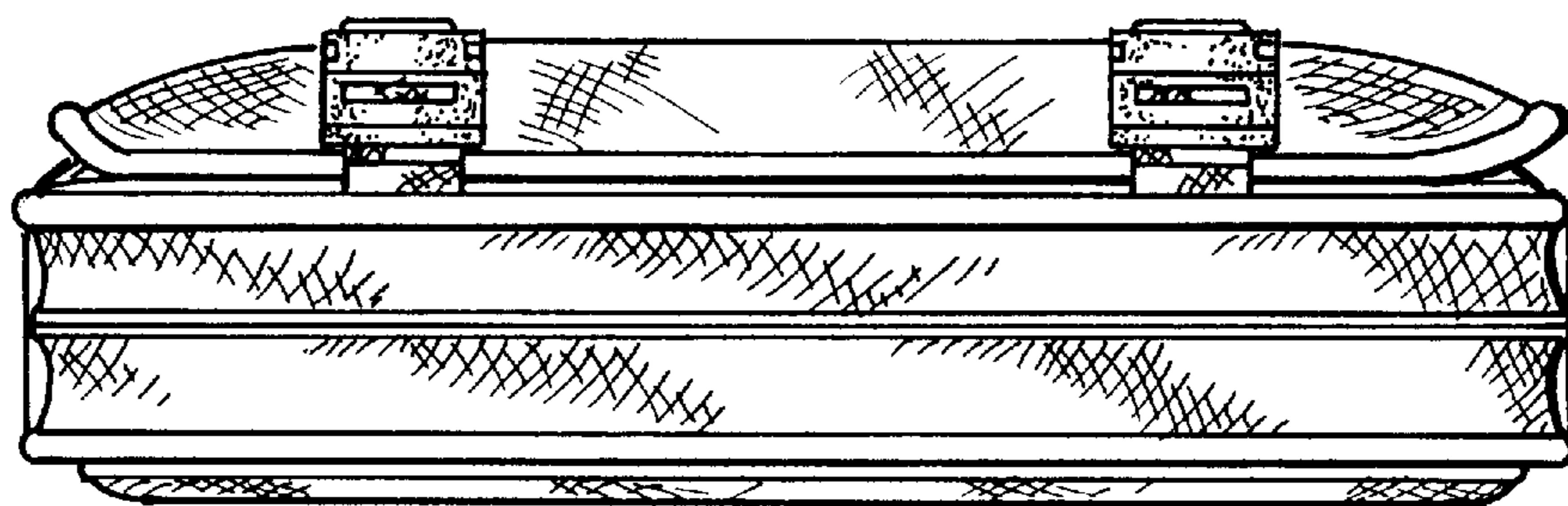
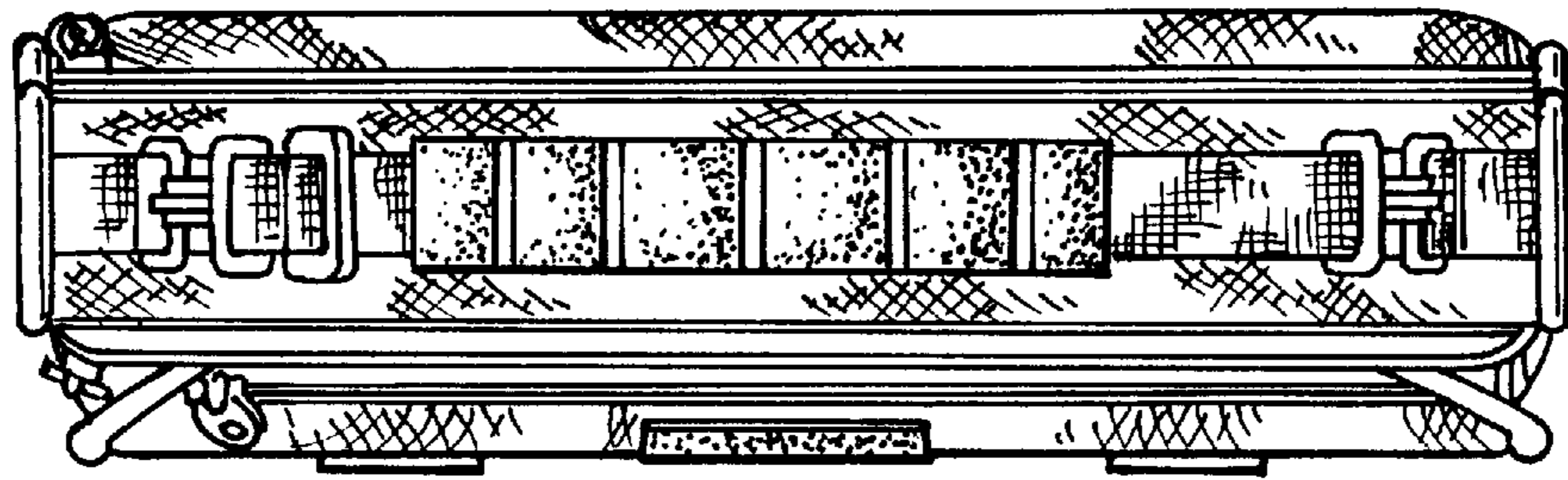
