The ornamental design for a tote box, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tote box showing our new design;  
FIG. 2 is an elevational view of one side thereof the other side being a mirror image thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a elevational view of the front side thereof the rear side being a mirror image thereof; and,  
FIG. 5 is a bottom plan view thereof.

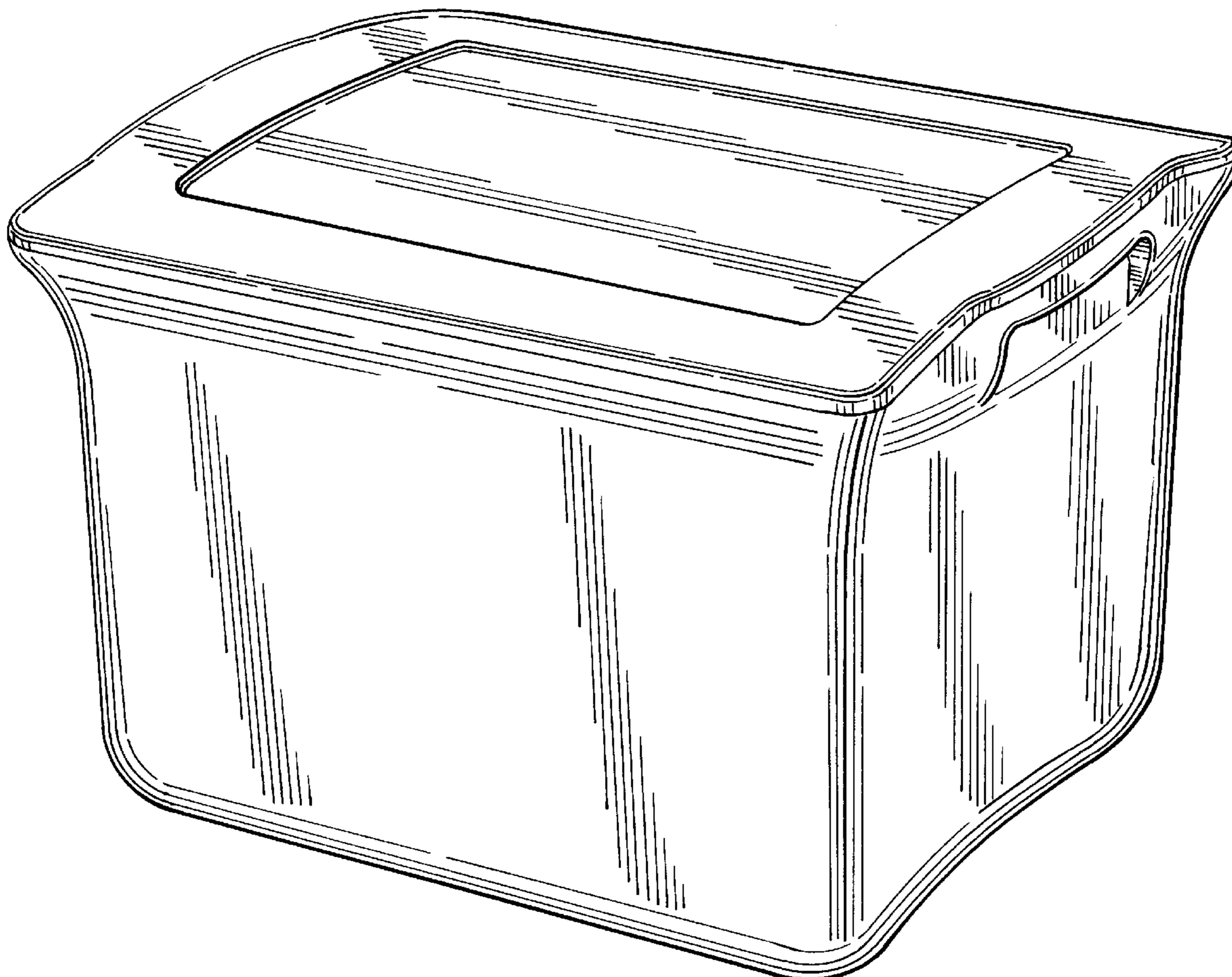

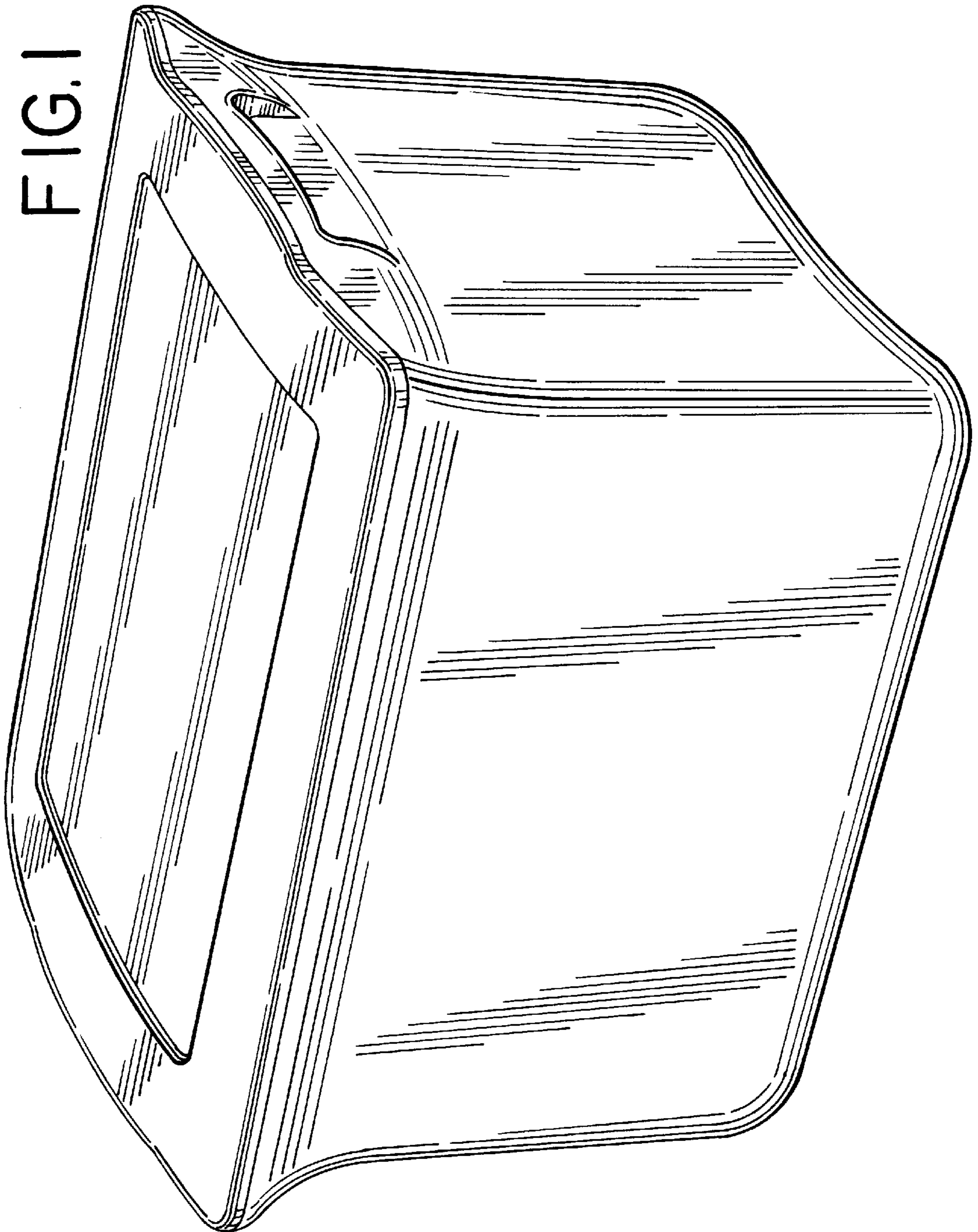

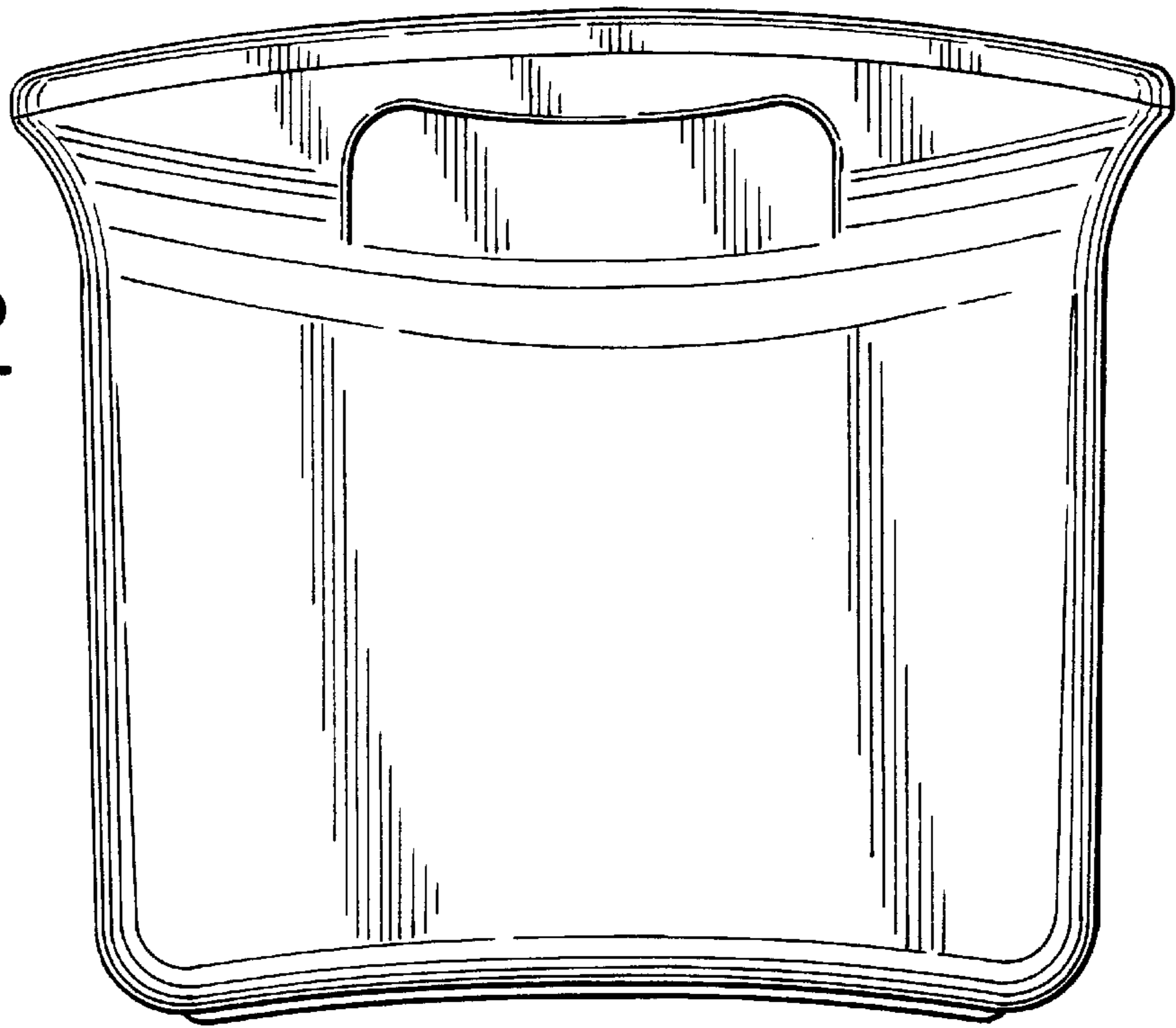

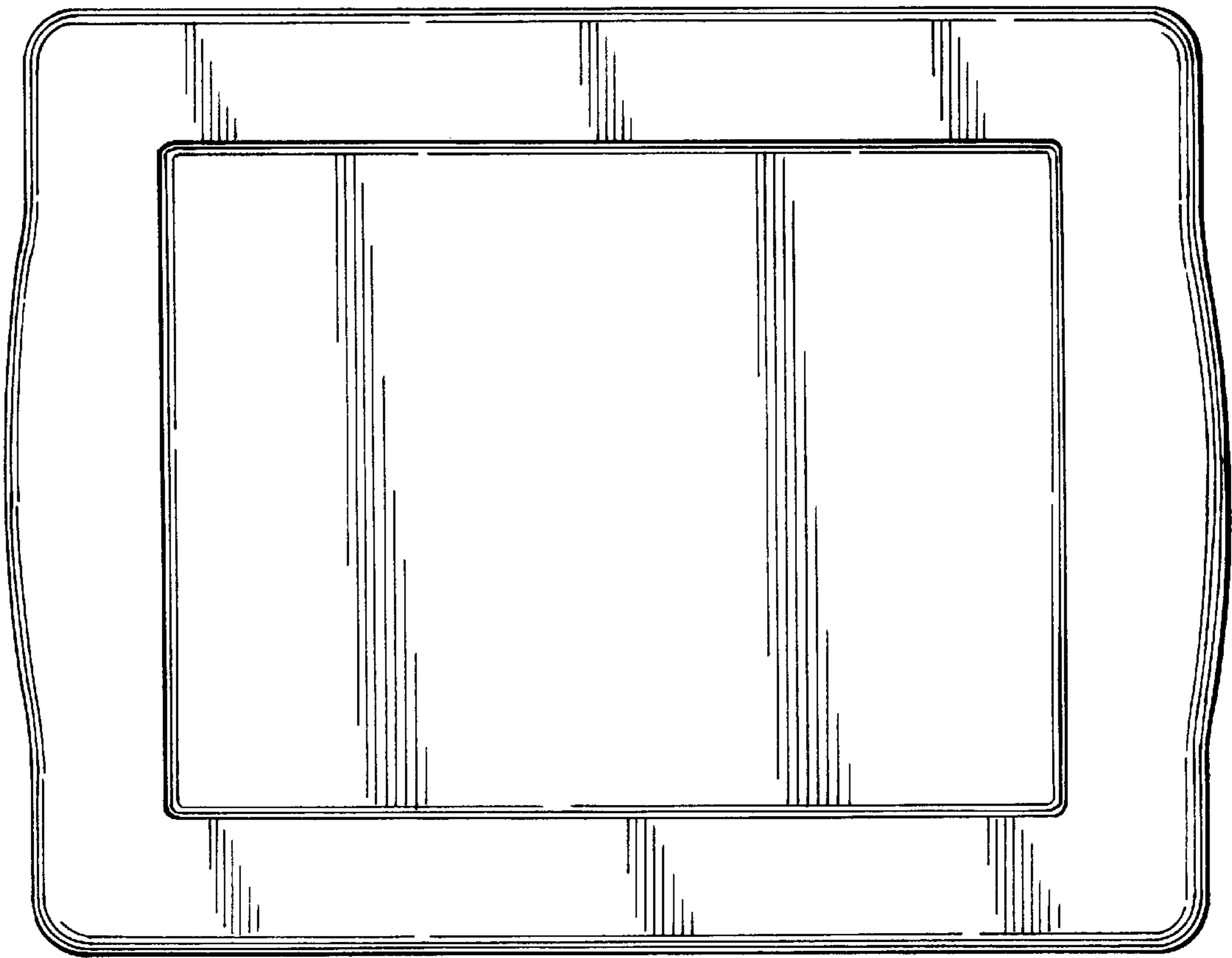

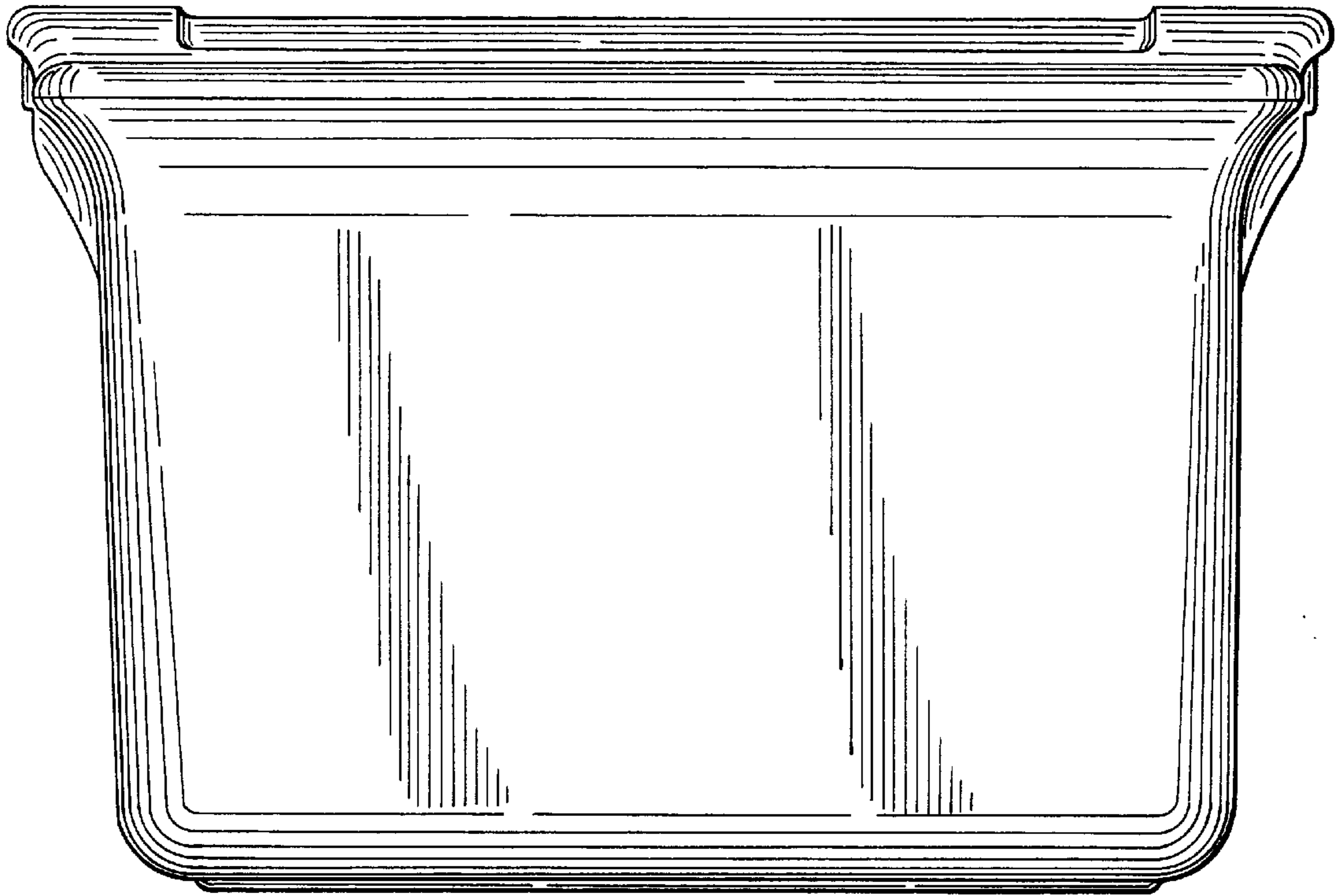
