### [57] CLAIM

The ornamental design for the floor covering, as shown and described.

### DESCRIPTION

FIG. 1 is a plan view showing a typical portion of our design invention for a floor covering, it being understood that the design is continuous and repeating over the surface thereof and that the top edge and right side edges are cut off;

FIG. 2 is an enlarged end view looking toward the bottom edge of FIG. 1;

FIG. 3 is an enlarged sectional view along the top cut off edge of FIG. 1;

FIG. 4 is an enlarged side view looking toward the left side of FIG. 1;

FIG. 5 is an enlarged sectional view along the right side cut off edge of FIG. 1;

FIG. 6 is an enlarged perspective view from the lower left corner of FIG. 1;

FIG. 7 is a plan view showing another floor covering of the present invention in which, similar to FIG. 1, the design is continuous and repeating over the surface thereof and the top edge and right side edges are cut off;

FIG. 8 is an enlarged end view looking toward the bottom edge of FIG. 7;

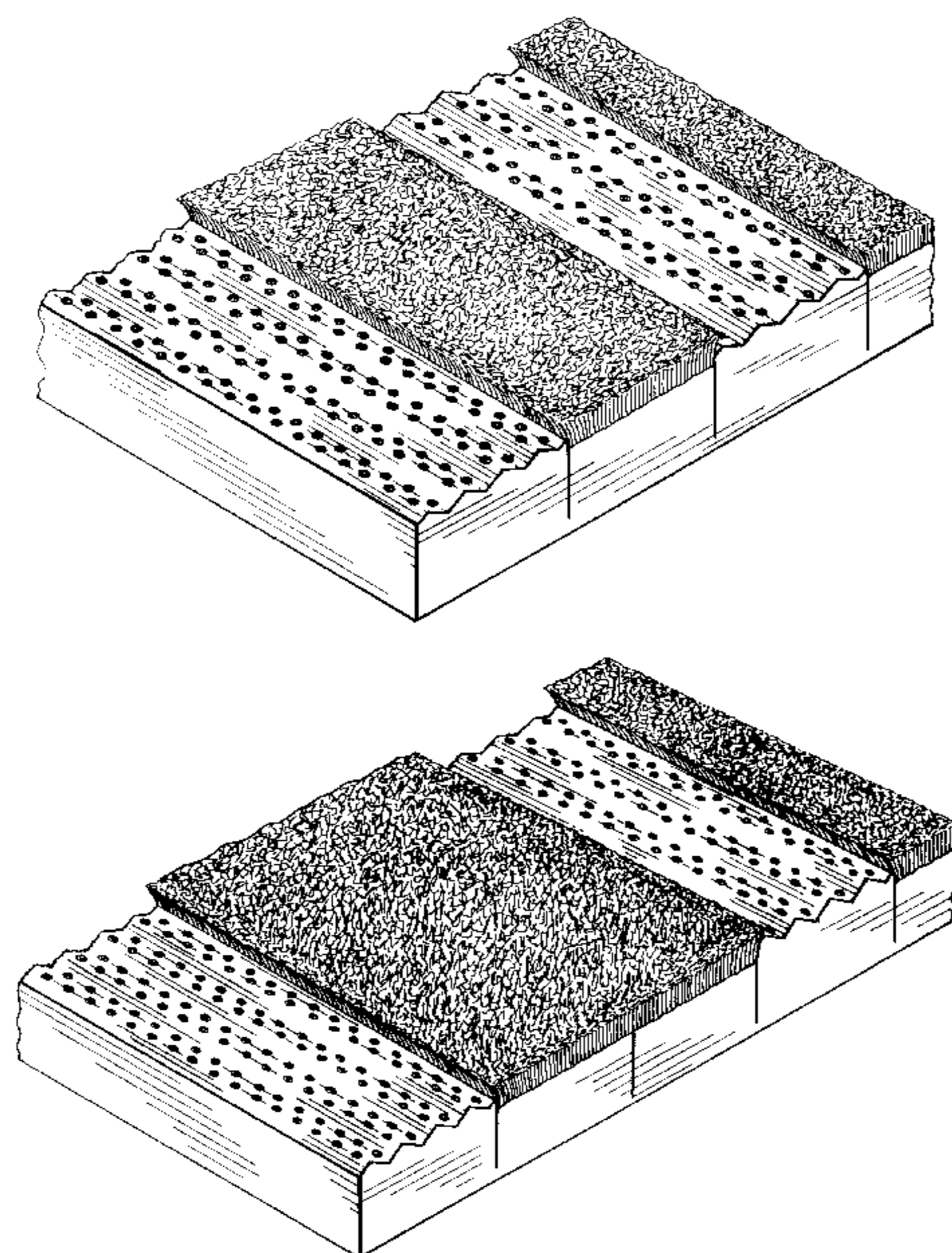
FIG. 9 is an enlarged sectional view along the top cut off edge of FIG. 7;

FIG. 10 is an enlarged side view looking toward the left side of FIG. 7;

FIG. 11 is an enlarged sectional view along the right side cut off edge of FIG. 7; and,

FIG. 12 is an enlarged perspective view from the lower left corner of FIG. 7.

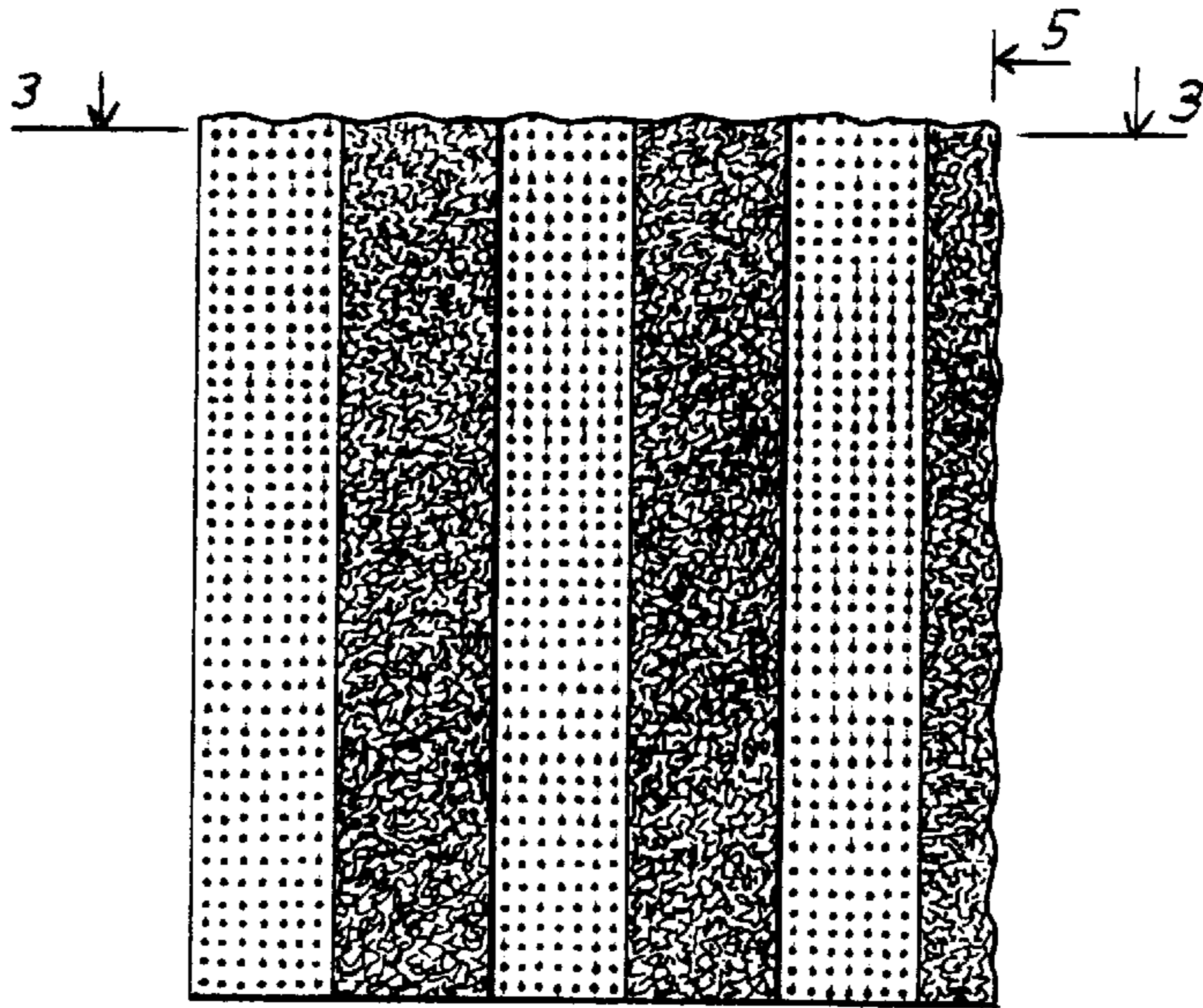

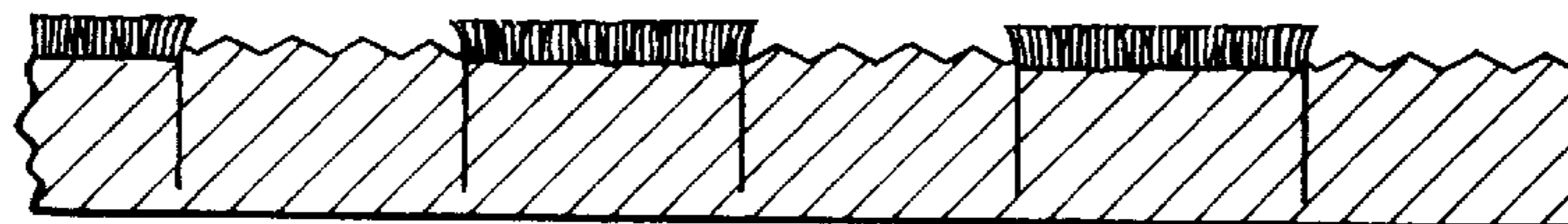

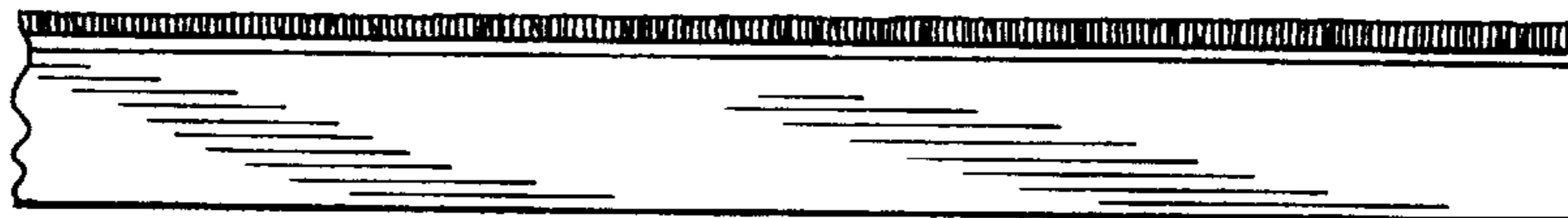

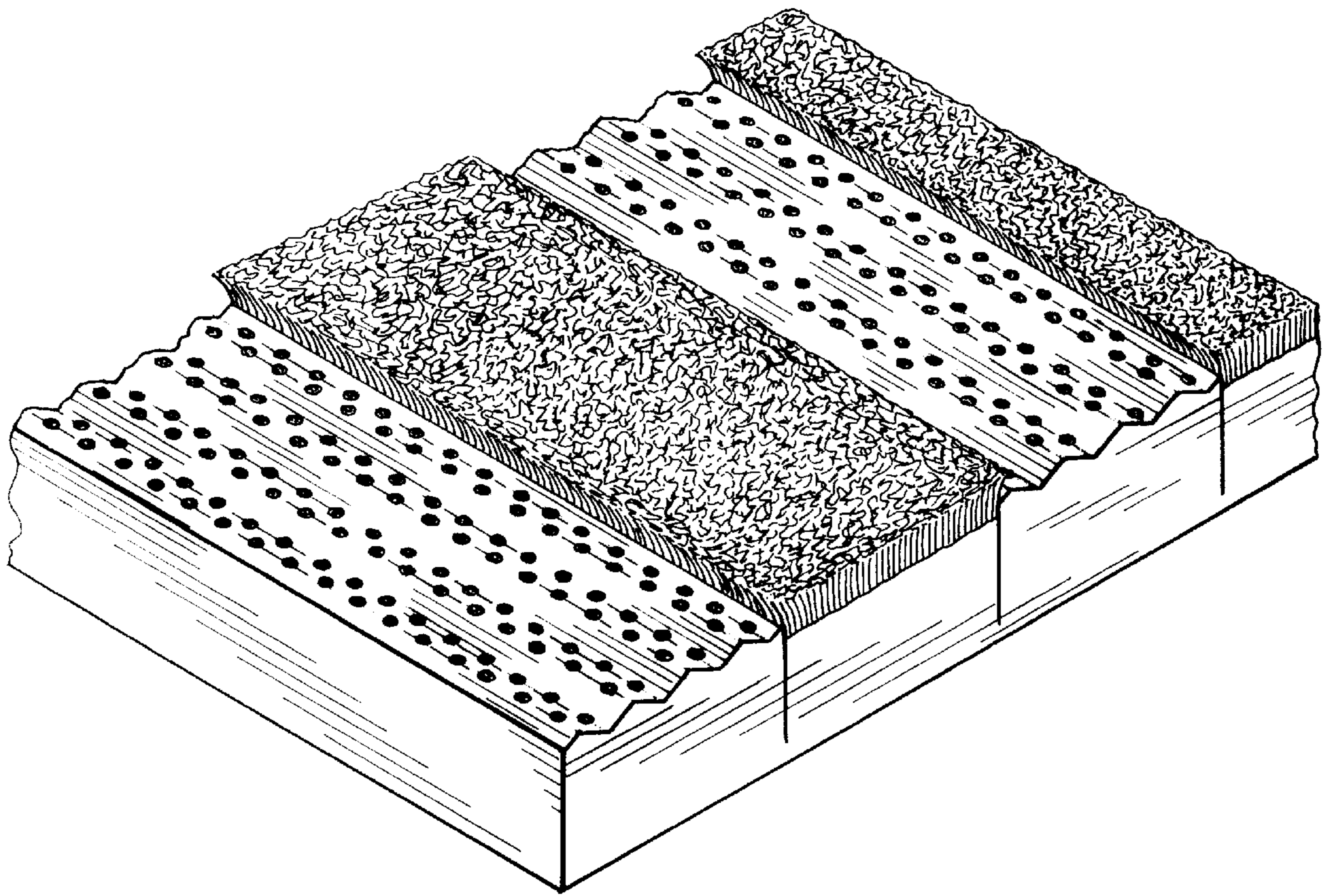

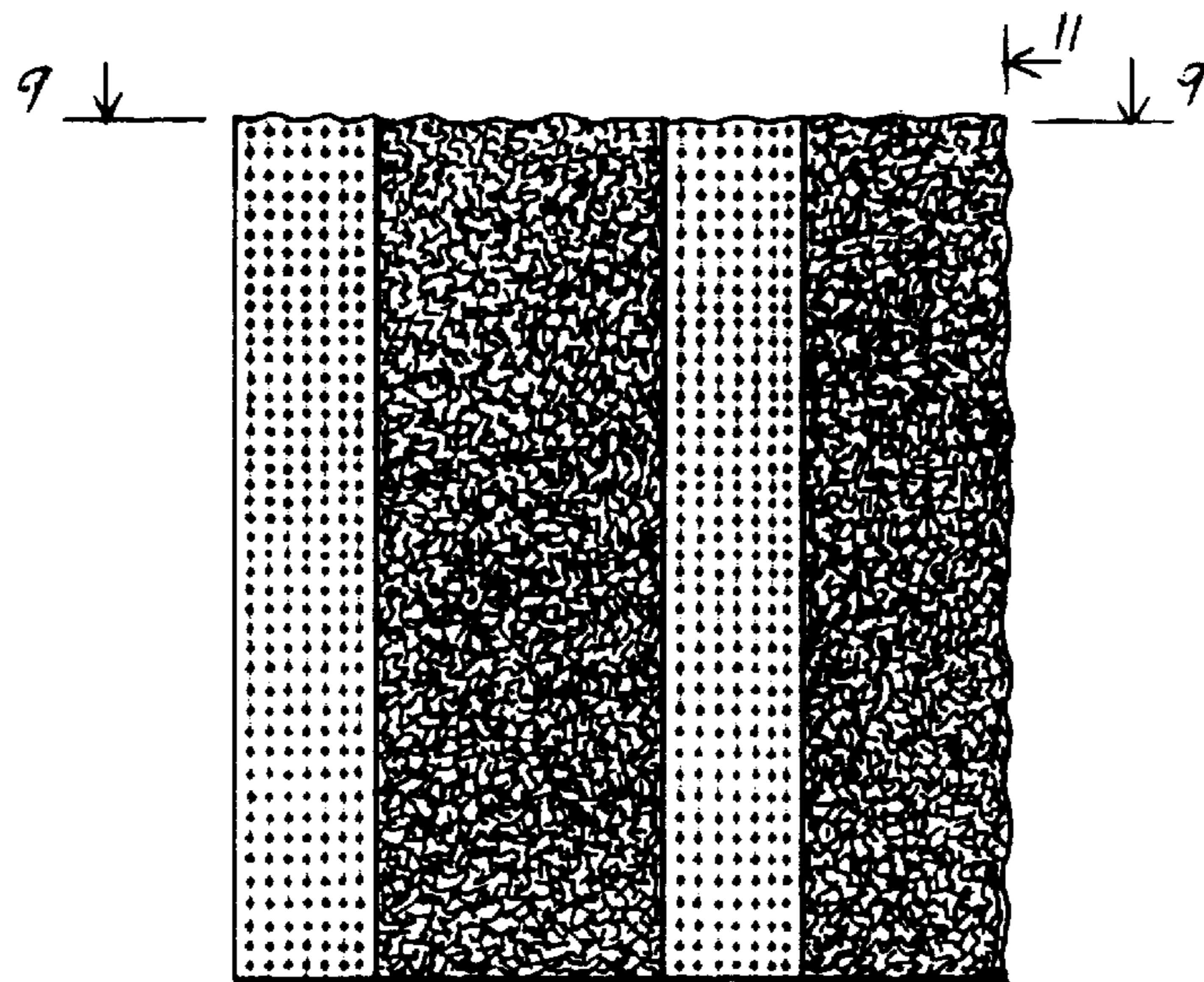

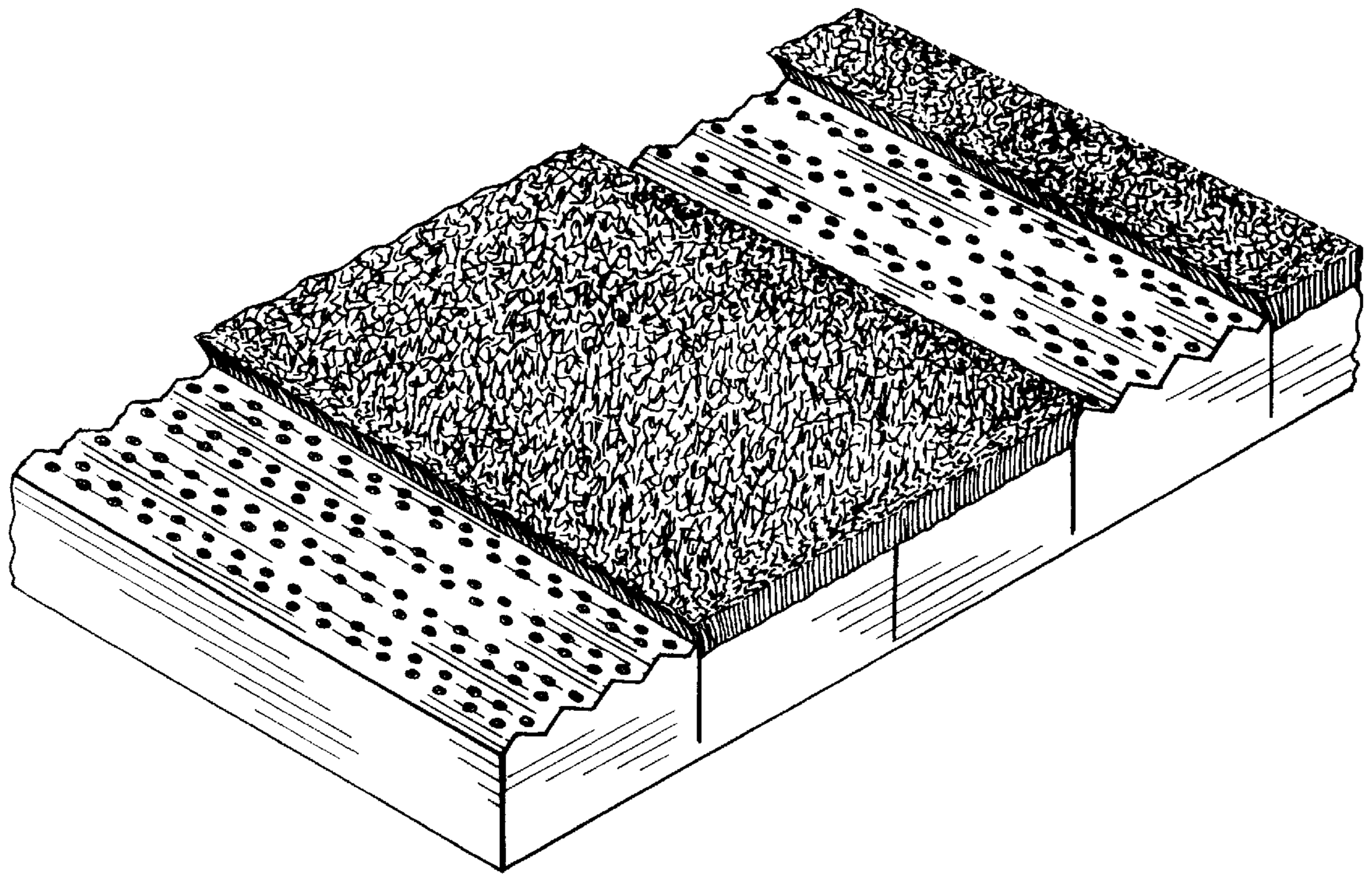
