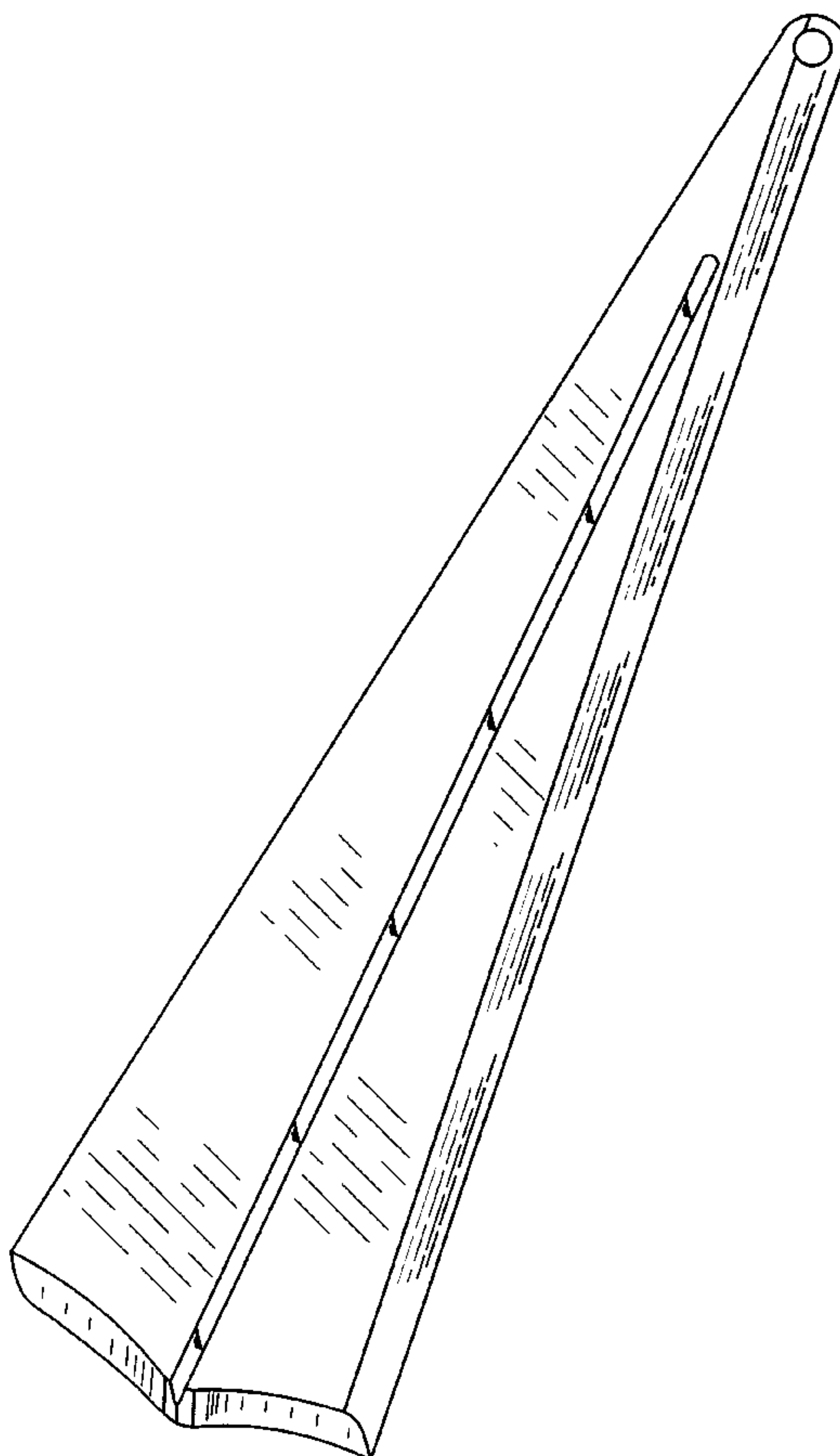

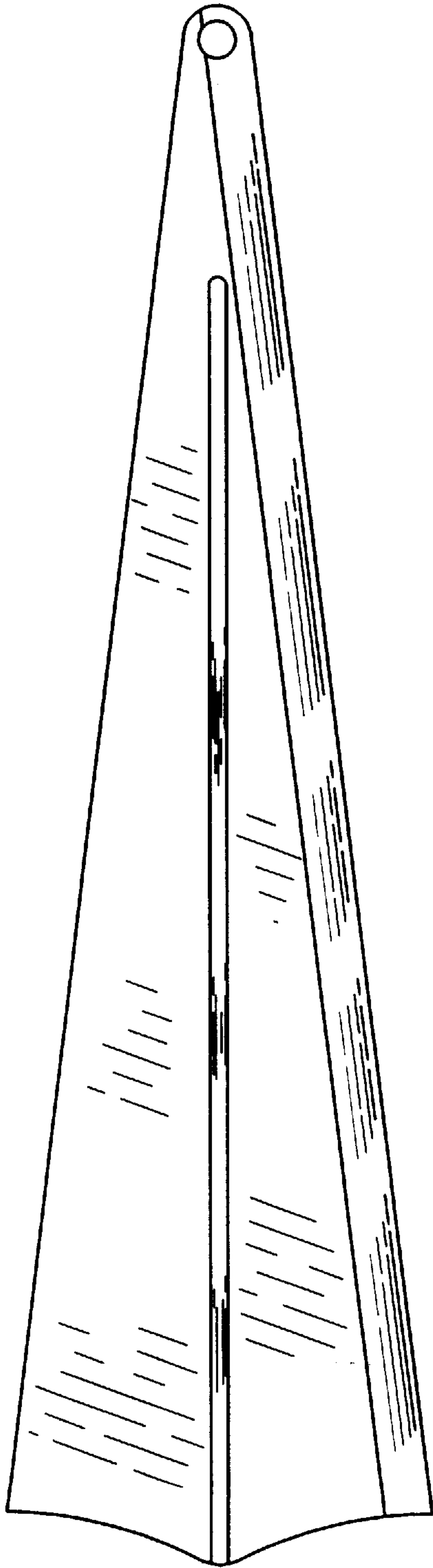
The ornamental design for a sharpening device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a sharpening device showing my new design;

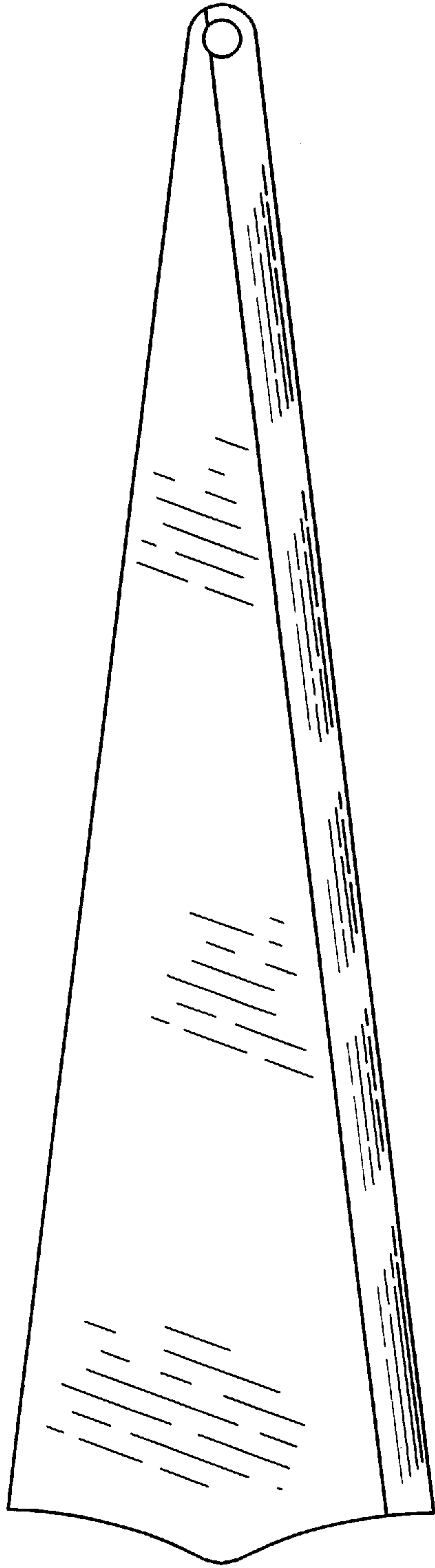

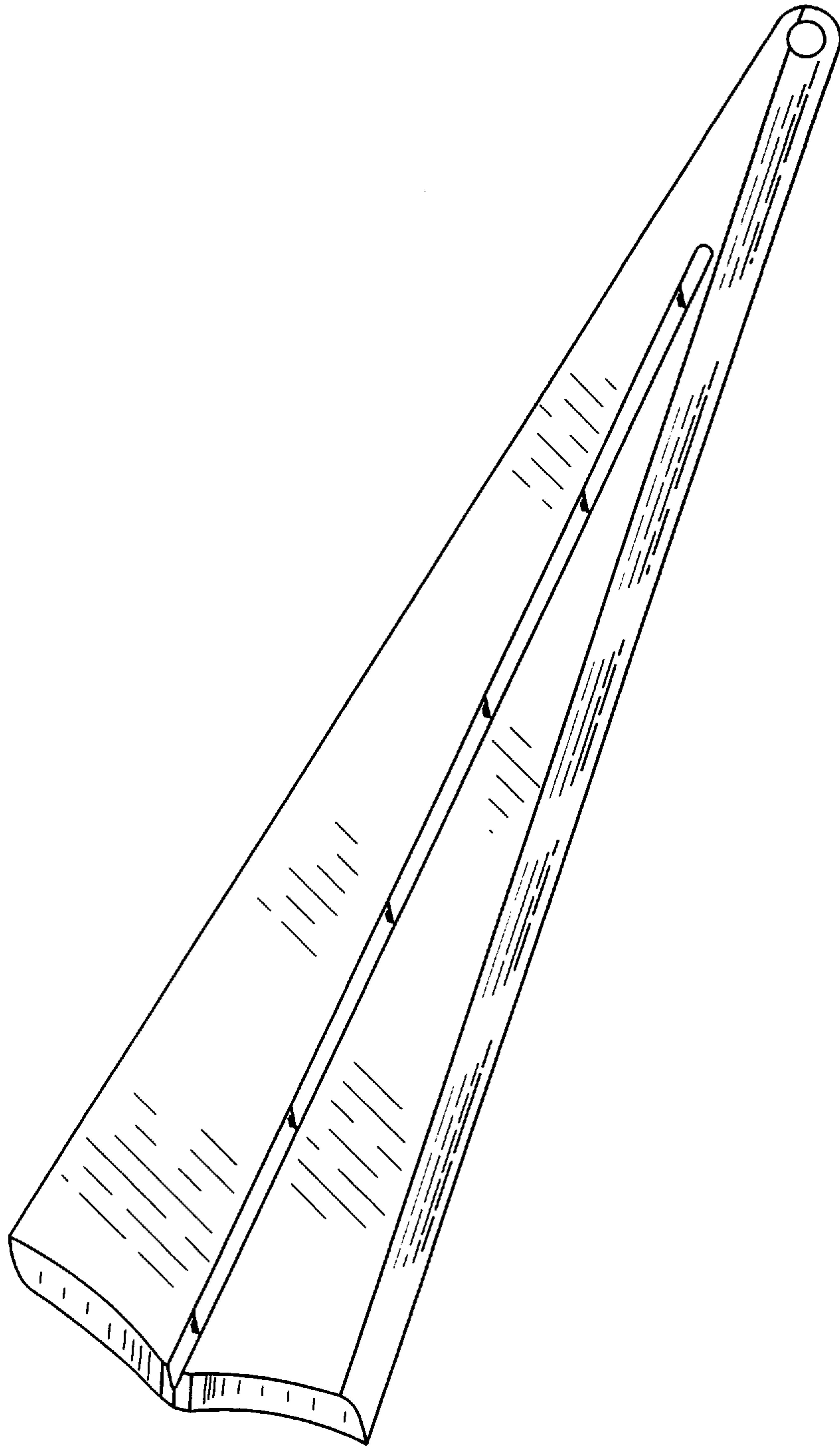
