The ornamental design for a combined bottle and bottle cap,
as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined bottle and bottle
cap showing my new design;

FIG. 2 is a front elevational view thereof, the rear elevational
view being the same;

FIG. 3 is a right side view thereof, the left side view being
the same;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a perspective view of a combined bottle and bottle
cap showing a second embodiment of my new design;

FIG. 7 is a front elevational view of FIG. 6, the rear
elevational view being the same;

FIG. 8 is a right side view of FIG. 6, the left side view being
the same;

FIG. 9 is a top plan view of FIG. 6;

FIG. 10 is a bottom plan view of FIG. 6;

FIG. 11 is a perspective view of a combined bottle and bottle
cap showing a third embodiment of my new design;

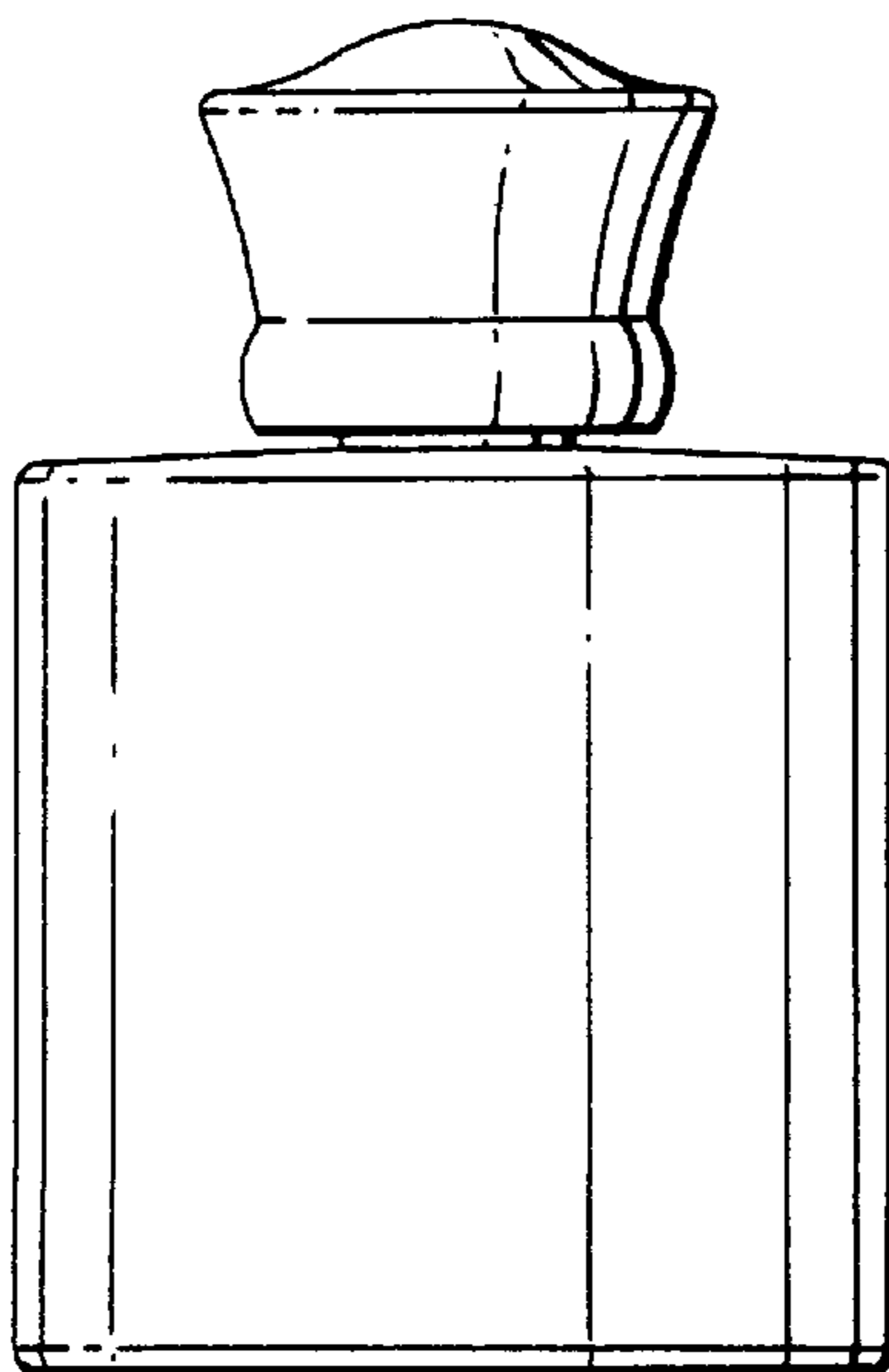
FIG. 12 is a front elevation view of FIG. 11, the rear

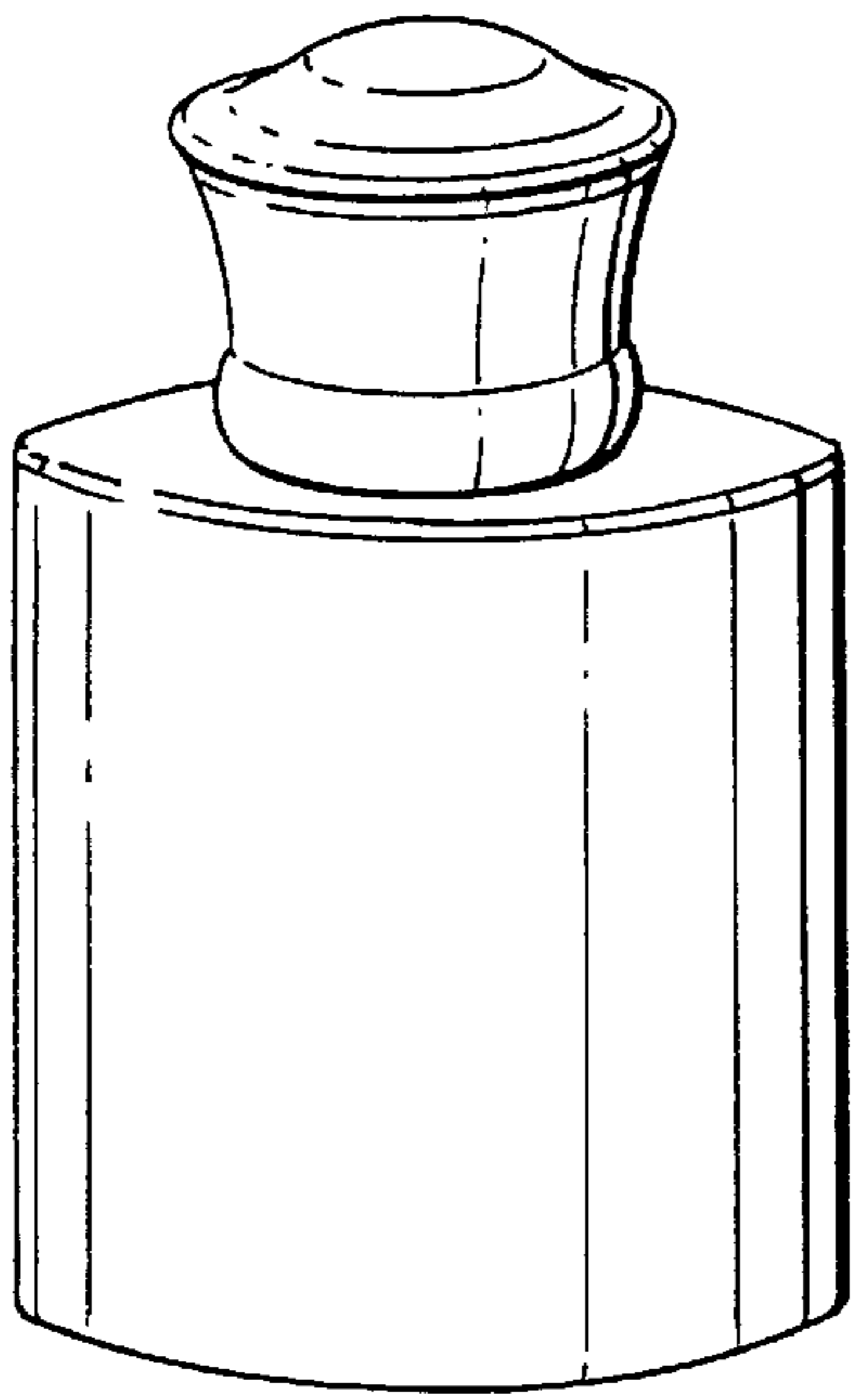

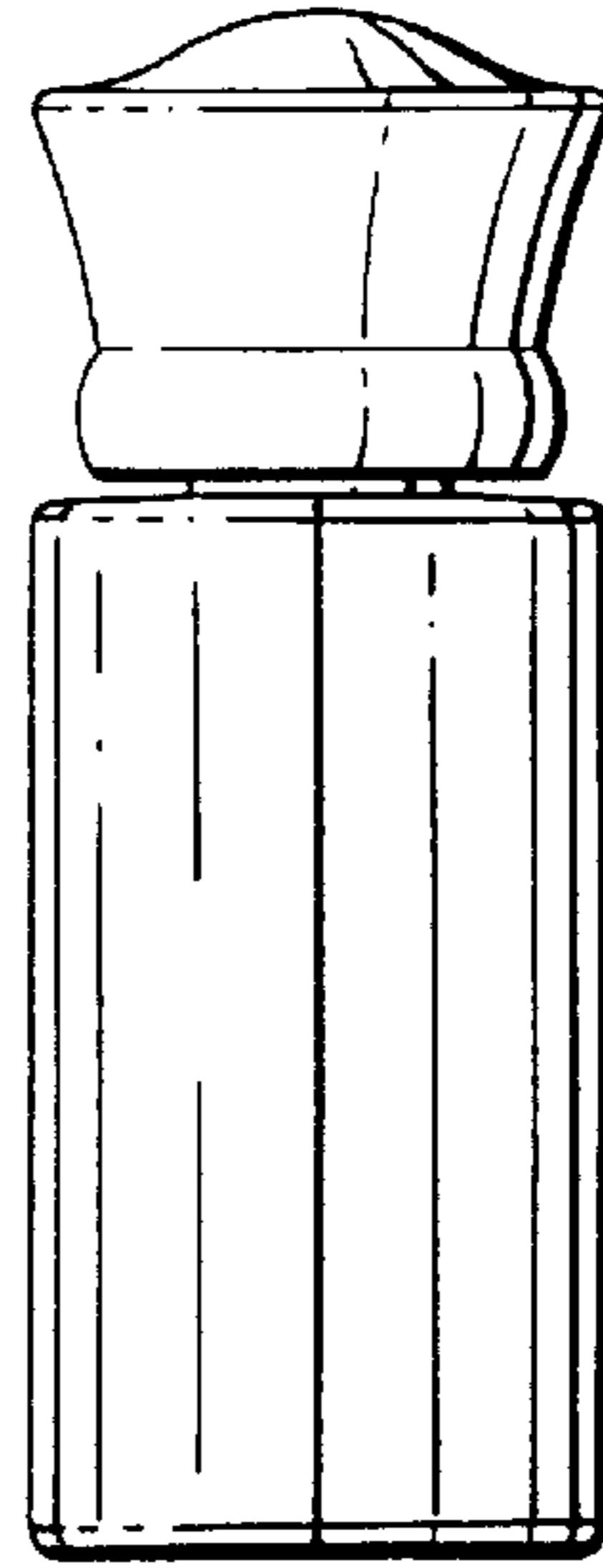

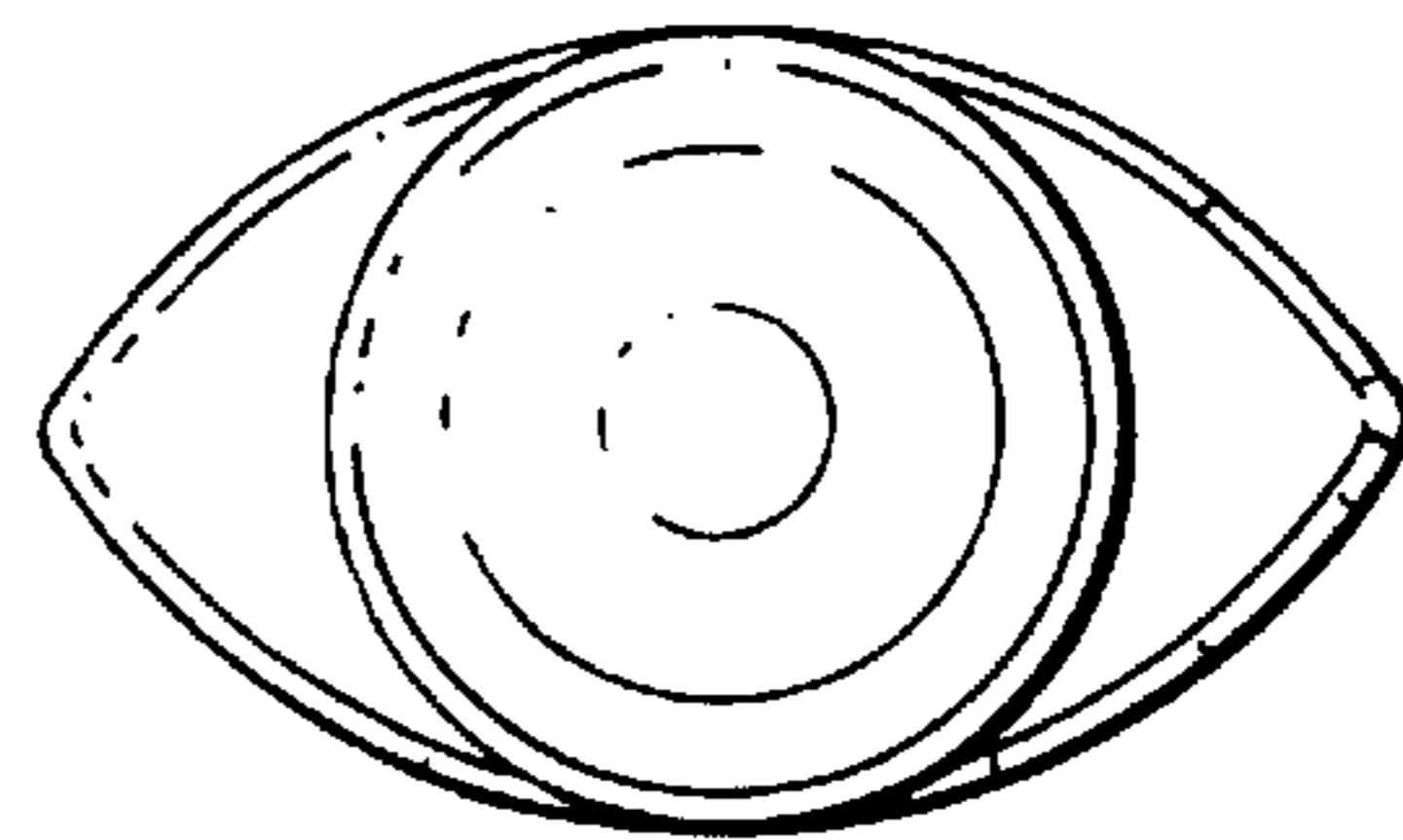

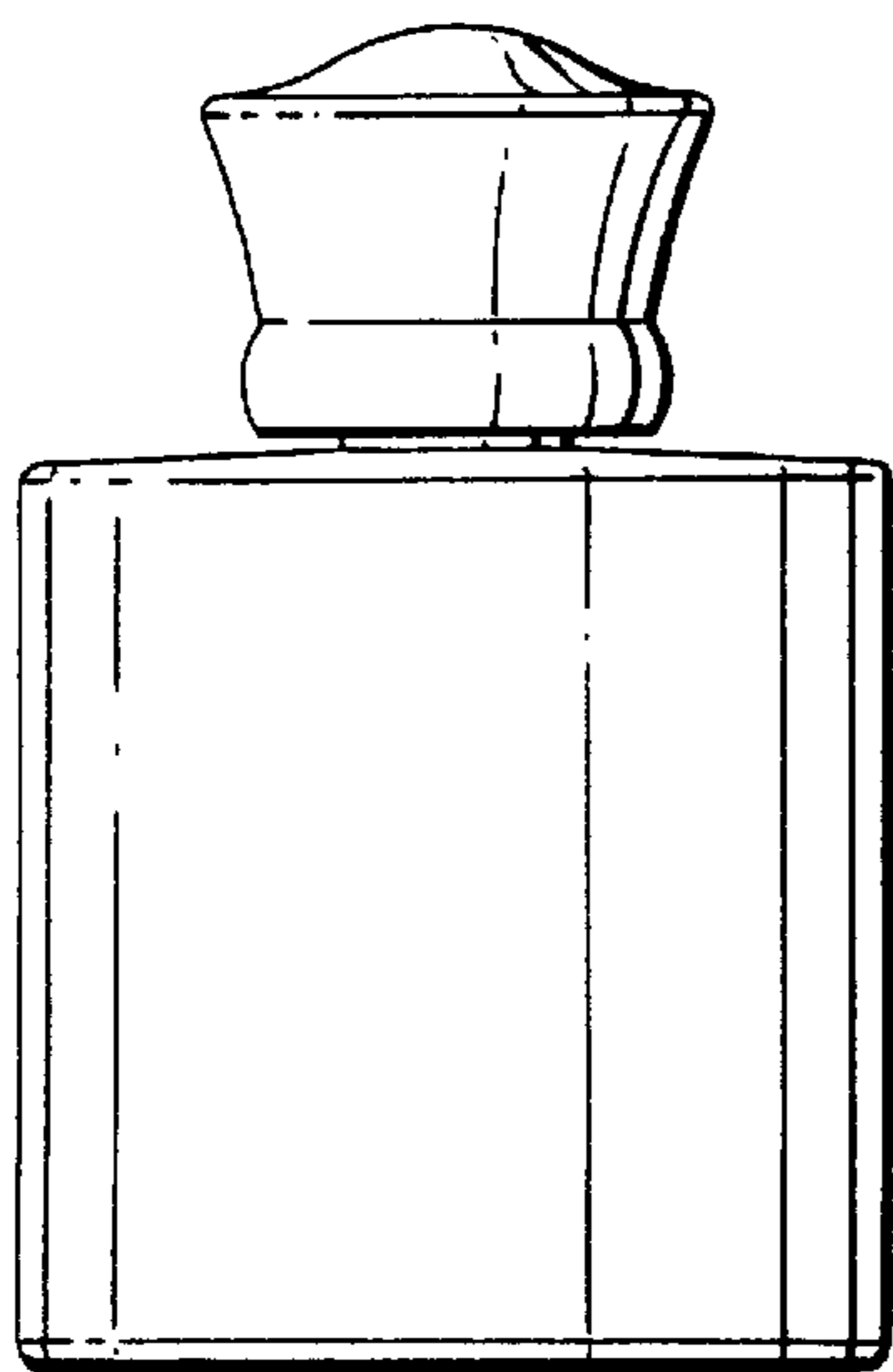

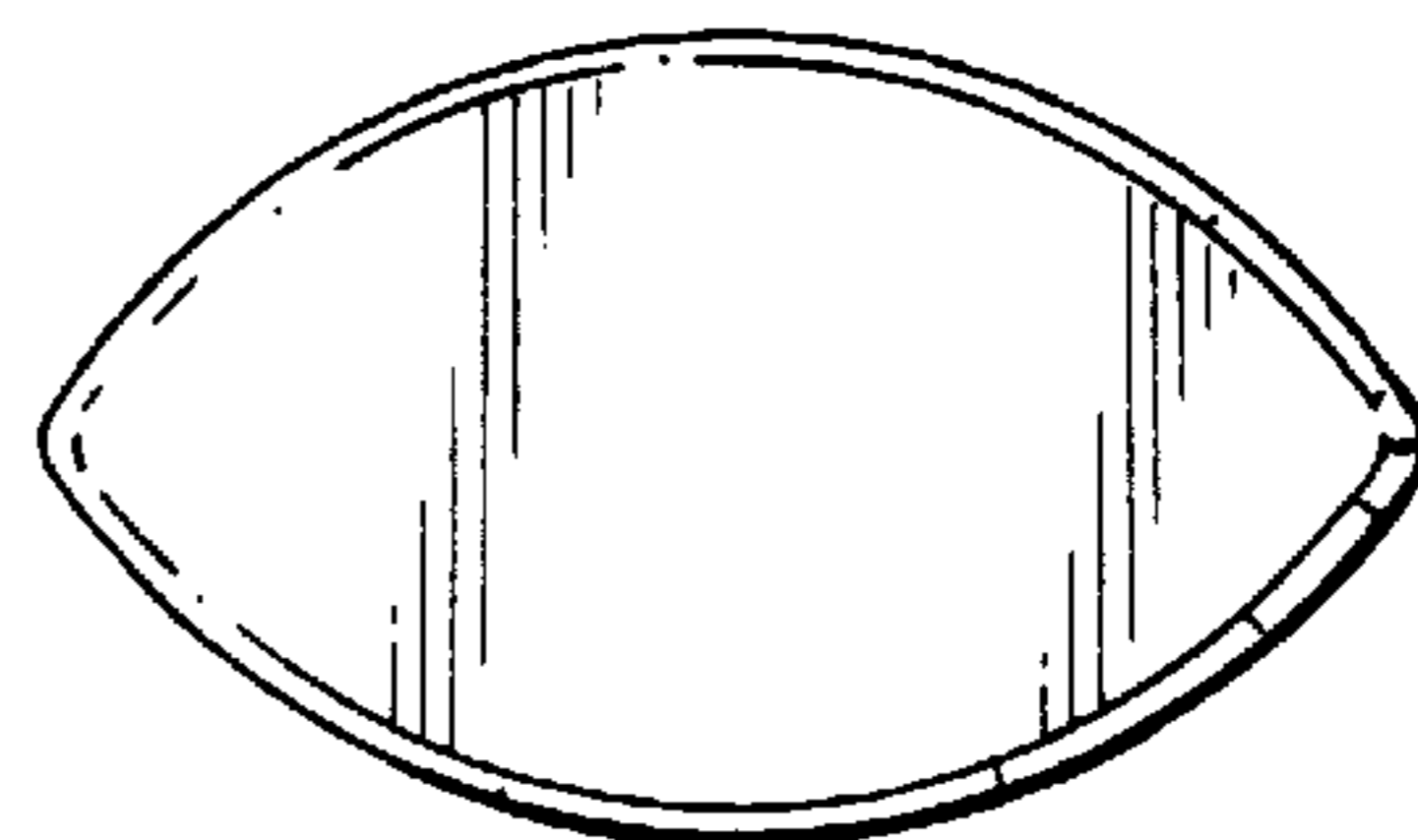

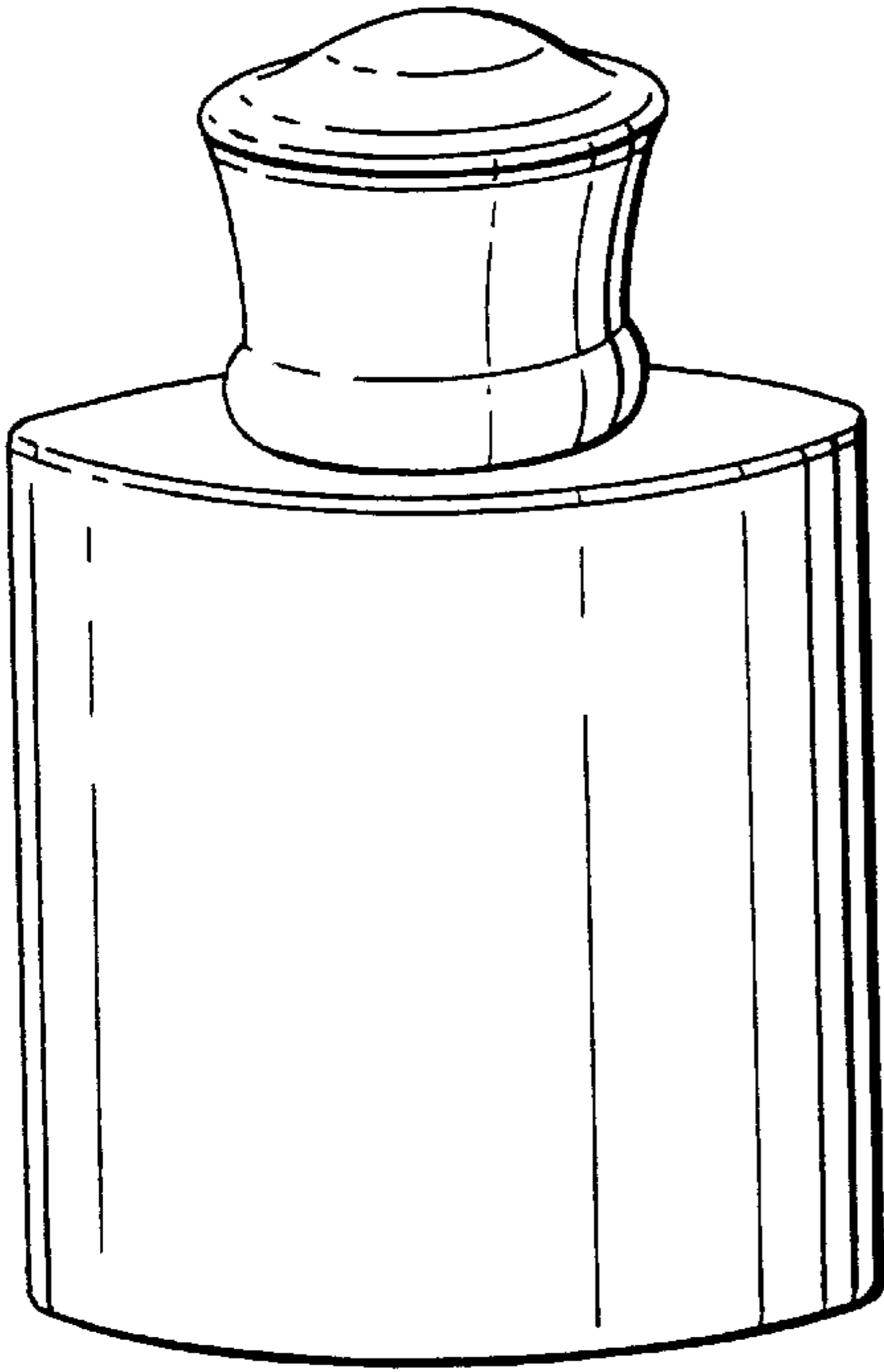

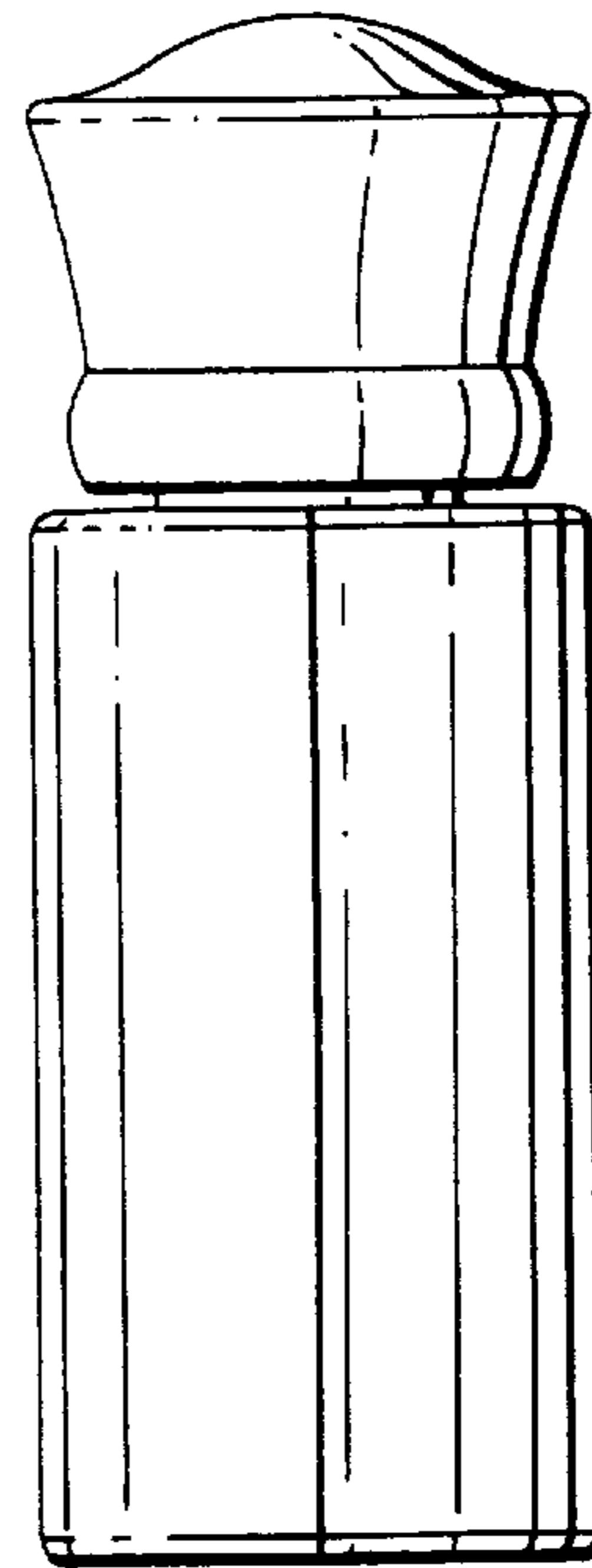

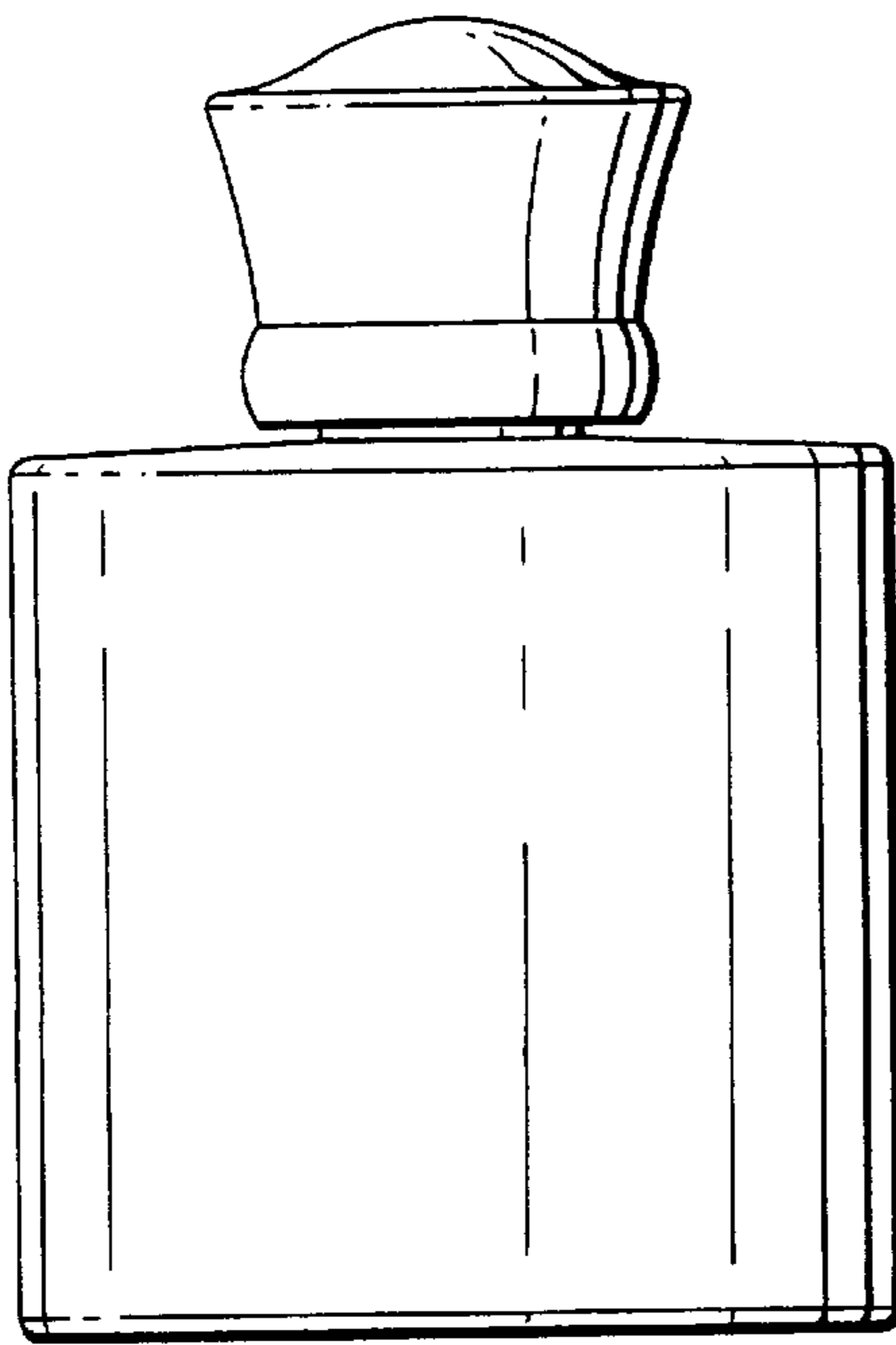

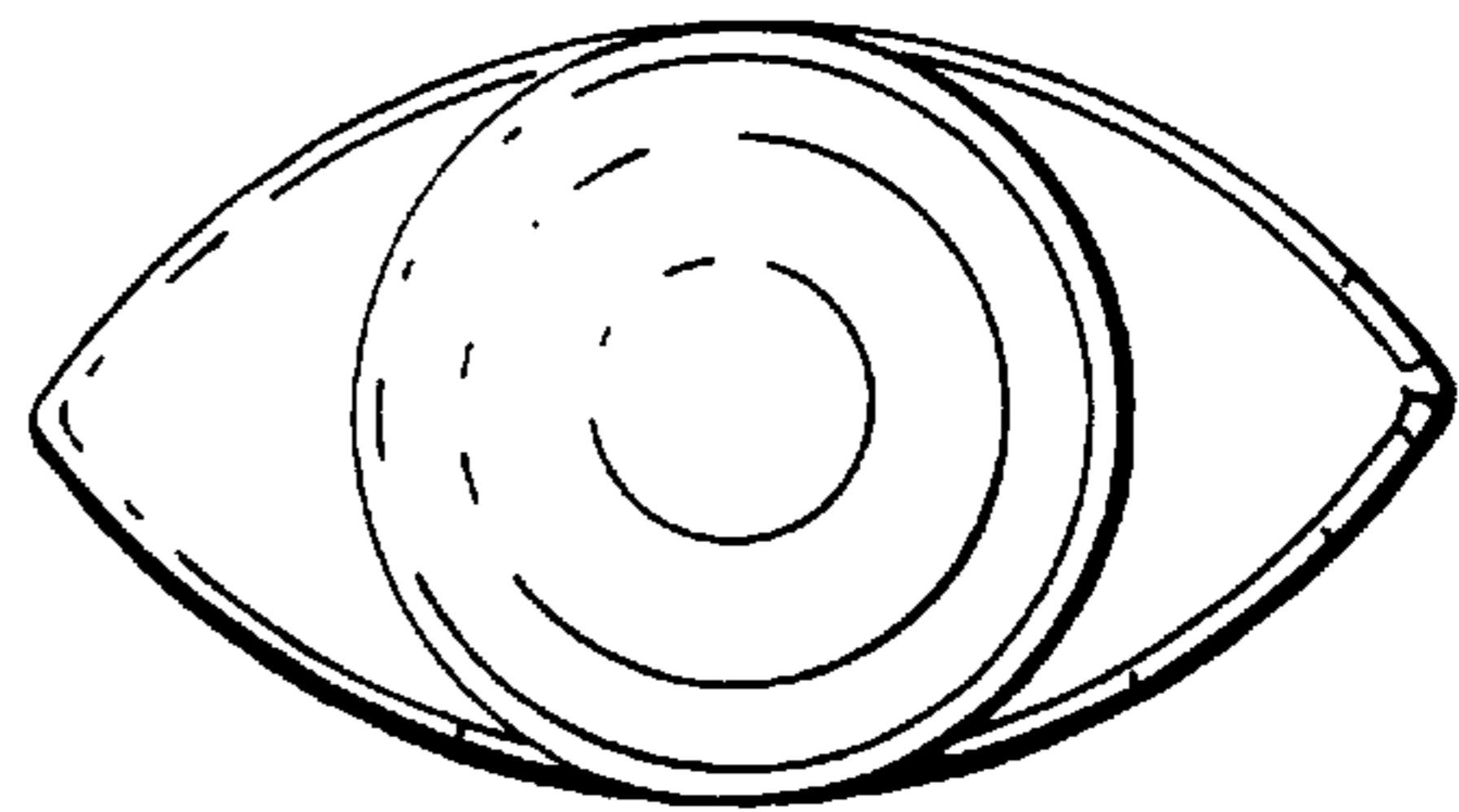

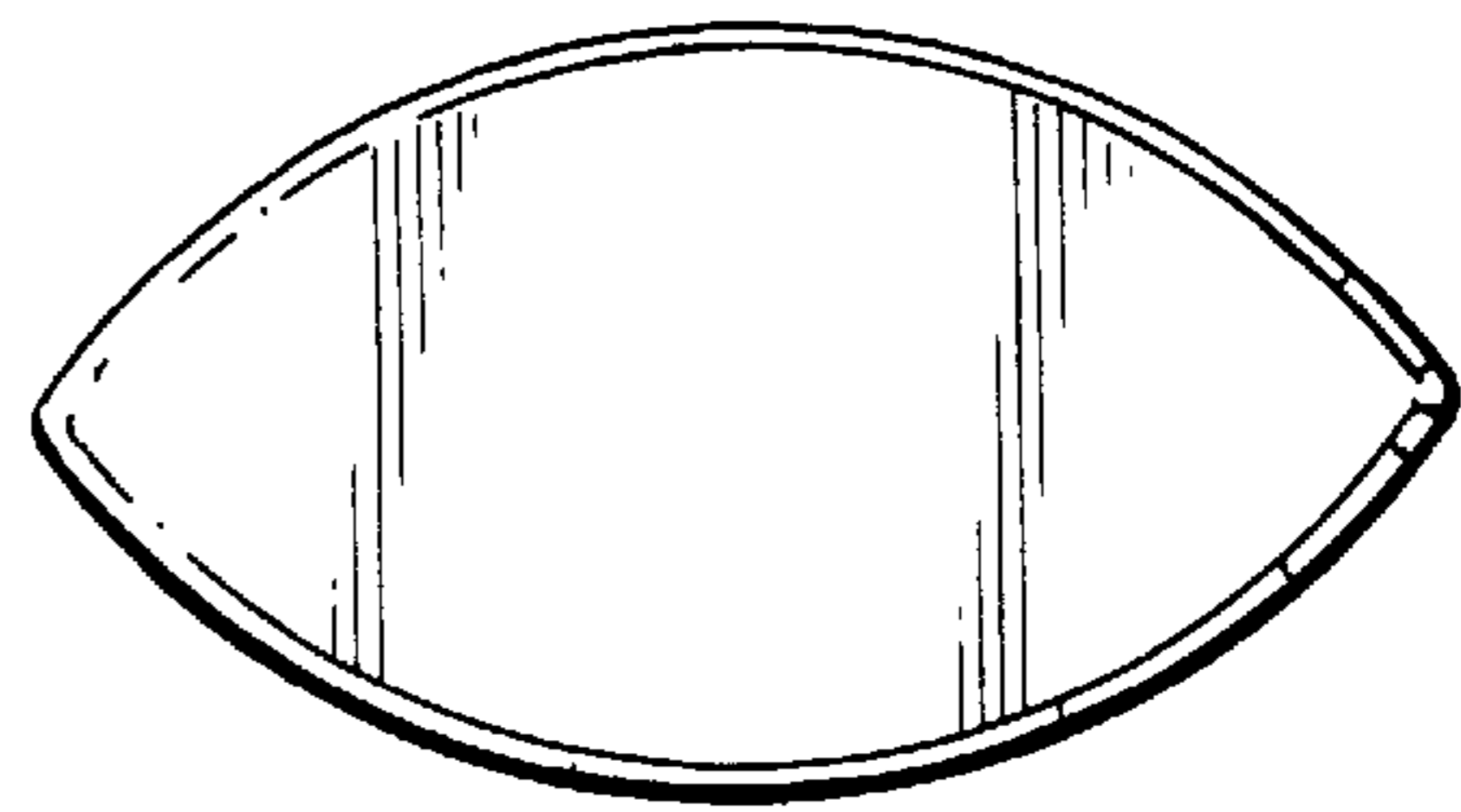

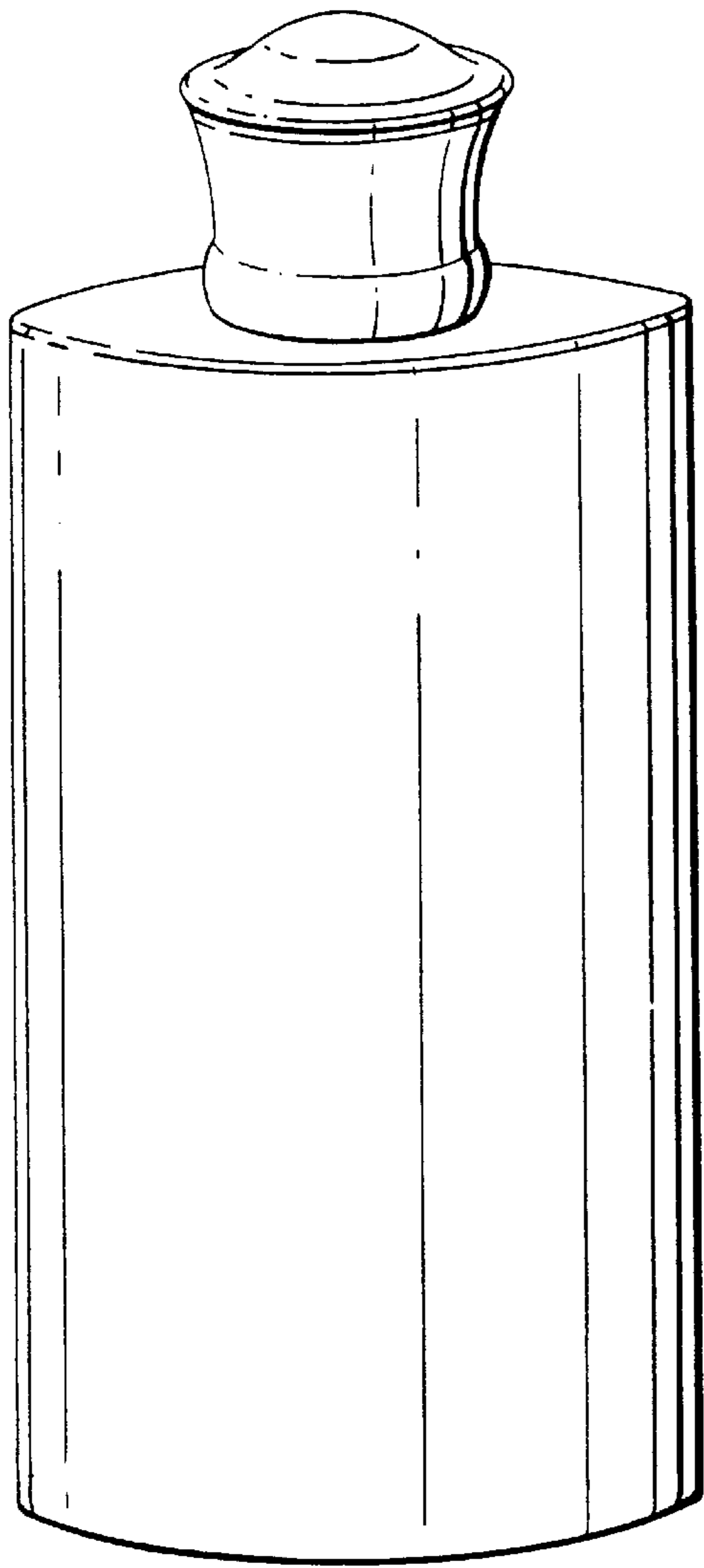

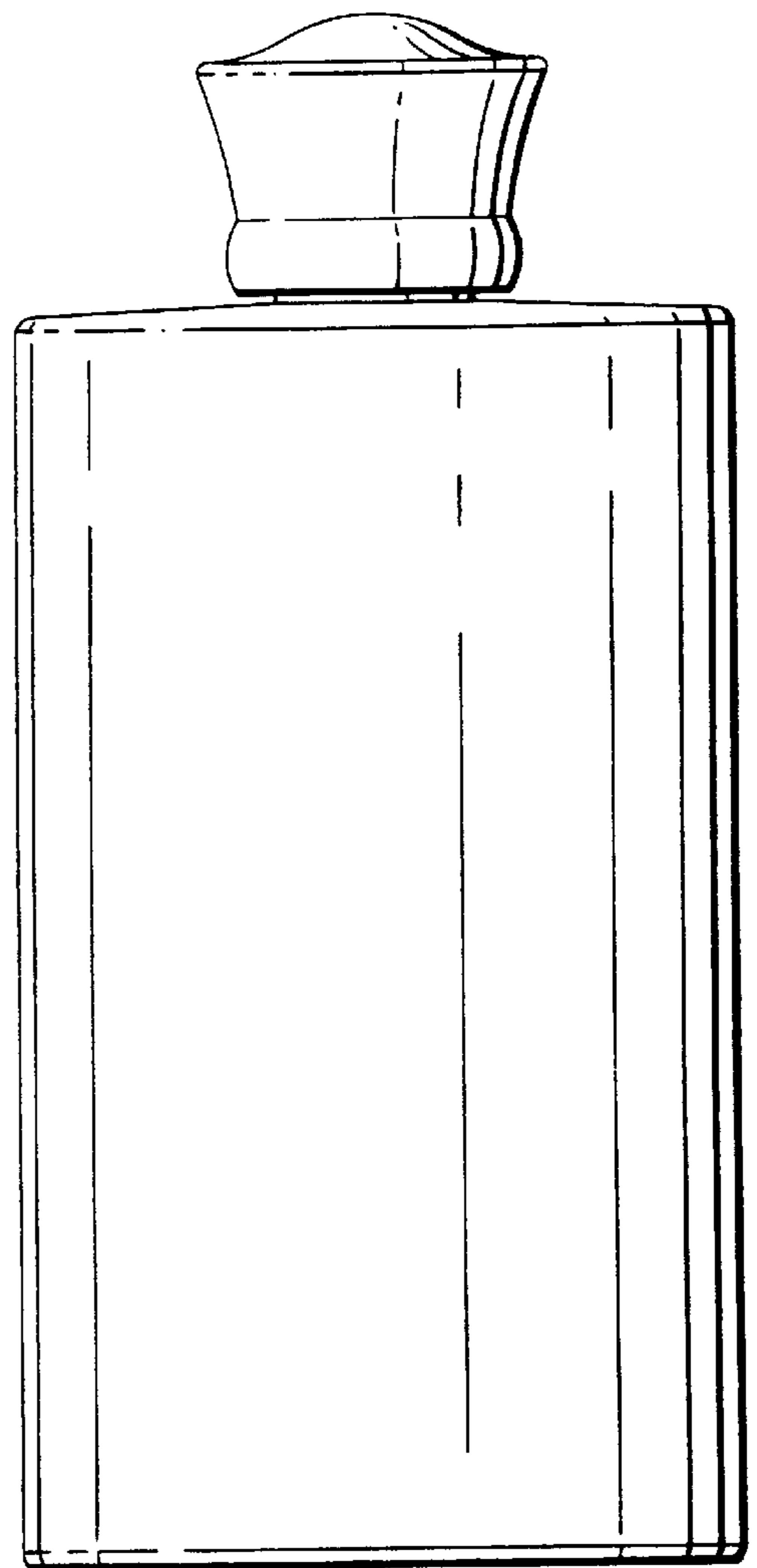

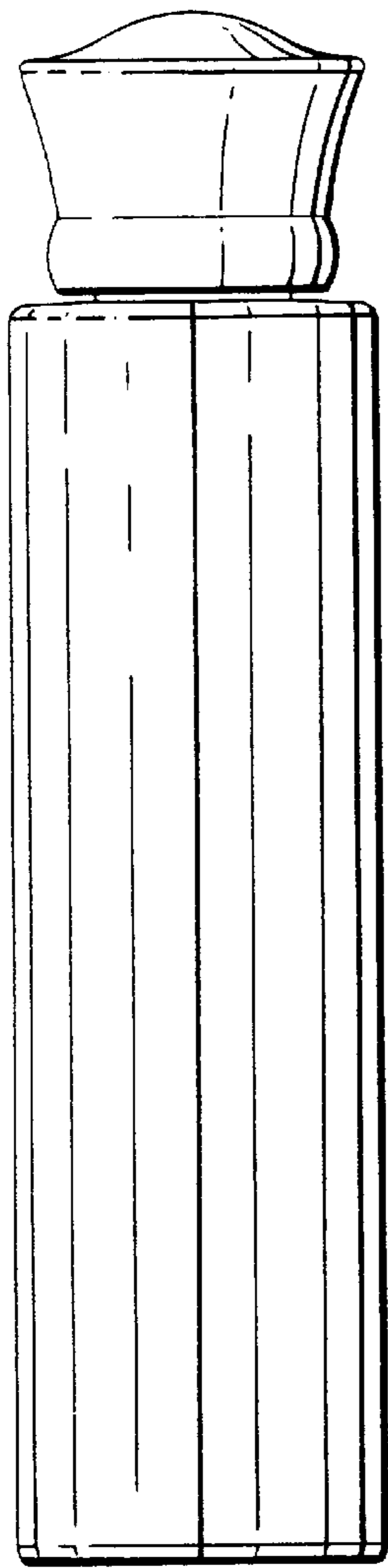

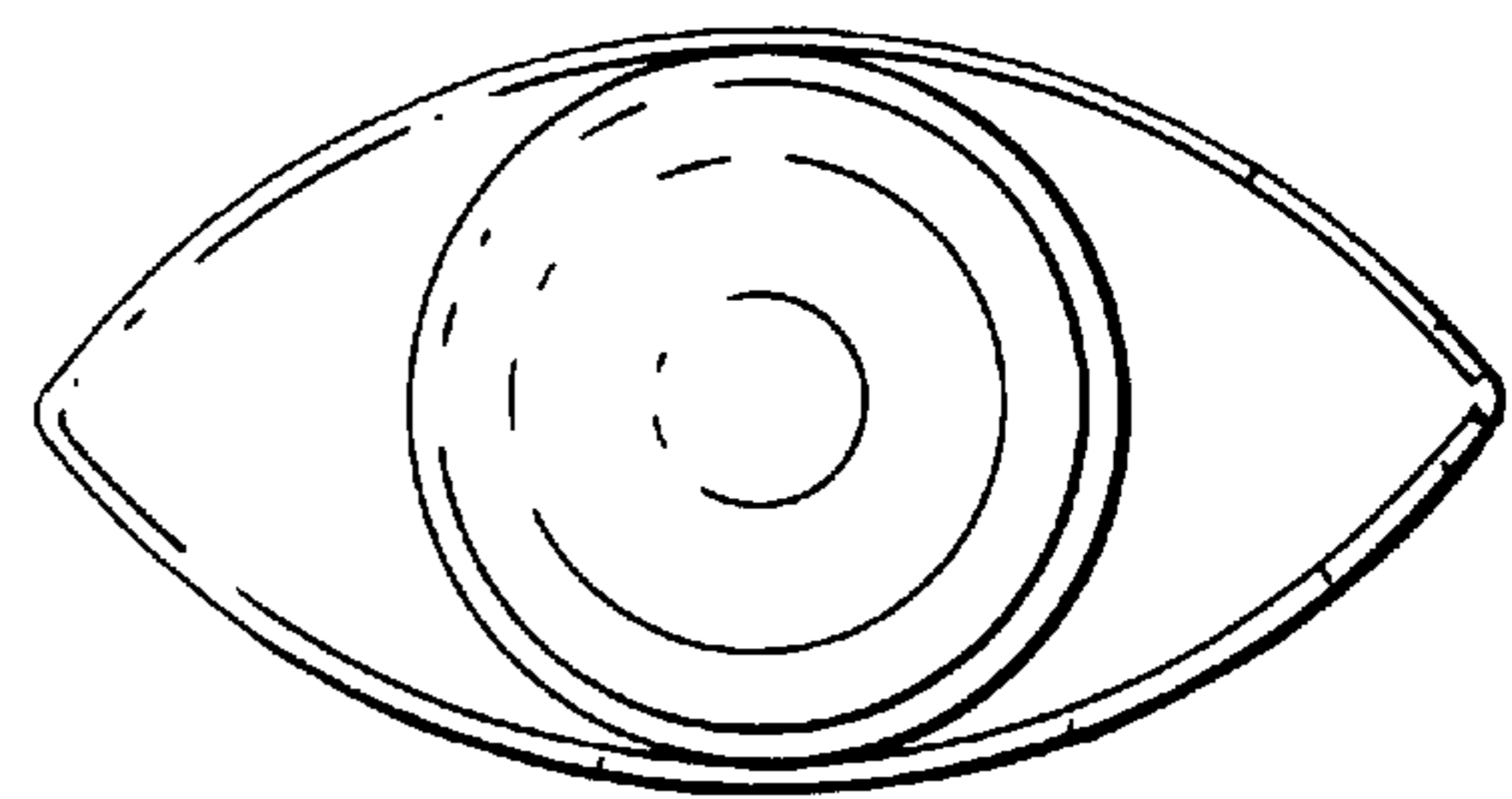

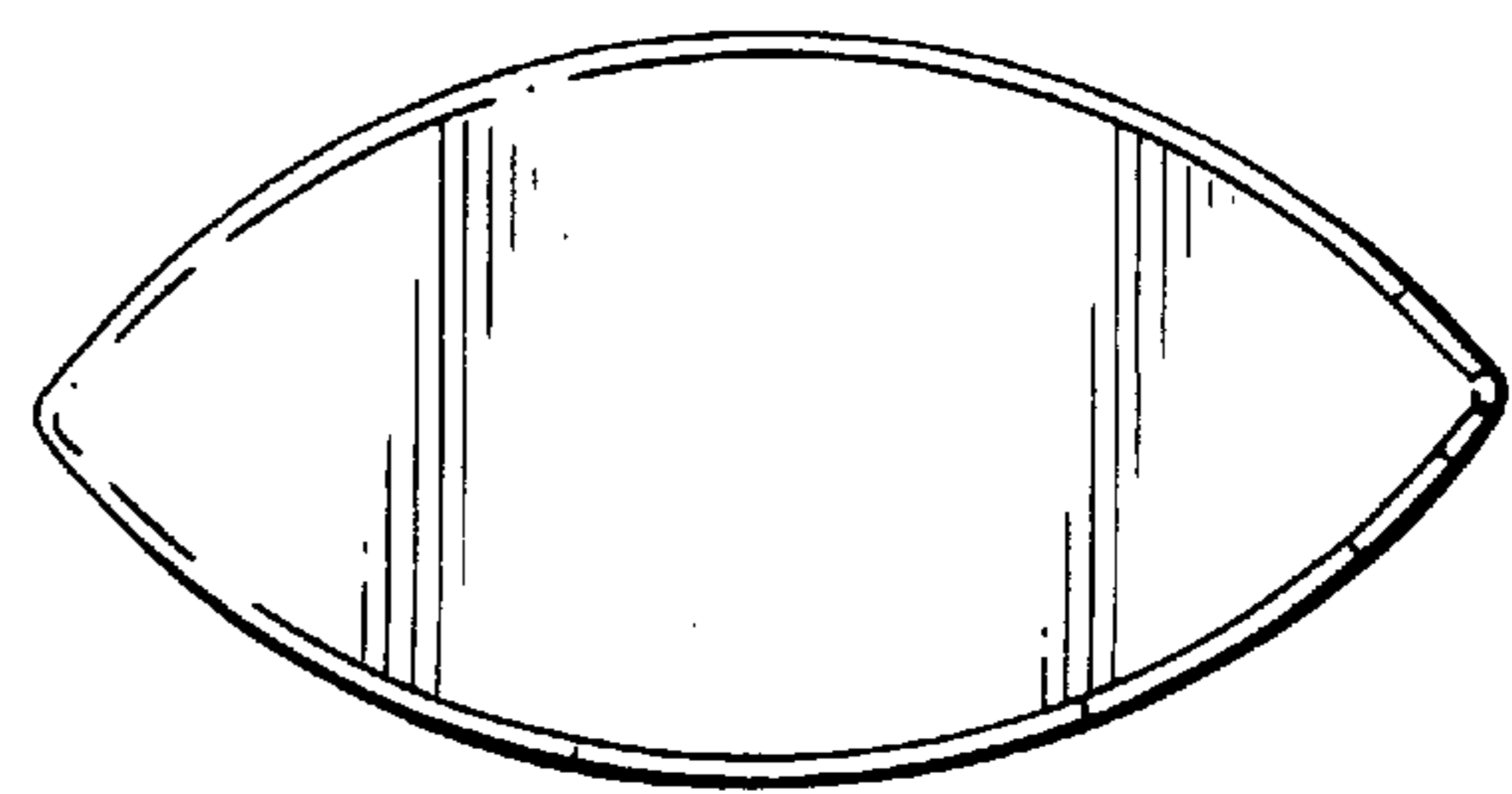
