DESCRIPTION

FIG. 1 is a perspective view of a hood ornament, showing my new design;
FIG. 2 is a reduced right side view thereof, it being understood that the left side is a mirror image thereof;
FIG. 3 is a reduced front view thereof;
FIG. 4 is a reduced bottom view thereof;
FIG. 5 is a reduced rear view thereof; and,
FIG. 6 is a reduced top view thereof.

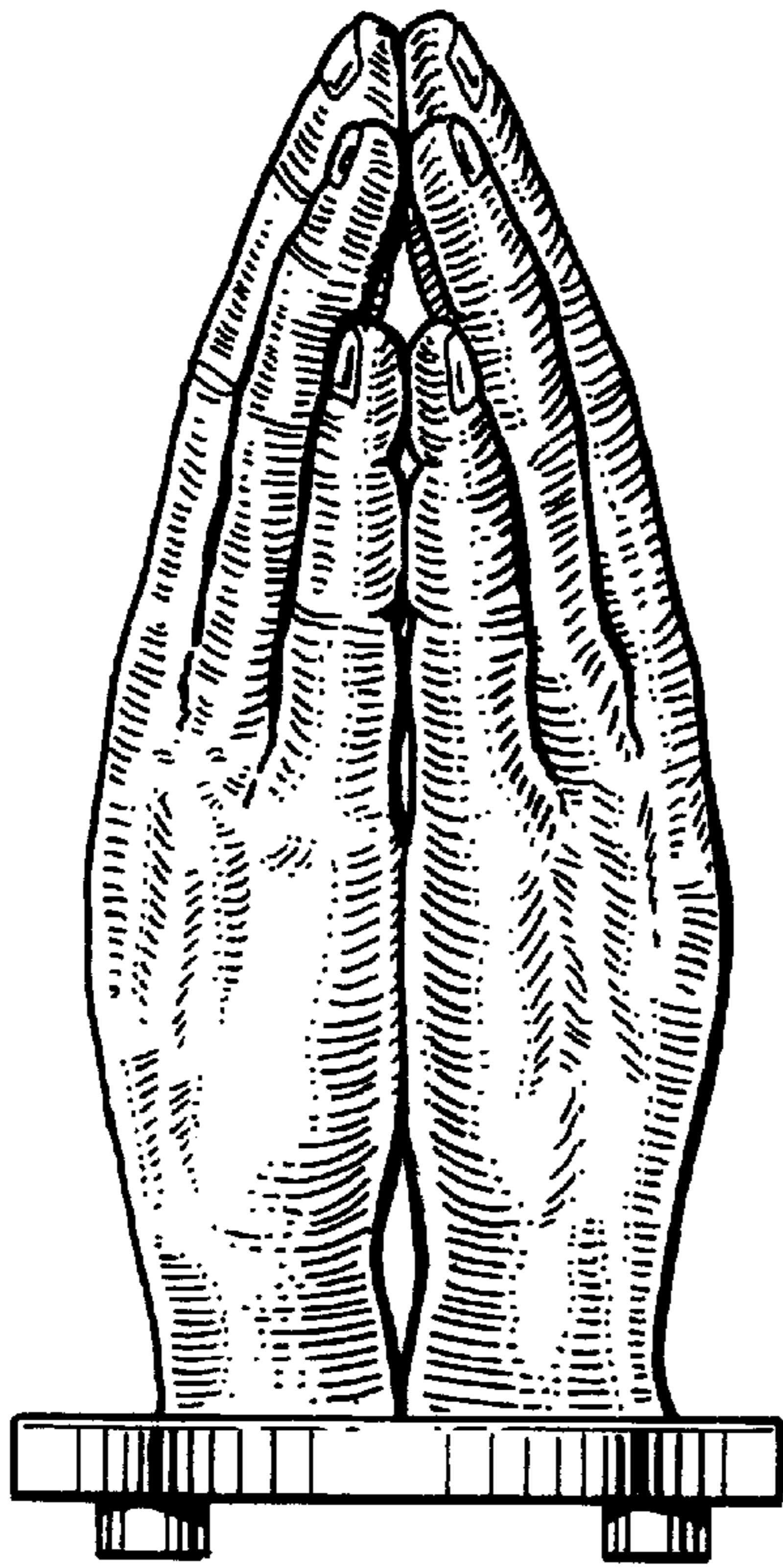

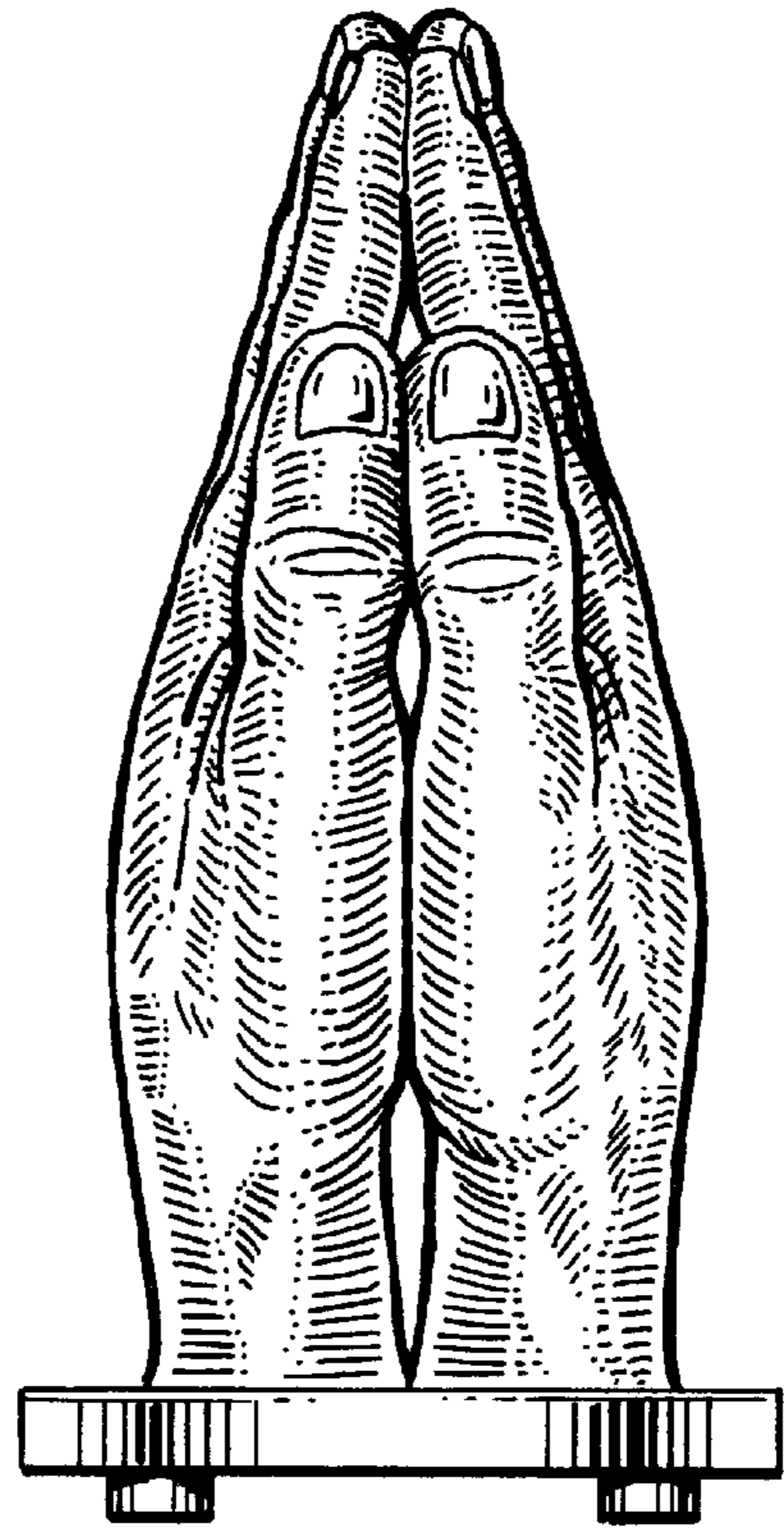

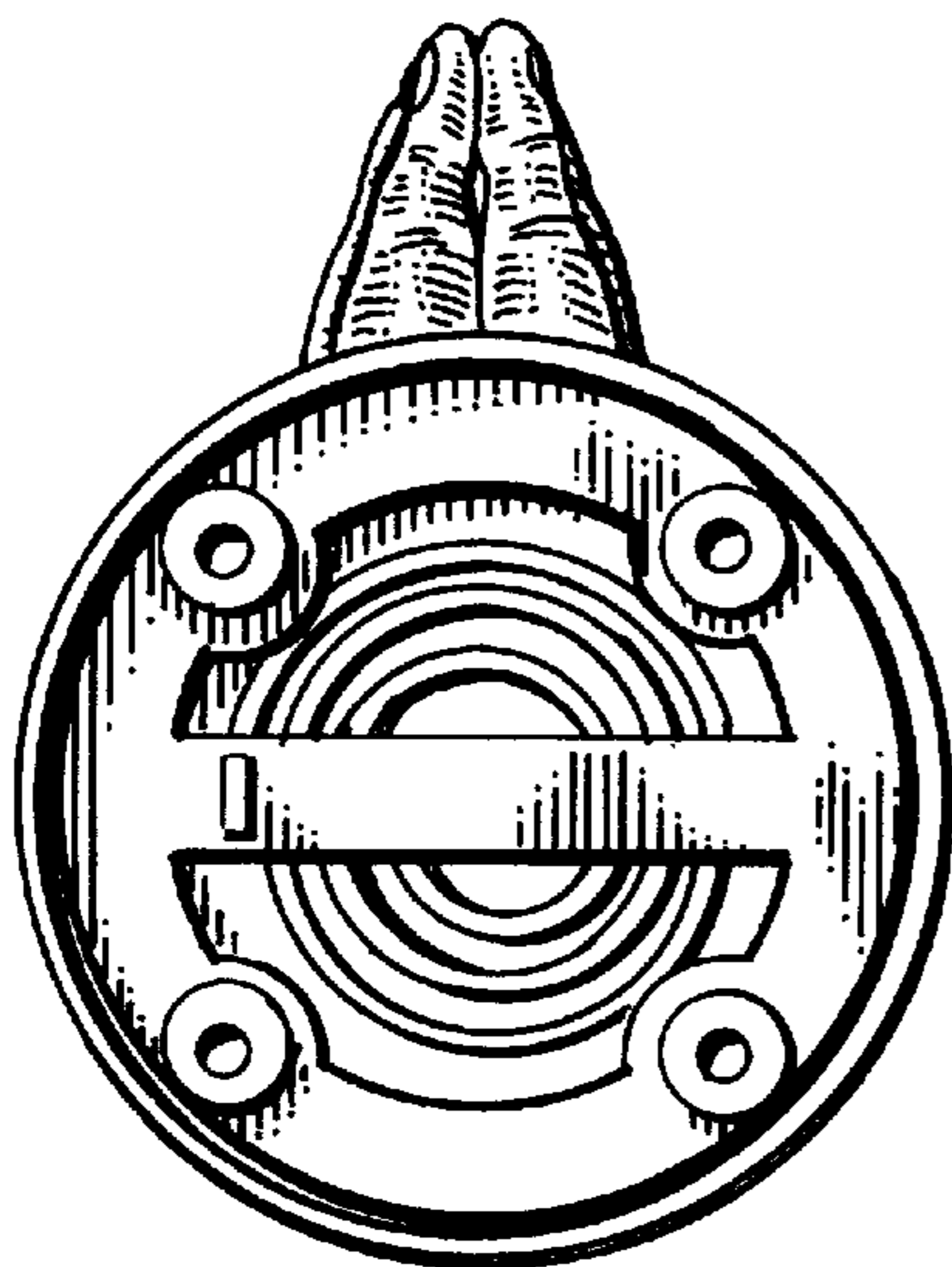

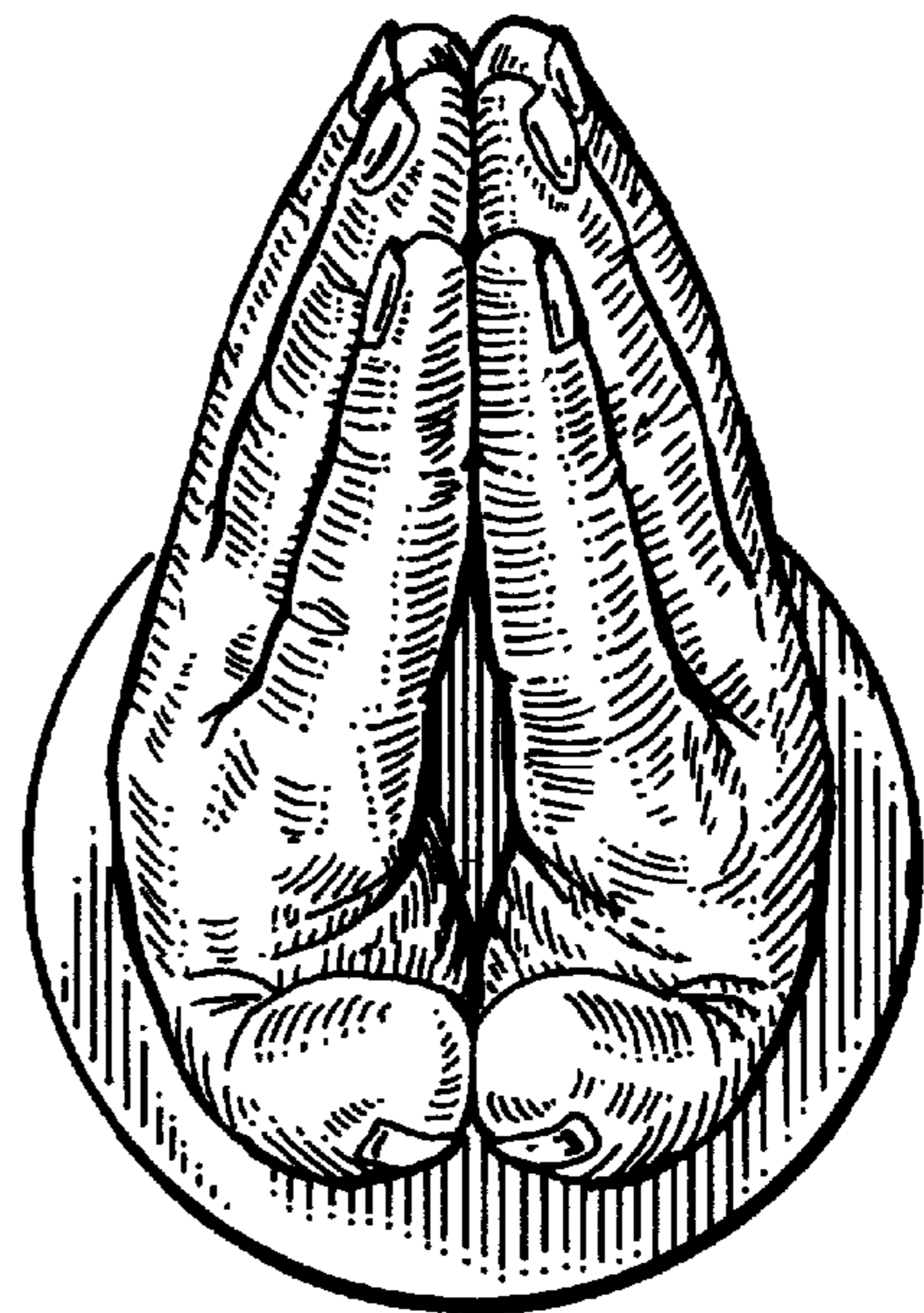
