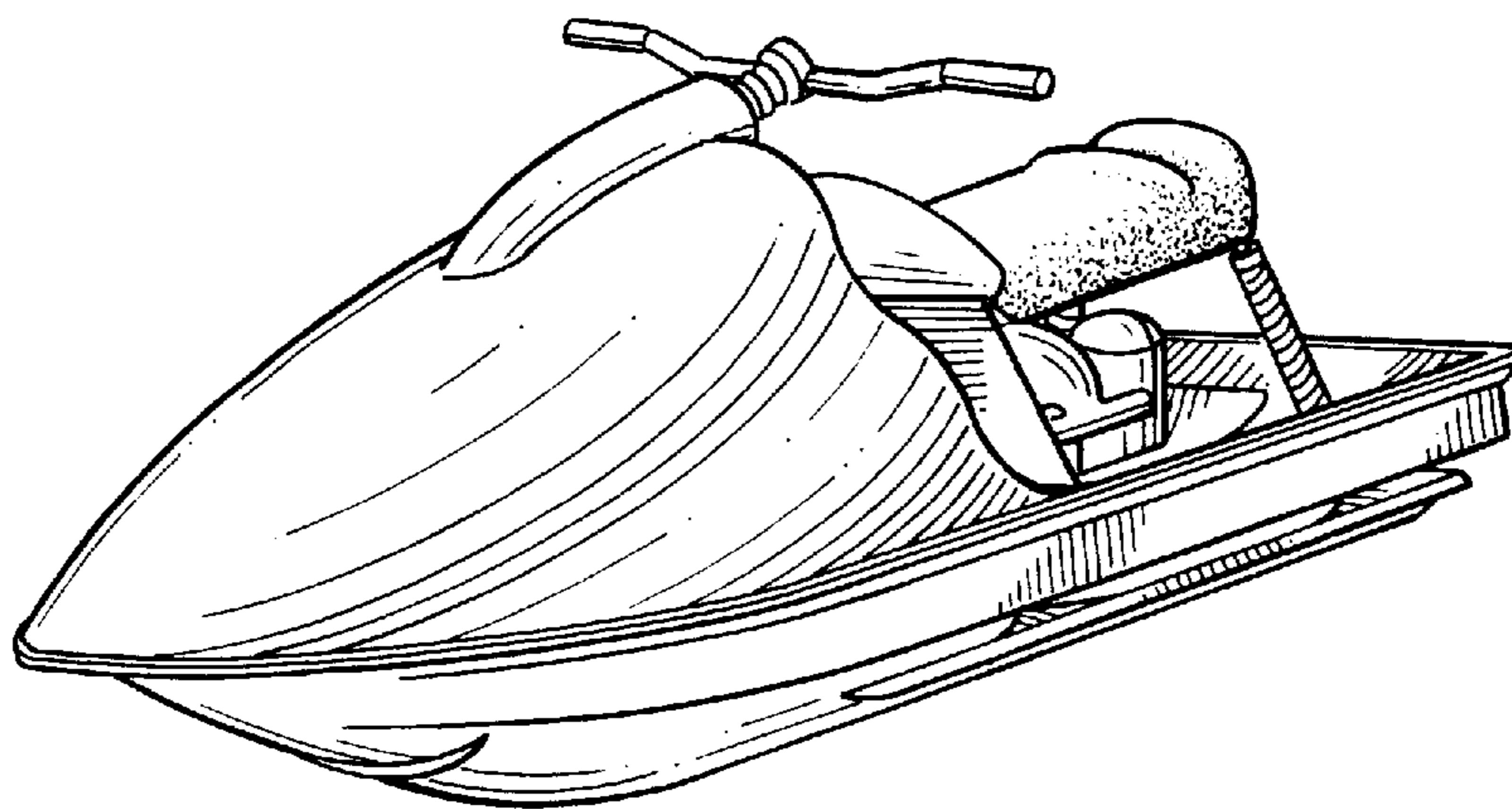
[57] **CLAIM**

The ornamental design for a personal watercraft, as shown and described.

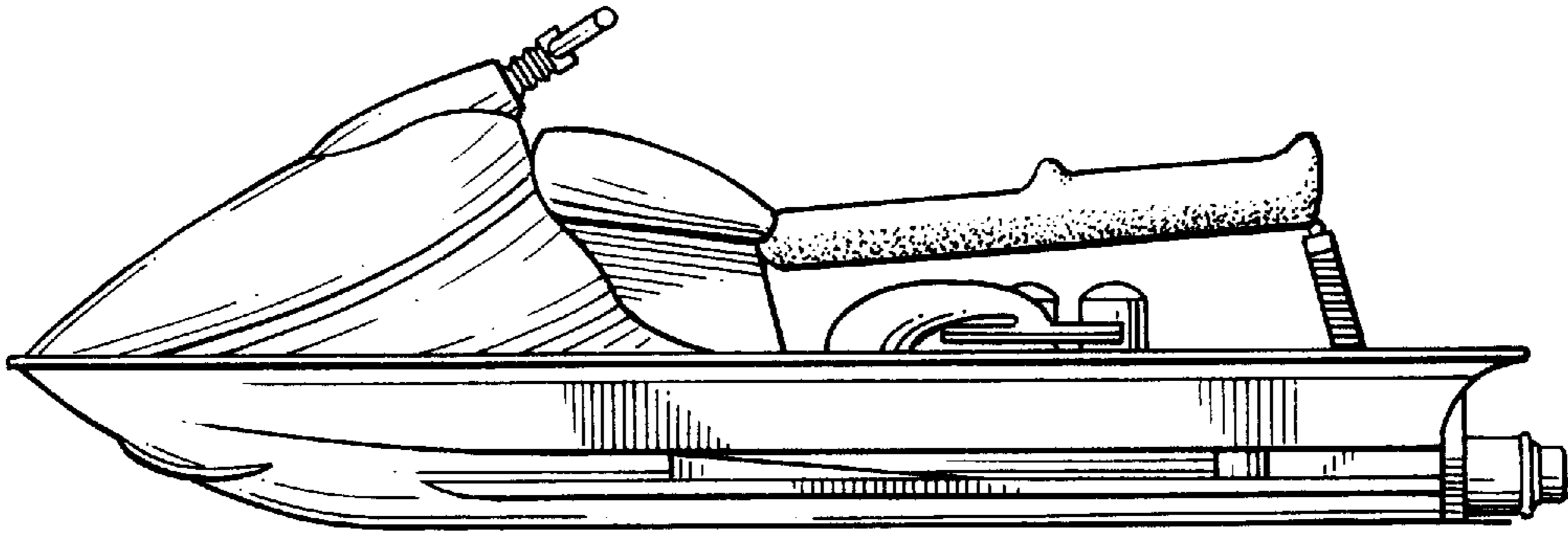

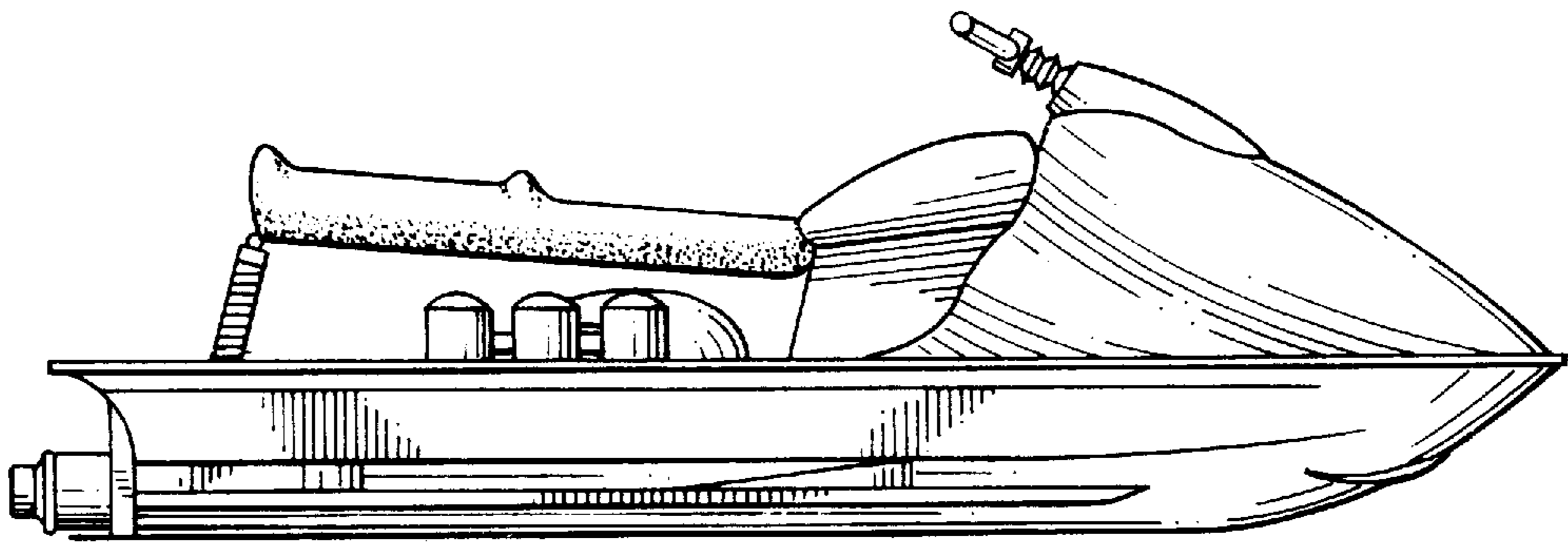

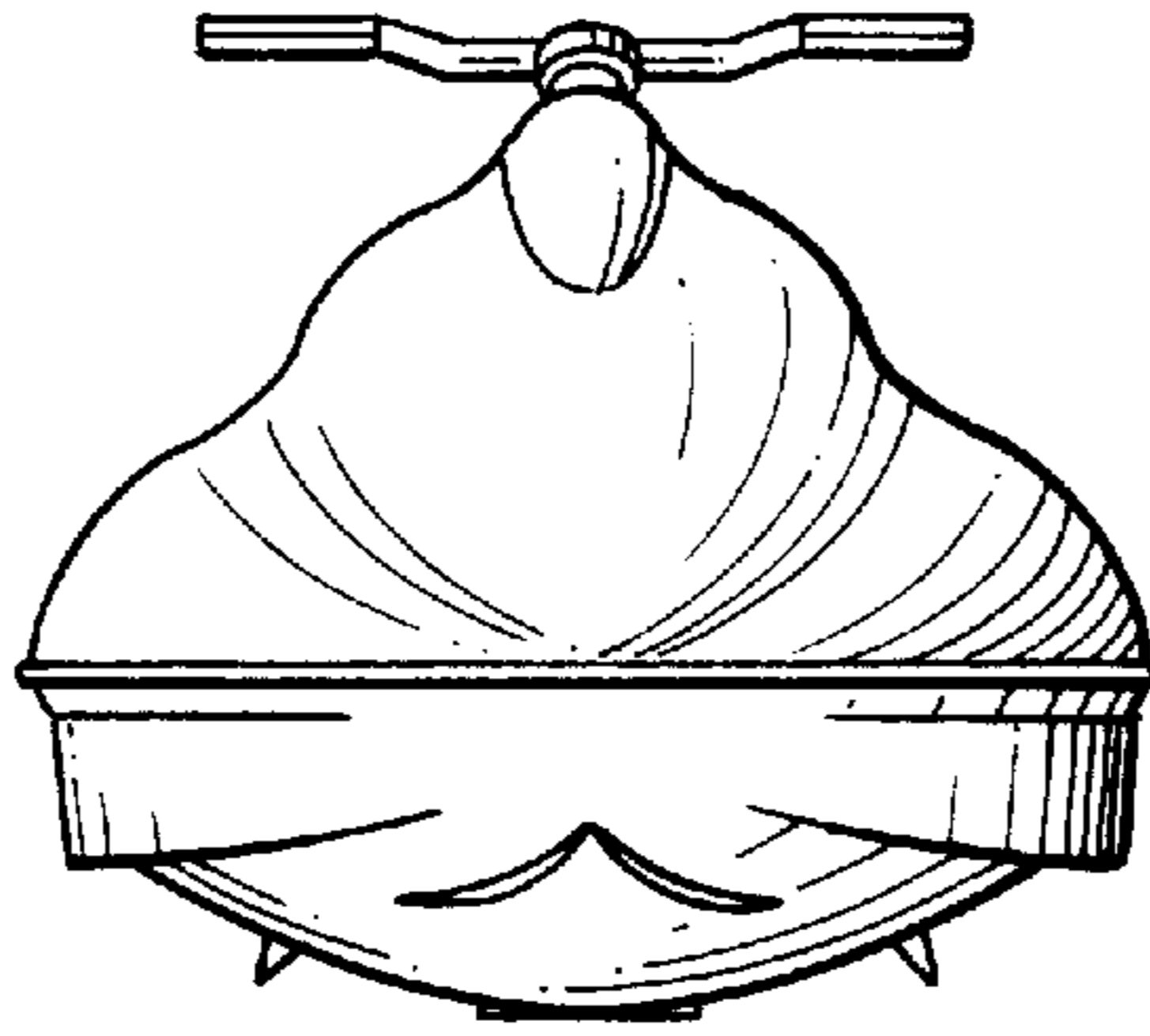

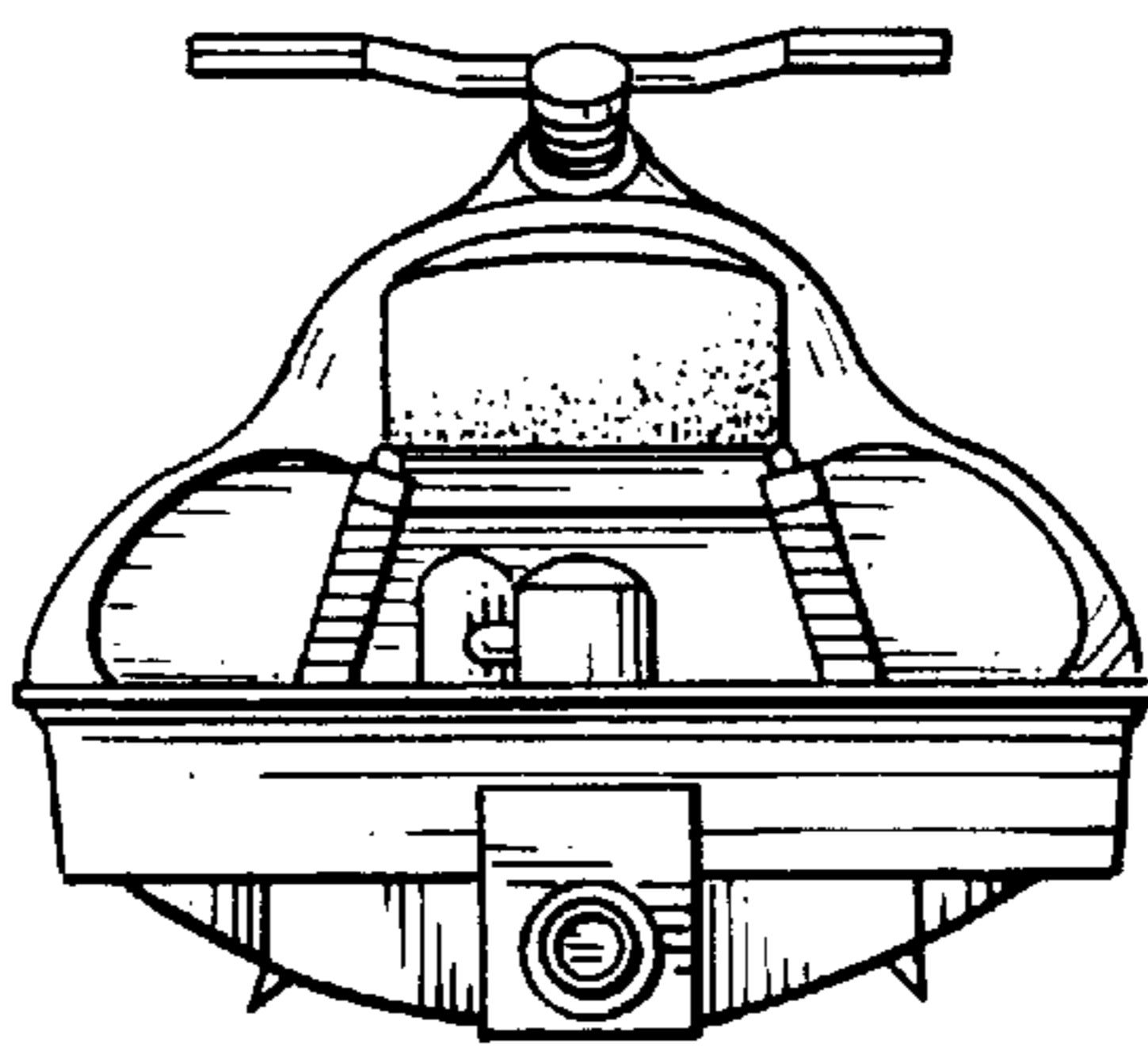

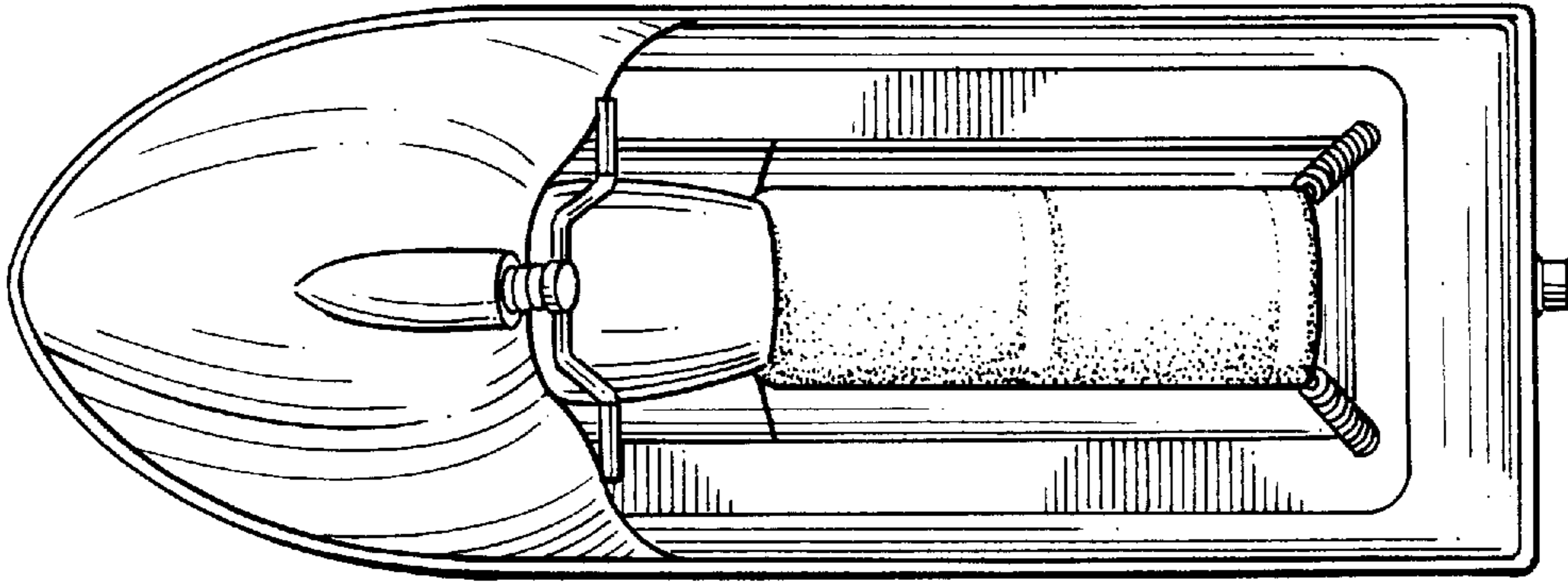

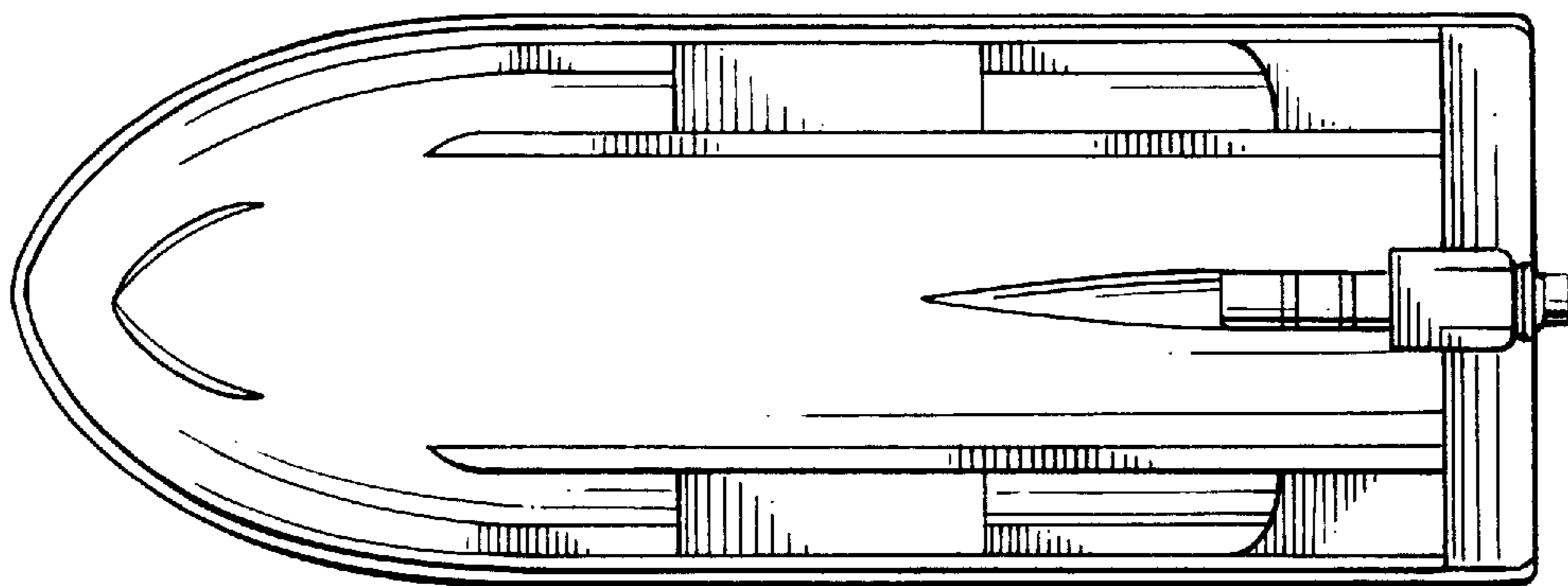

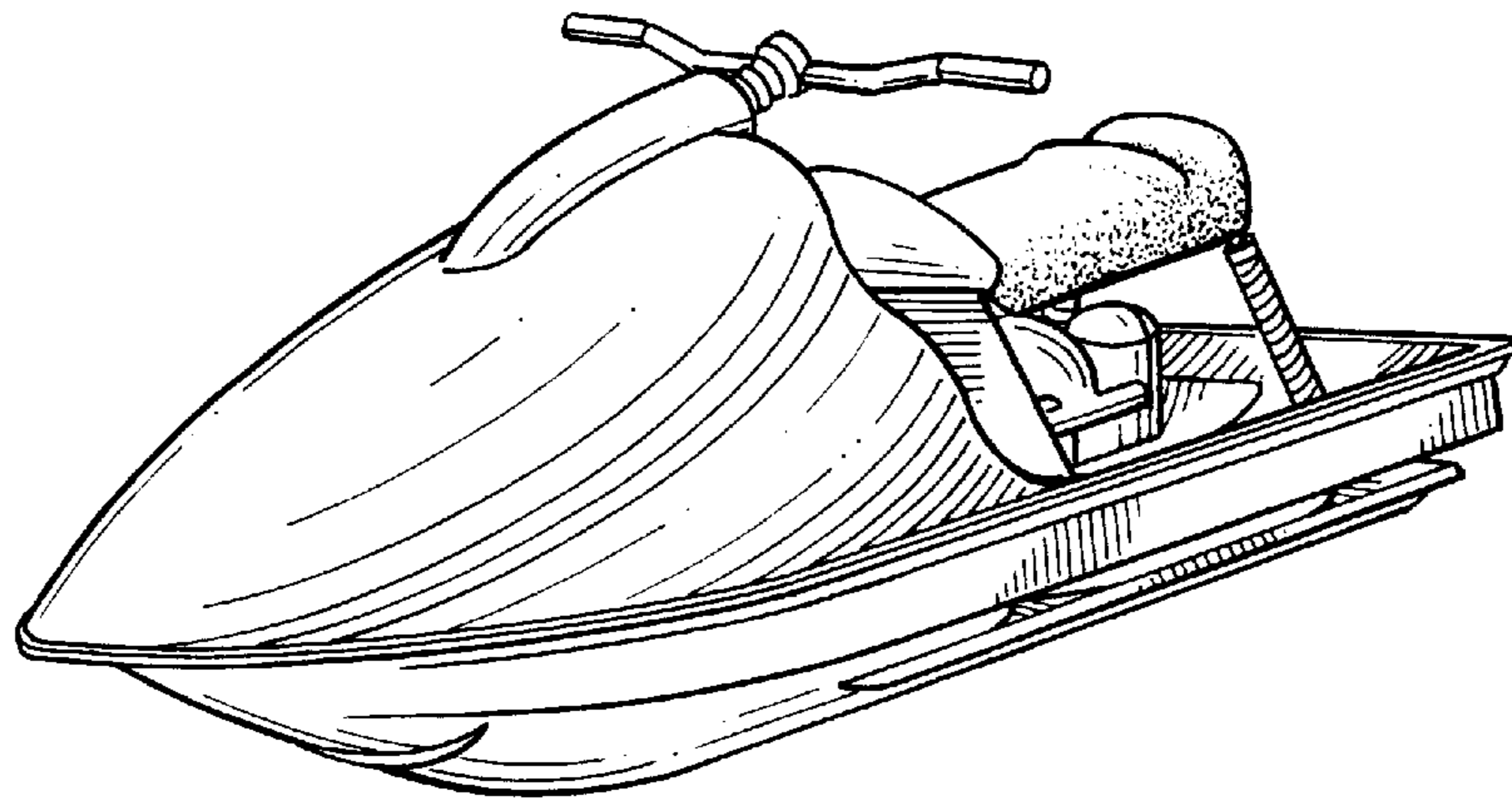

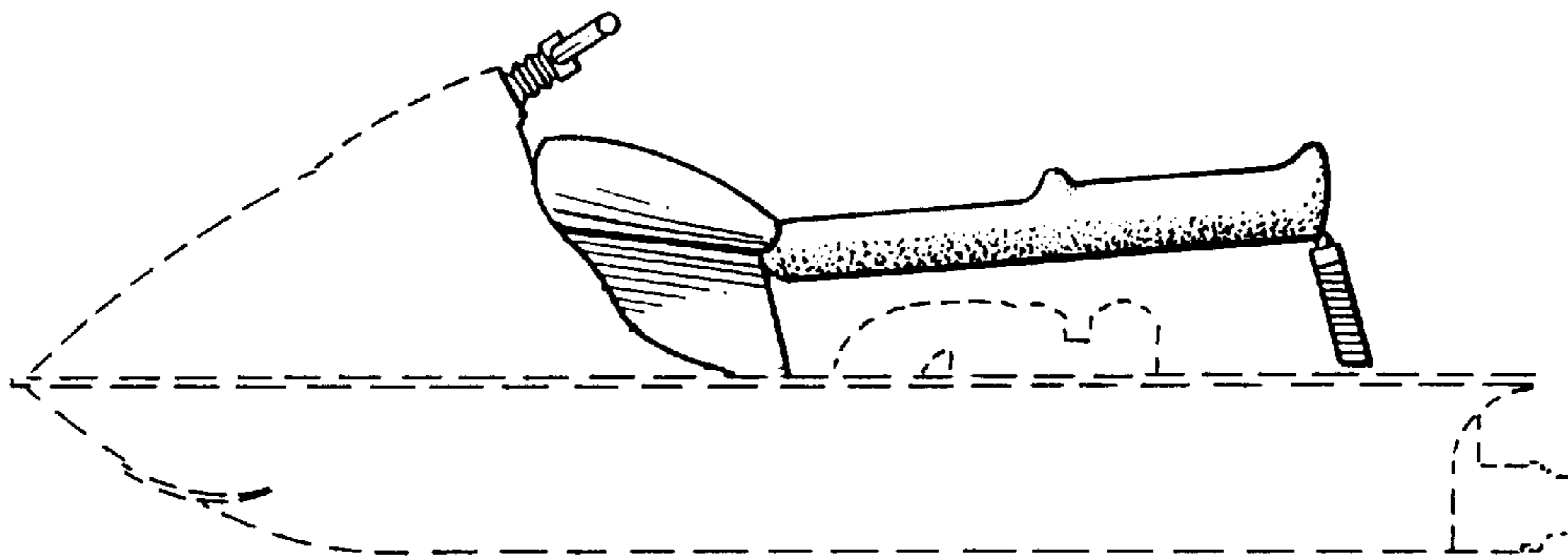

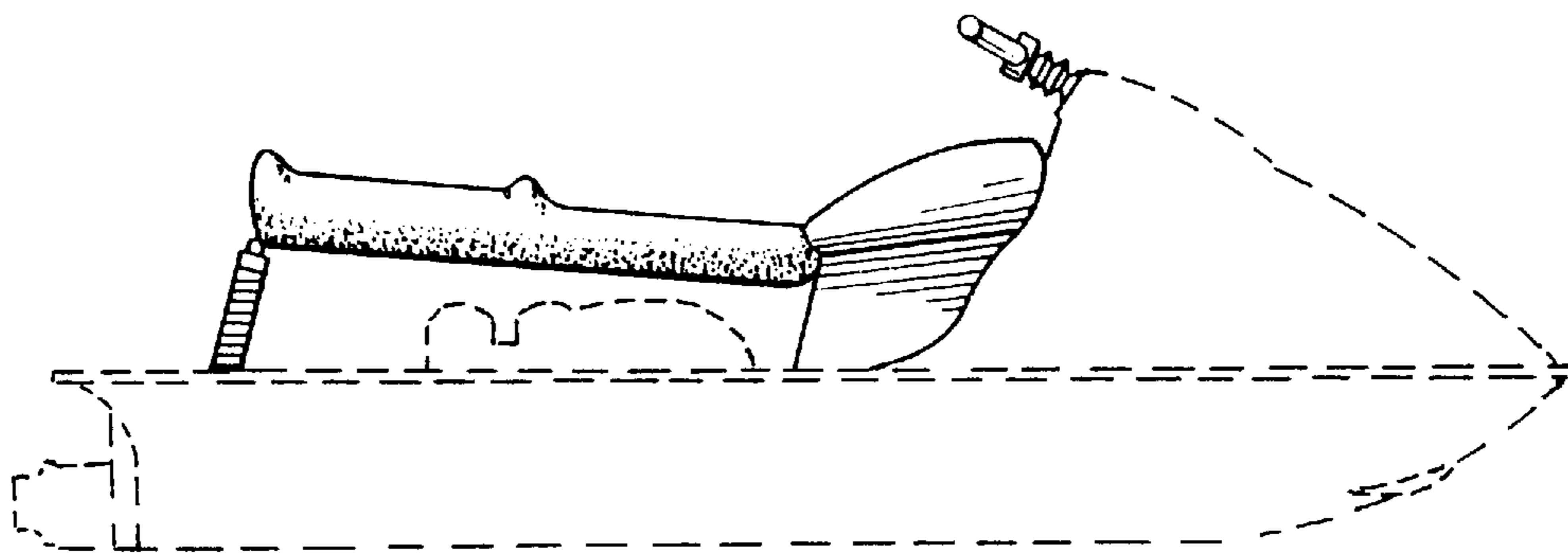

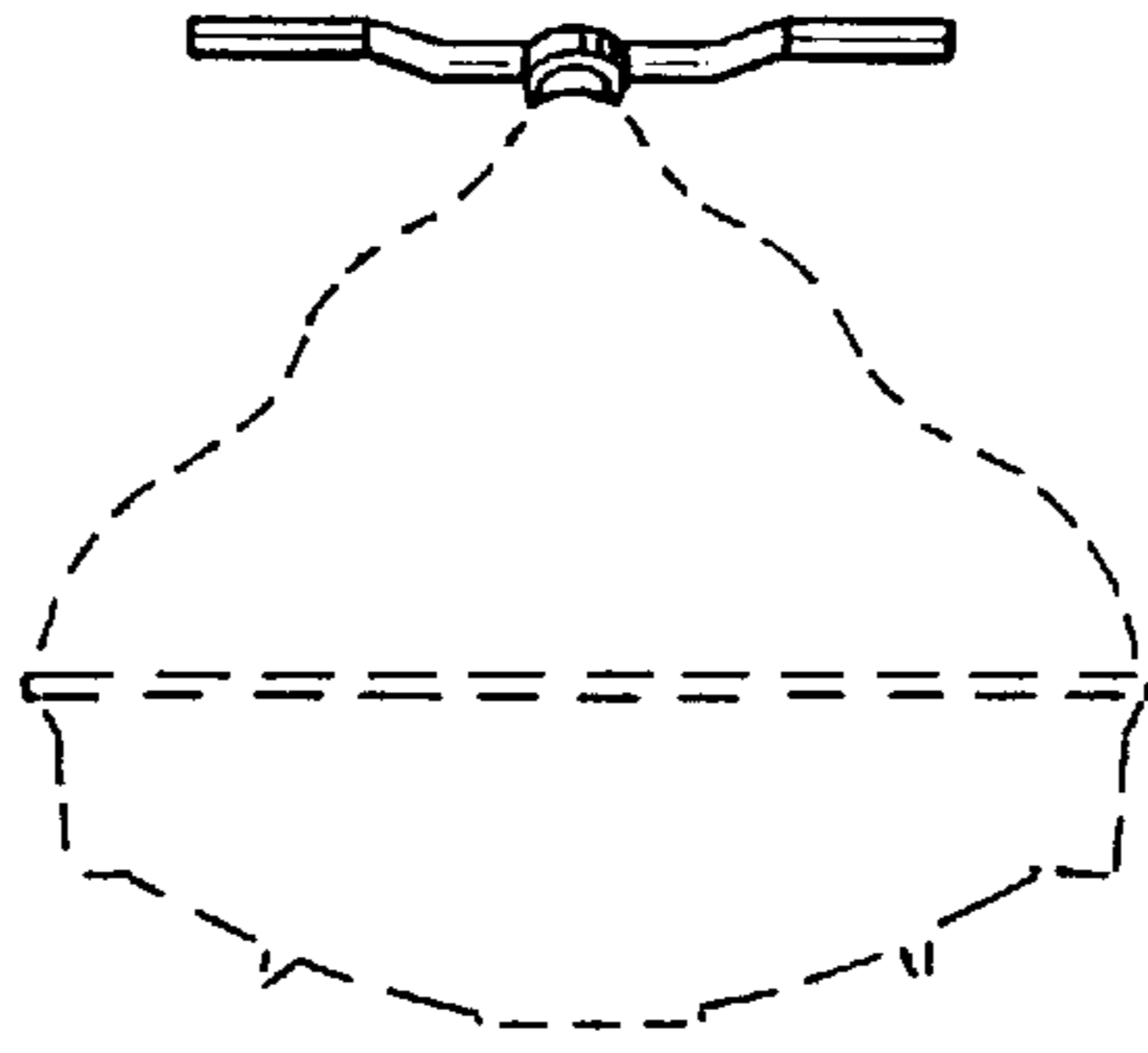

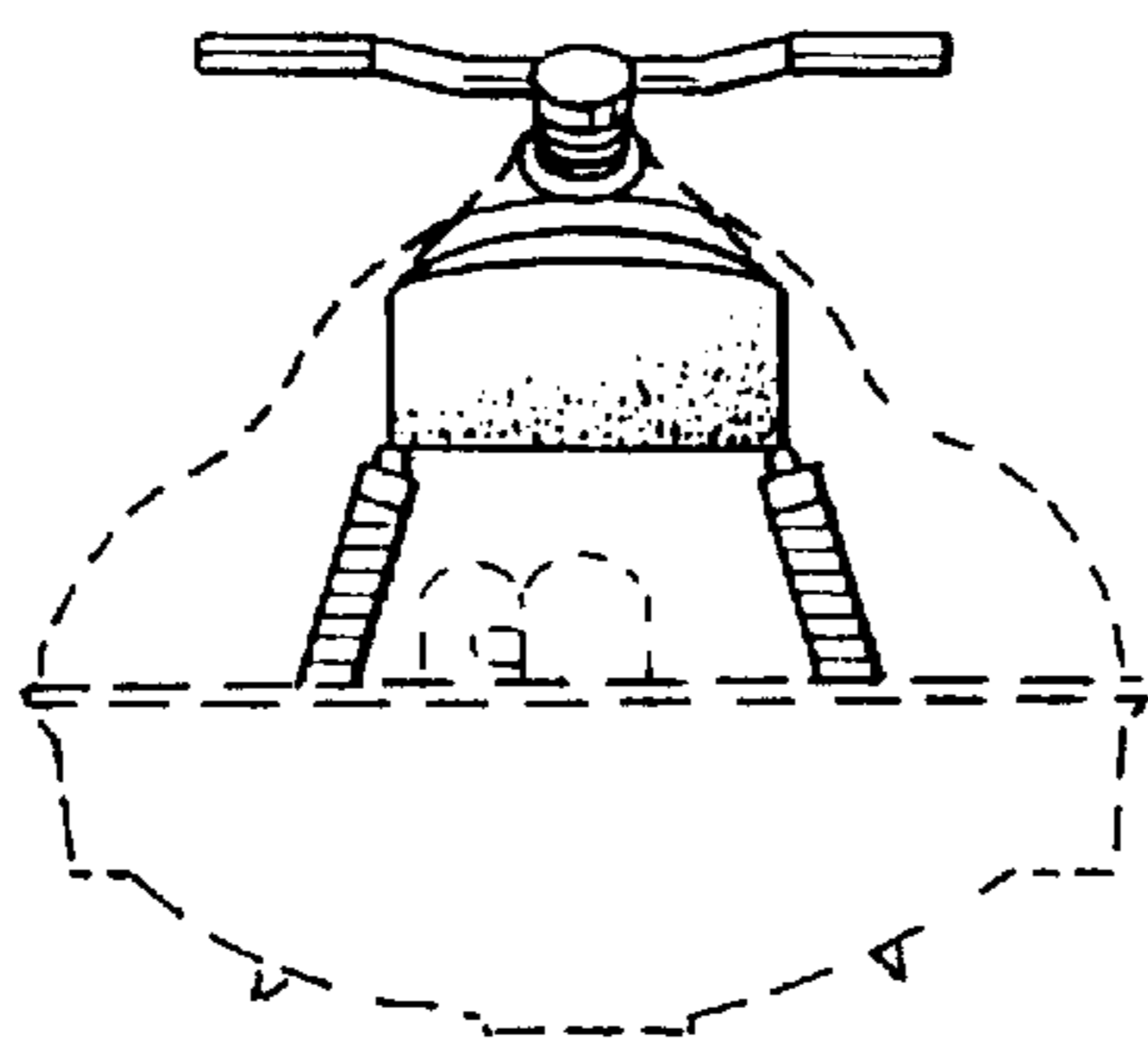

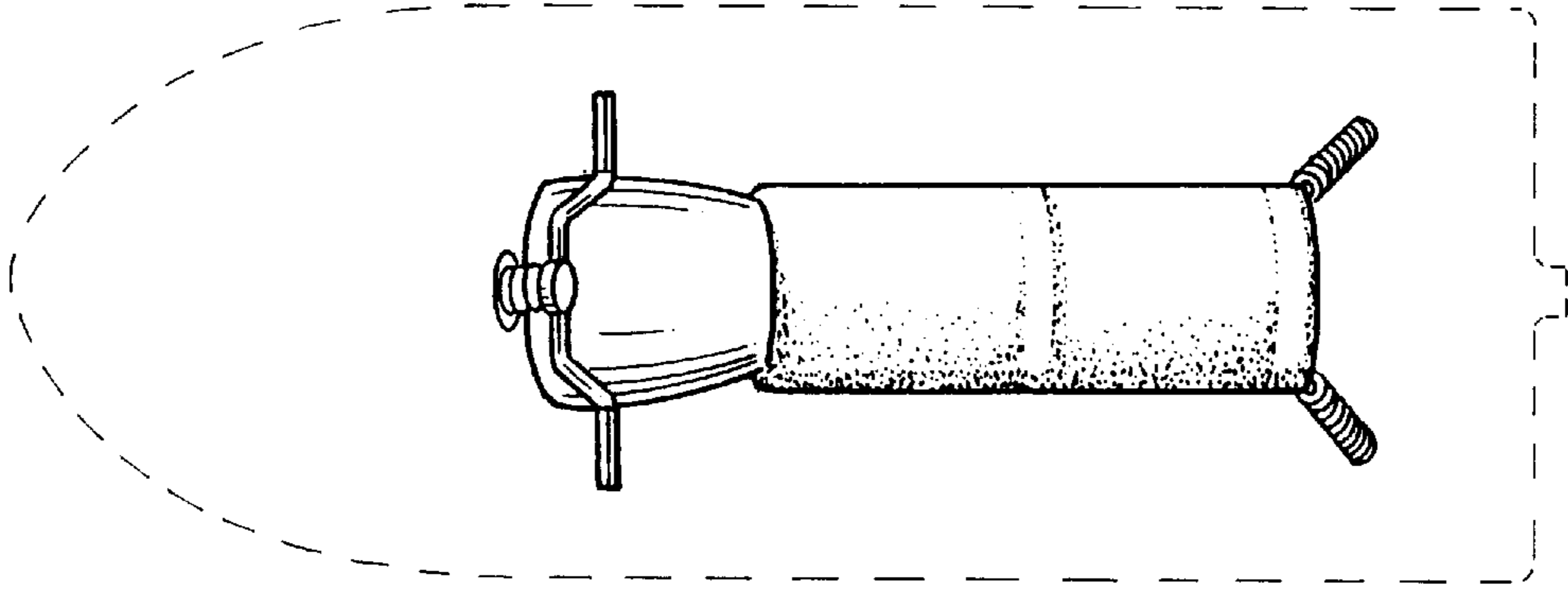

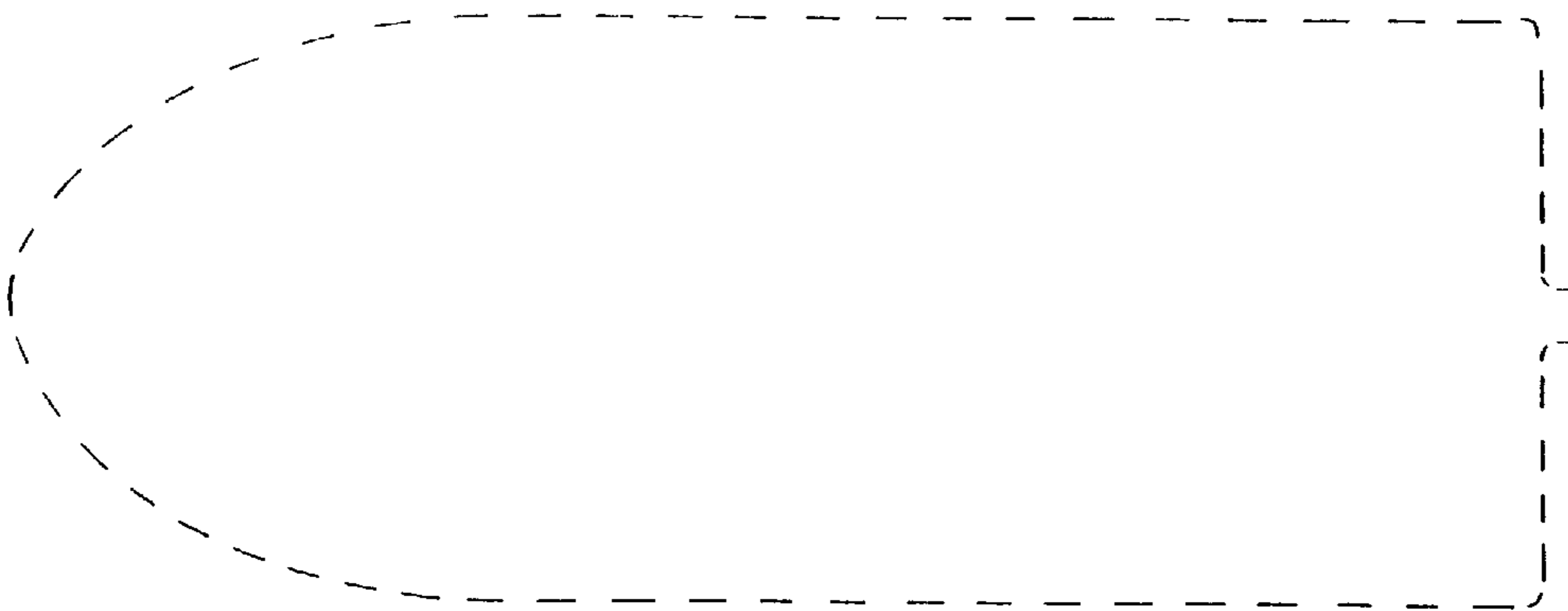

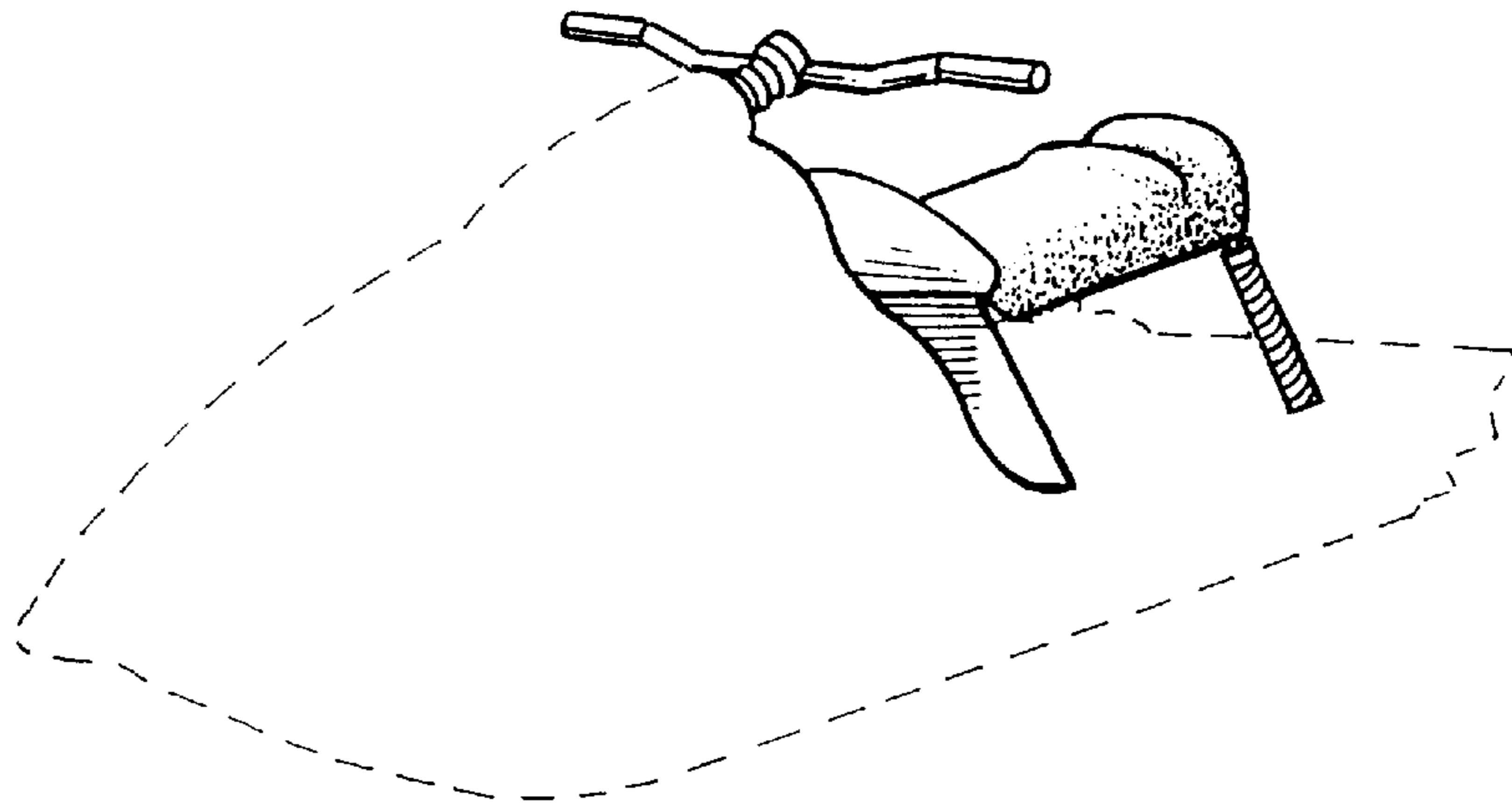

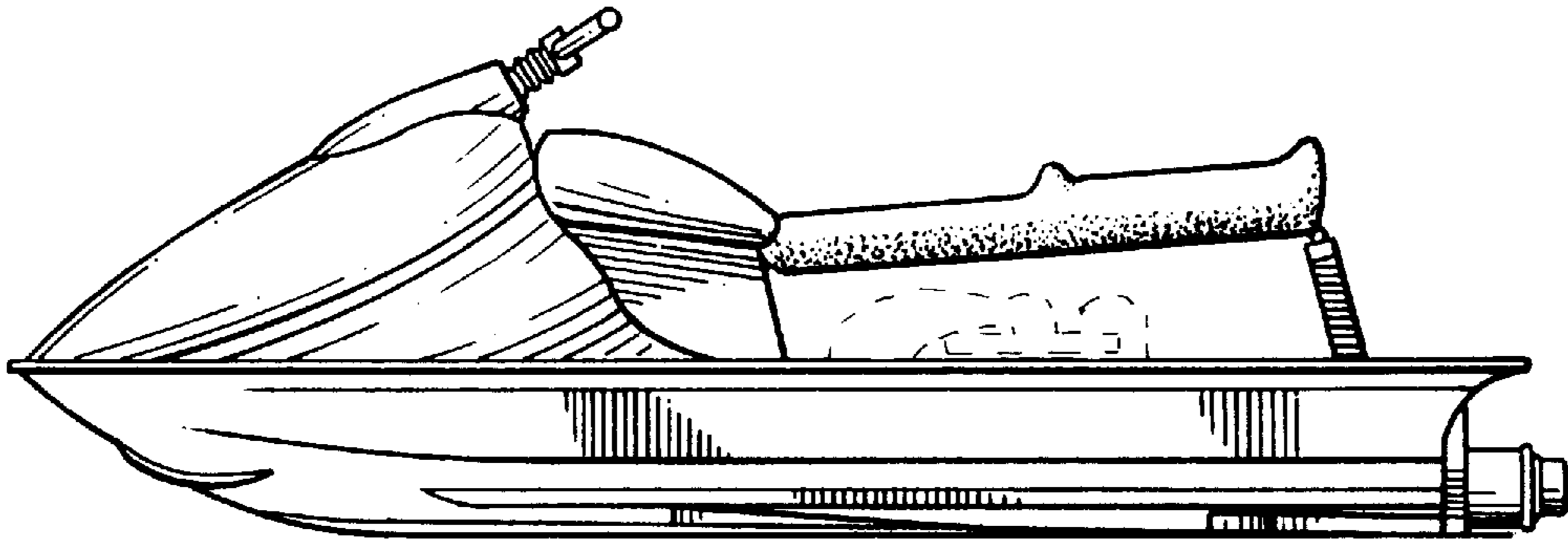

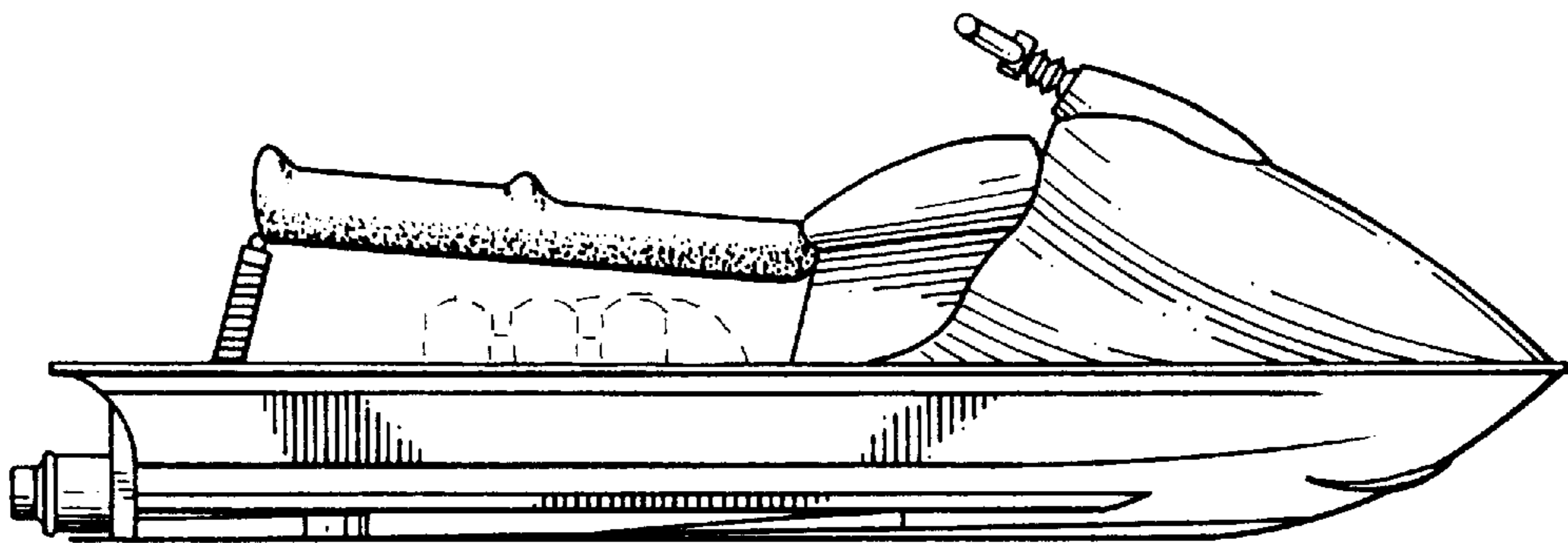

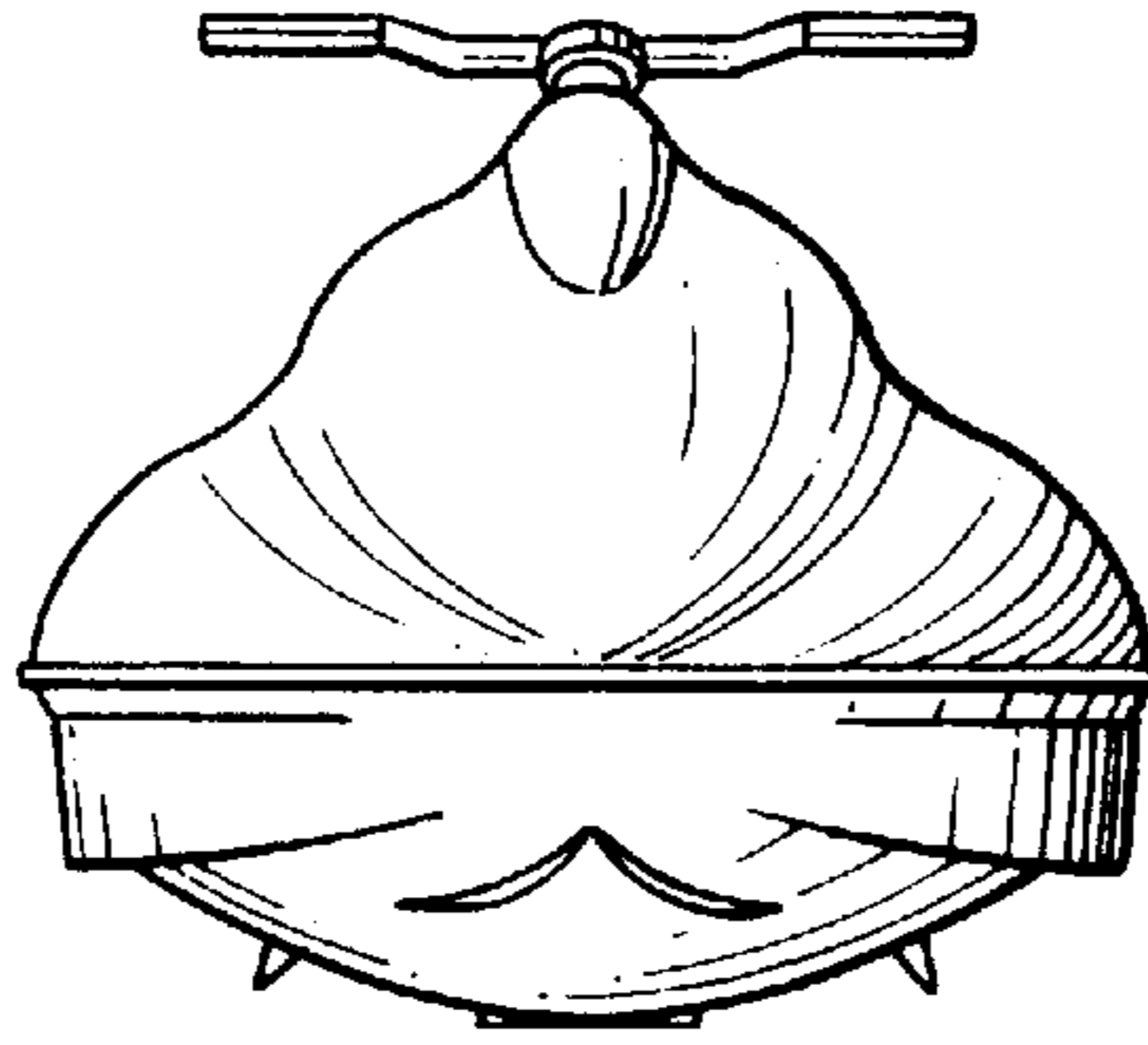

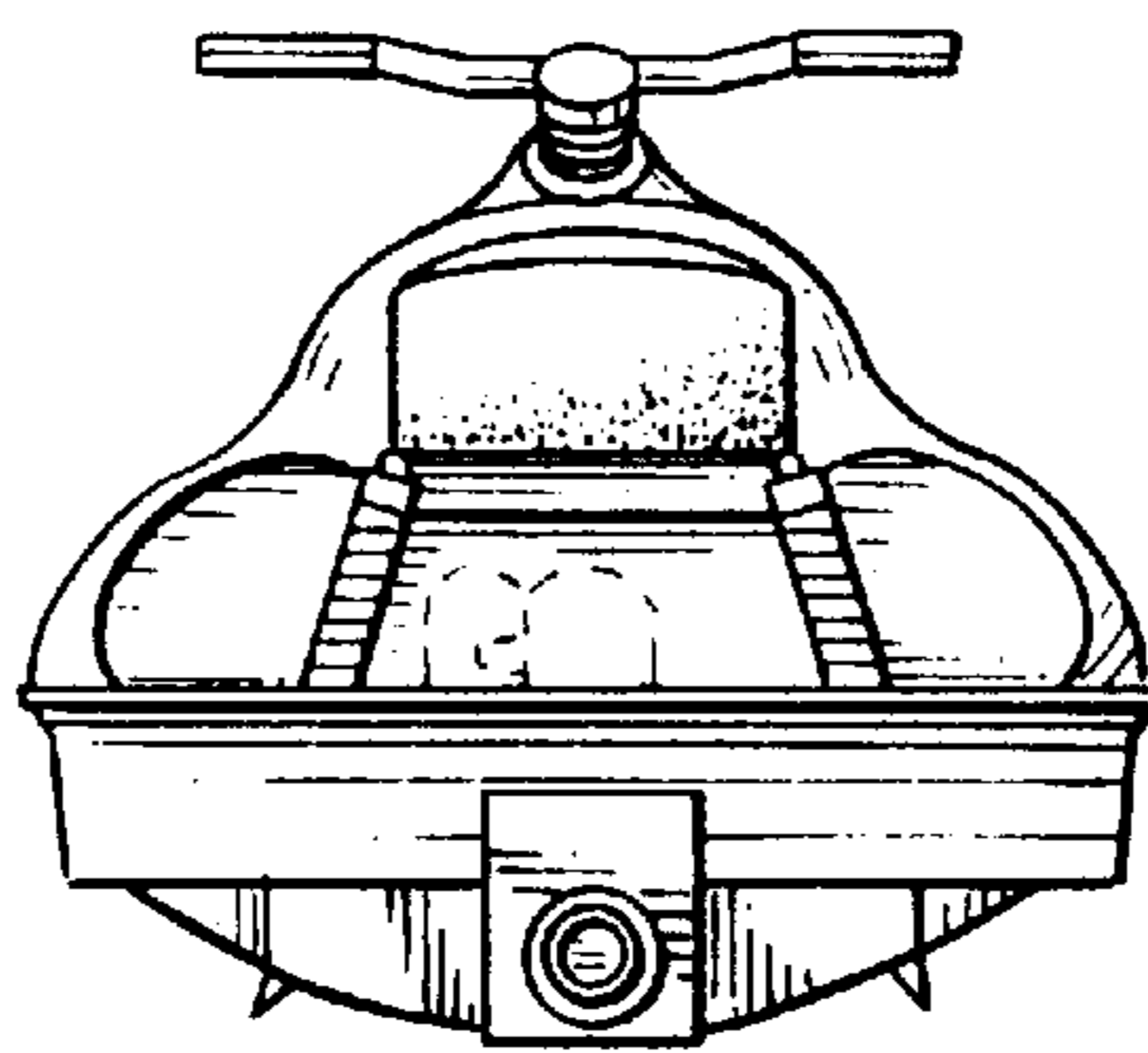

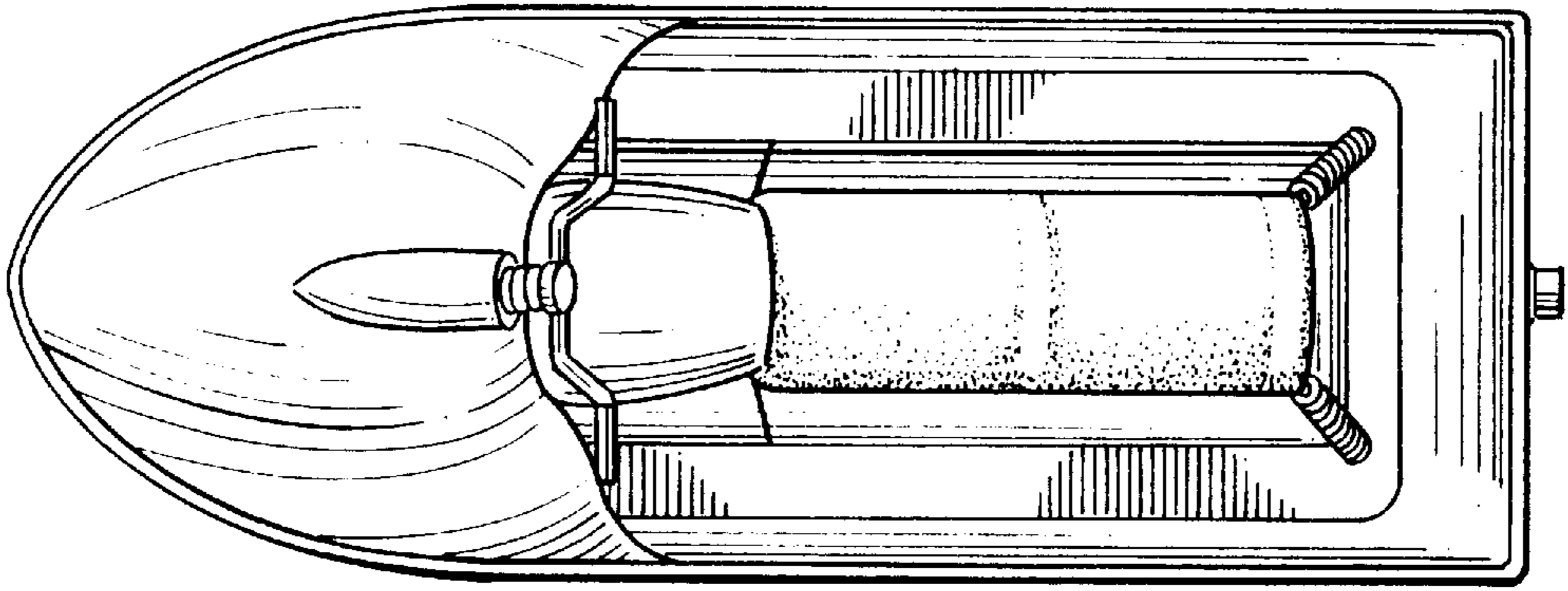

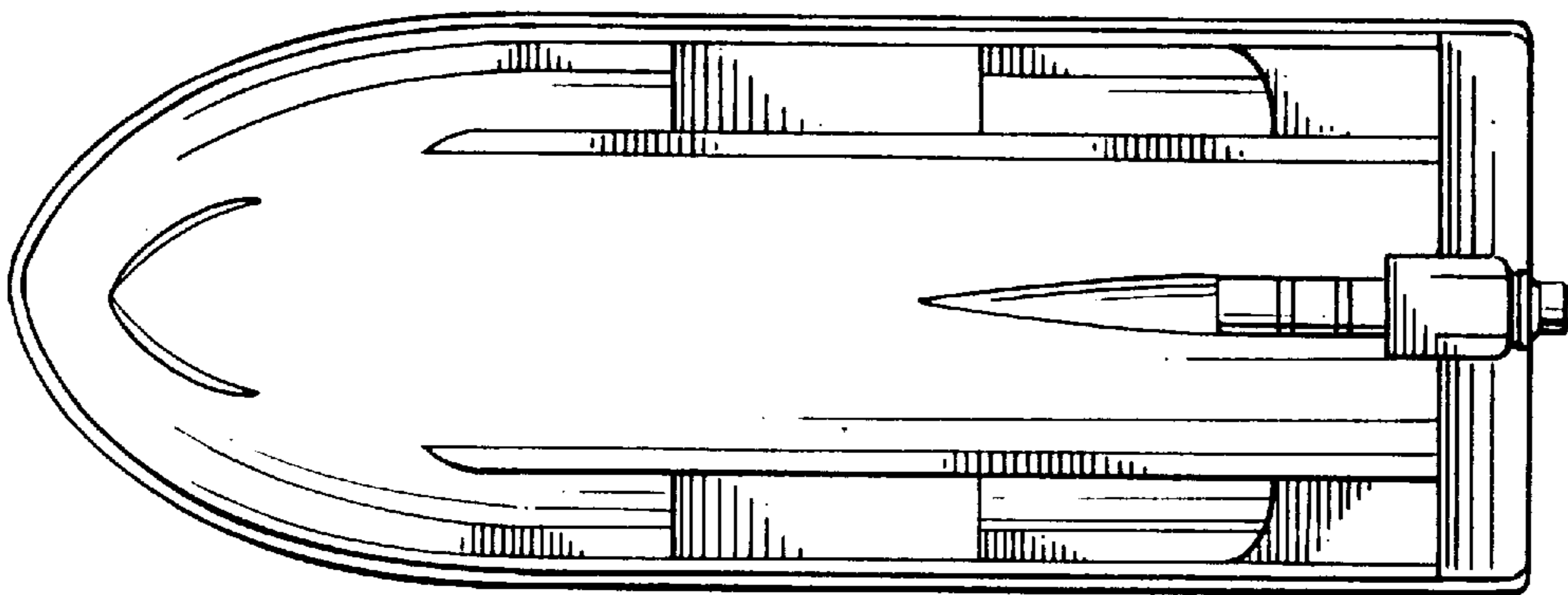

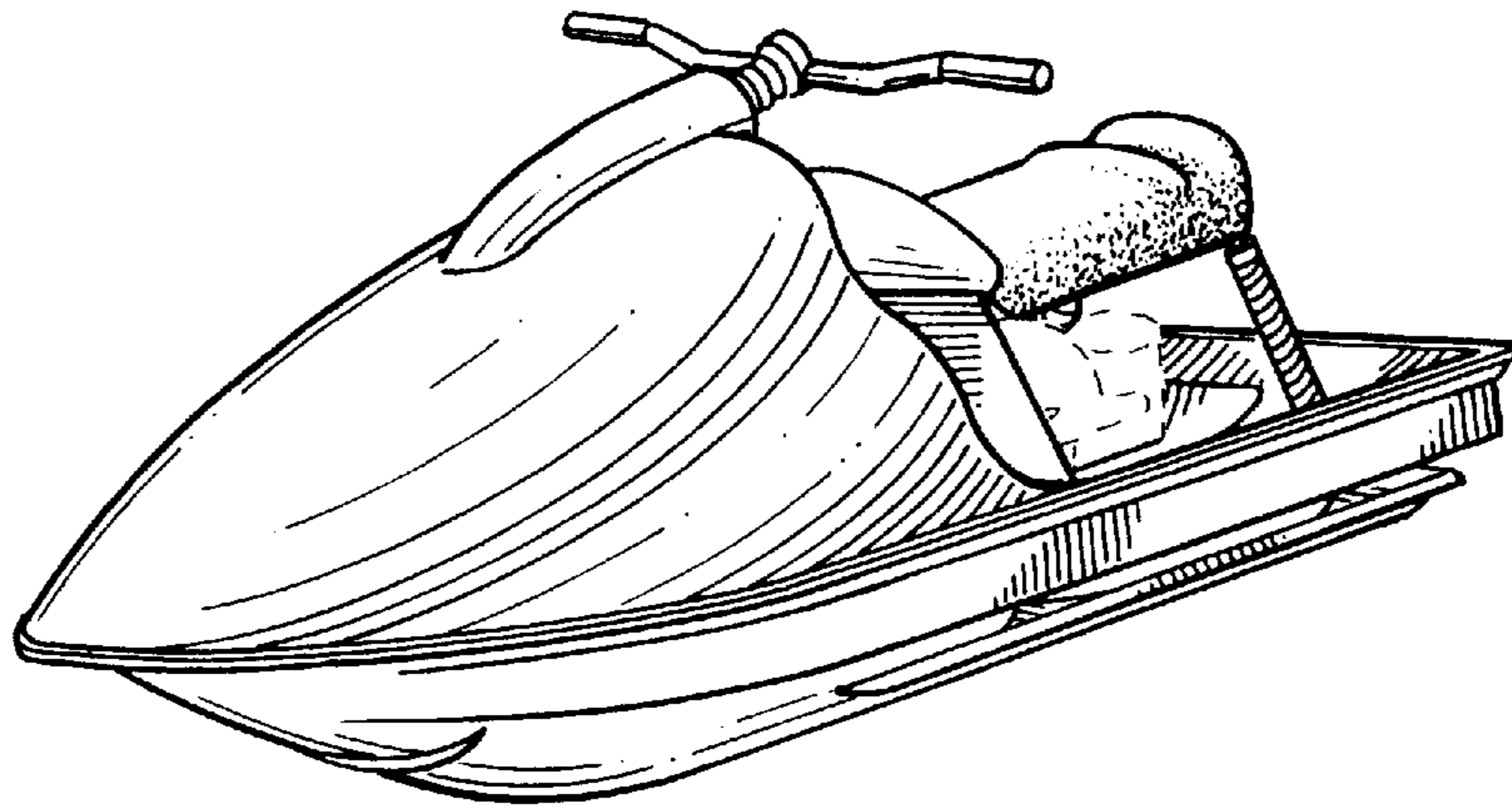
