[57] **CLAIM**

The ornamental design for a vehicle rifle mount, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a lower portion of a vehicle rifle mount according to this invention;

FIG. 2 is a right side view of the lower portion of the invention, it being understood that portions of this FIGURE shown with broken lines are for illustrative purposes only and form no part of the claimed design;

FIG. 3 is a front elevation view of the lower portion of the invention;

FIG. 4 is a top plan view of the lower portion of the invention;

FIG. 5 is a left side view of the lower portion of the invention;

FIG. 6 is a rear elevation view of the lower portion of the invention;

FIG. 7 is a bottom plan view of the lower portion of the invention;

FIG. 8 is a perspective view of an upper portion of the vehicle rifle mount of this invention;

FIG. 9 is a front elevation view of the upper portion of the invention;

FIG. 10 is a rear elevation view of the upper portion of the invention;

FIG. 11 is a bottom plan view of the upper portion of the invention;

FIG. 12 is a top plan view of the upper portion of the invention;

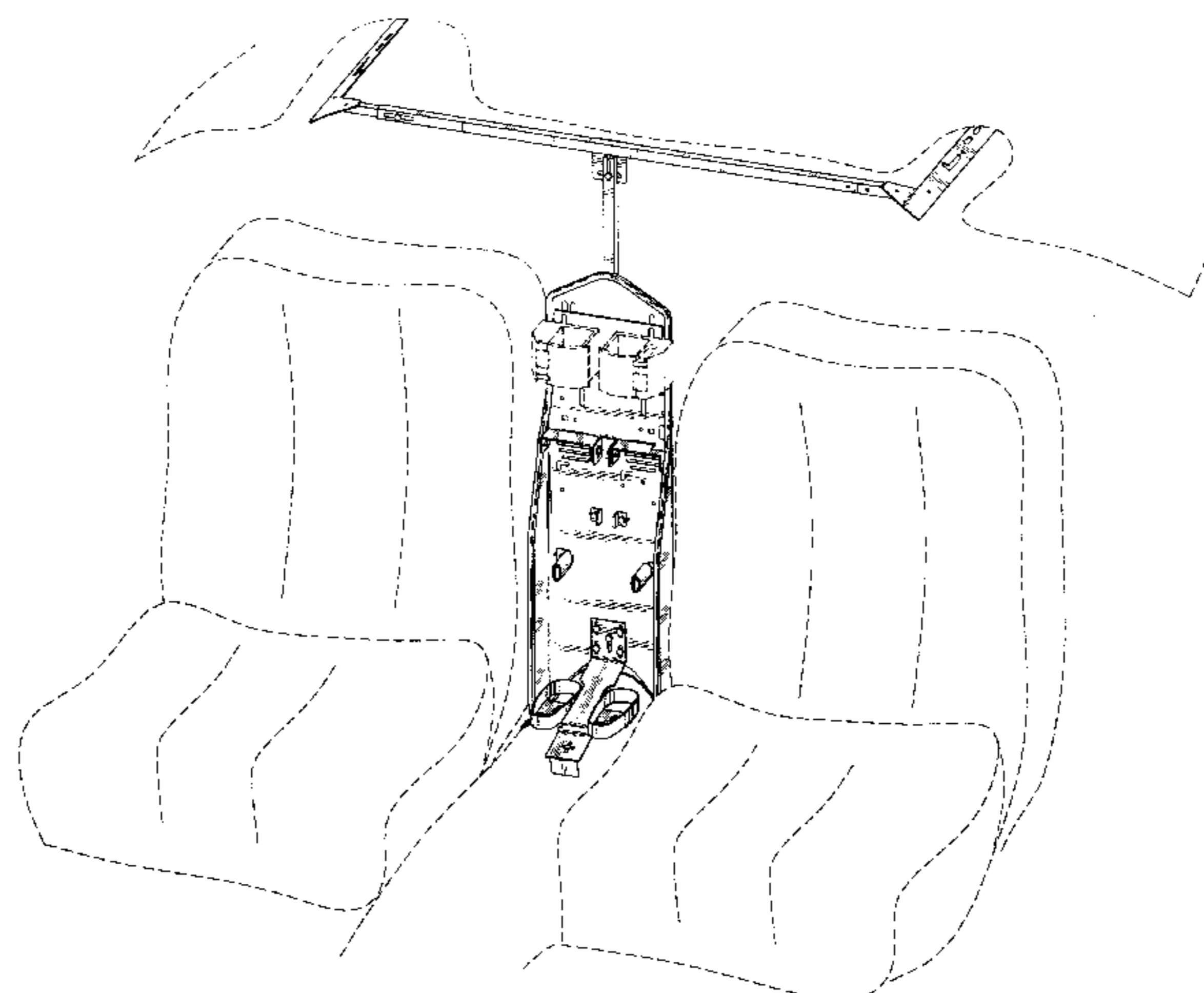
FIG. 13 is a right side view of the upper portion of the invention;

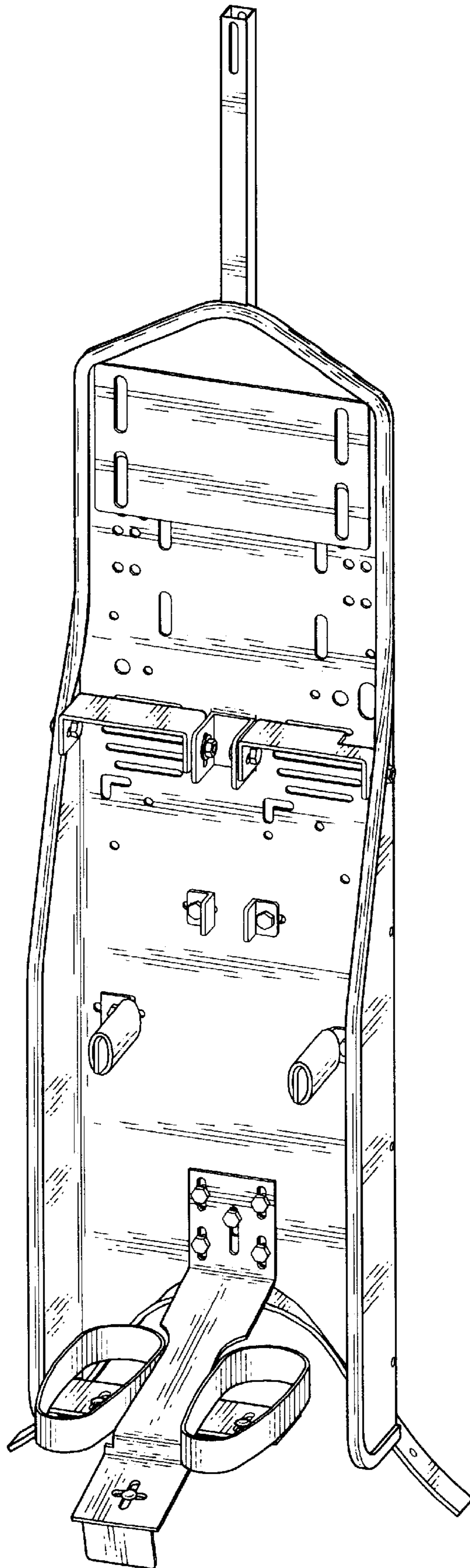
FIG. 14 is a top right side view of the upper portion of the invention taken along lines 14—14 of FIG. 9;

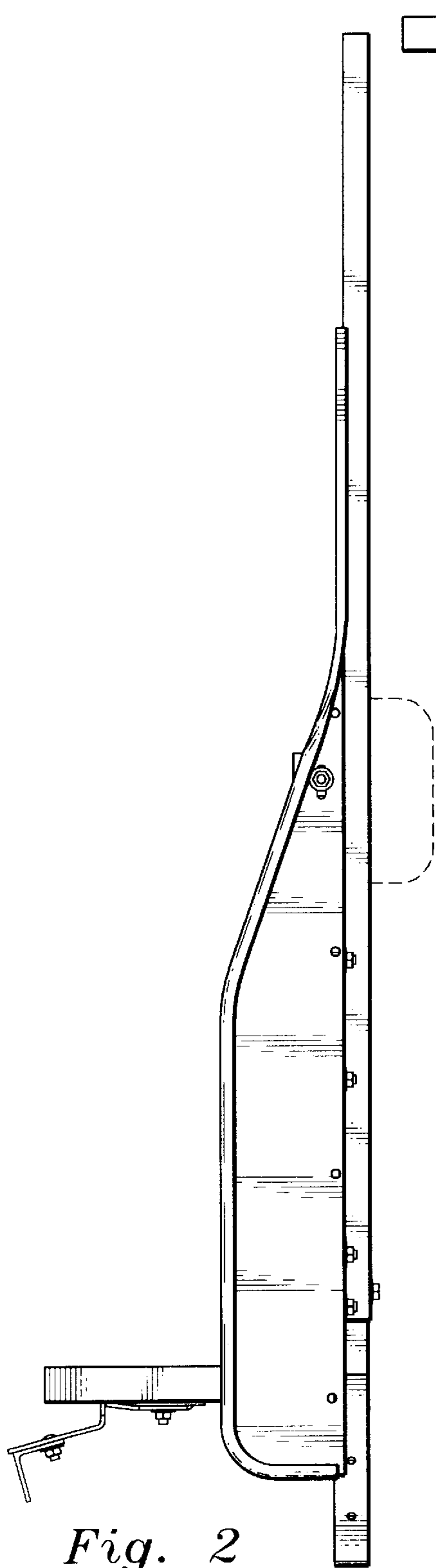
The lower portion and the upper portion of the vehicle rifle mount have been shown separately in FIGS. 1-7 and 8-14 respectively, for convenience of illustration.

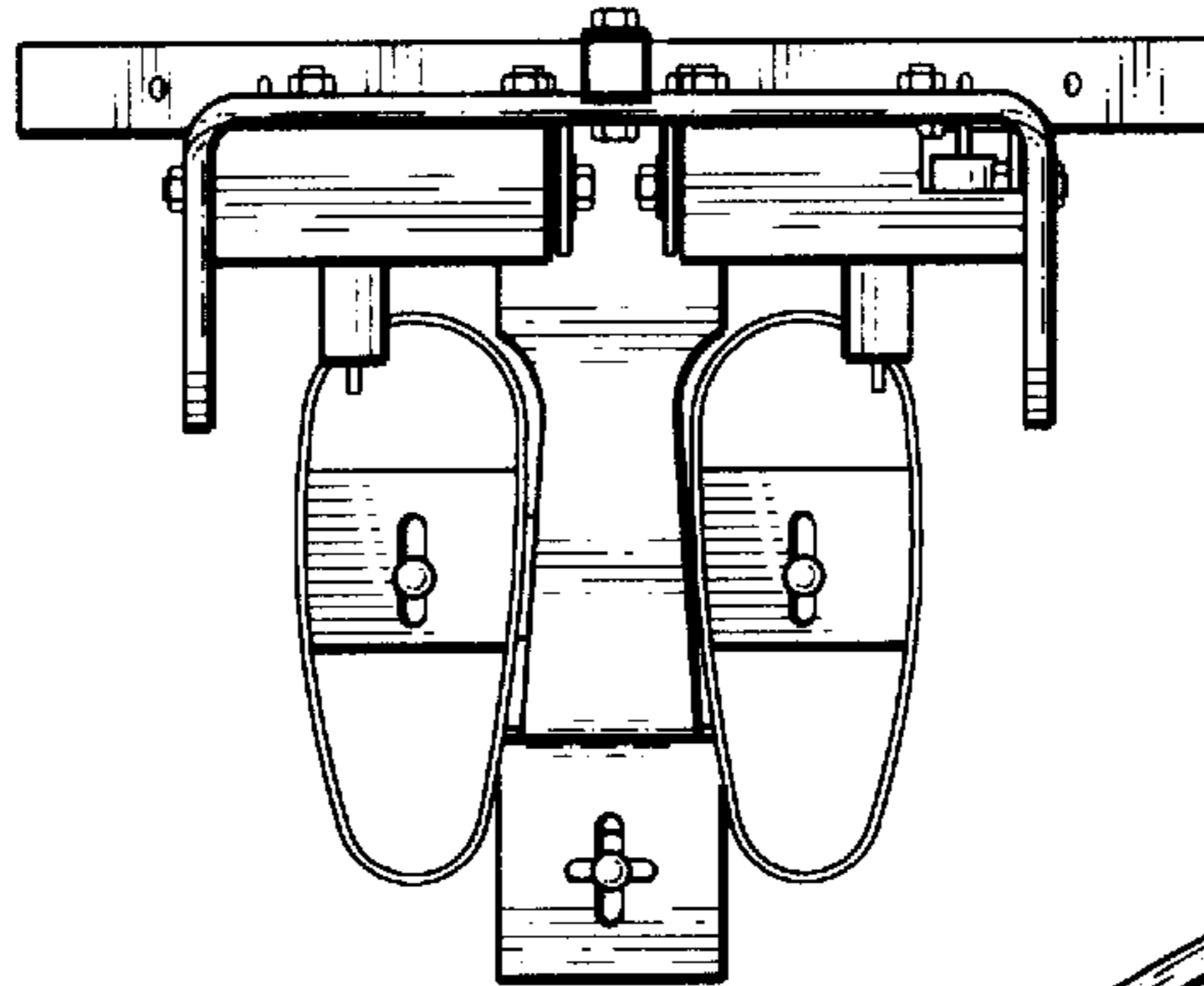




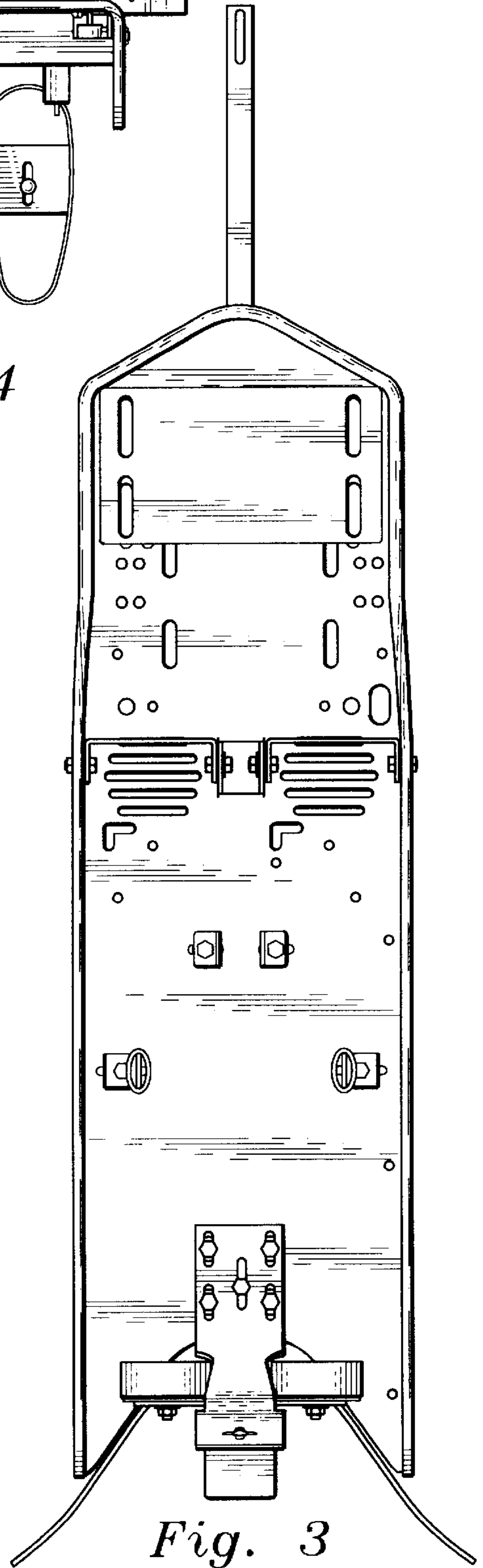

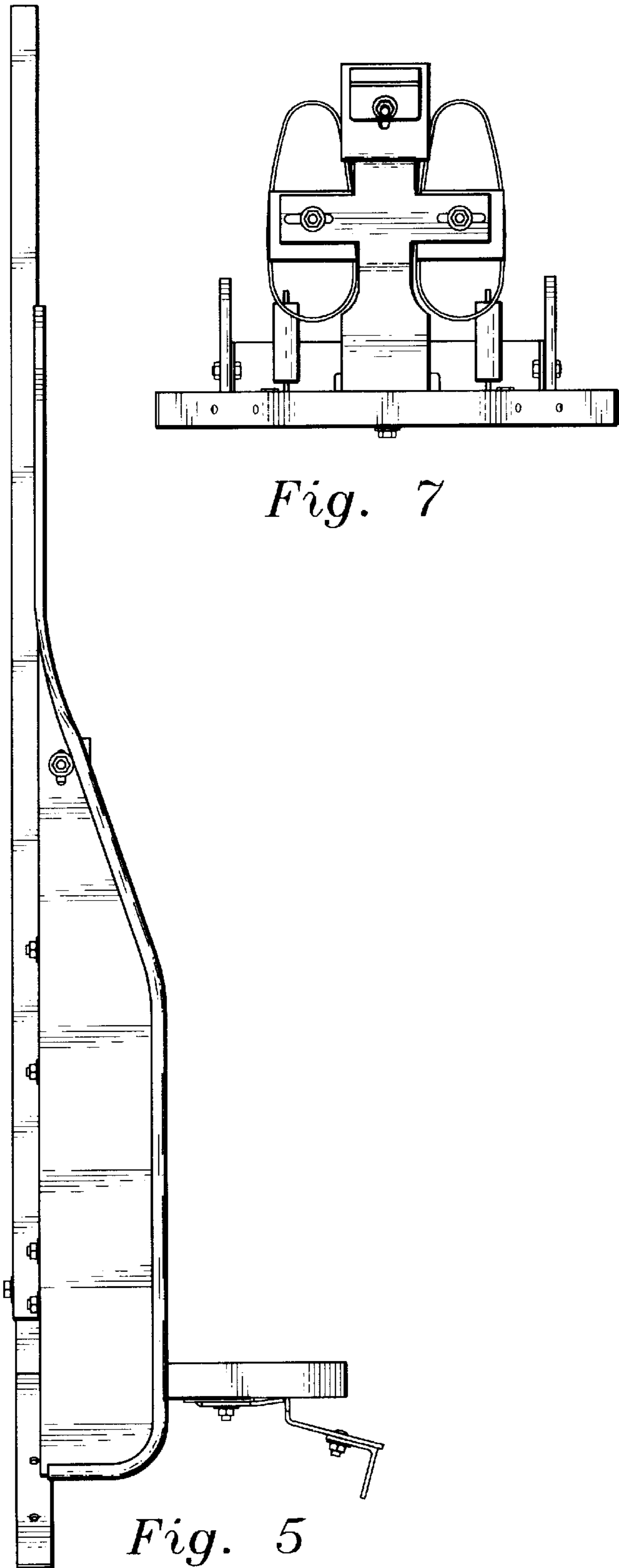

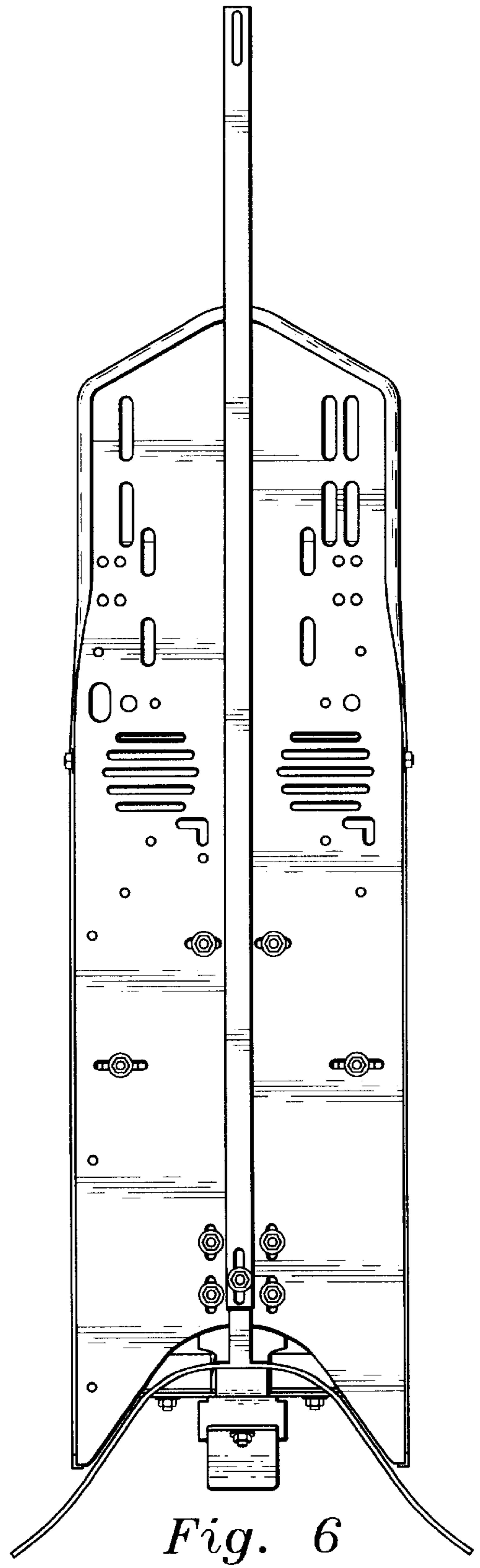

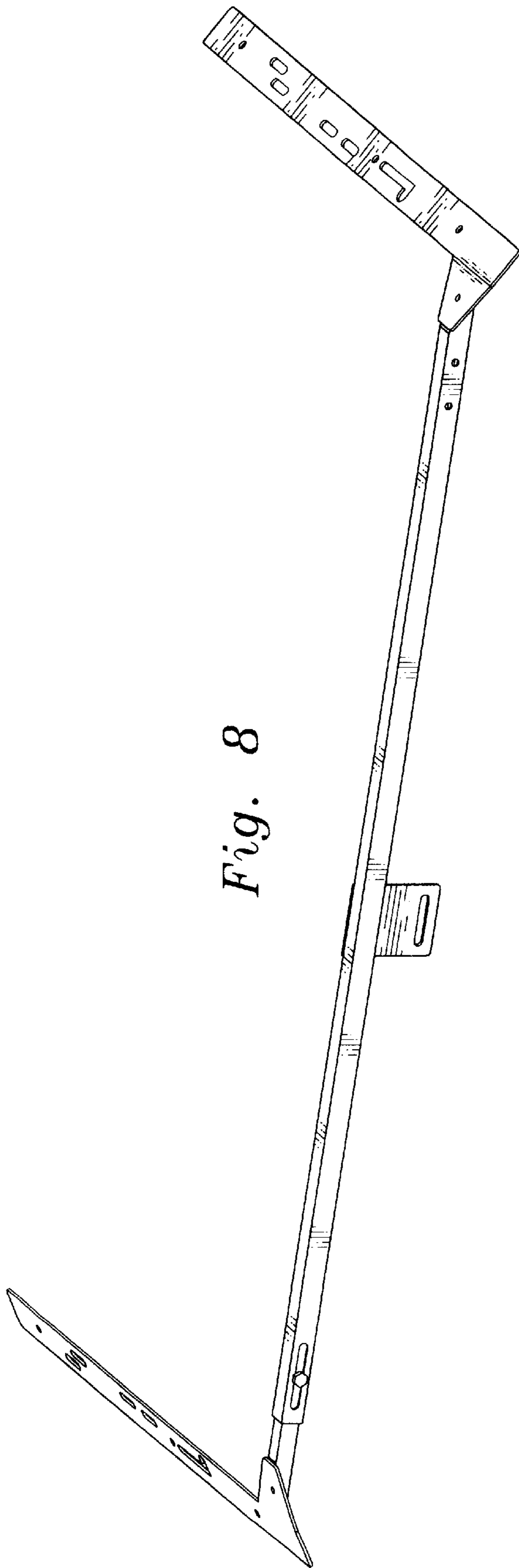

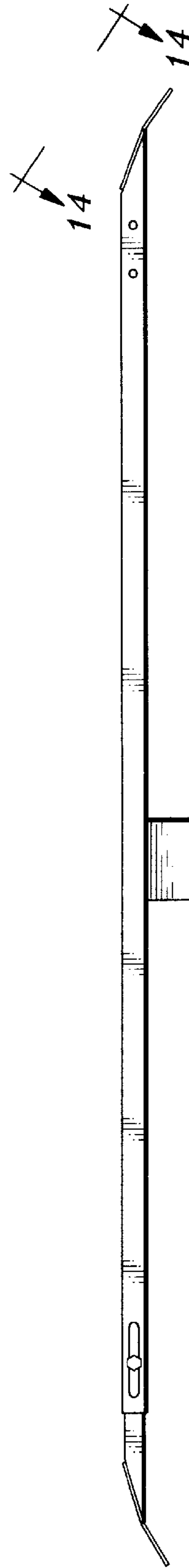

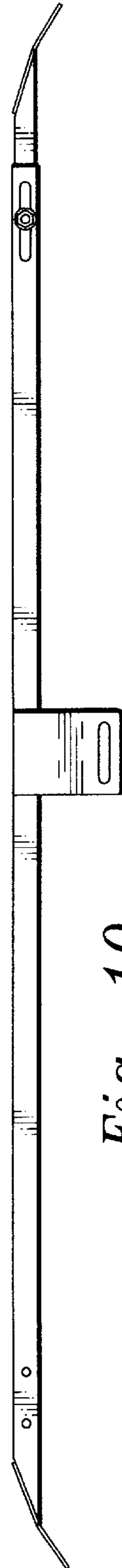

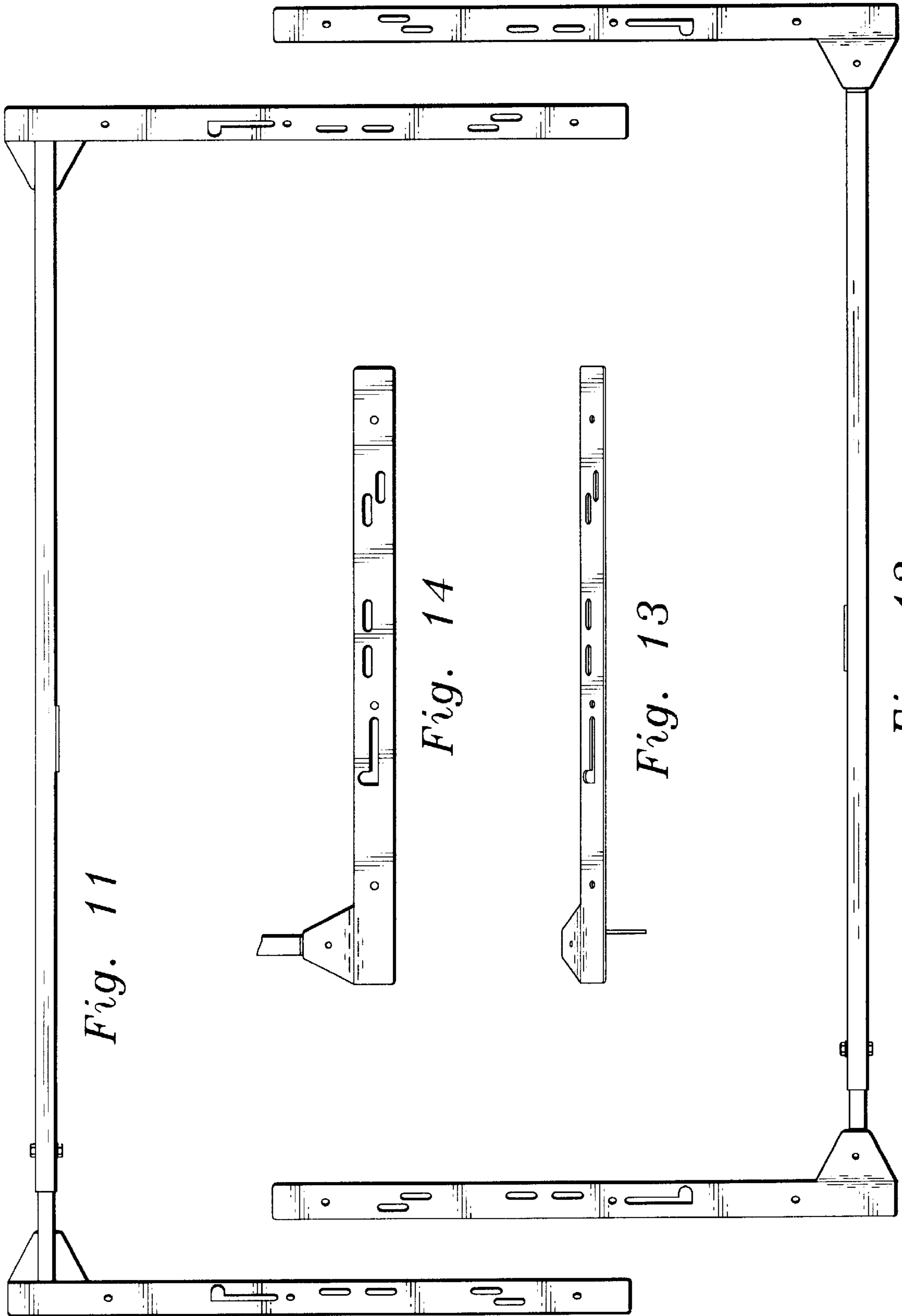

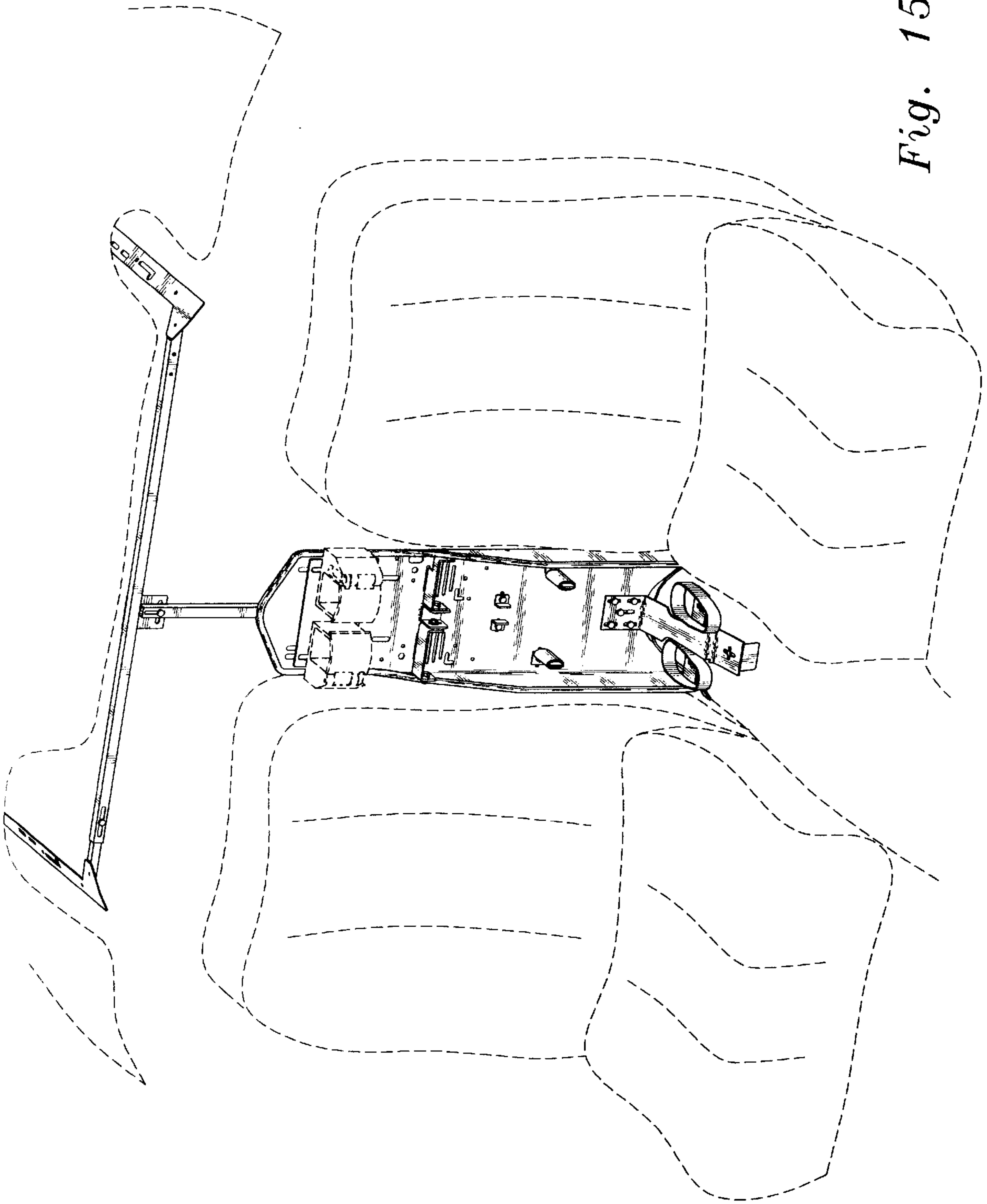
