FIG. 1 is a front perspective view of a set of icons for the display screen of a video monitor;

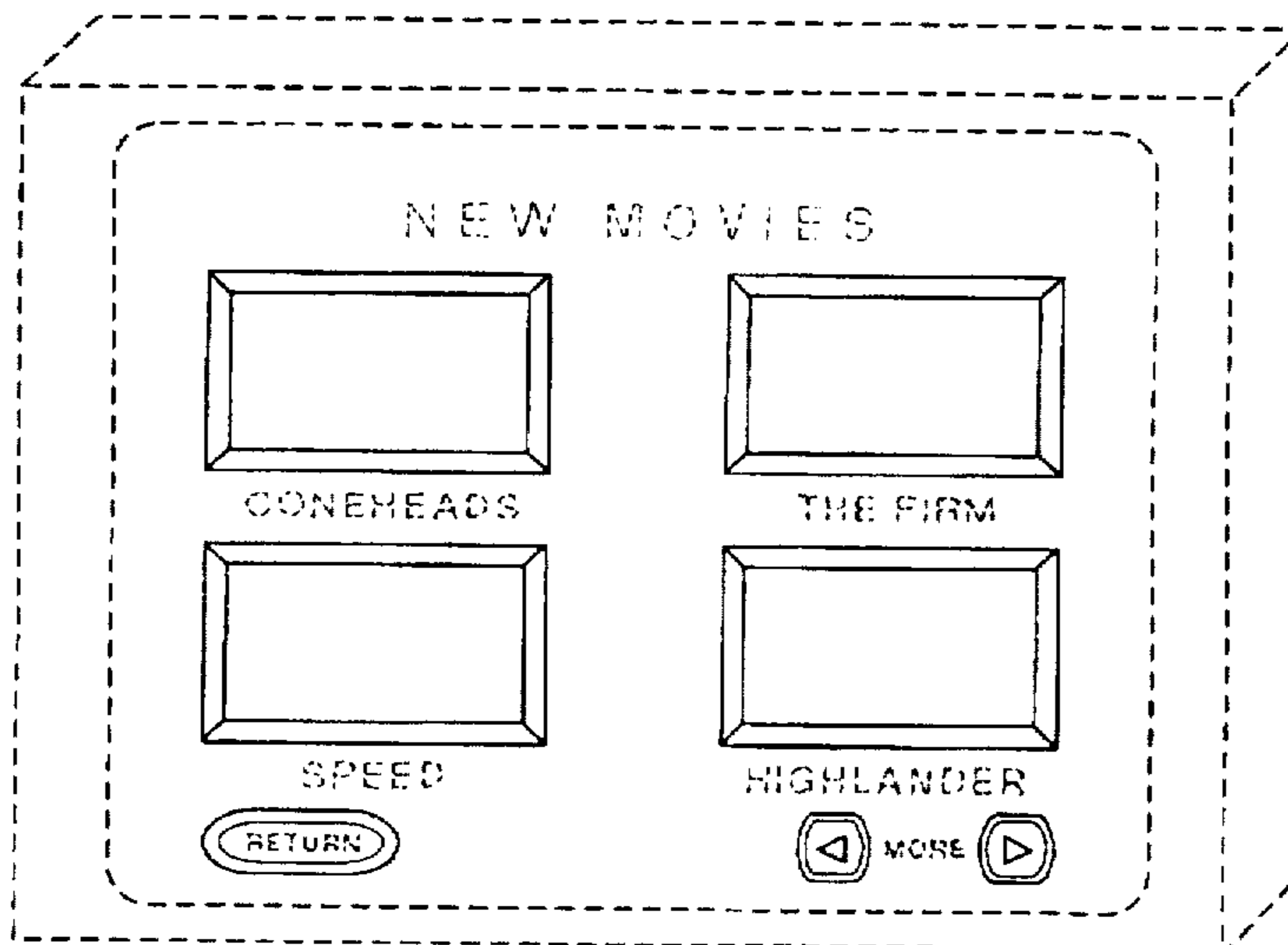
FIG. 2 is a front perspective view of second embodiment thereof;

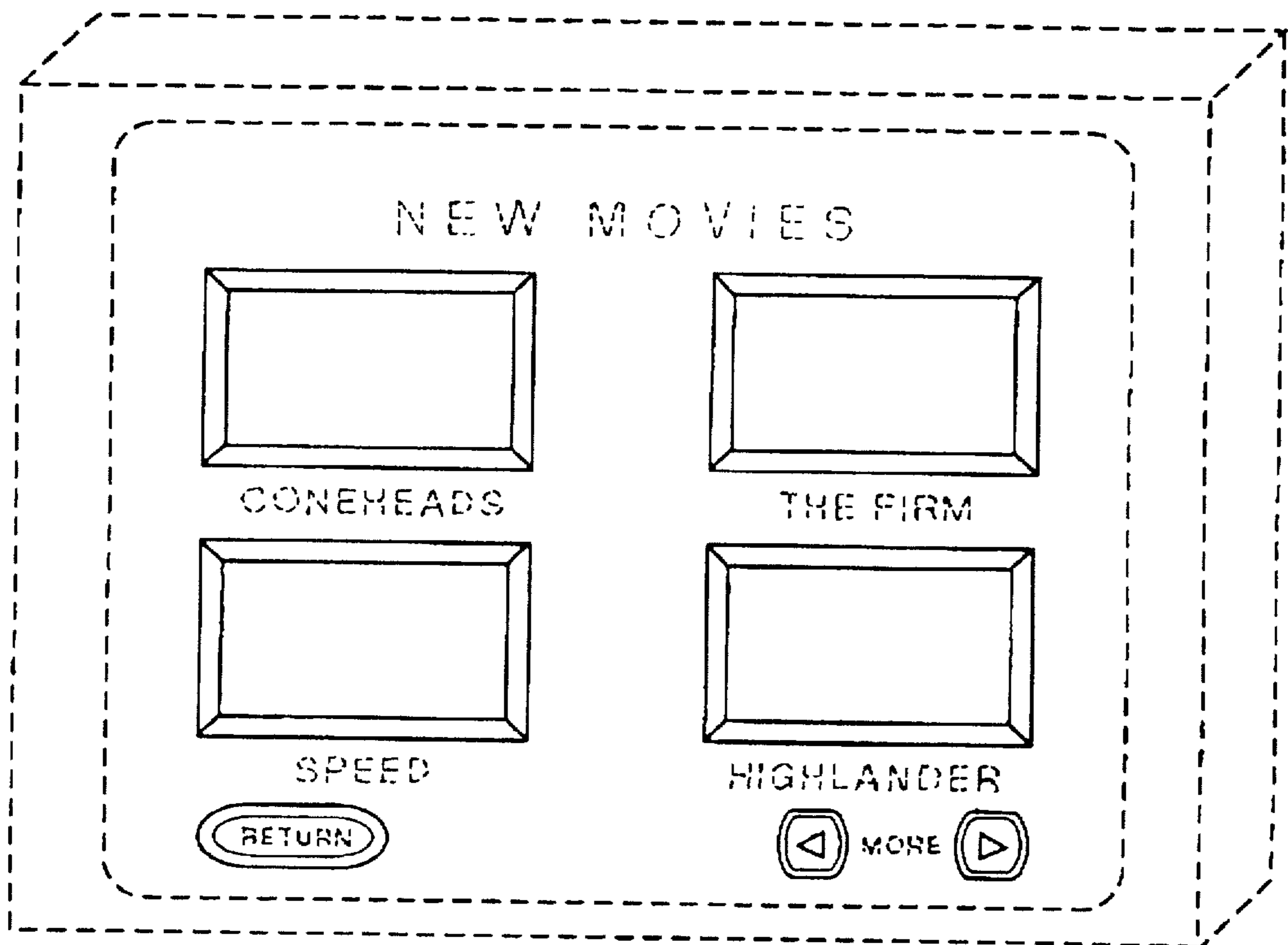

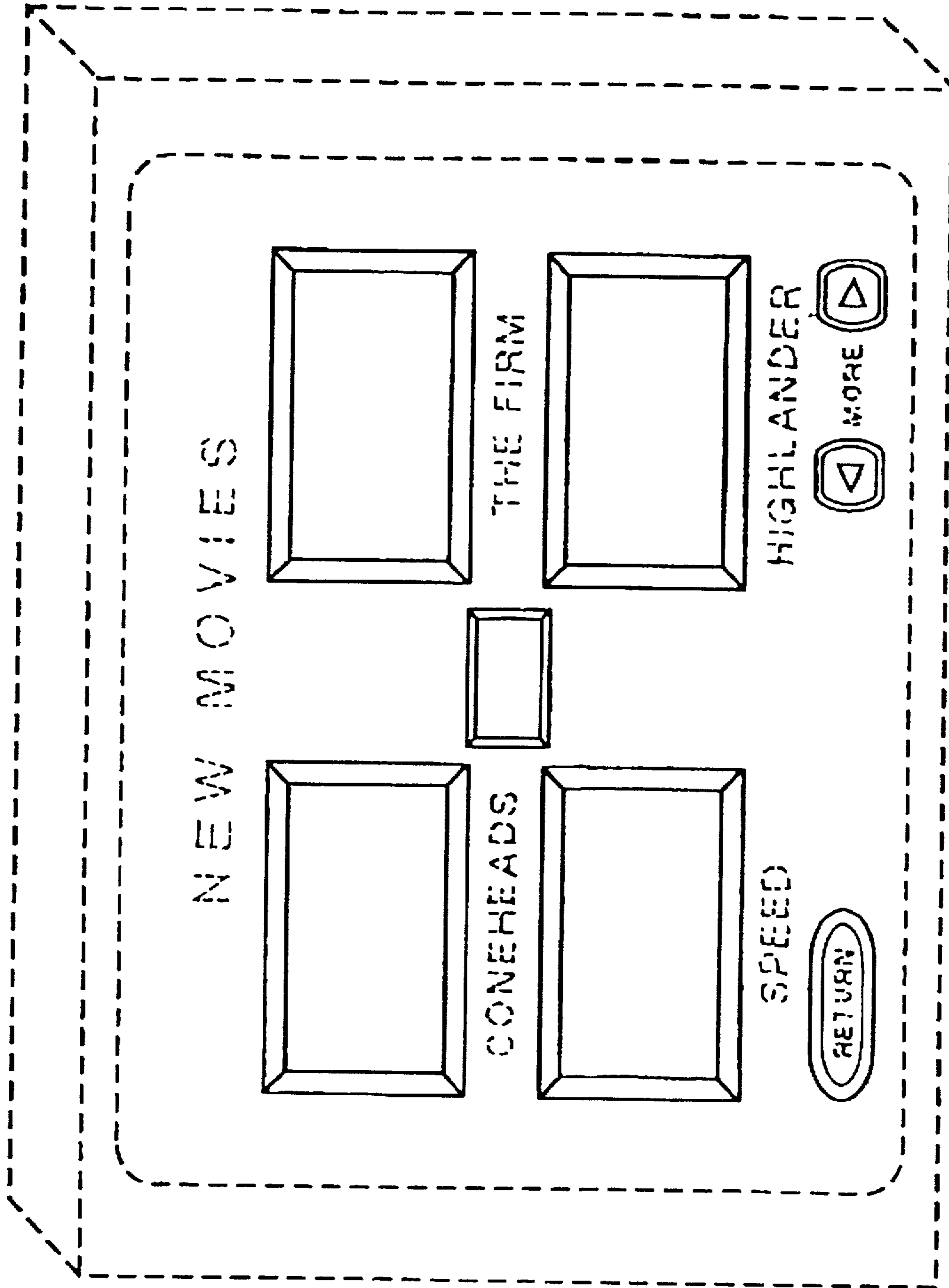

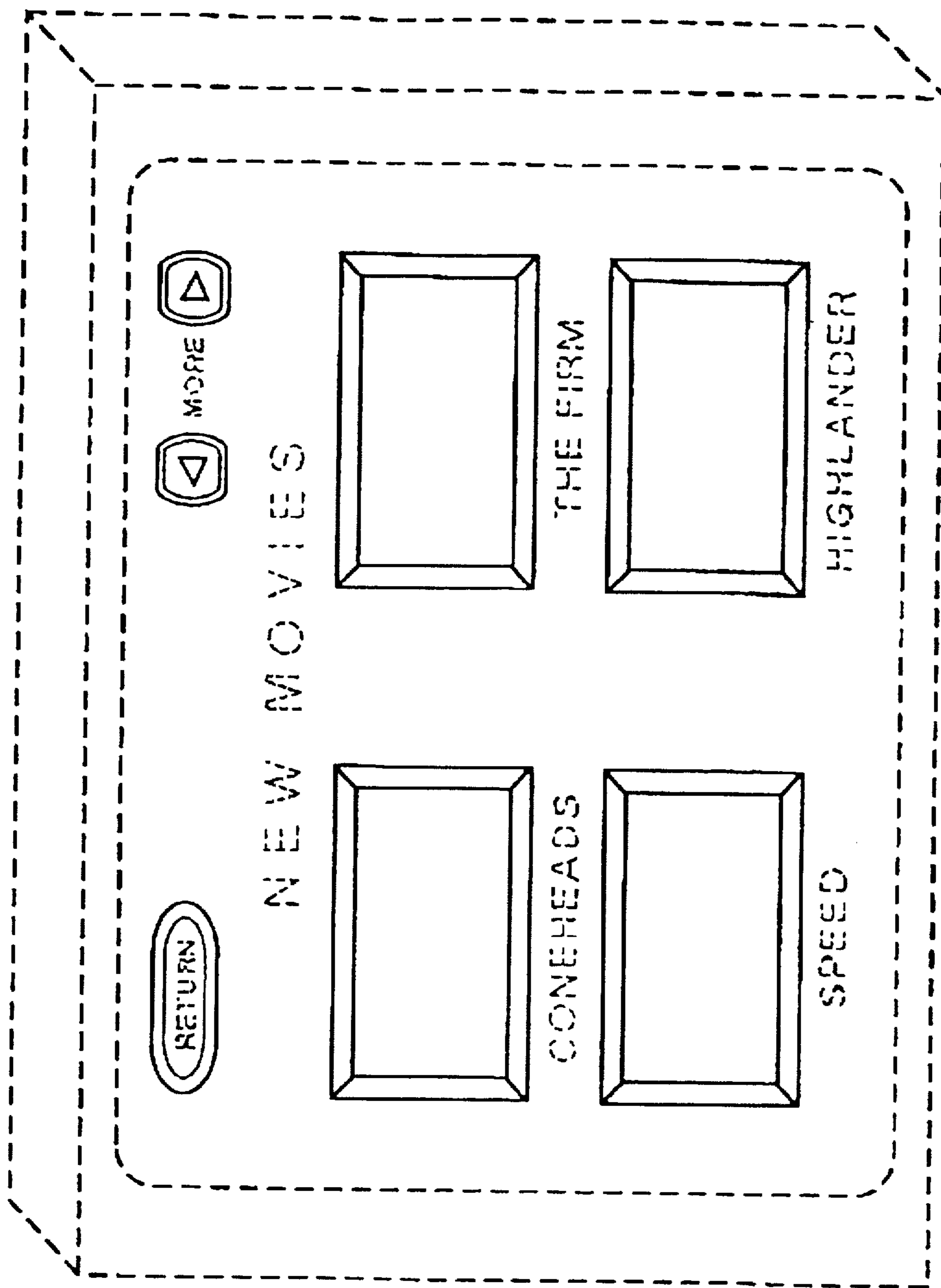

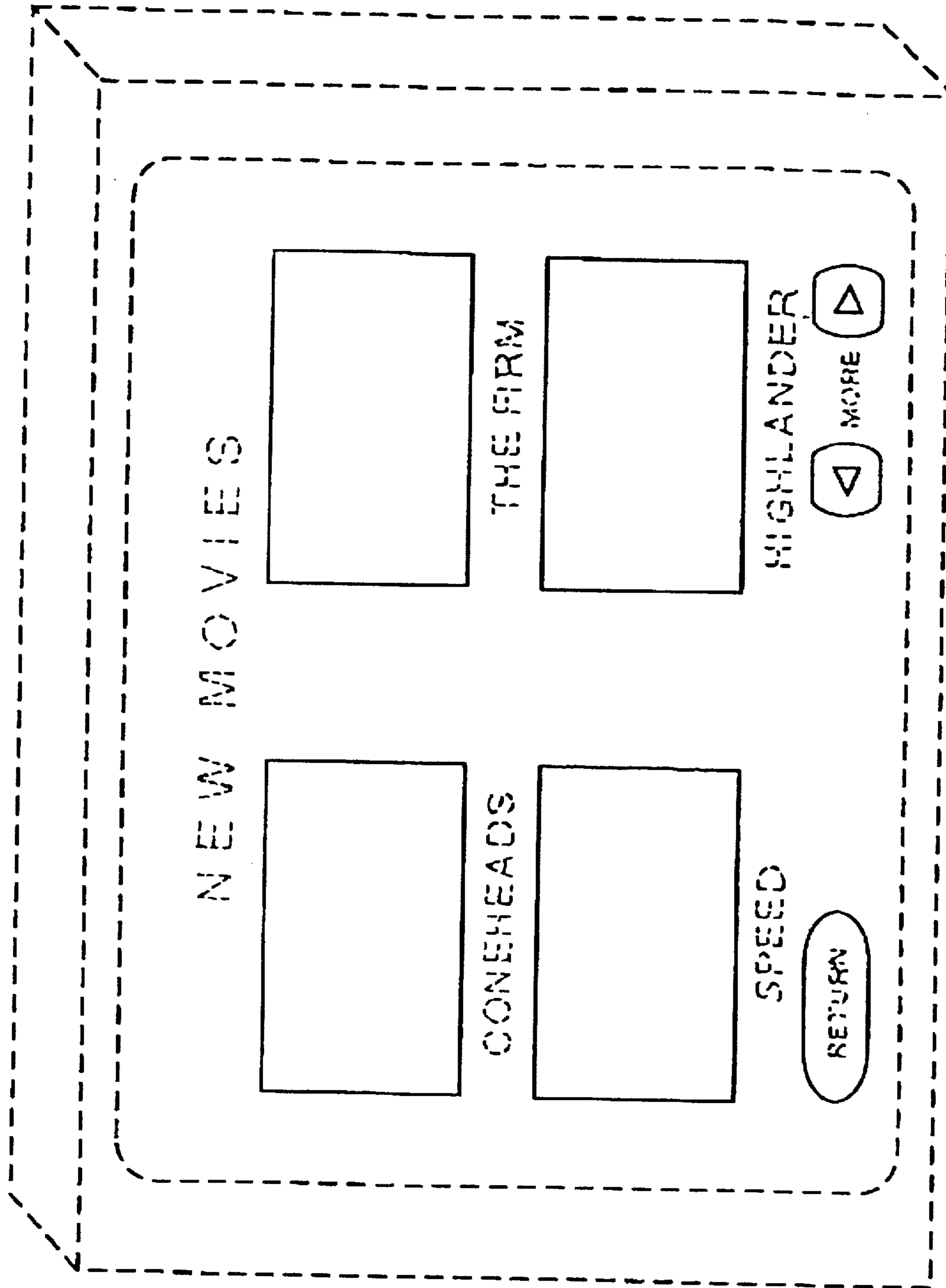
