[57] **CLAIM**

I claim the ornamental design for a 'bingo marker', as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a bingo marker, showing my new design;

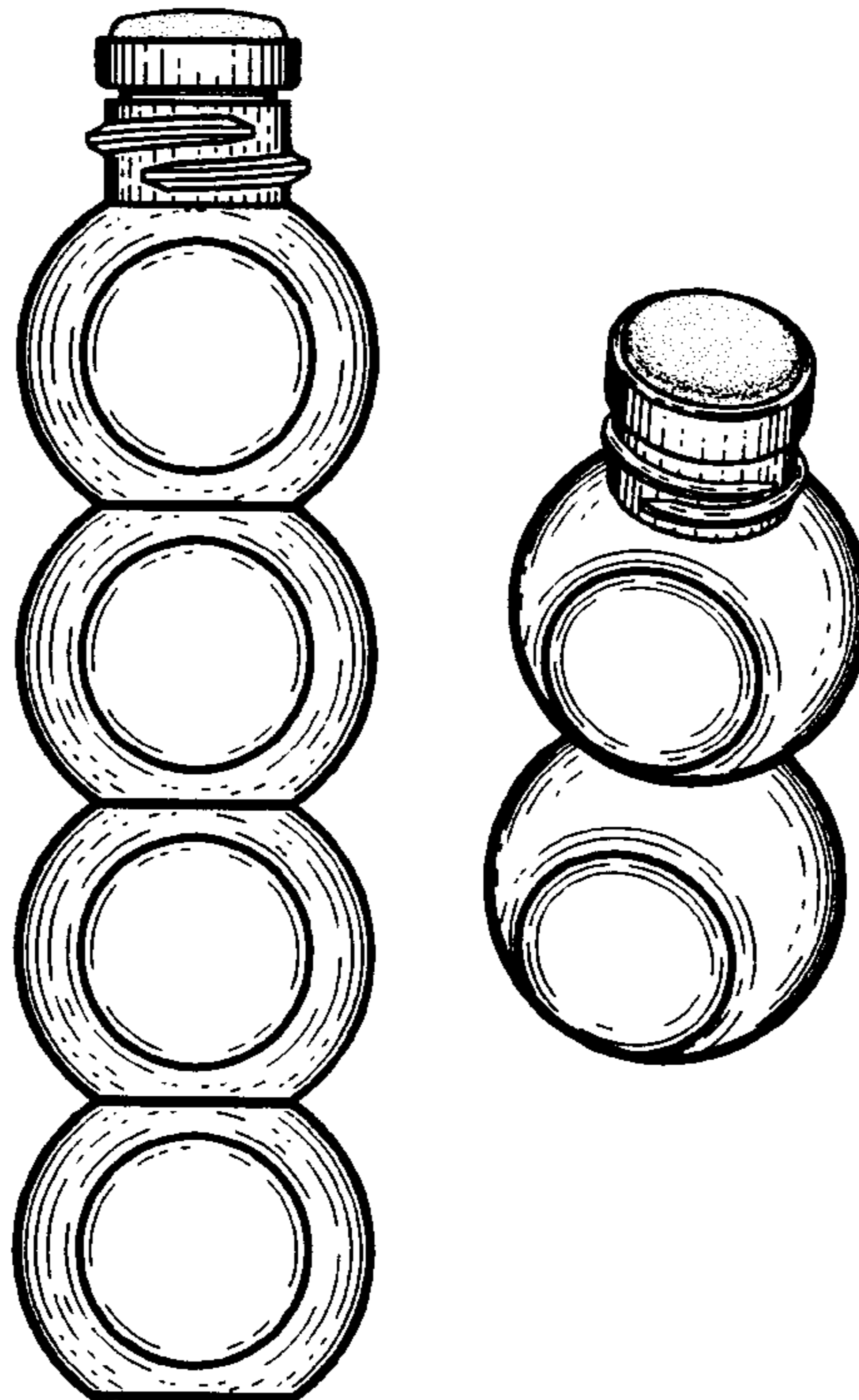

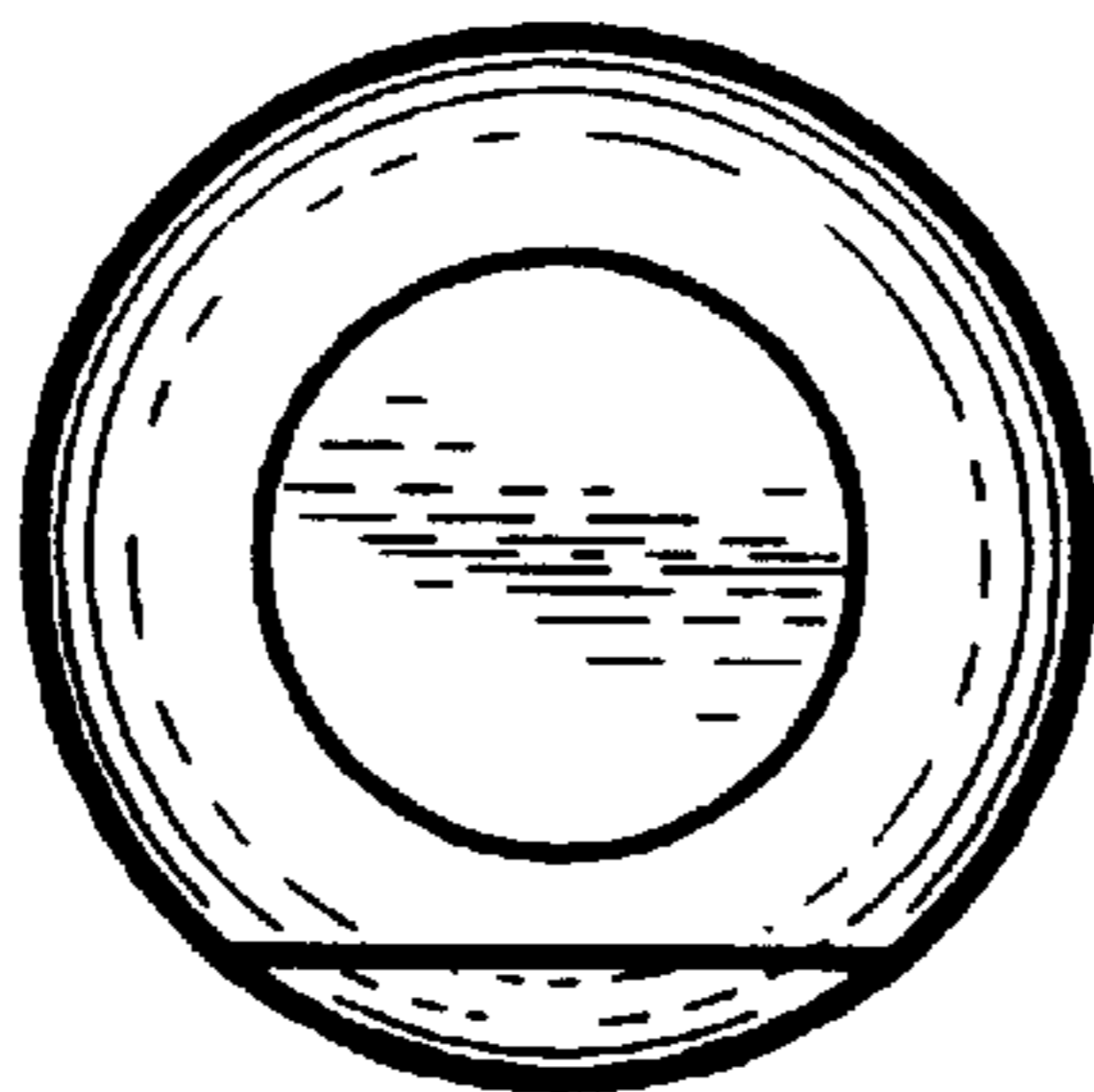

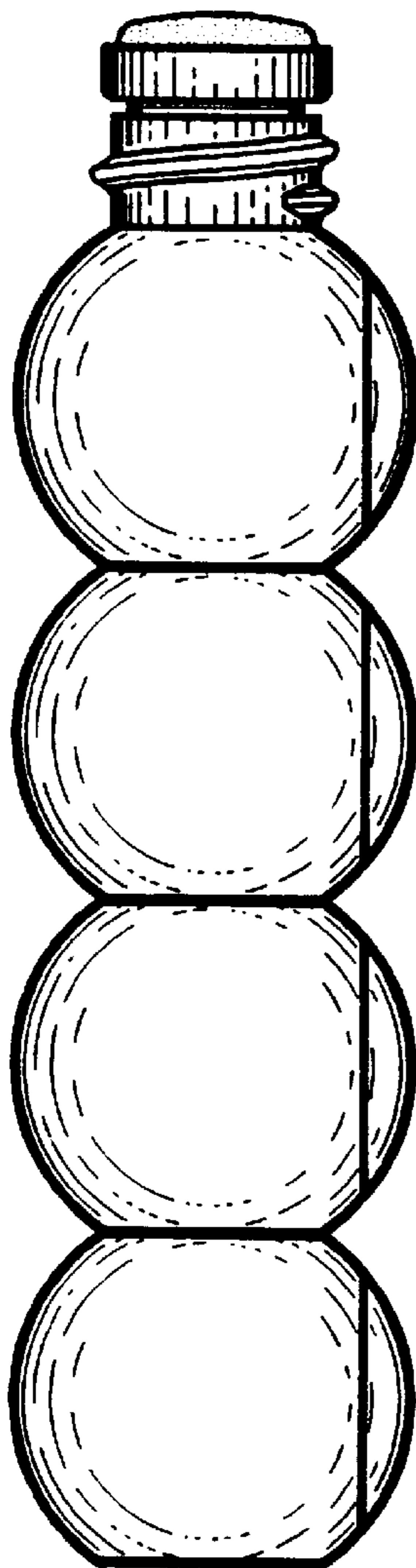
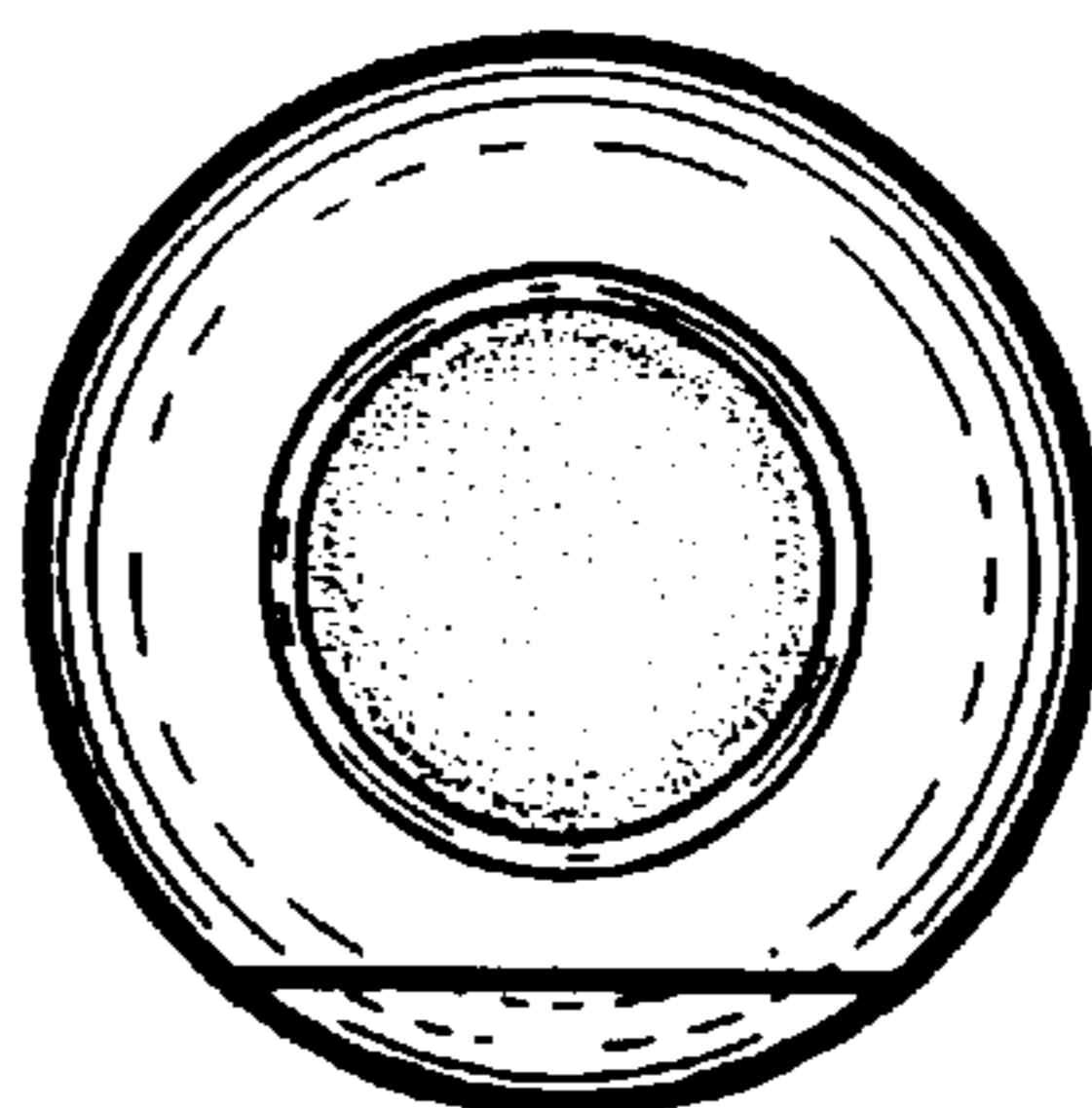

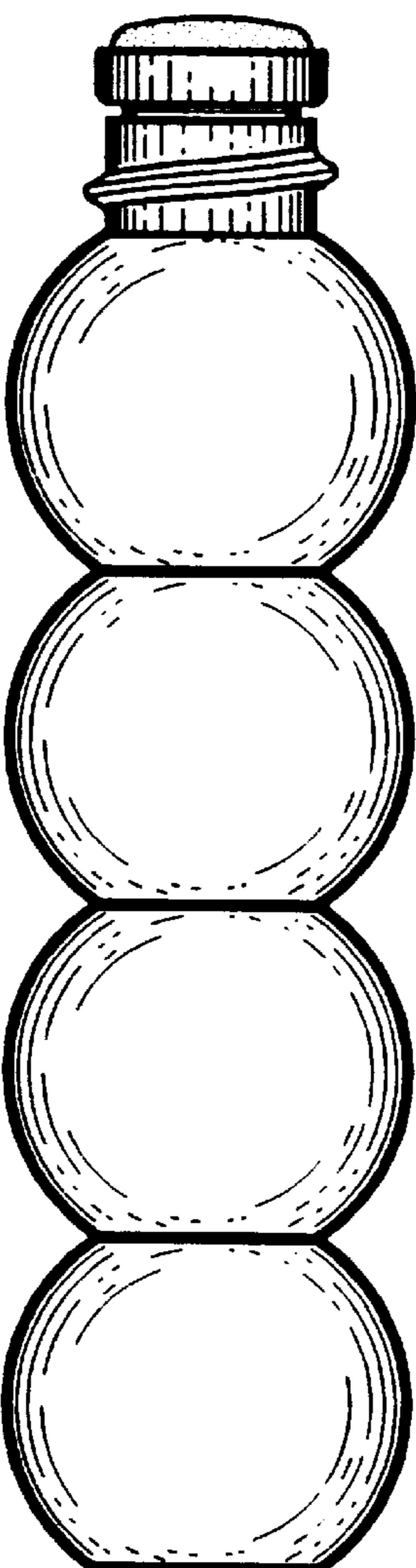

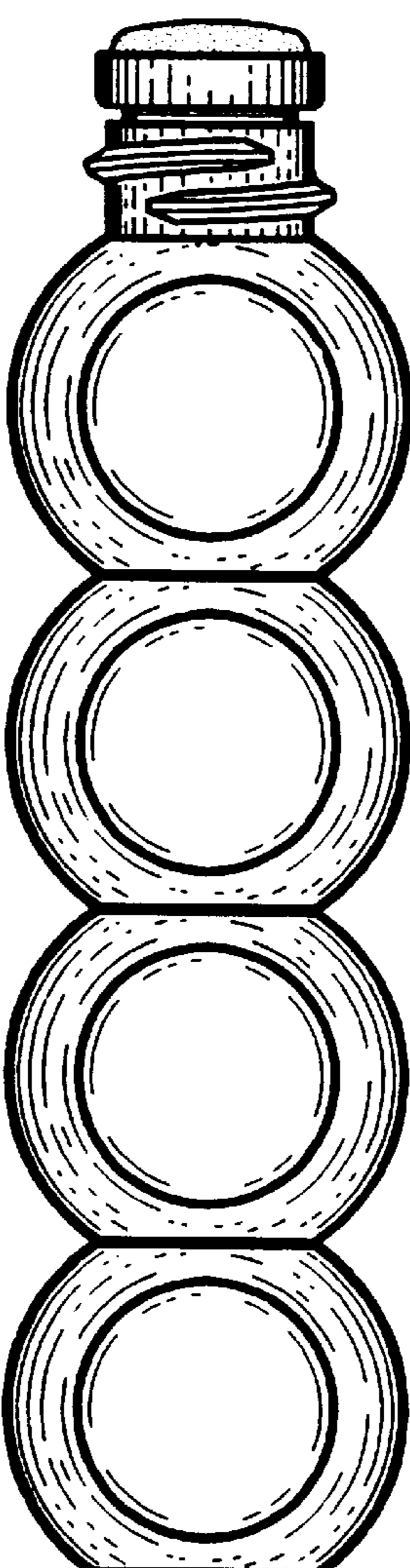

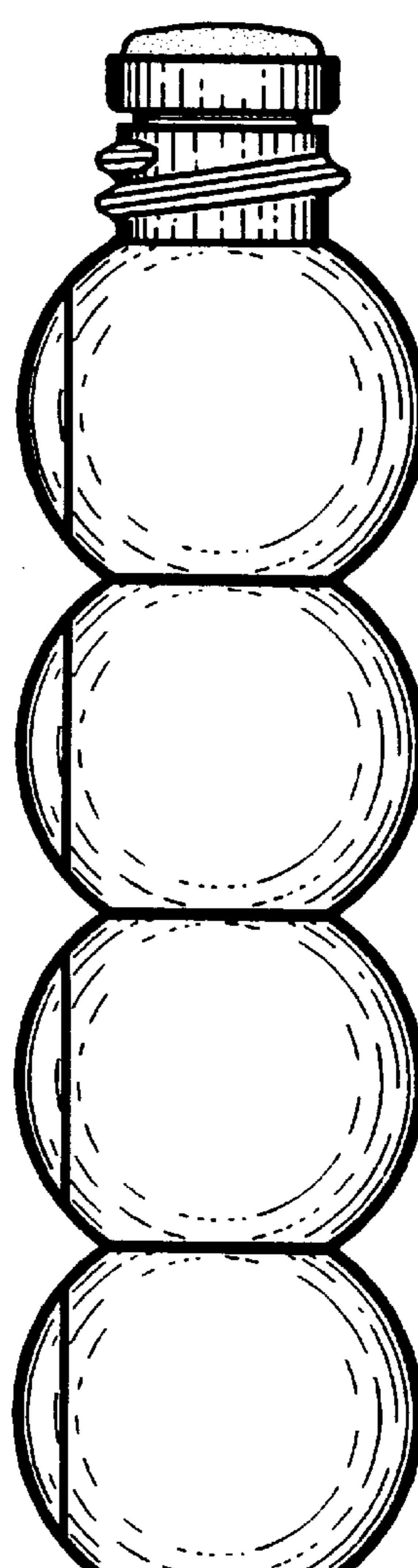

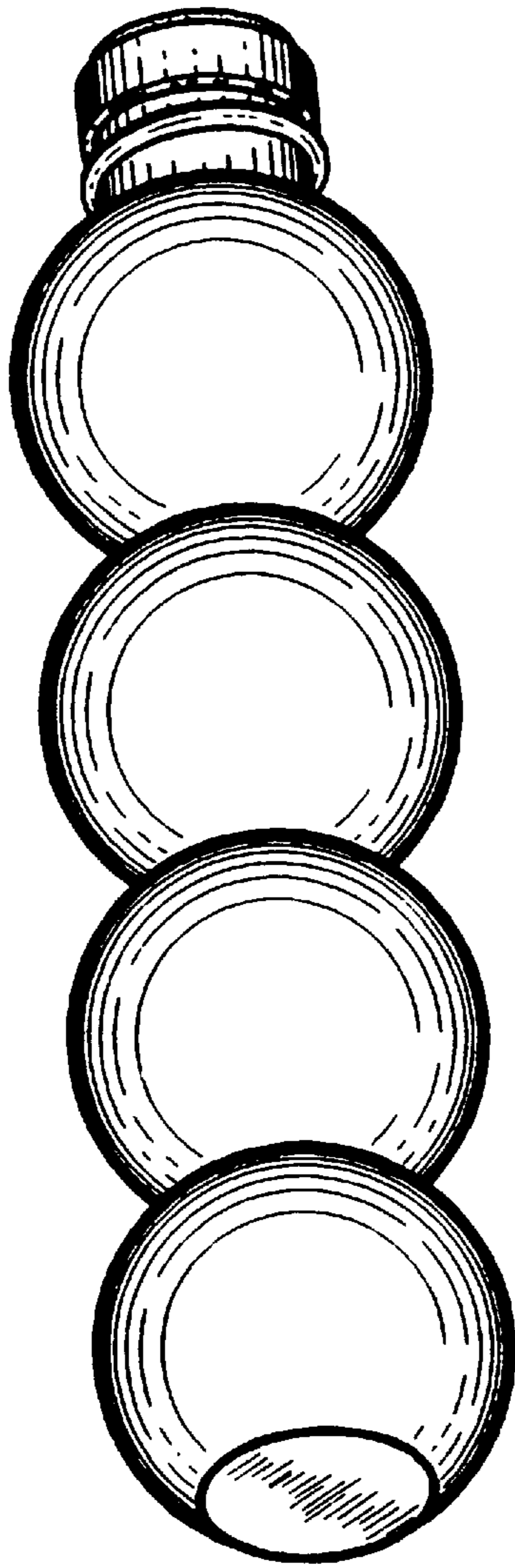

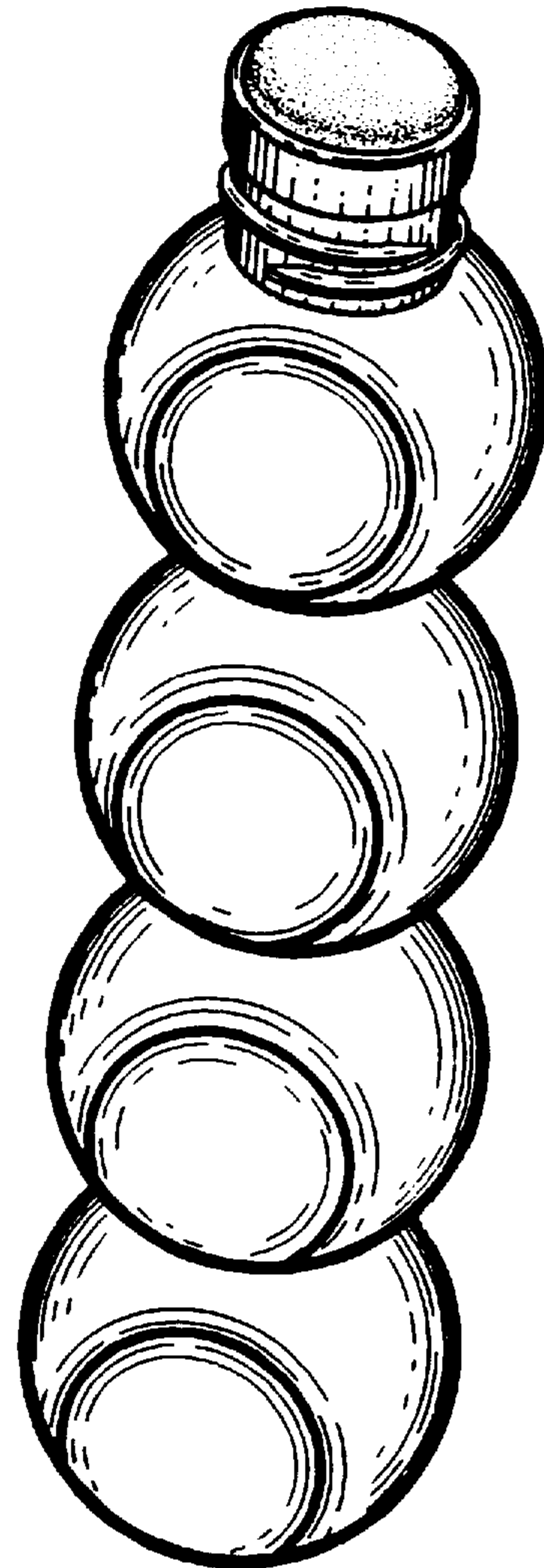

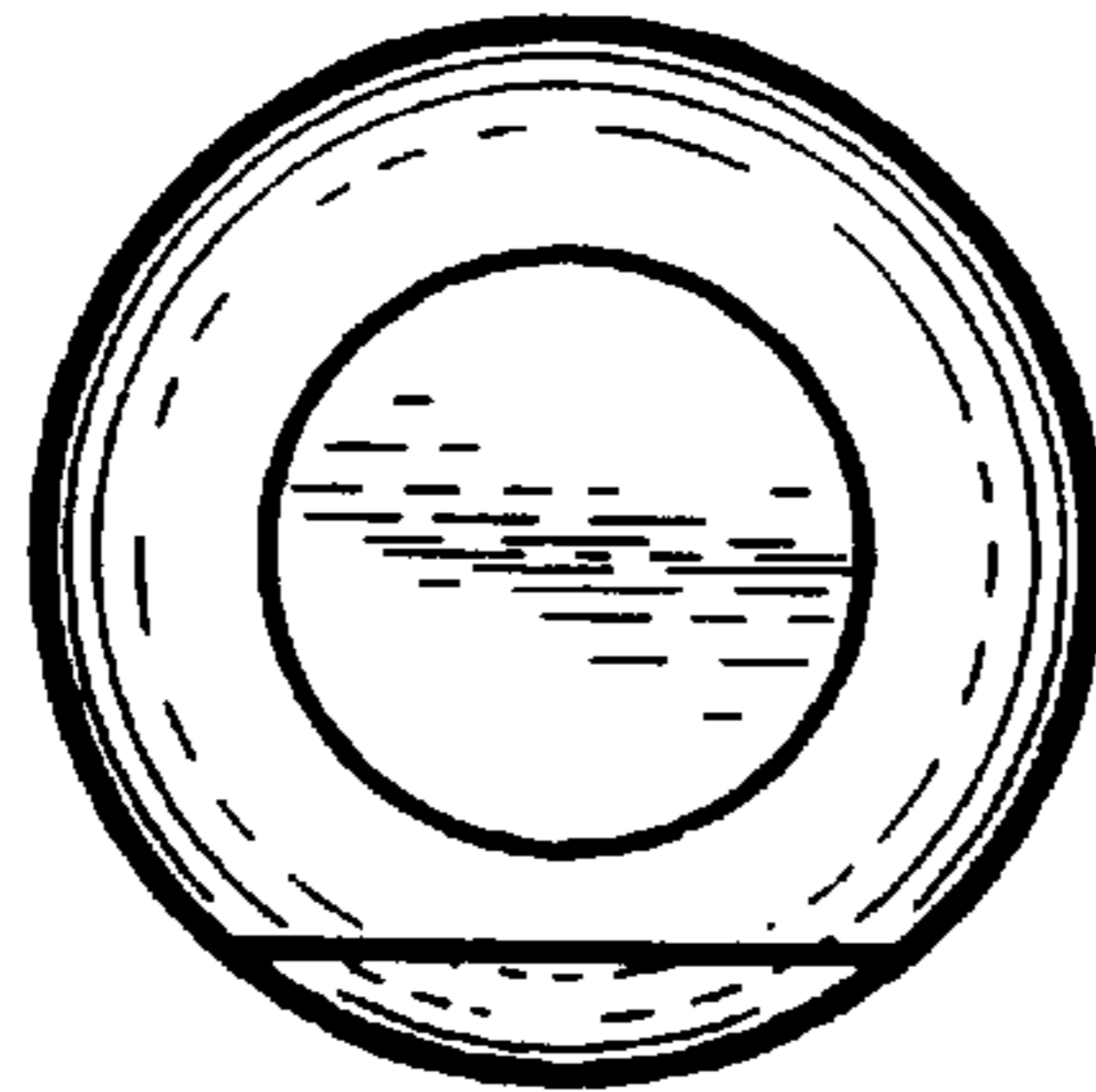

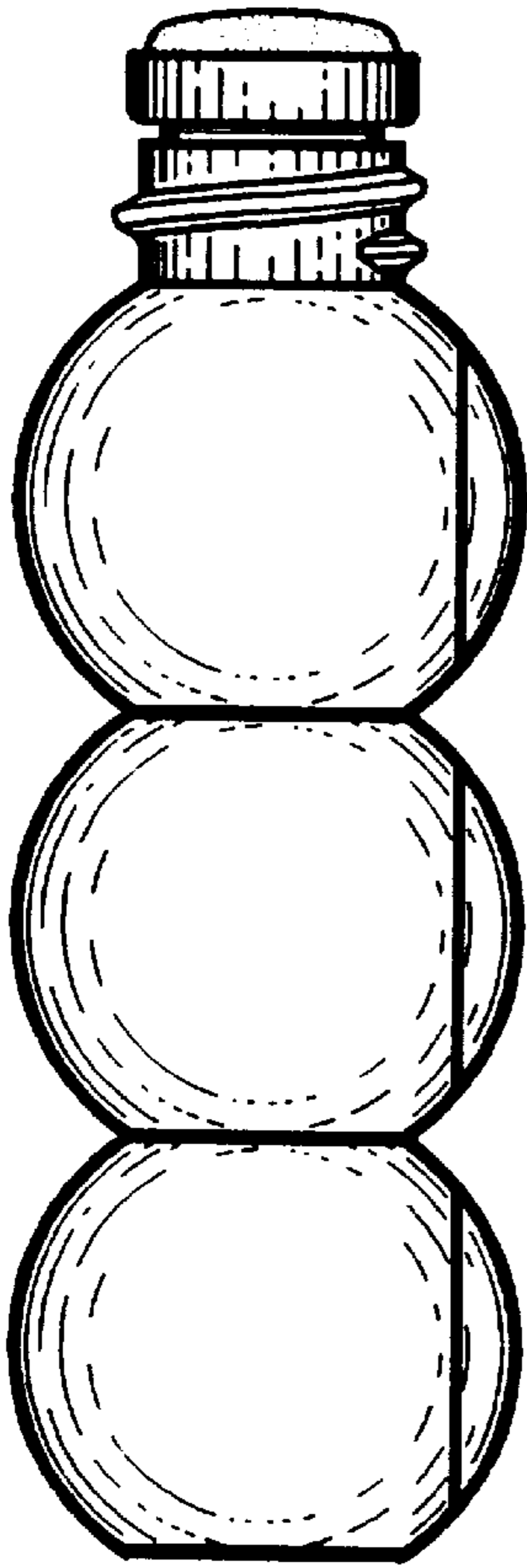
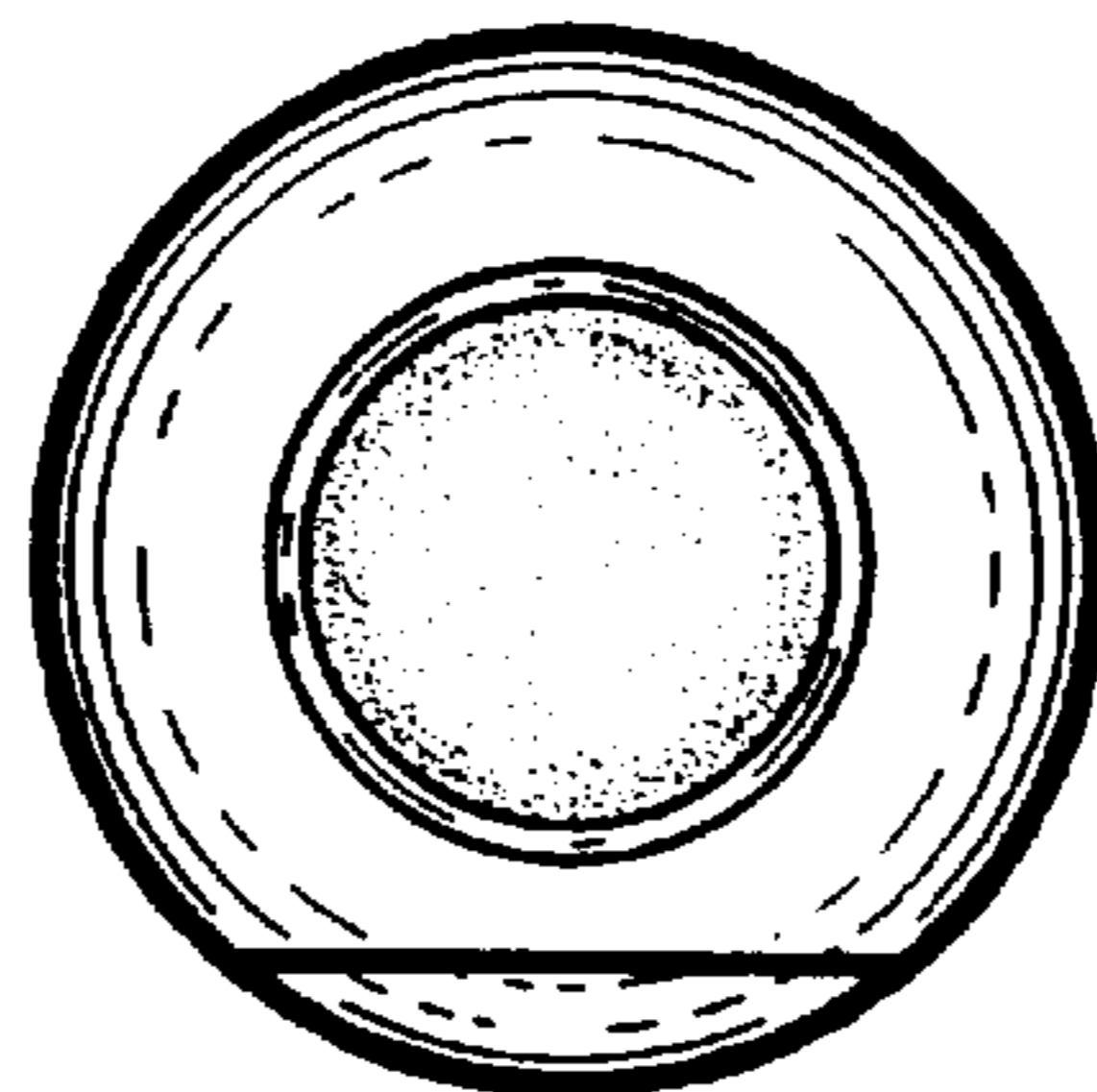

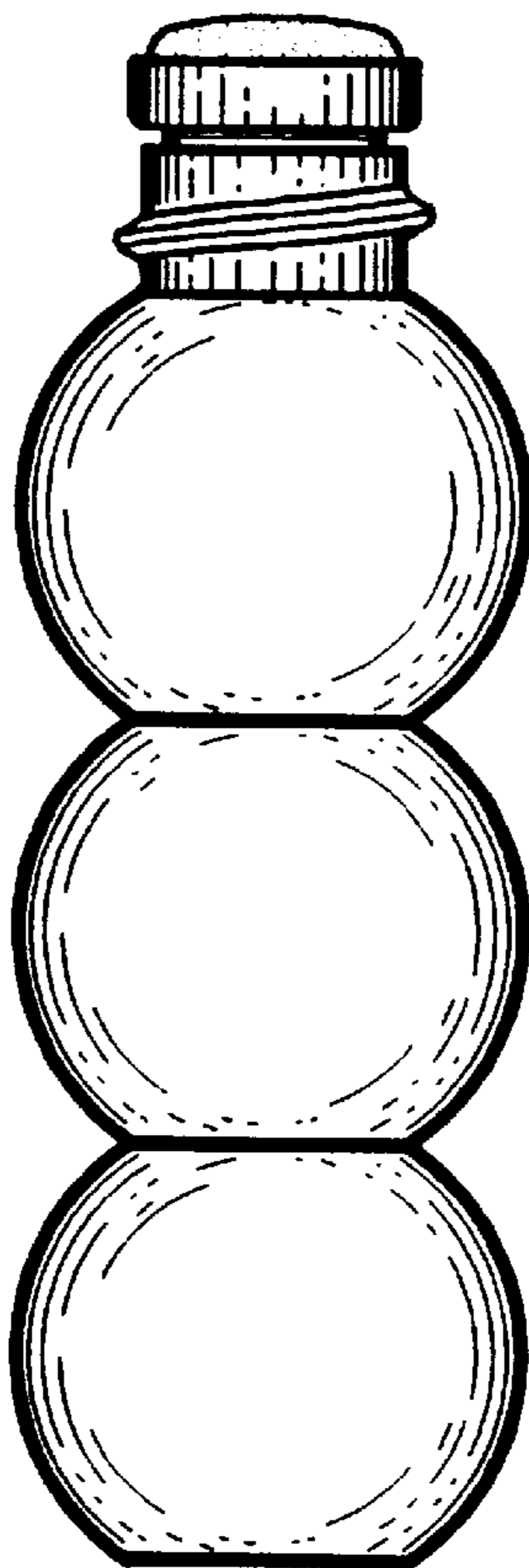

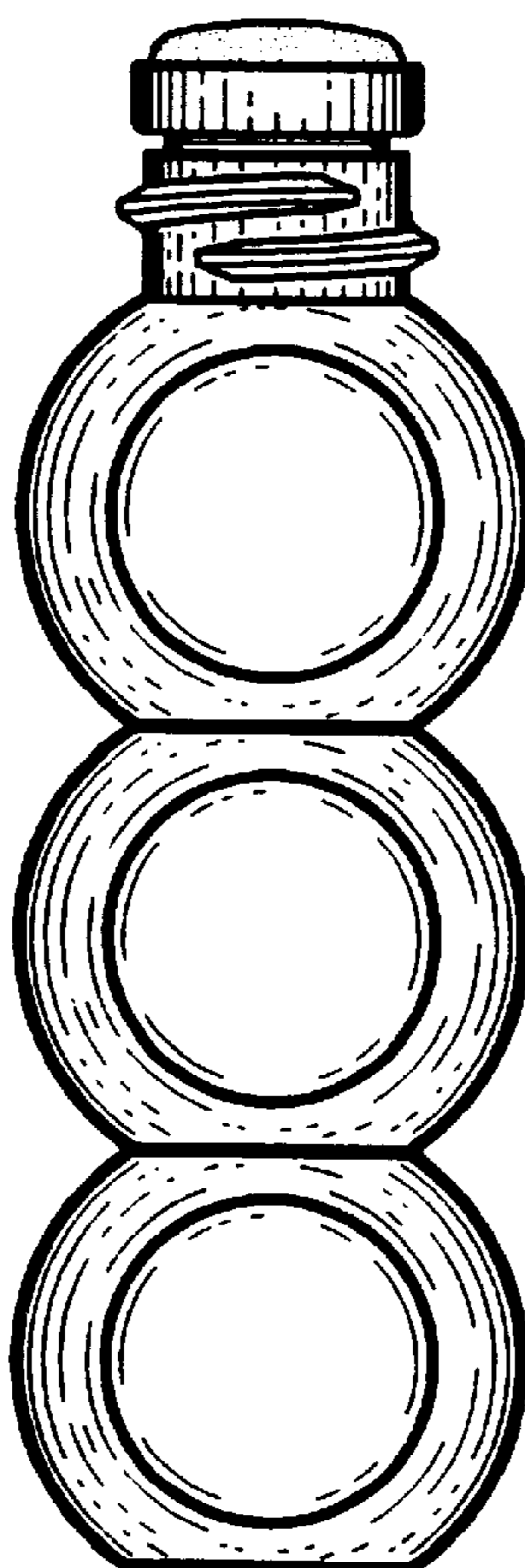

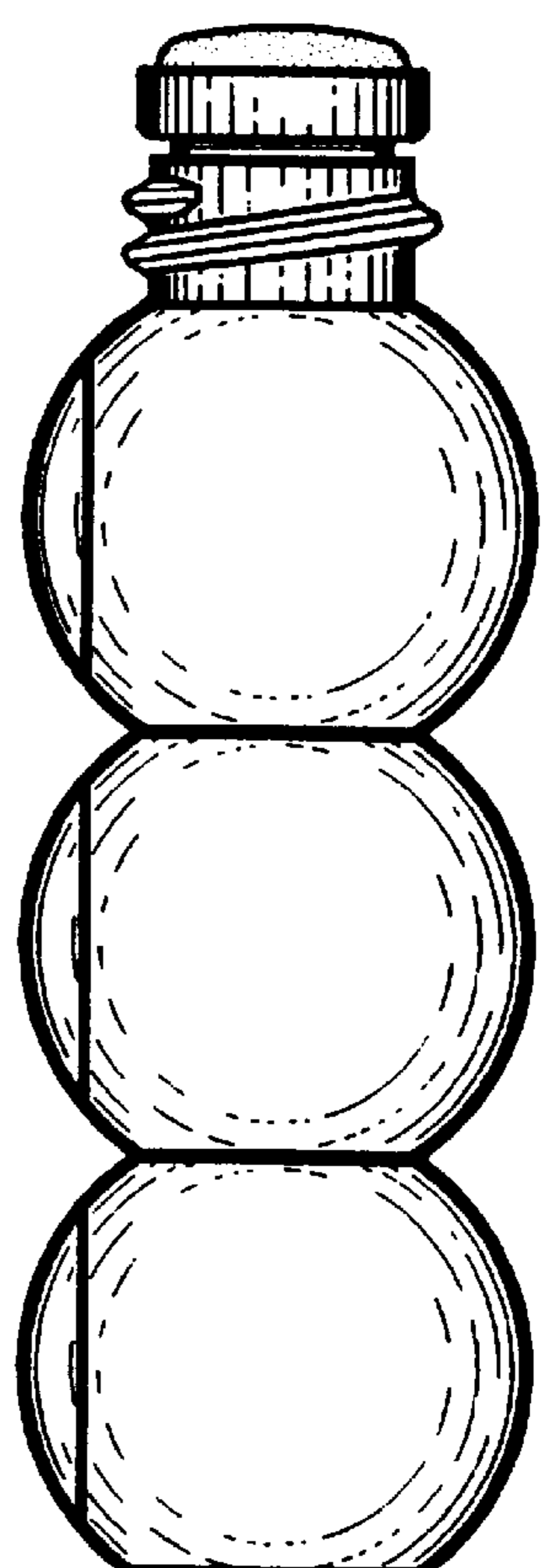

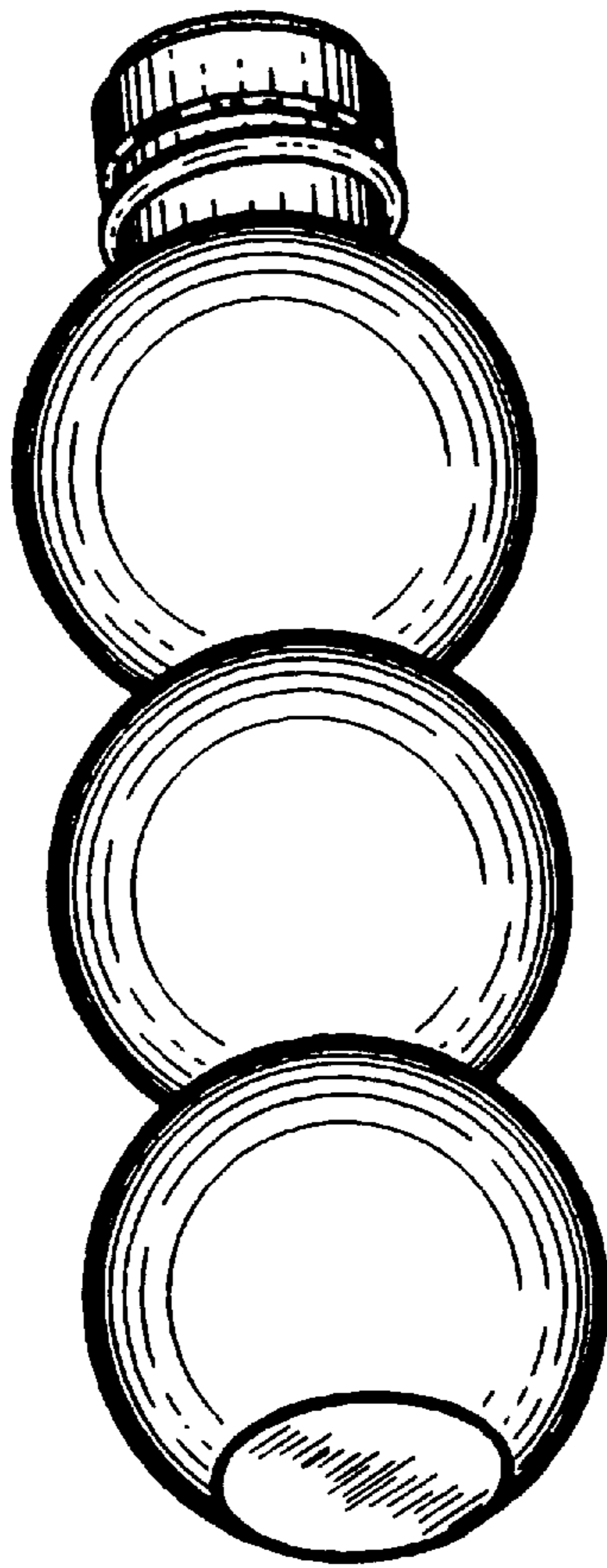

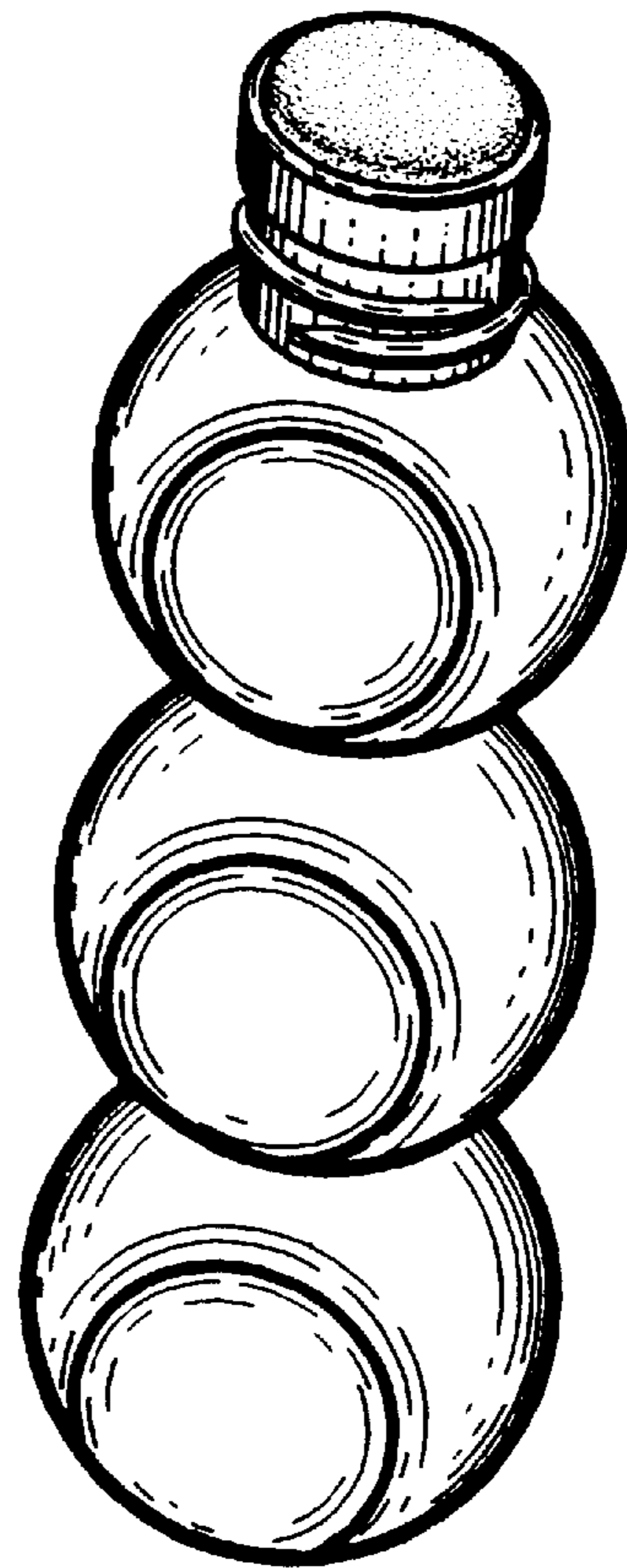

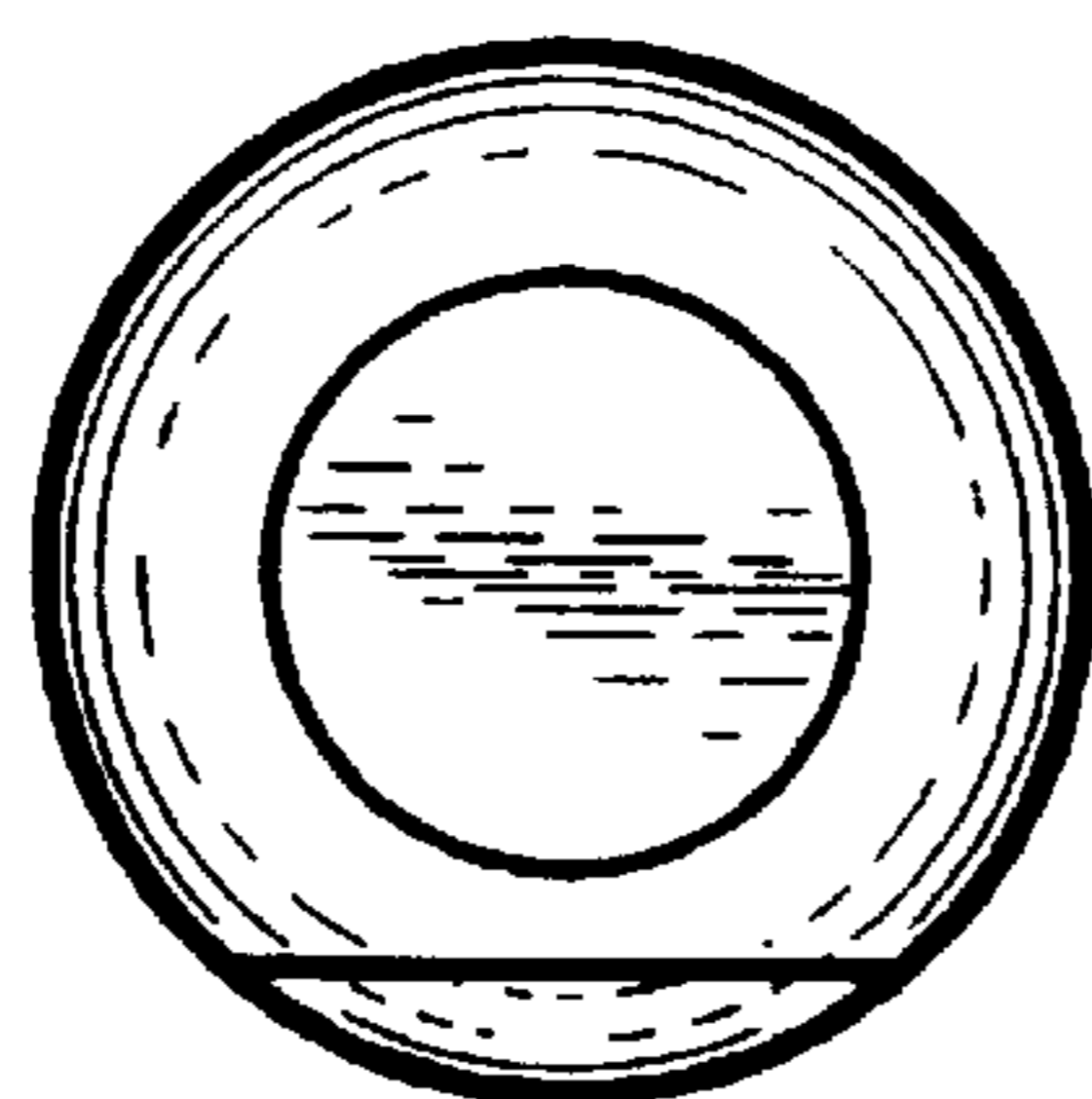

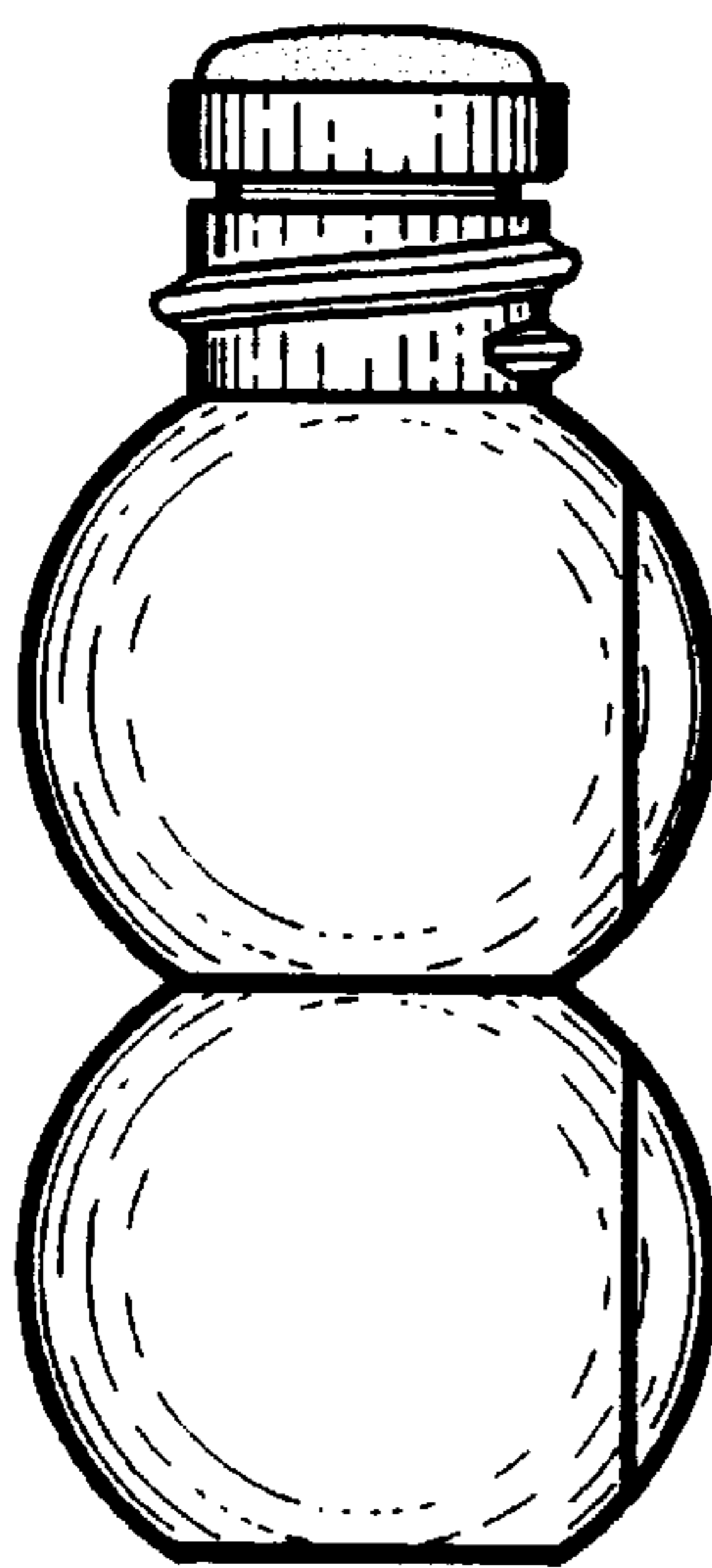
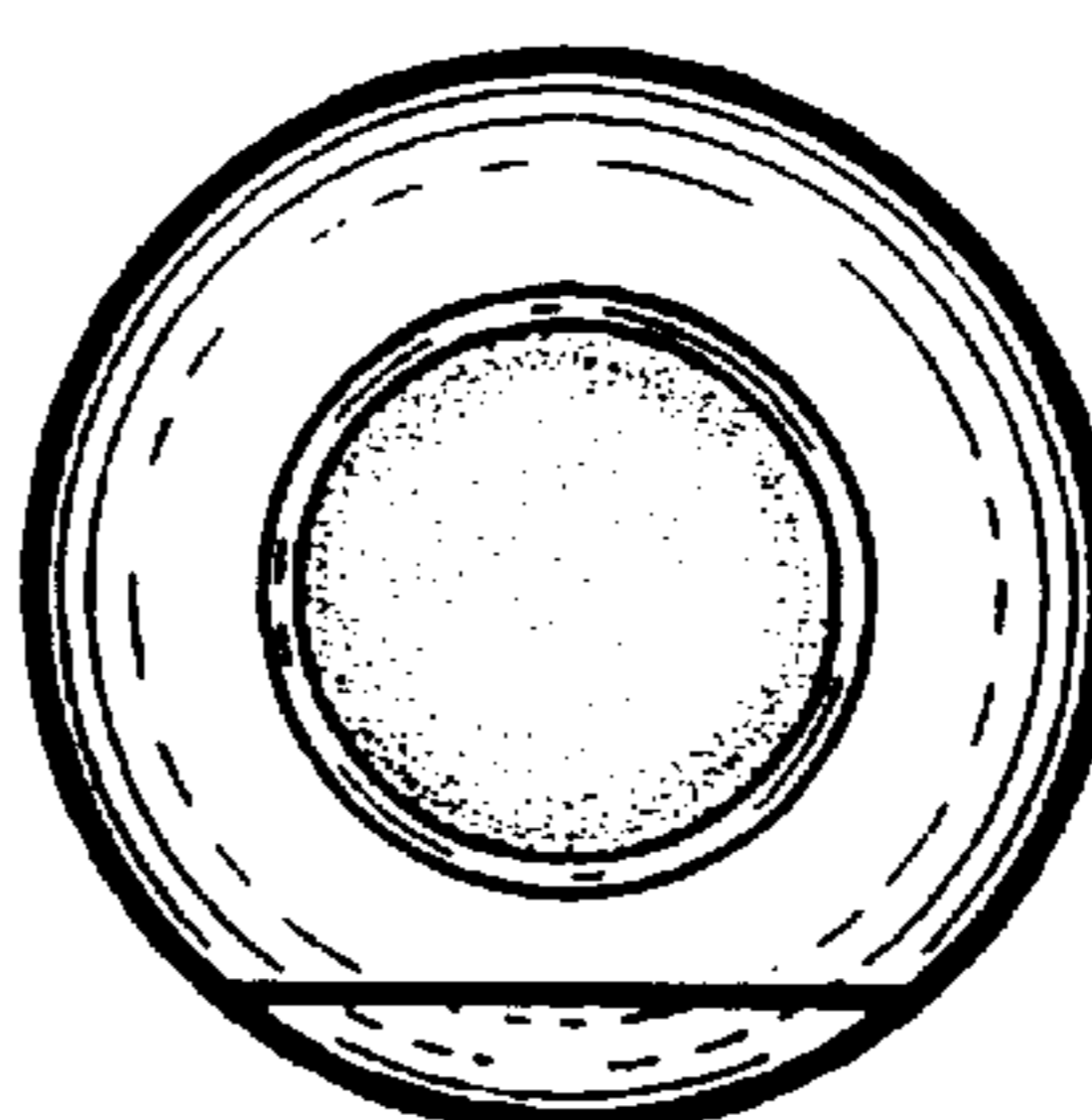

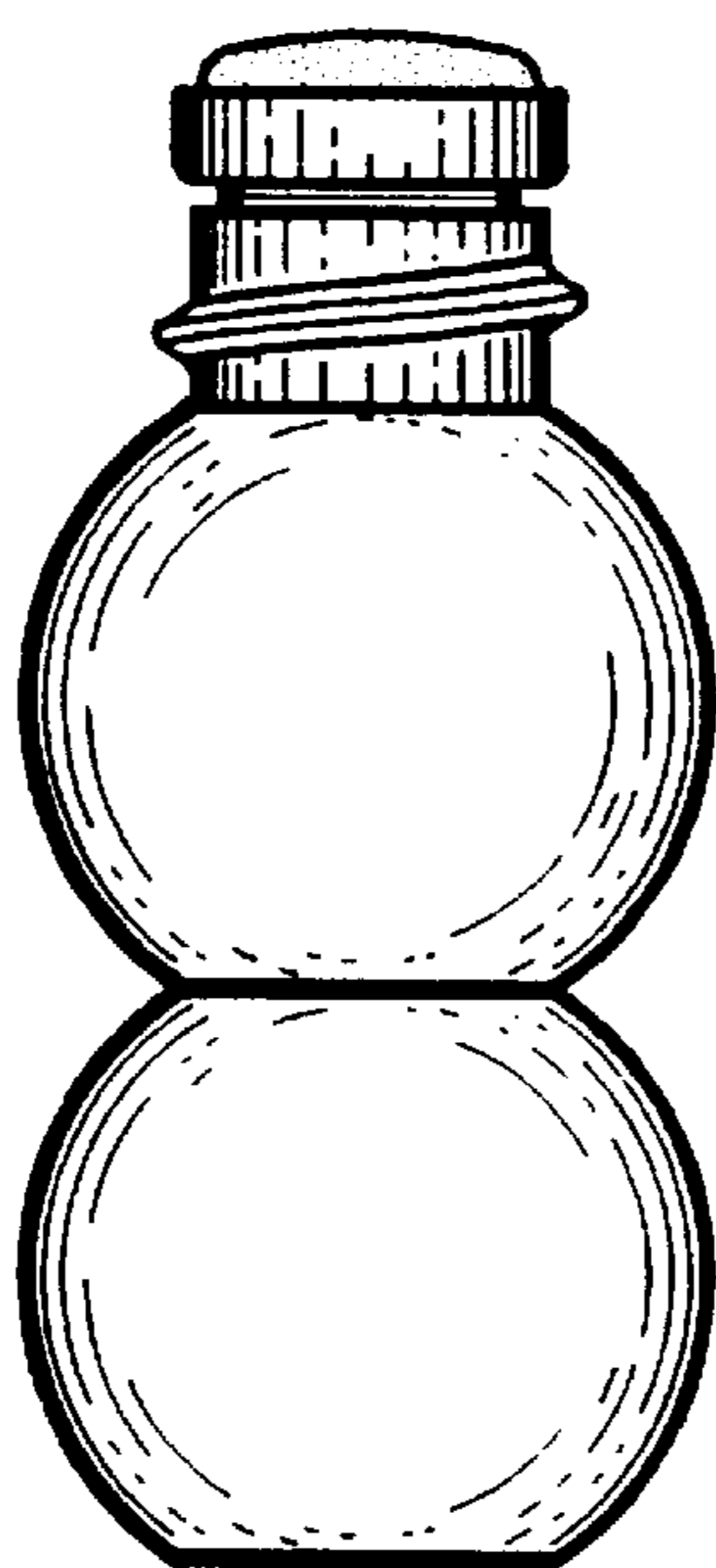

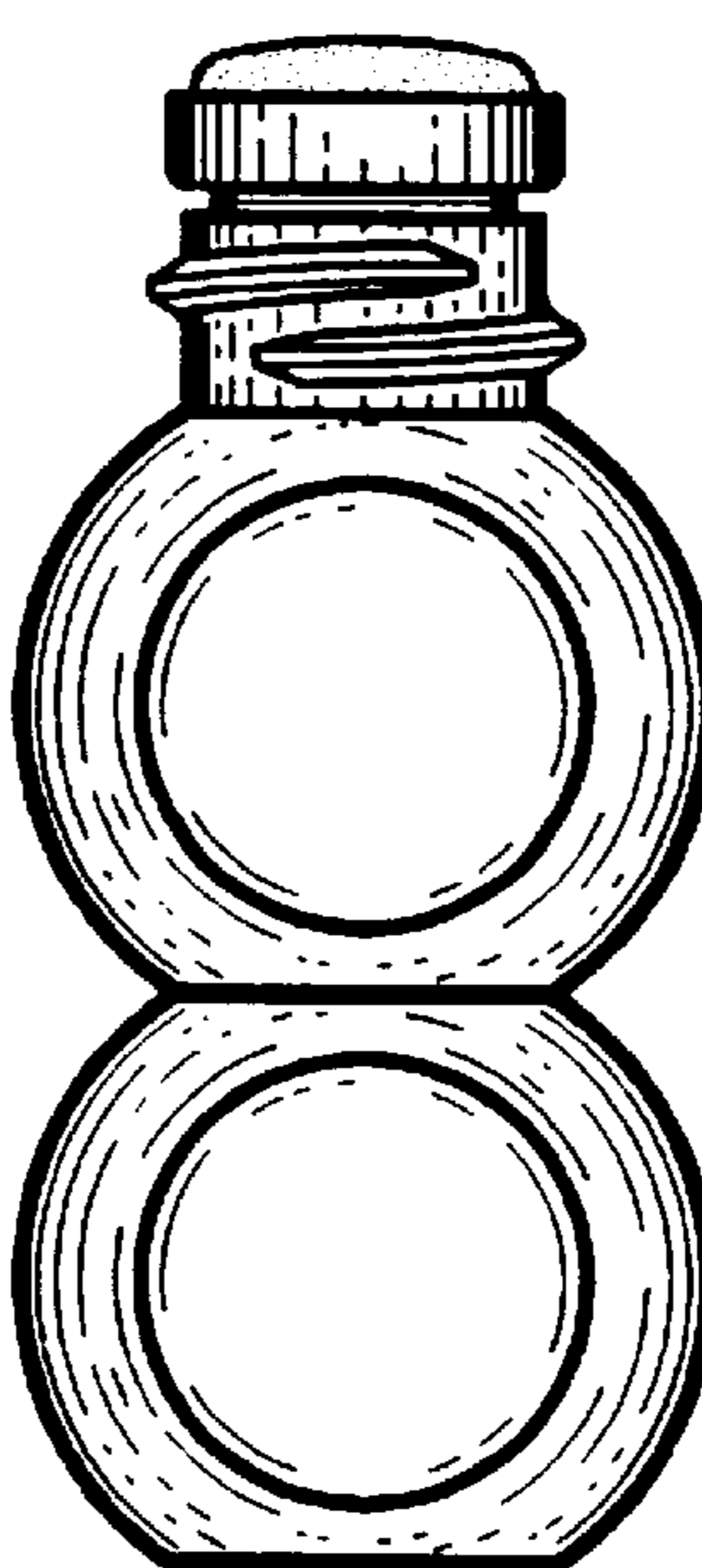

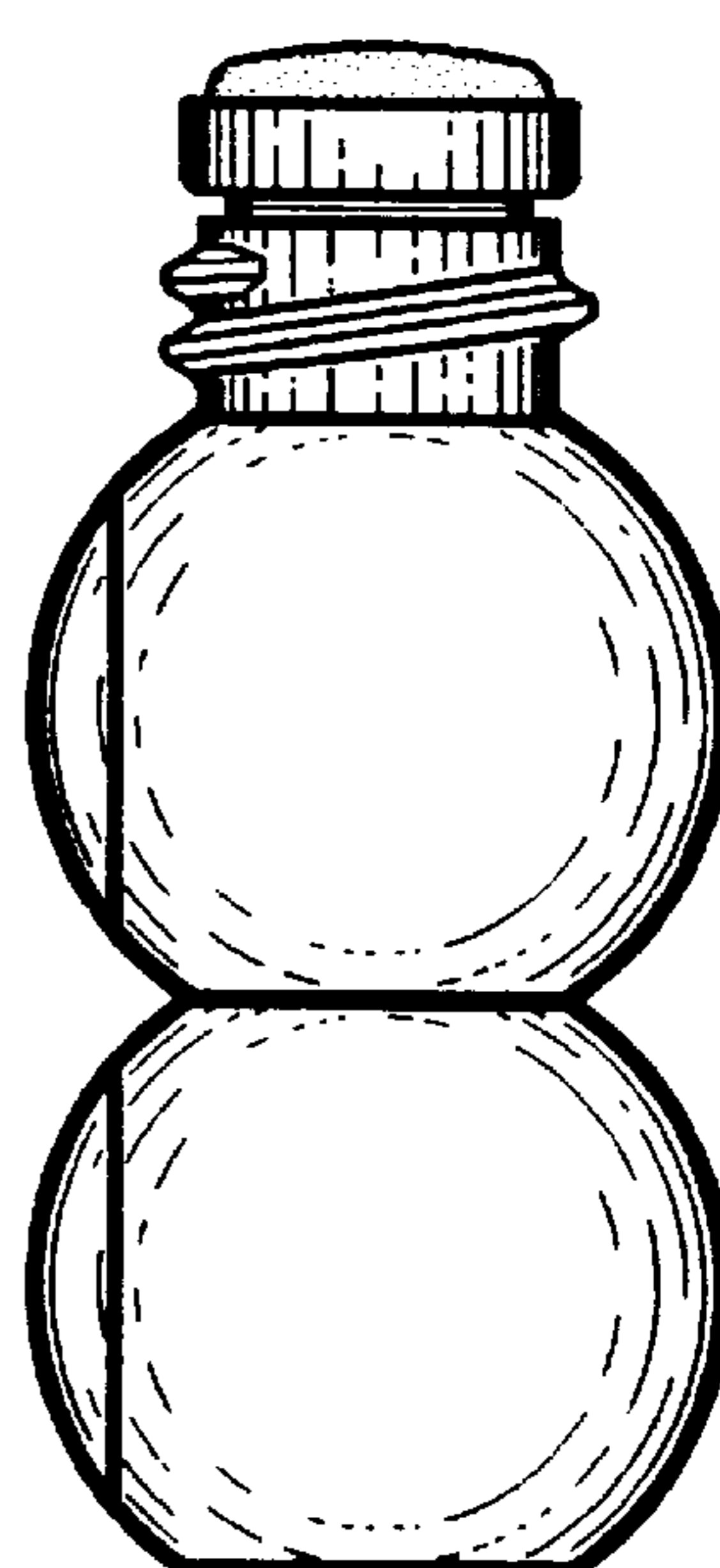

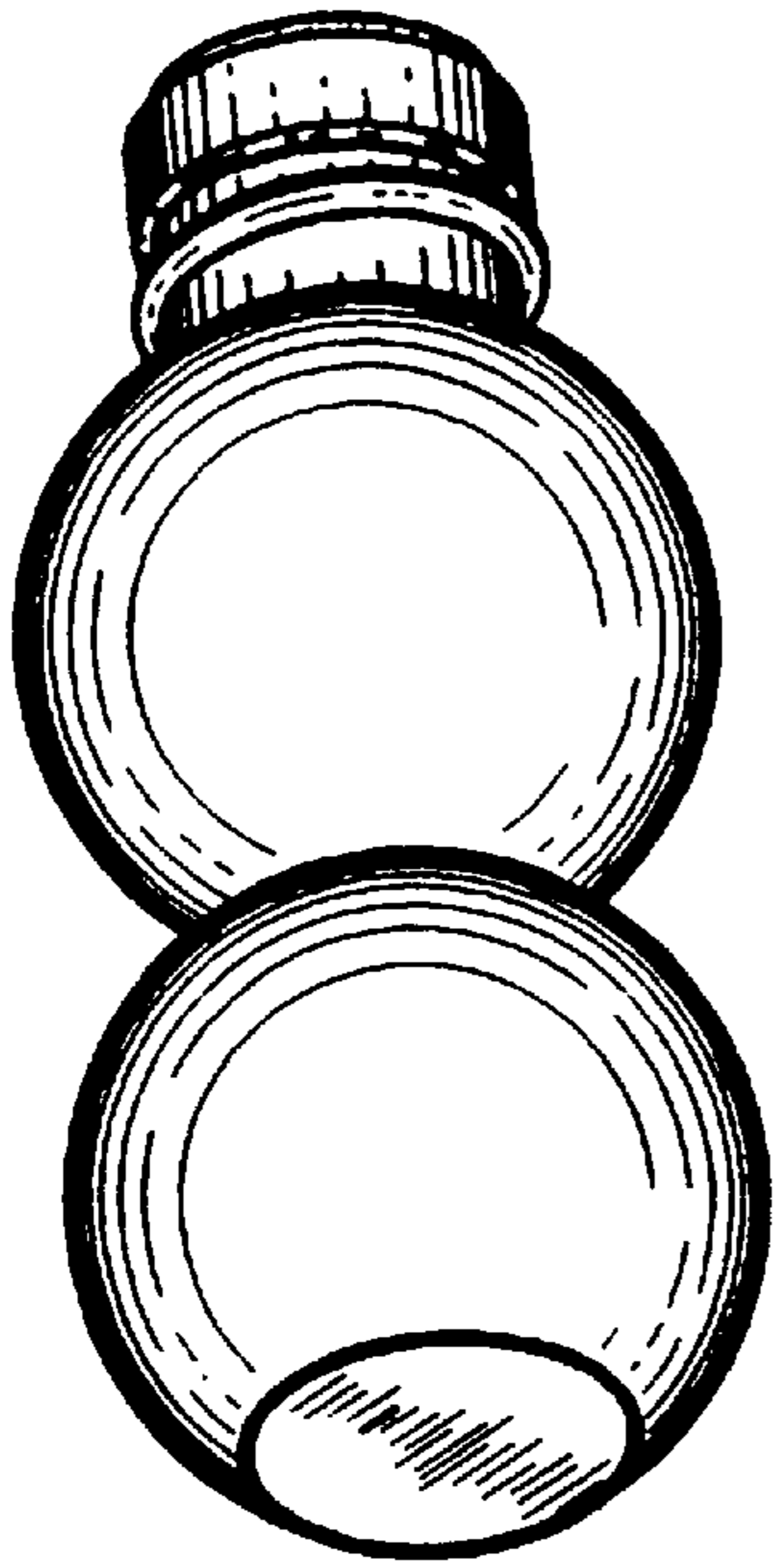

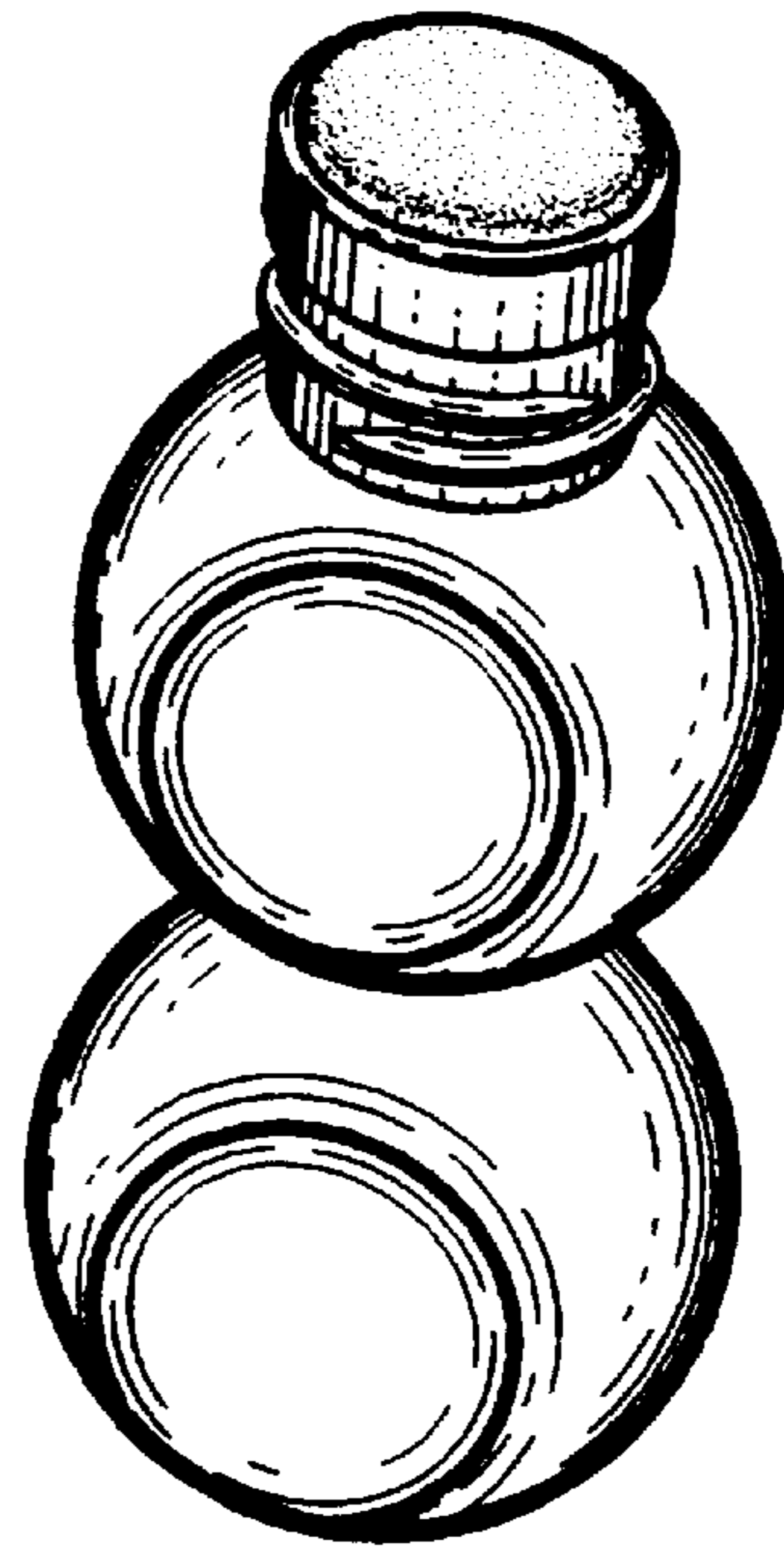
