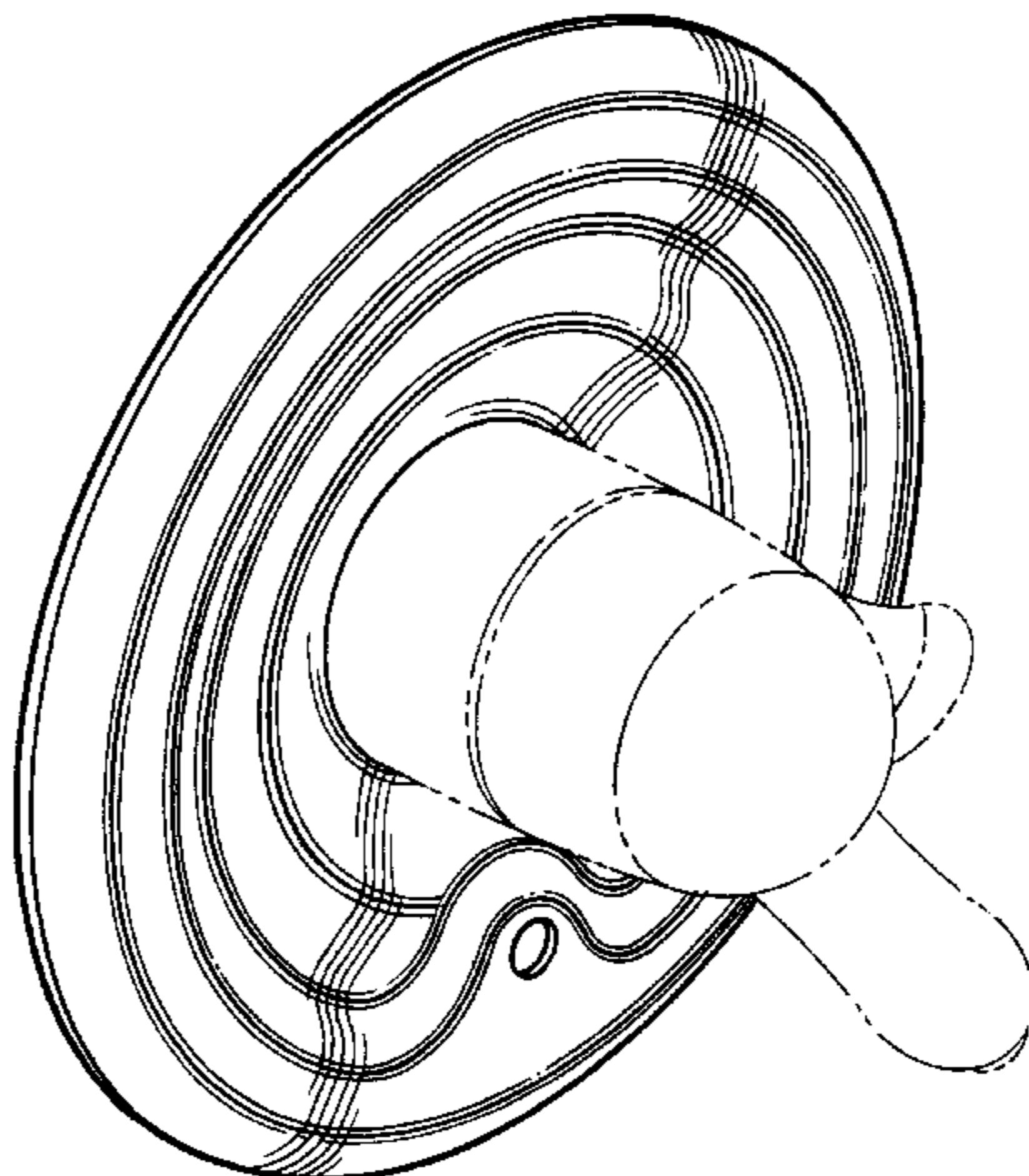
[57] **CLAIM**

The ornamental design for a shower escutcheon, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shower escutcheon showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a cross-sectional view taken along line 7—7 in FIG. 2.
The broken line showing of the handle in FIG. 1 is for purposes of illustration only and forms no part of the claimed design.

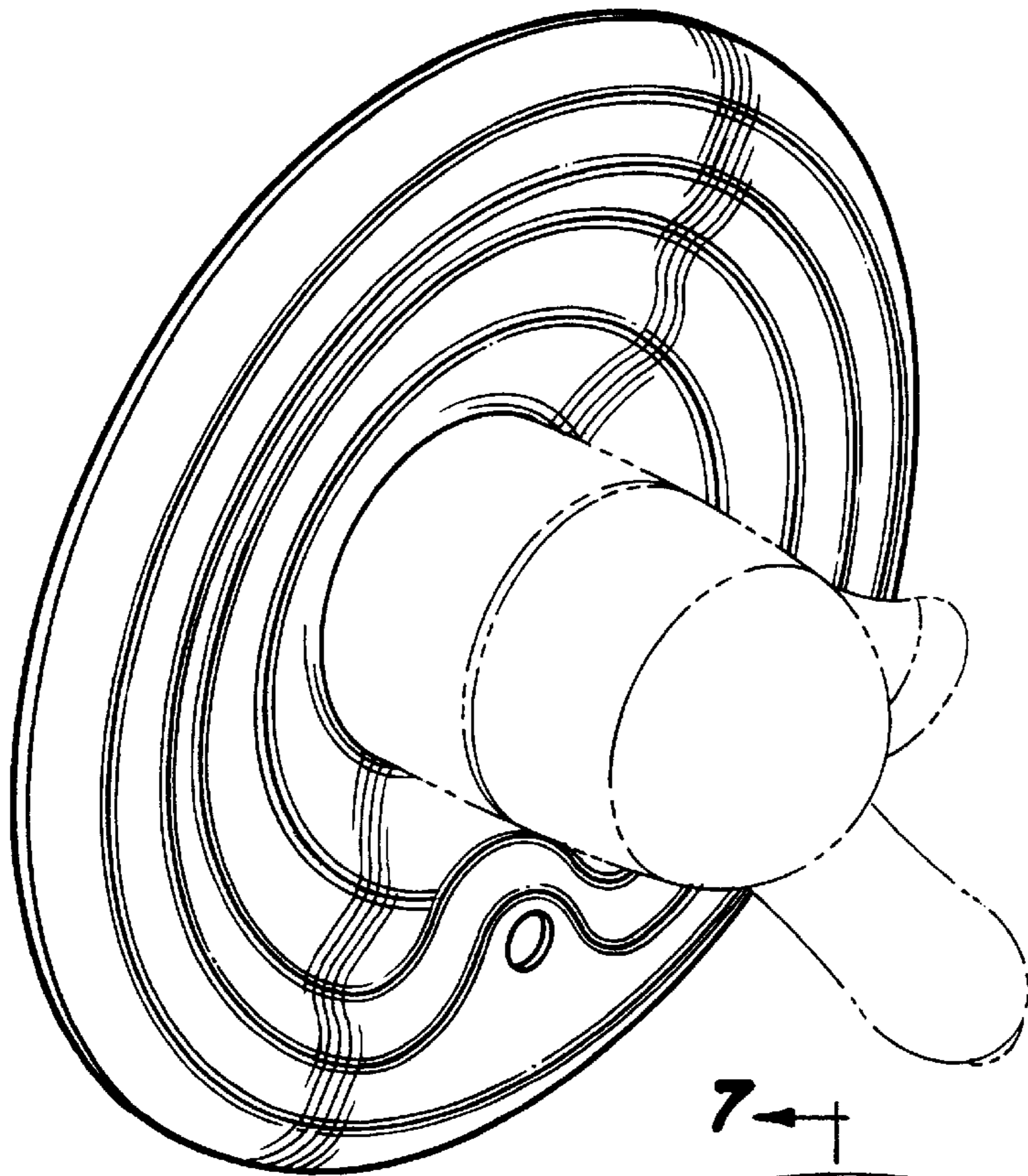

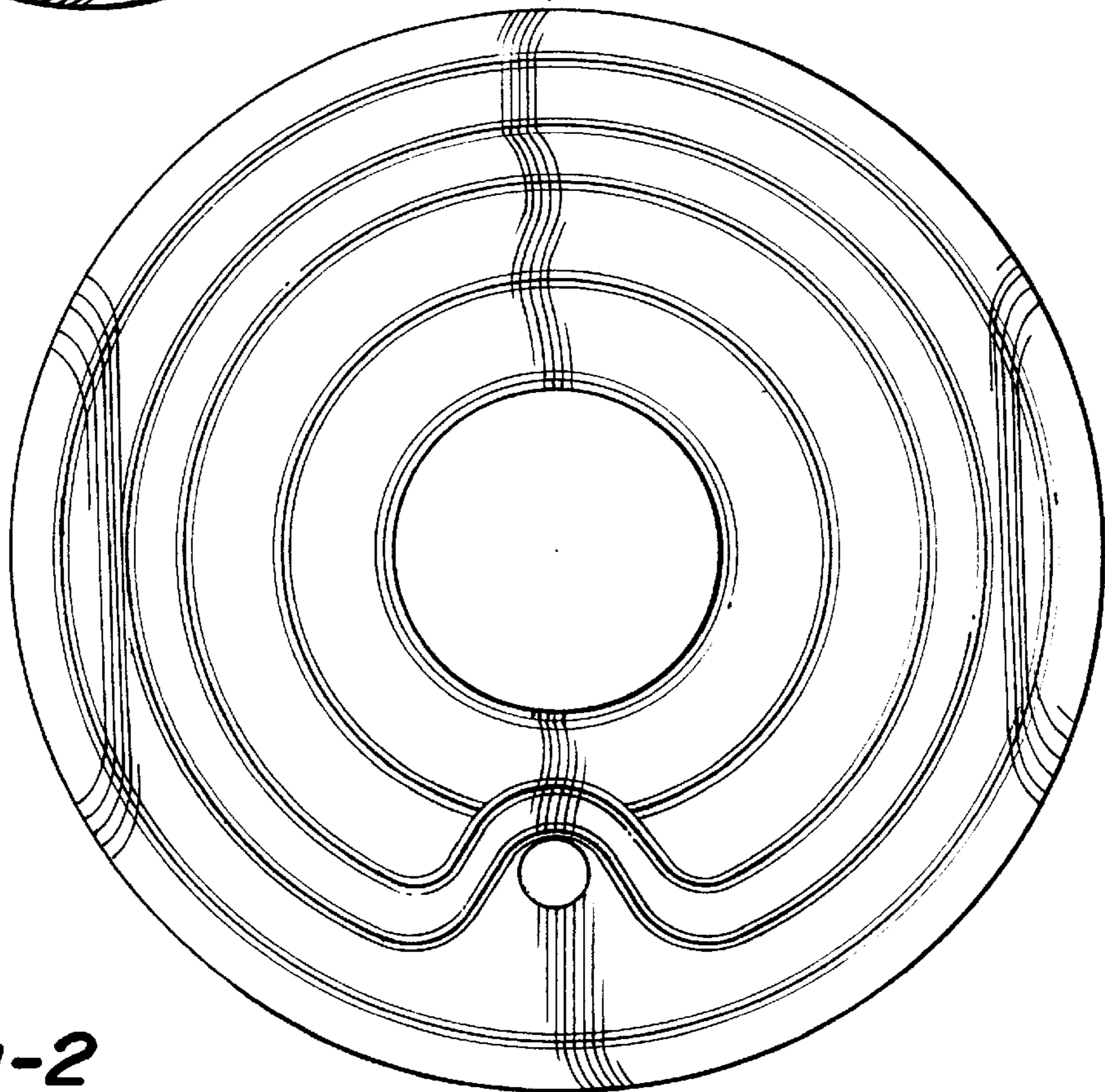

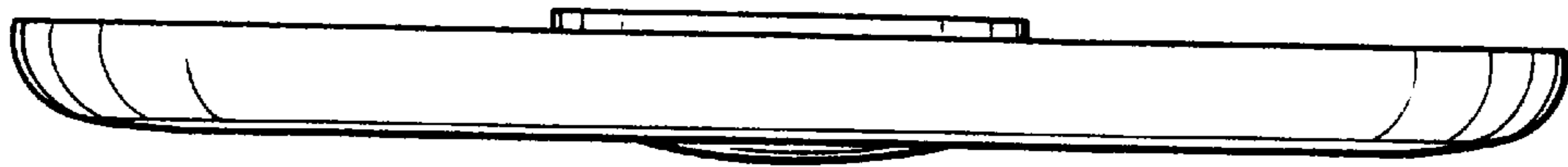

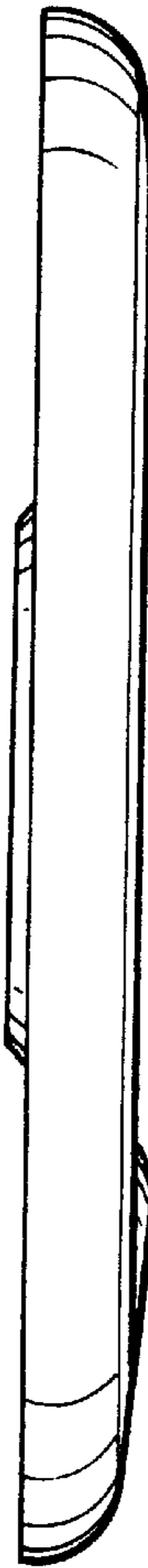

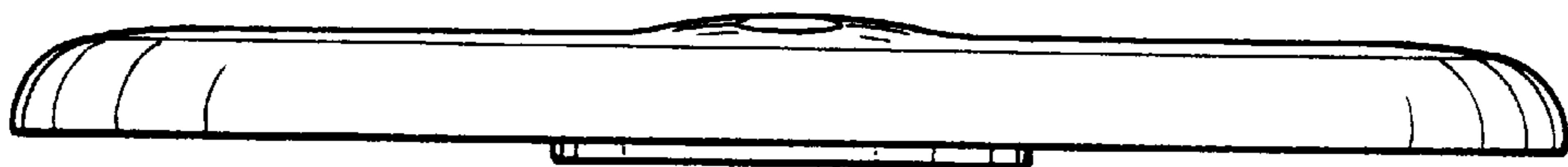

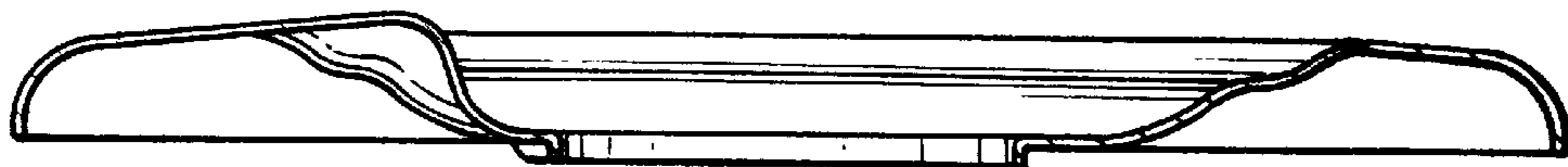
