[57] CLAIM

The ornamental design for a disposable diagnostic swab for measuring depth of wounds, as shown and described.

DESCRIPTION

FIG. 1 is an enlarged side view of a disposable diagnostic swab for measuring depth of wounds showing our new design, the other side being identical thereof; FIG. 2 is an end view thereof; and, FIG. 3 is the other end view thereof.
