[57] **CLAIM**

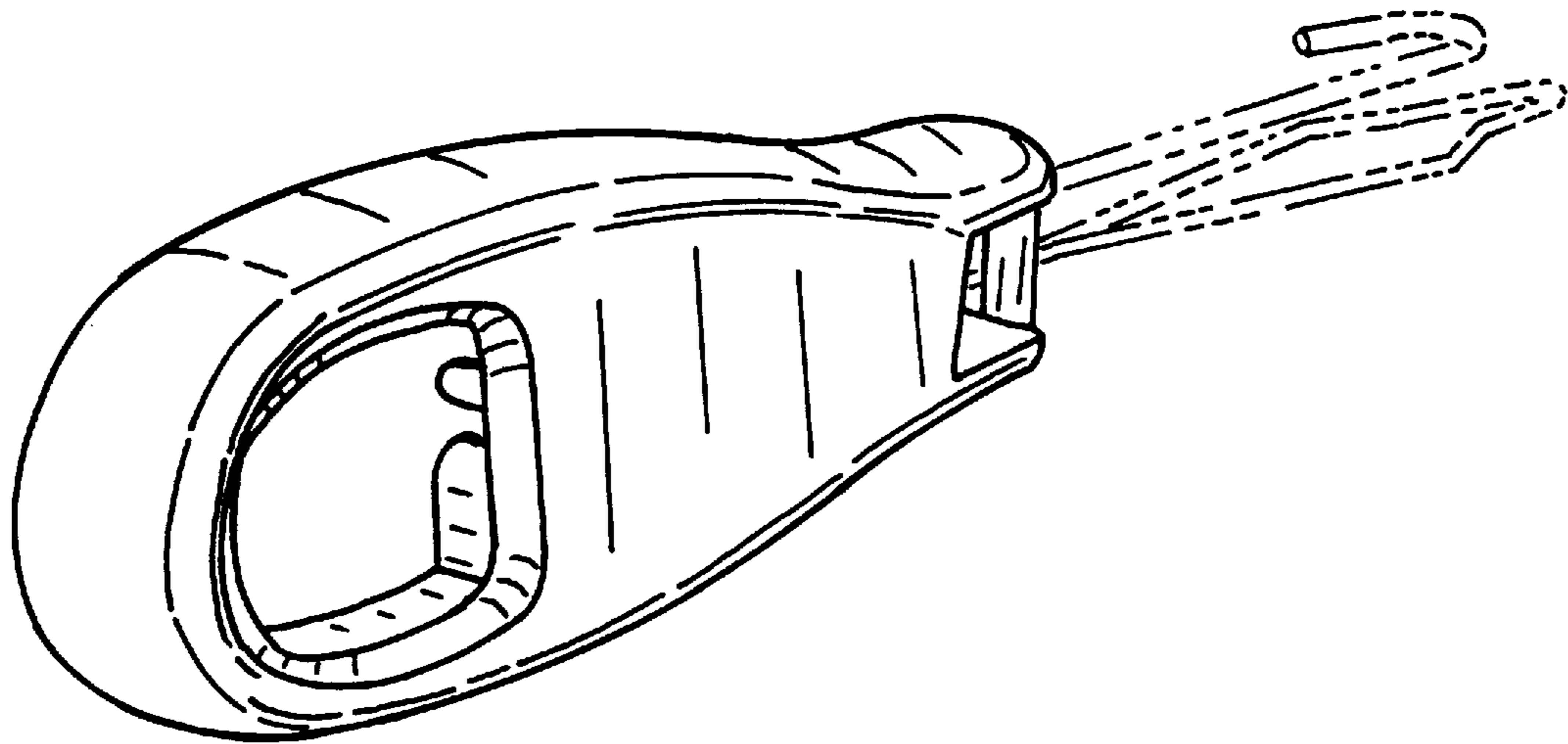
The ornamental design for zipper and button puller, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a zipper and button puller showing our new design;
 FIG. 2 is a rear perspective view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is an end elevational view taken from the right of FIG. 3 ;
 FIG. 7 is an end elevational view taken from the left of FIG. 3 ;
 FIG. 8 is a left side elevational view thereof; and,
 FIG. 9 is a right side elevational view thereof.

The broken line showing of zipper and button hook in FIGS. 1,2,3, and 5, the zipper hook and zipper in FIG. 8 , and the button hook, button, and article of clothing in FIG. 9 is for illustrative purposes only and forms on part of the claimed design.

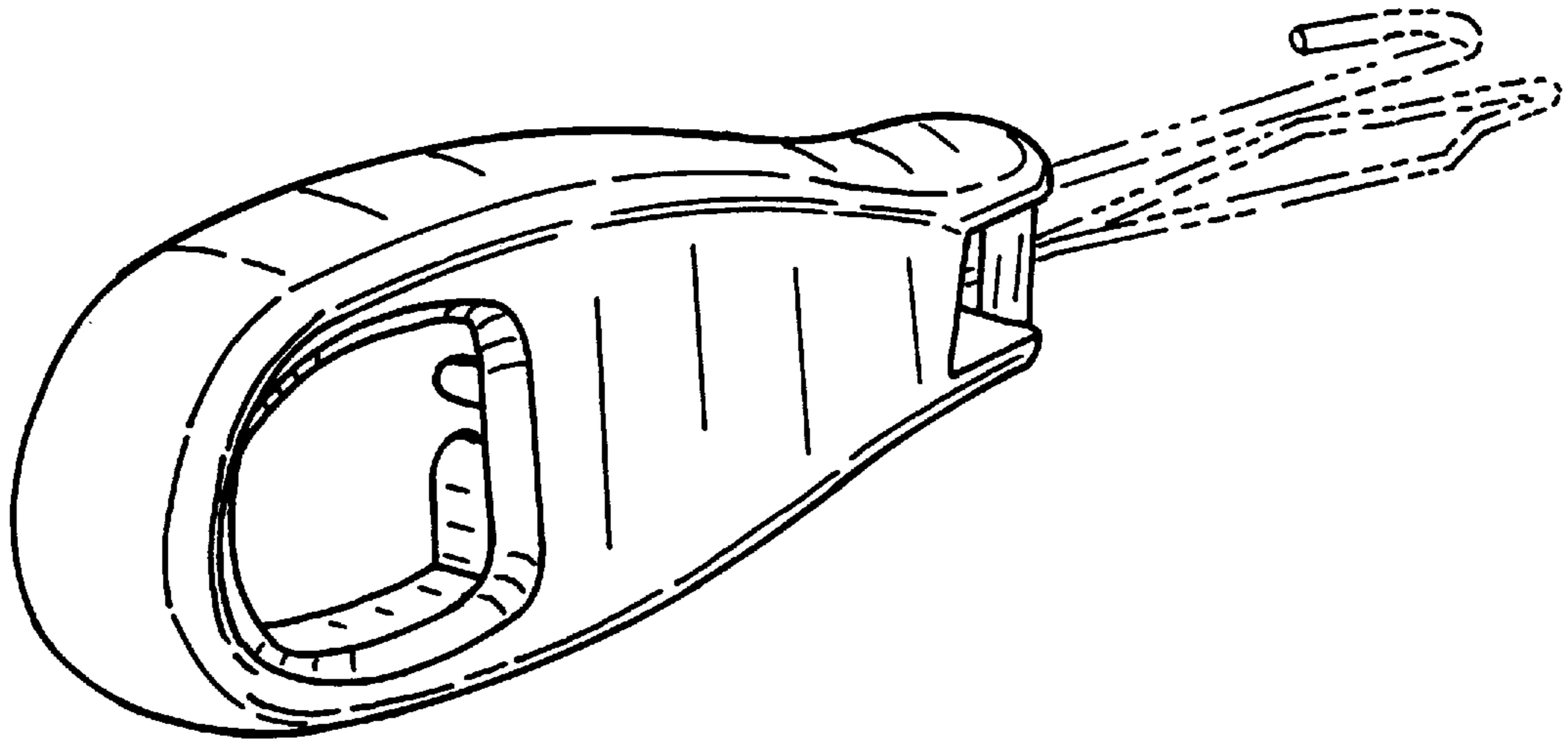

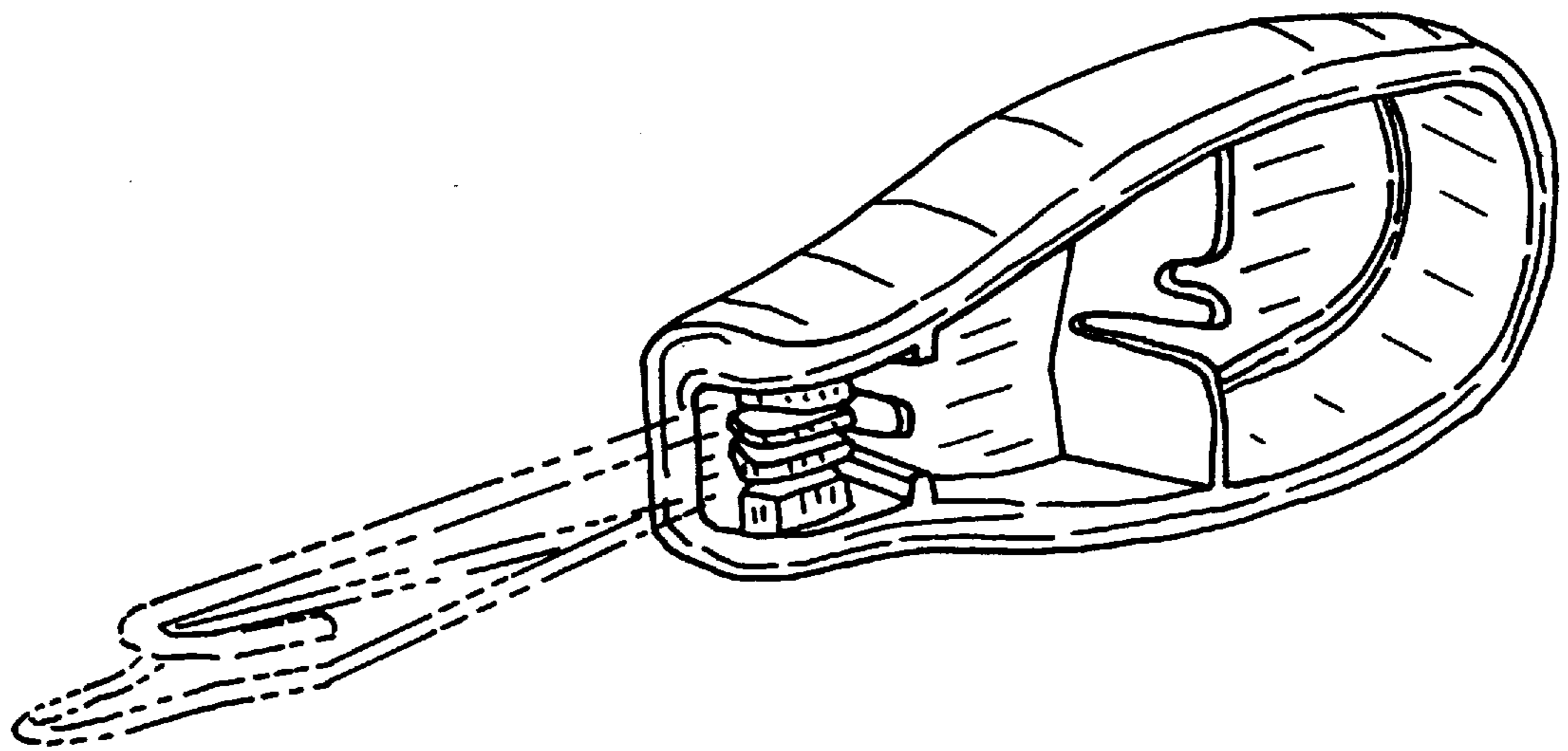

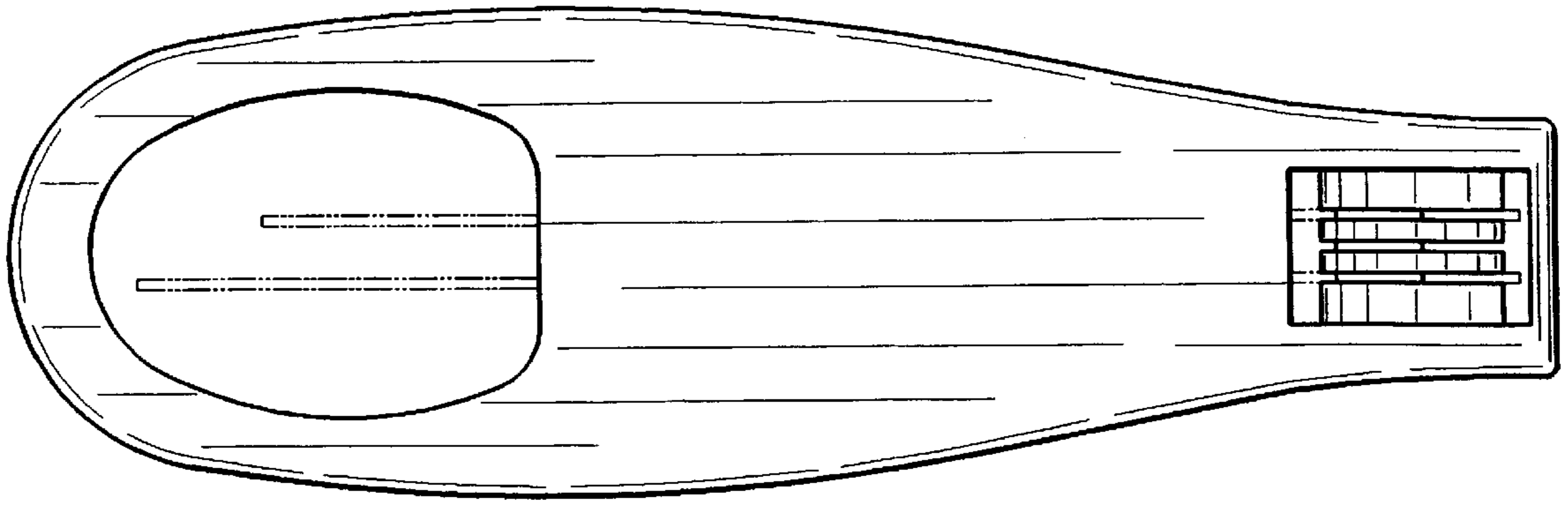

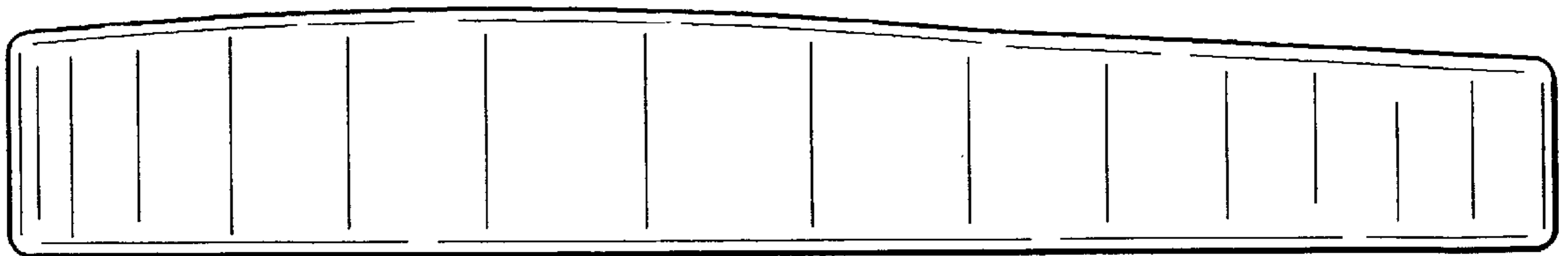

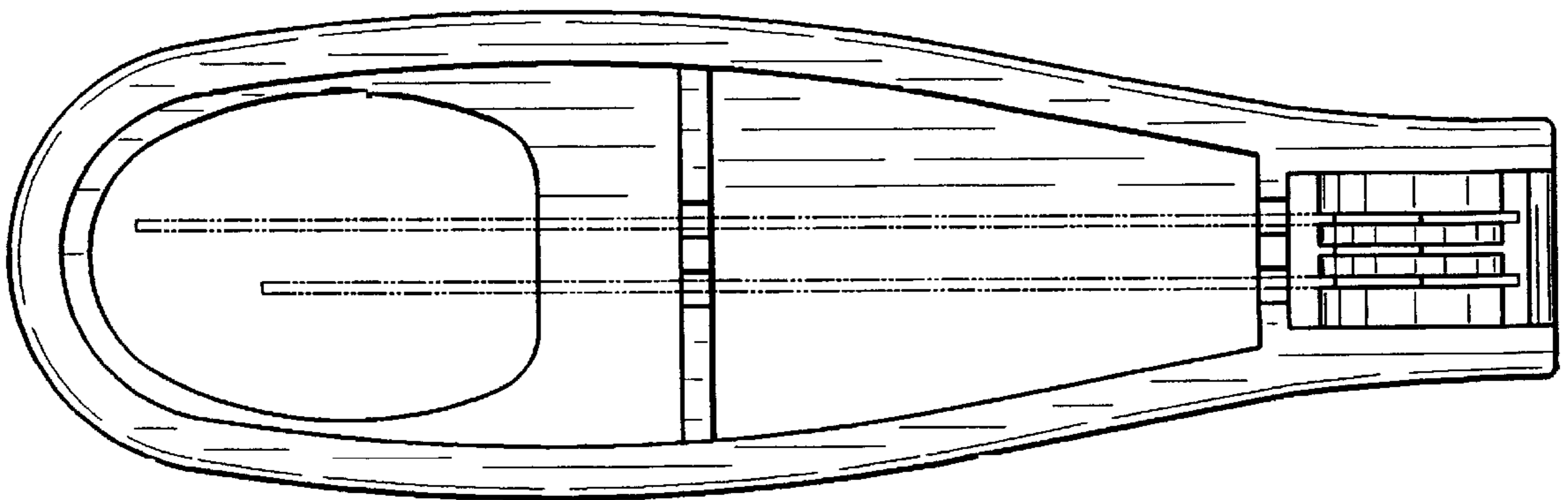

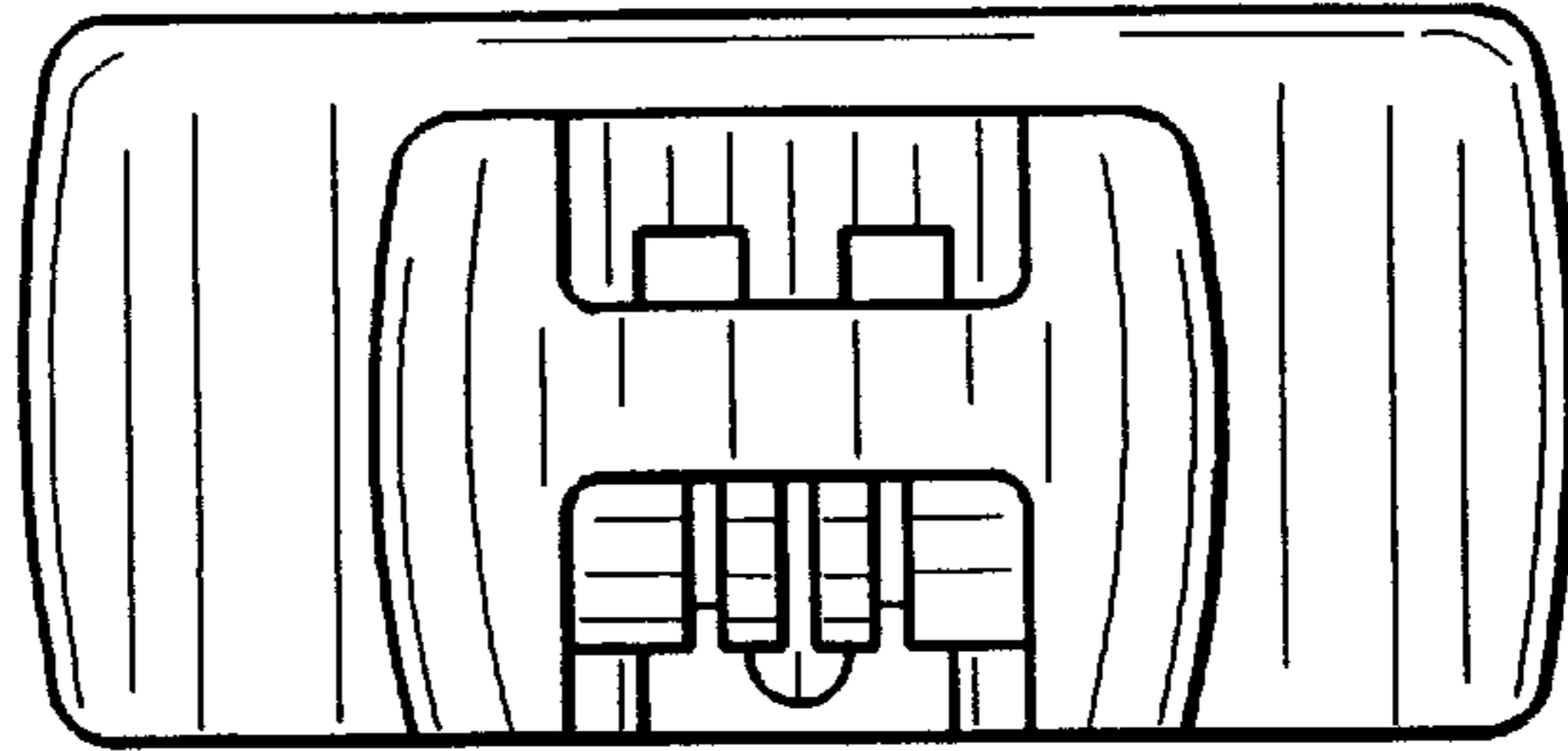

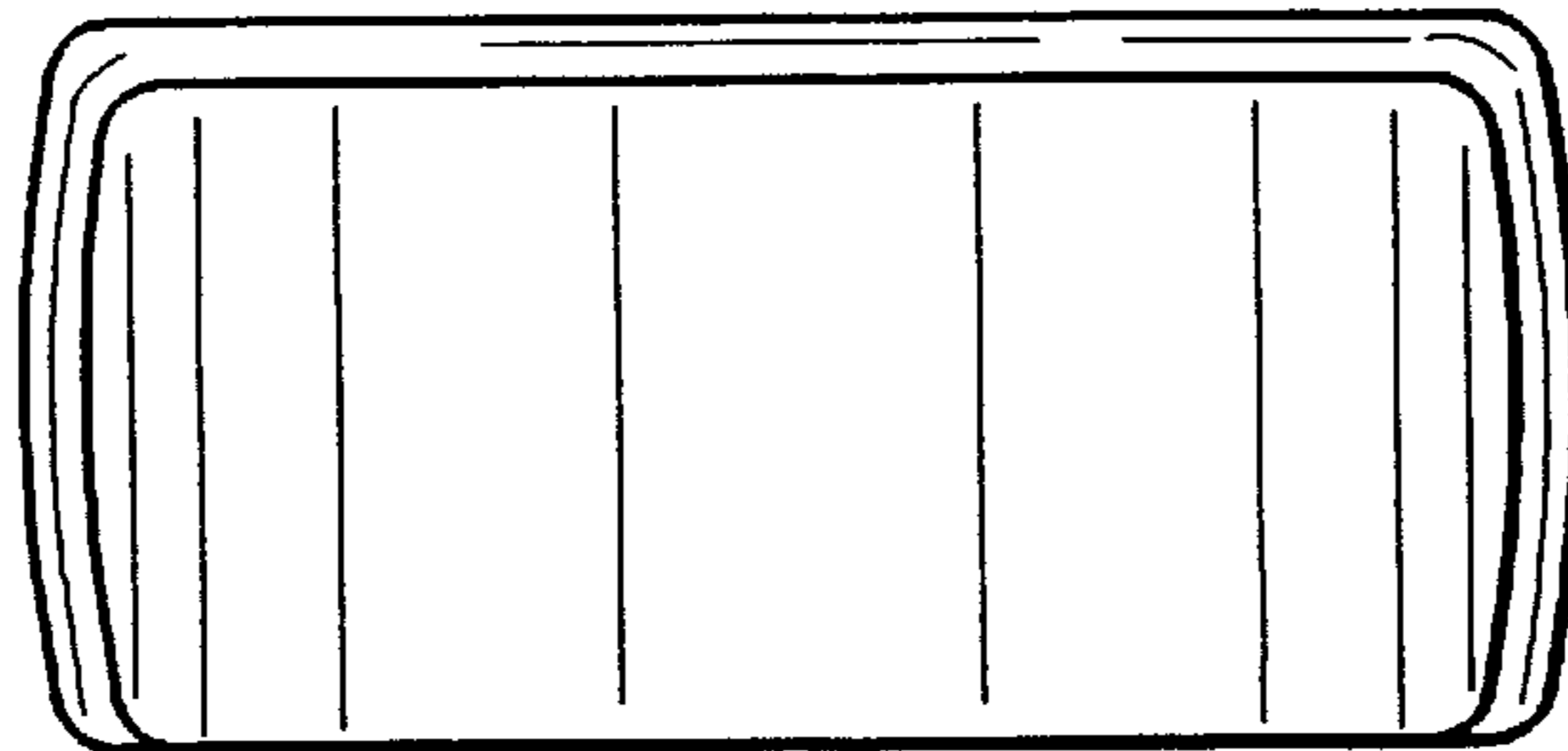

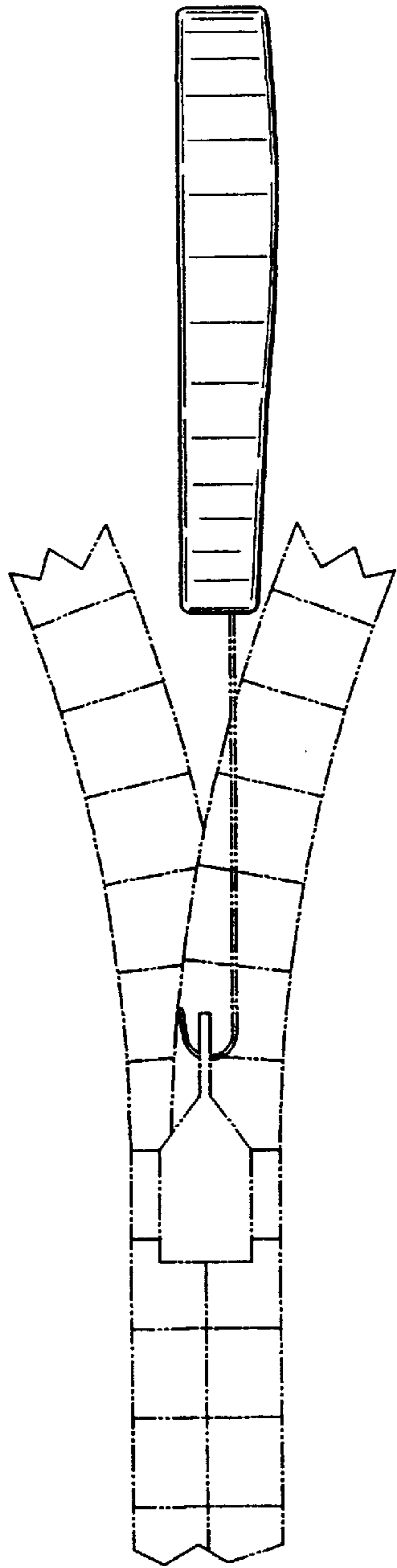

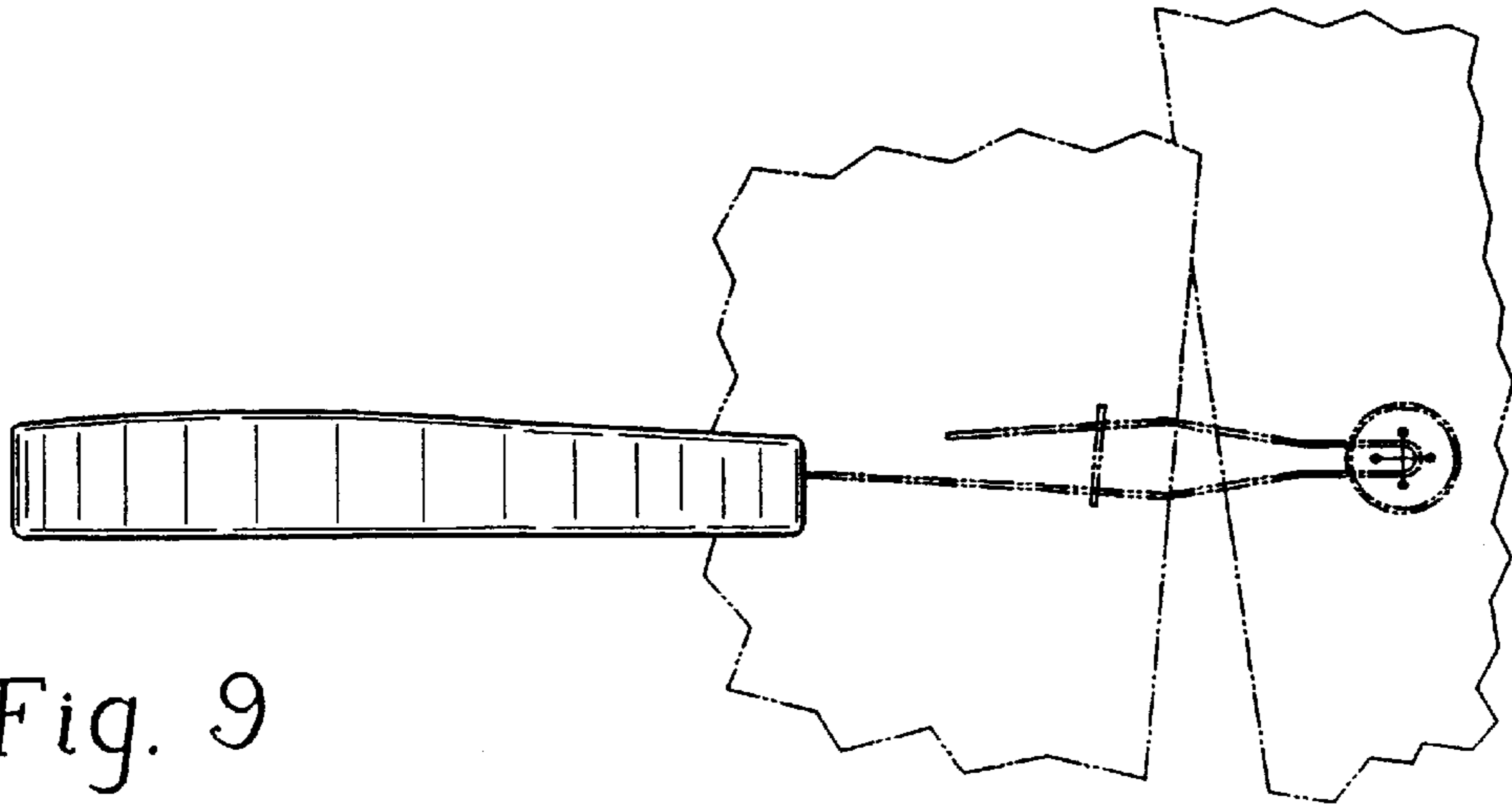
