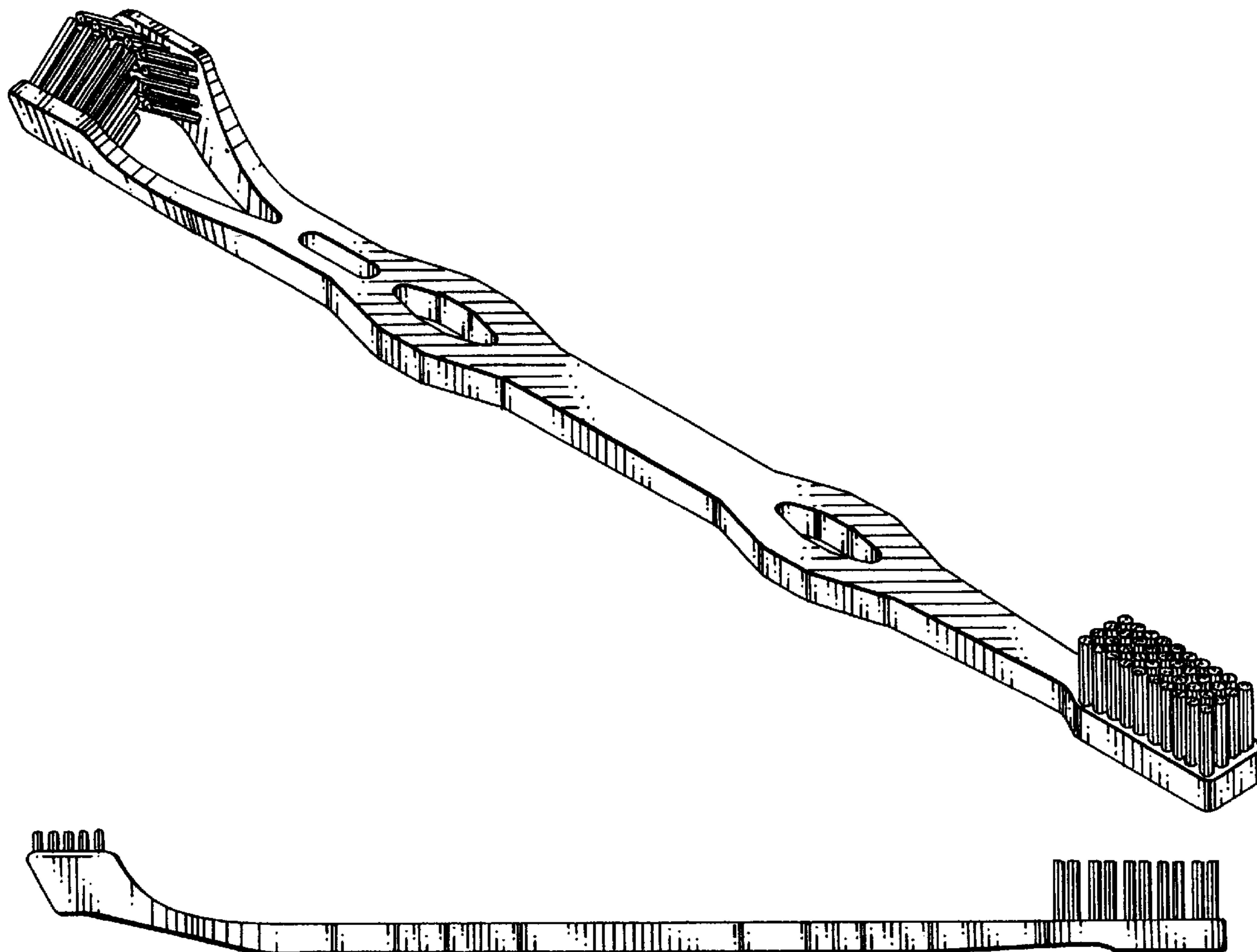
[57] **CLAIM**

The ornamental design for a multiple head tooth brush, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a multiple head tooth brush showing my new design;  
FIG. 2 is a frontal elevation thereof;  
FIG. 3 is a rear elevation thereof;  
FIG. 4 is a top view thereof;  
FIG. 5 is a side elevation thereof, the opposite side being a mirror image; and,  
FIG. 6 is a bottom view thereof.

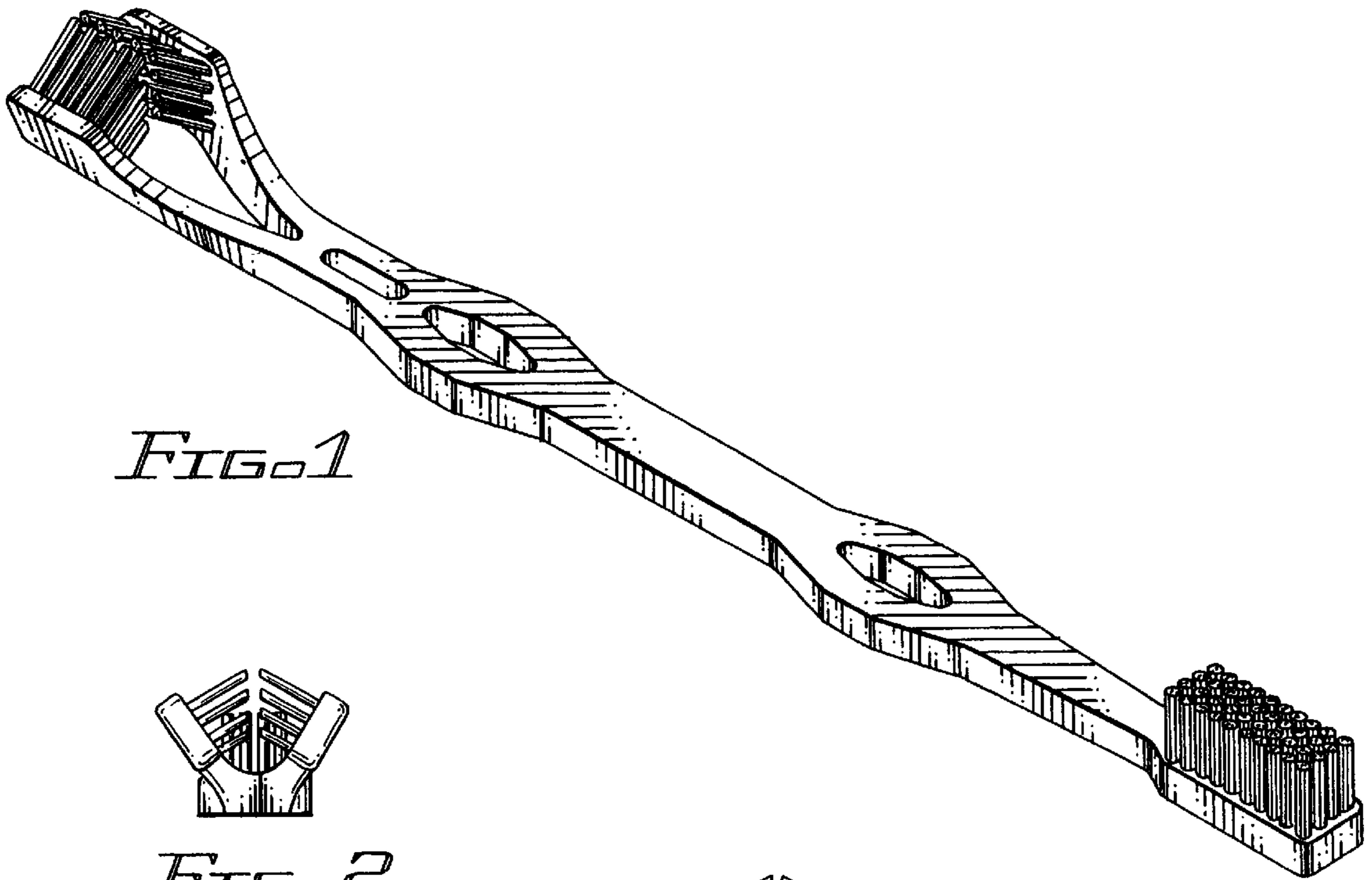

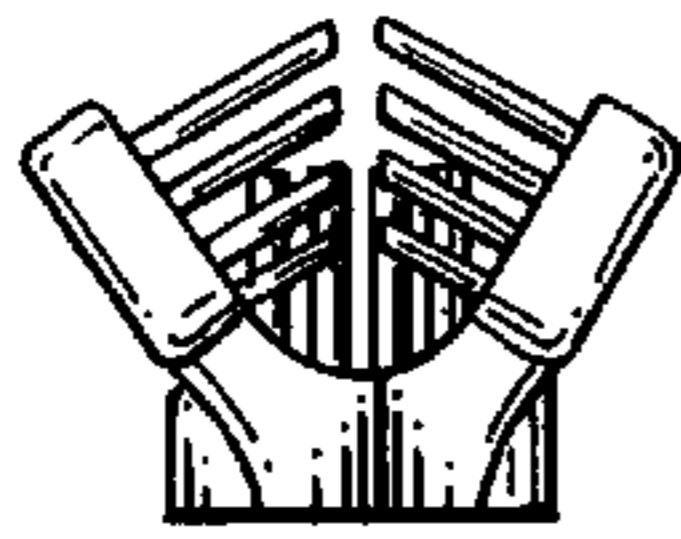

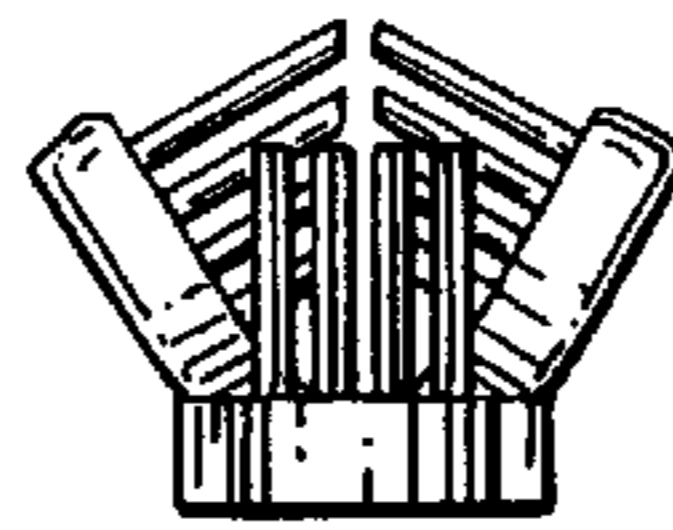

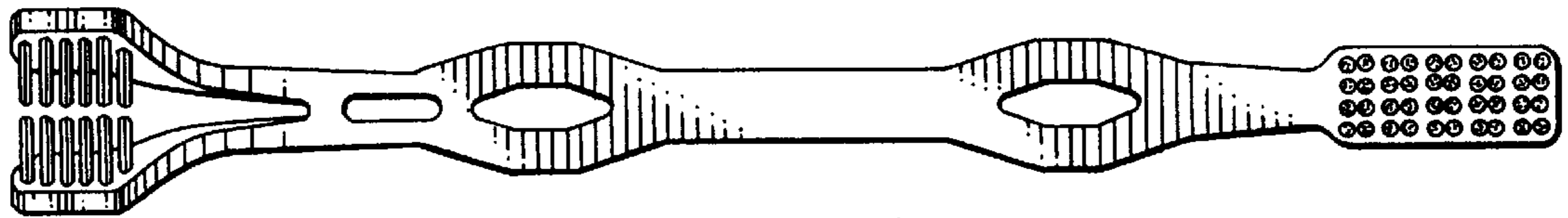

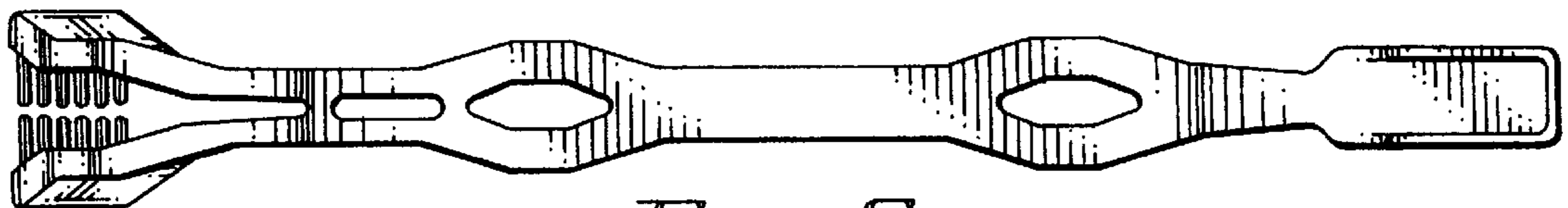
