[57] CLAIM

The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view, taken from the bottom, of a golf club head according to our new design;

FIG. 24 is a top view of a fifth embodiment of a golf club head according to our new design;

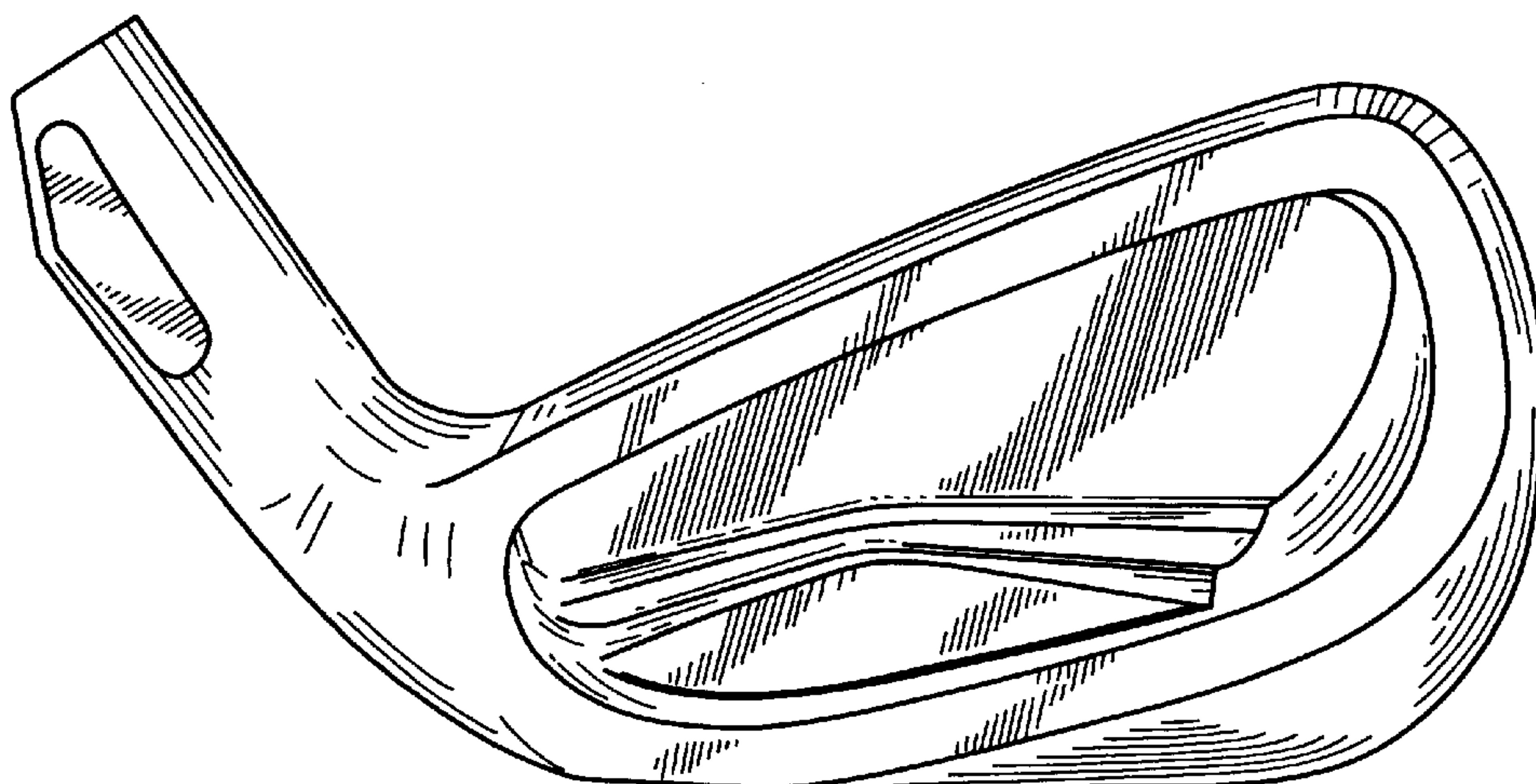
FIG. 25 is a front view of FIG. 24;

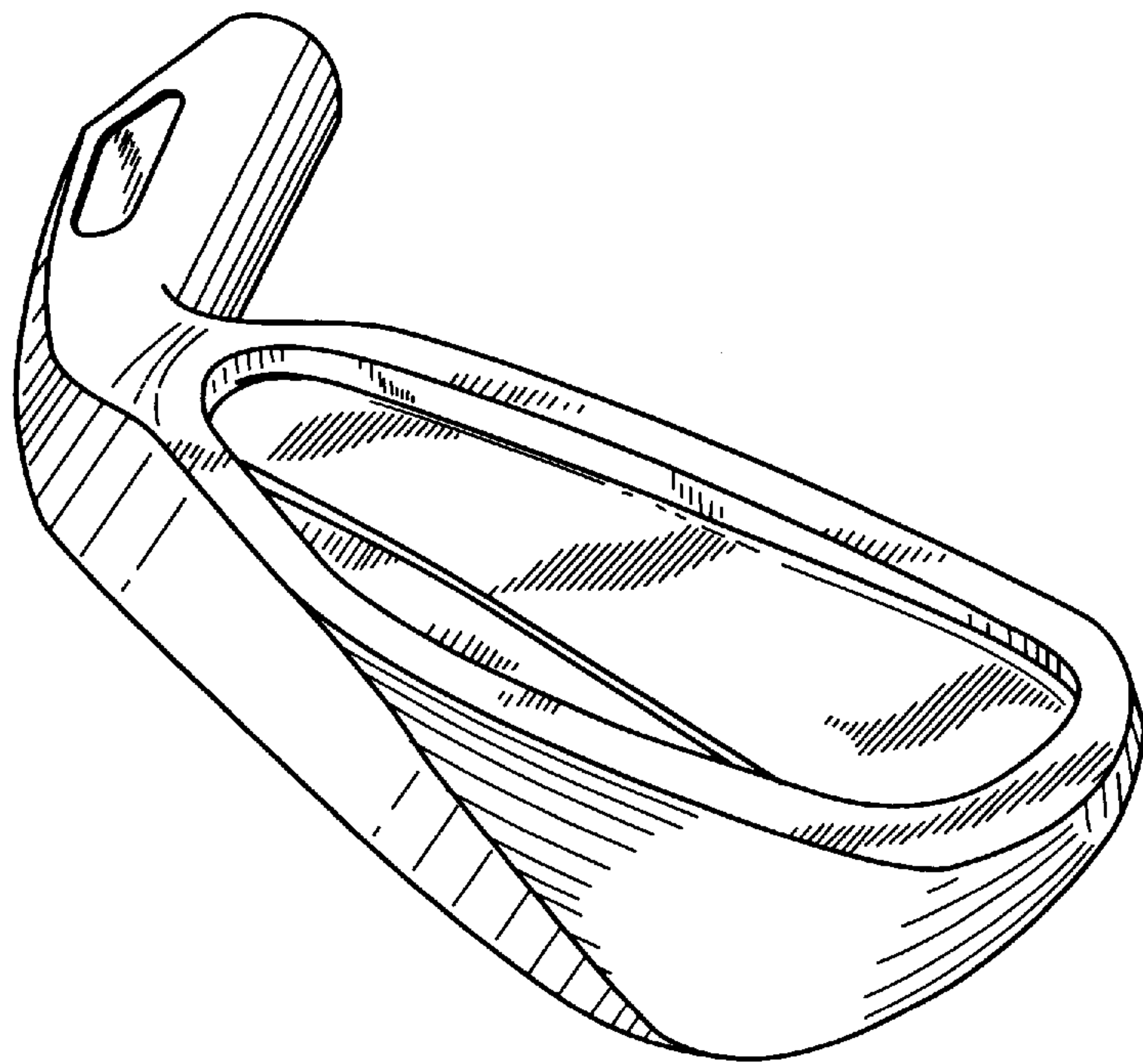

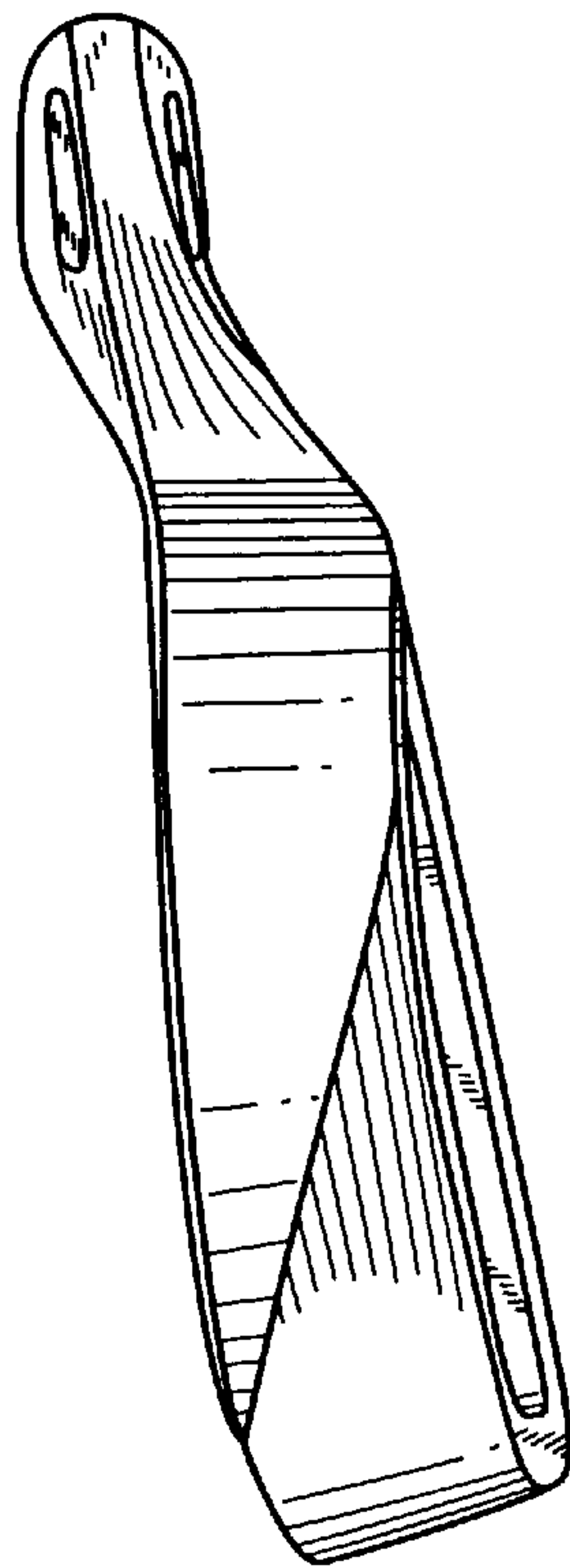

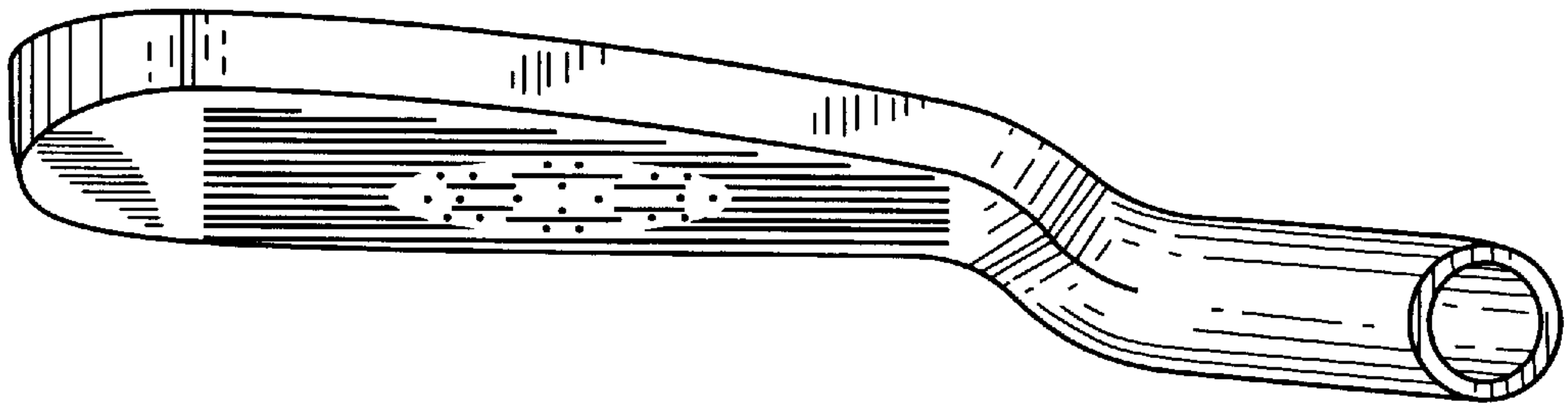

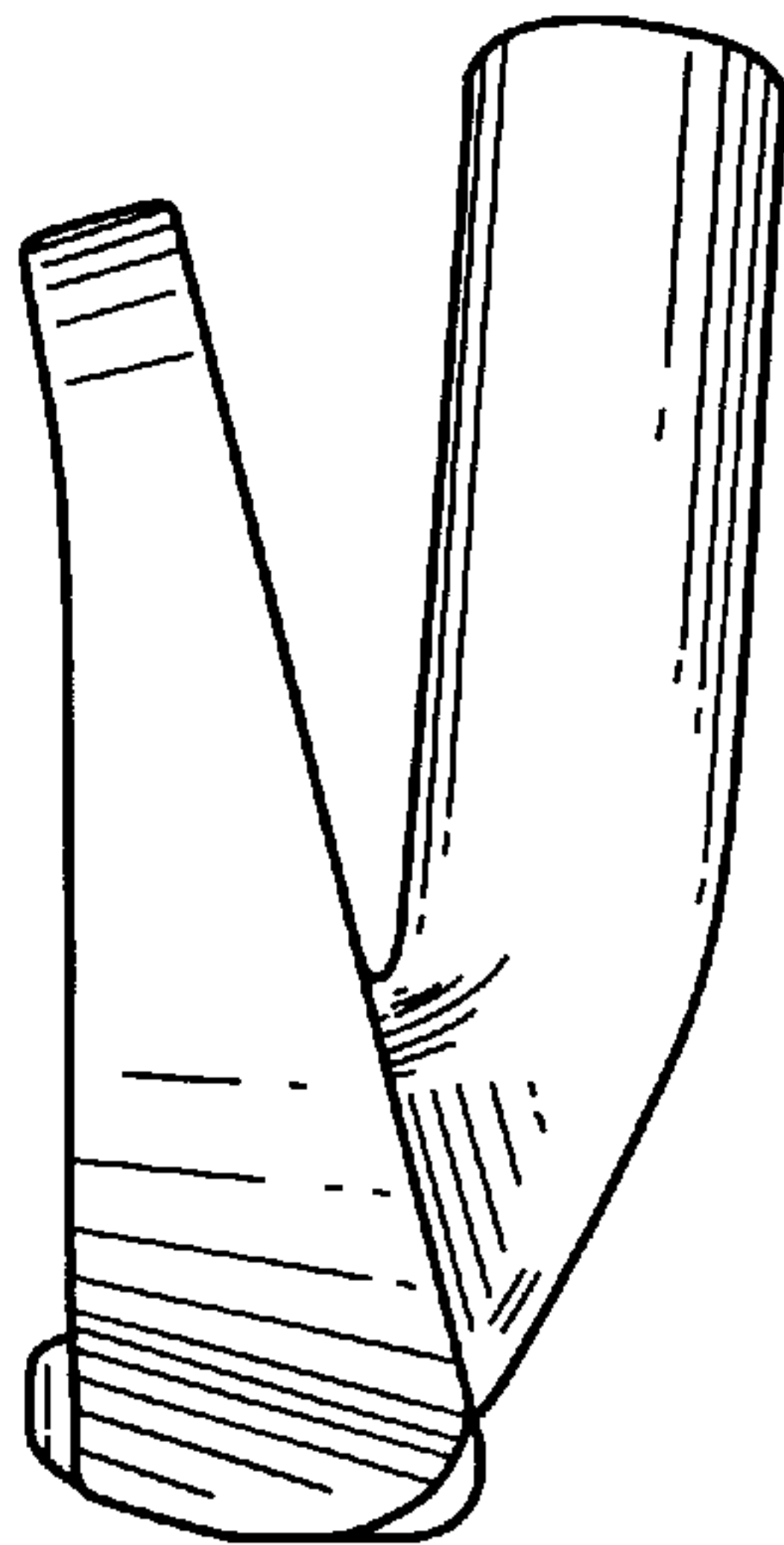

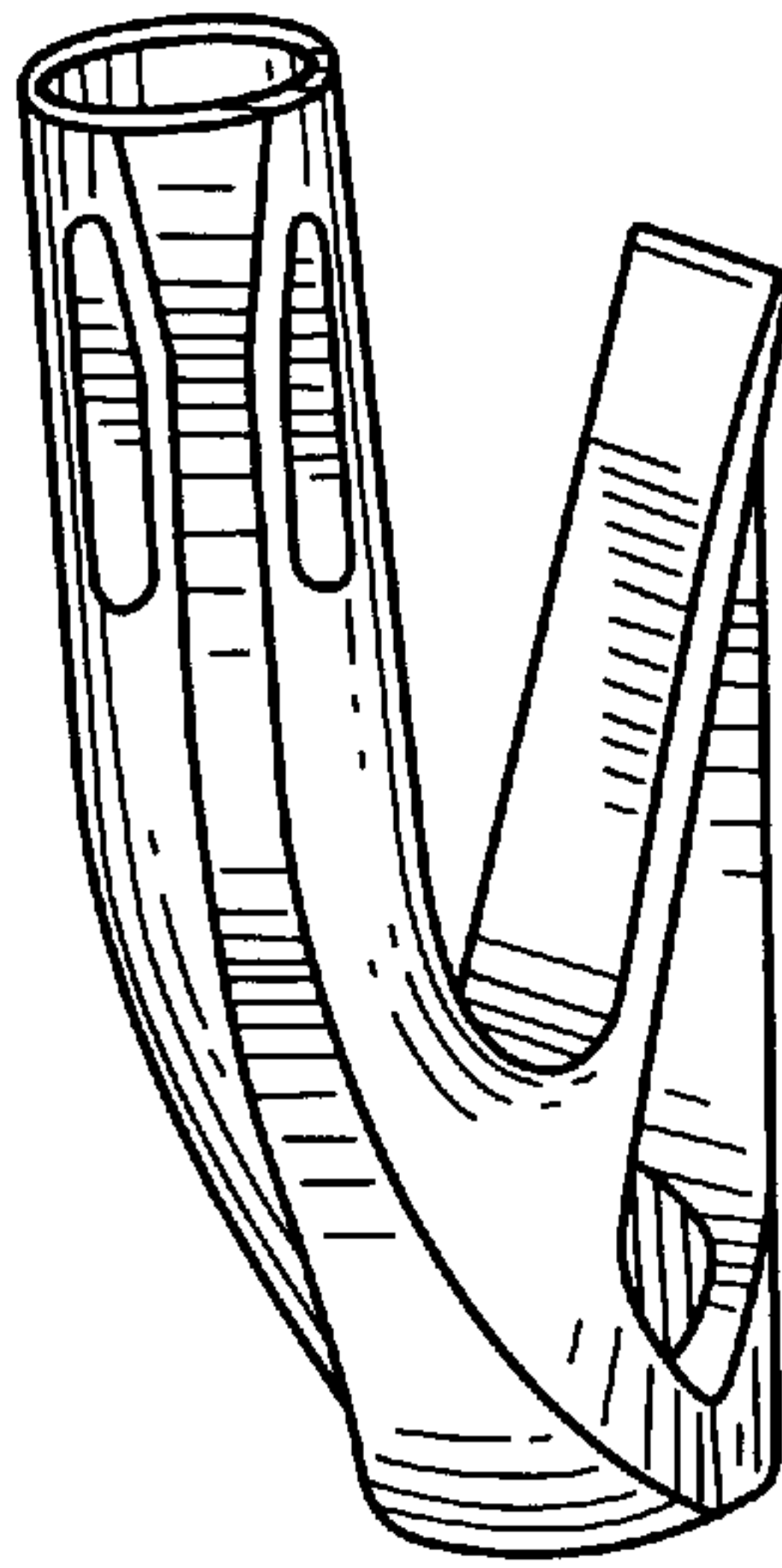

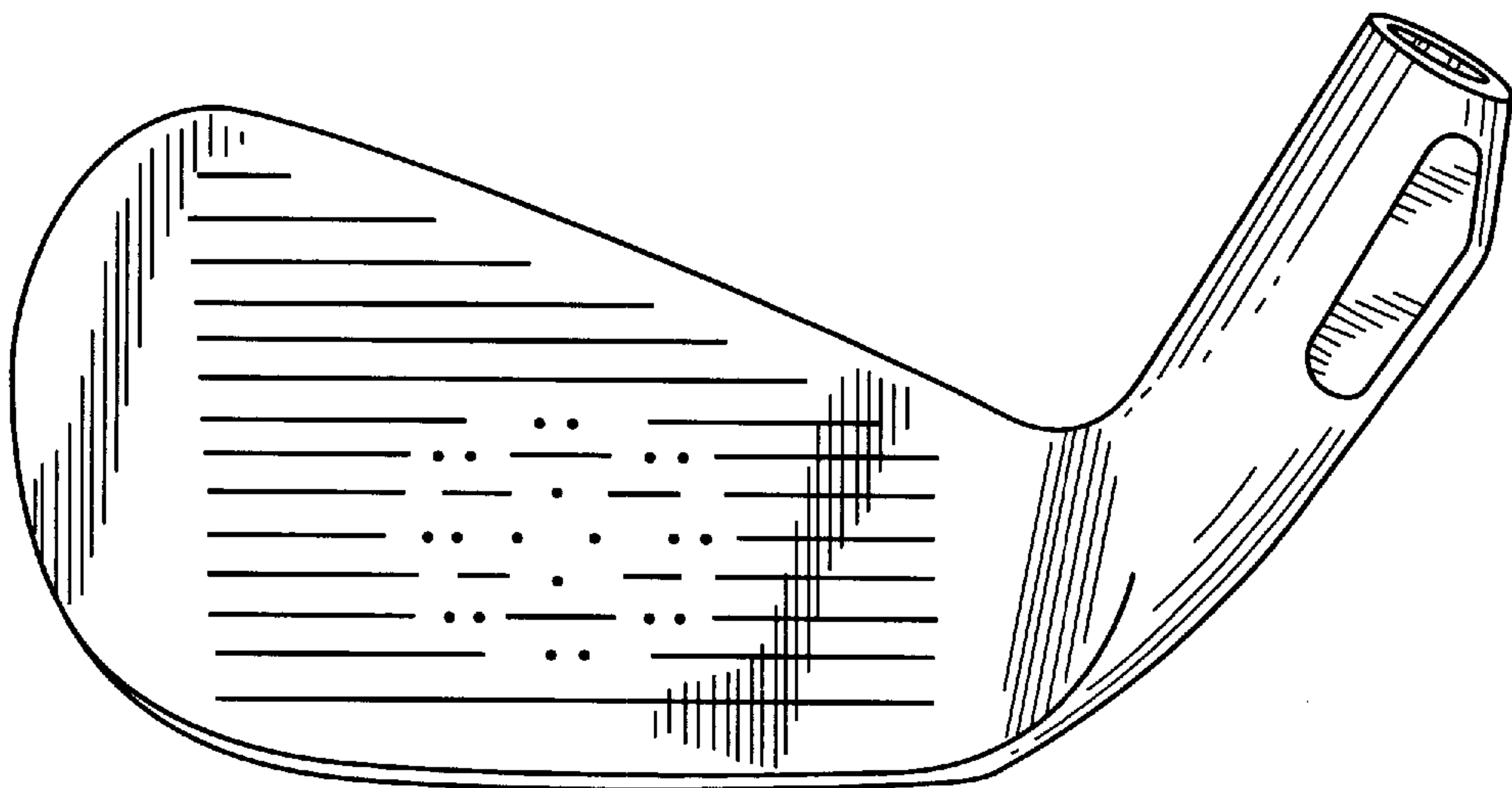

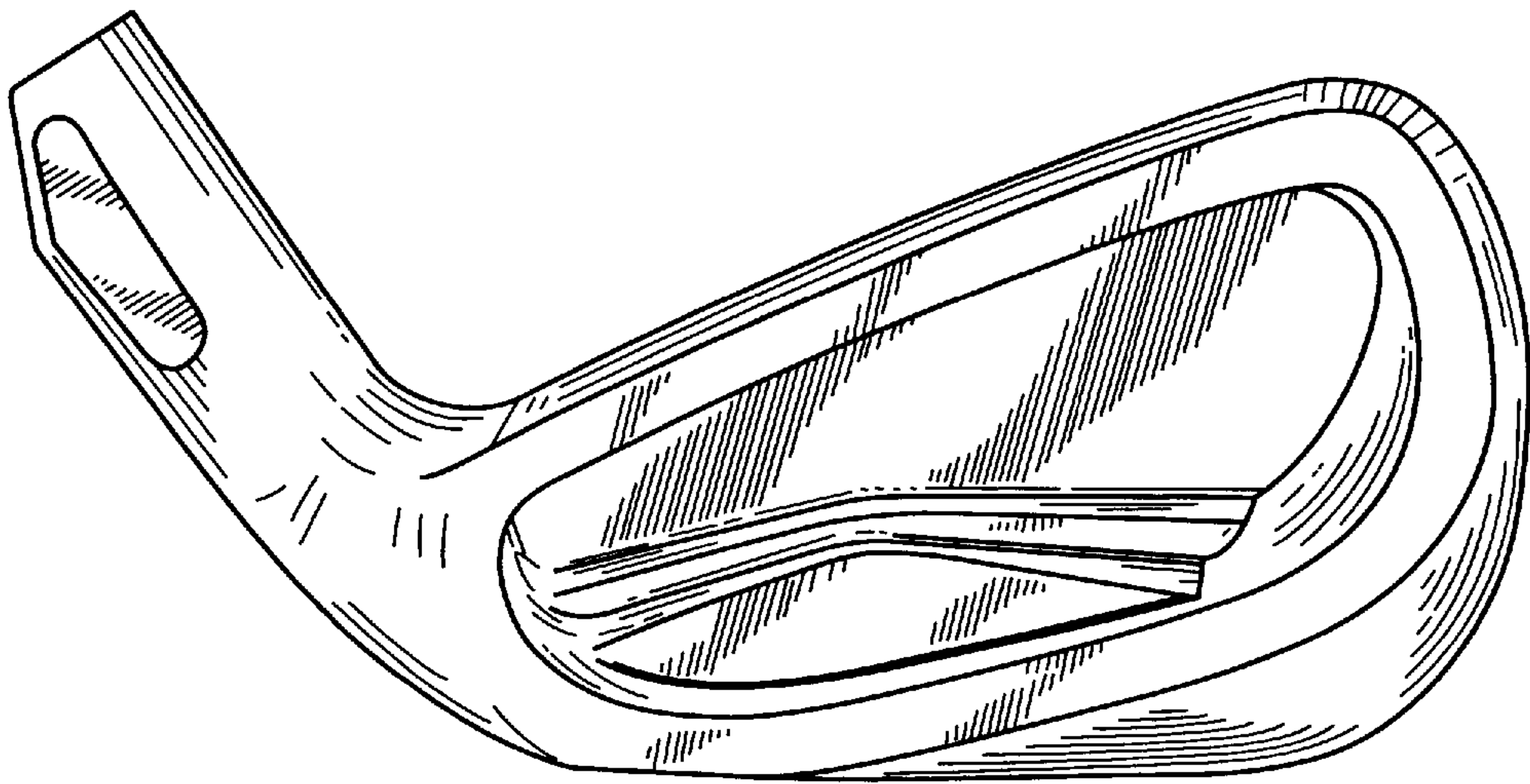

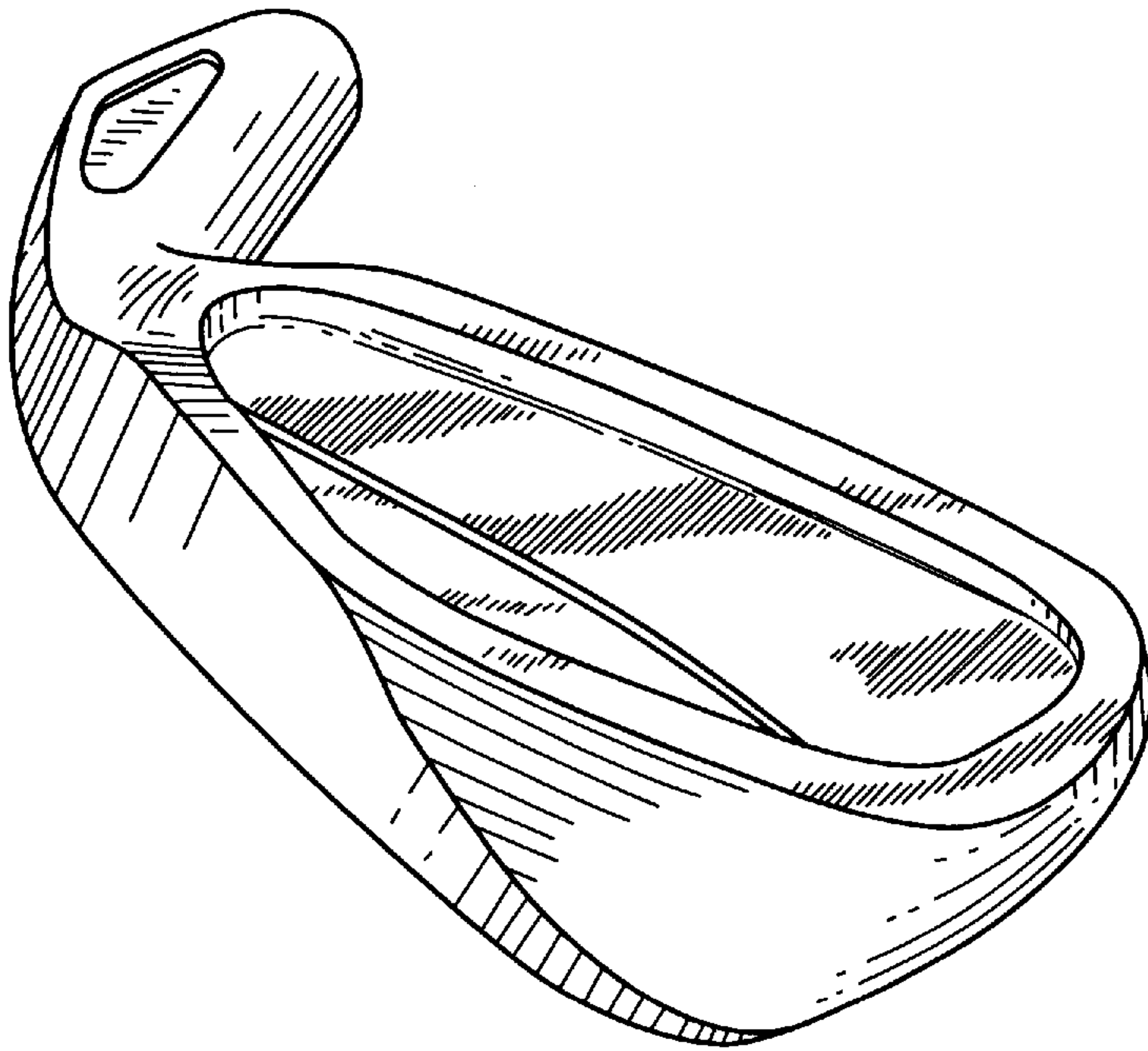

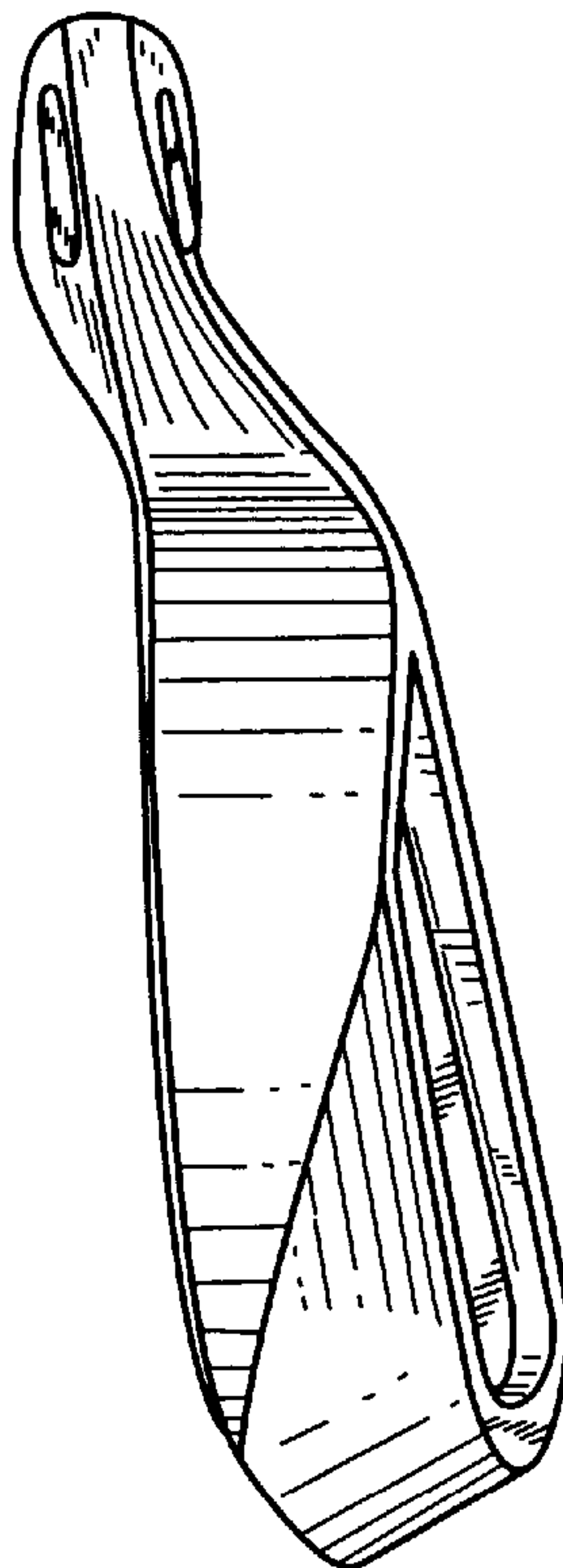

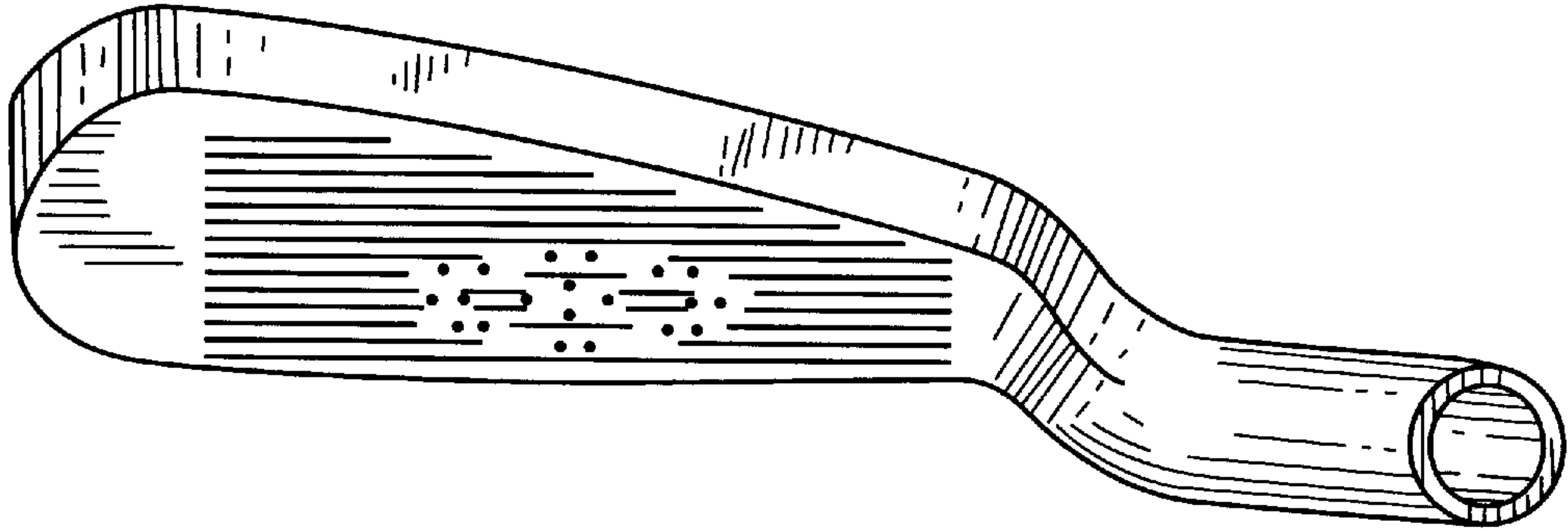

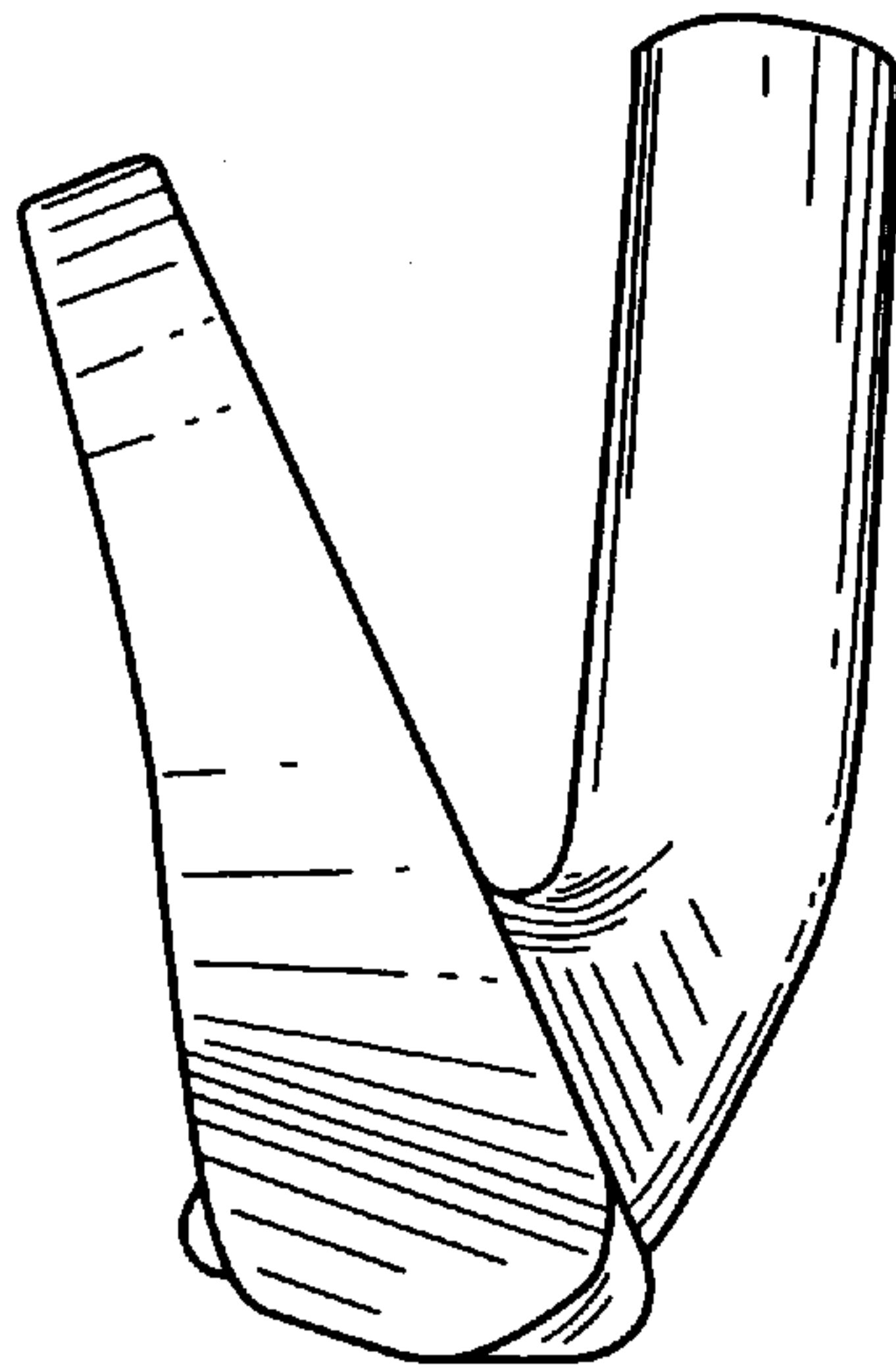

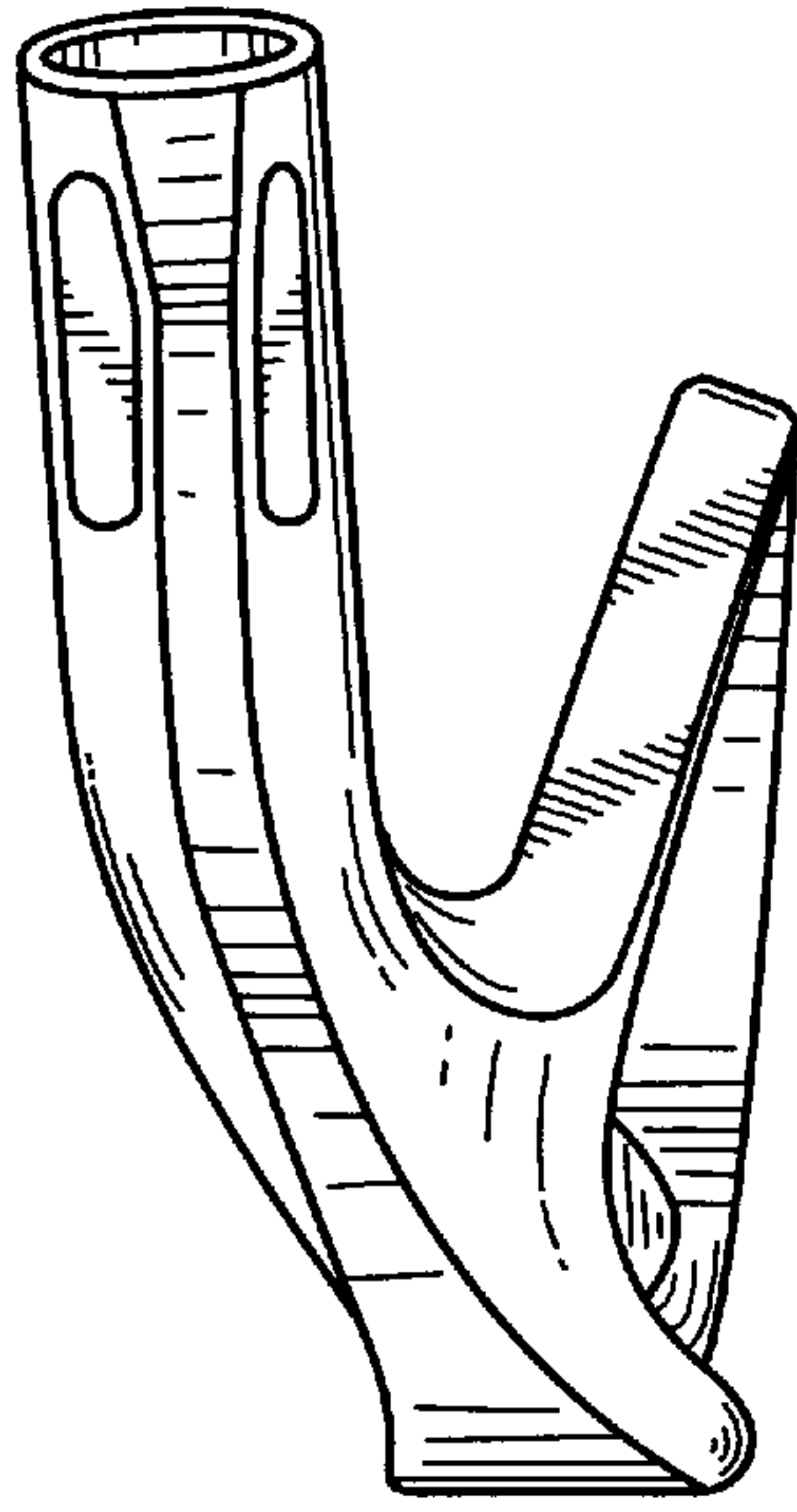

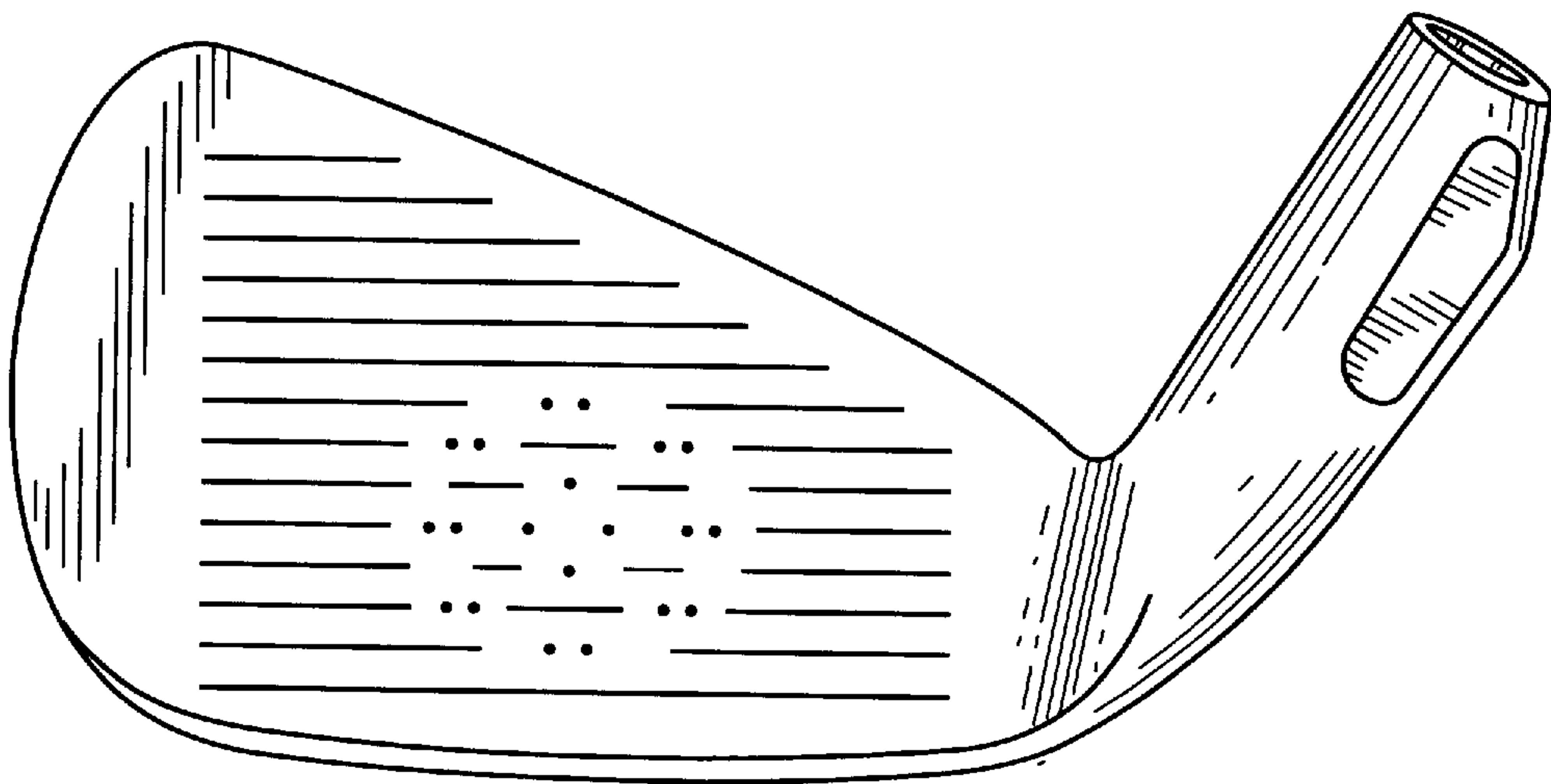

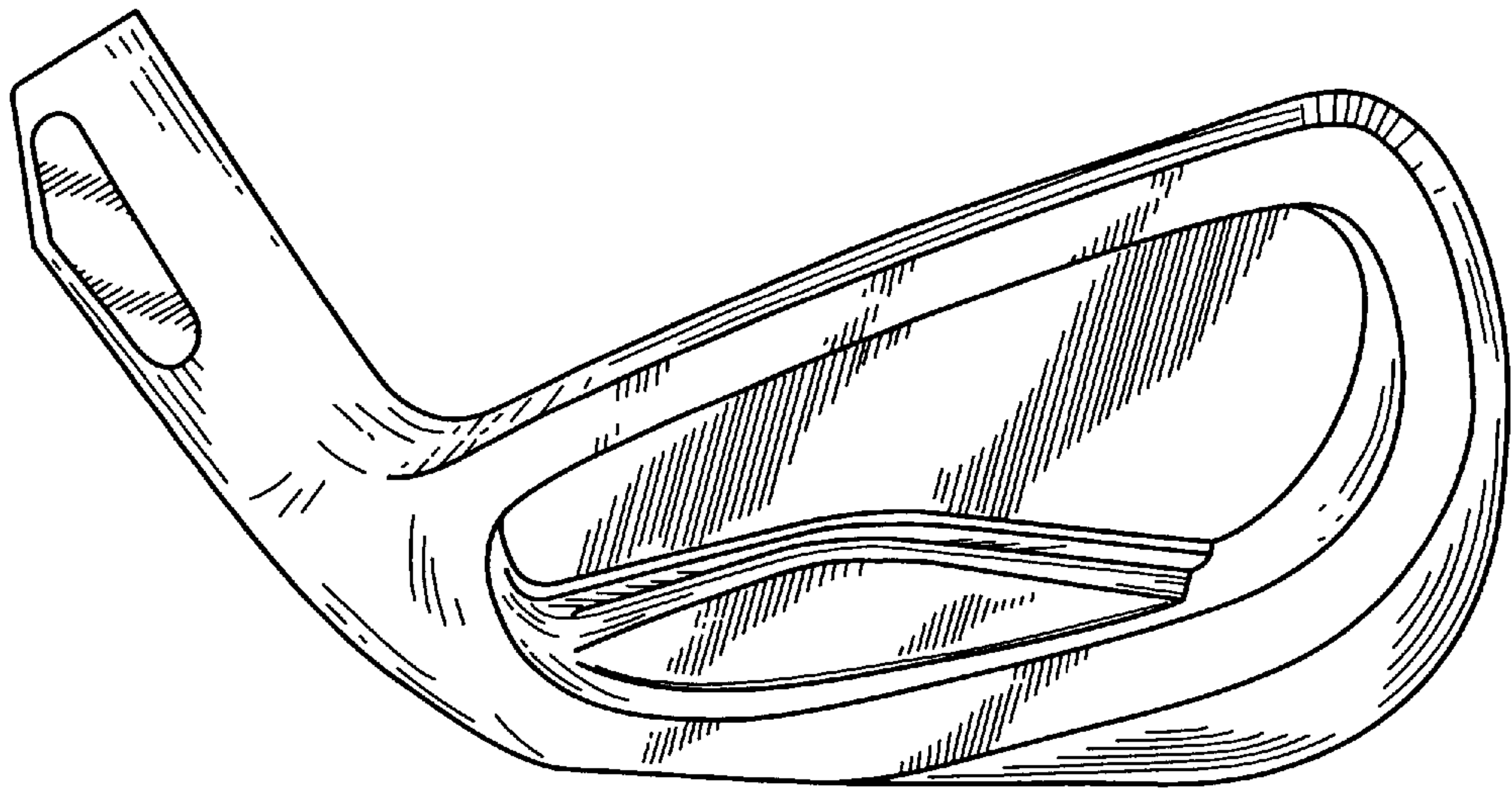

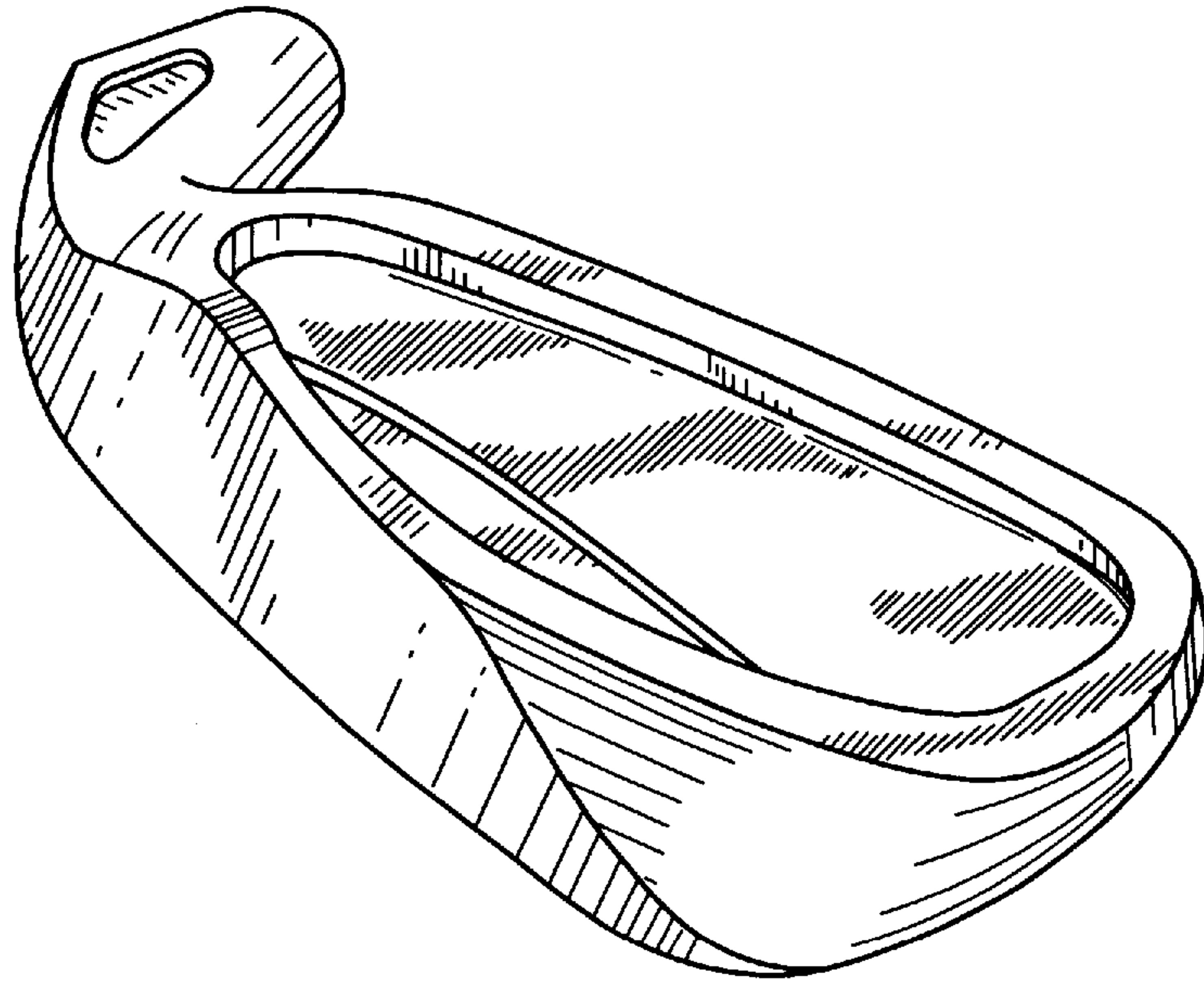

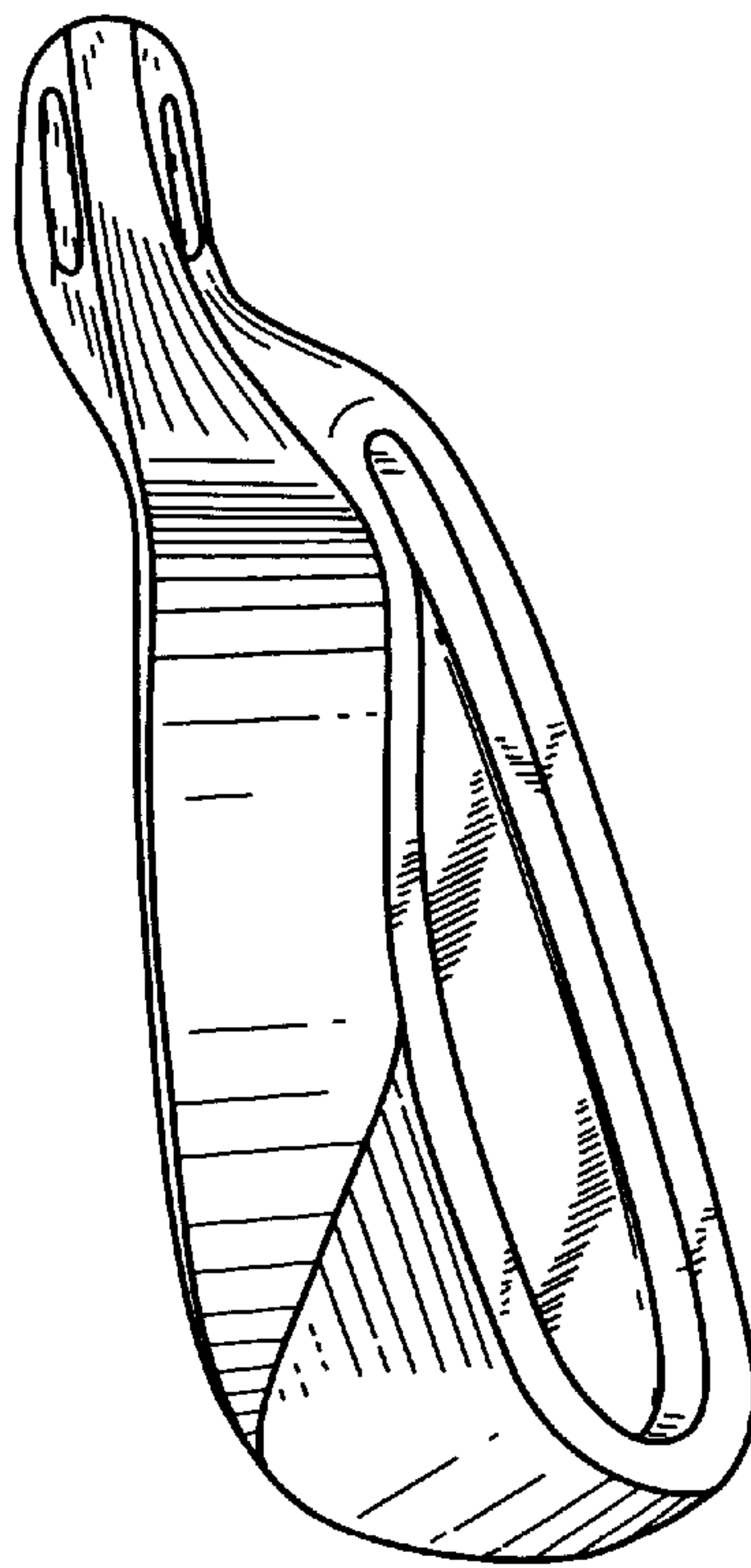

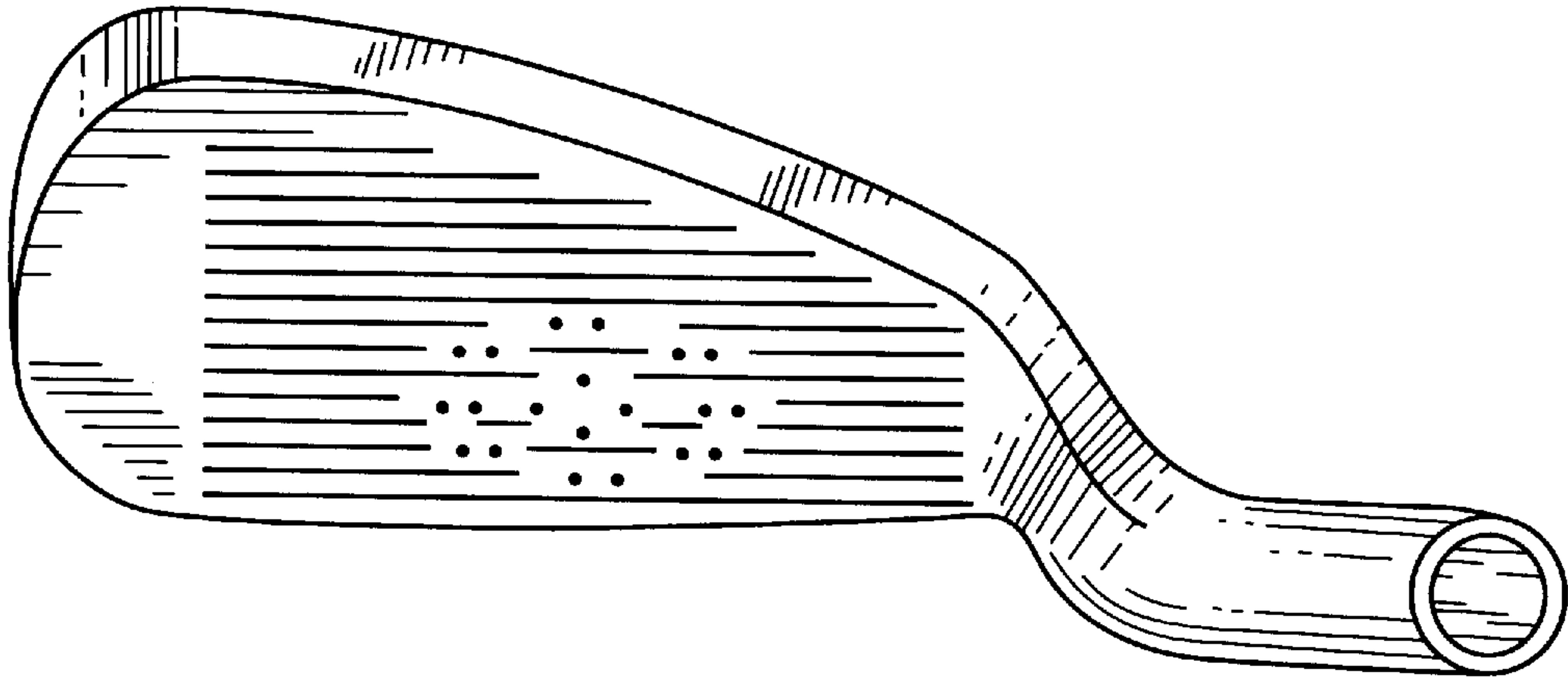

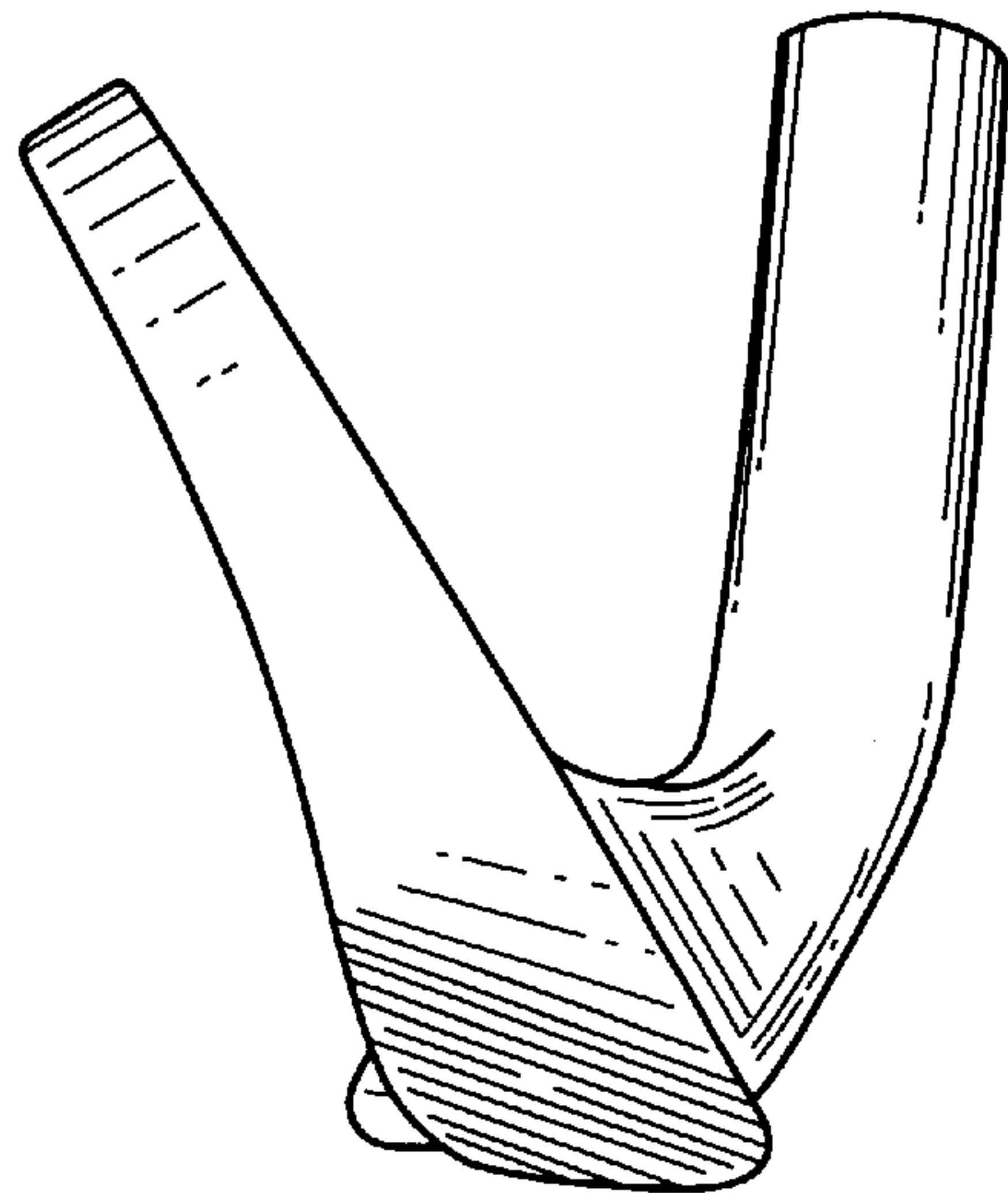

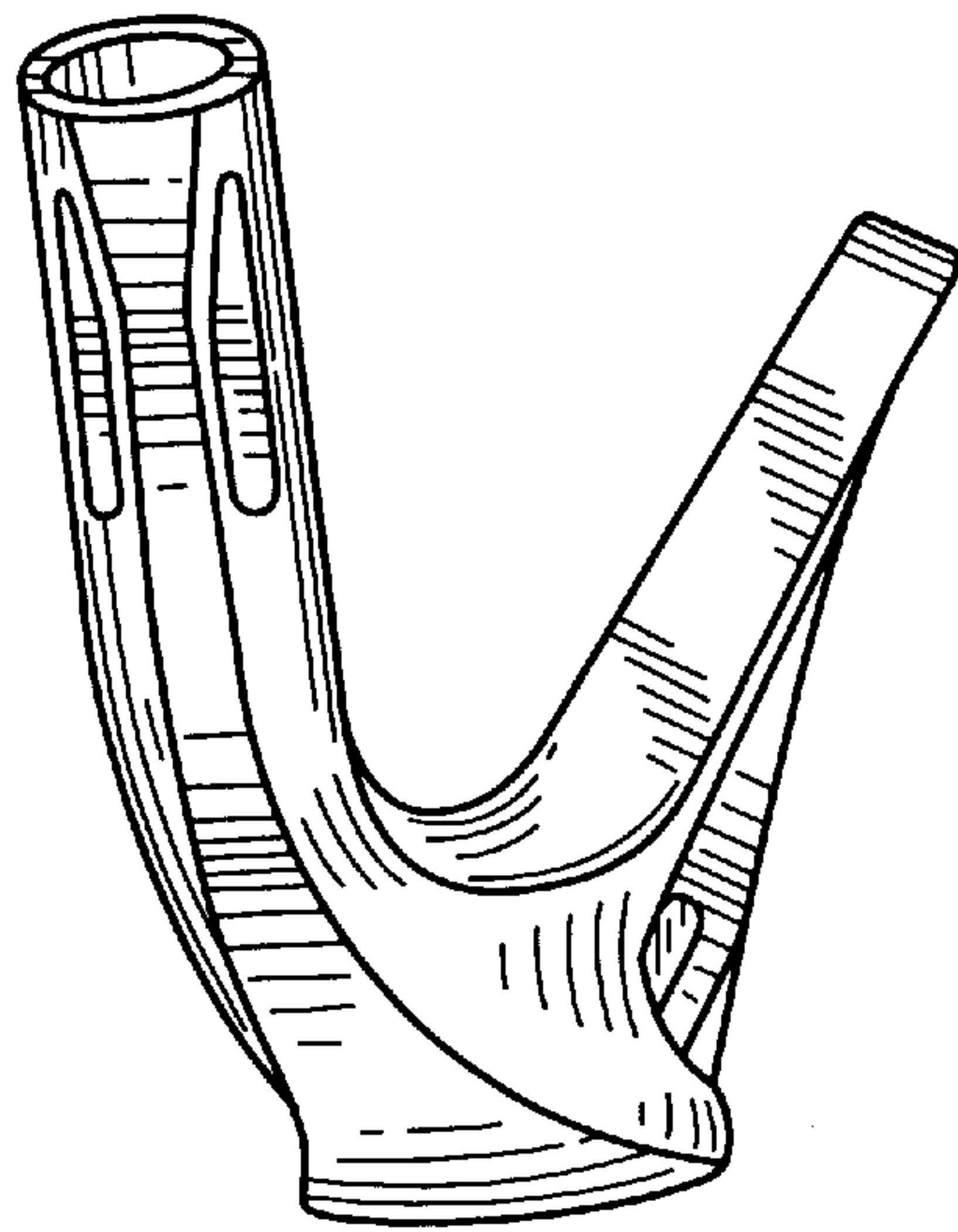

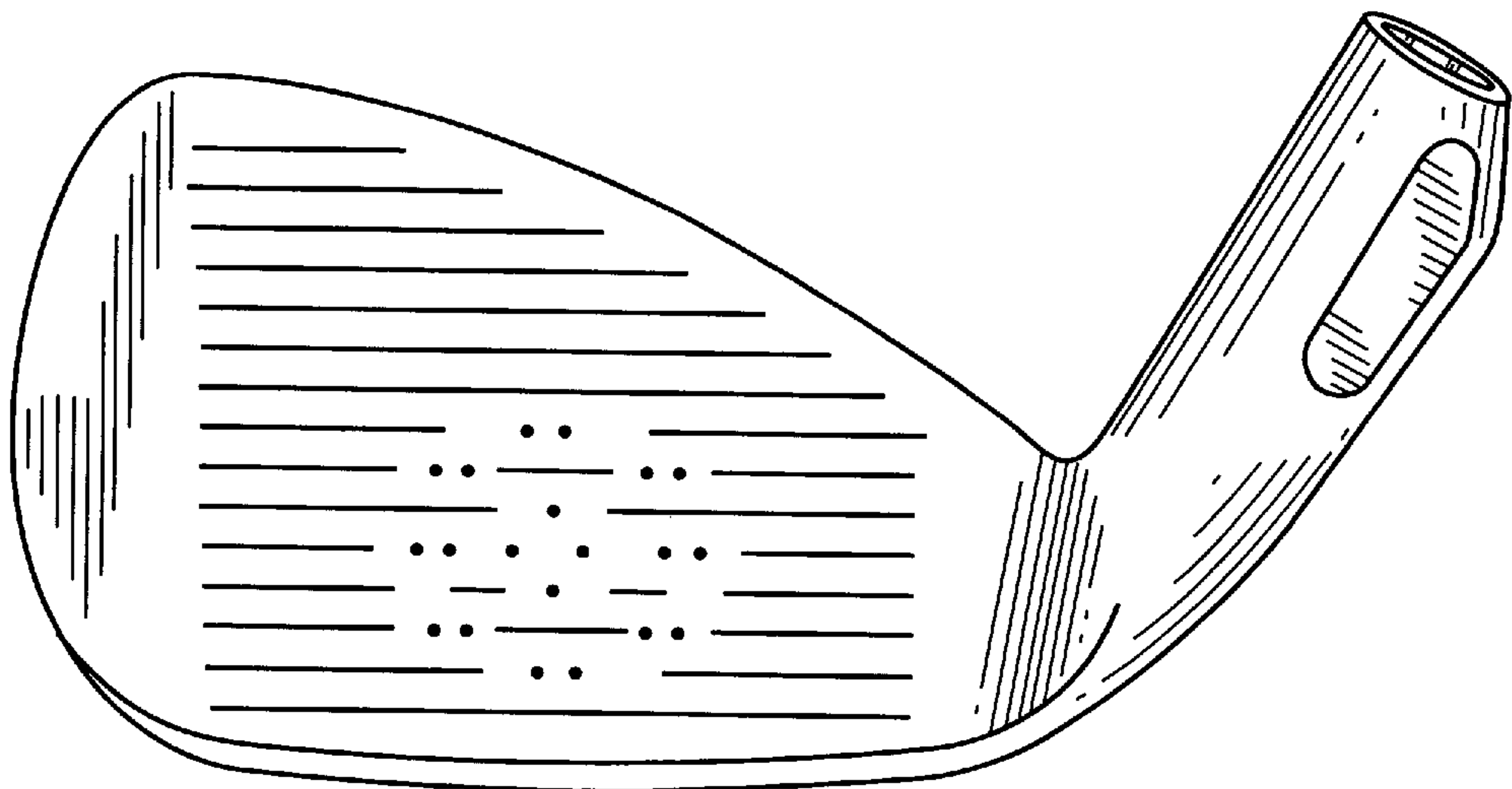

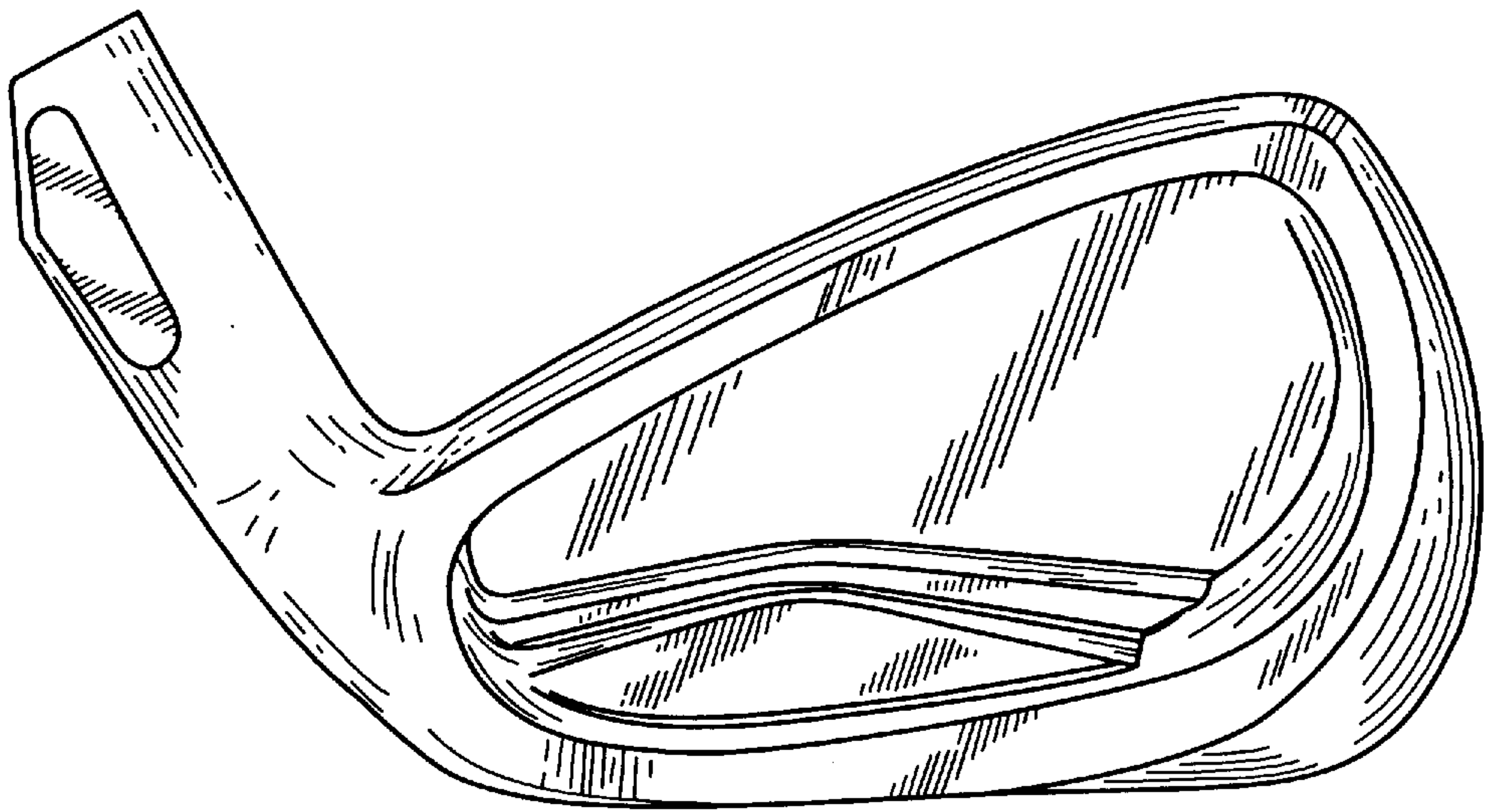

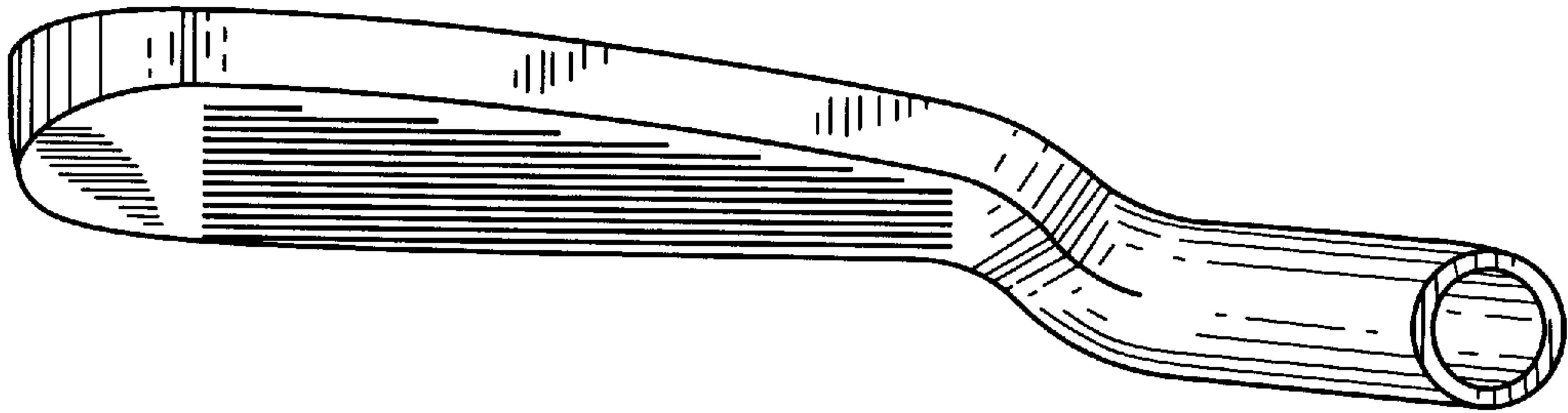

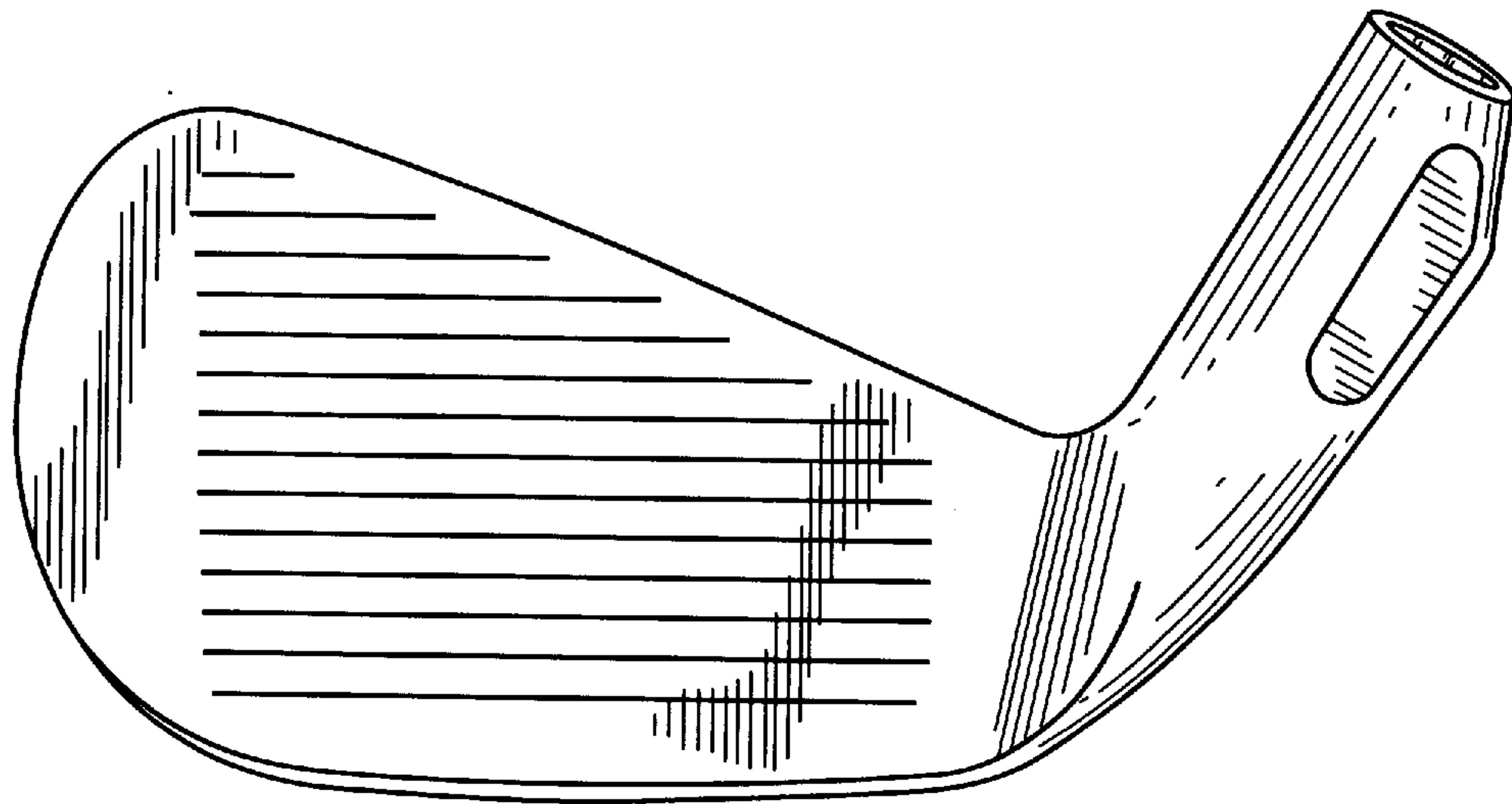

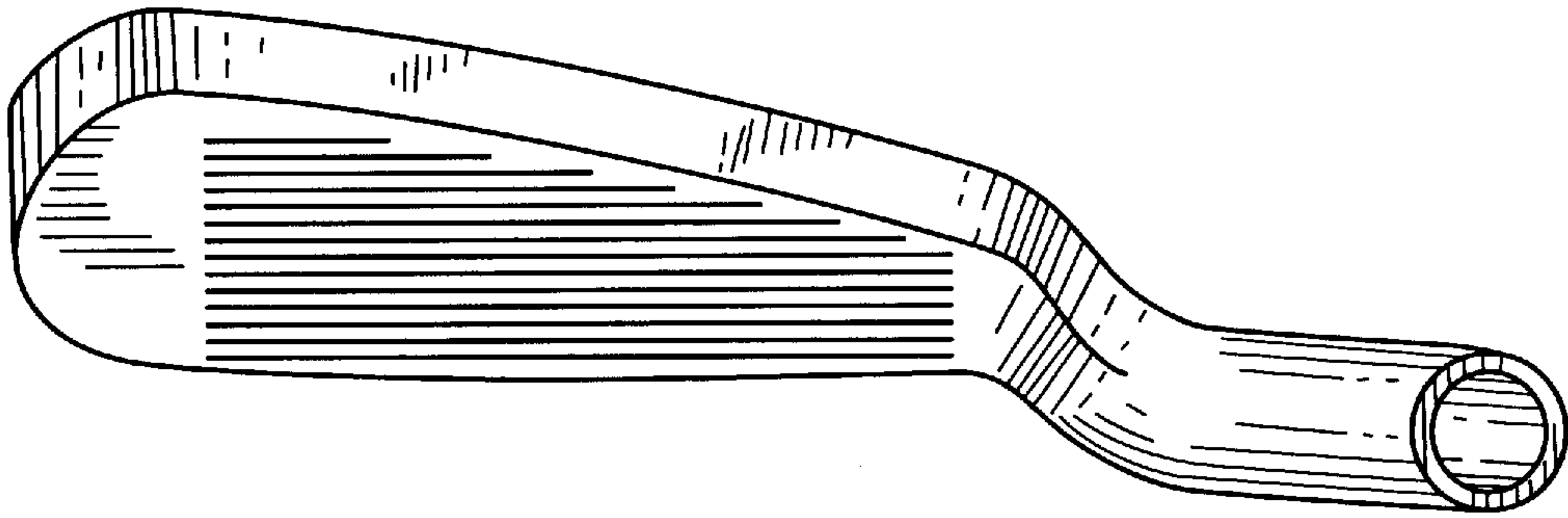

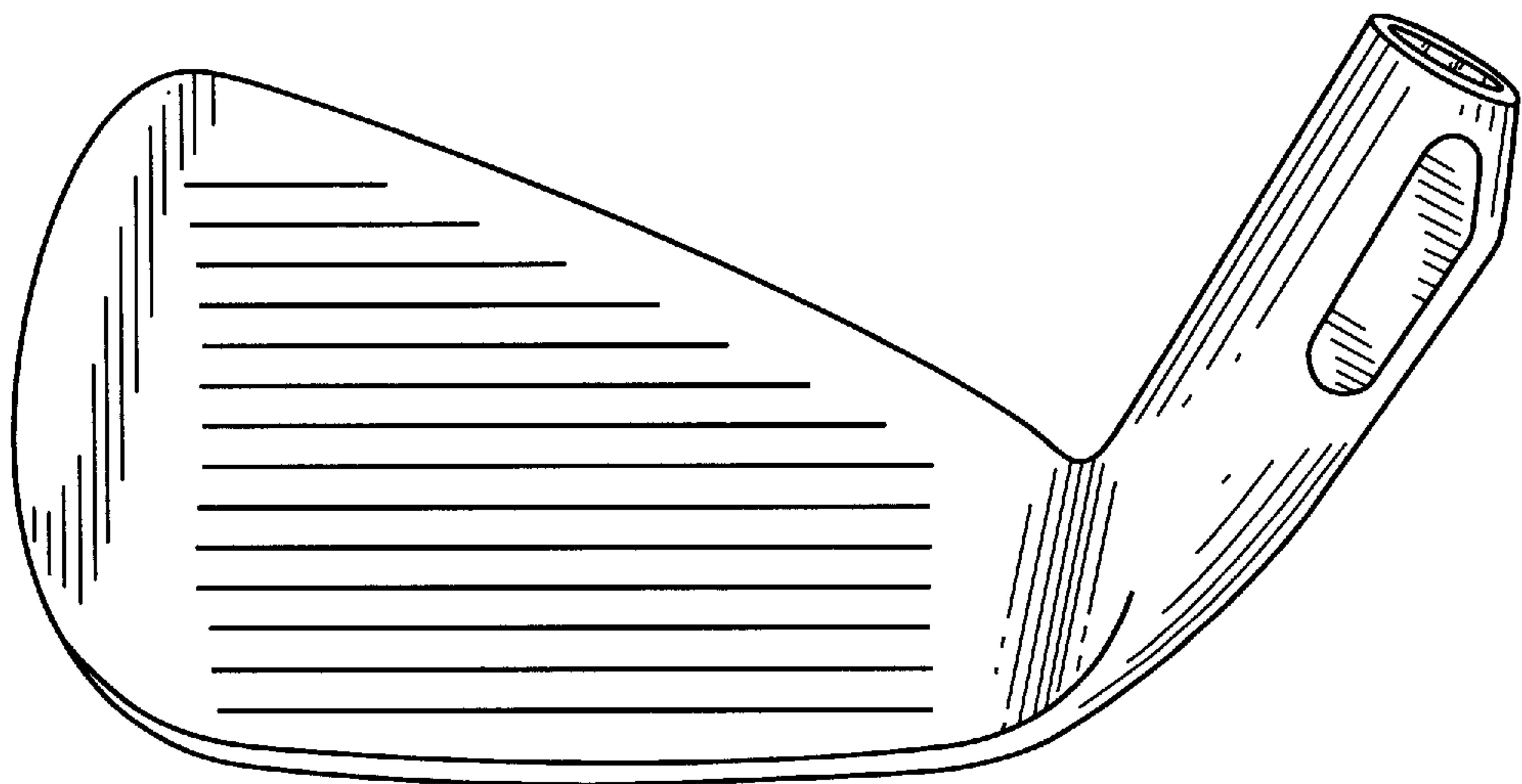

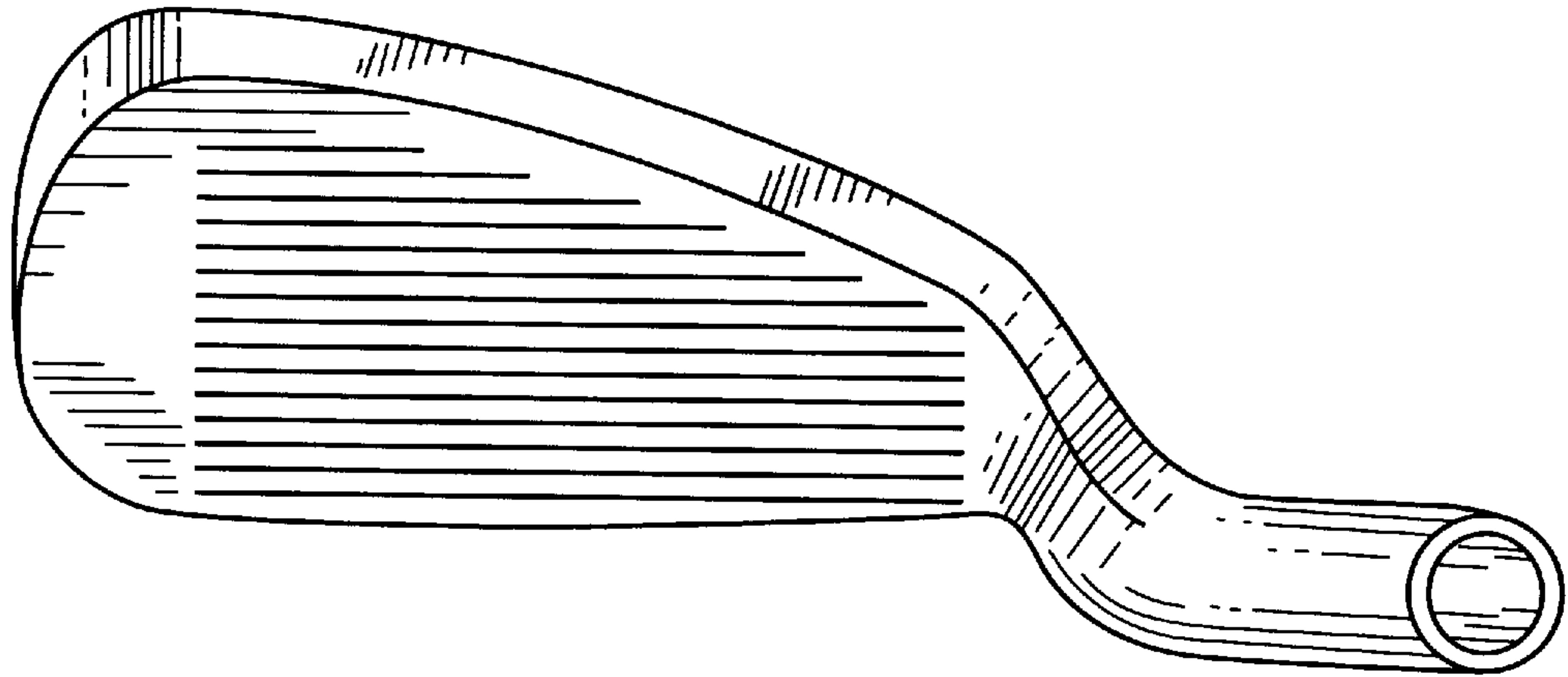

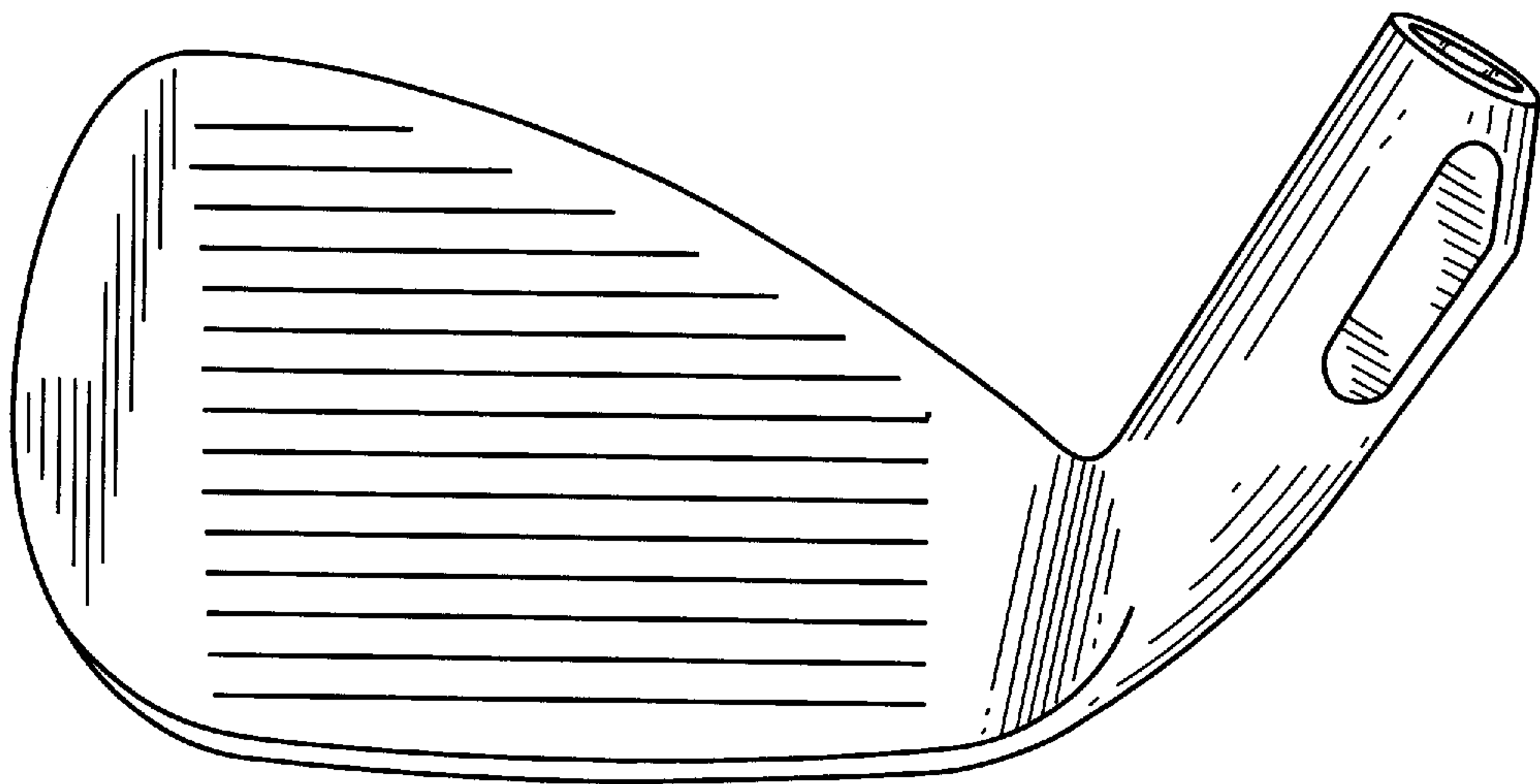
